FIG. 5 is a second image thereof; and,

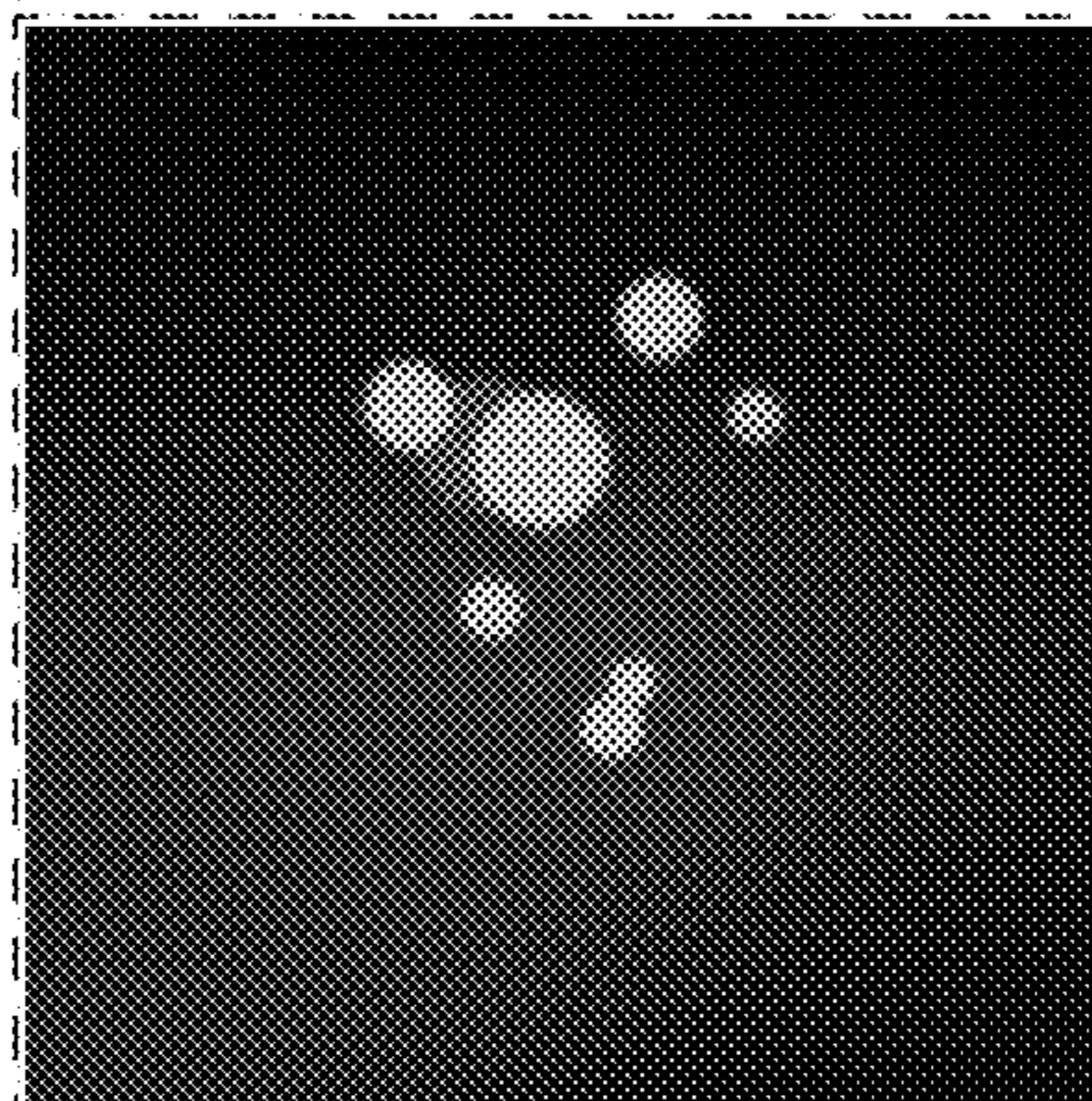
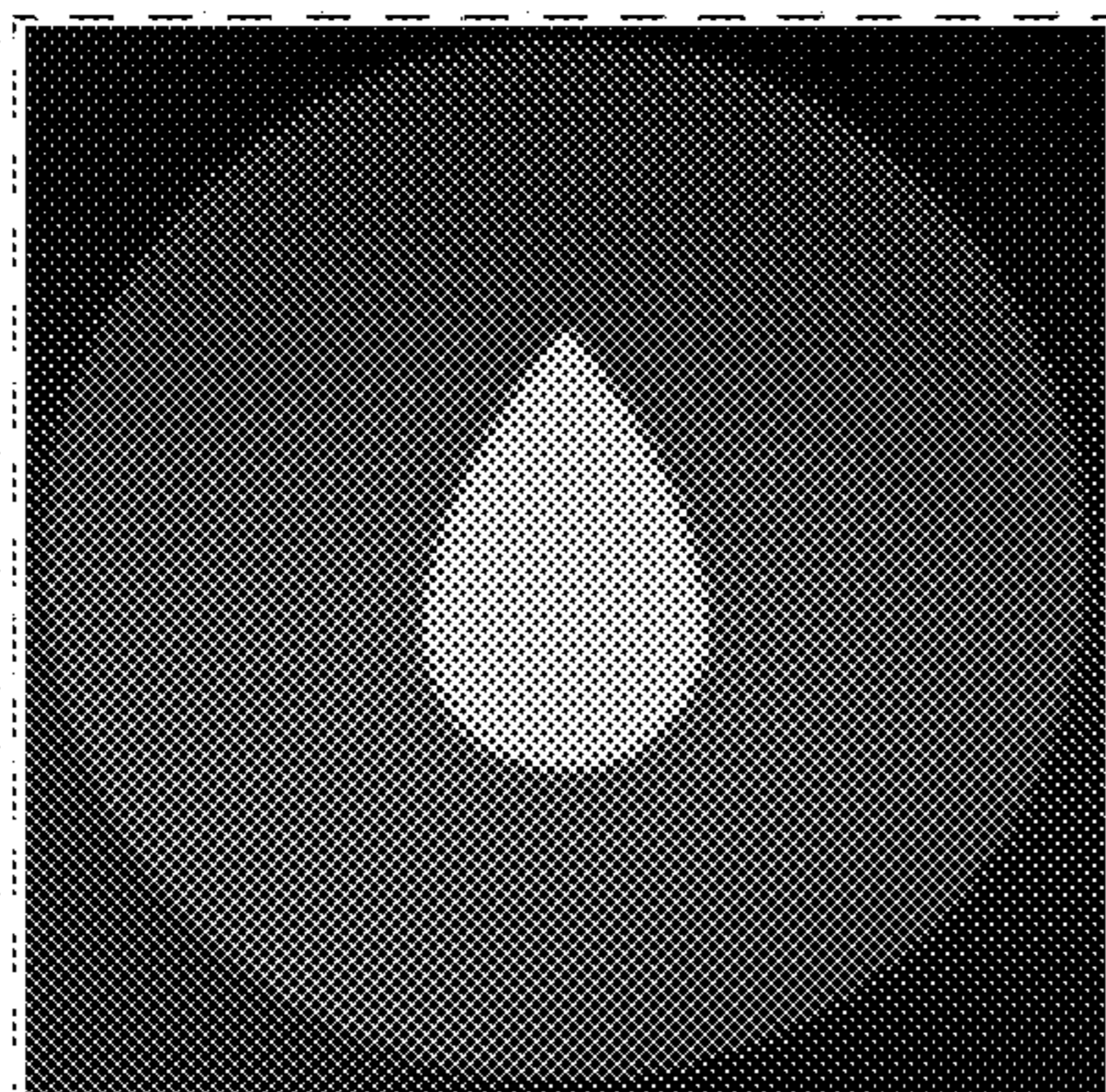
FIG. 6 is a third image thereof.

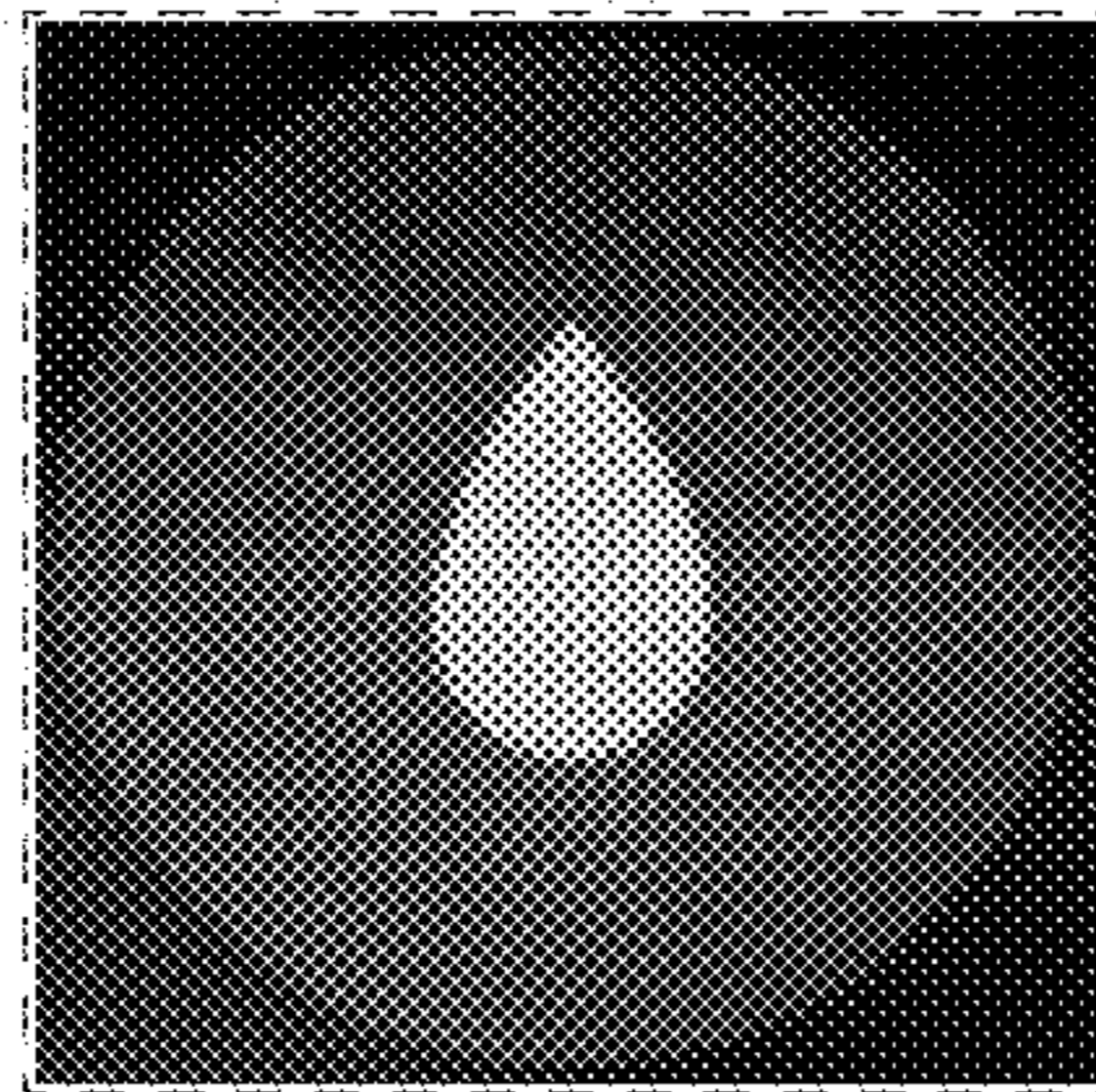

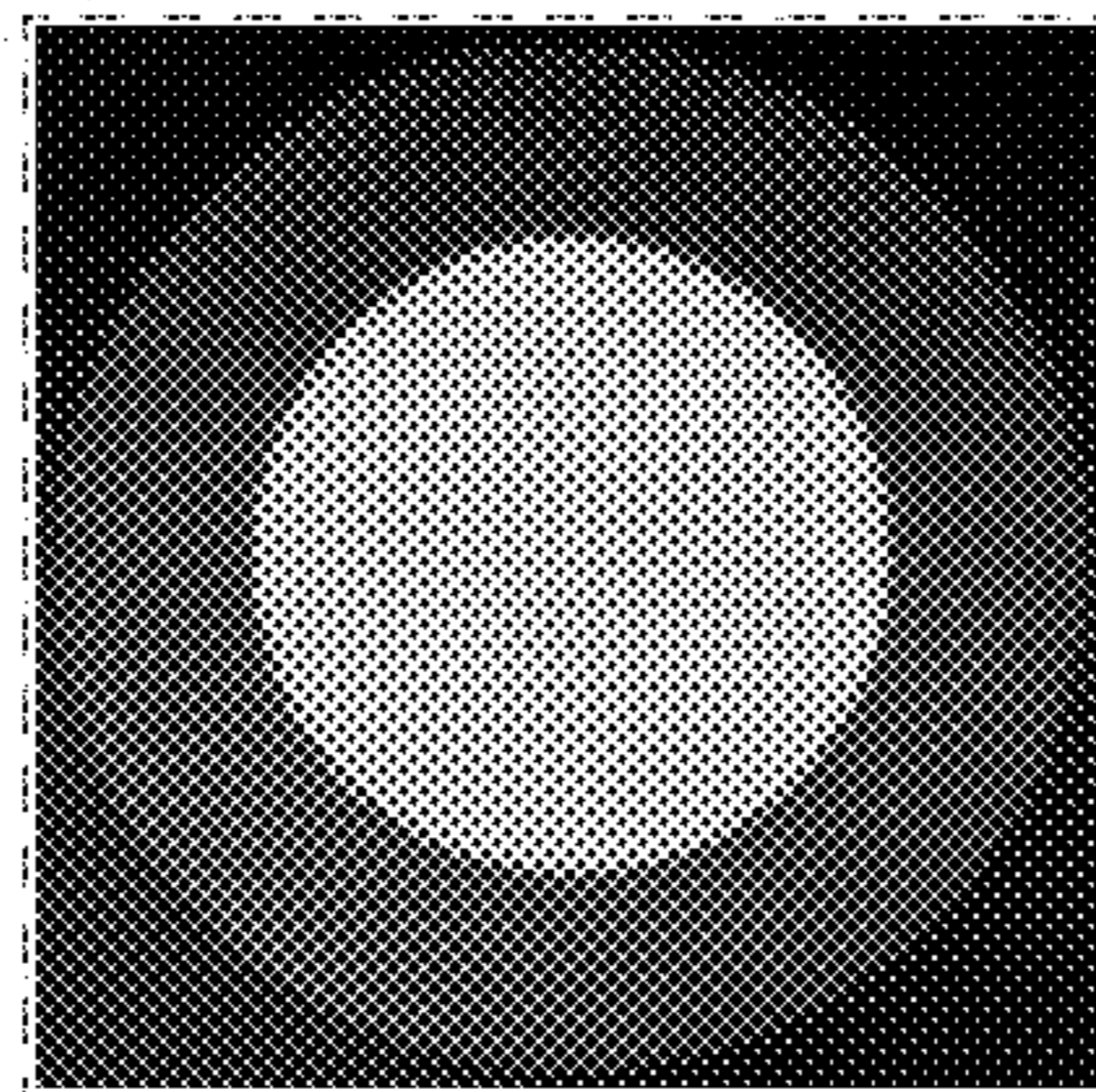

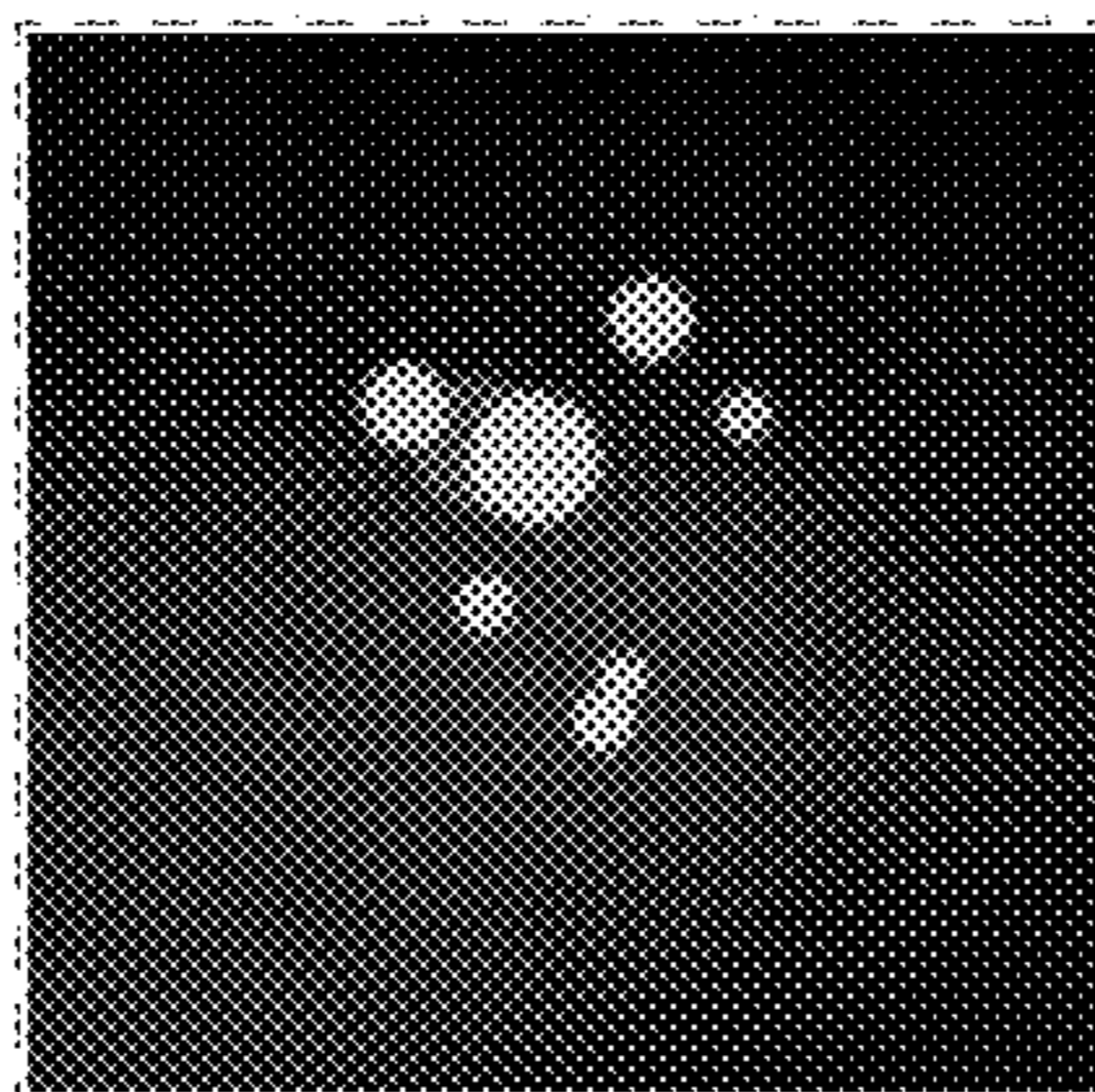

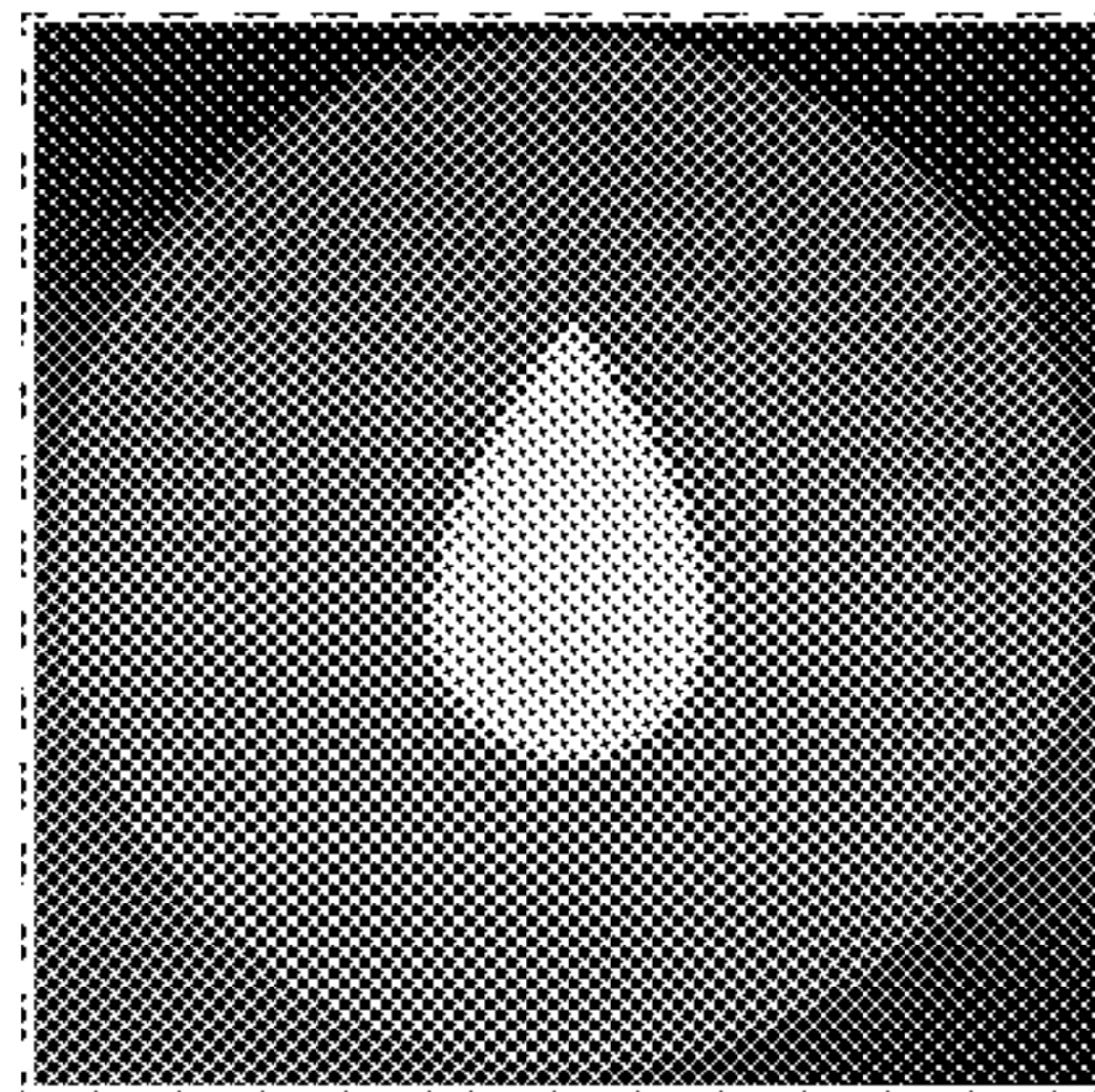

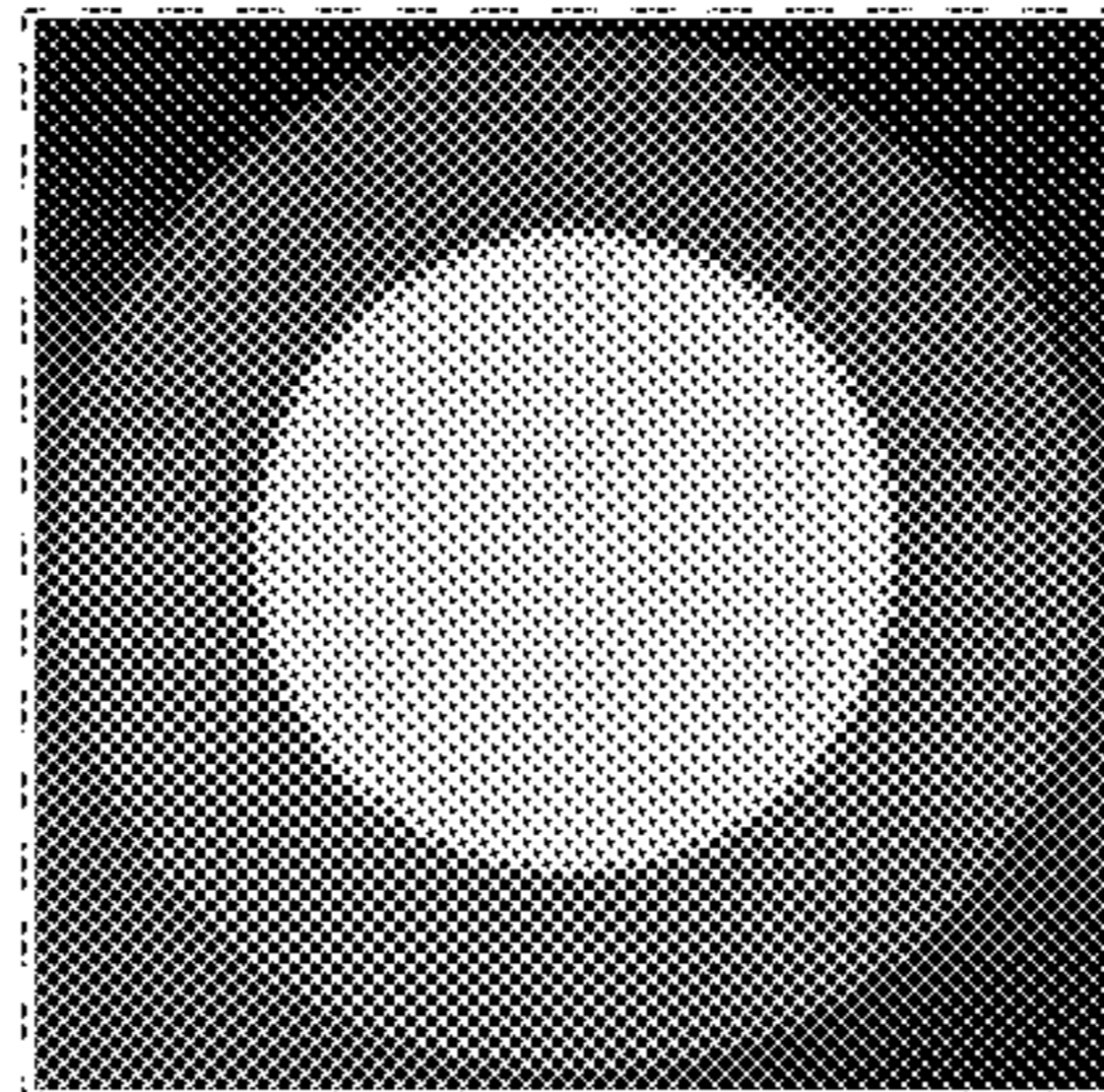

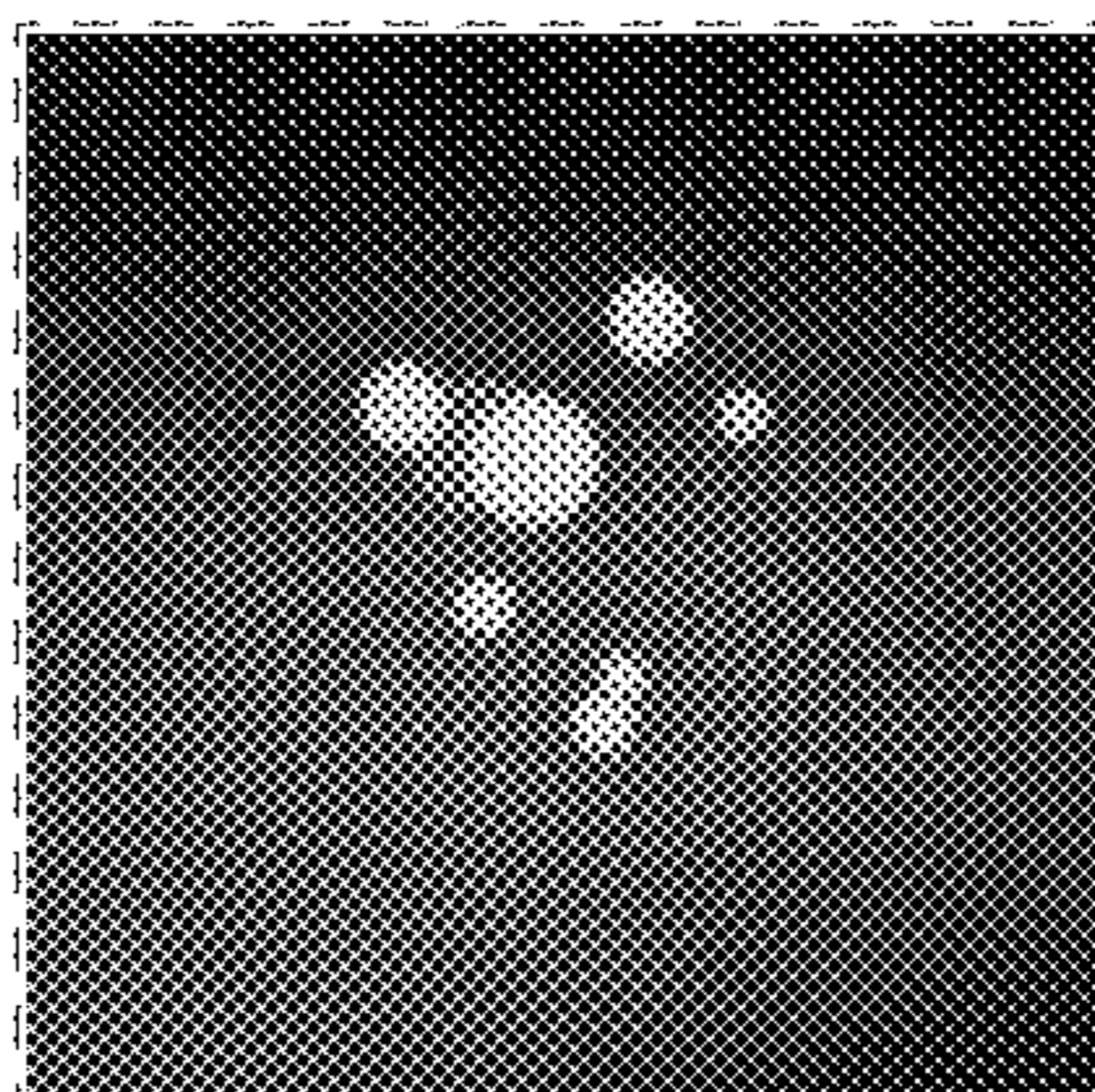
