FIG. 4 is a right side view thereof, the left side view being a mirror image thereof;

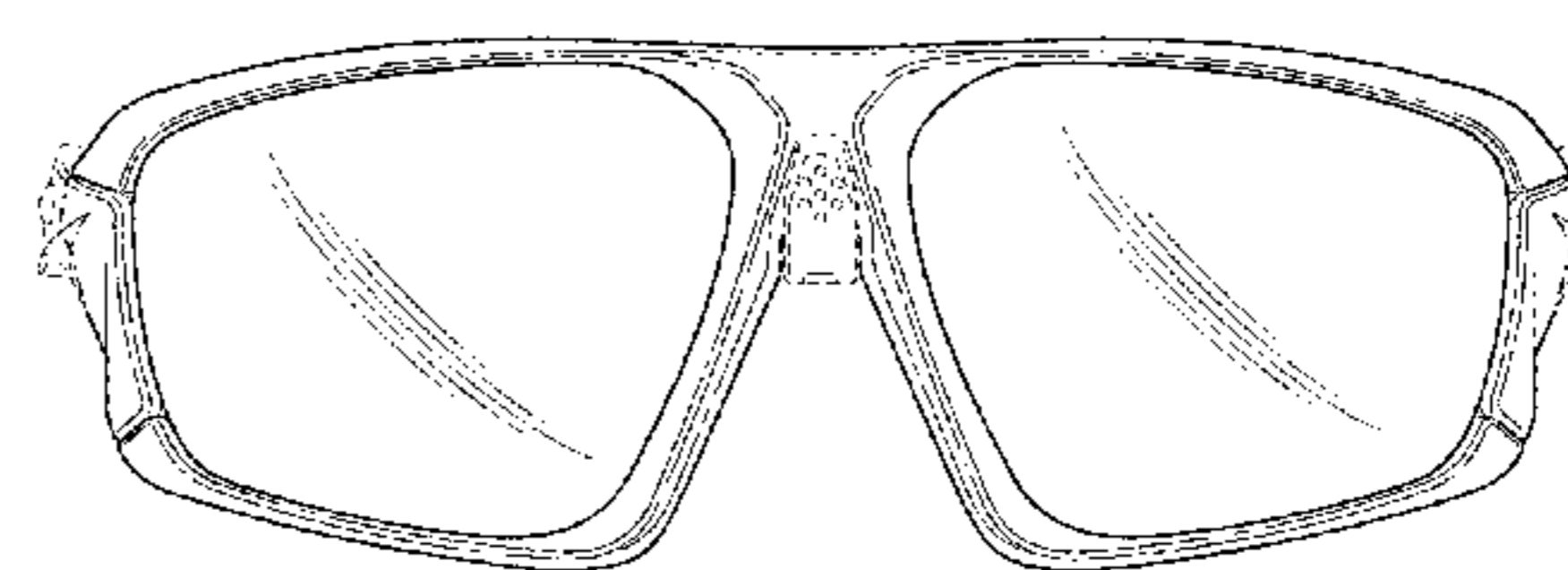
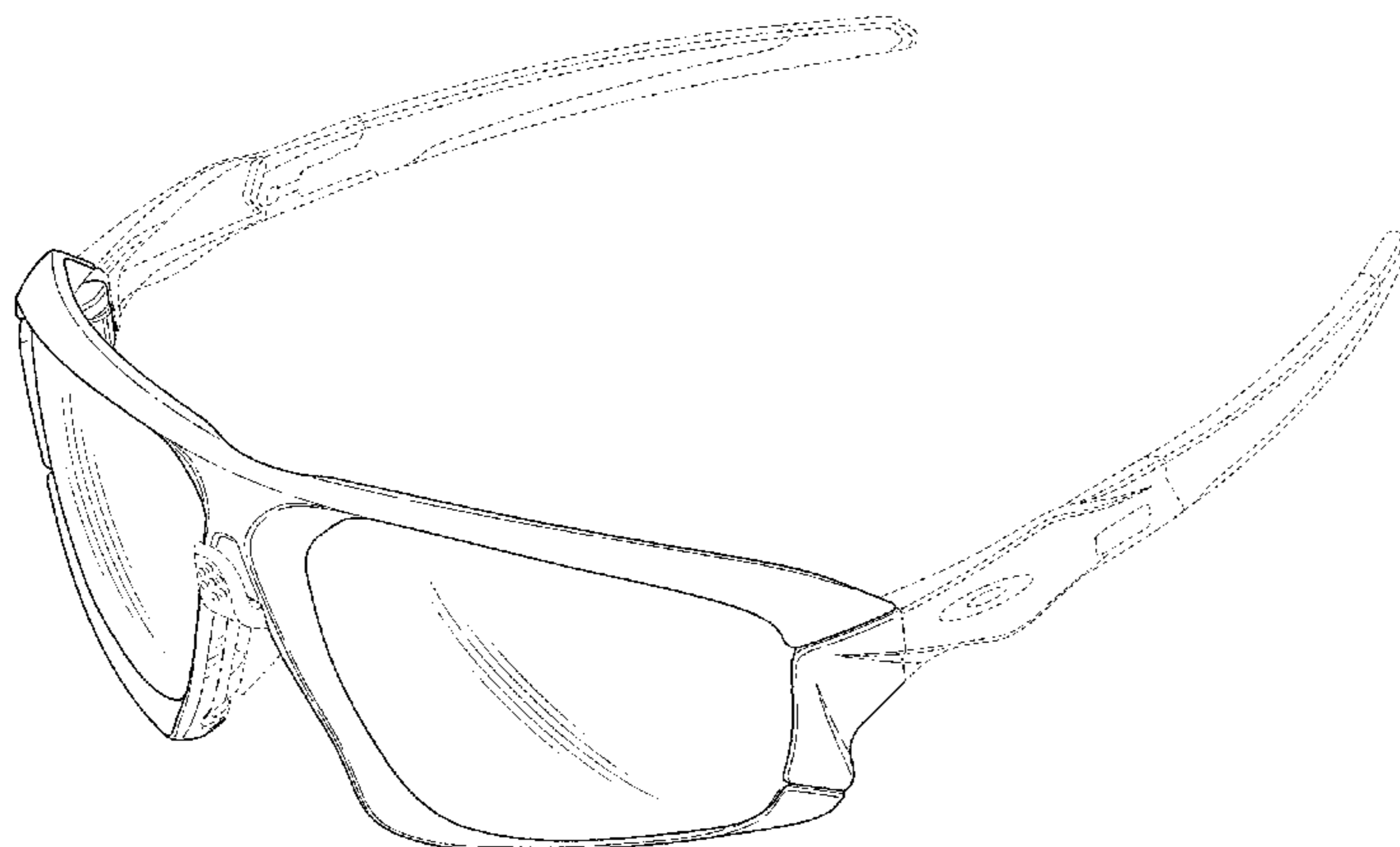
FIG. 5 is a top view thereof; and,

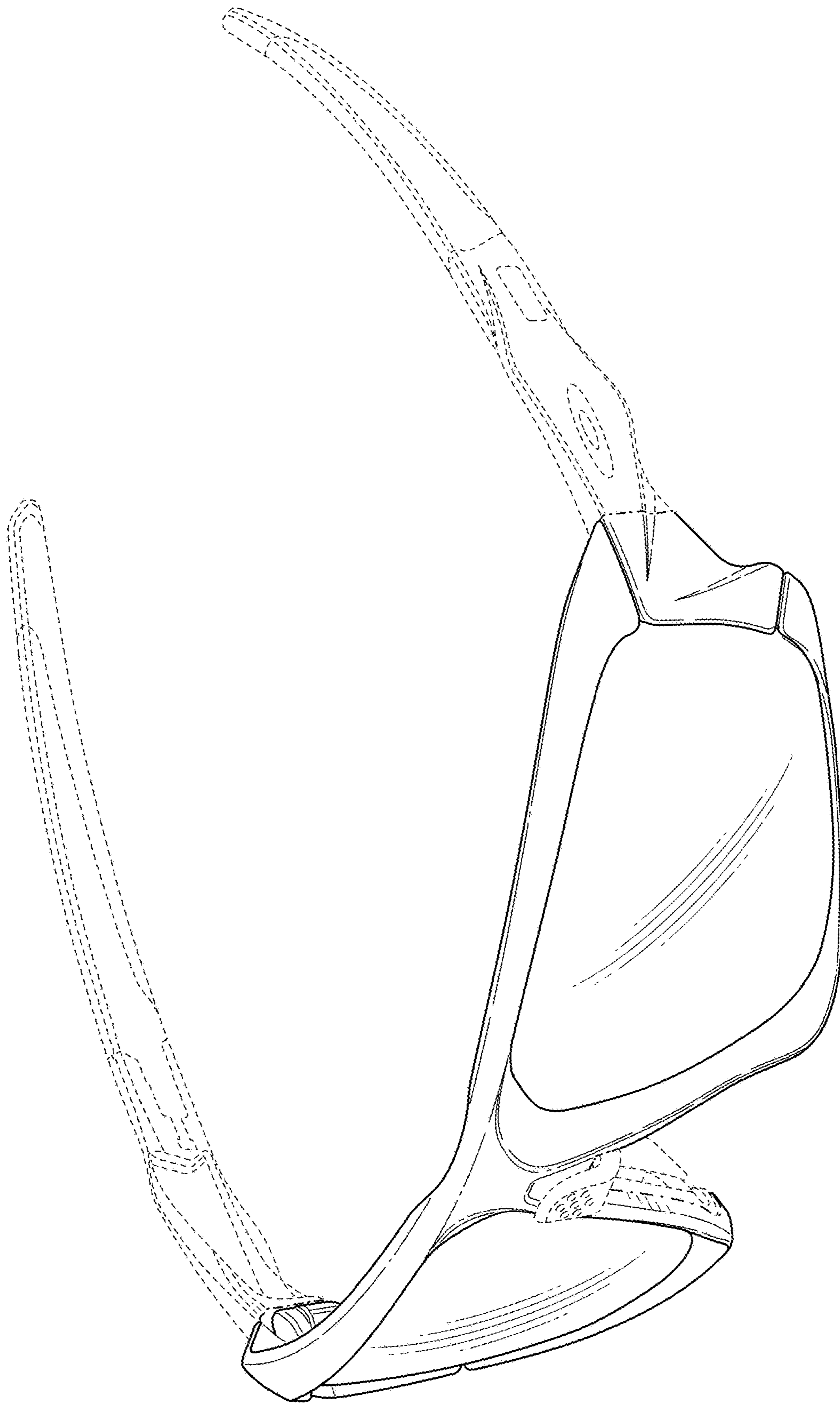

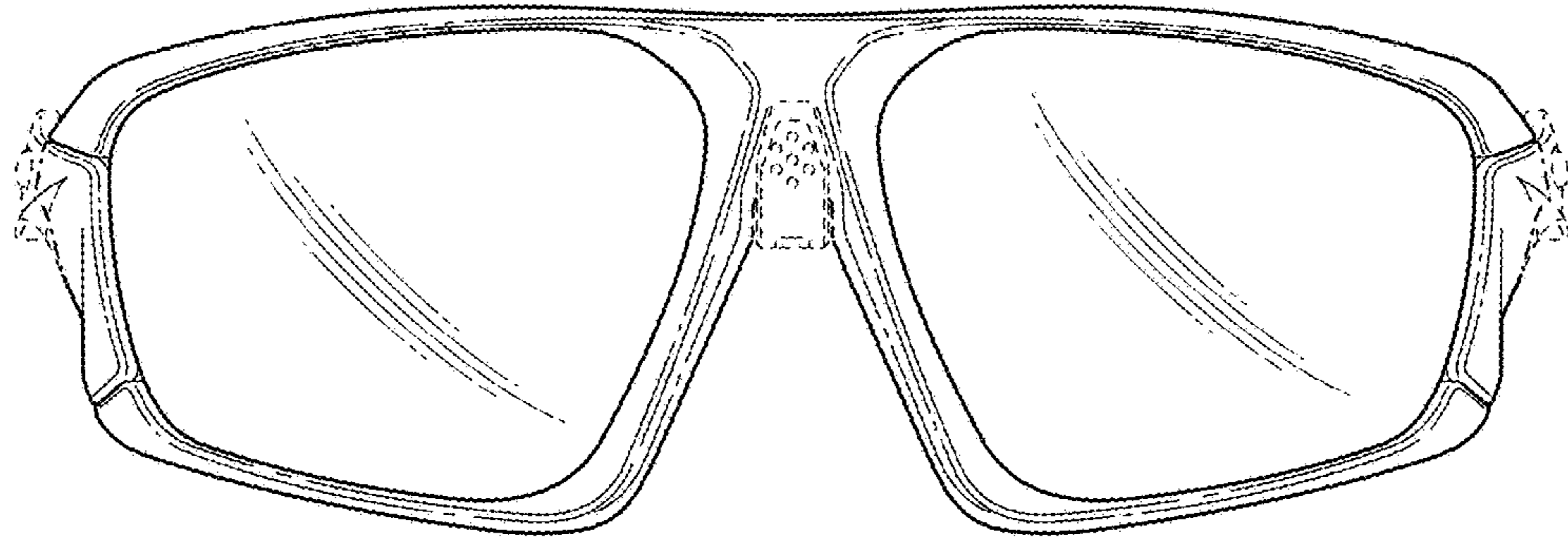

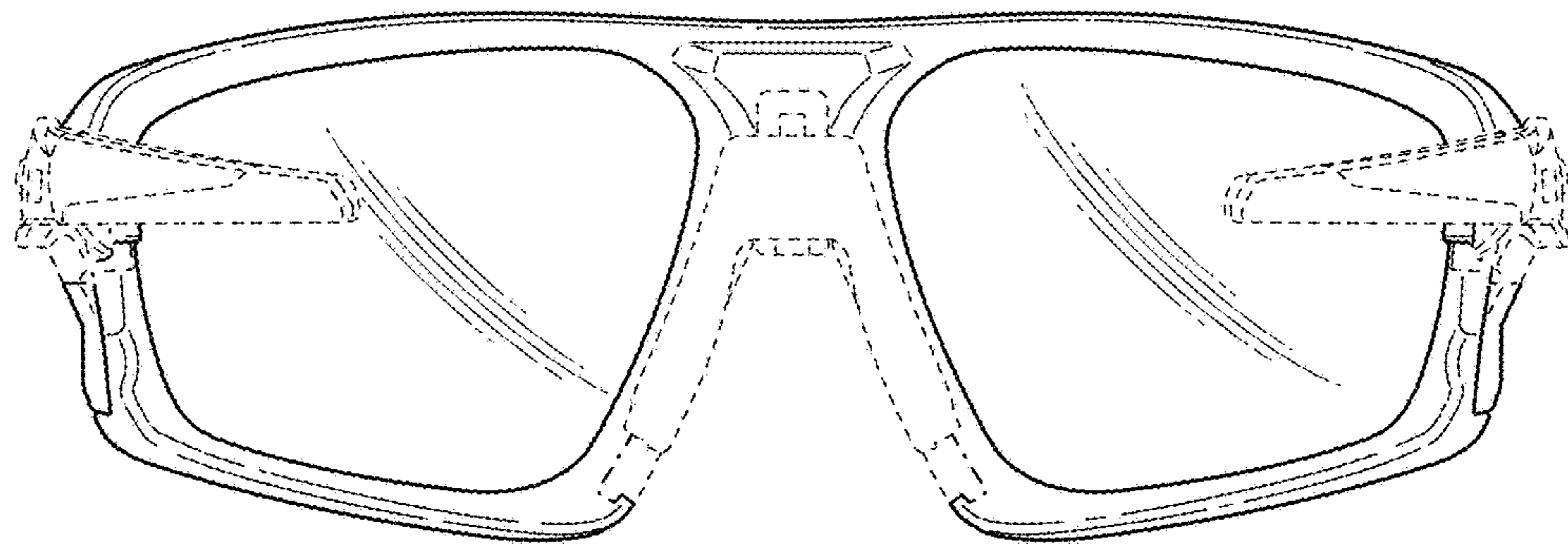

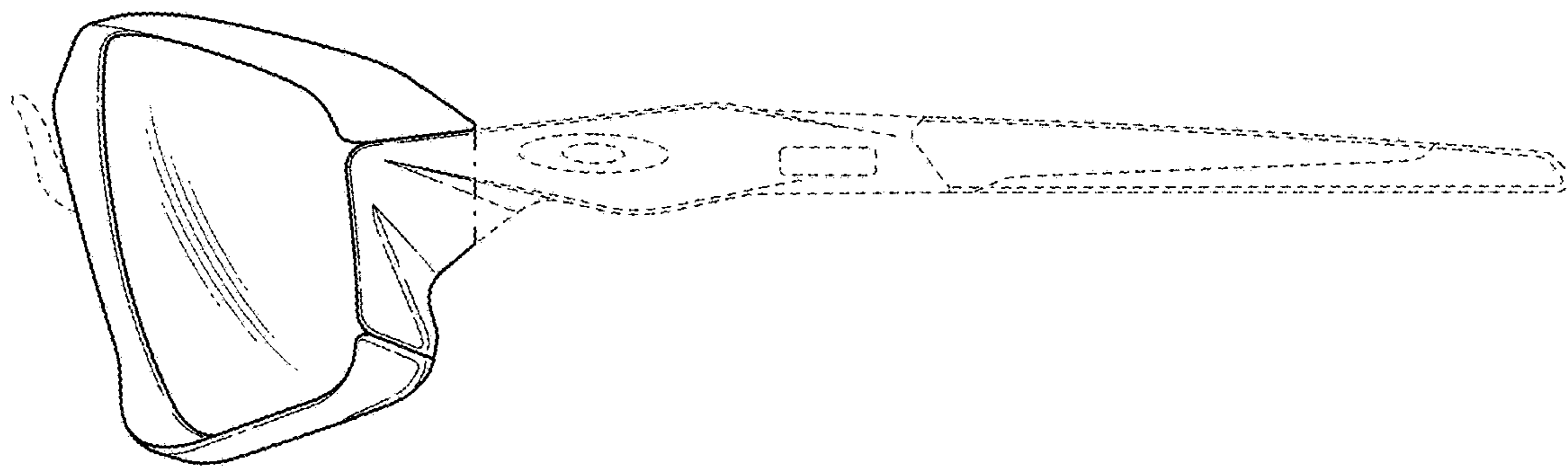

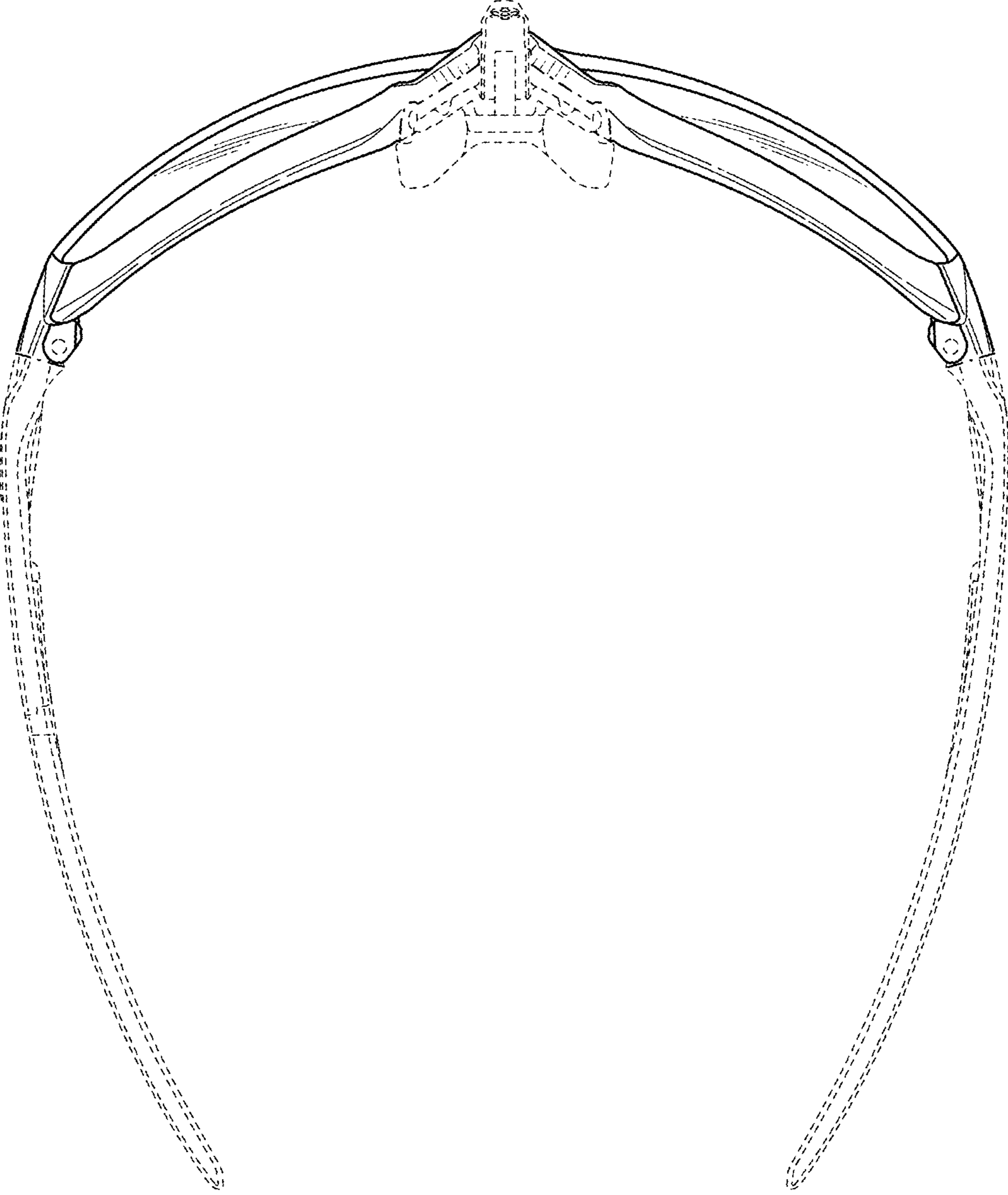
