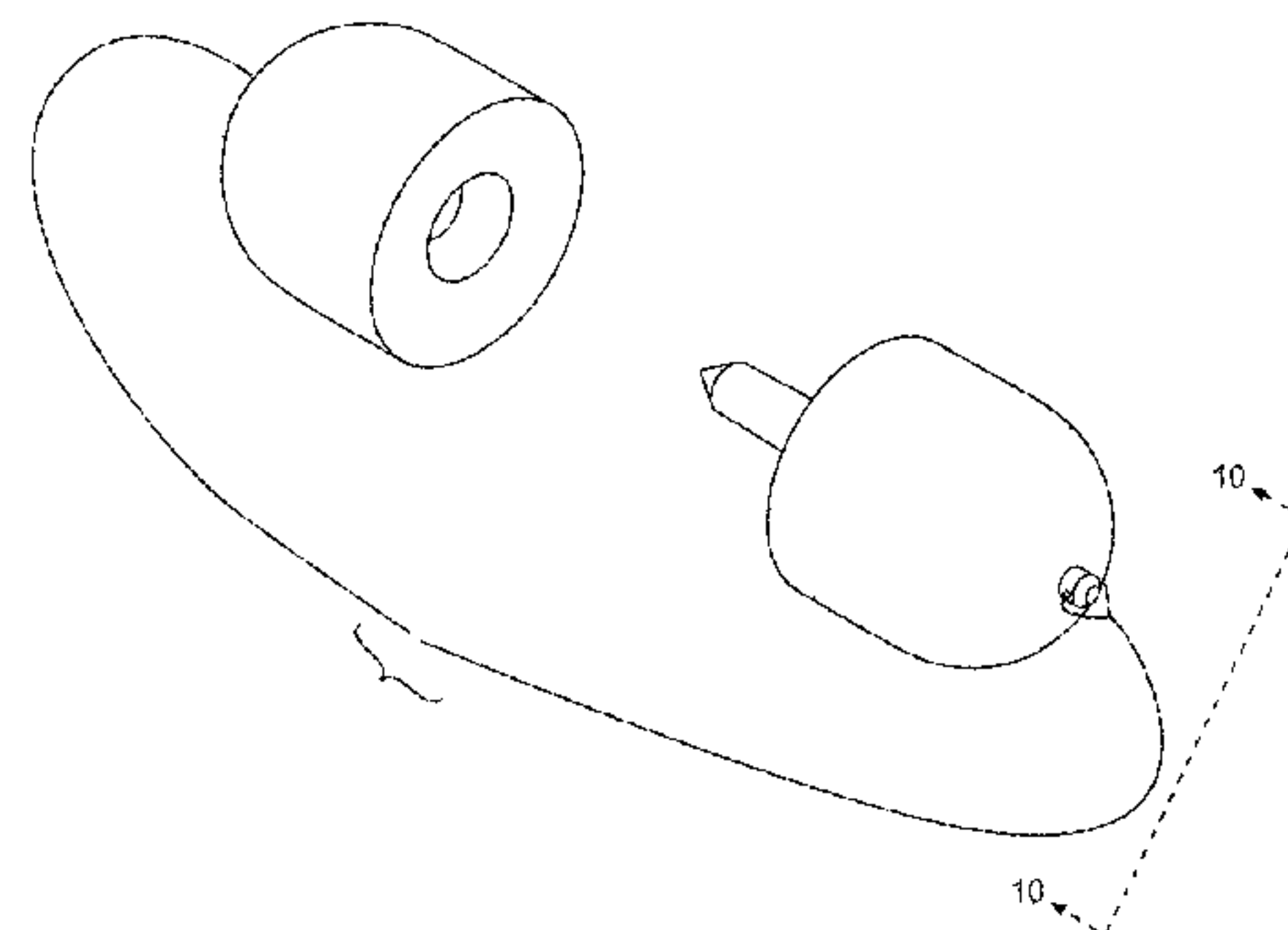
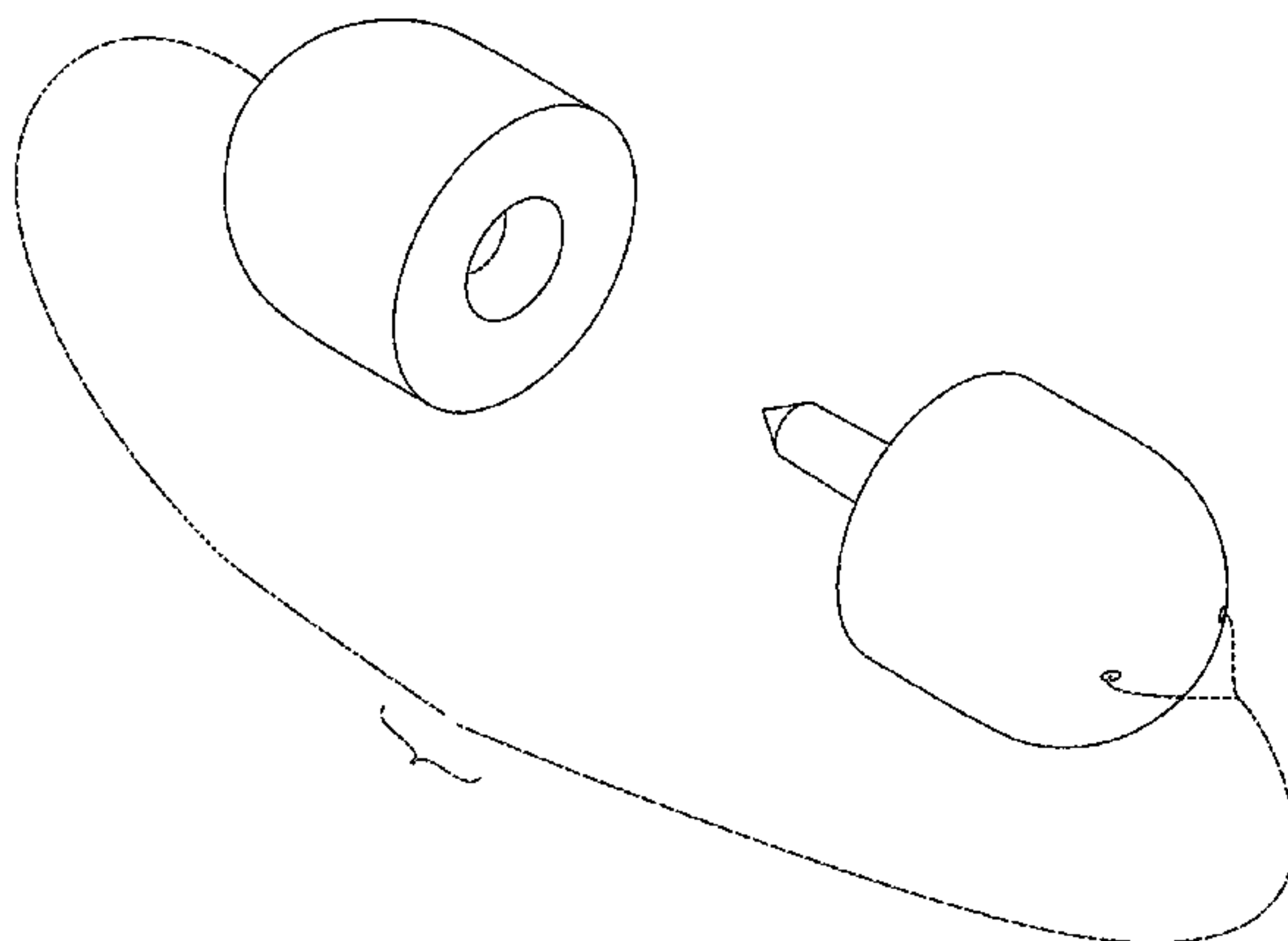
(57) **CLAIM**

The ornamental design for a/an skill toy, as shown and described.

DESCRIPTION

FIG. 1 is a side elevation view showing my new design for a skill toy with its components in a non-mated position; FIG. 2 is a perspective view thereof; FIG. 3 is a side elevation view showing the design components of preceding figures in the mated position; FIG. 4 is a perspective view thereof; FIG. 5 is a side elevation view showing a second embodiment of my new design with its components in a non-mated position; FIG. 6 is a perspective view thereof; FIG. 7 is a side elevation view showing the design components of preceding figures of the second embodiment in the mated position; FIG. 8 is a perspective view thereof; FIG. 9 is a perspective view showing a third embodiment of my new design, wherein the inner end surface of the female component is concave; and, FIG. 10 is a cross sectional view taken along line 10-10 of FIG. 10.

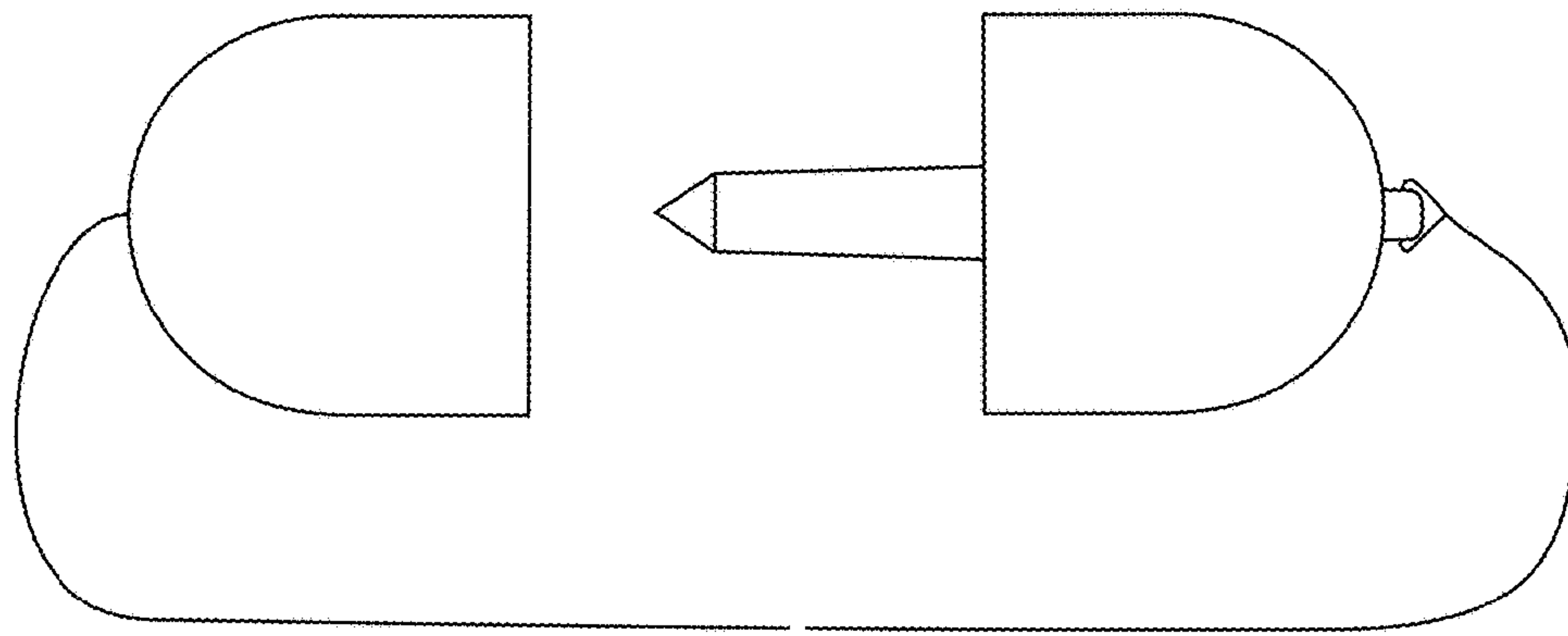

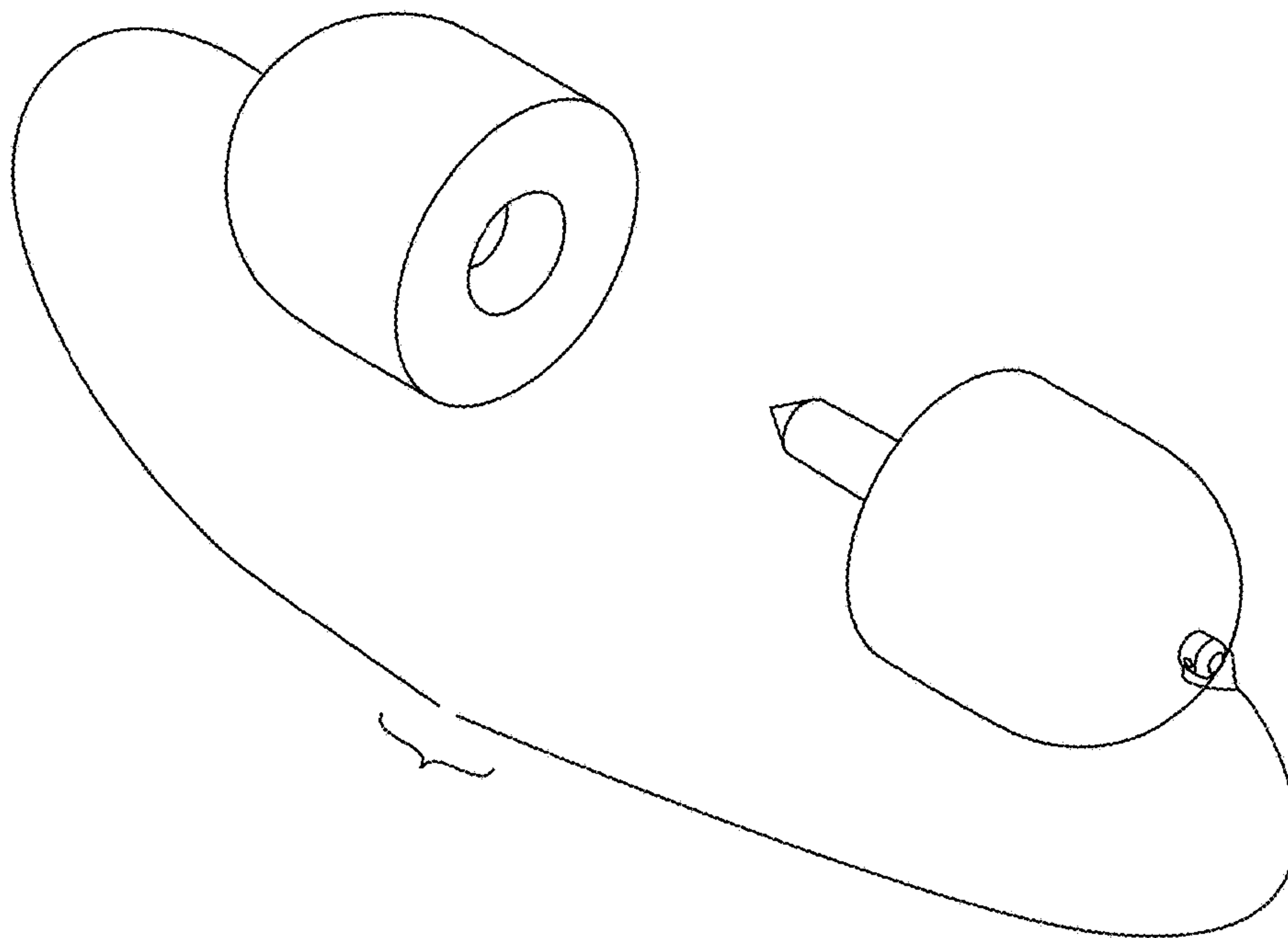

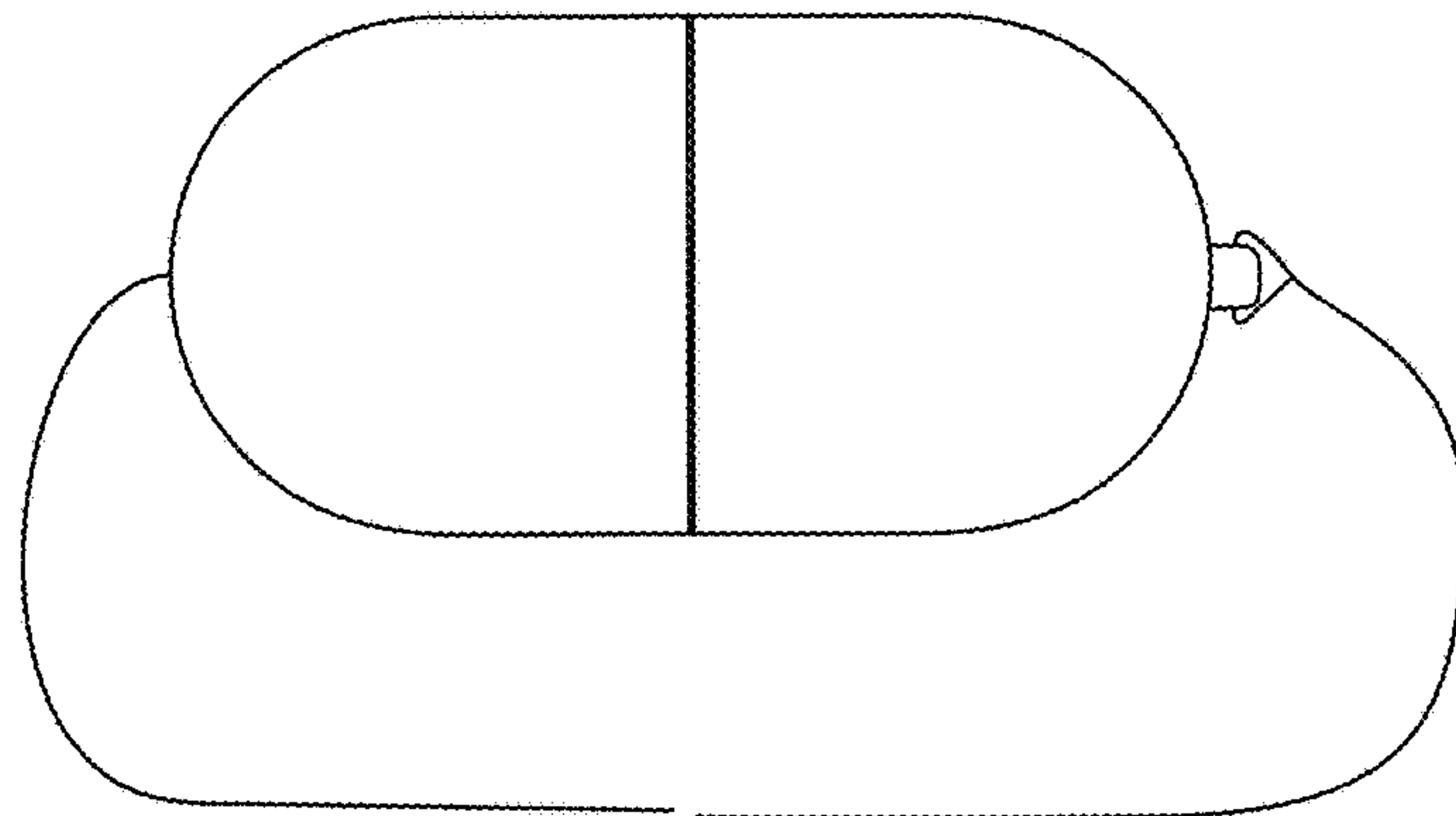

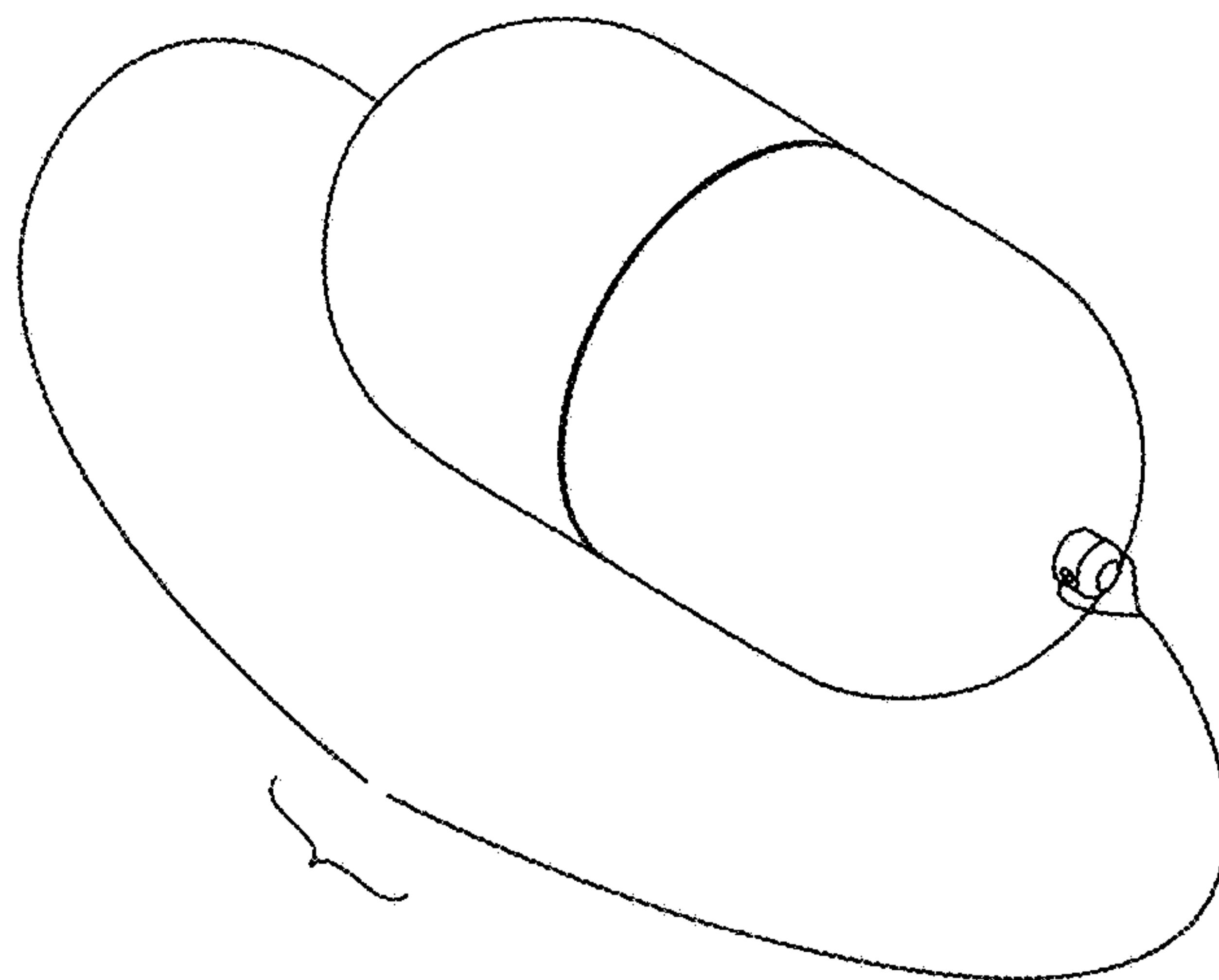

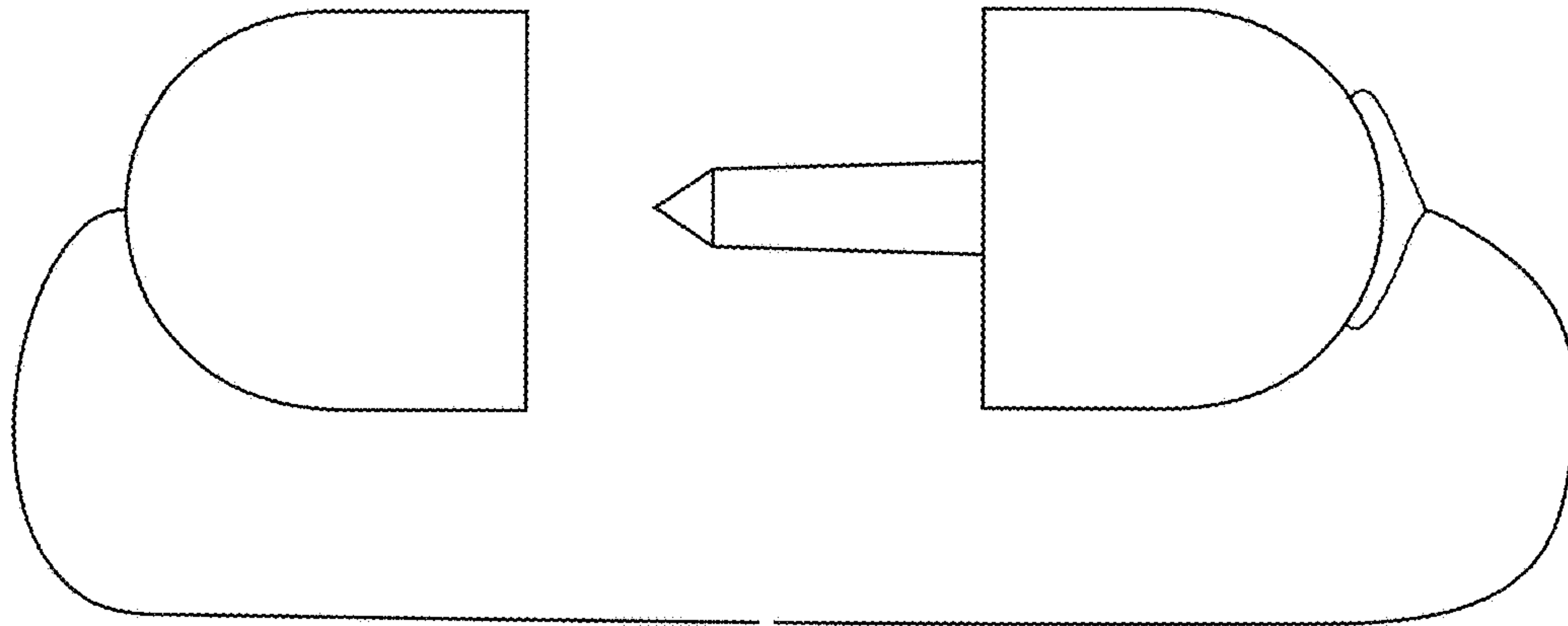

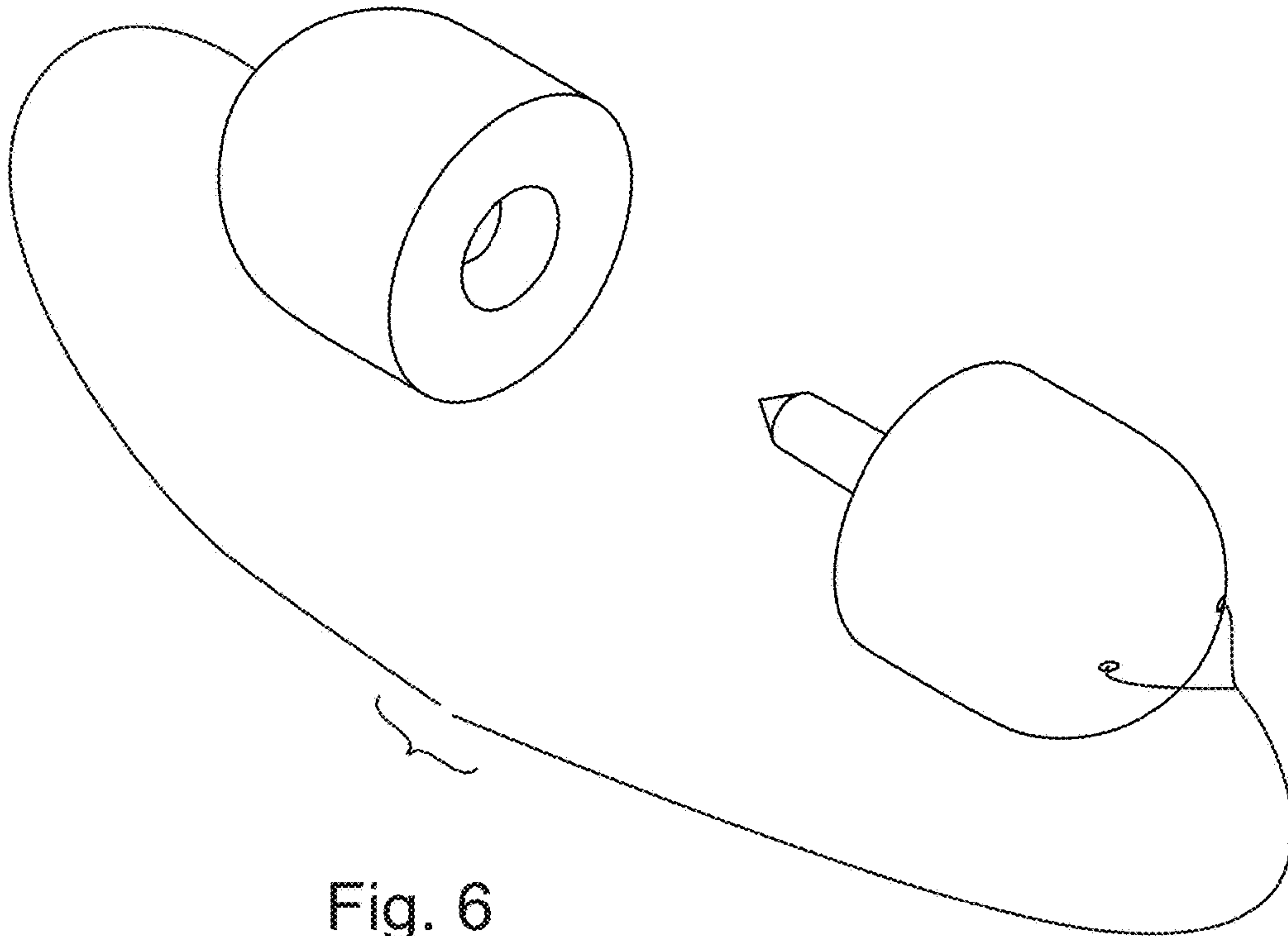

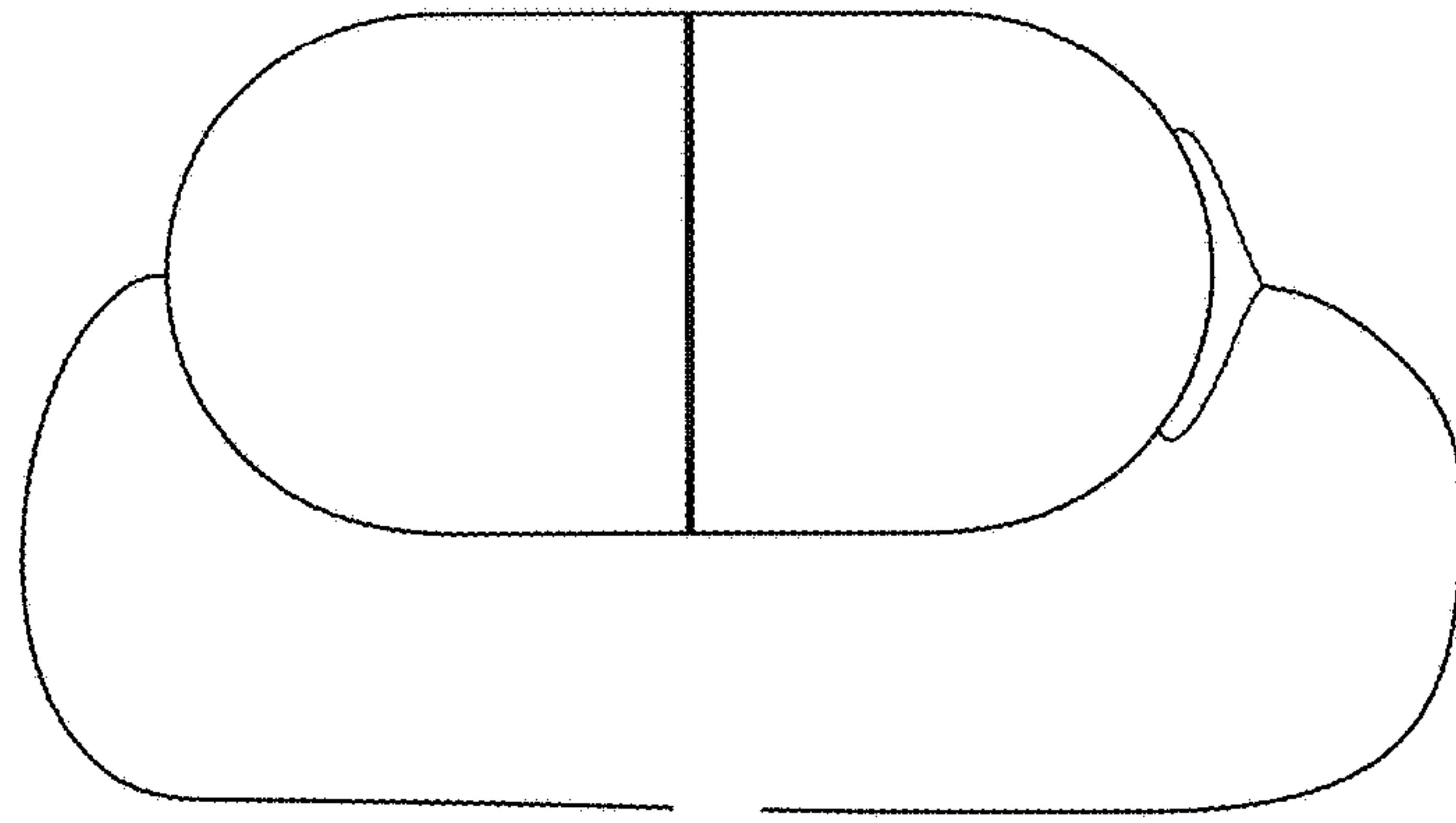

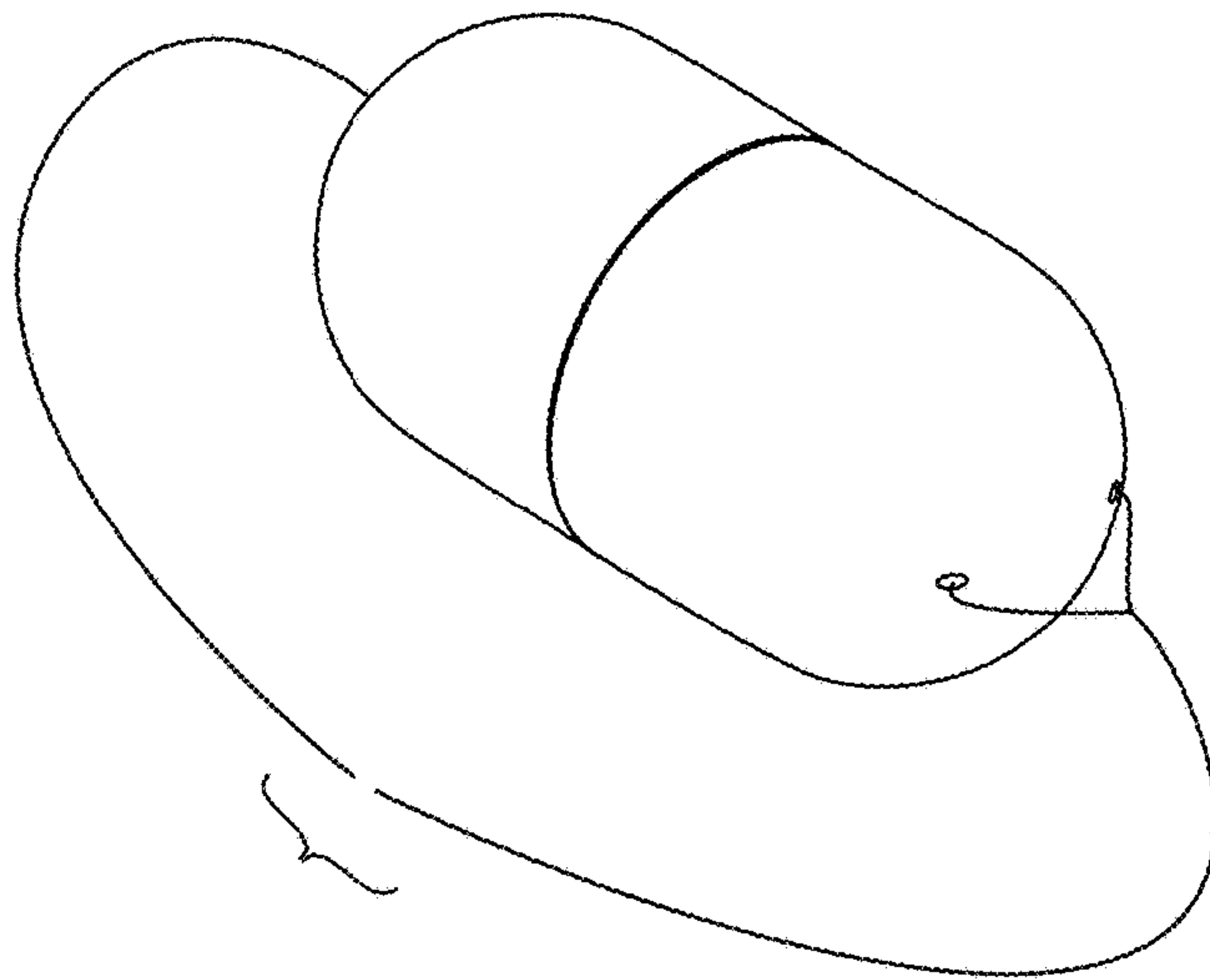
