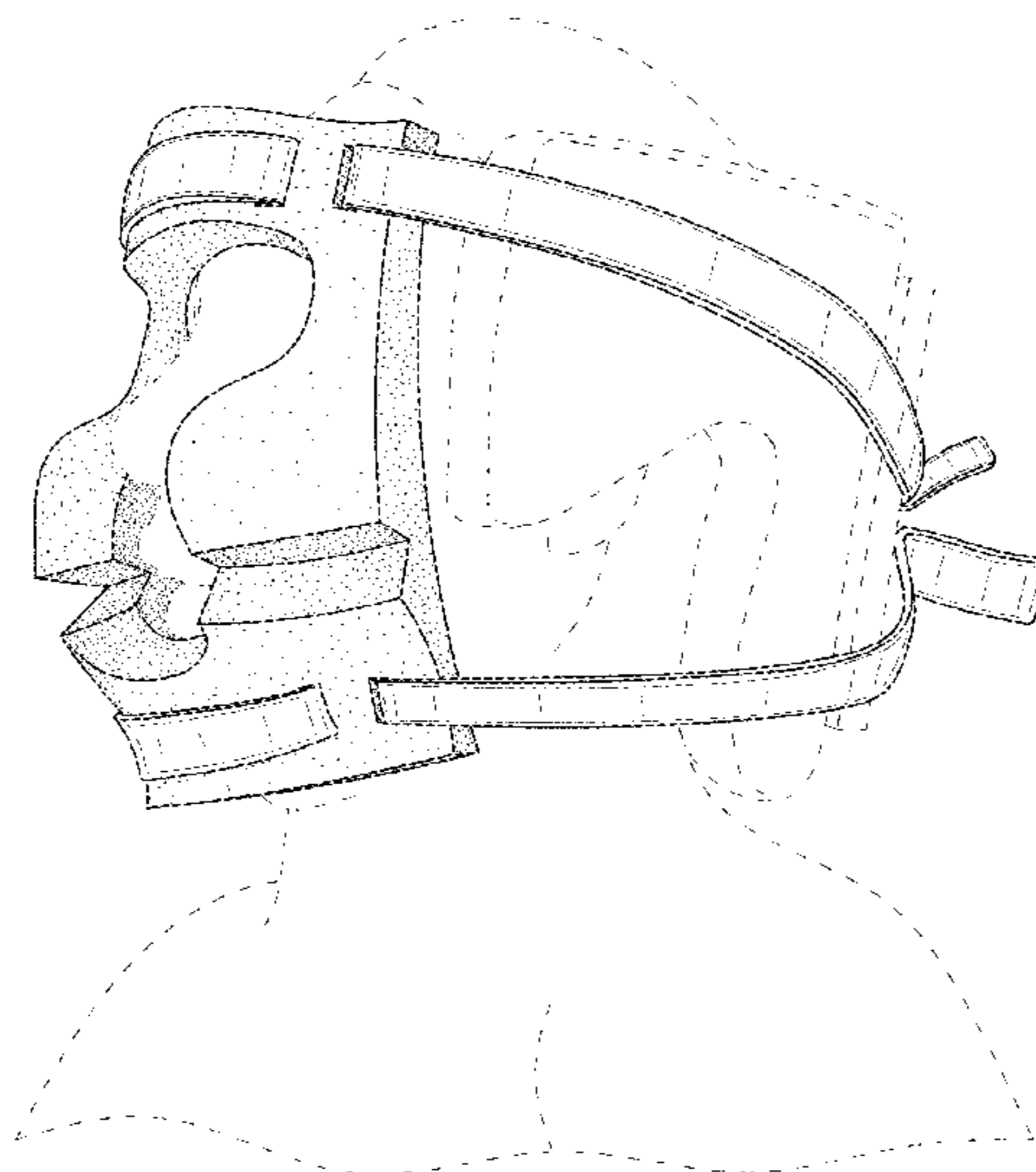
(57) **CLAIM**

The ornamental design for the facial protective device, as shown and described.

DESCRIPTION

FIG. 1 is a frontal left side perspective view of the facial protective device showing the design in an attached orientation;
FIG. 2 is a frontal right side perspective view of the facial protective device of FIG. 1 in an unattached orientation;
FIG. 3 is a front plan view of the facial protective device of FIG. 1 in an unattached orientation;
FIG. 4 is a rear plan view of the facial protective device of FIG. 1 in an unattached orientation;
FIG. 5 is a right side elevation view of the facial protective device of FIG. 1 in an unattached orientation; and,
FIG. 6 is a top plan view of the facial protective device of FIG. 1 in an unattached orientation.

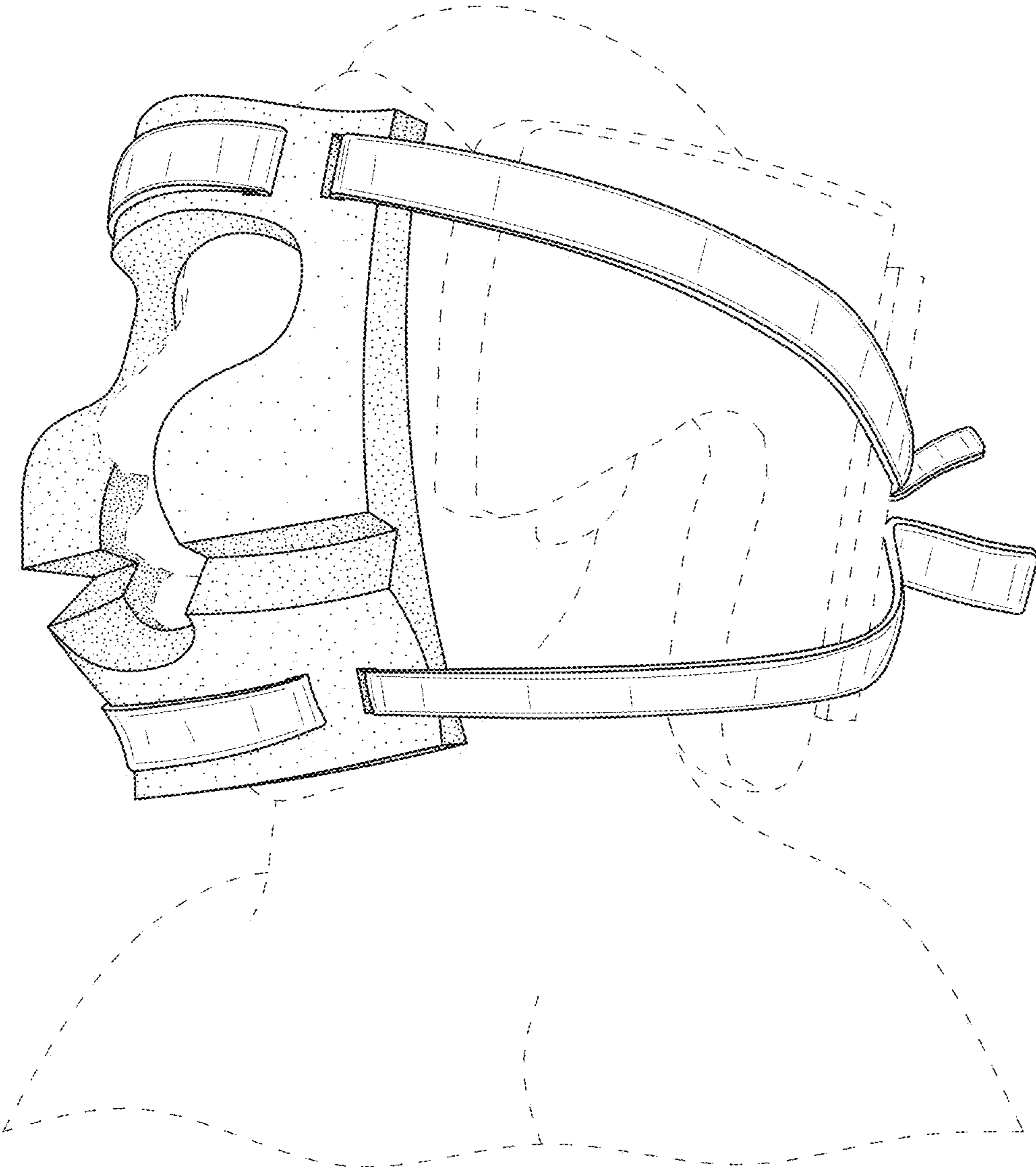

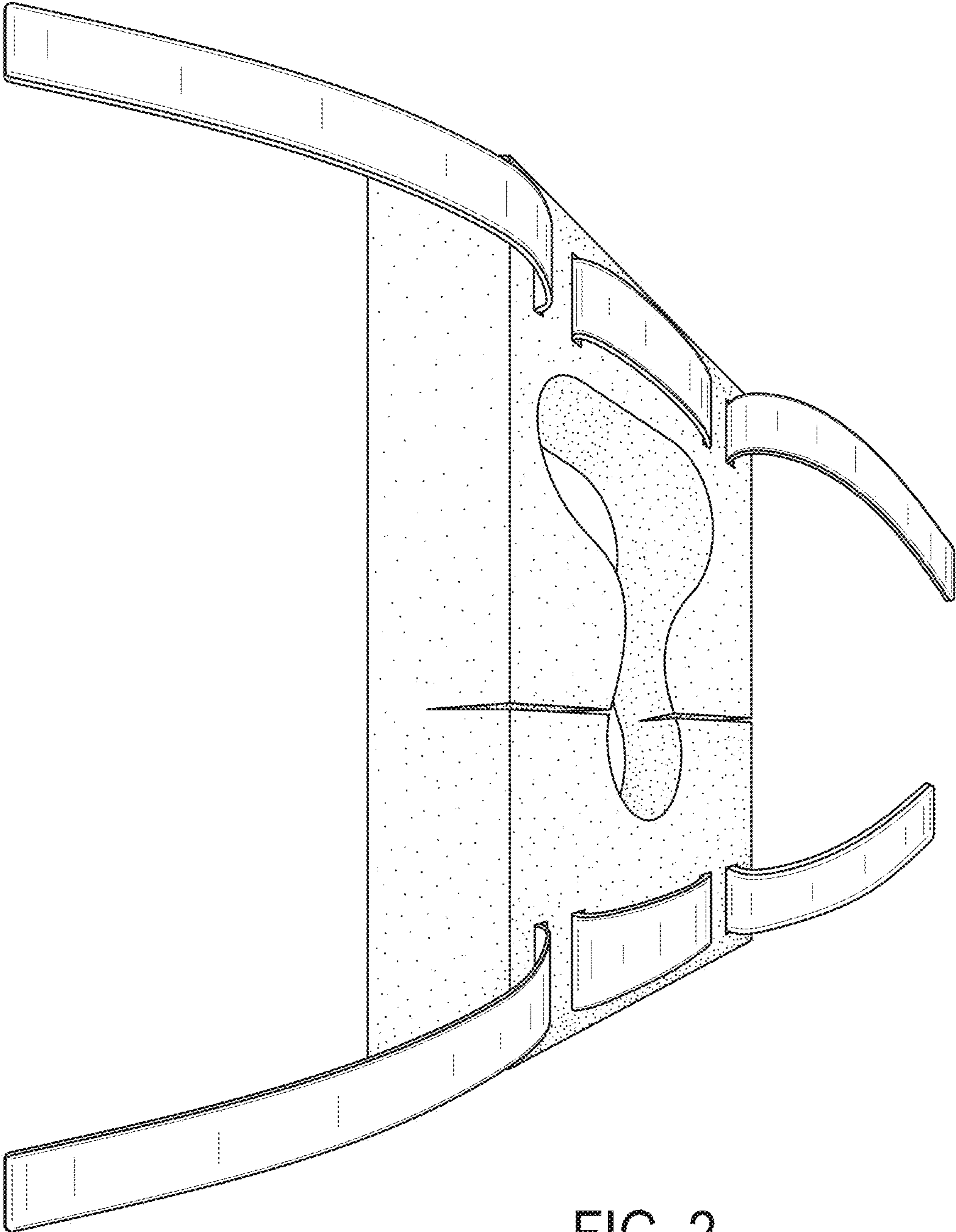

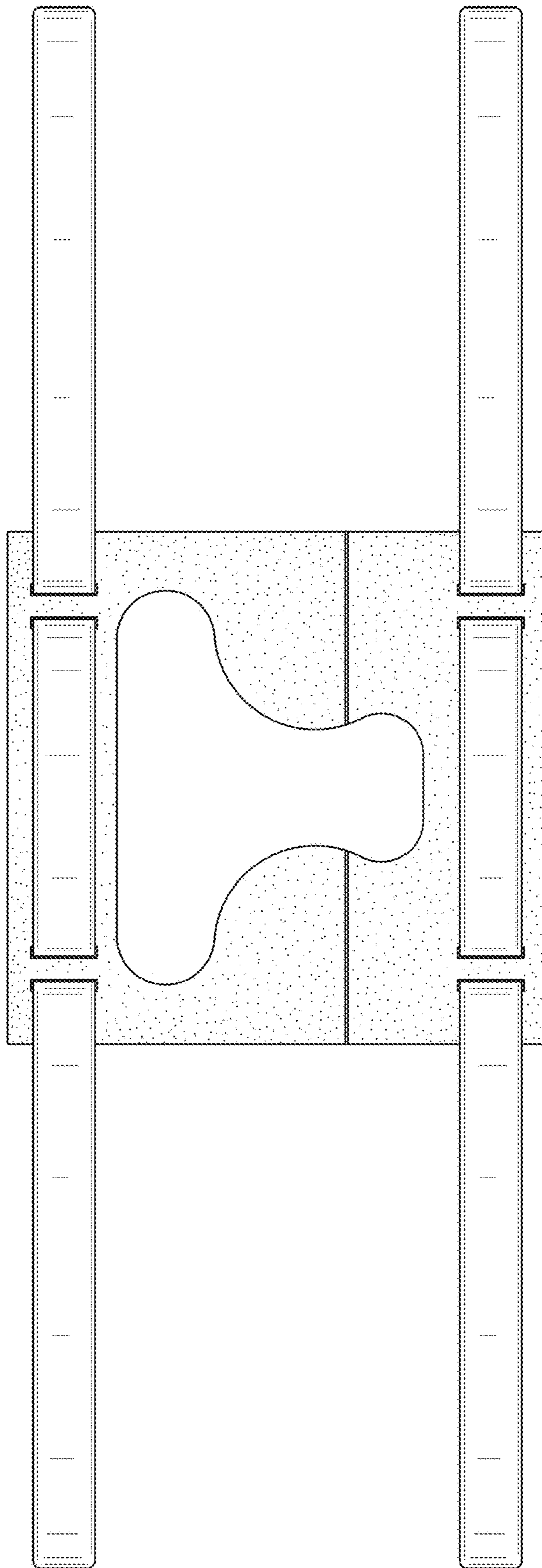

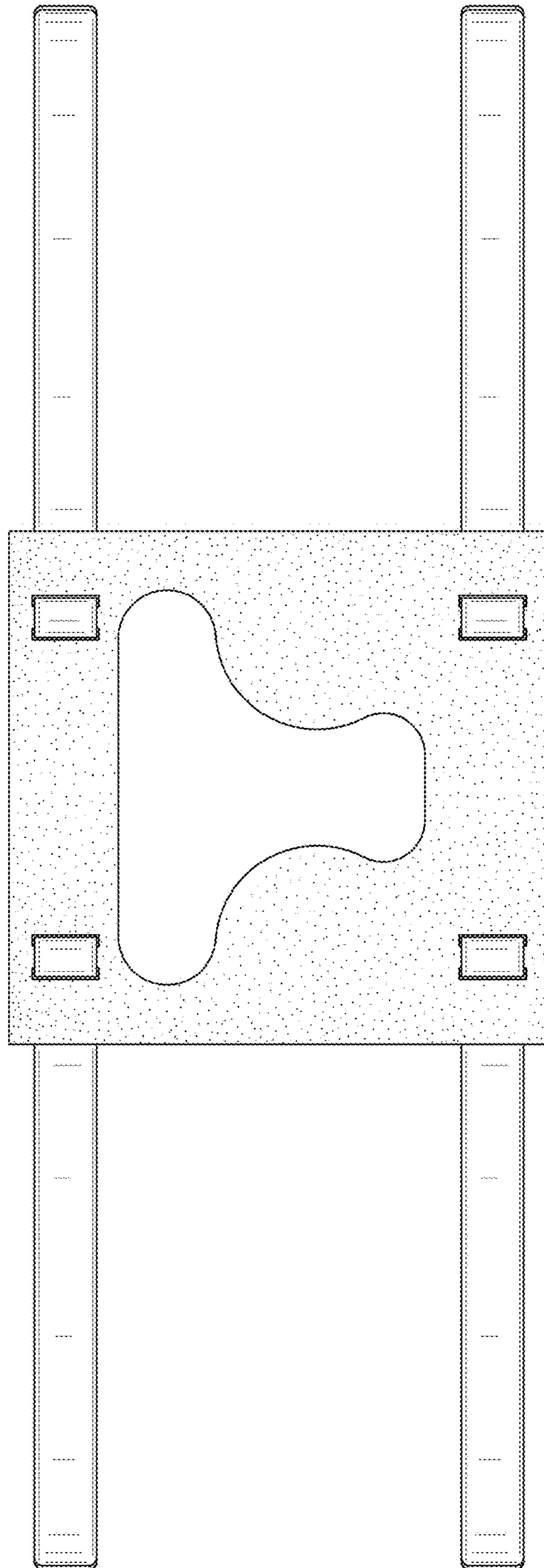

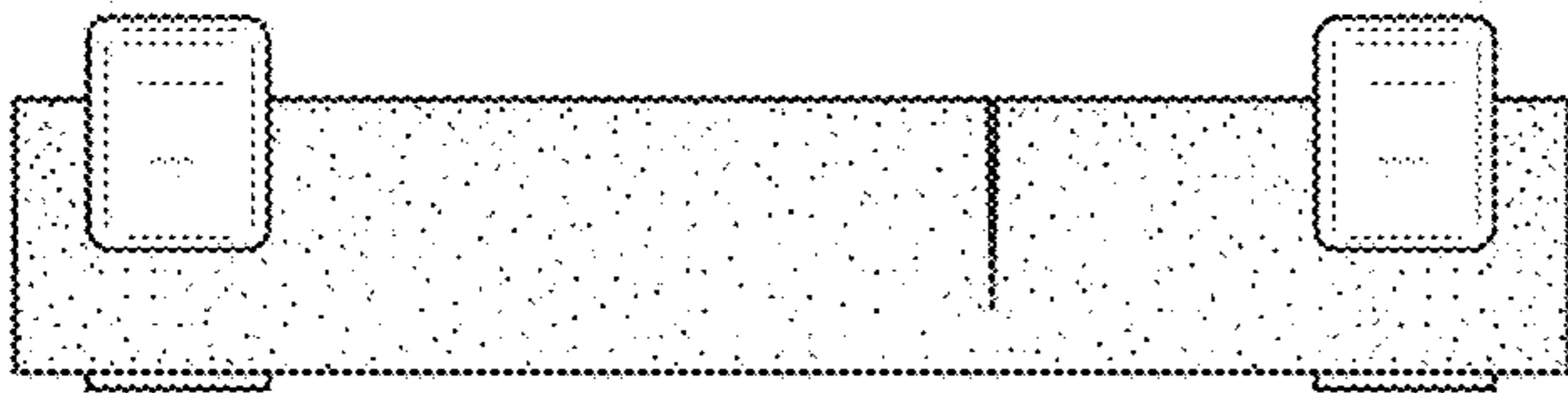

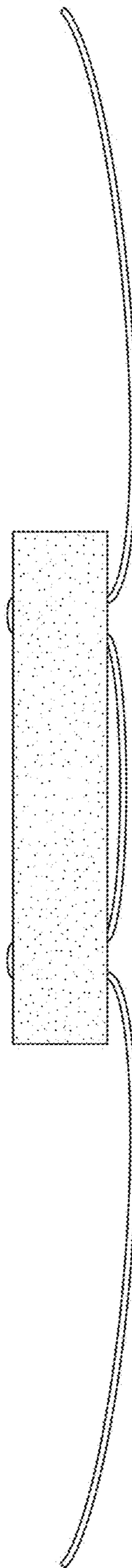
