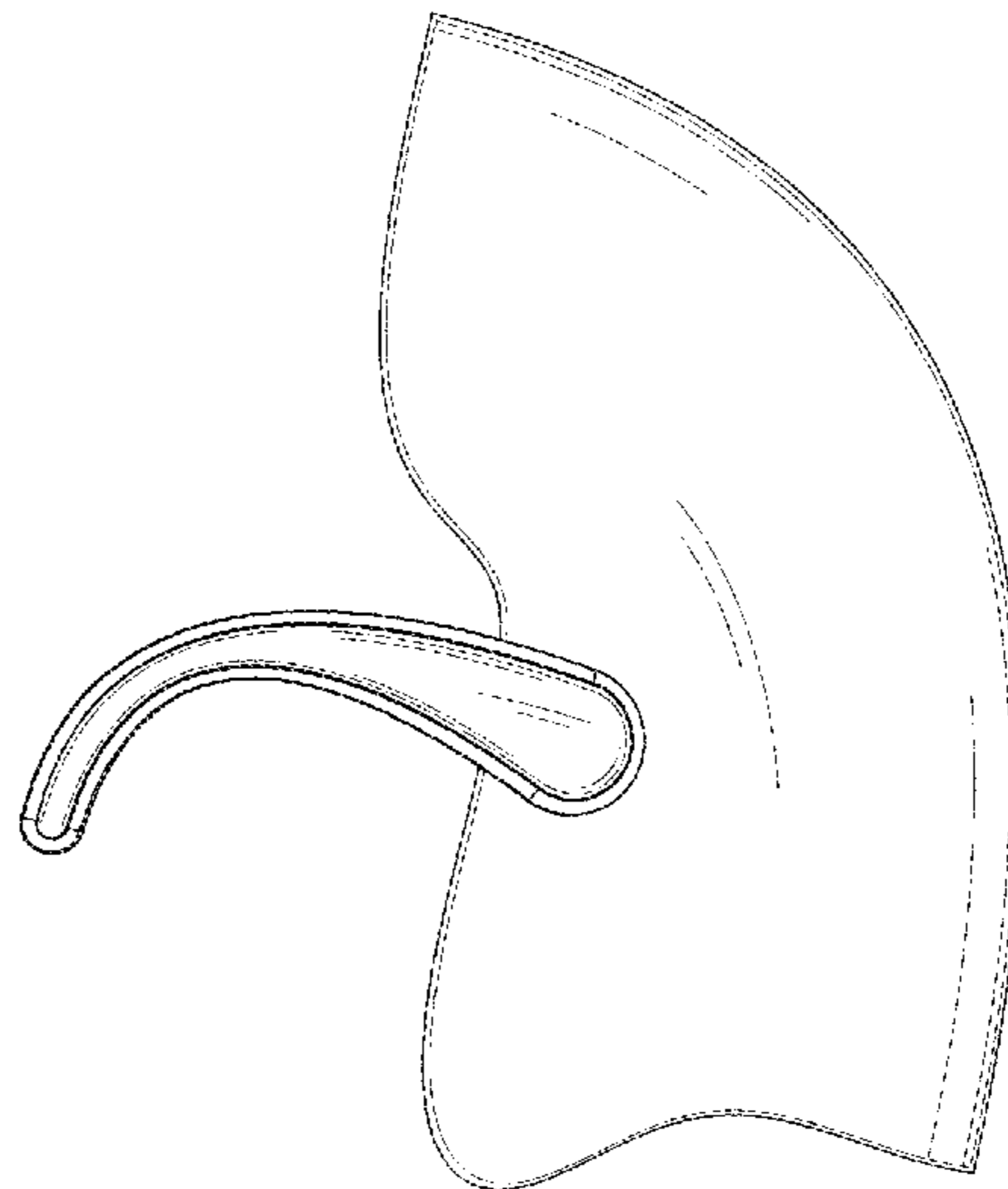
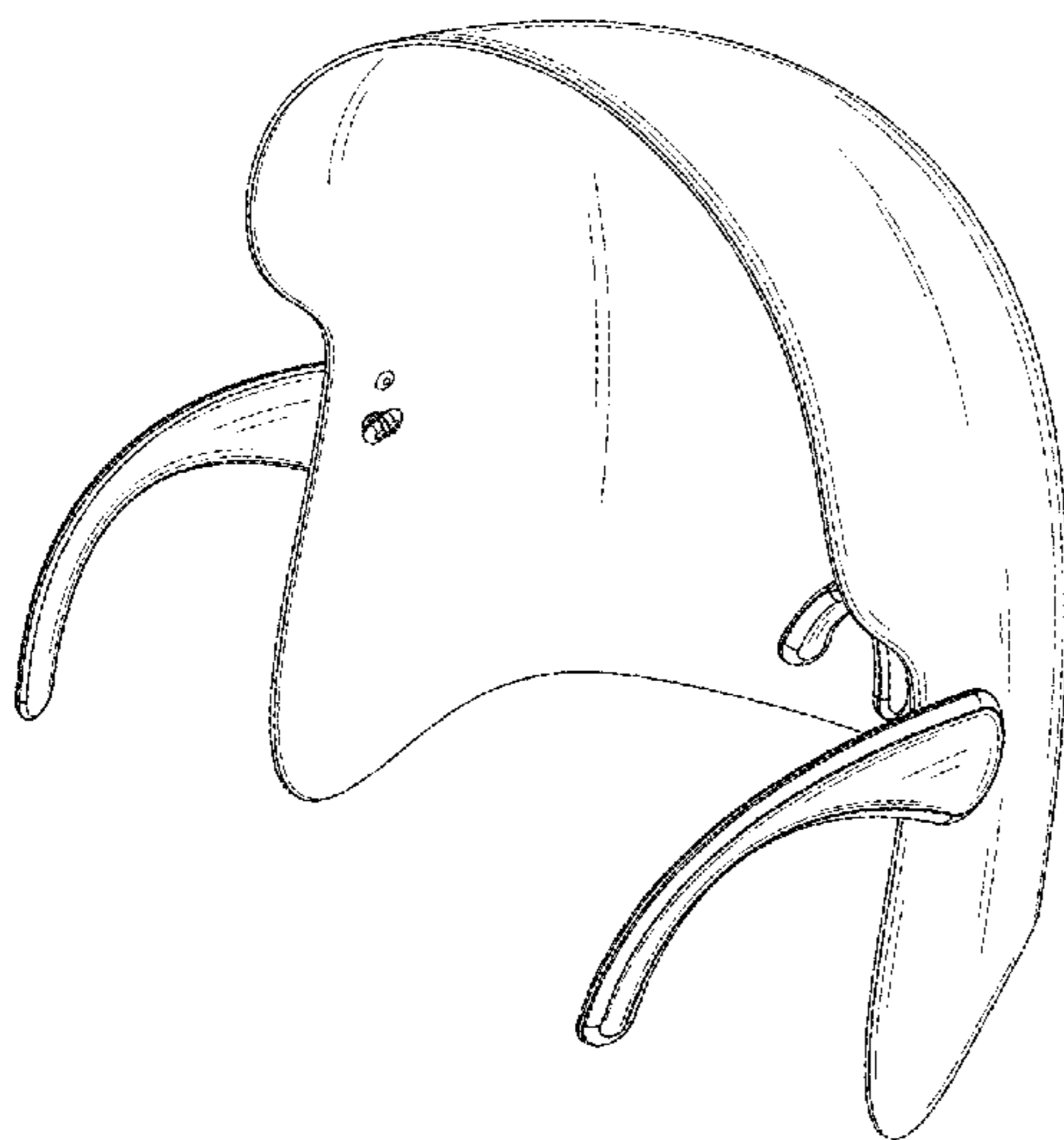
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a rear perspective view of a sun shield showing my new design;
FIG. 2 is a front view thereof;

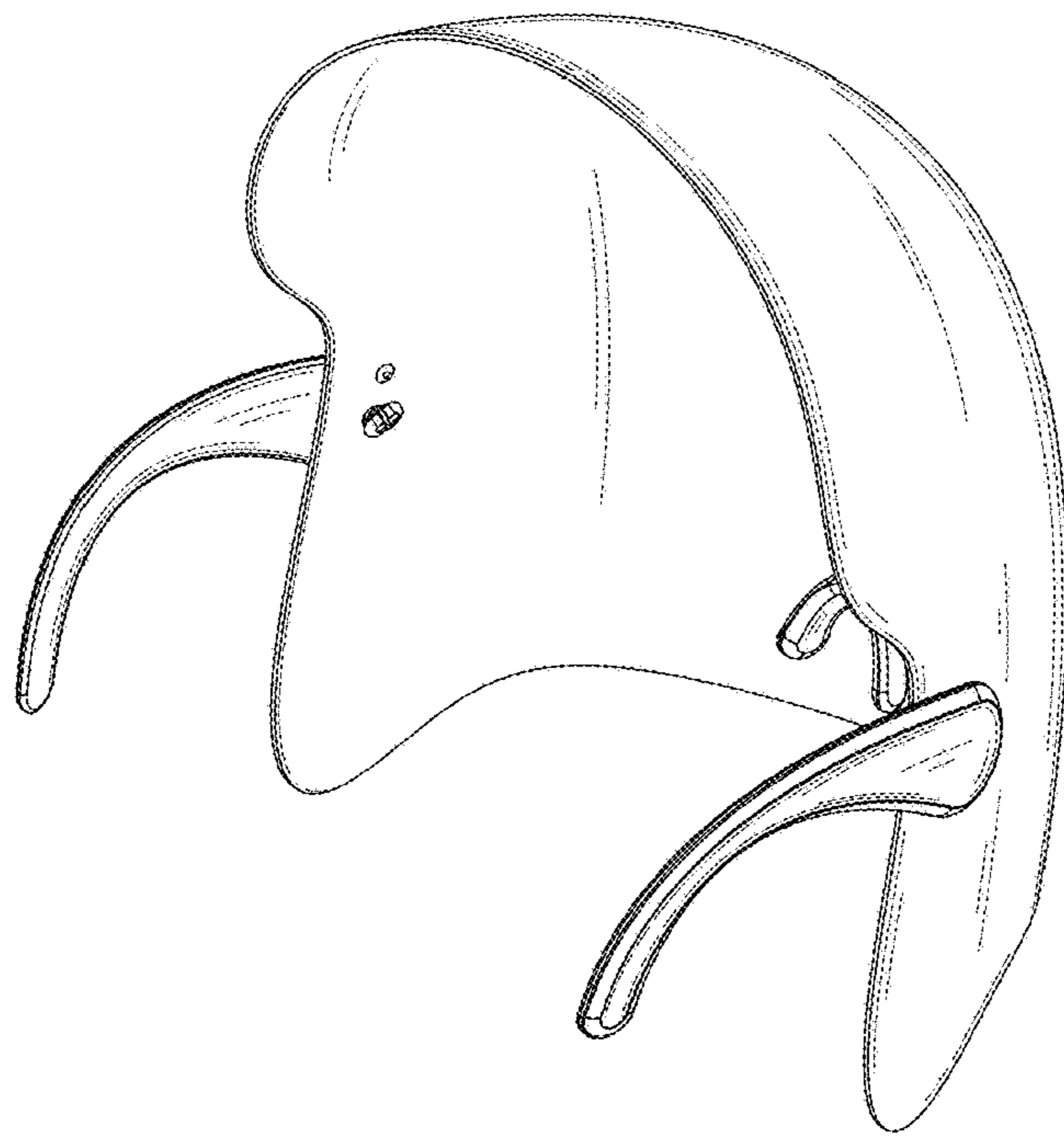

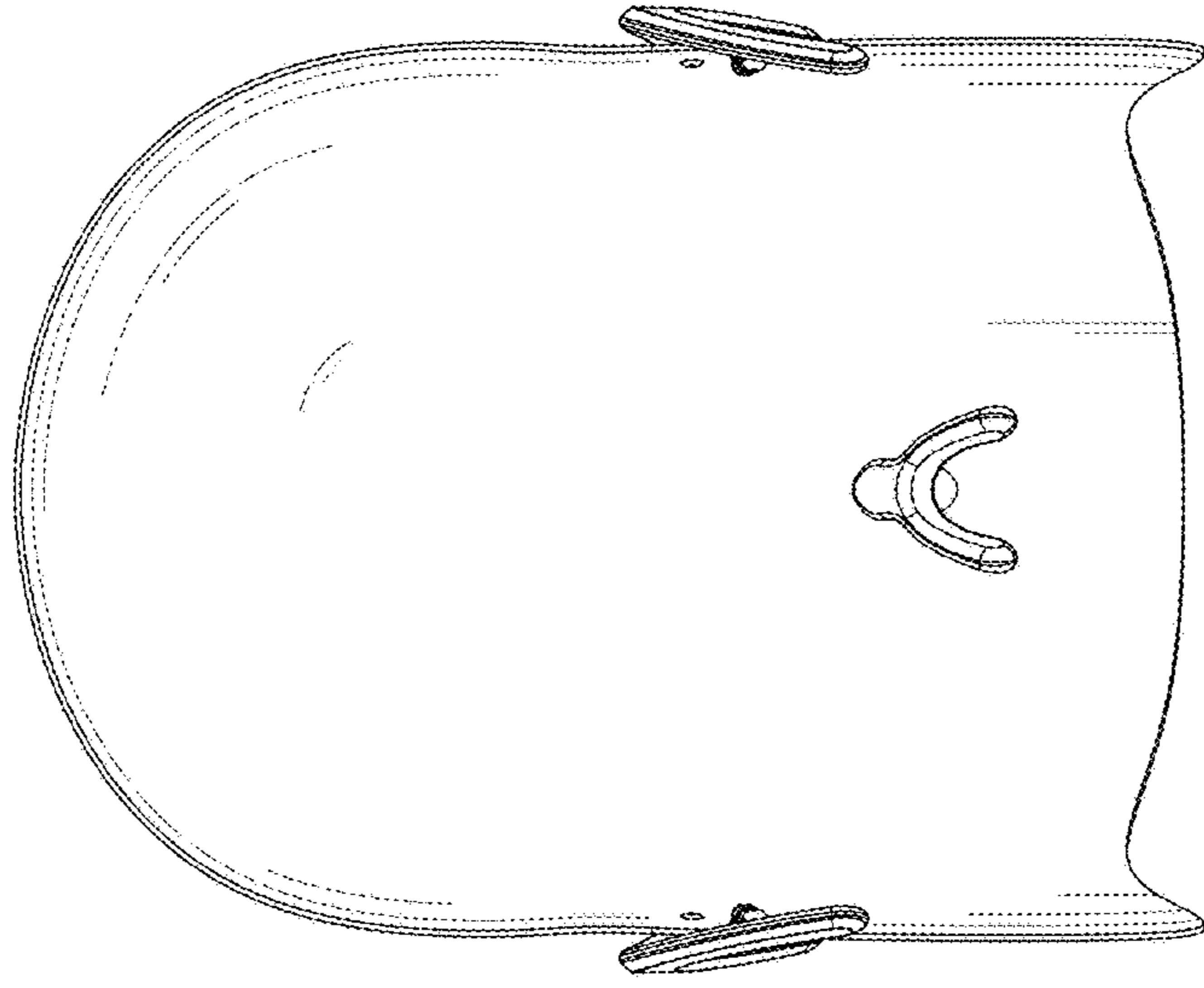

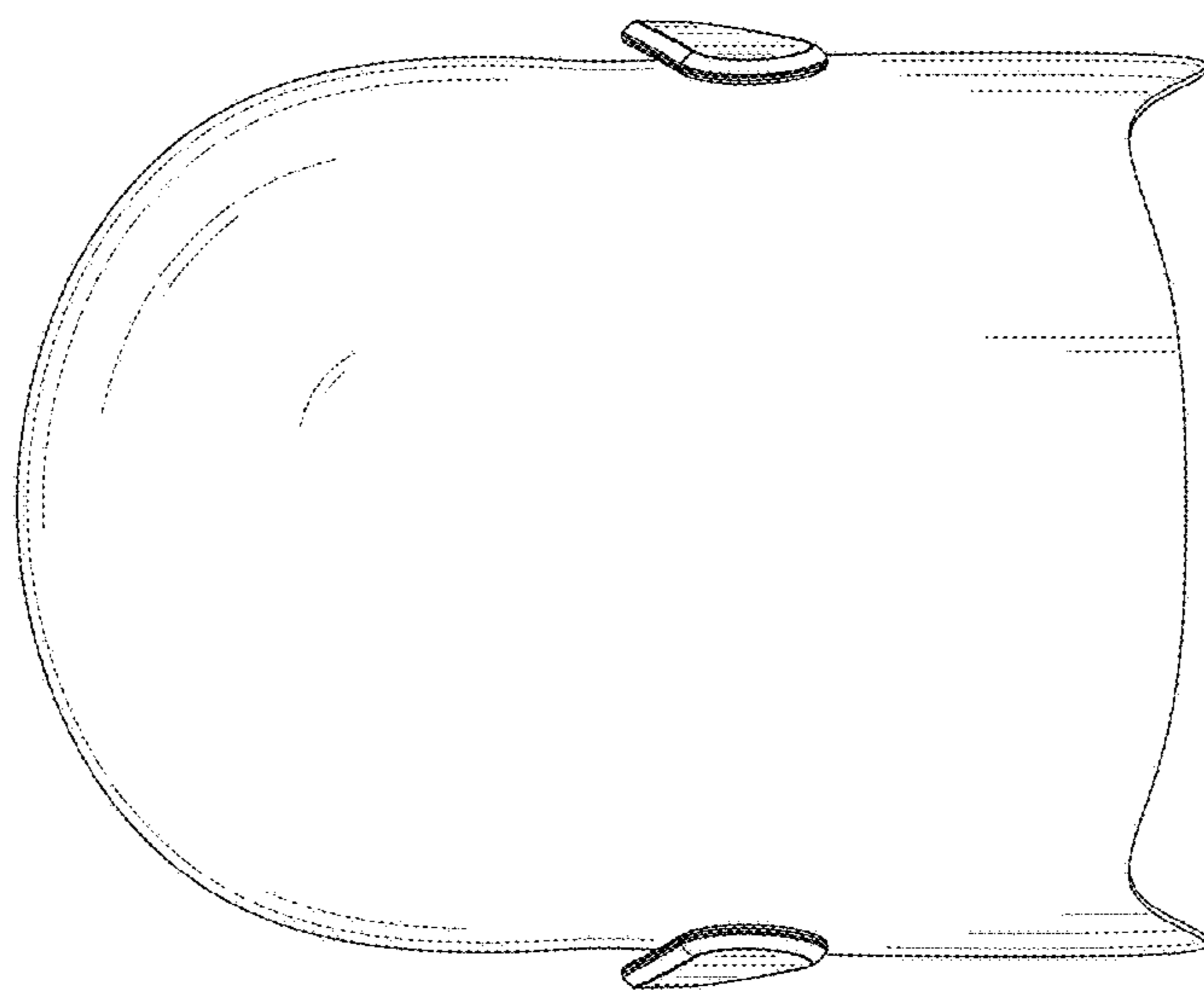

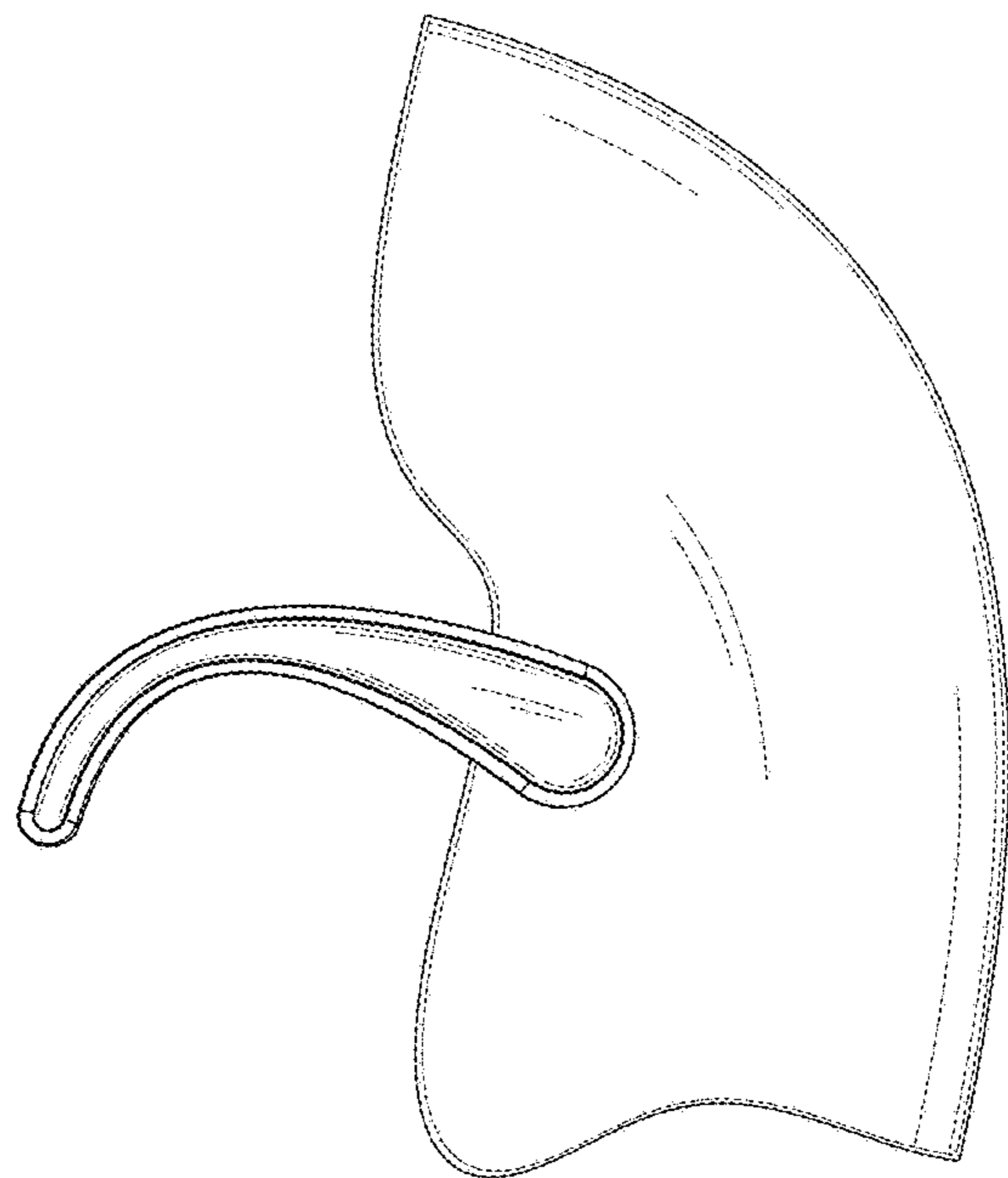

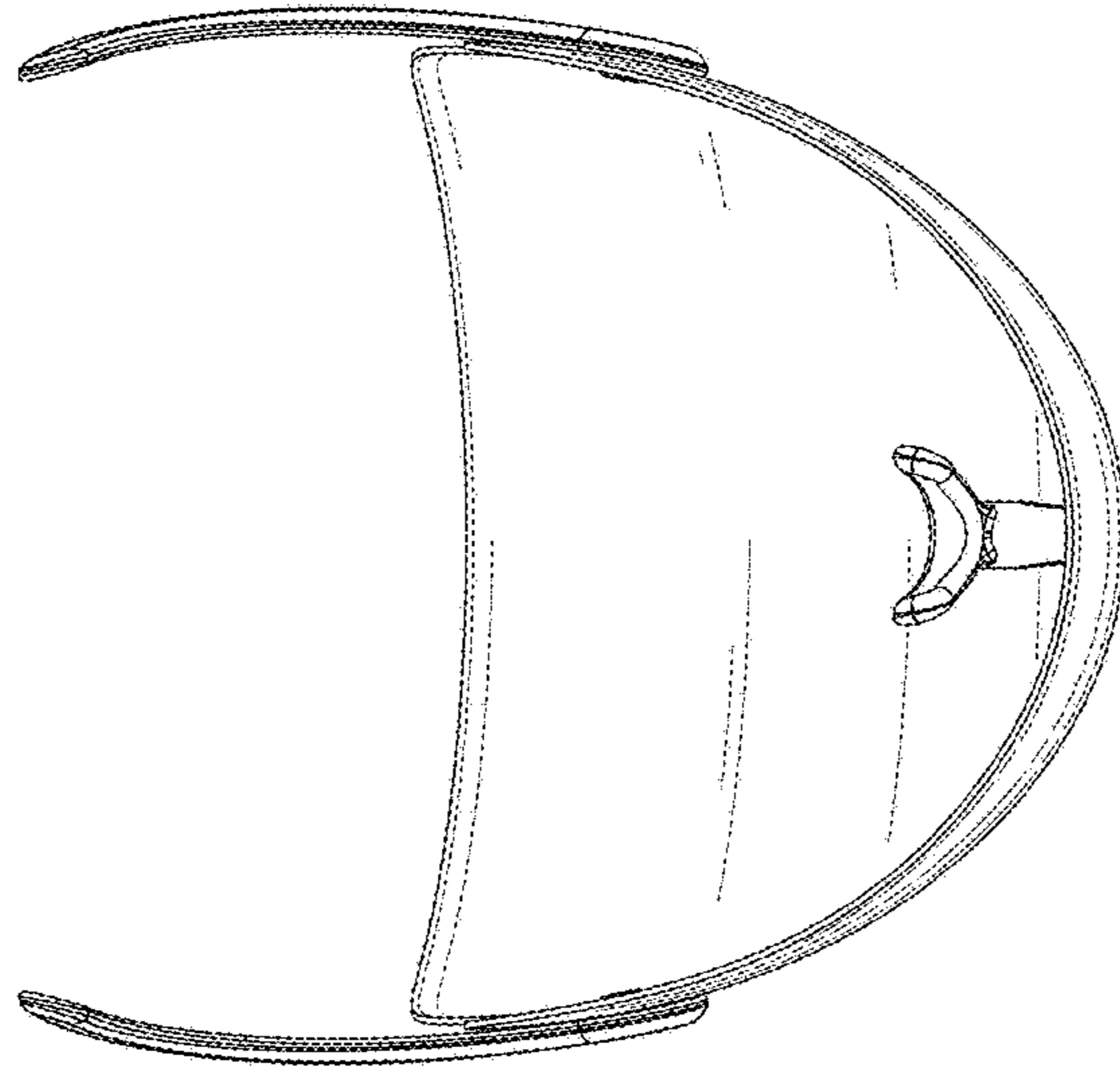

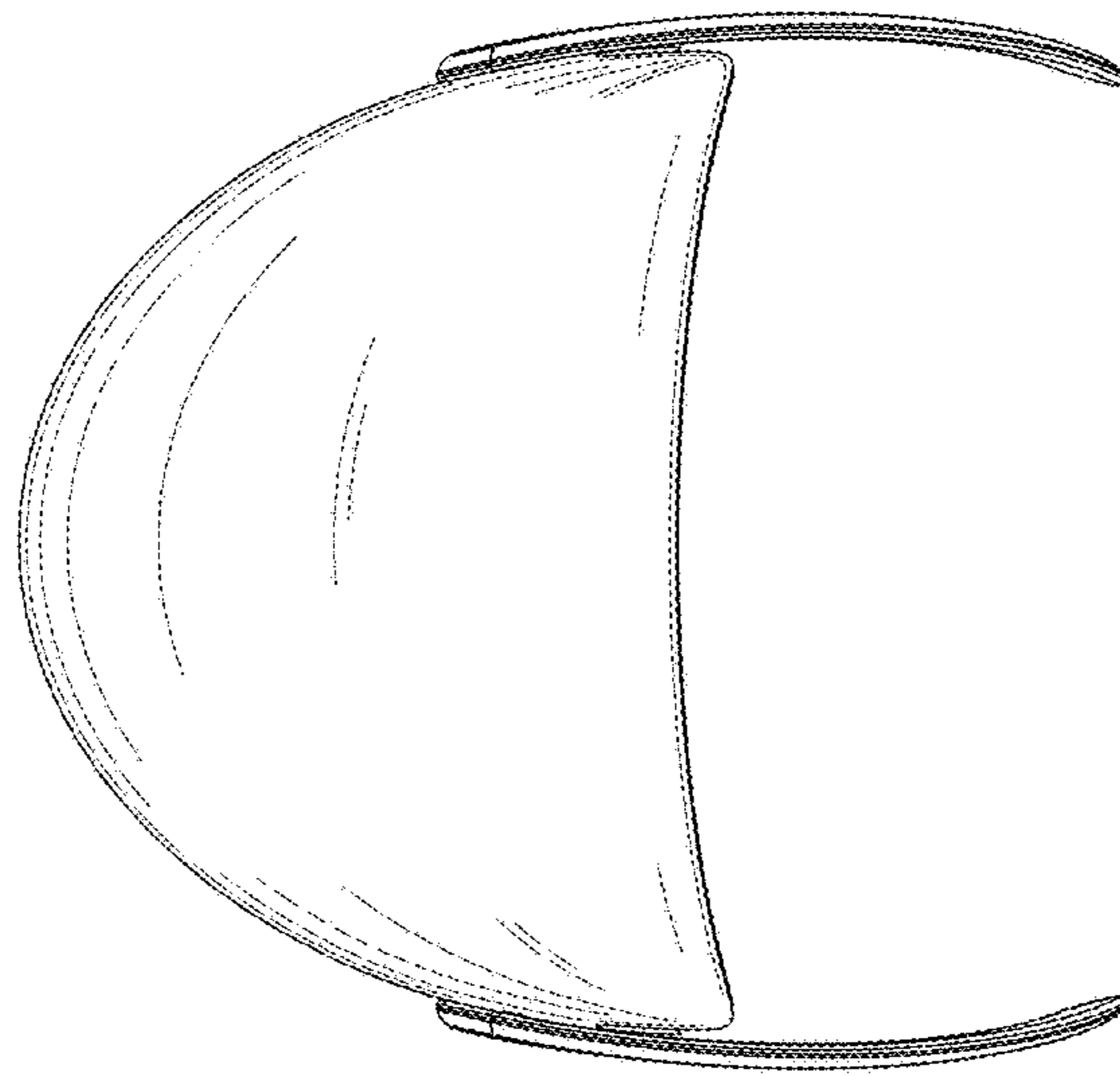

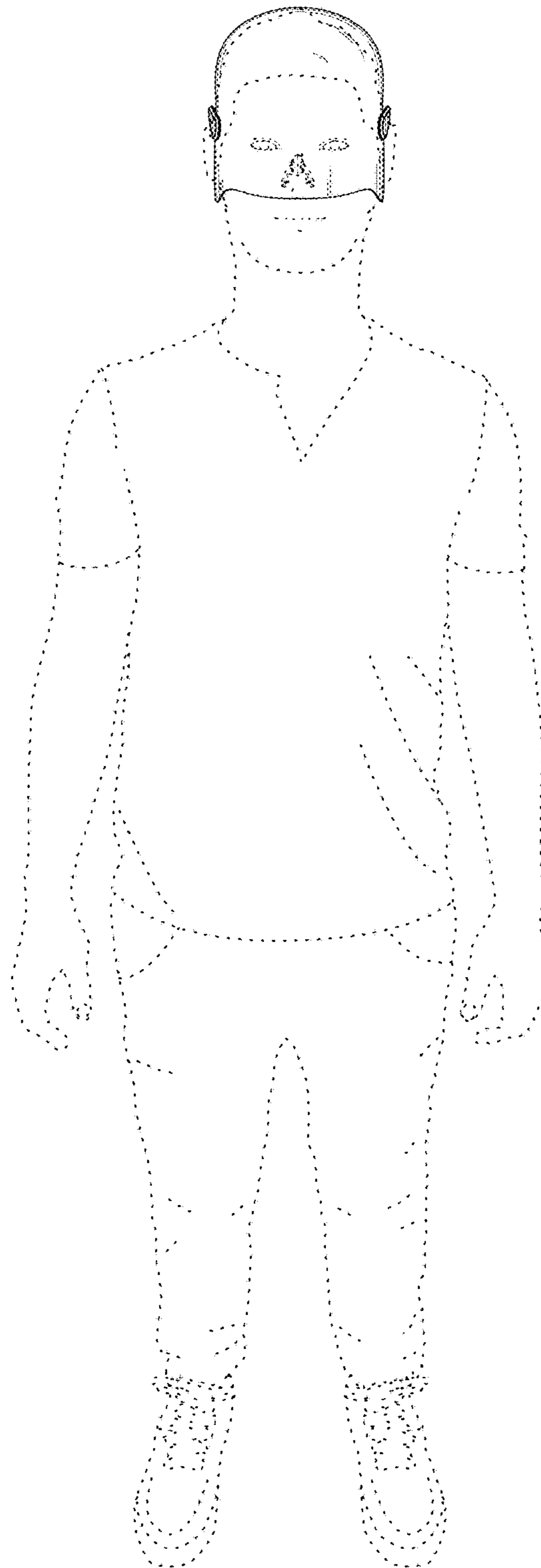
