(57) **CLAIM**

The ornamental design for zippered pants, as shown and described.

DESCRIPTION

FIG. 1 is a right side elevation view of zippered pants embodying the claimed design.

FIG. 2 is a left side elevation view of zippered pants embodying the claimed design.

FIG. 3 is a front elevation view of zippered pants embodying the claimed design.

FIG. 4 is a rear elevation view of zippered pants embodying the claimed design.

FIG. 5 is a right side elevation view of zippered pants embodying the claimed design in an alternative configuration, showing the zipper fully unzipped; the left side being a mirror image.

FIG. 6 is a right side elevation view of zippered pants embodying the claimed design in an alternative configuration, showing the zipper partially unzipped; the left side being a mirror image.

FIG. 7 is an enlarged view of the zipper flap as indicated in FIG. 6.

FIG. 8 is an enlarged view of the zipper flap indicated in FIG. 6, shown in the open position; and,

FIG. 9 is a front perspective view of zippered pants embodying the claimed design.

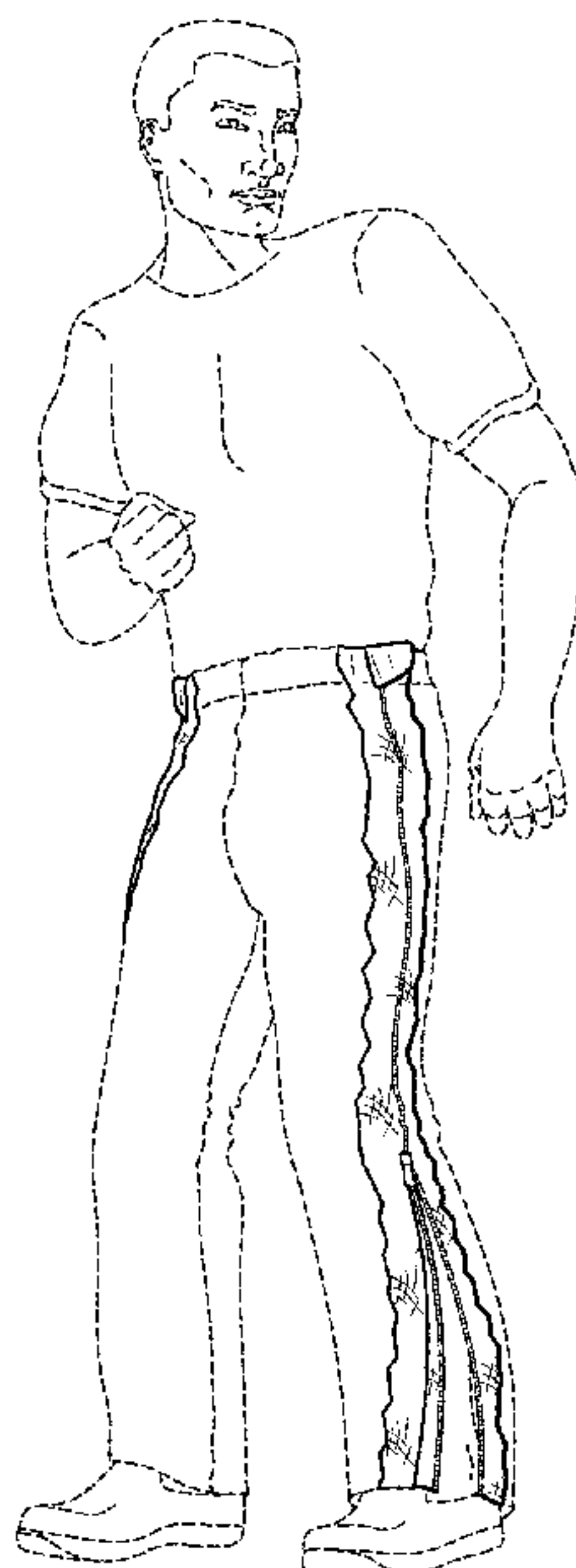

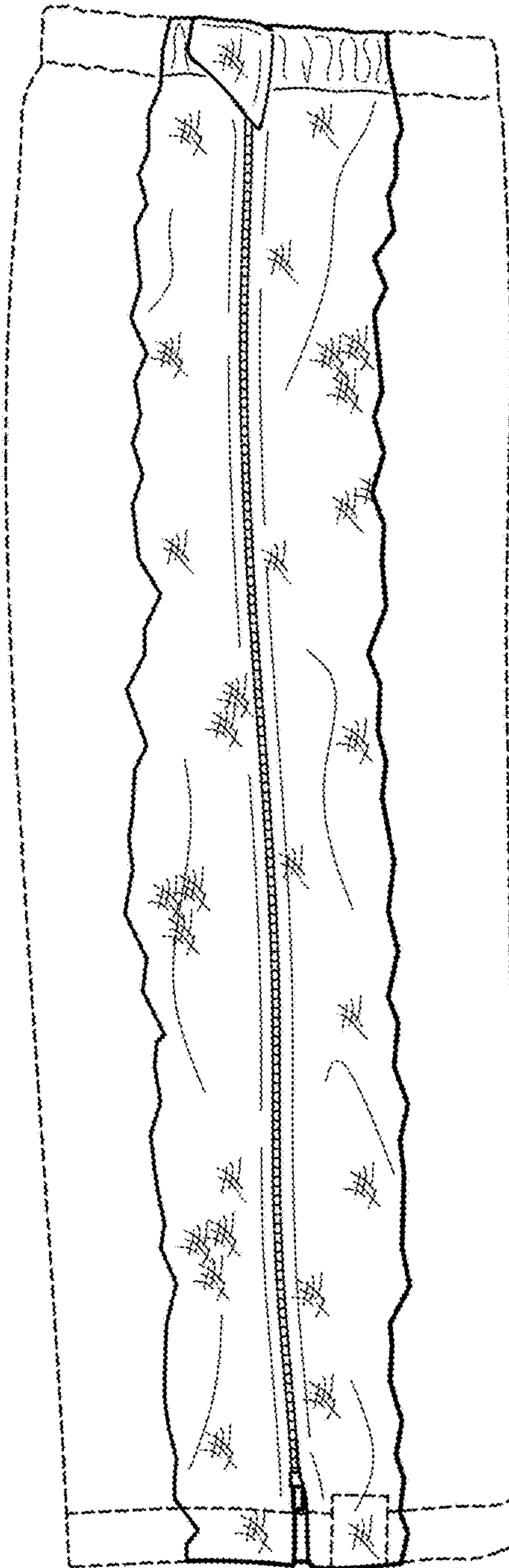

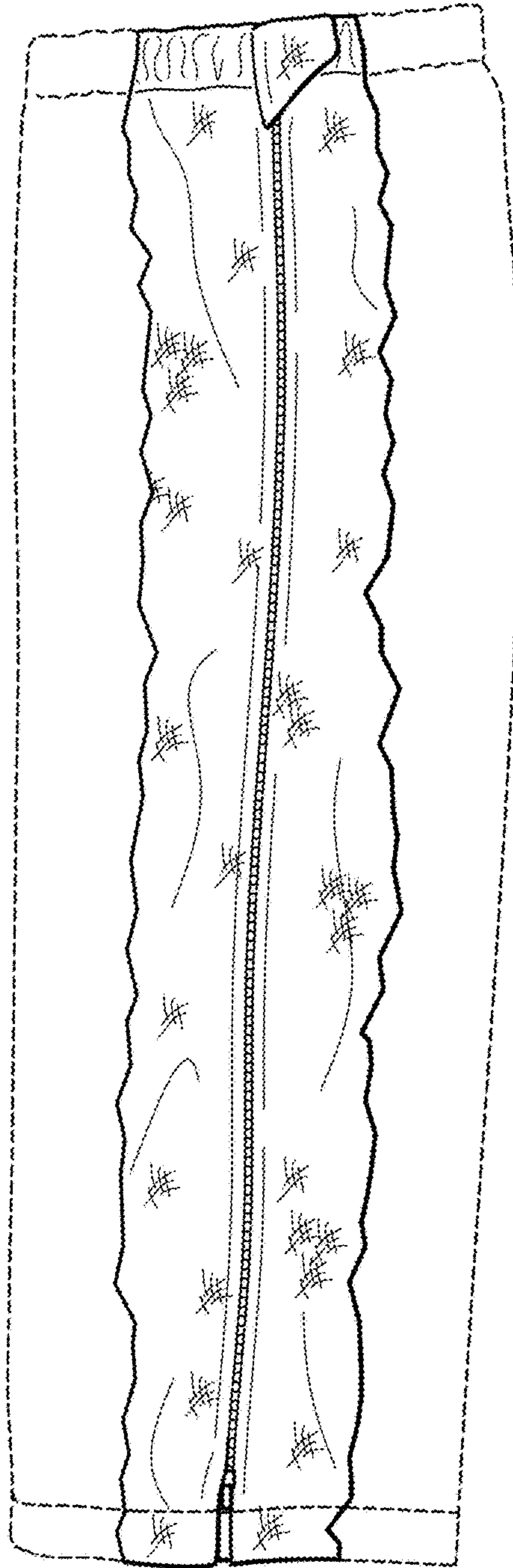

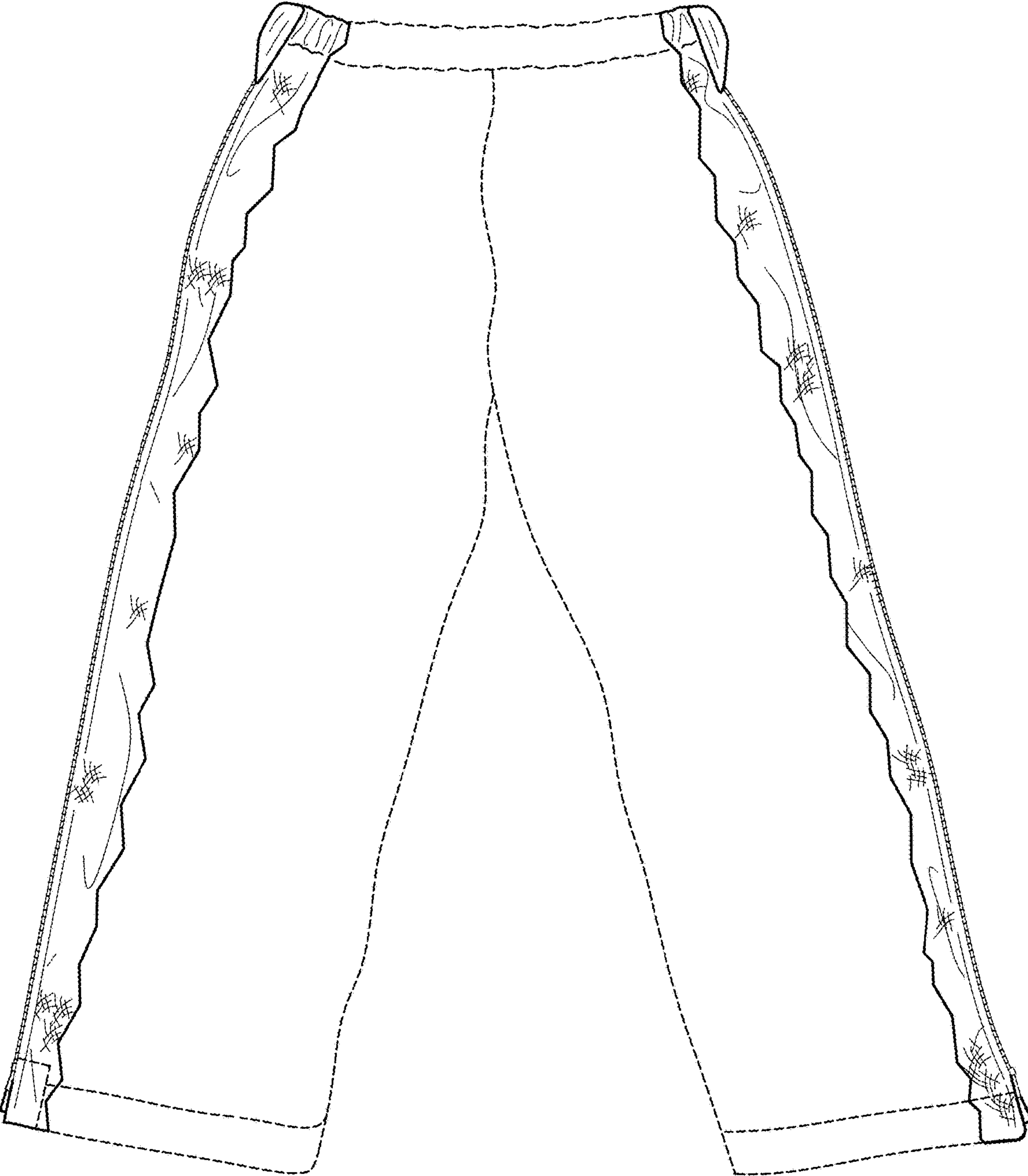

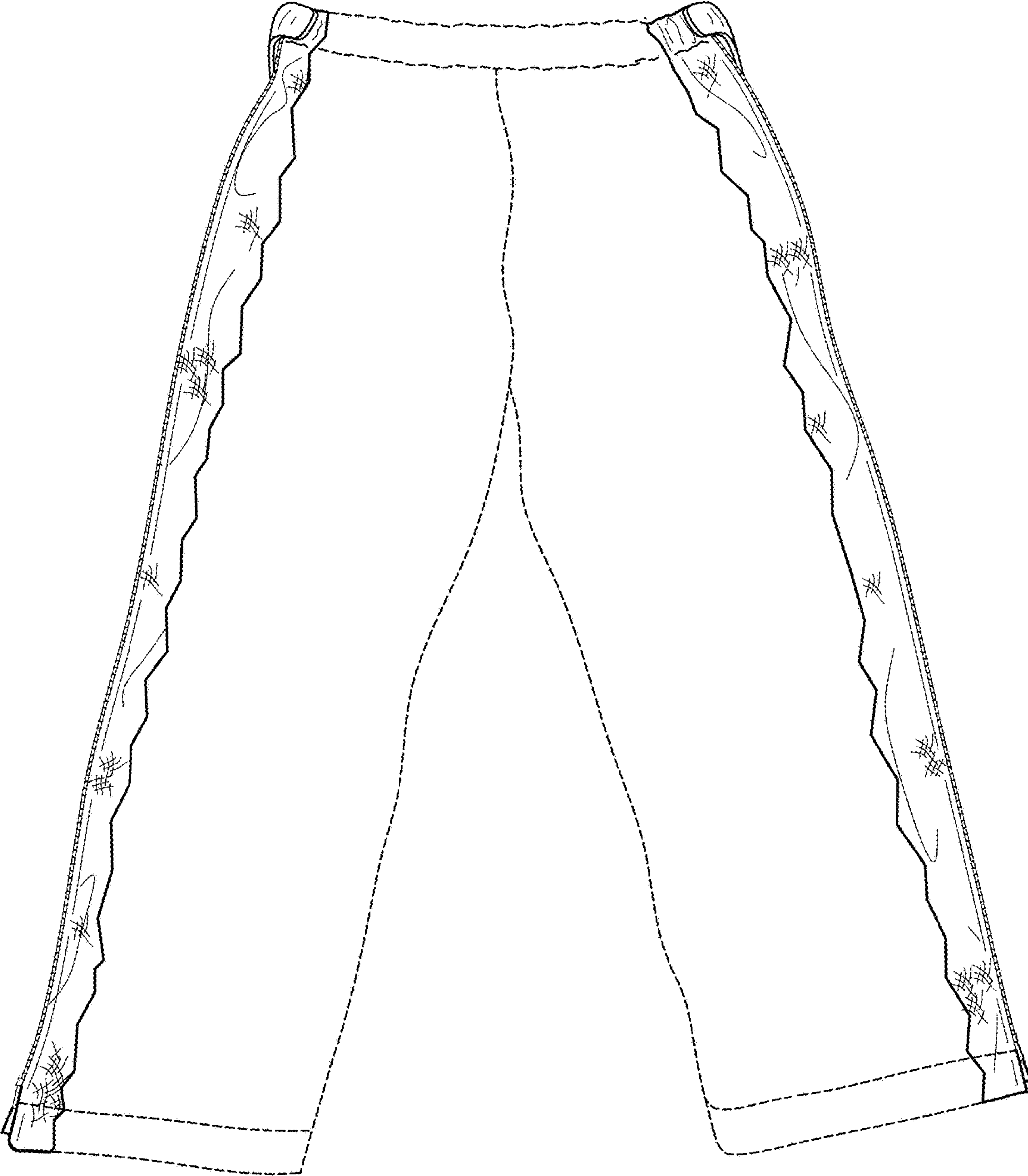

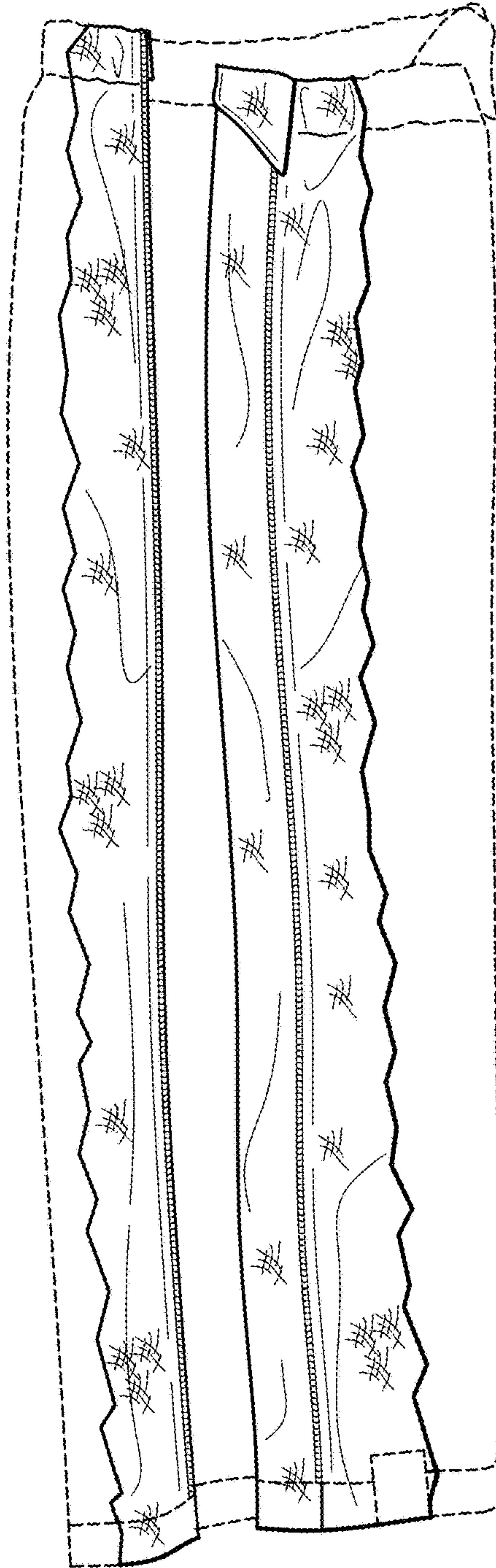

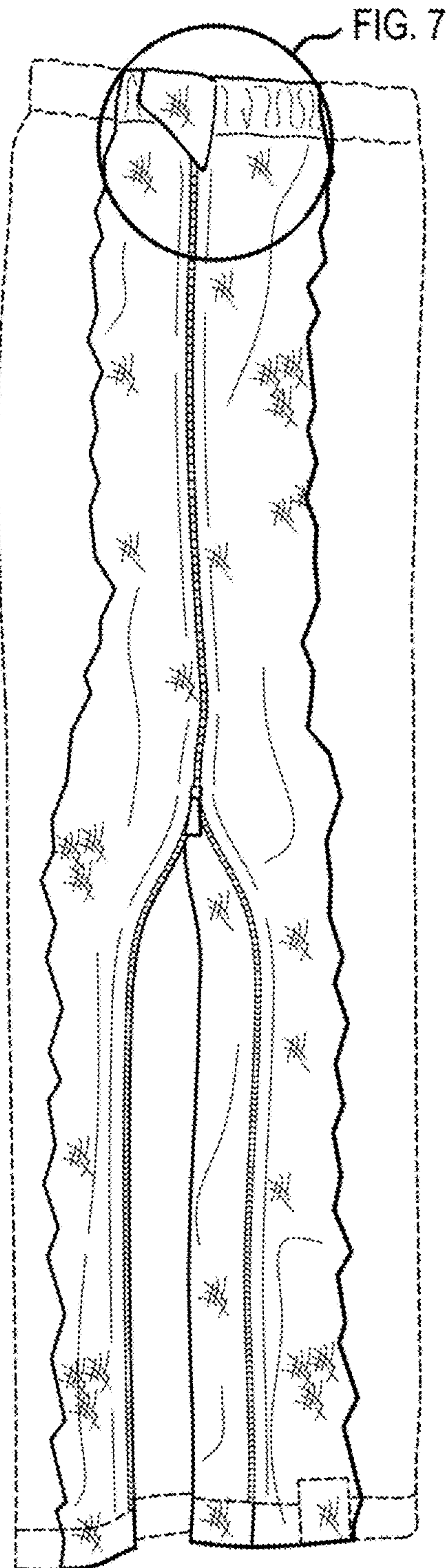

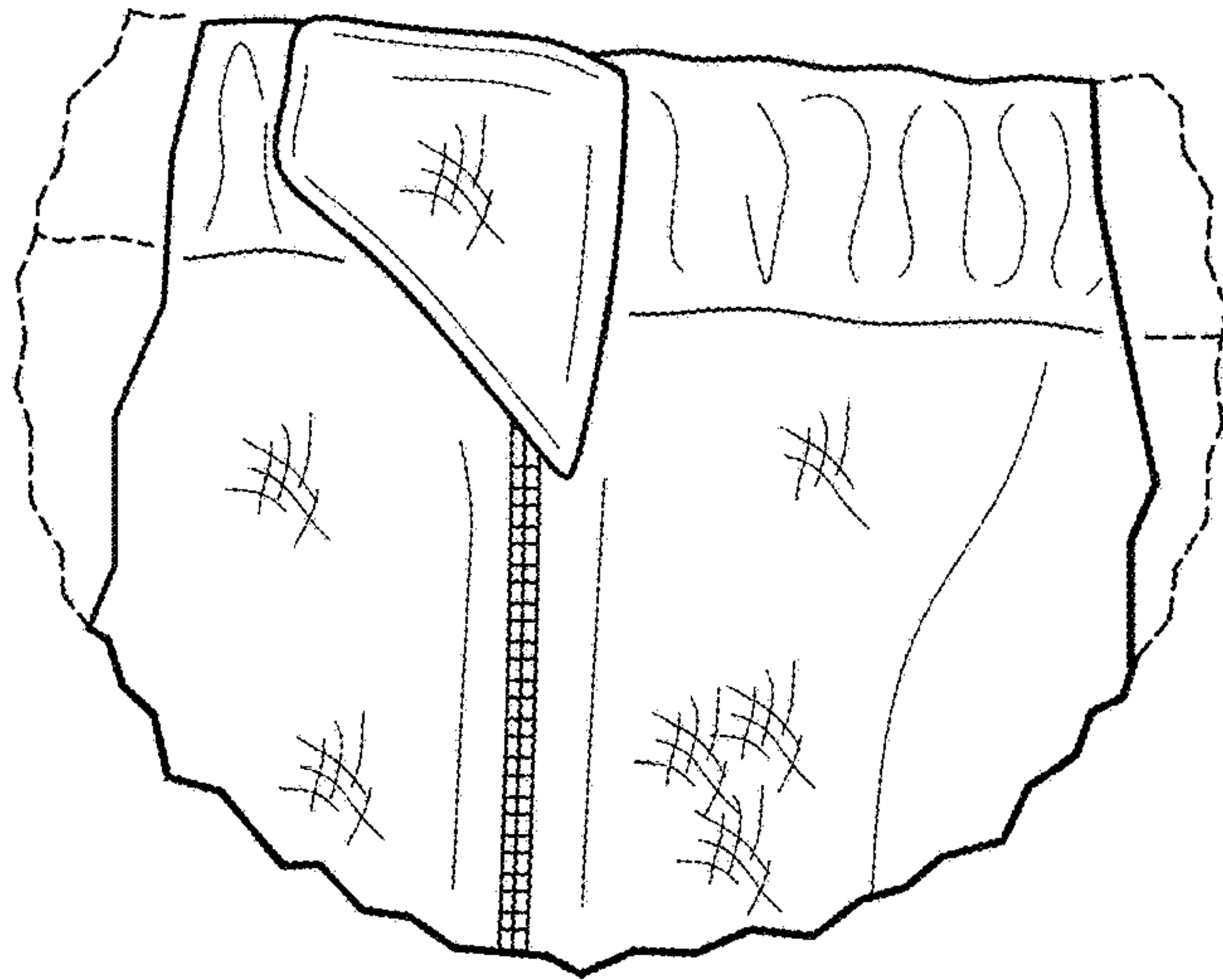

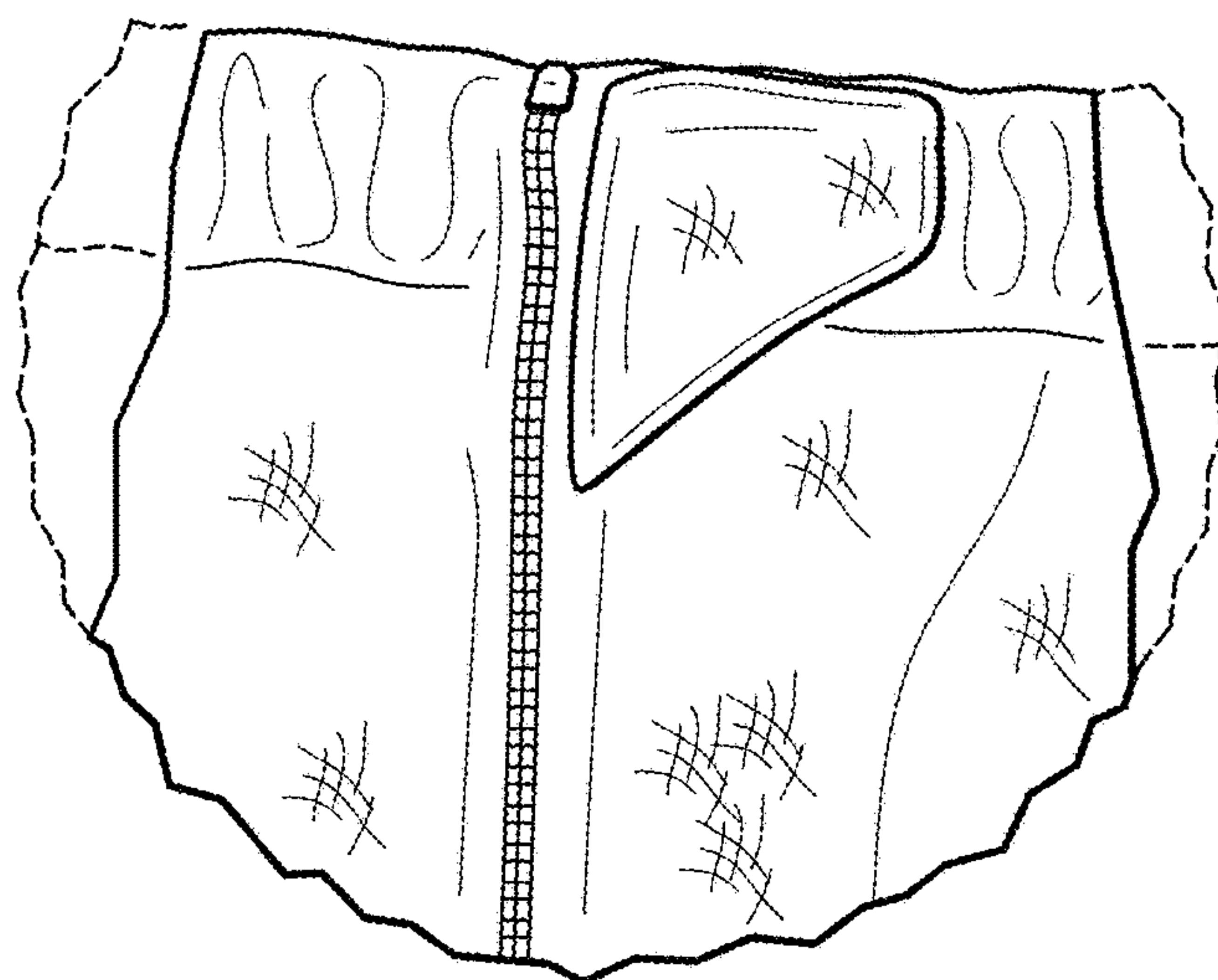
