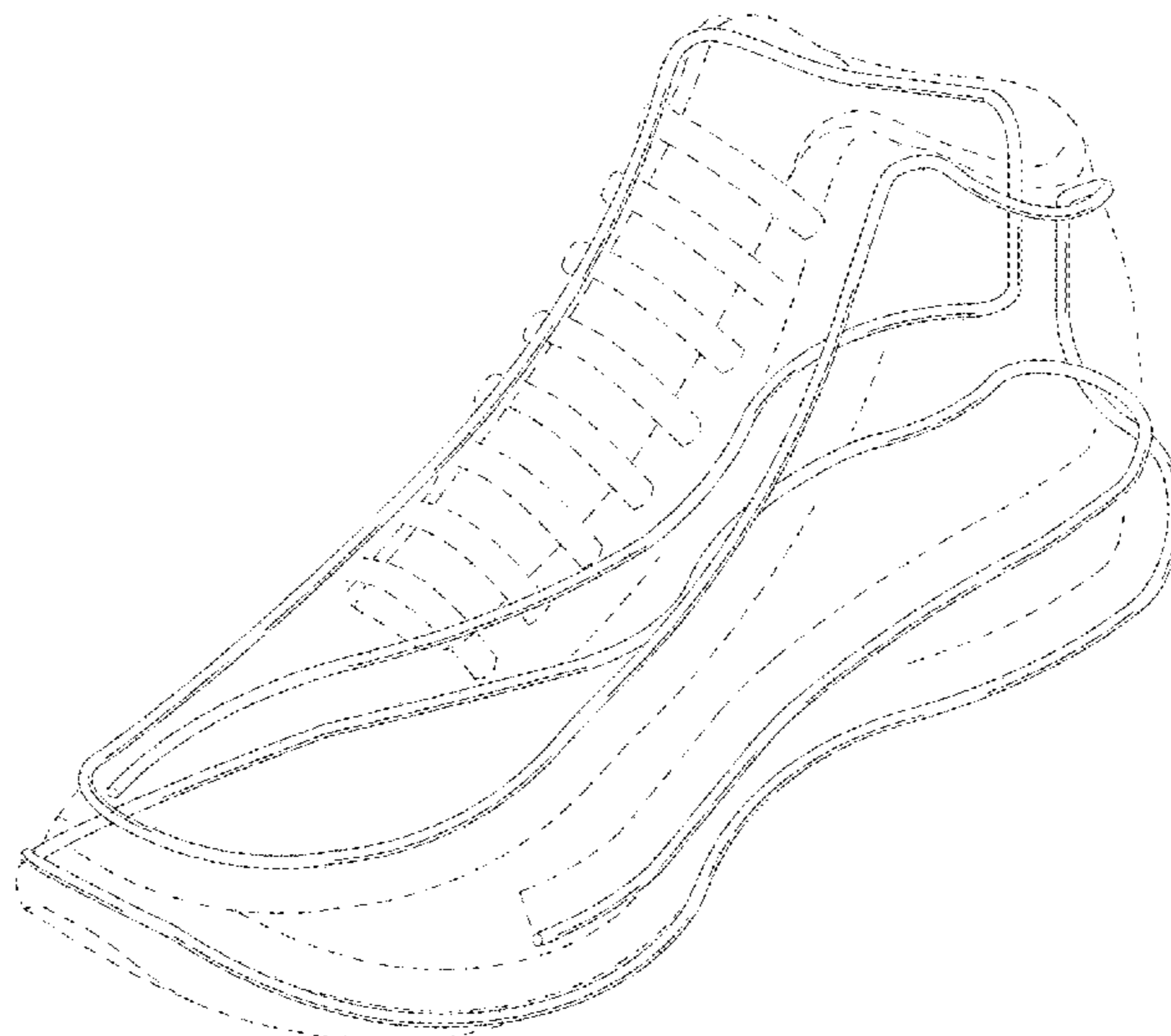
(57) **CLAIM**

The ornamental design for a surface ornamentation for shoes, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the surface ornamentation for shoes showing my new design;  
FIG. 2 is a right side elevation view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a left side elevation view thereof;

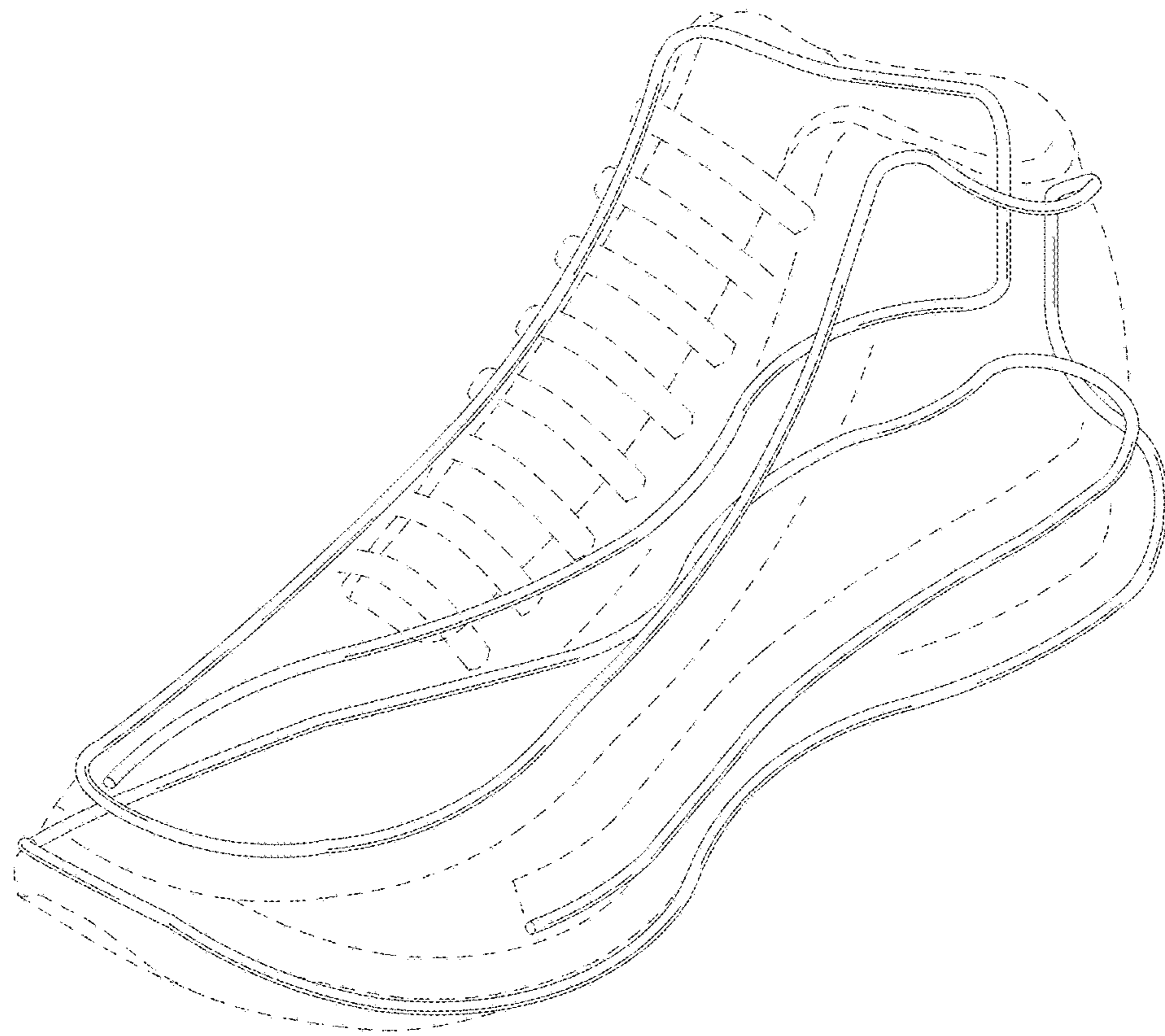

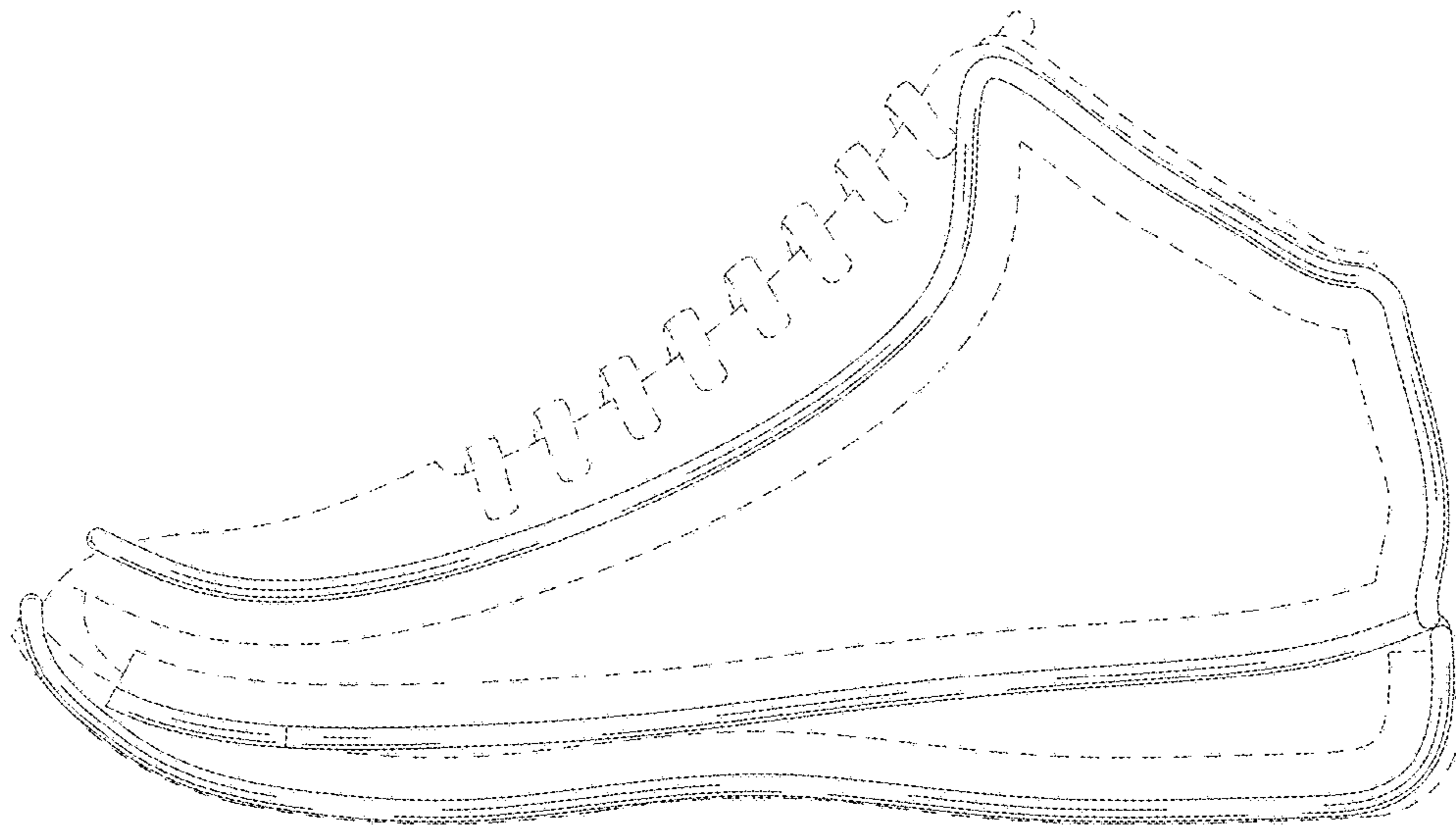

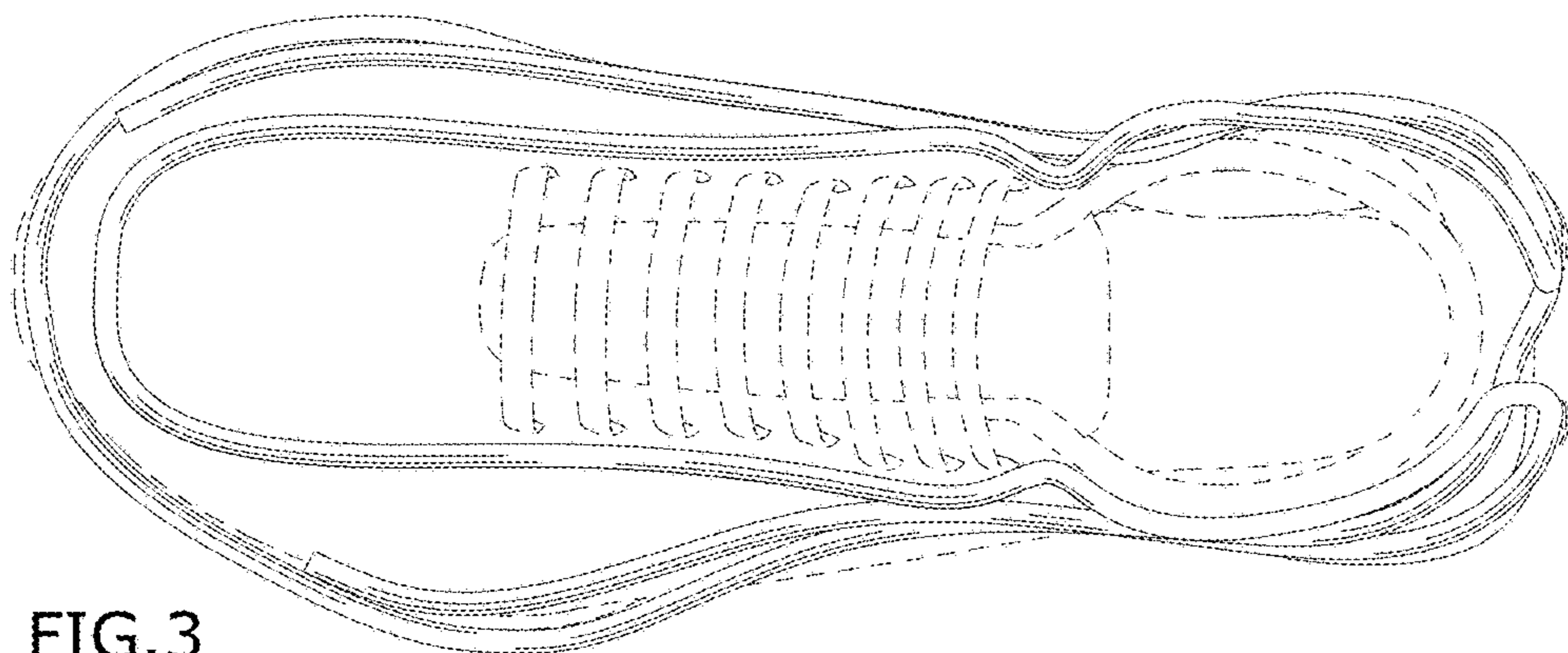

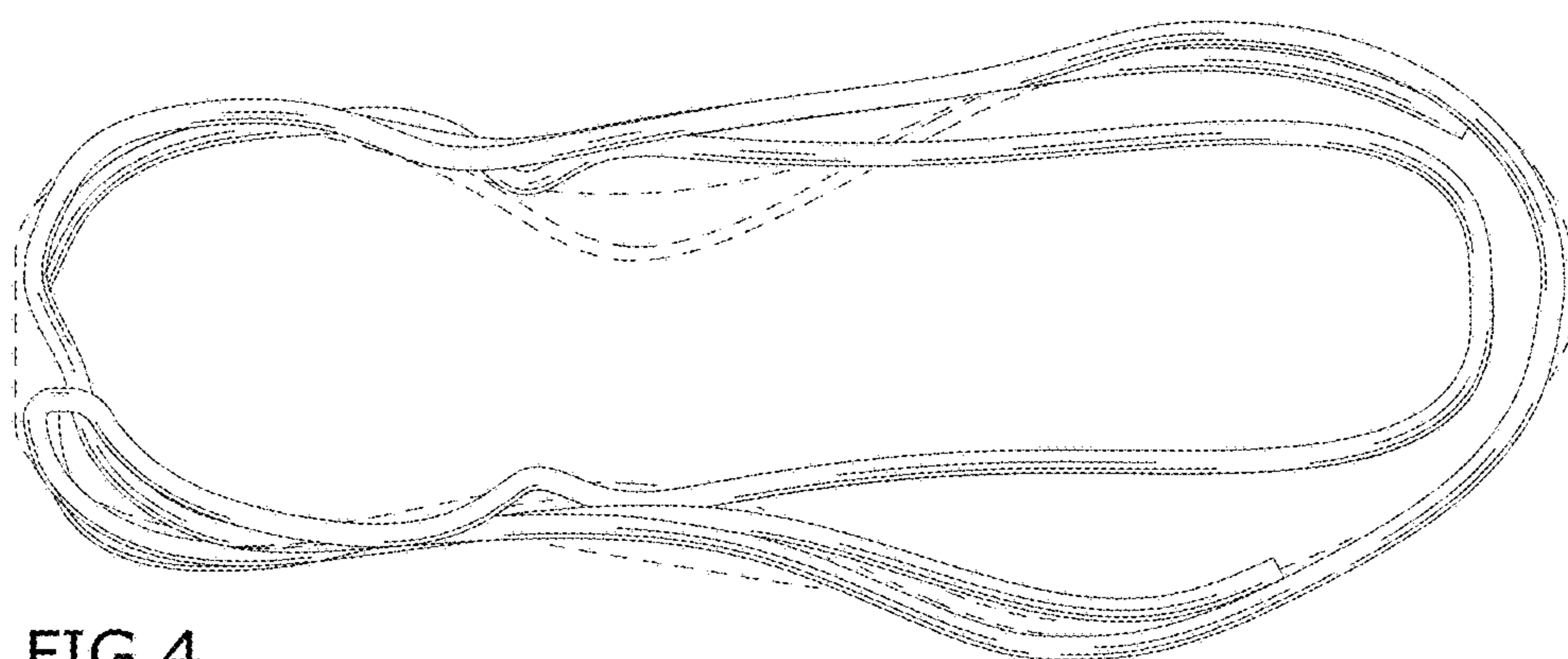

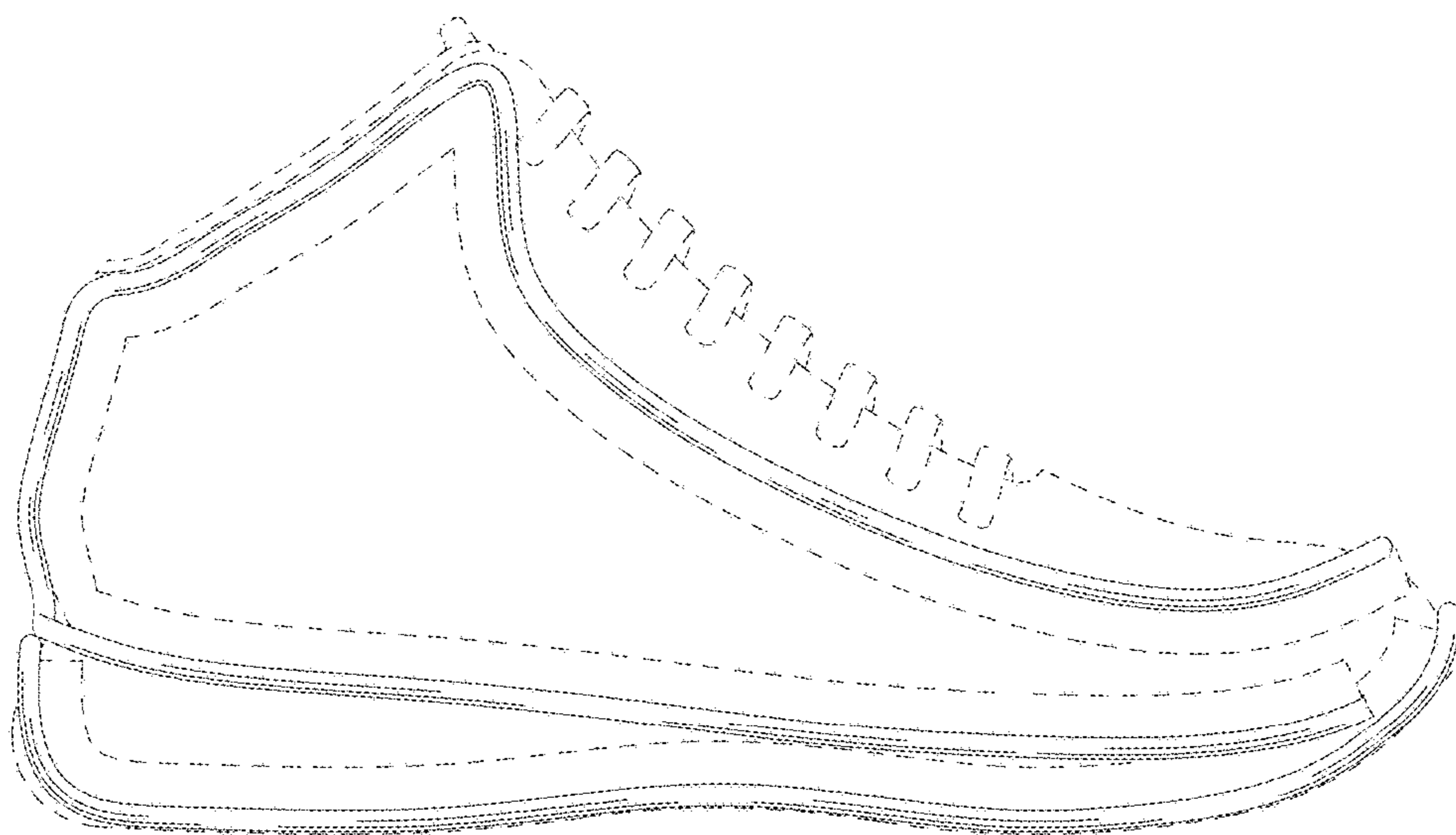

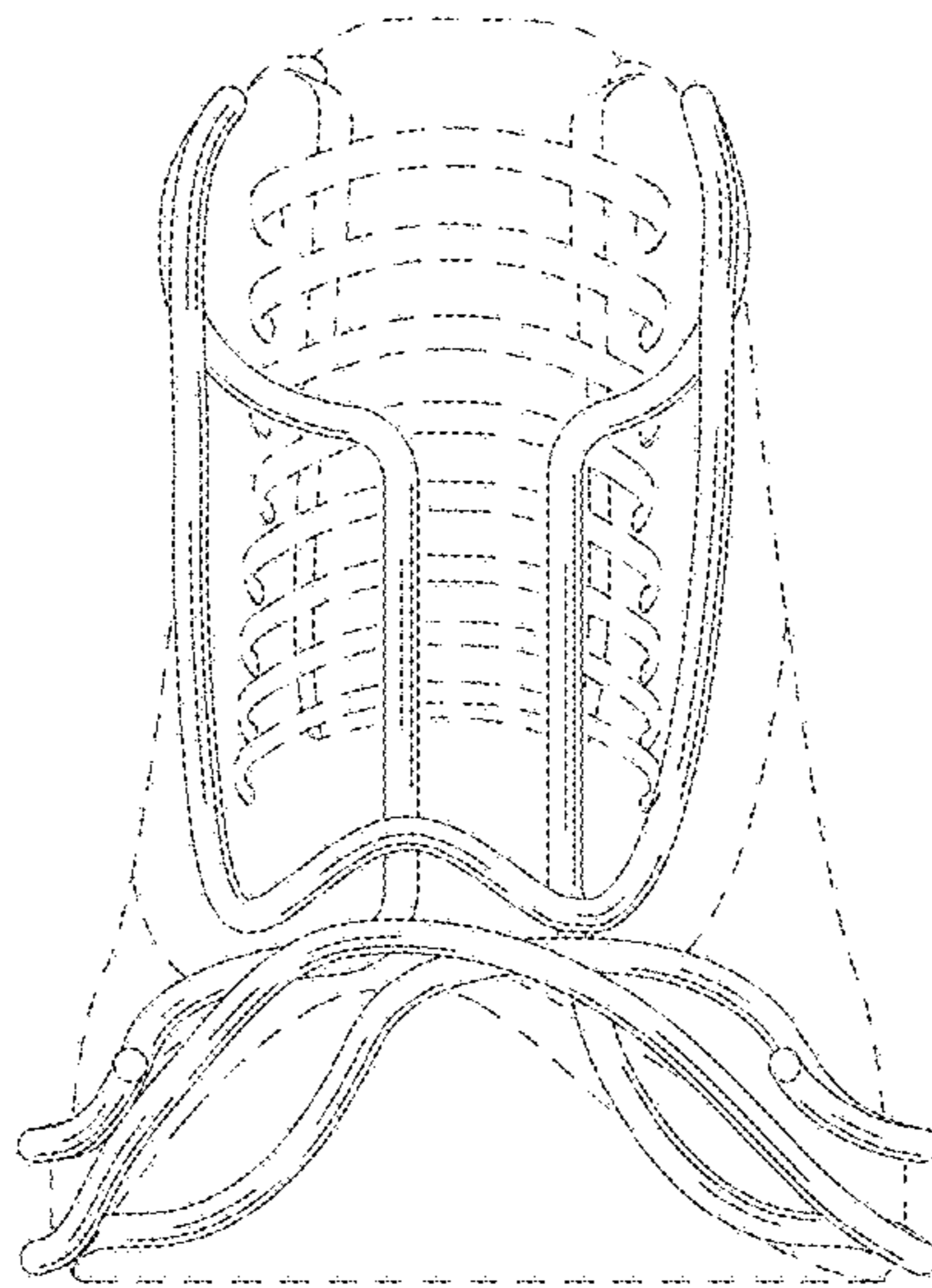

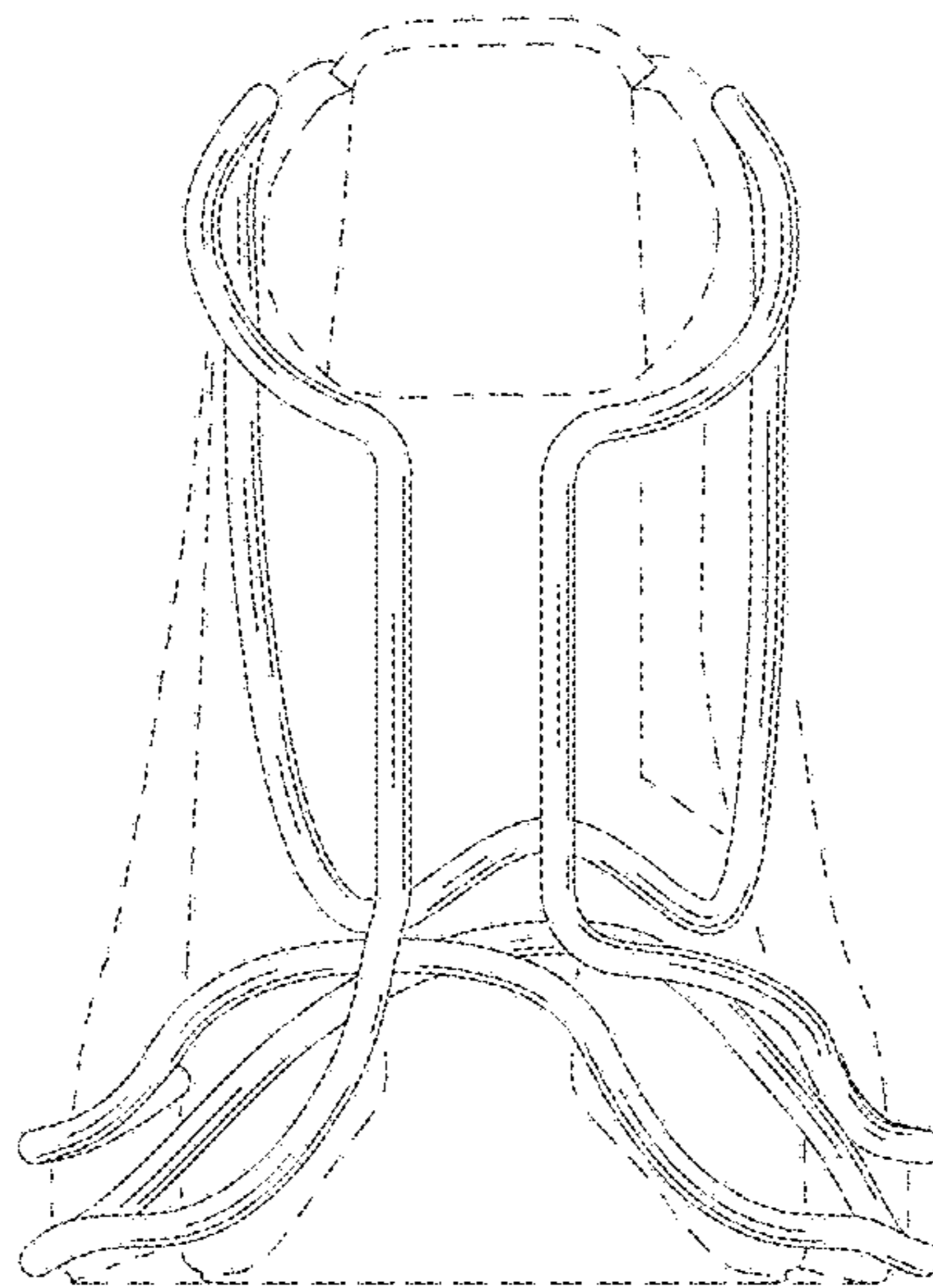
