(57) **CLAIM**

We claim the ornamental design for a clip accessory for a wearable fitness monitor, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a clip accessory for a wearable fitness monitor.

FIG. 2 is a back view of the clip accessory of FIG. 1.

FIG. 3 is a front view of the clip accessory of FIG. 1.

FIG. 4 is a top view of the clip accessory of FIG. 1.

FIG. 5 is a bottom view of the clip accessory of FIG. 1.

FIG. 6 is a side view of the clip accessory of FIG. 1; the left and right side views are identical since the clip accessory is symmetric in this respect.

FIG. 7 is an off-angle view of the clip accessory of FIG. 1. FIG. 8 is a different off-angle view of the clip accessory of FIG. 1.

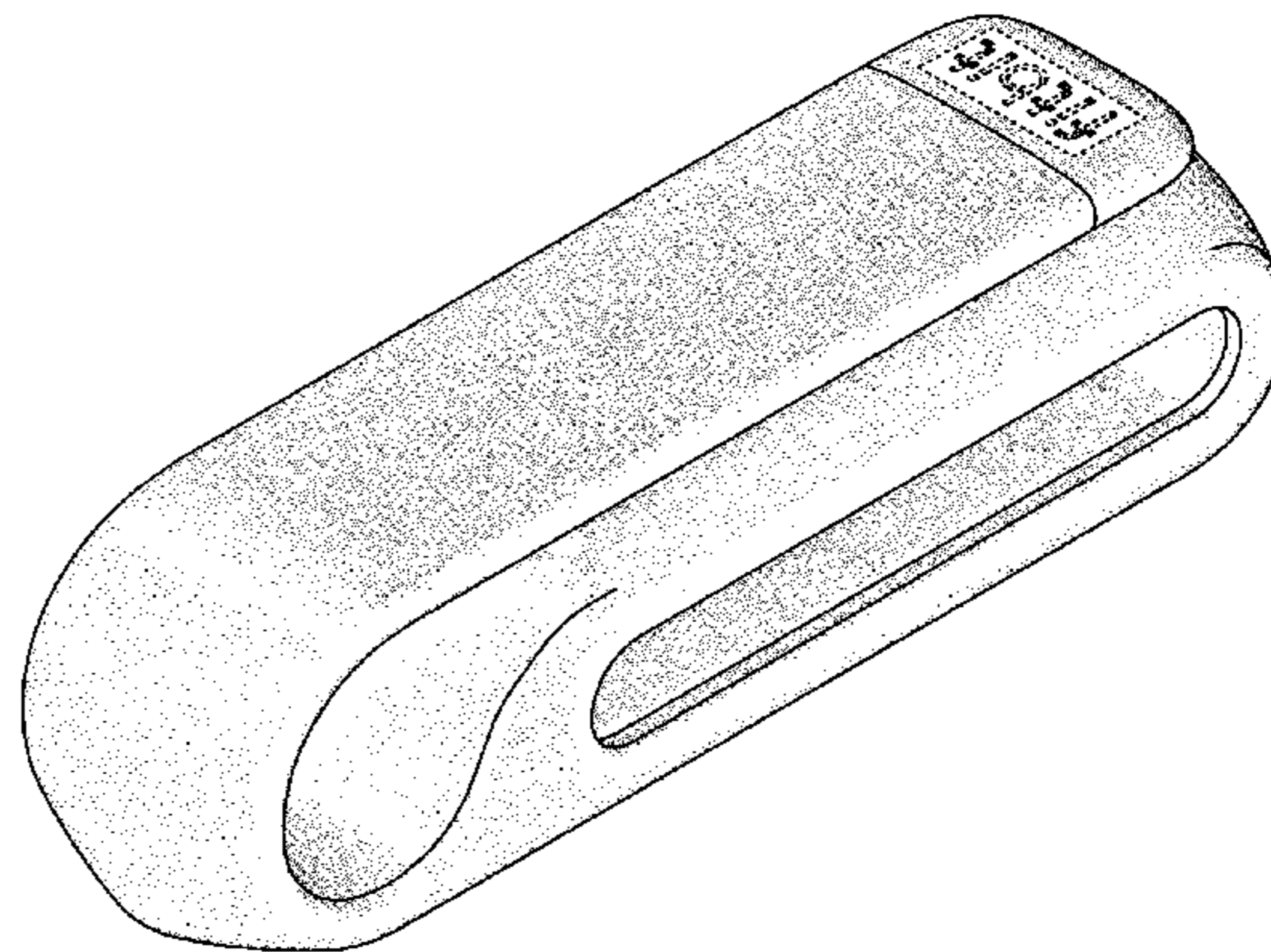
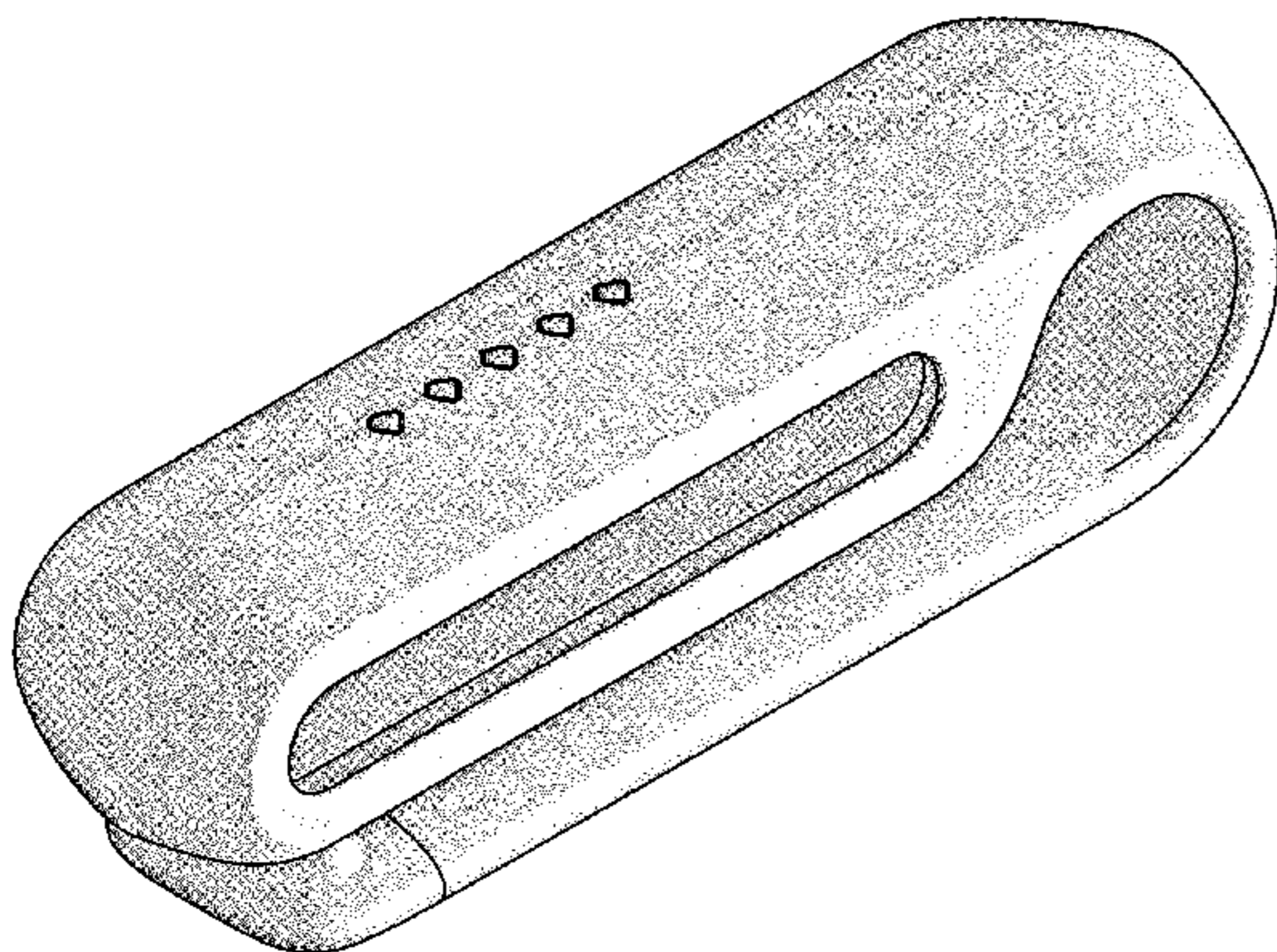
FIG. 9 is a side view of the clip accessory of FIG. 1 with a wearable fitness monitor inserted inside the clip accessory; and,

FIG. 10 depicts the clip accessory with the wearable fitness monitor or pebble inserted.

Stipple shading is used in all of the accompanying Figures to convey surface contouring and not texture.

The broken line showing of structural features is included for the purpose of illustrating non-claimed subject matter and forms no part of the claimed design.

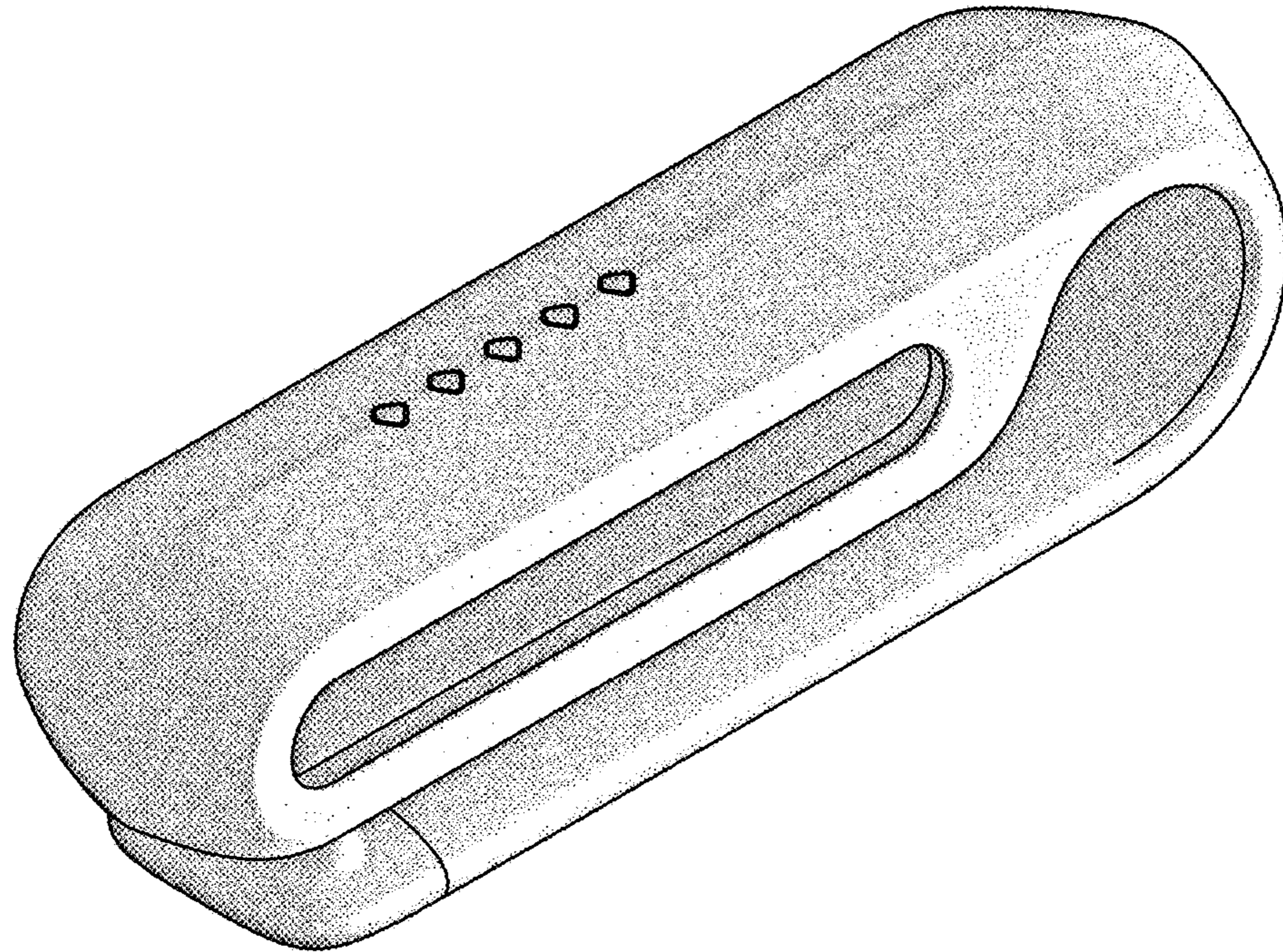

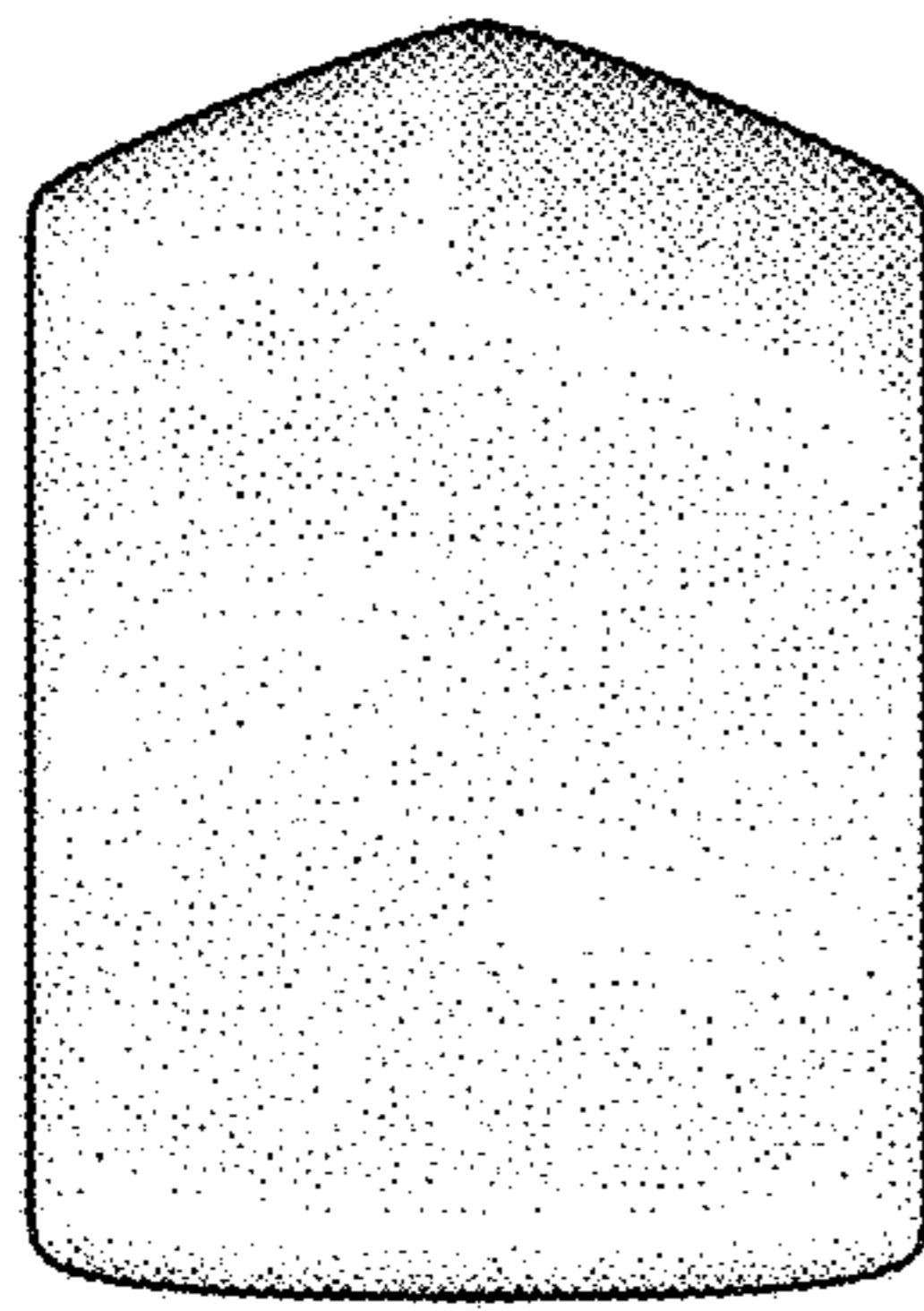

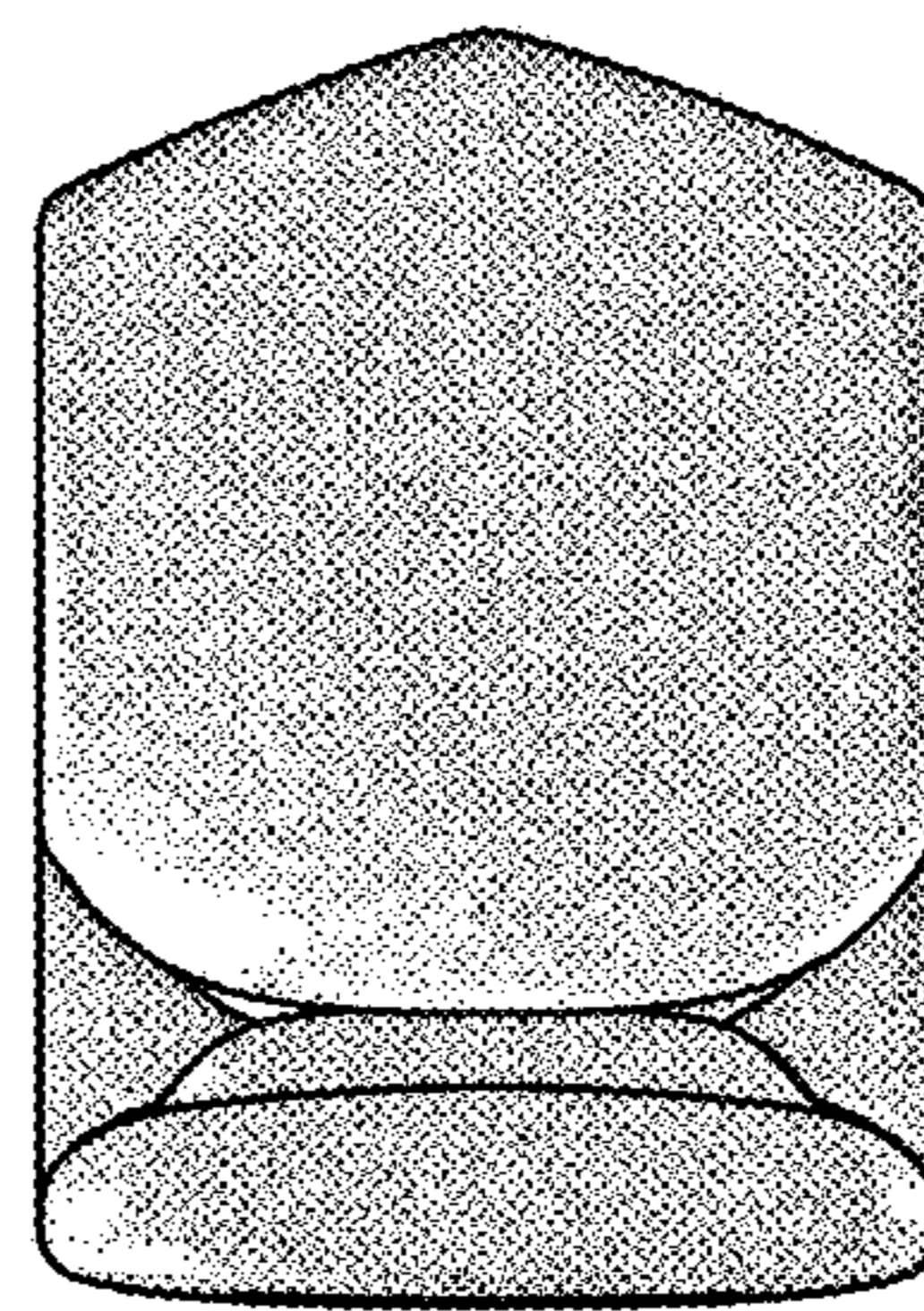

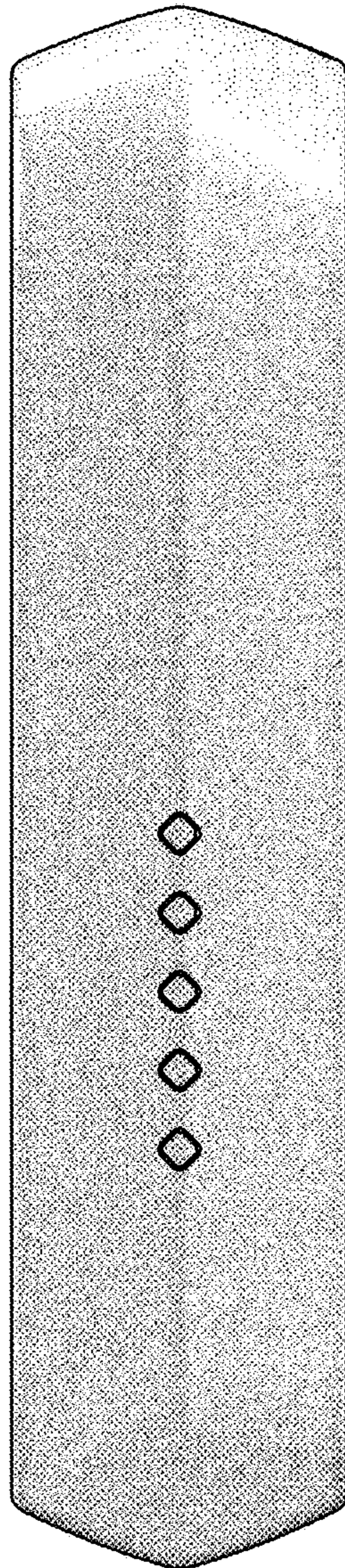

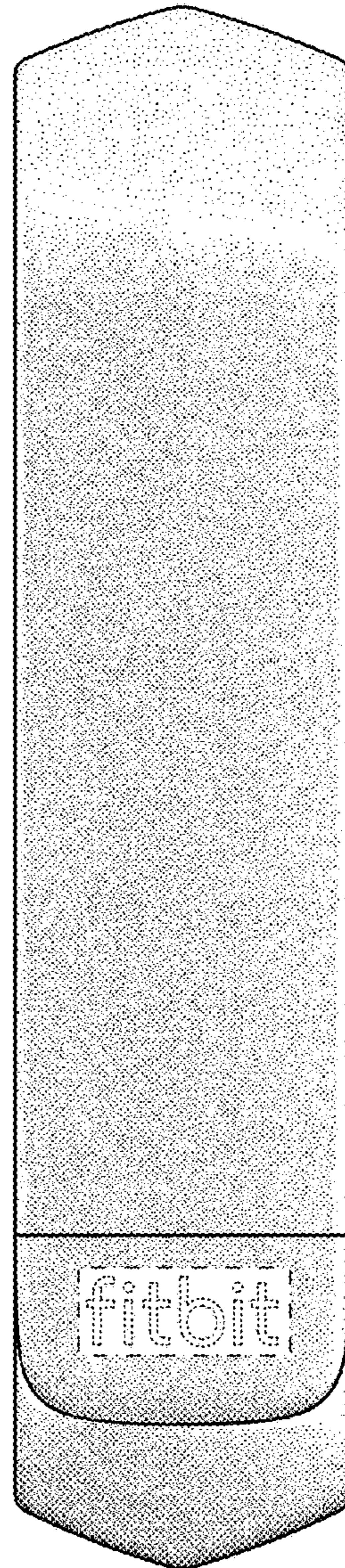

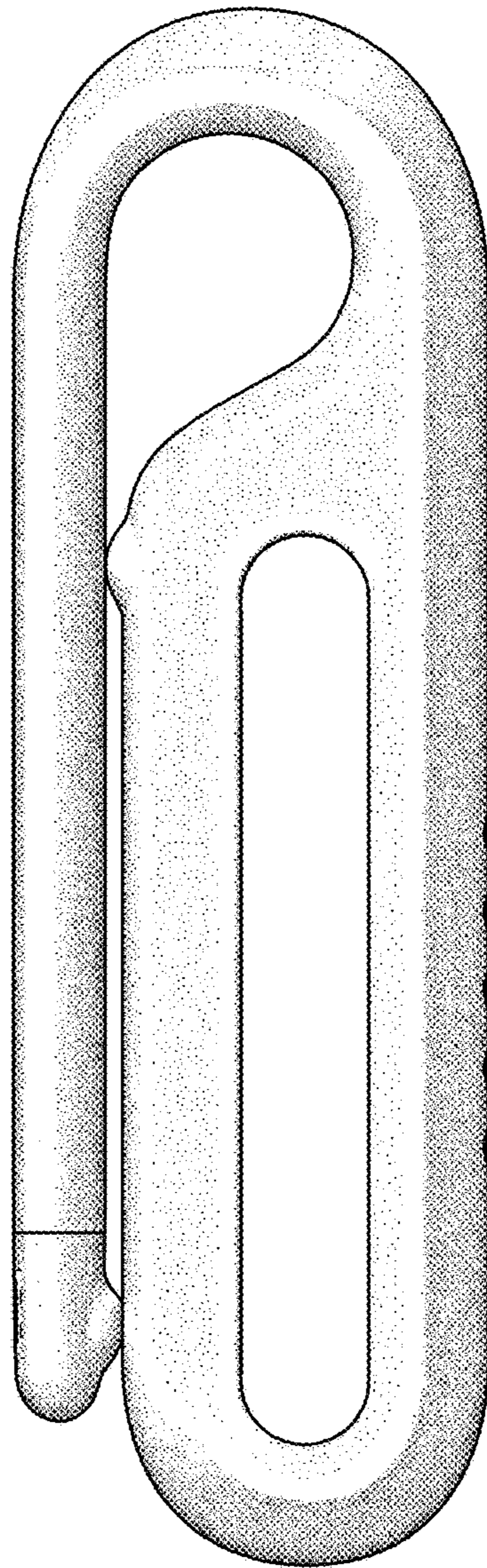

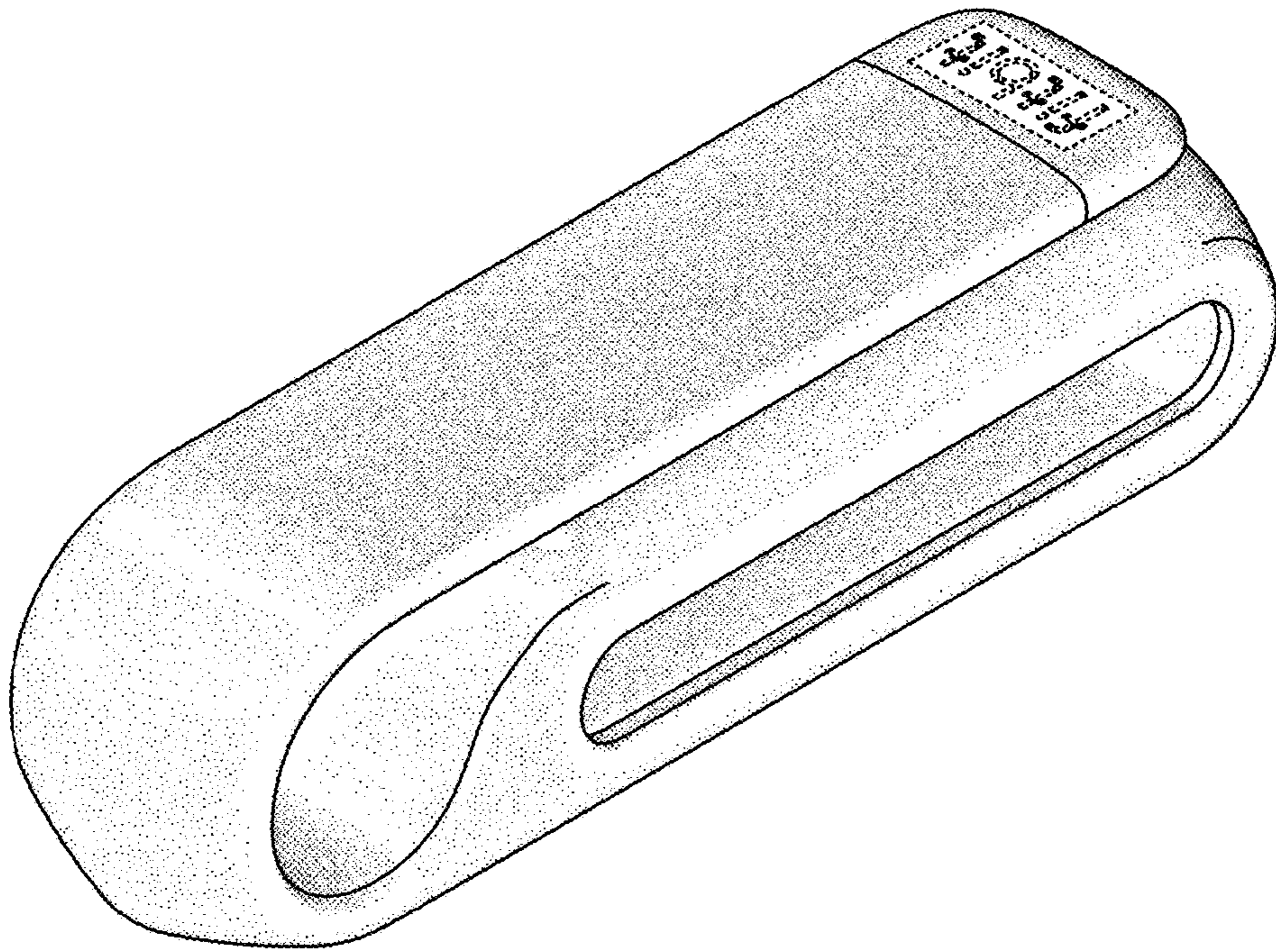

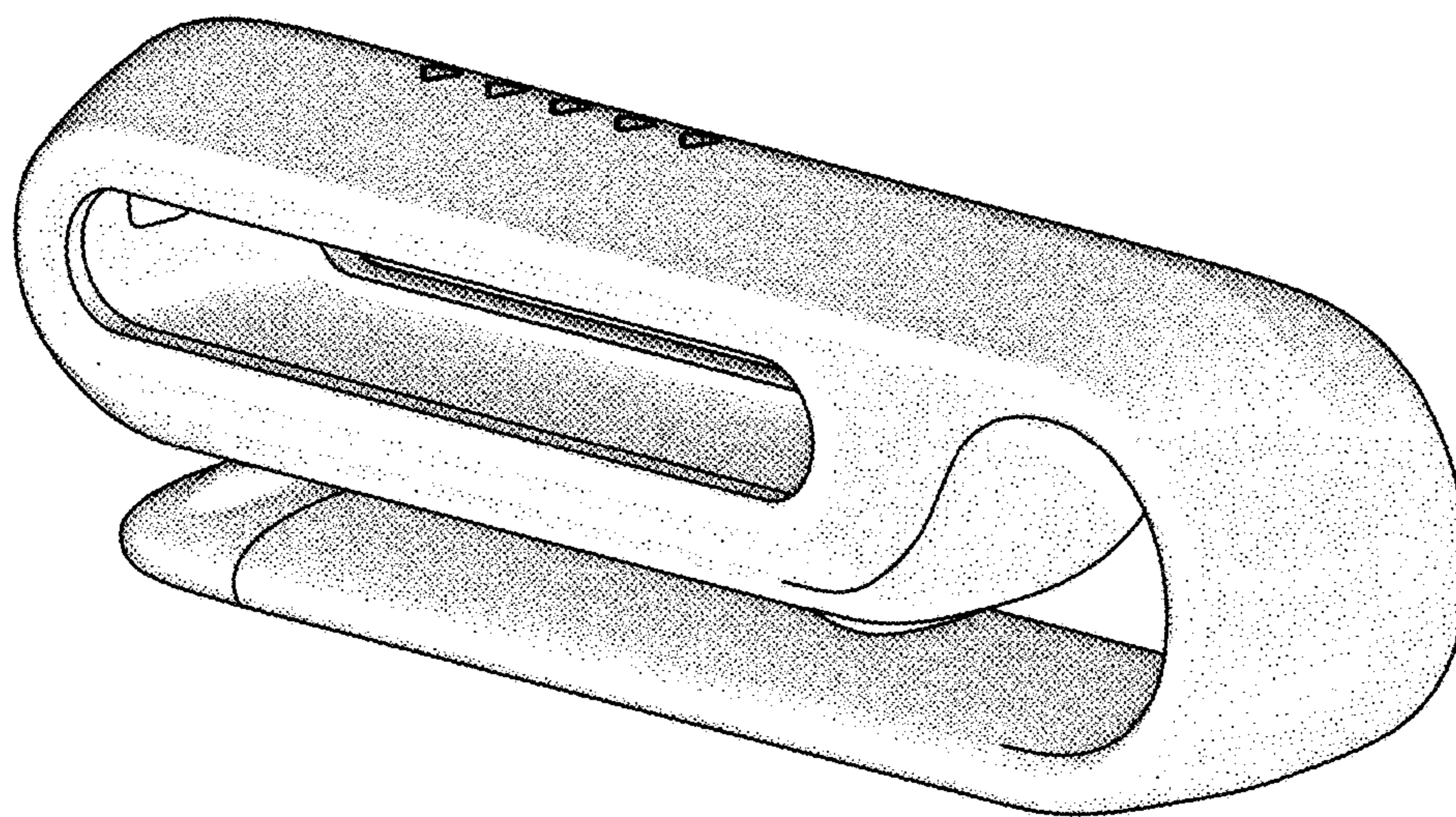

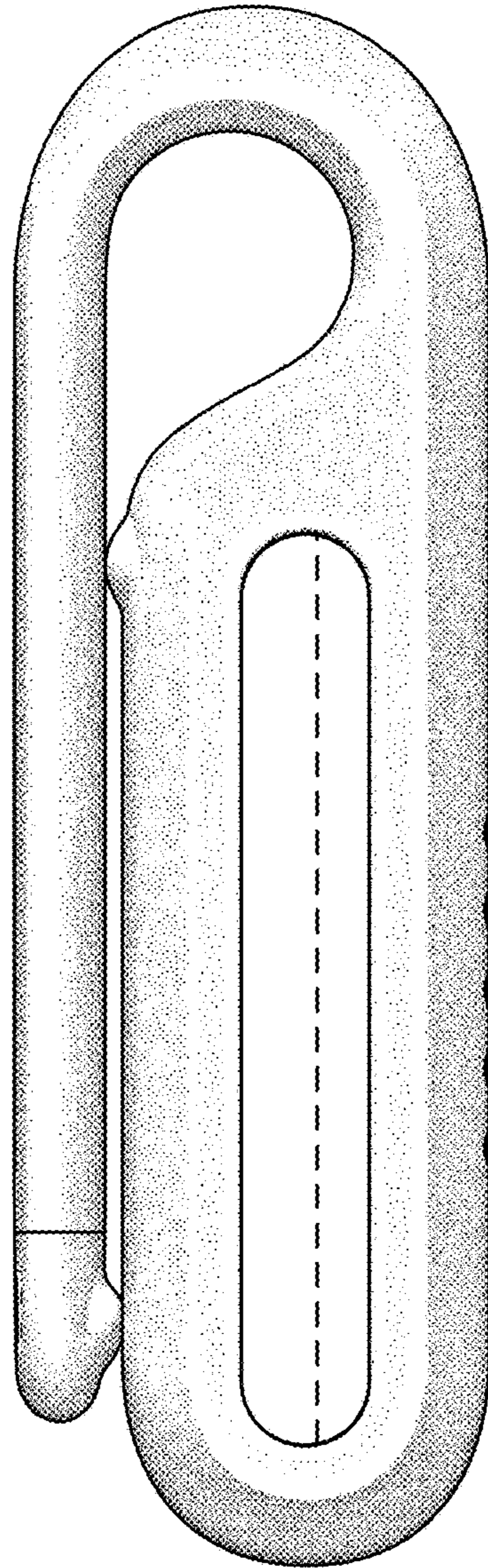

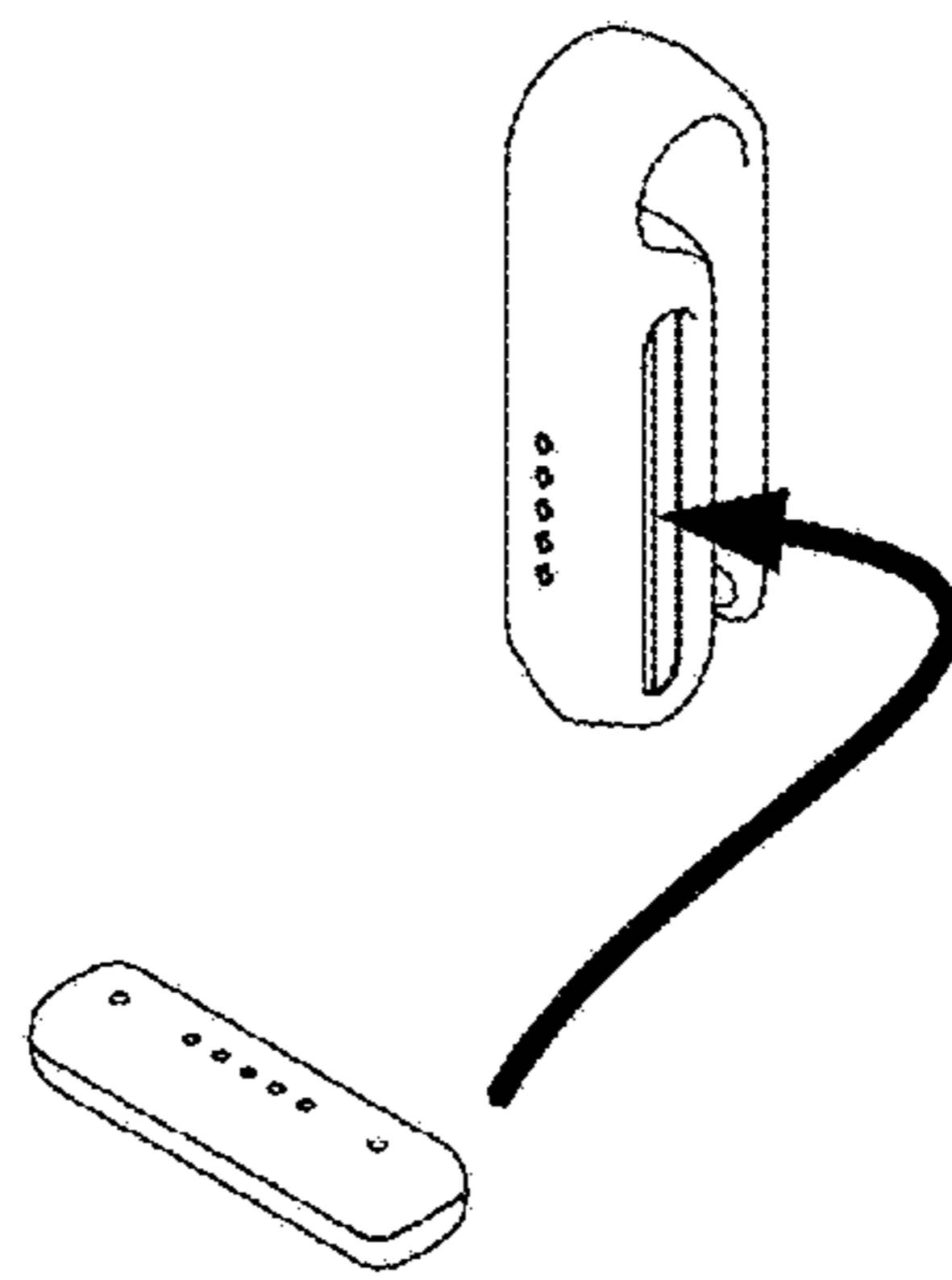
