(57) **CLAIM**

The ornamental design for a tote, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the design of a tote showing the new design;
FIG. 2 is a bottom perspective view of the tote shown in FIG. 1;
FIG. 3 is a front elevation view of the tote shown in FIG. 1 (the rear elevation view of the tote is a mirror image of the view shown in FIG. 3); and,
FIG. 4 is a right side elevation view of the tote shown in FIG. 1 (the left side elevation view of the tote is a mirror image of the view shown in FIG. 4).

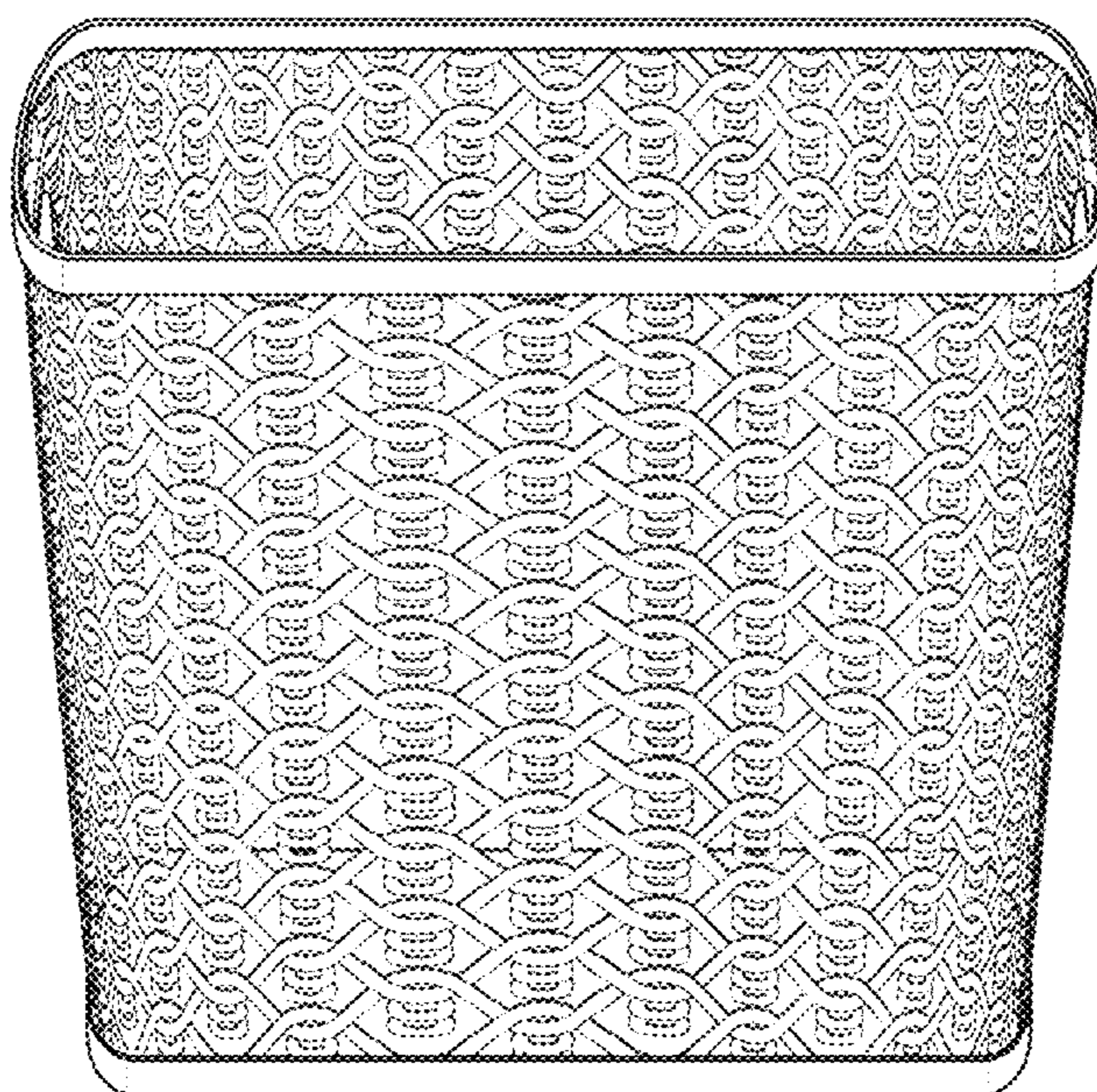

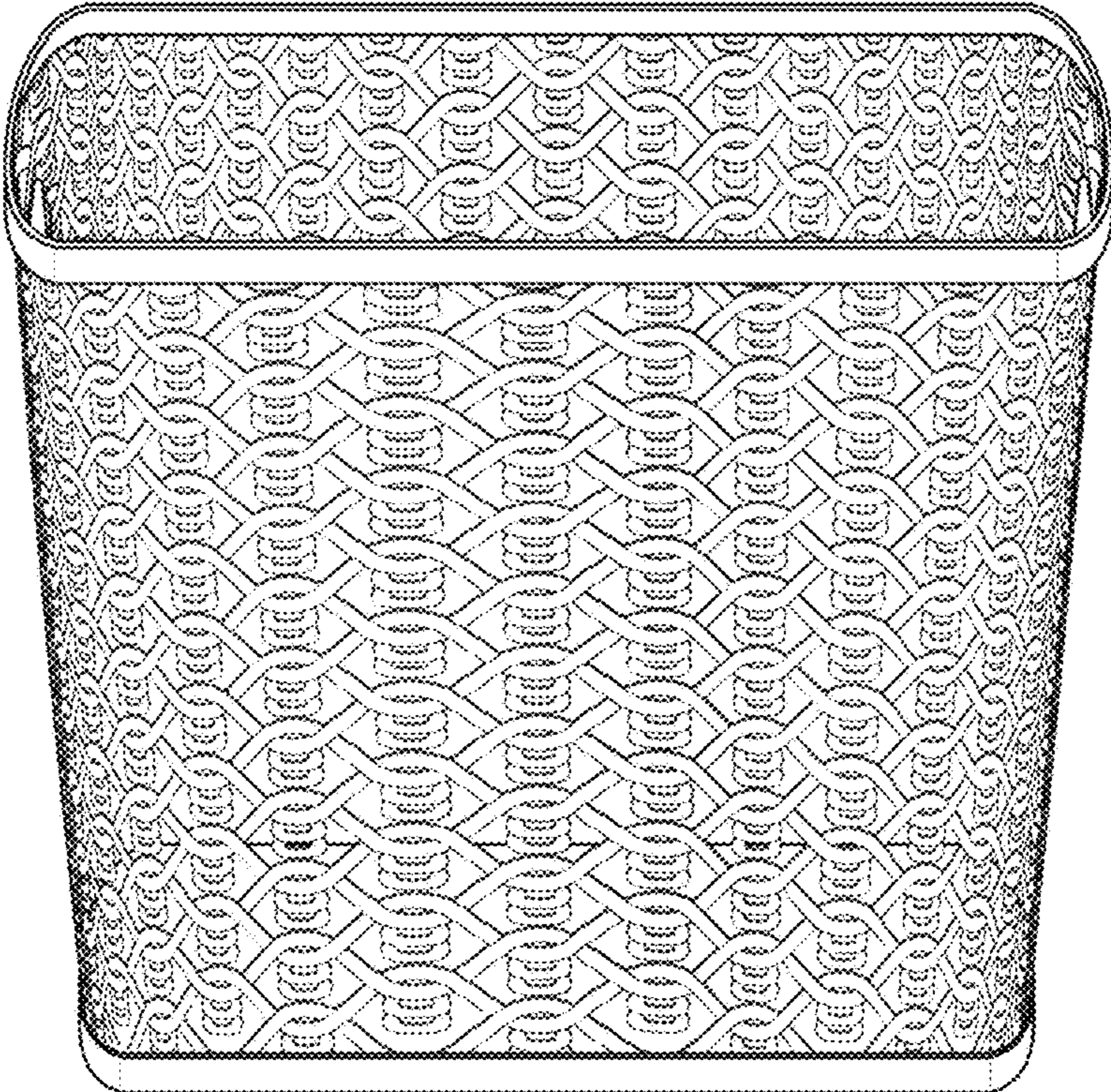

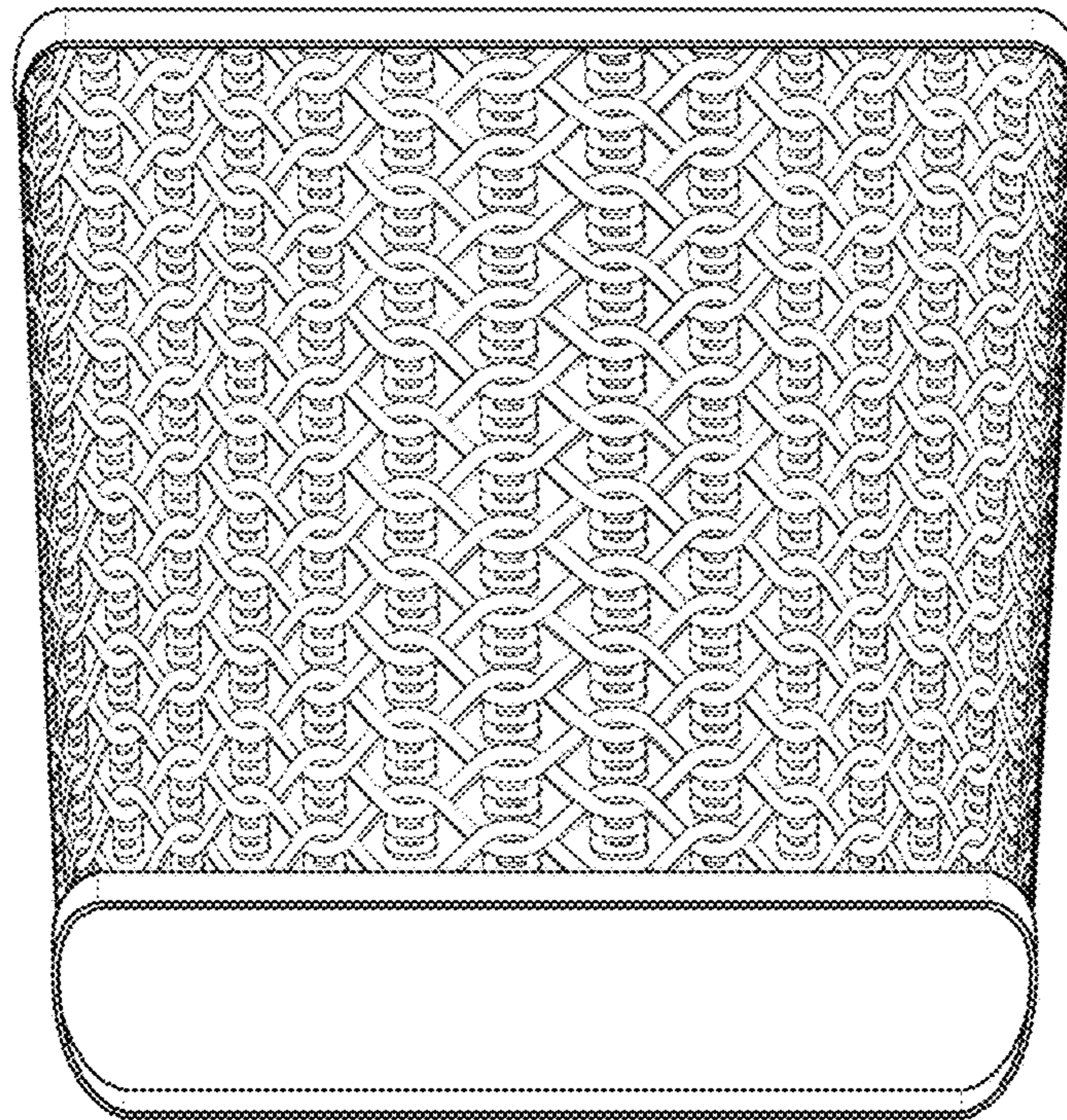

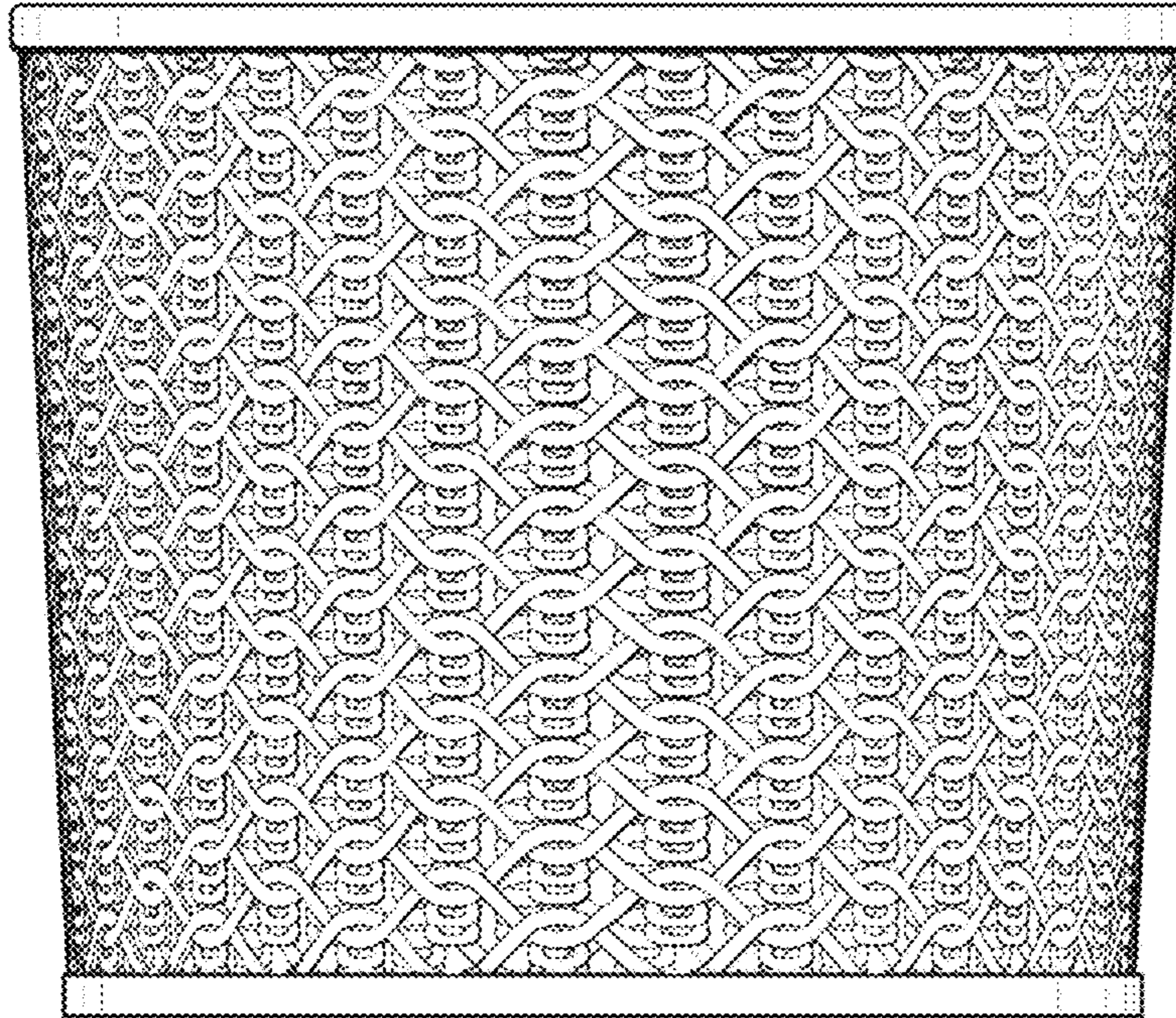

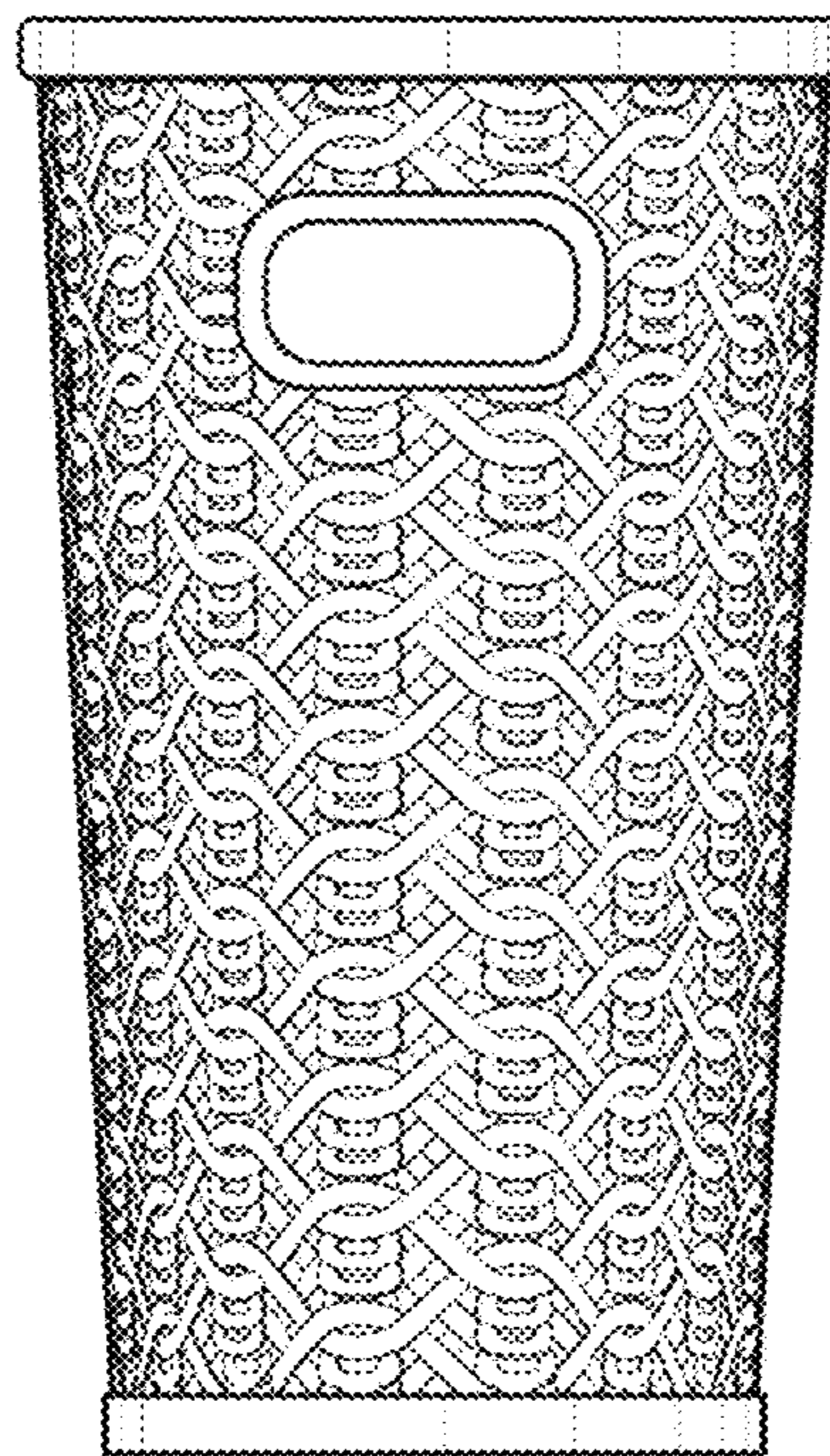
