DESCRIPTION

FIG. 1 is a front right perspective view of a bench seat for a vehicle according to the present invention.

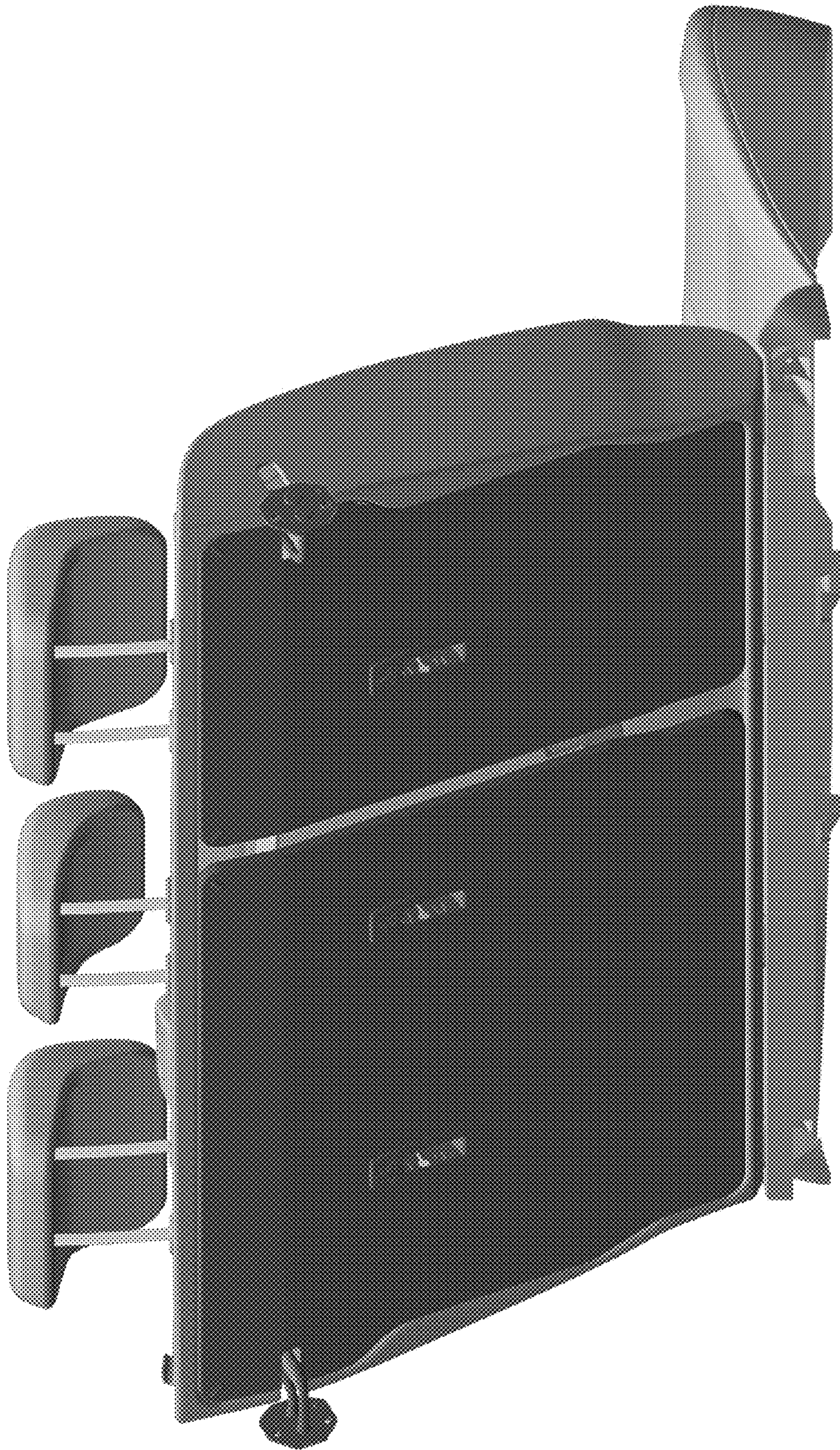

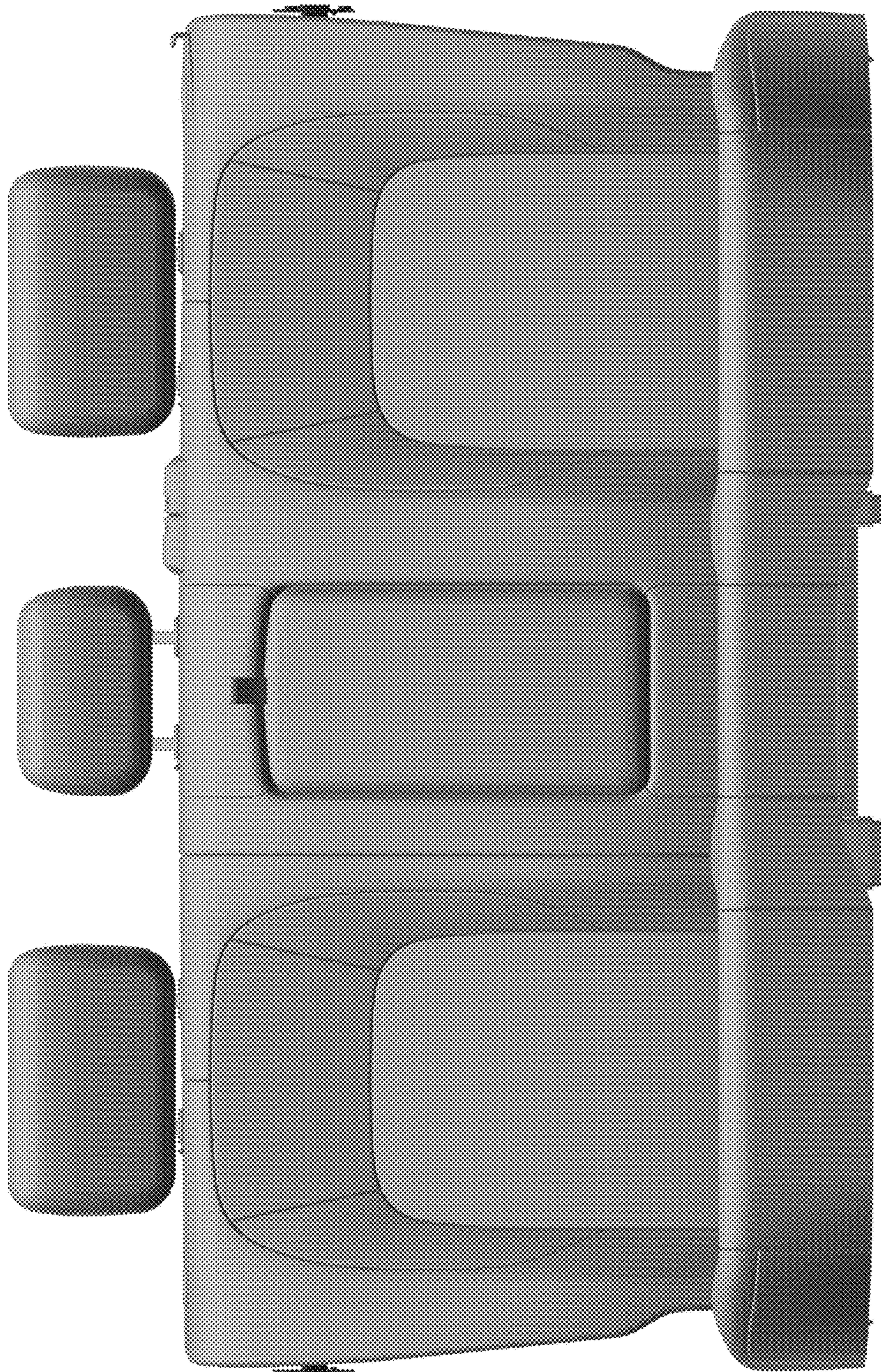

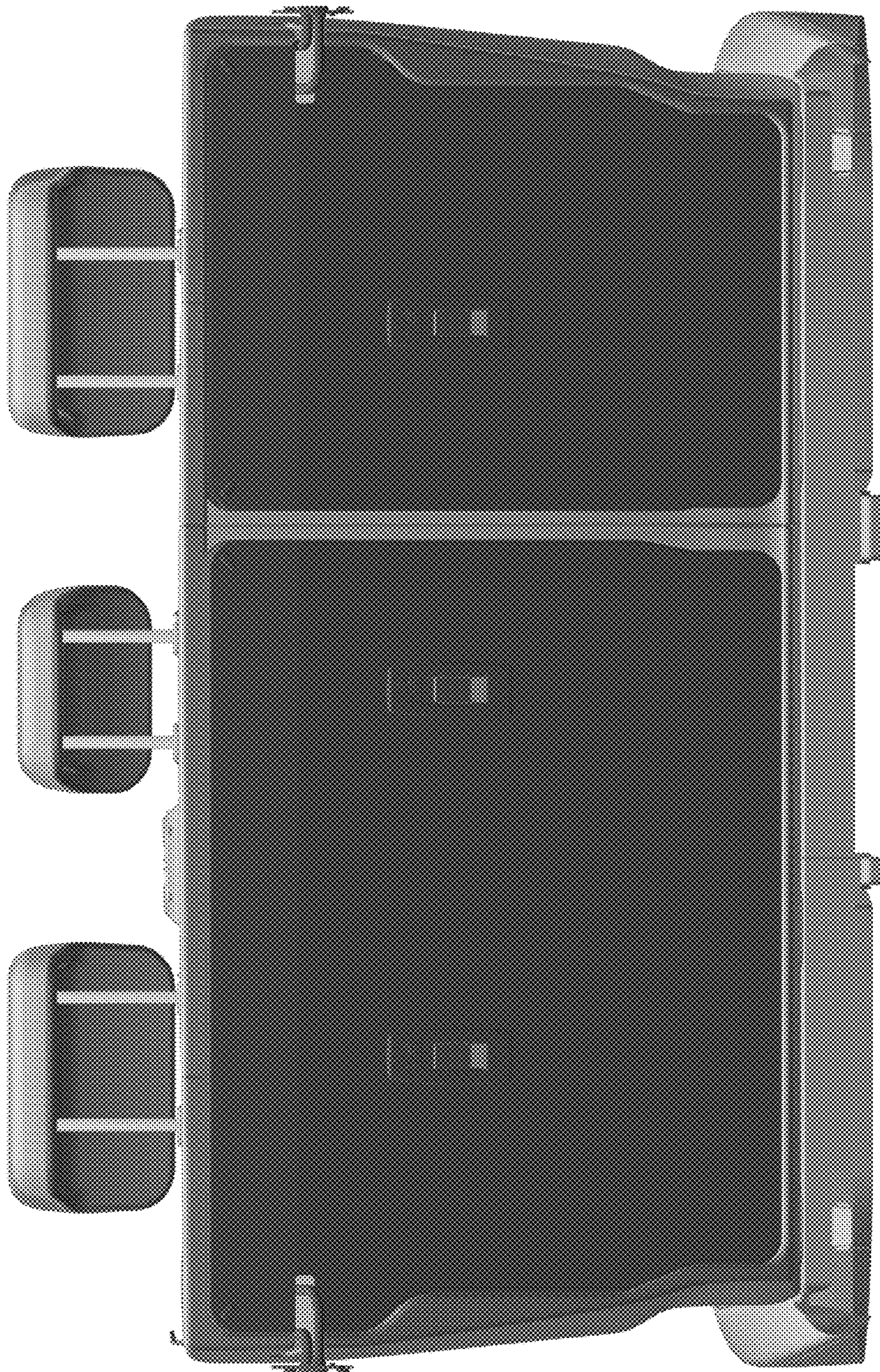

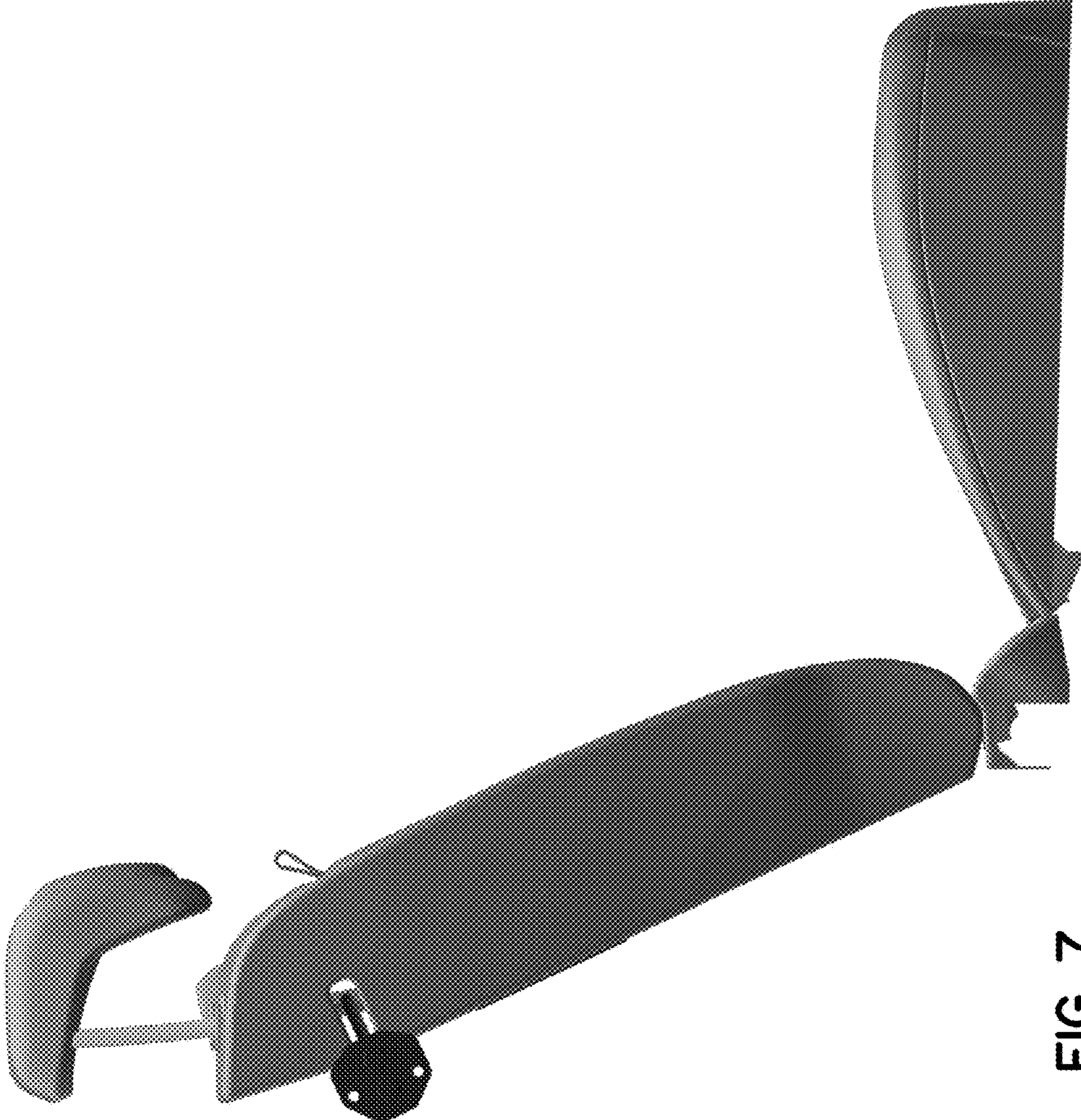

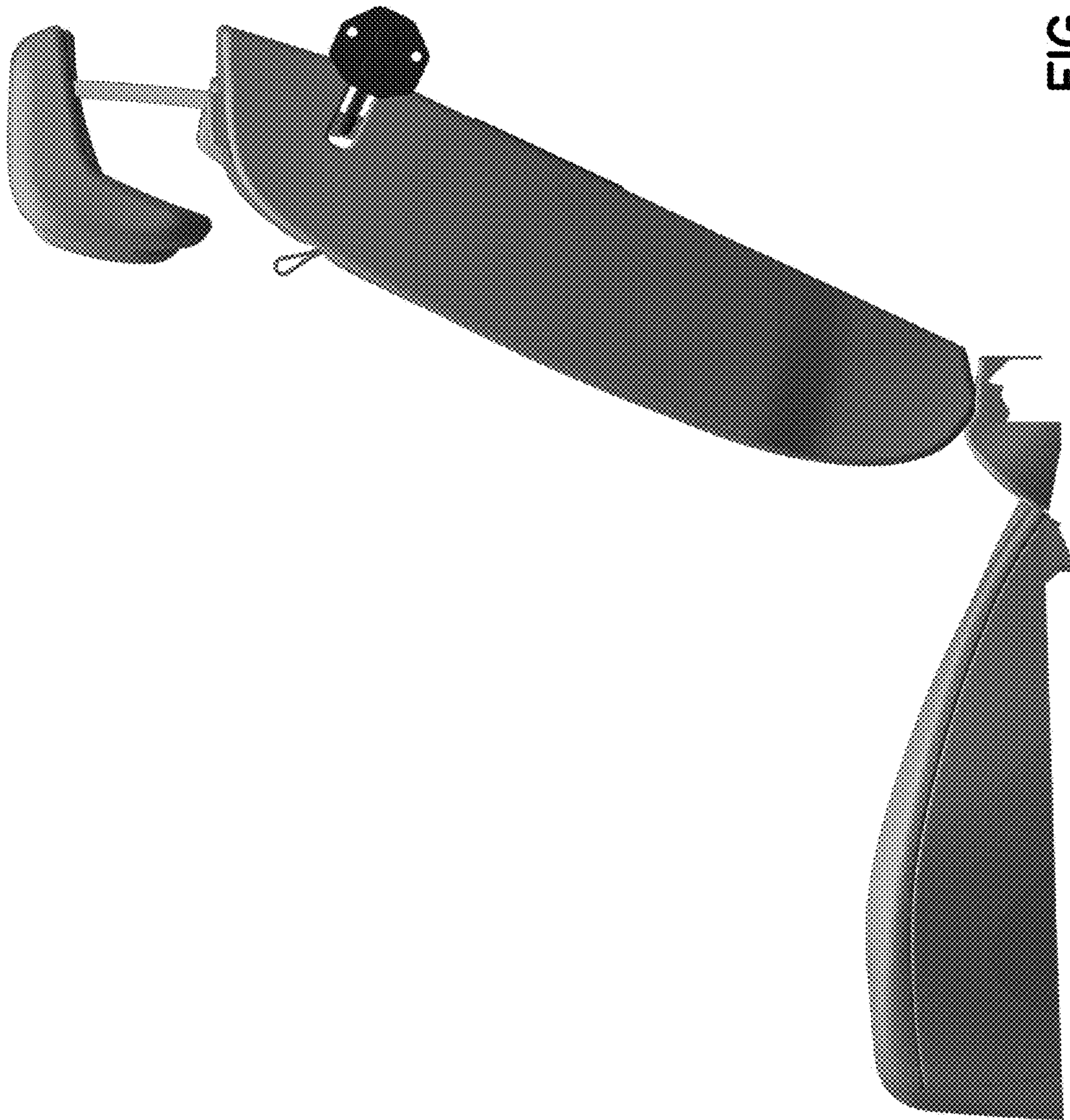

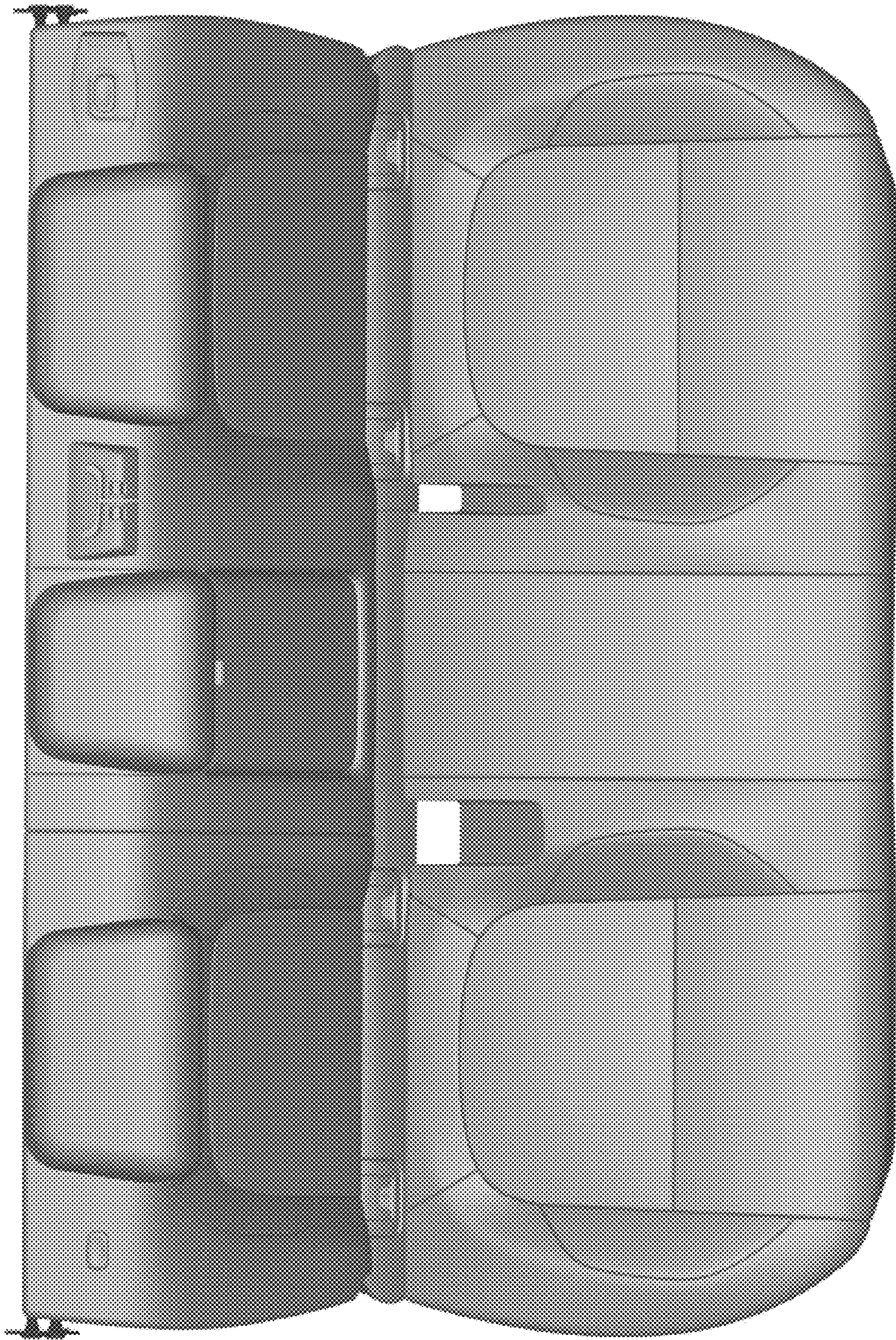
