DESCRIPTION

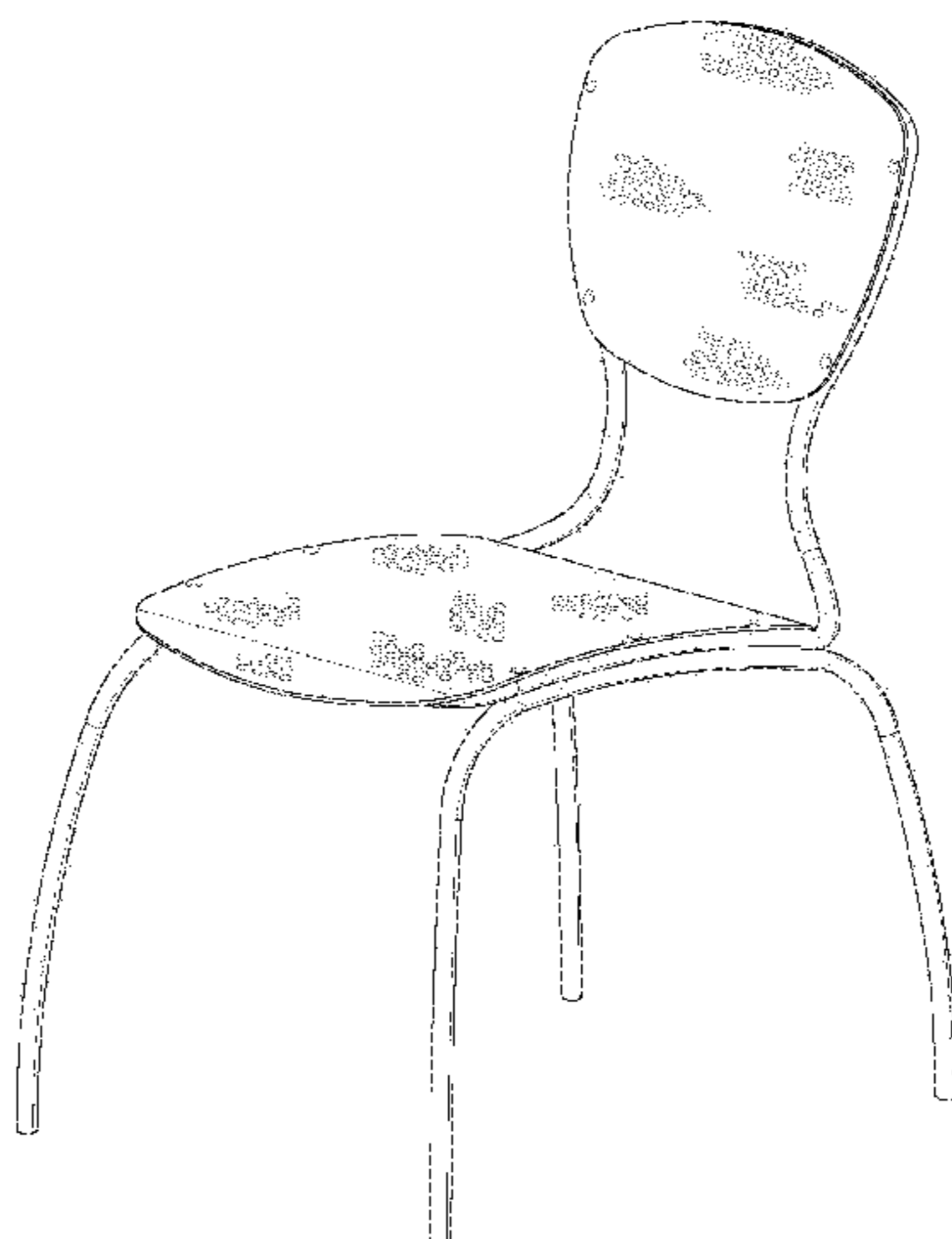

View 1.1 is a top and side perspective view of the chair;
 View 1.2 is a top view thereof;
 View 1.3 is a bottom view thereof;
 View 1.4 is a front view thereof;
 View 1.5 is a rear elevation view thereof;
 View 1.6 is a right side view thereof;
 View 1.7 is a left side view thereof;
 View 2.1 is a top and side perspective view of a second embodiment of the chair design with extenders;
 View 2.2 is top view thereof;
 View 2.3 is bottom view thereof;
 View 2.4 is a front view thereof;
 View 2.5 is a rear view thereof;
 View 2.6 is a left right view thereof; and
 View 2.7 is a left side view thereof.

The dashed or broken line representations are for the purposes of illustration only and form no part of the claimed design.

Views 2.1-2.7 show symbolic breaks in the length of the legs. The appearance of any portions of the article between the break lines forms no part of the claimed design.

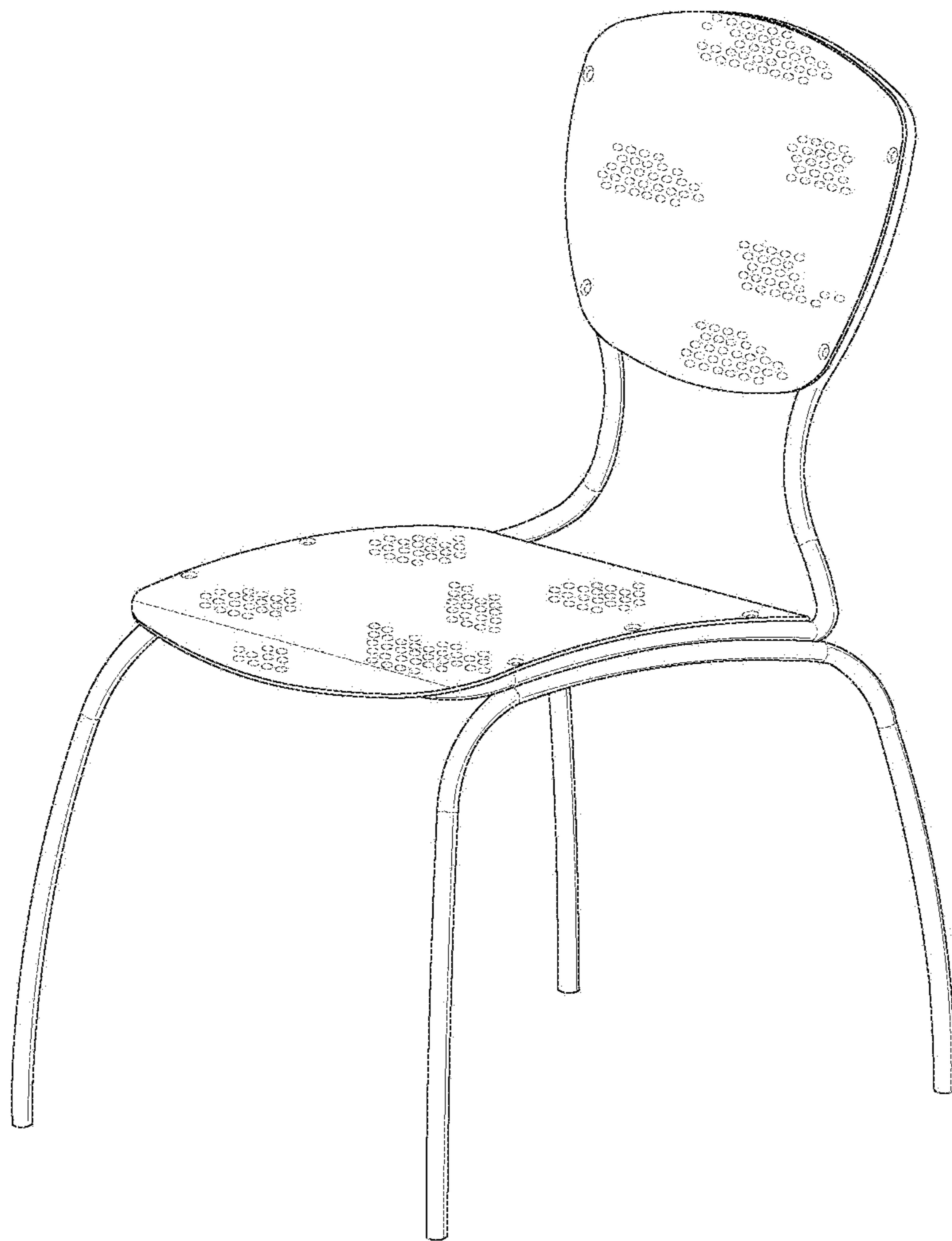

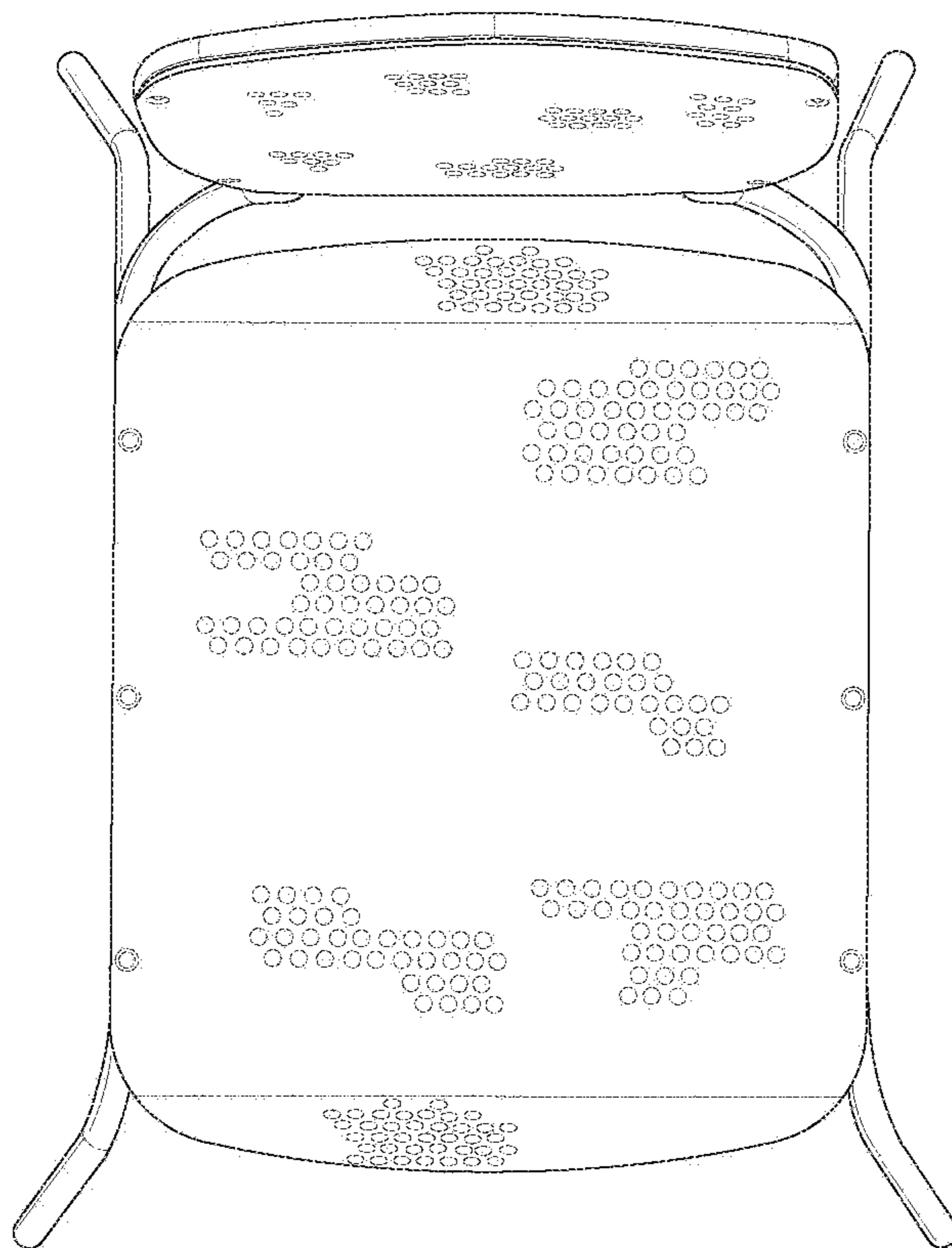

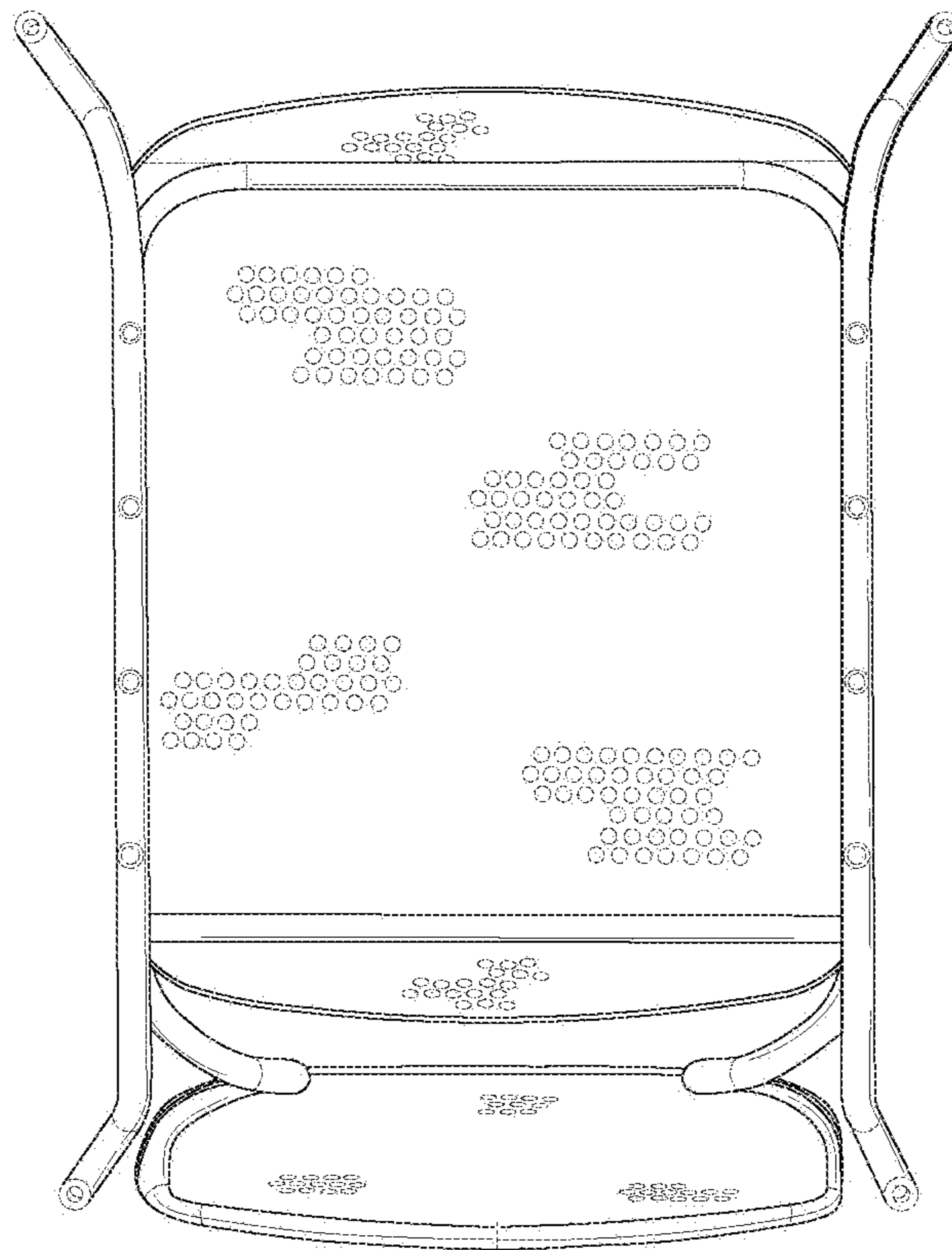

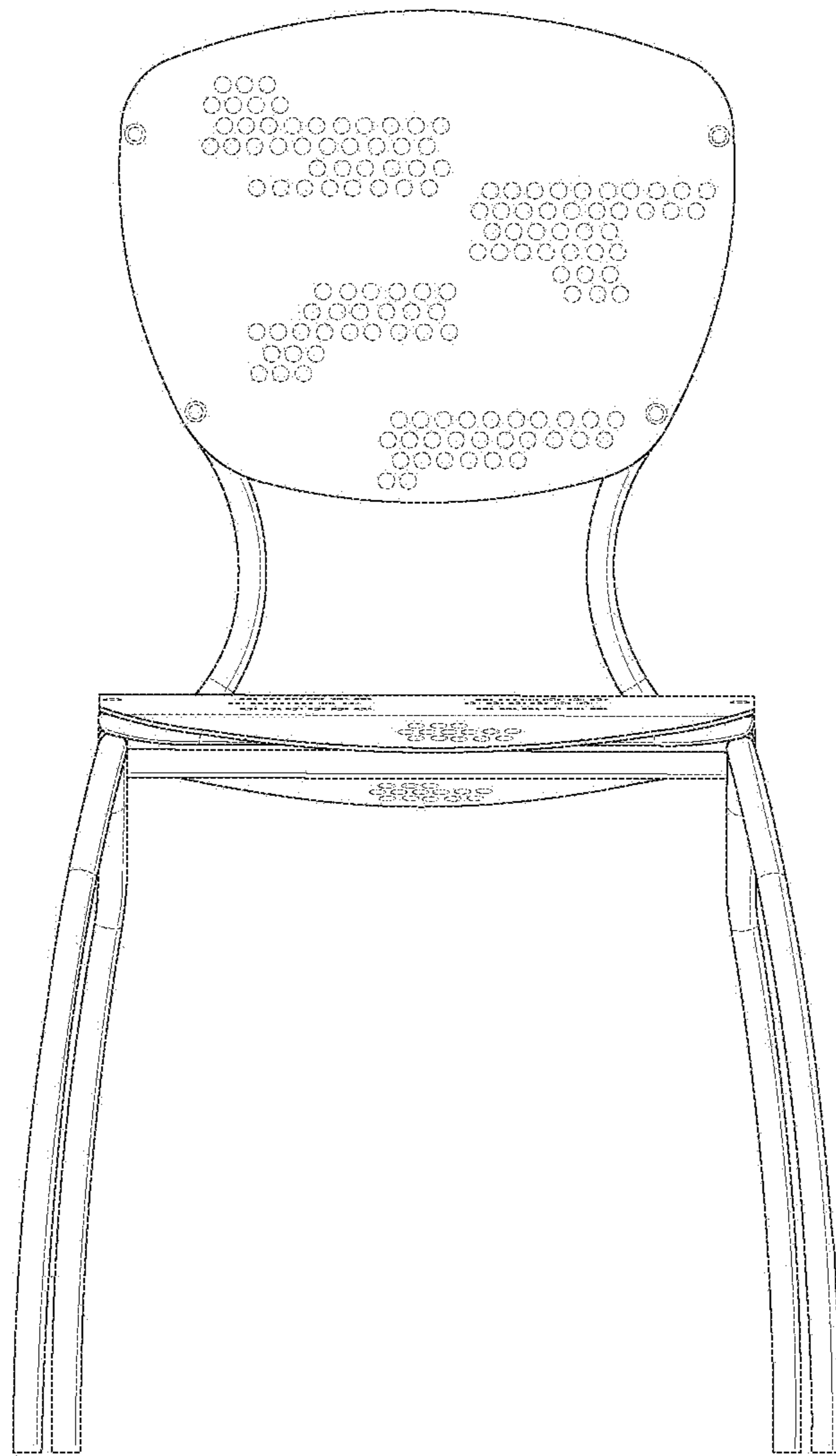

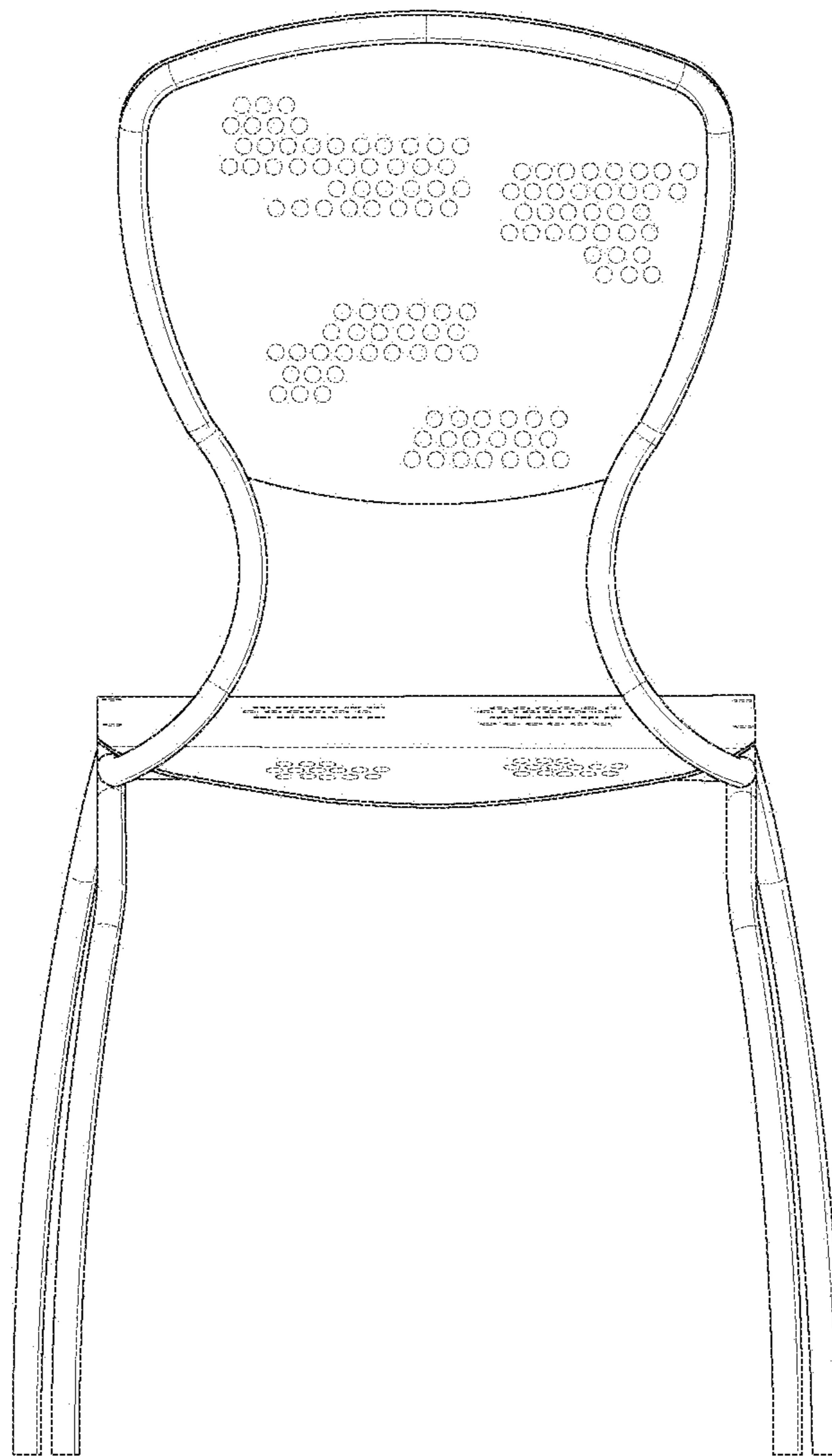

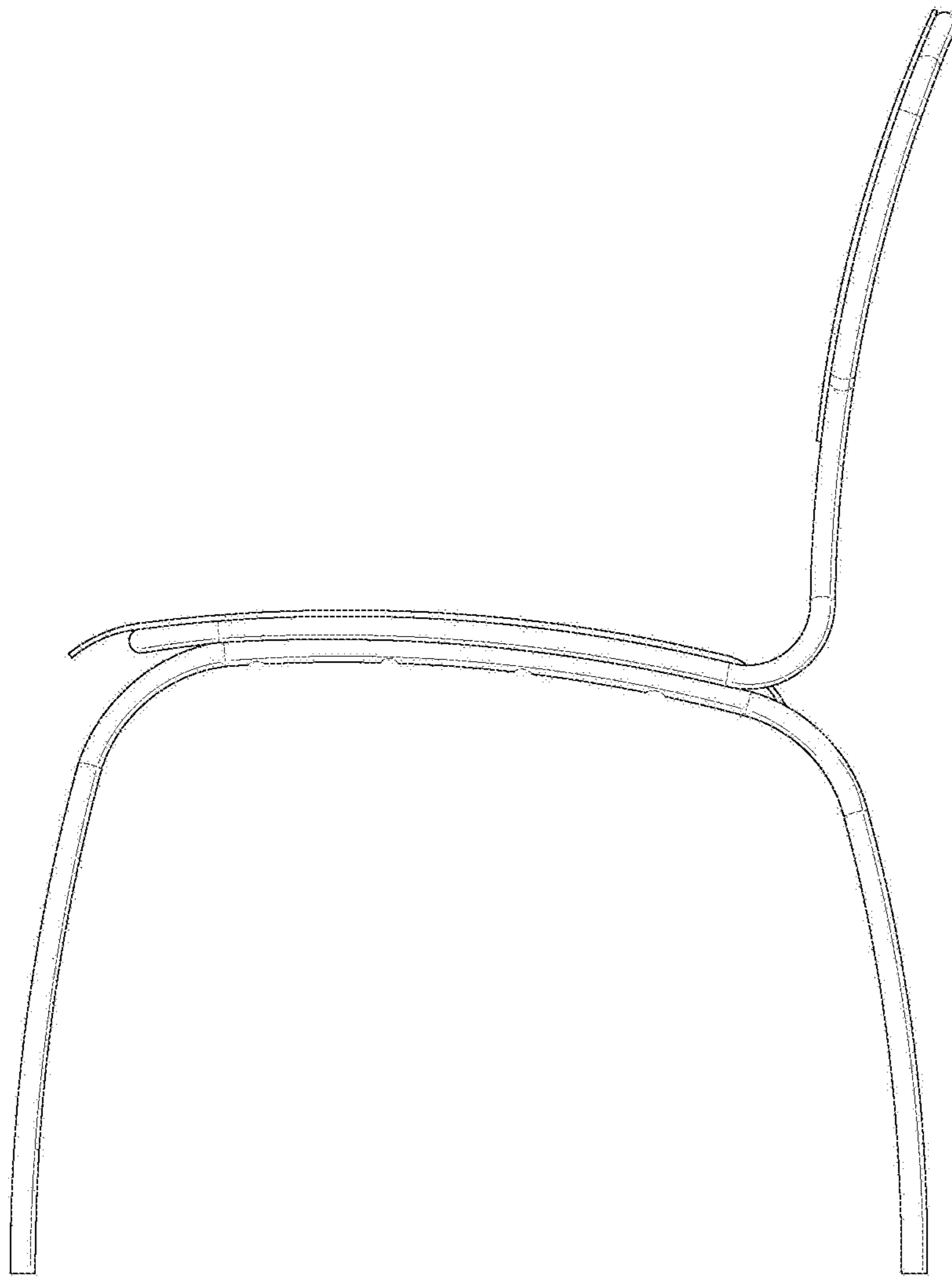

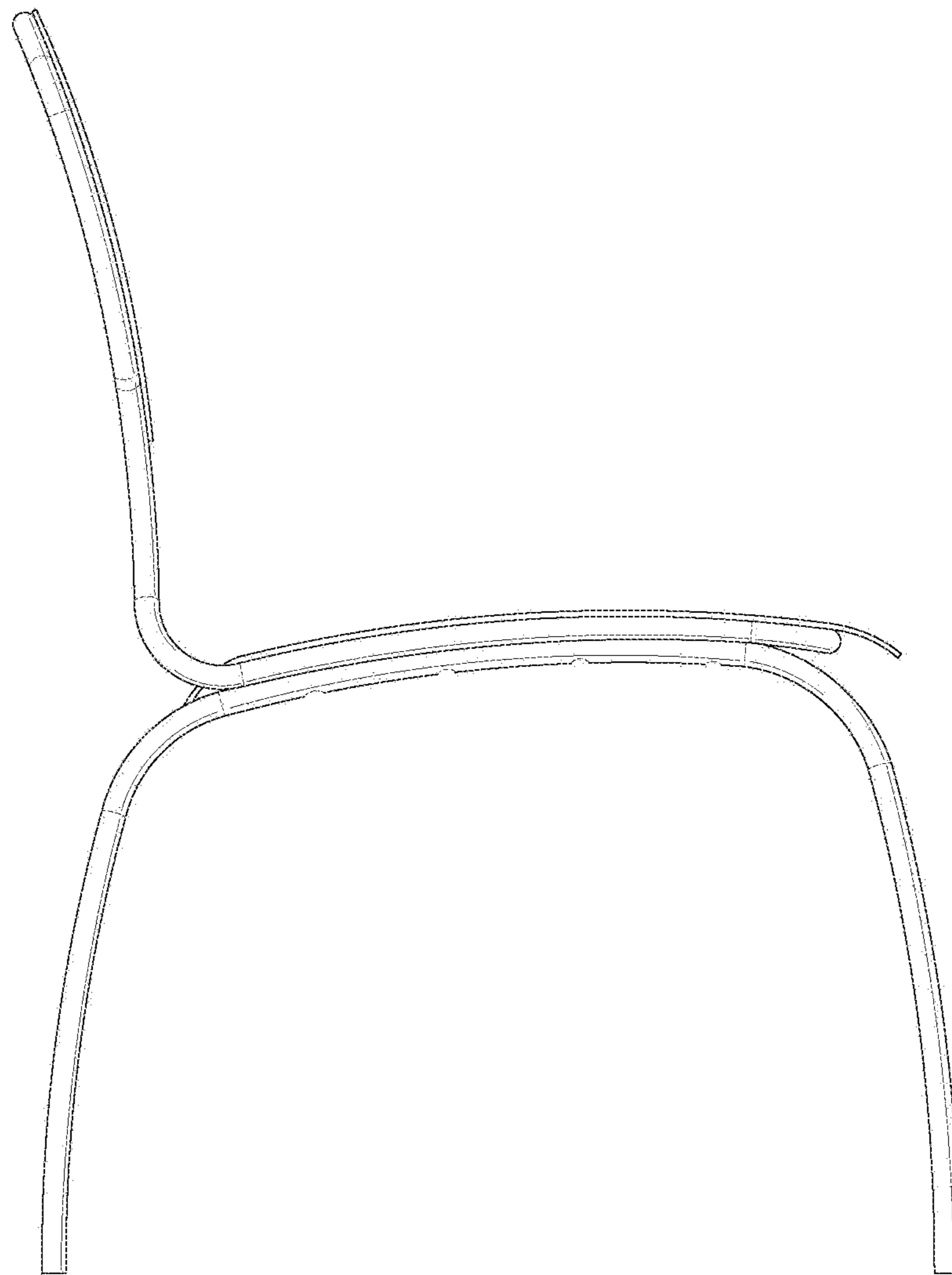

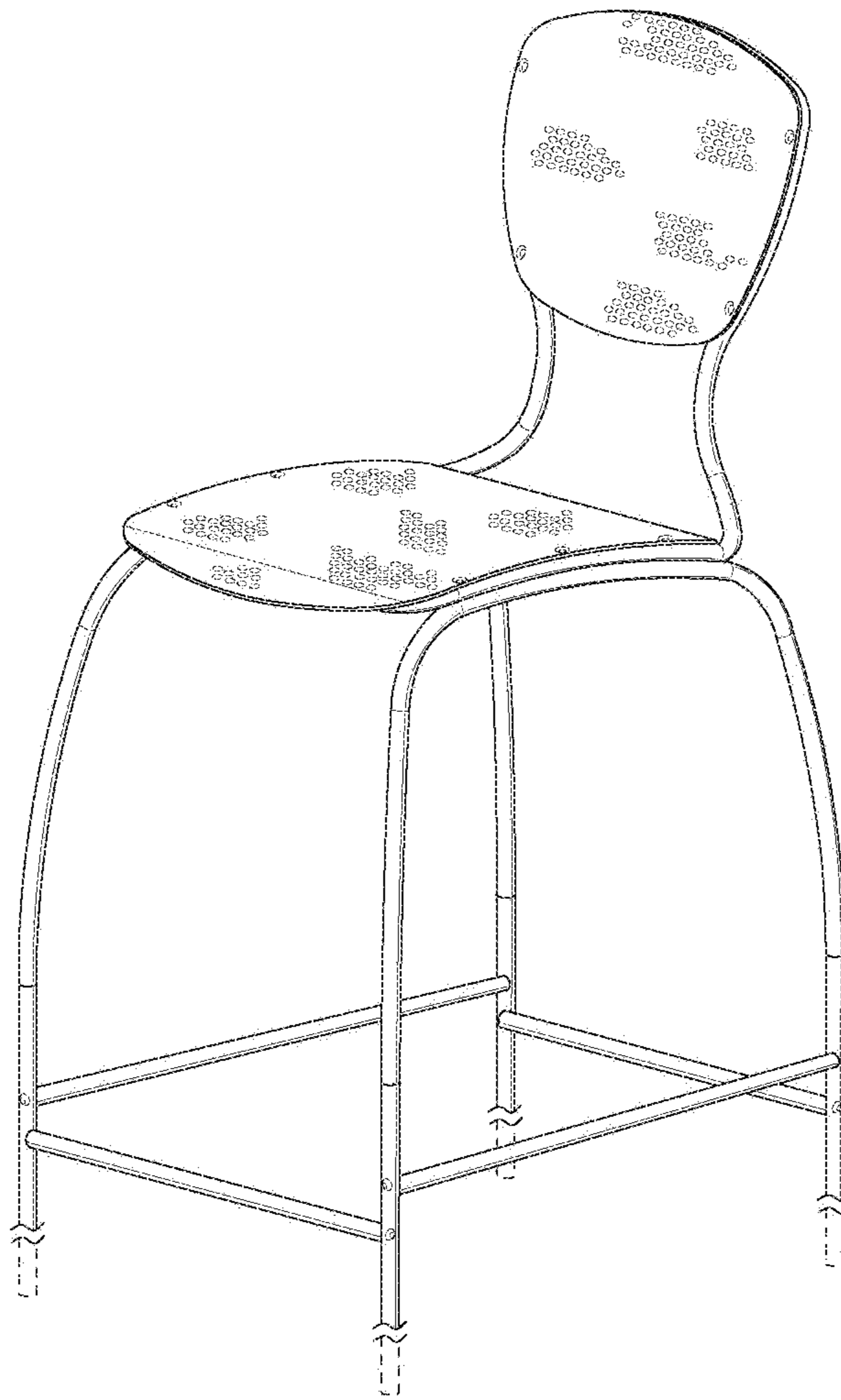

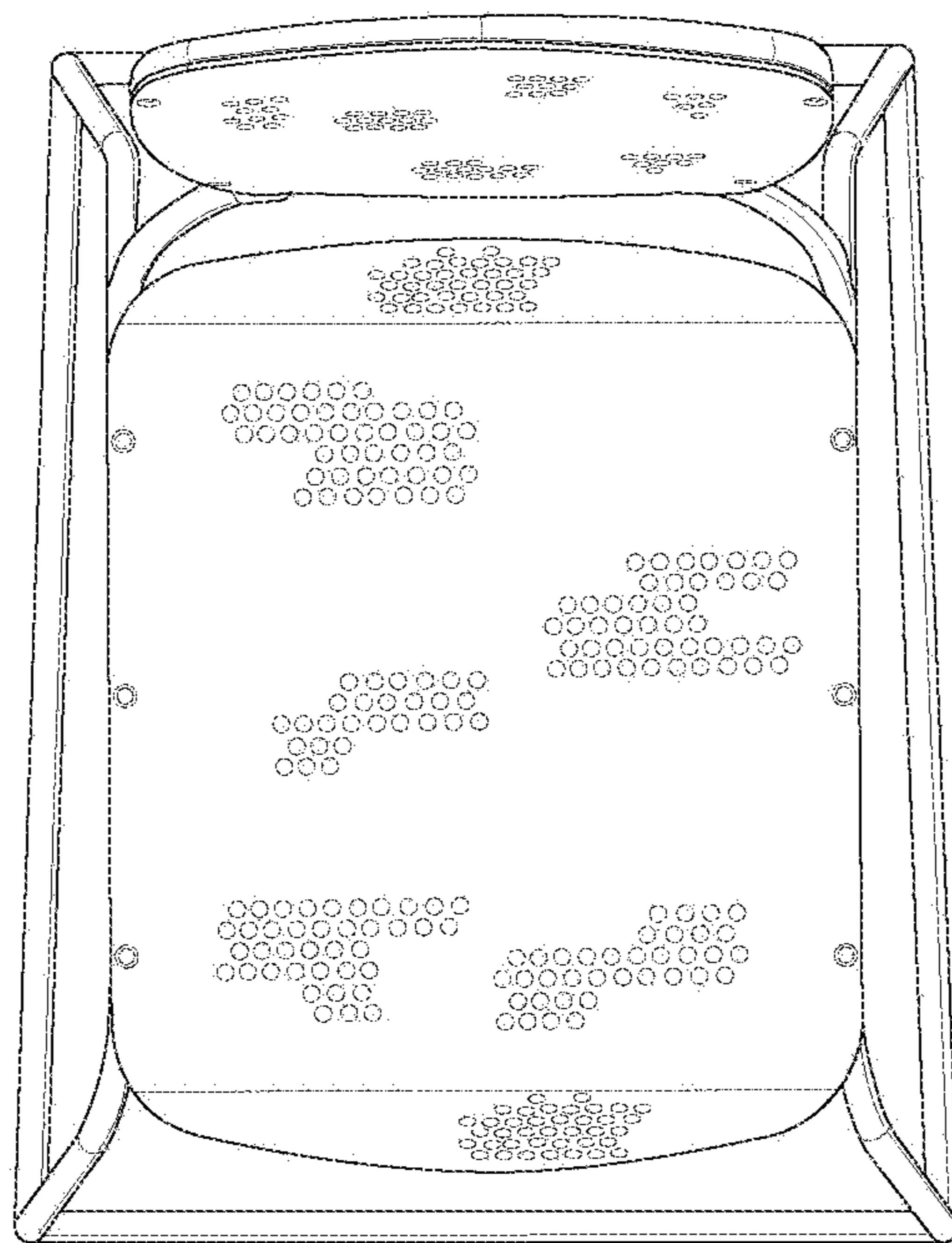

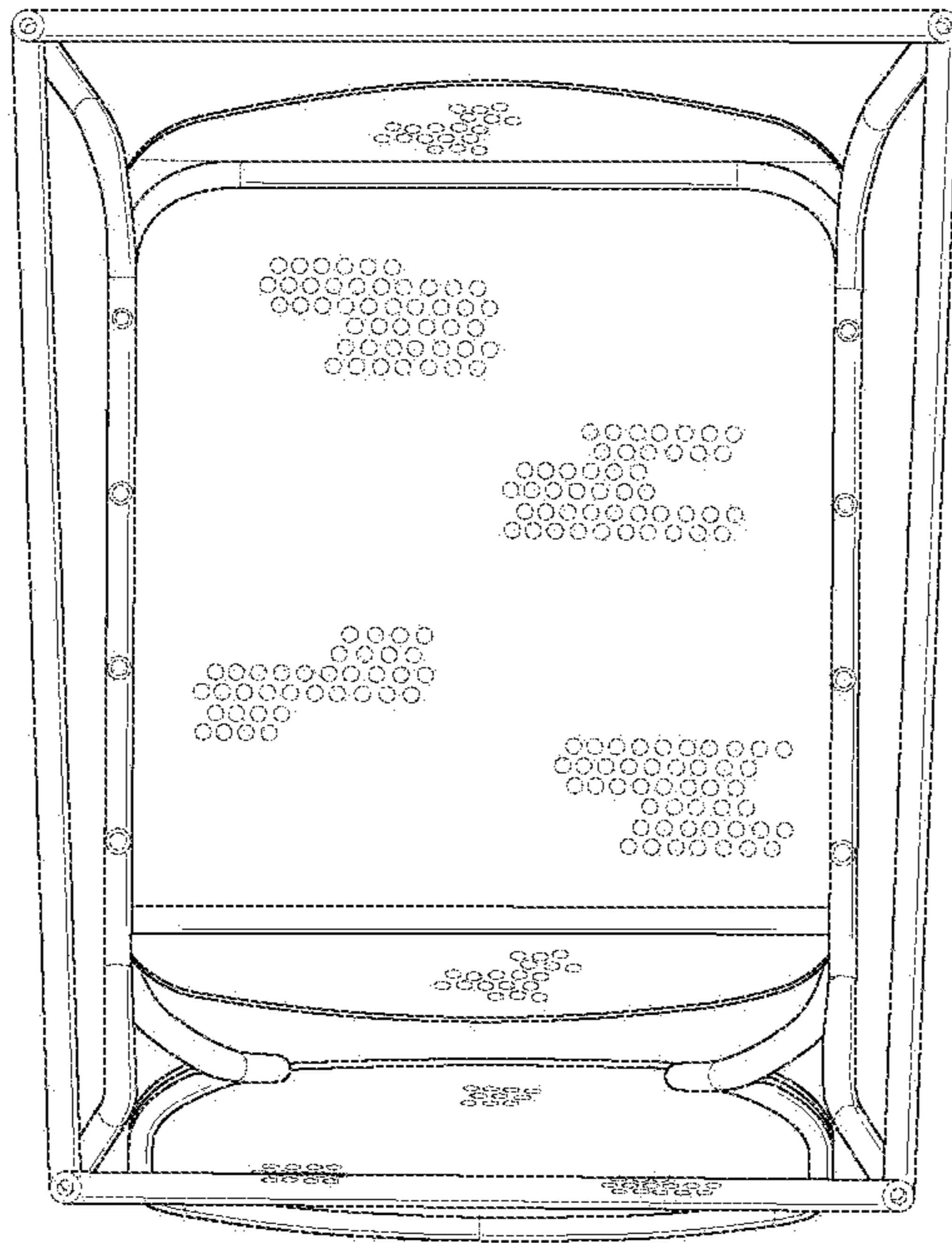

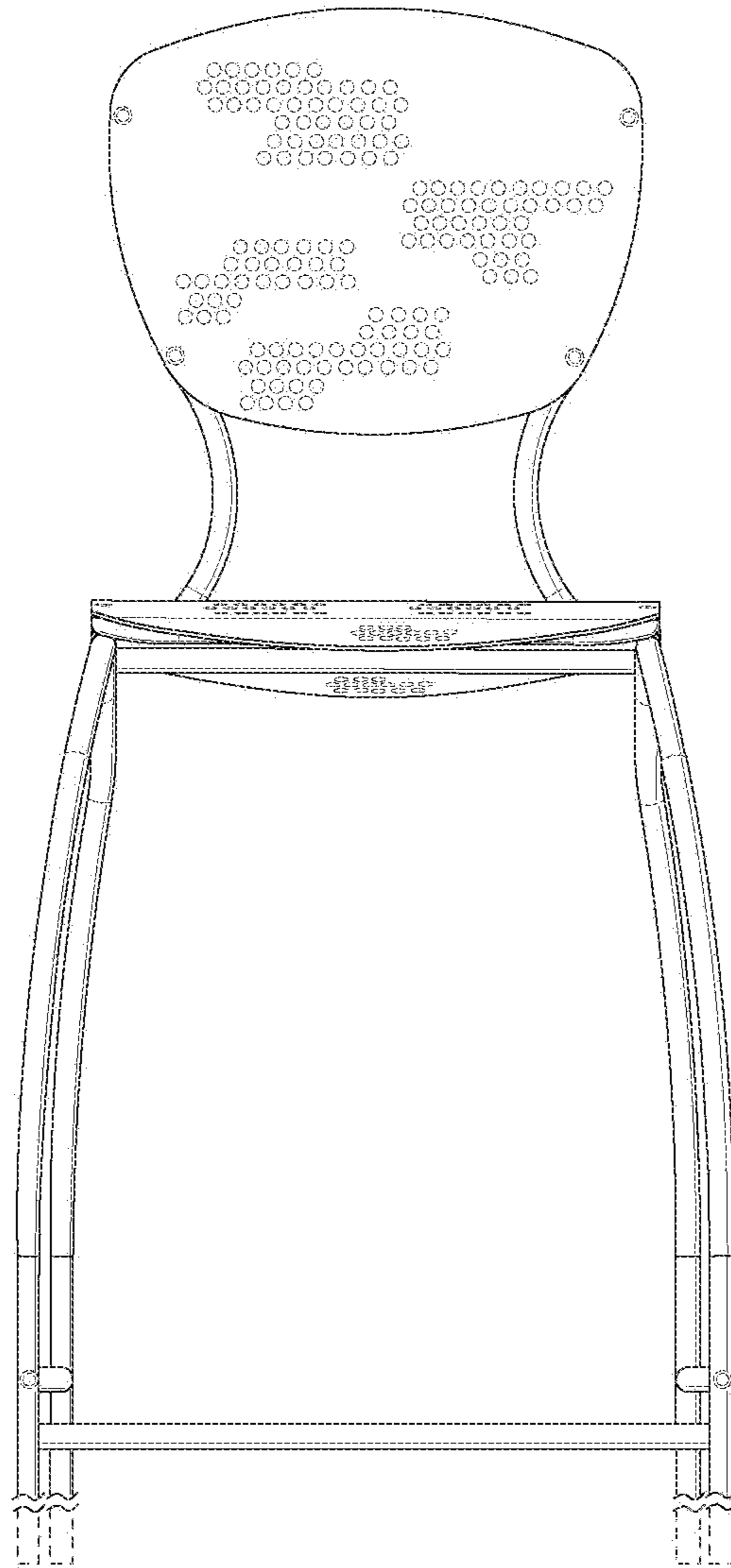

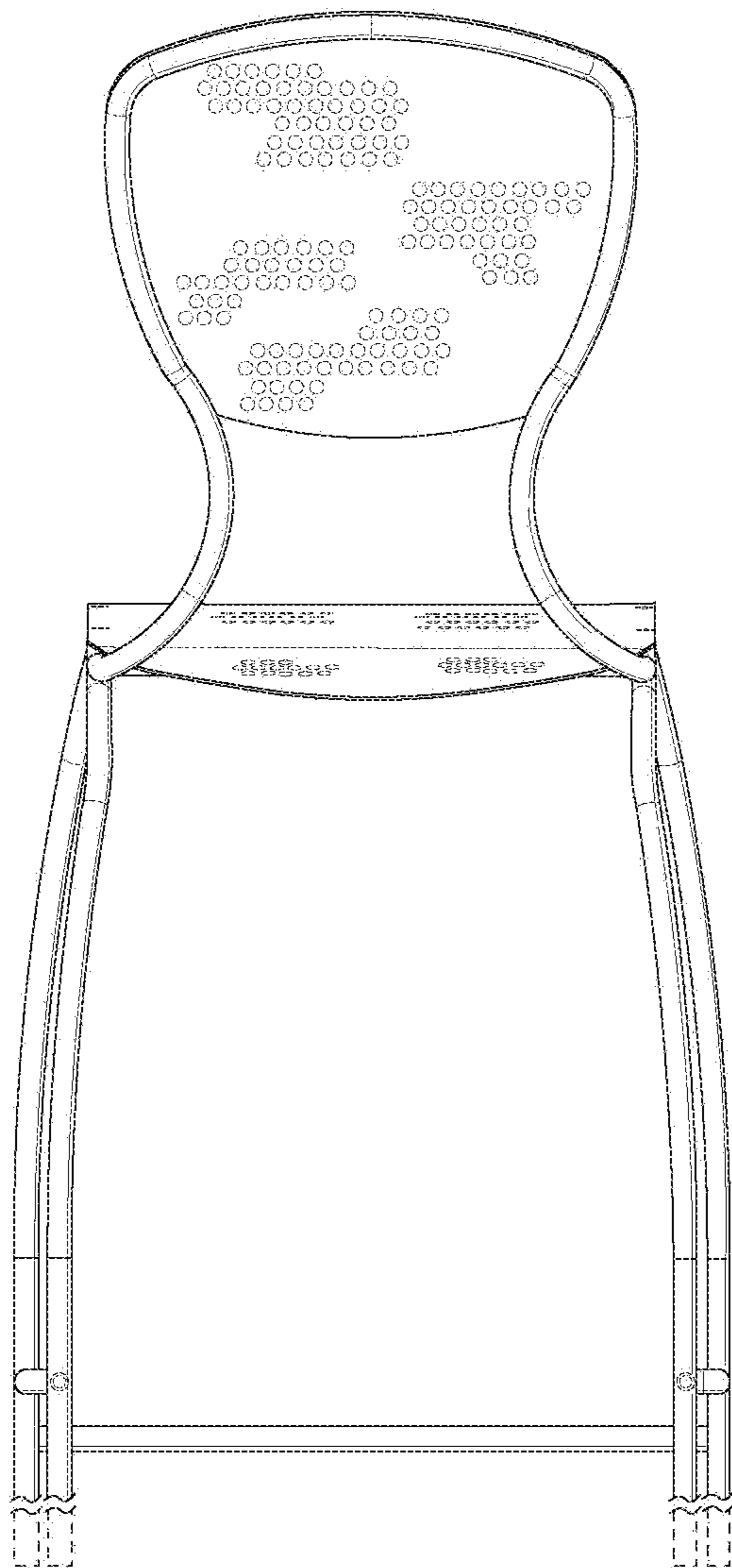

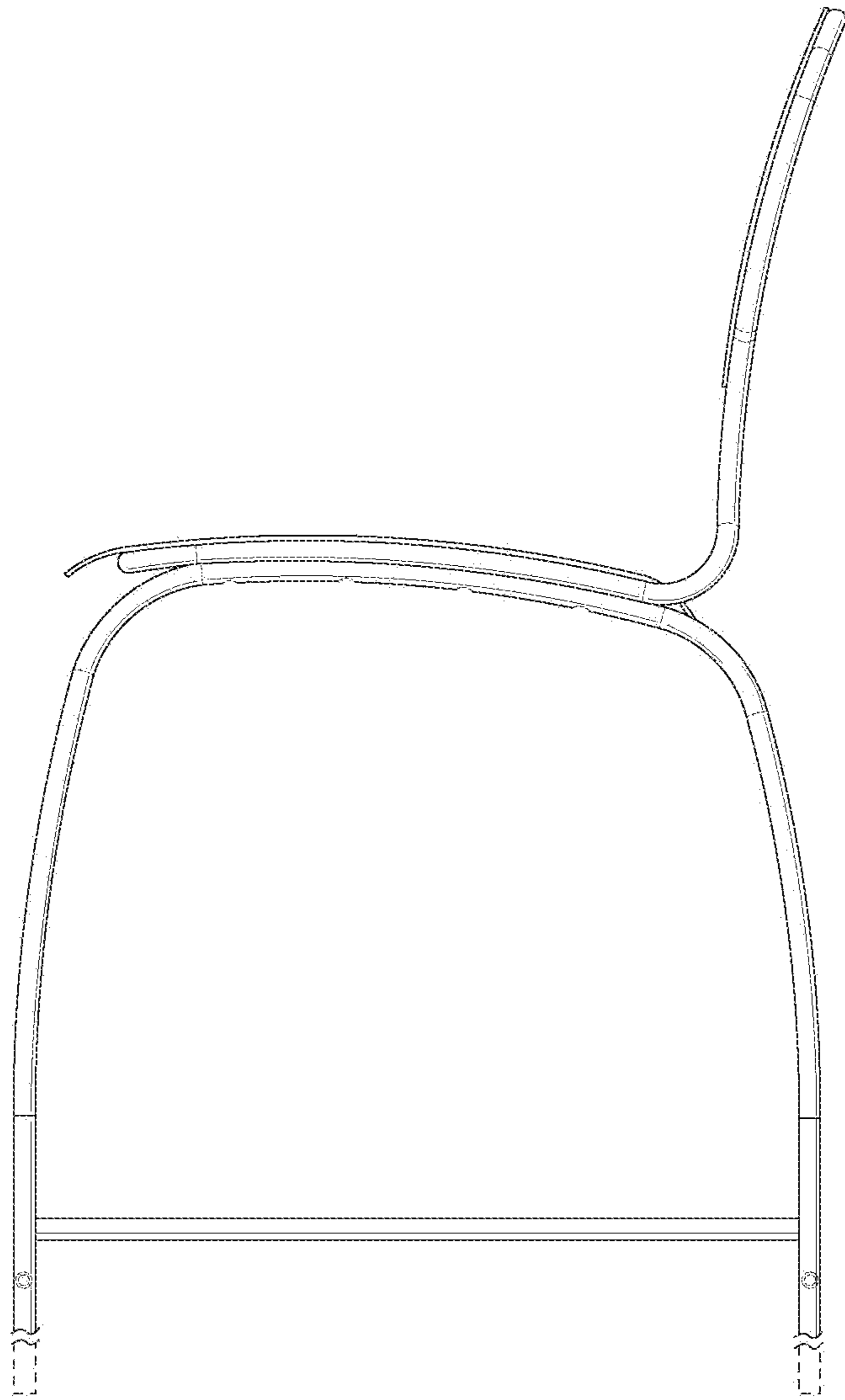

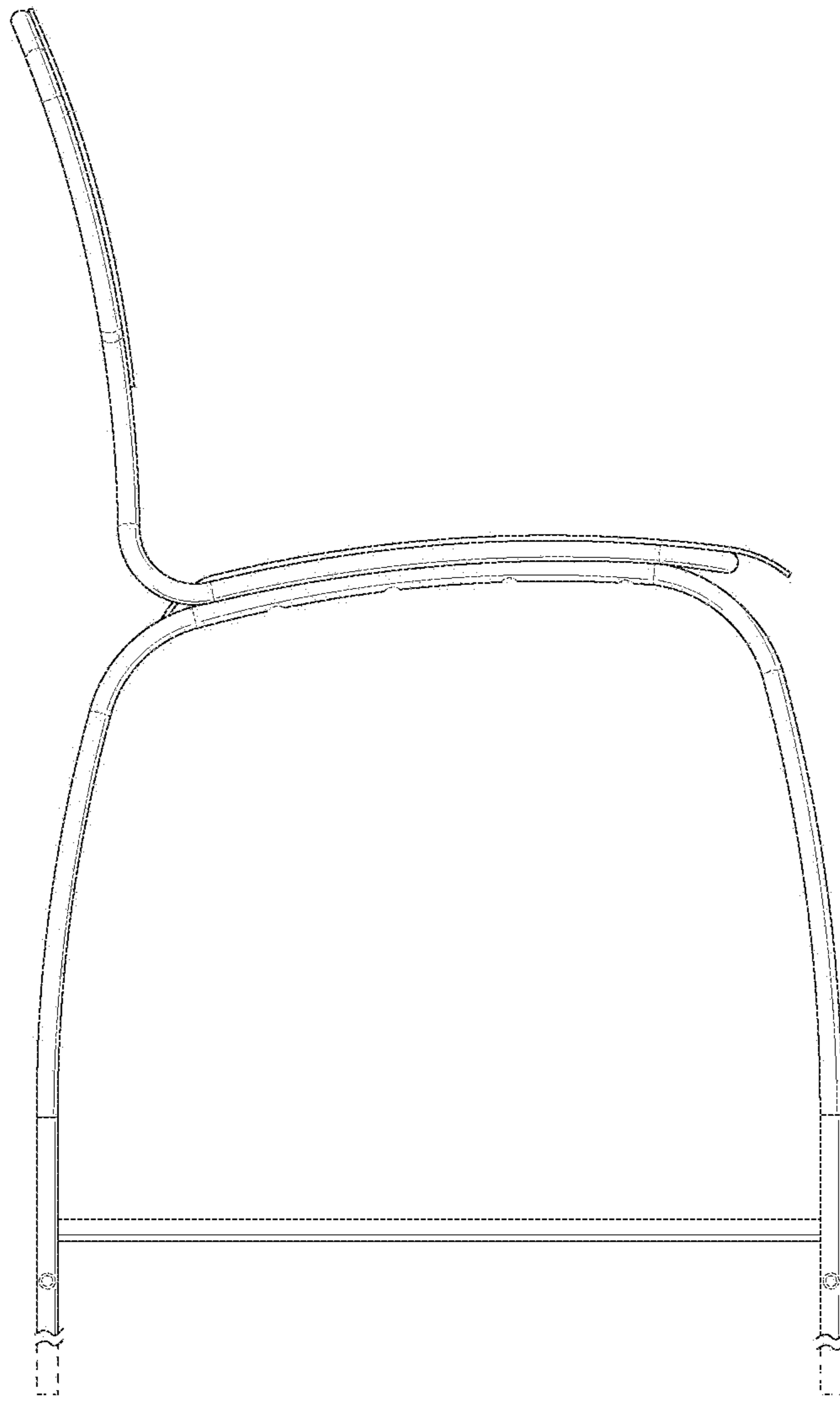
