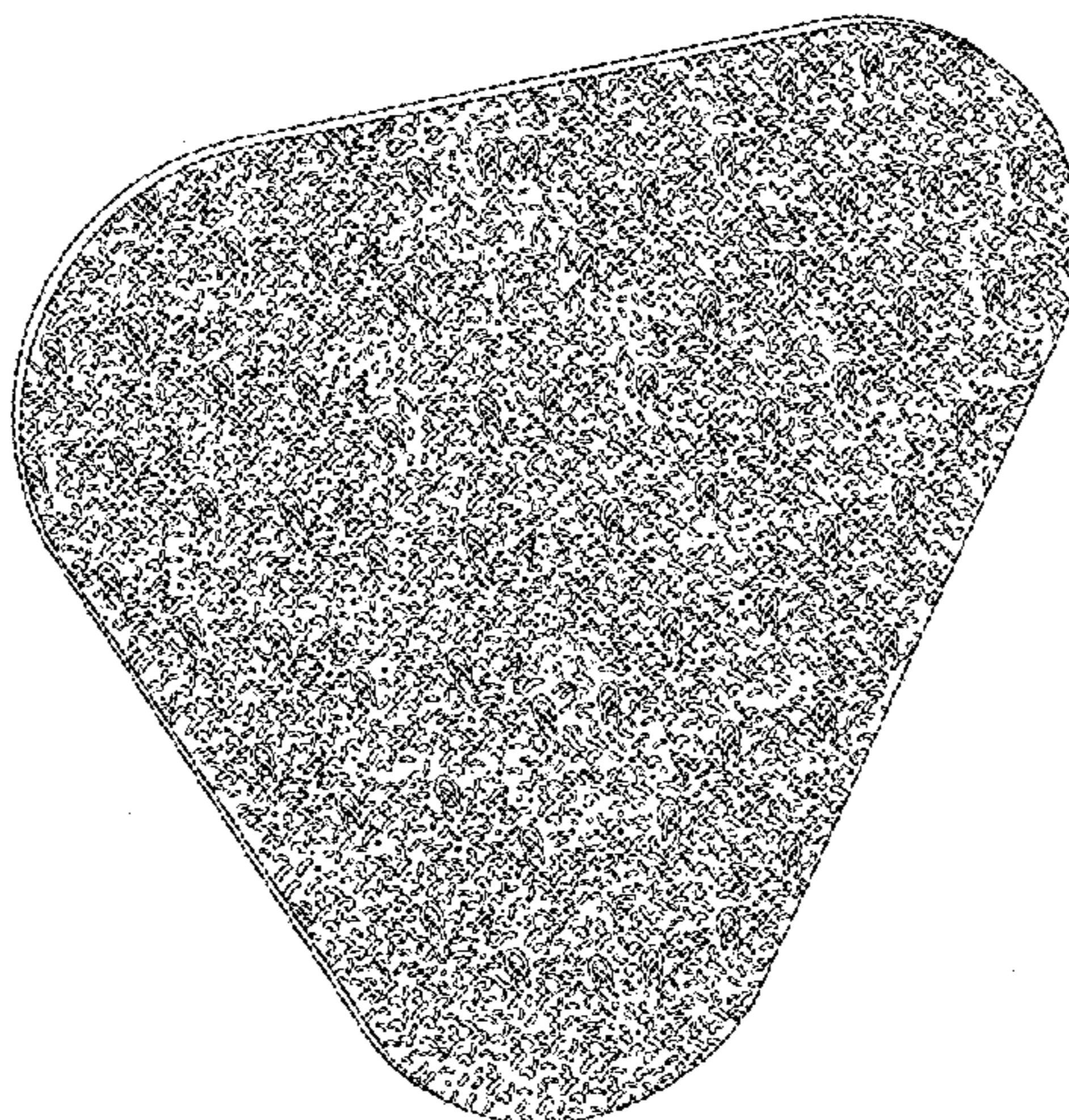
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a triangular urinal floor mat showing my new design;

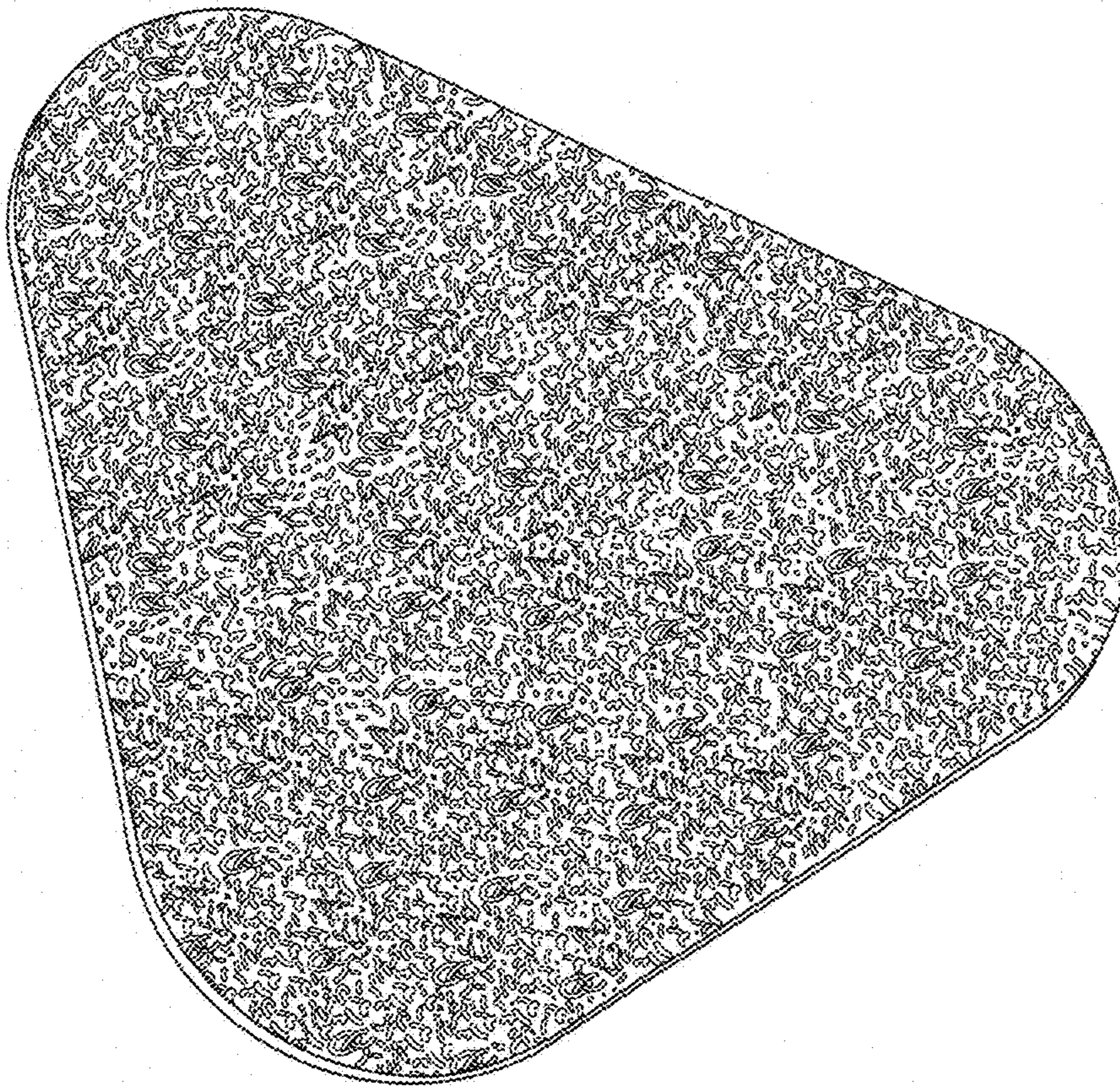

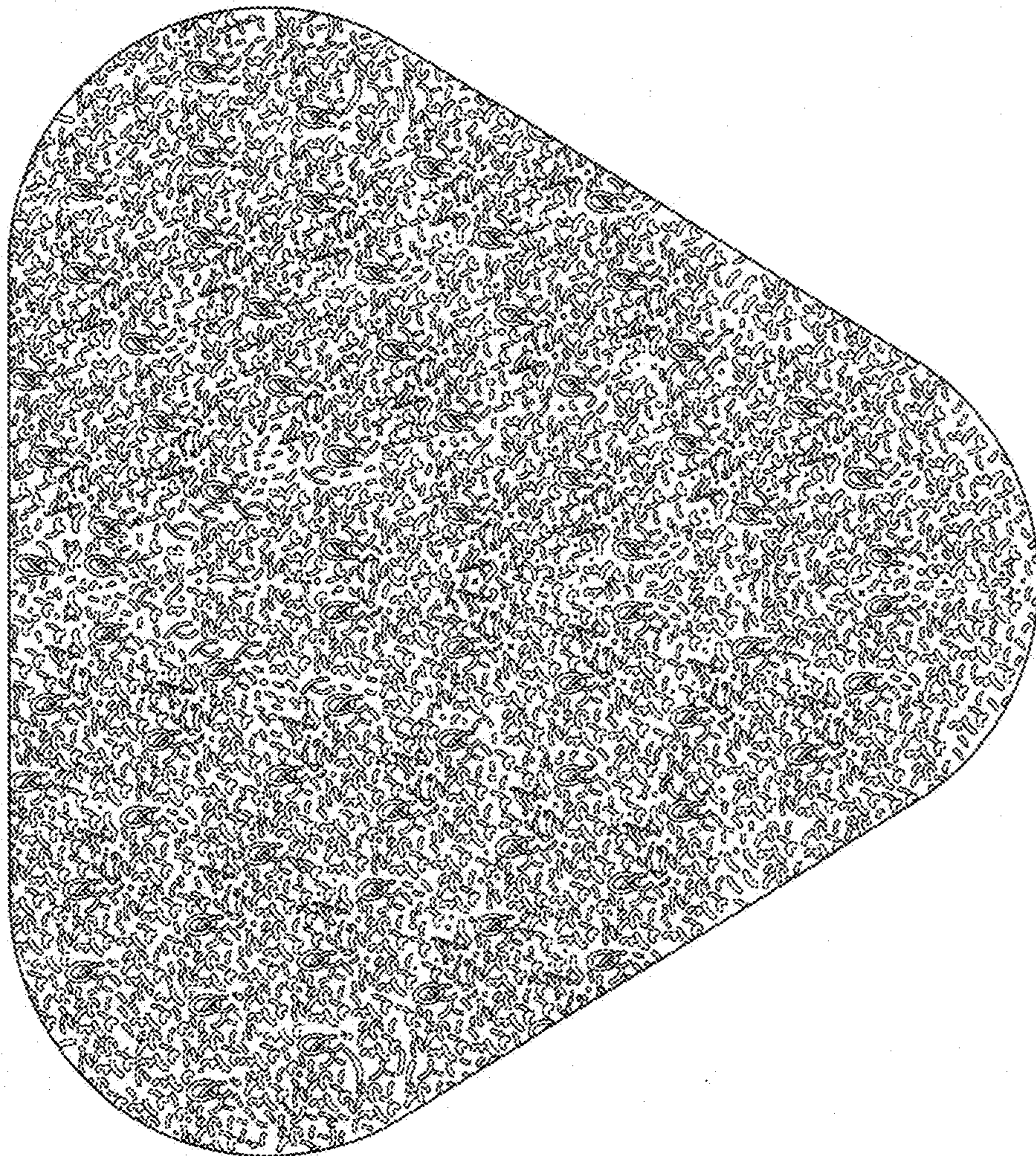

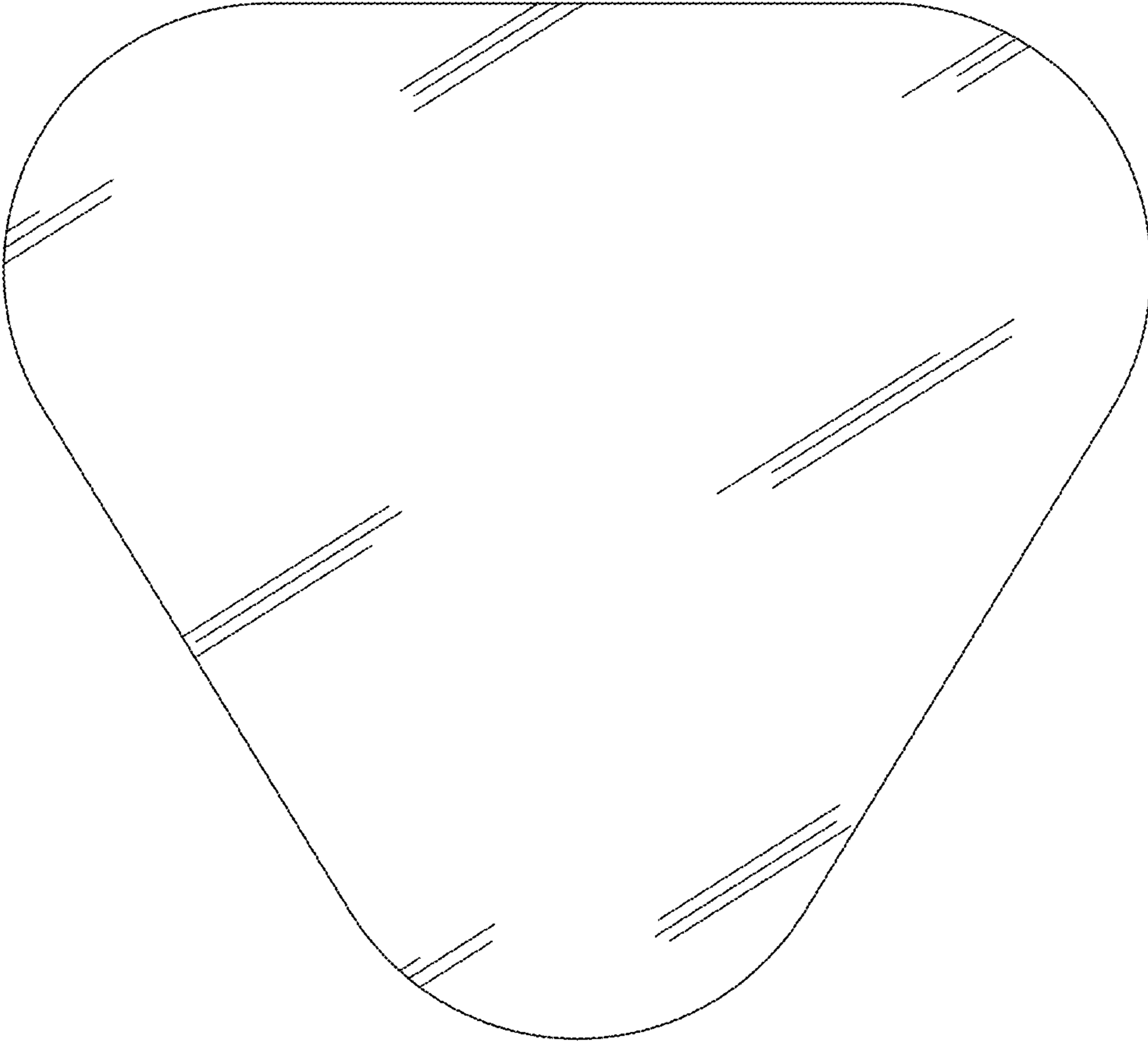
