(57) **CLAIM**

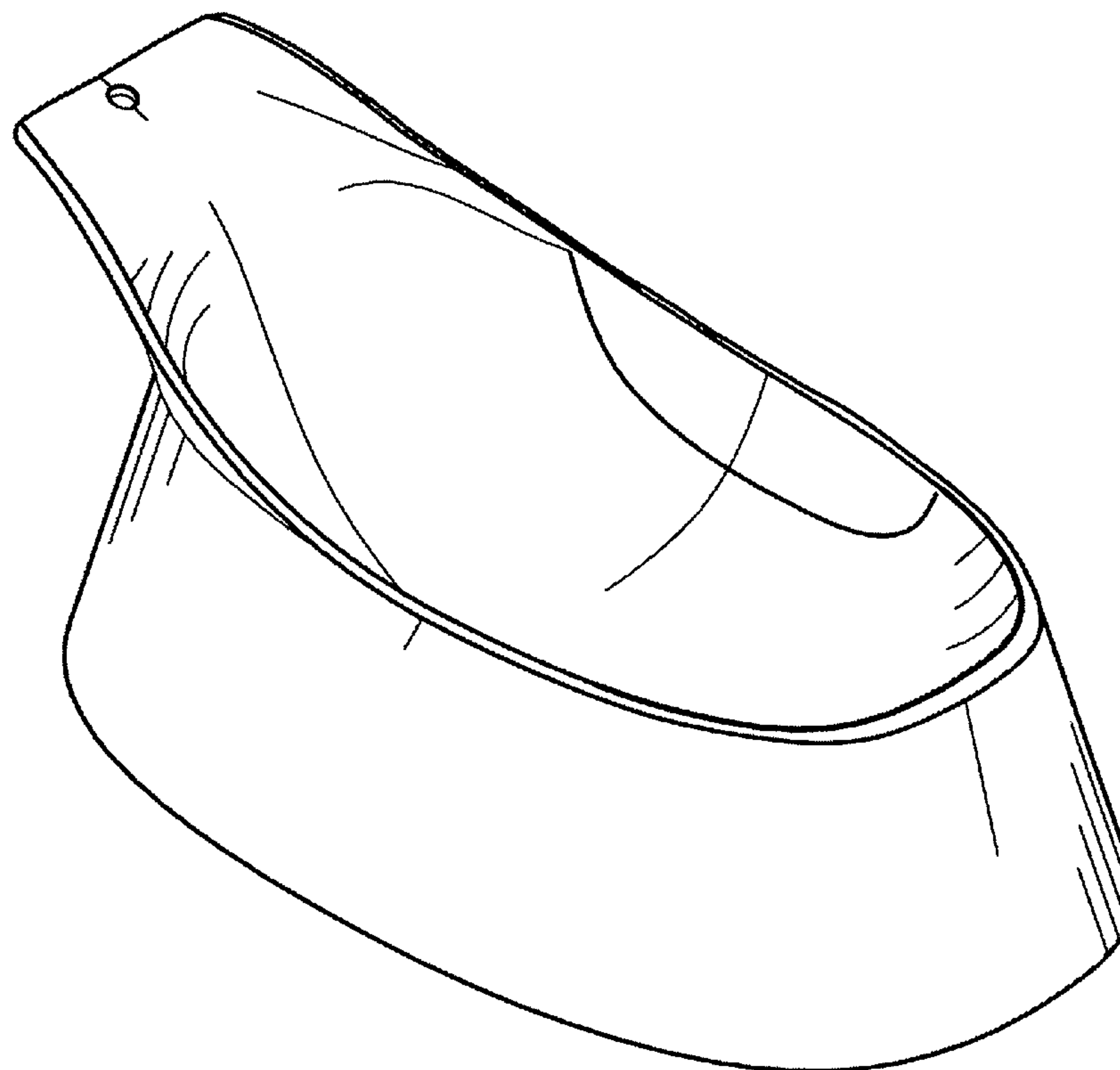
The ornamental design for a bowl, as shown and described.

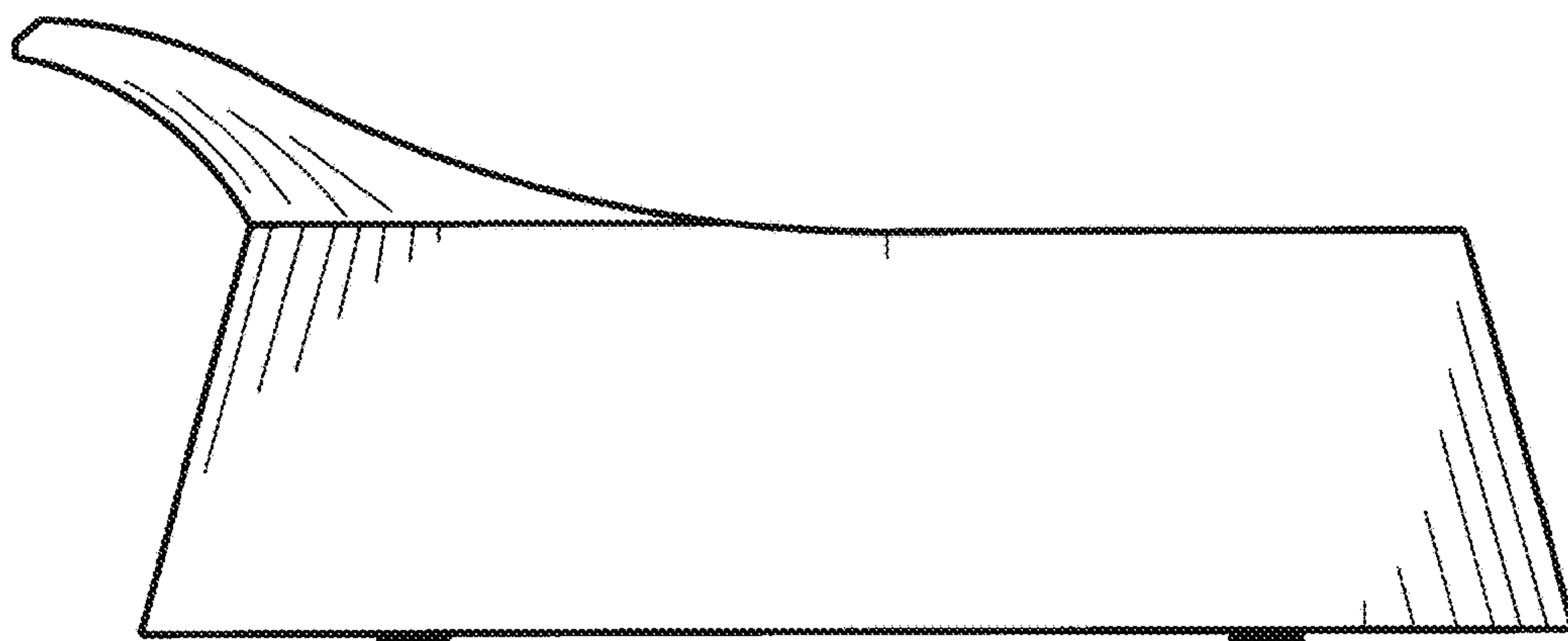

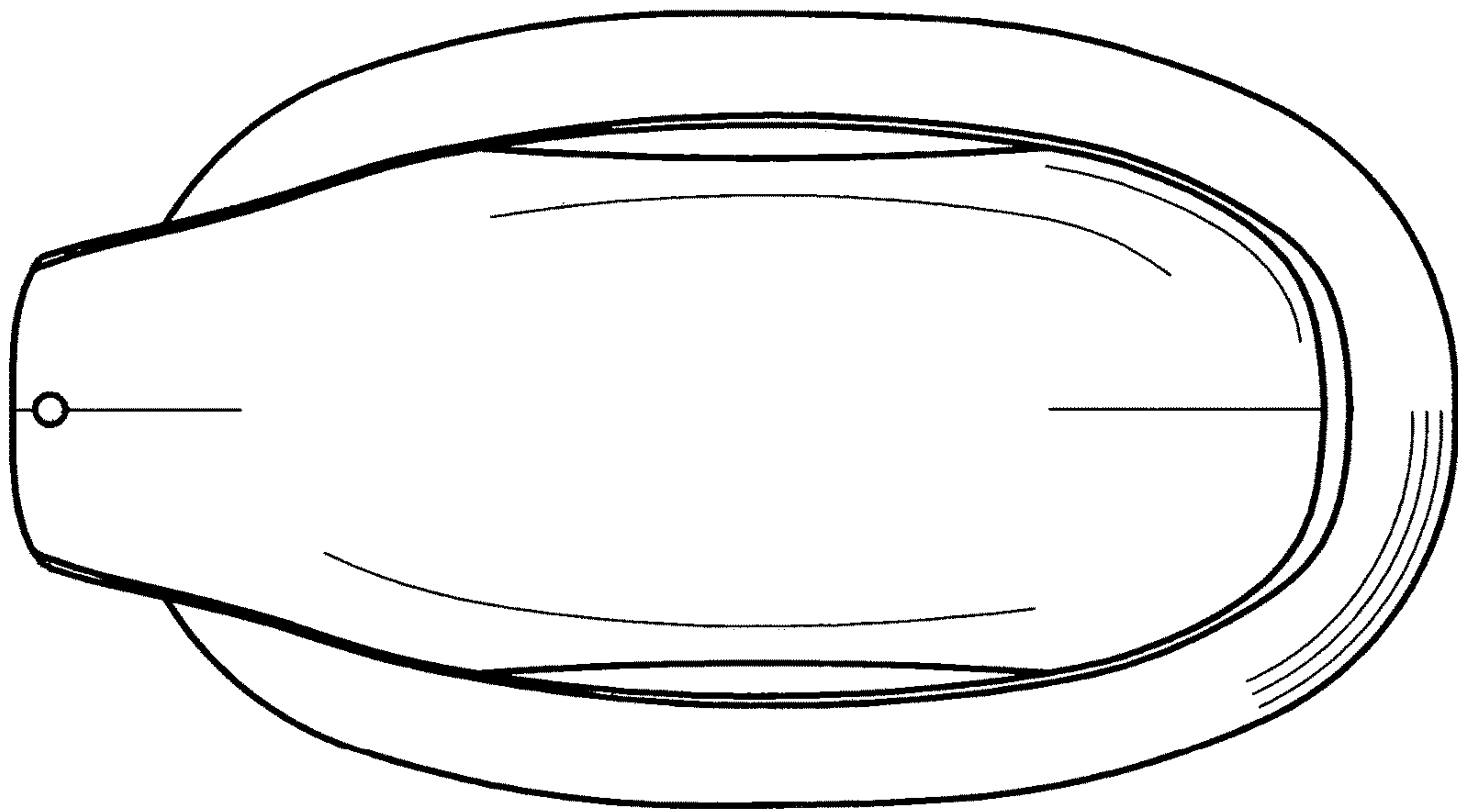

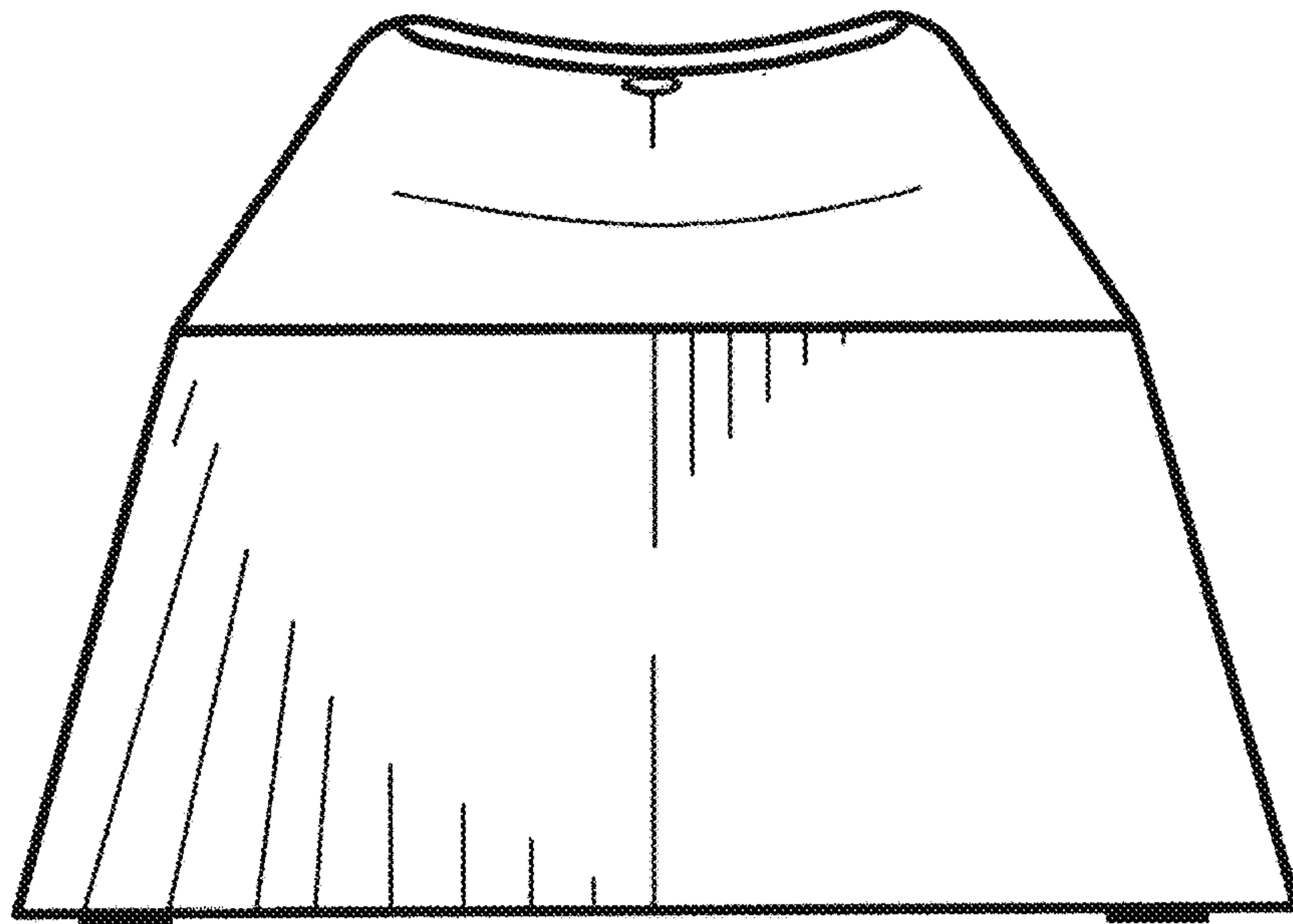

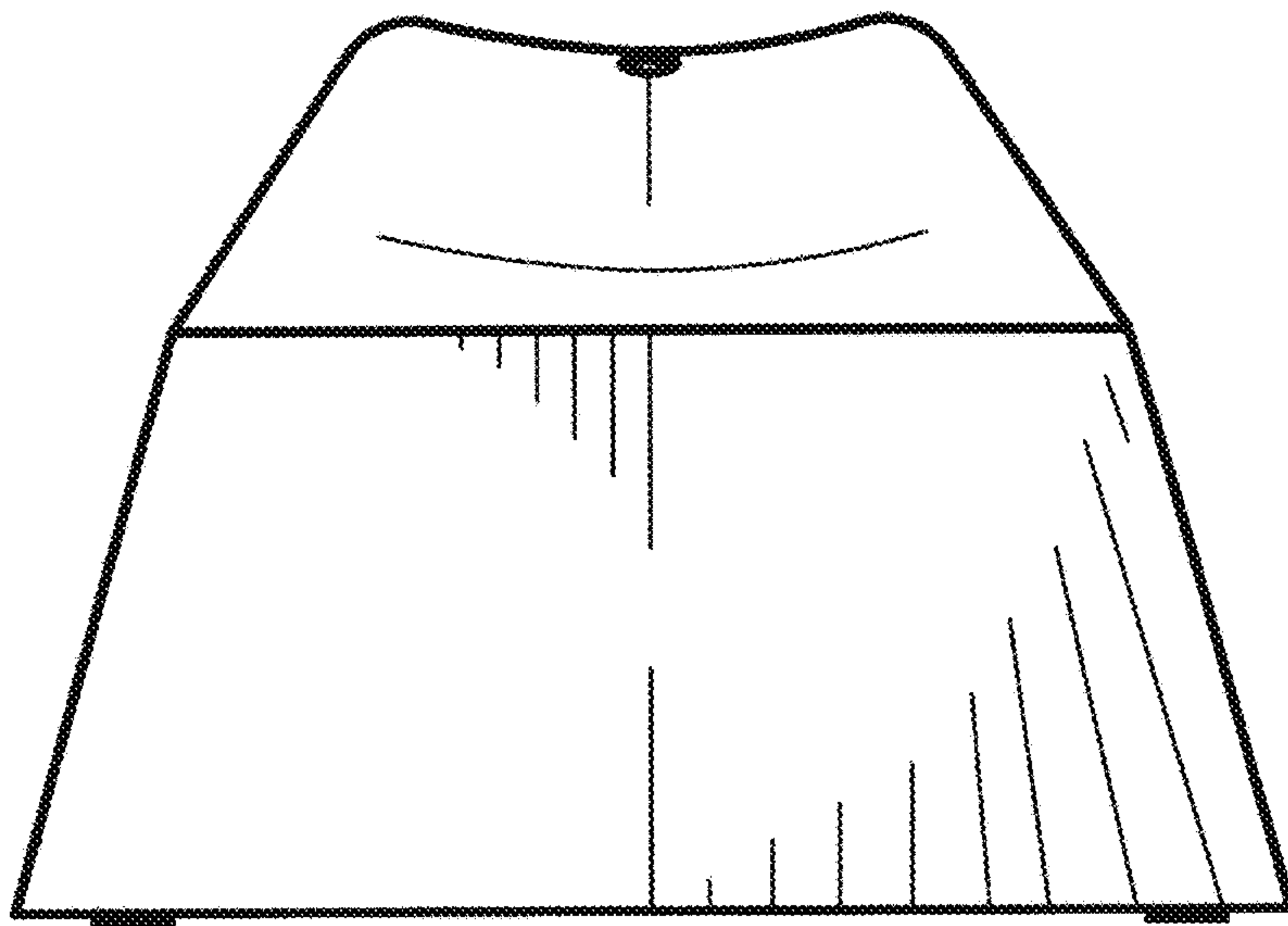

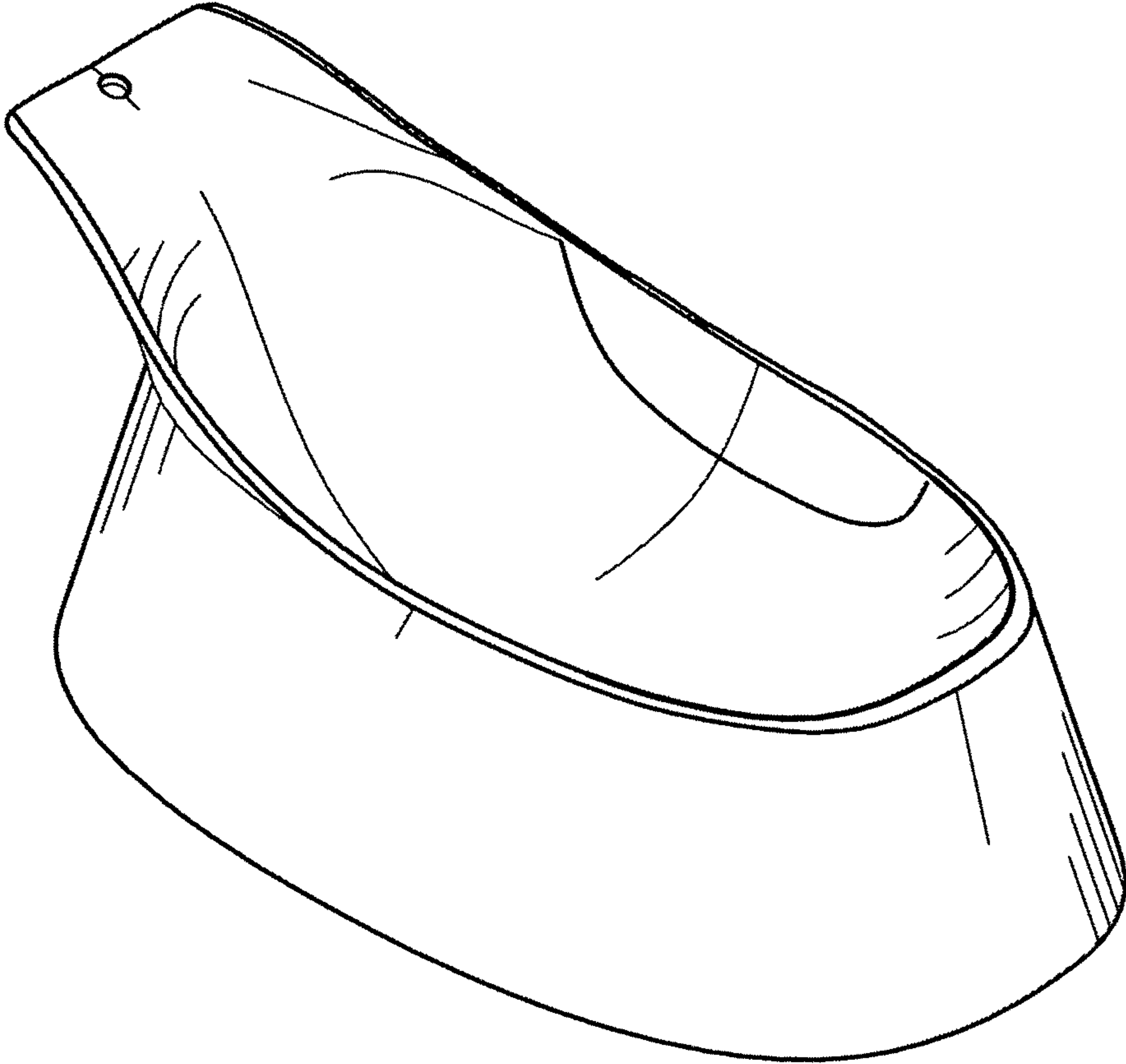
