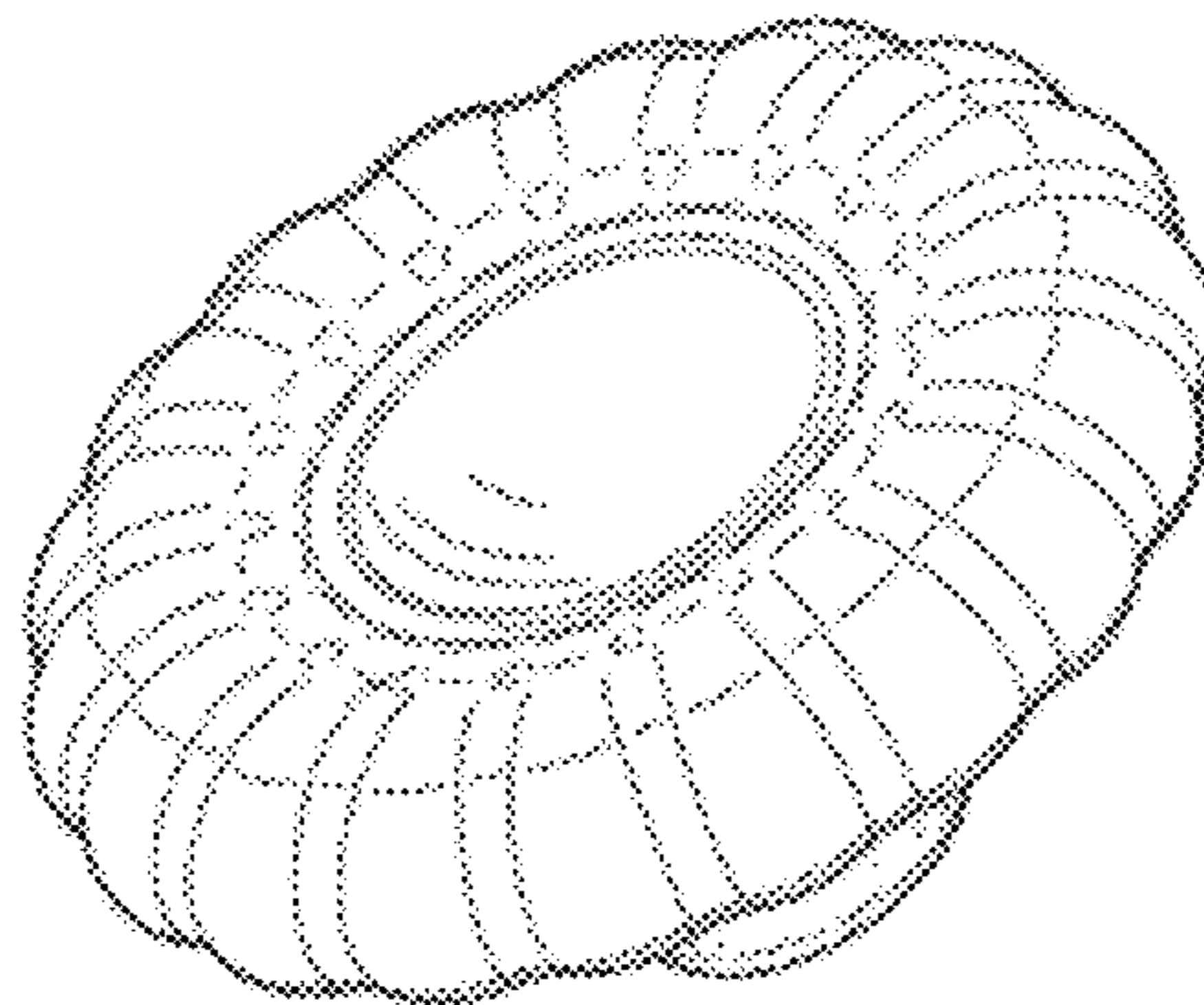
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a hook according to an embodiment;  
FIG. 2 is a top plan view of the hook of FIG. 1;  
FIG. 3 is a side elevation view of the hook of FIG. 1;  
FIG. 4 is a perspective view of a hook according to another embodiment;  
FIG. 5 is a top plan view of the hook of FIG. 4; and,  
FIG. 6 is a side elevation view of the hook of FIG. 4.

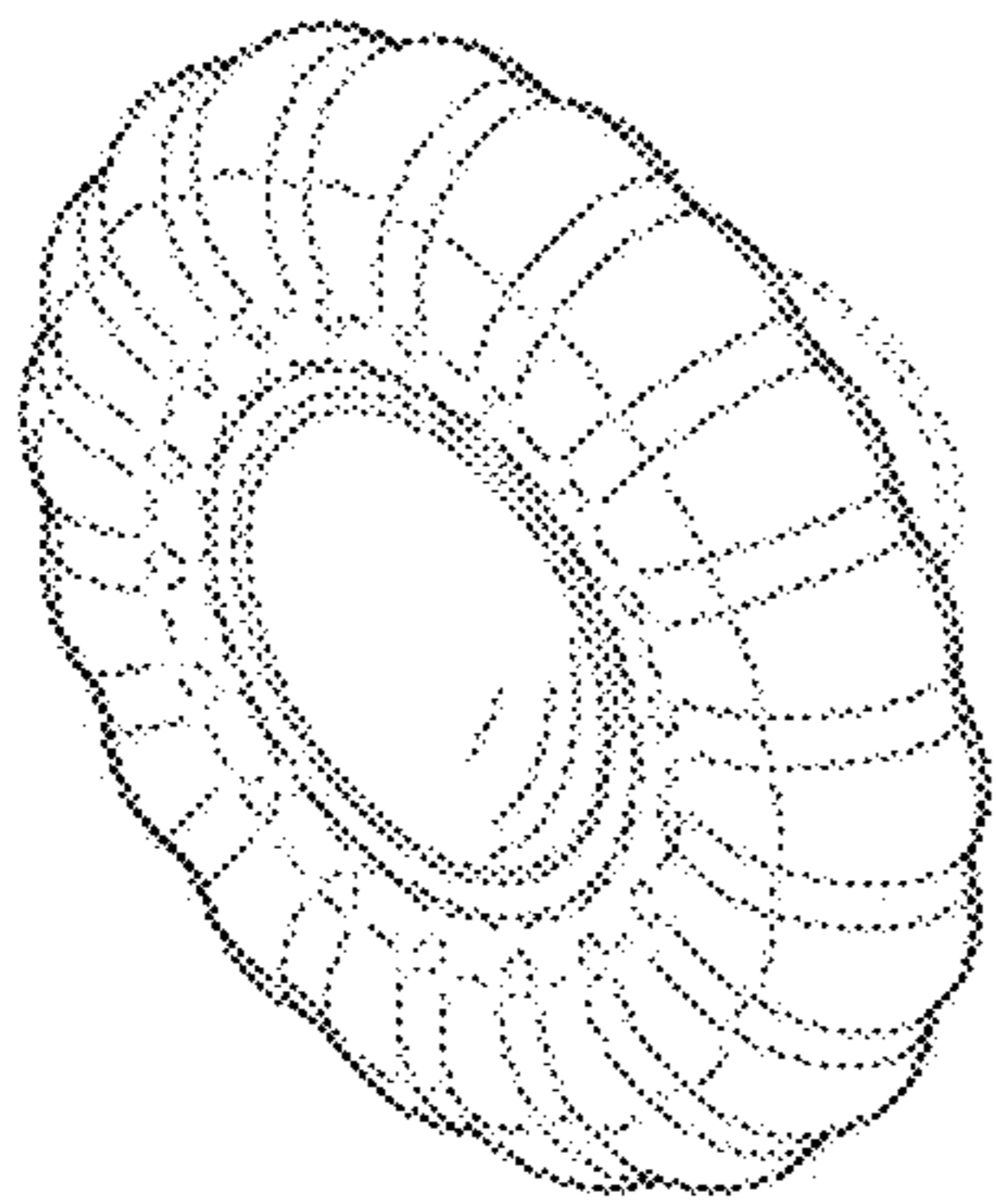

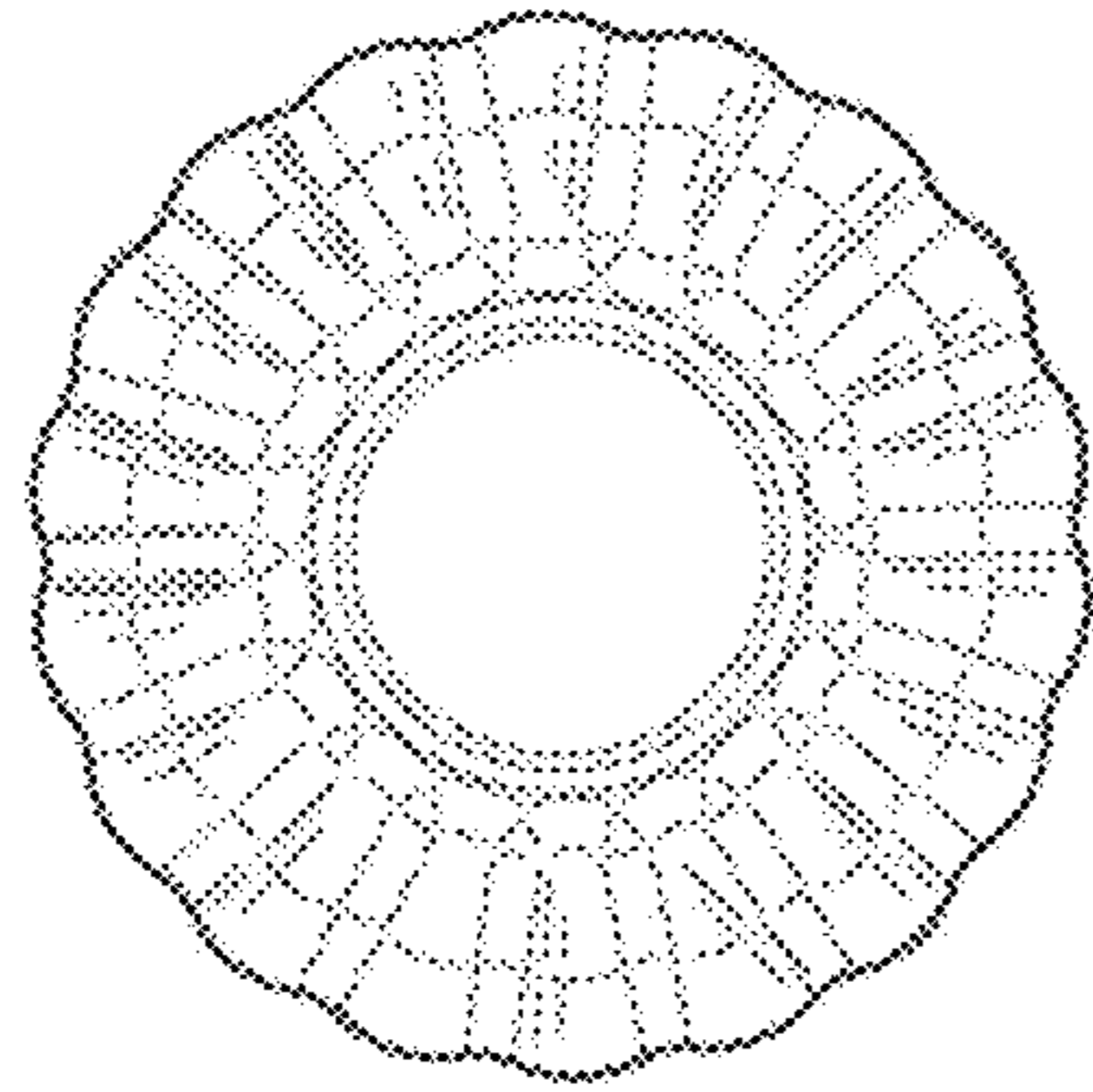

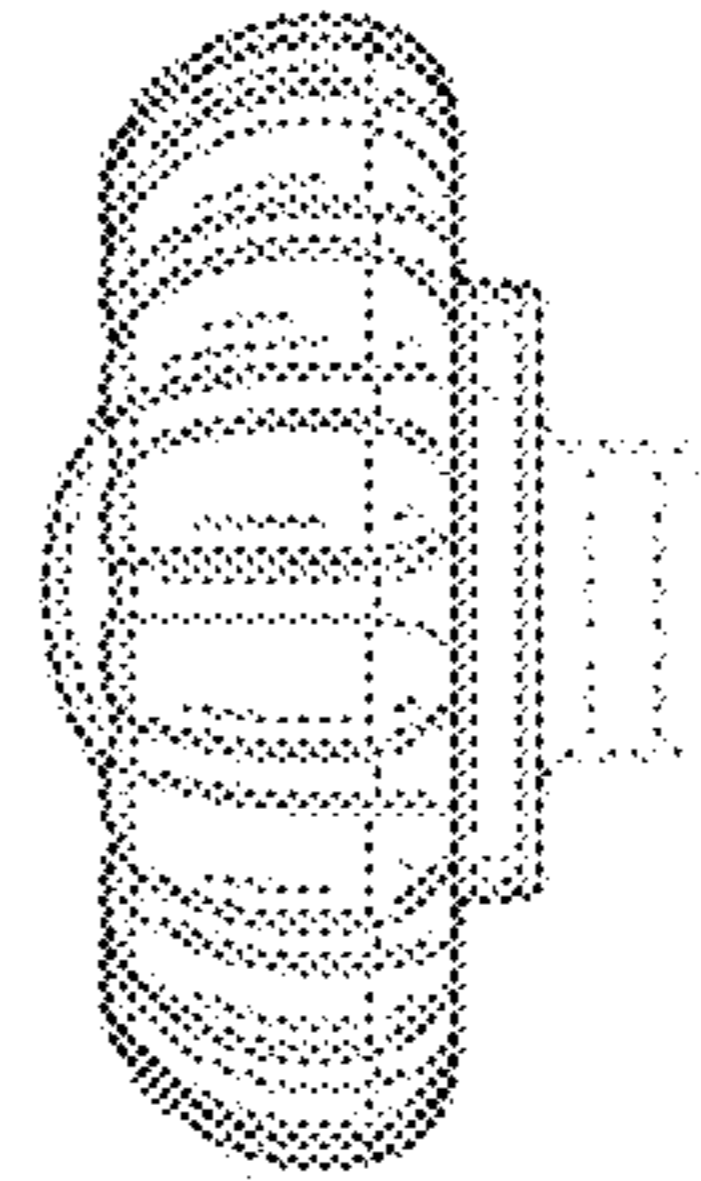

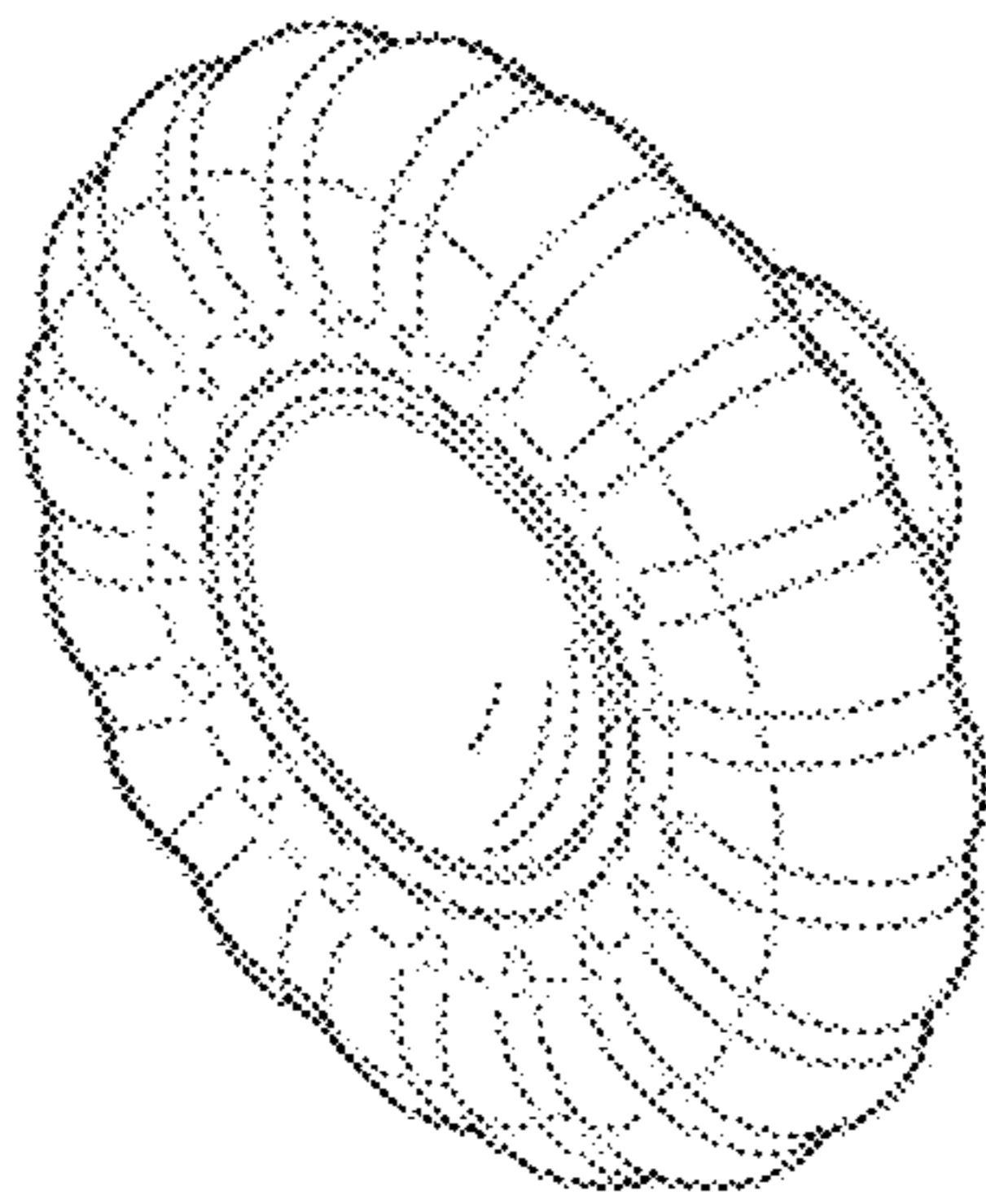

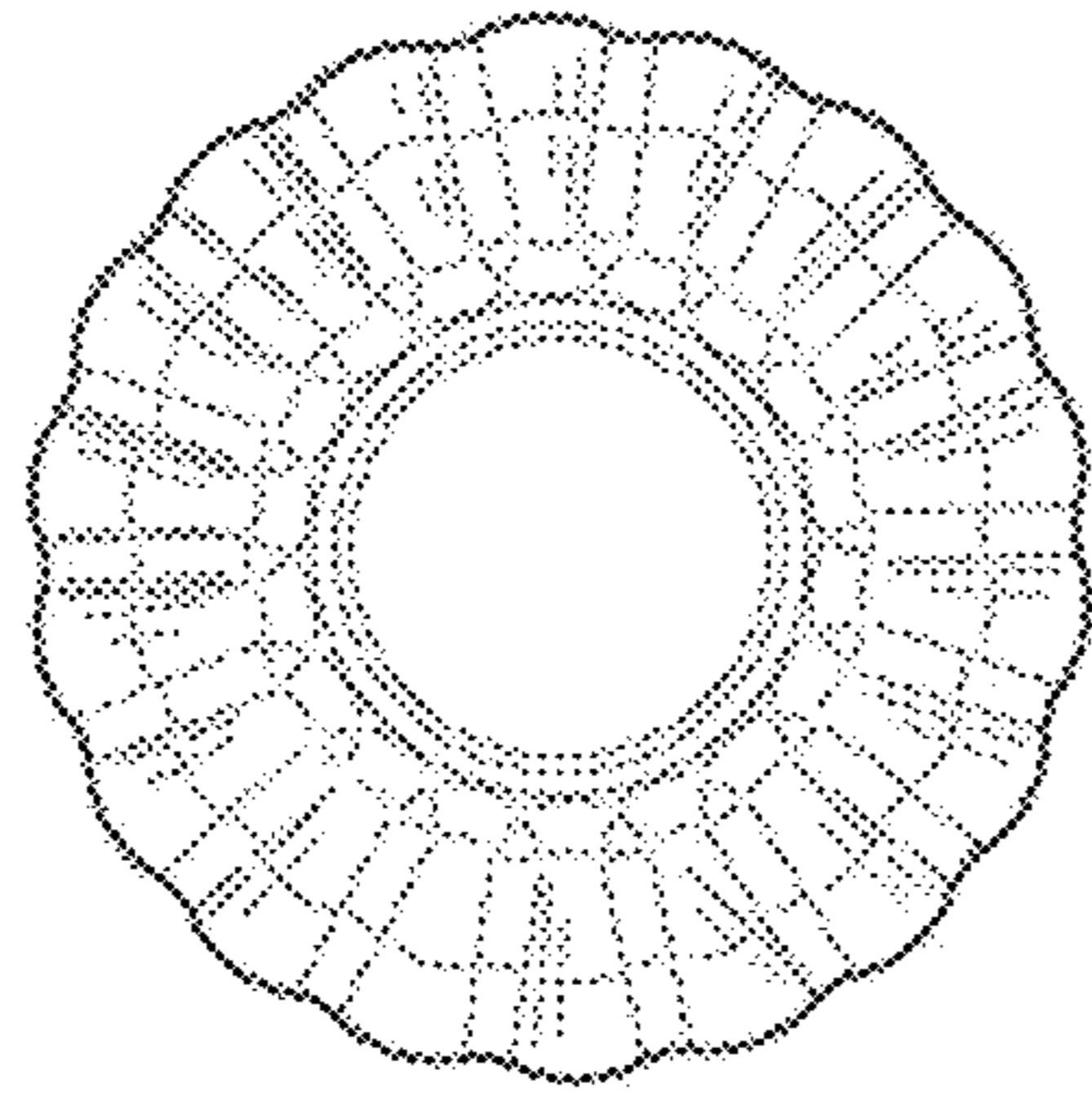

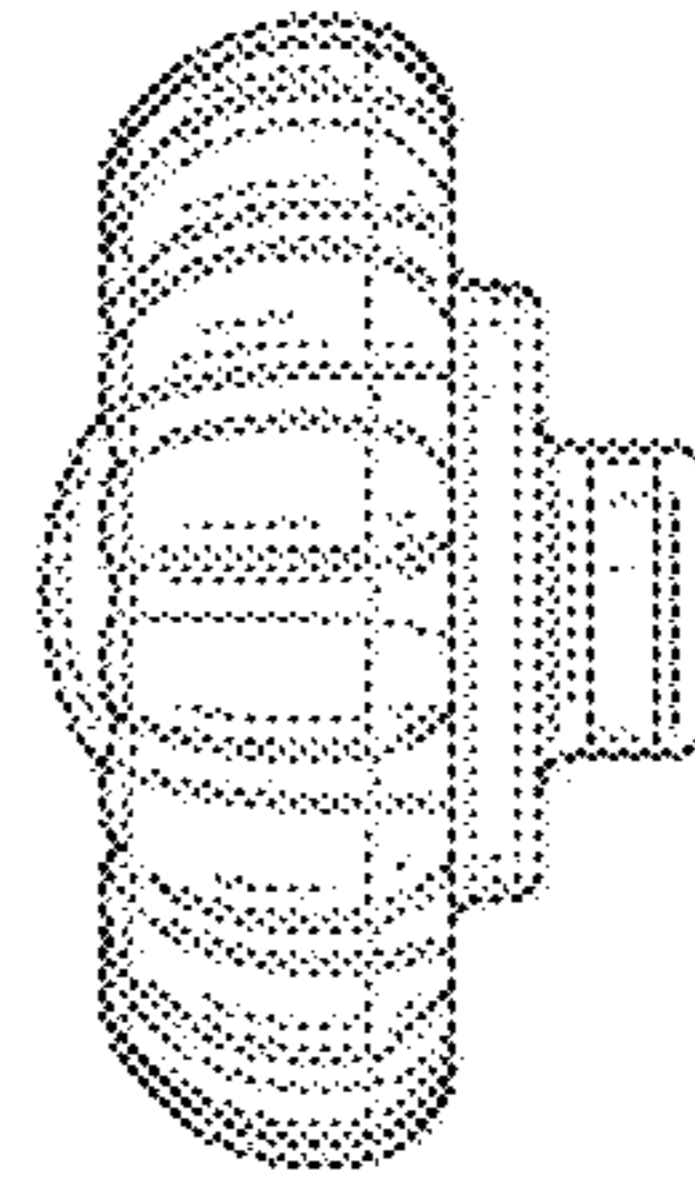
