(57) **CLAIM**

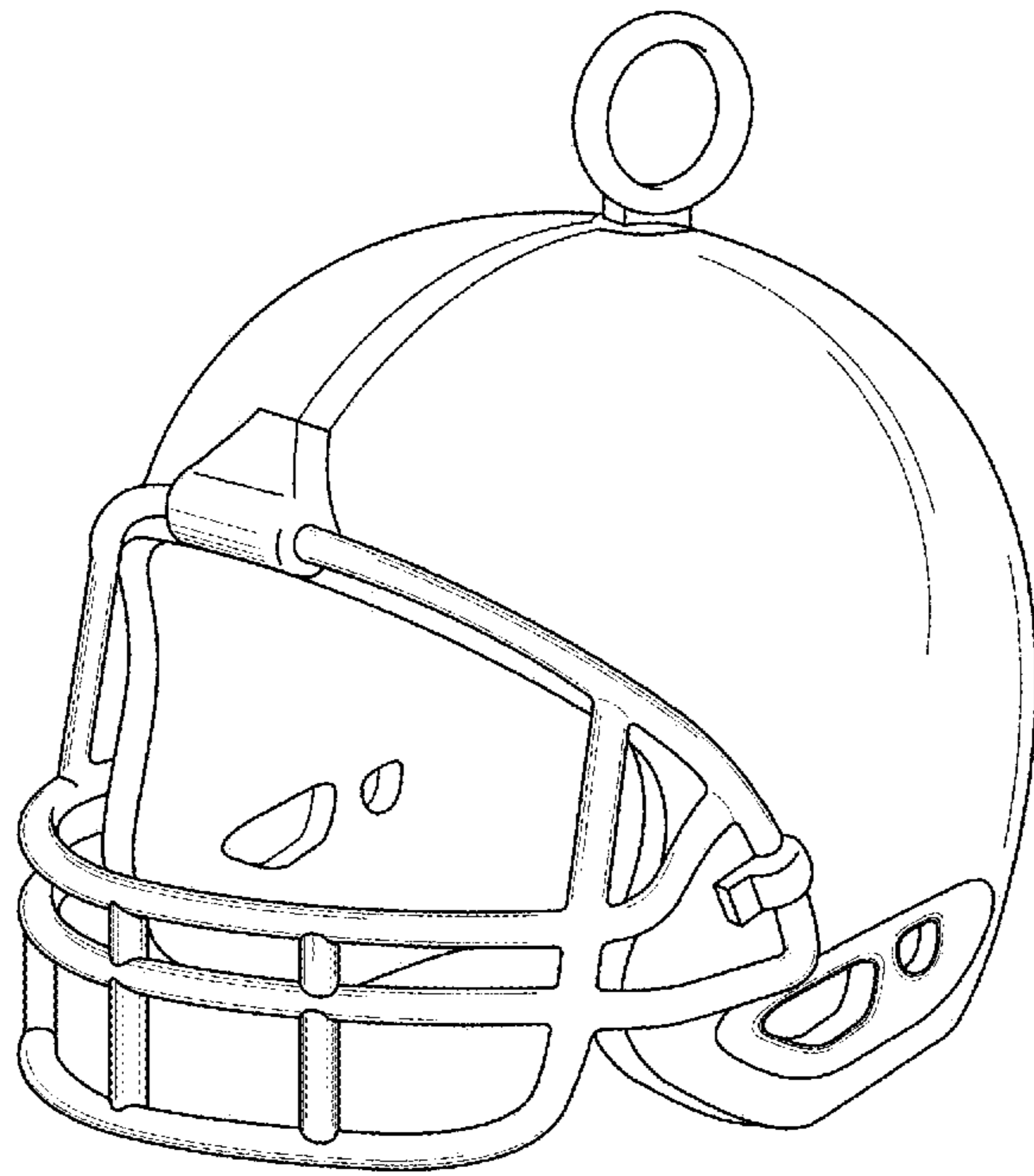
The ornamental design for a football helmet piece, as shown and described.

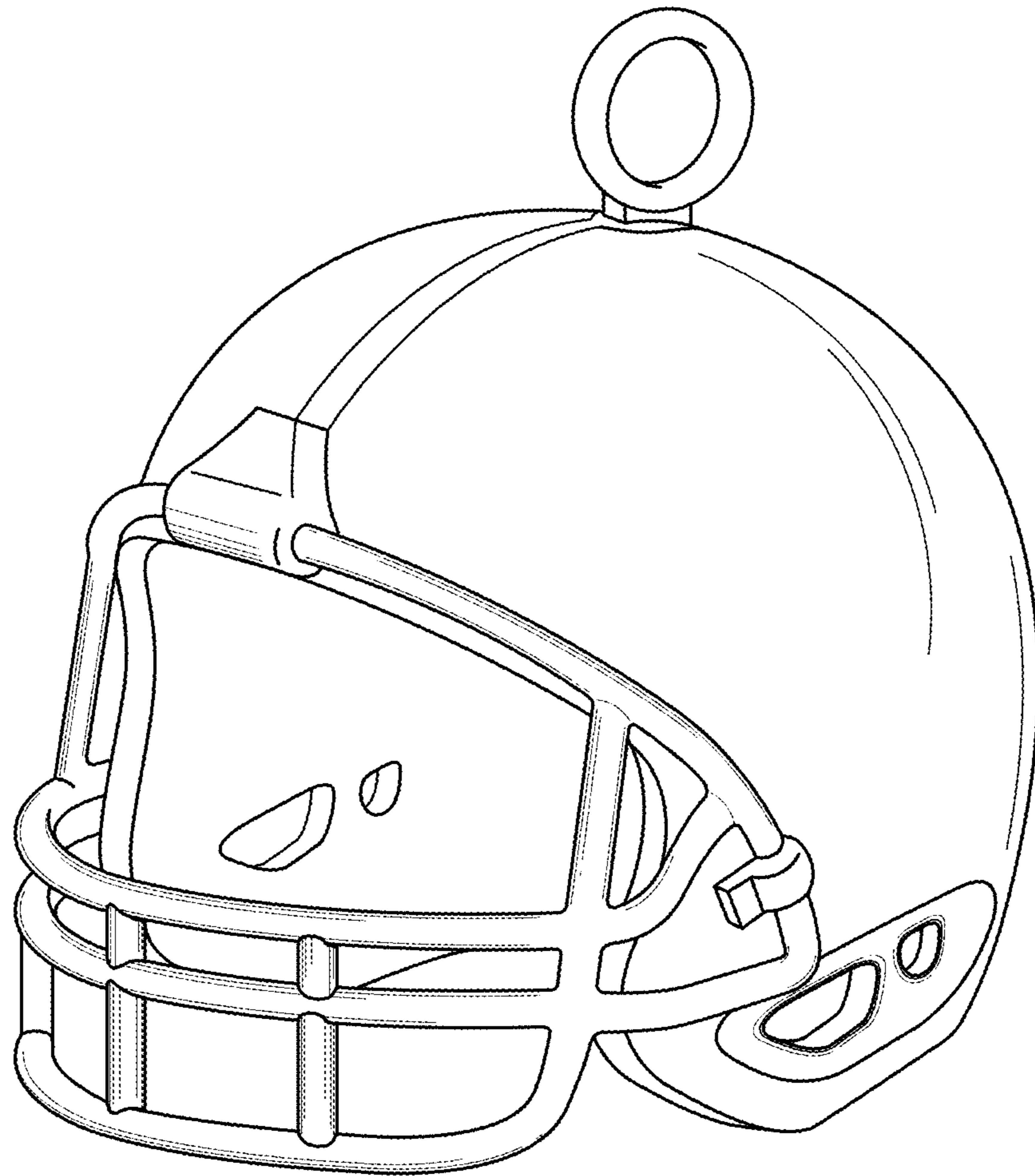

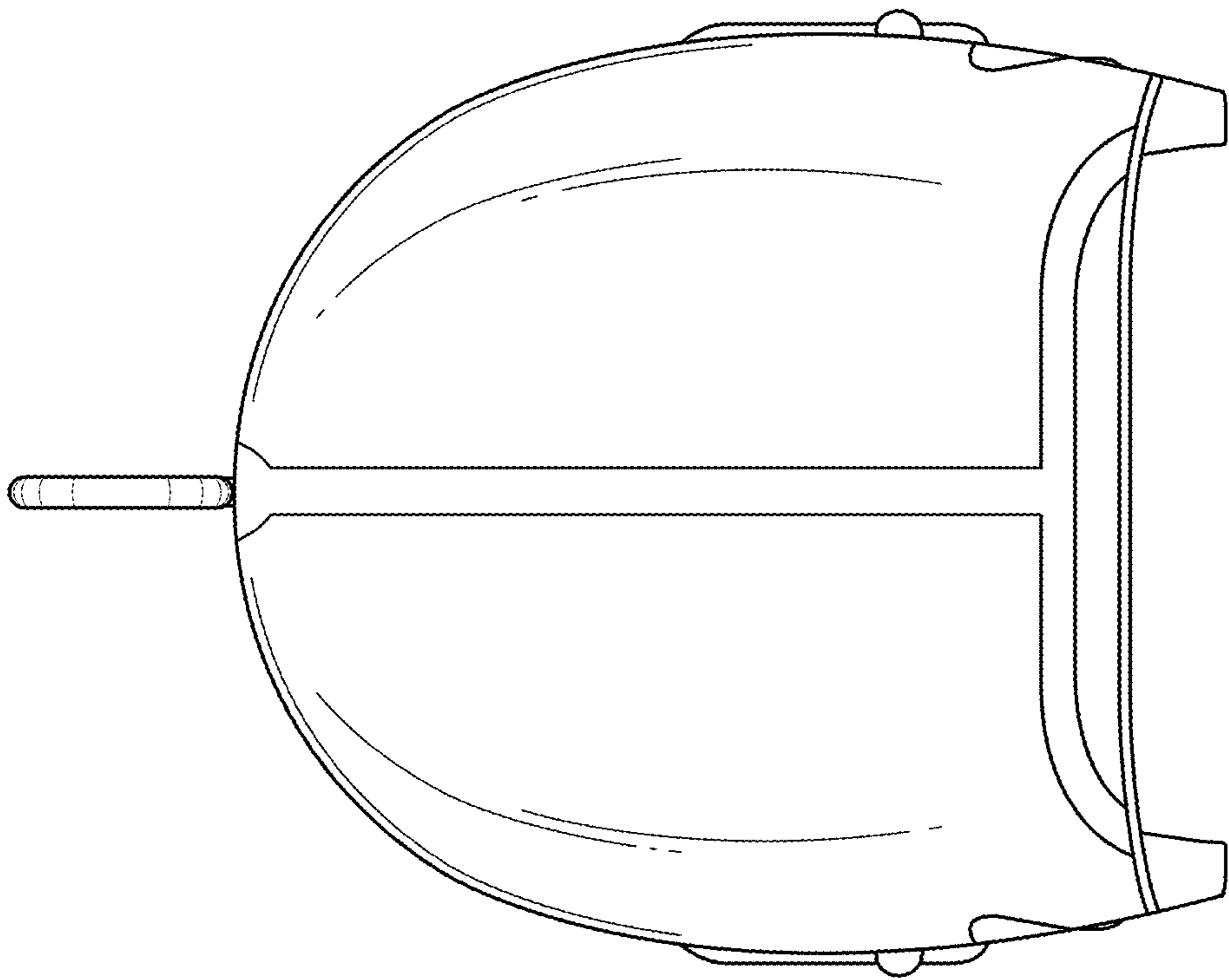

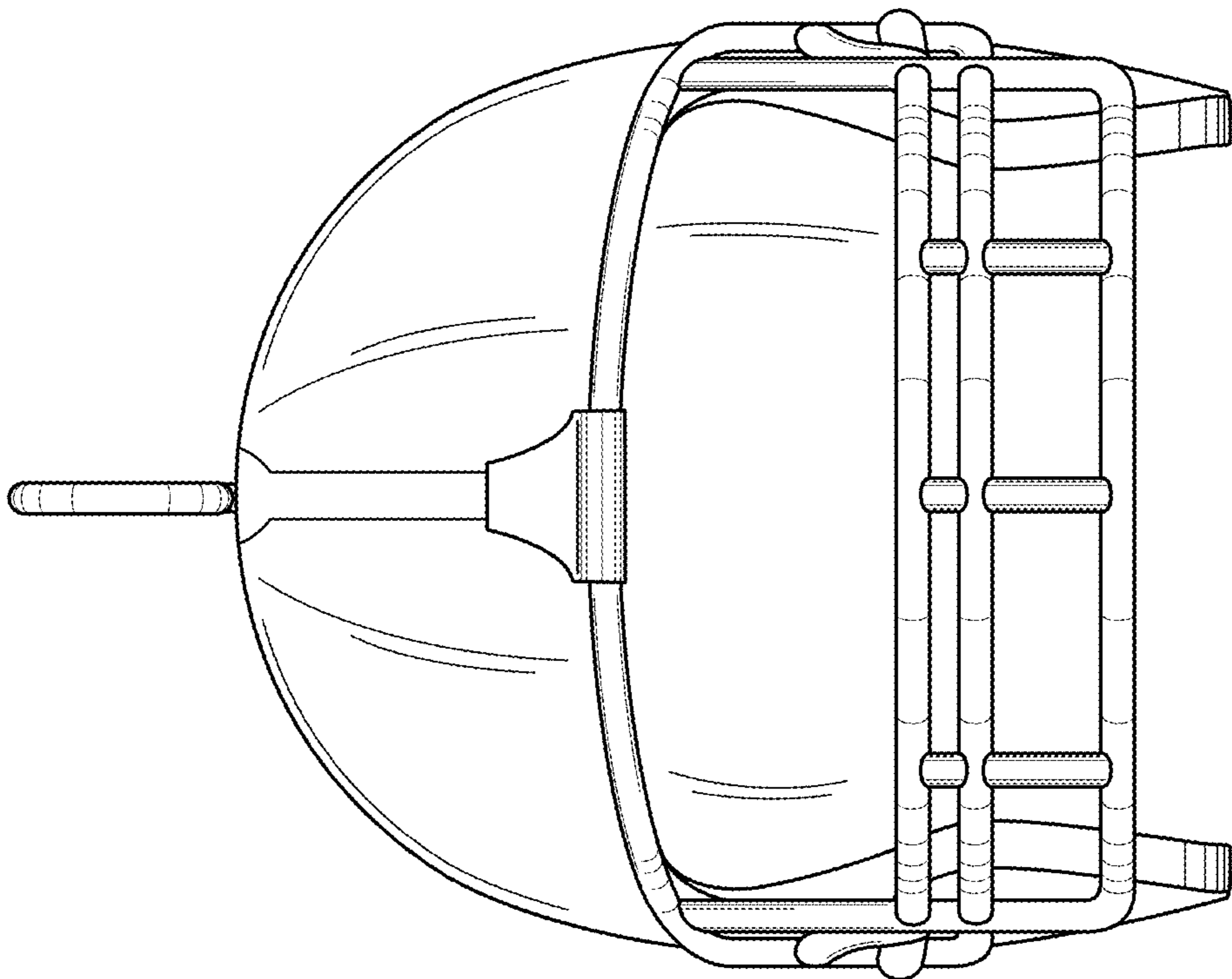

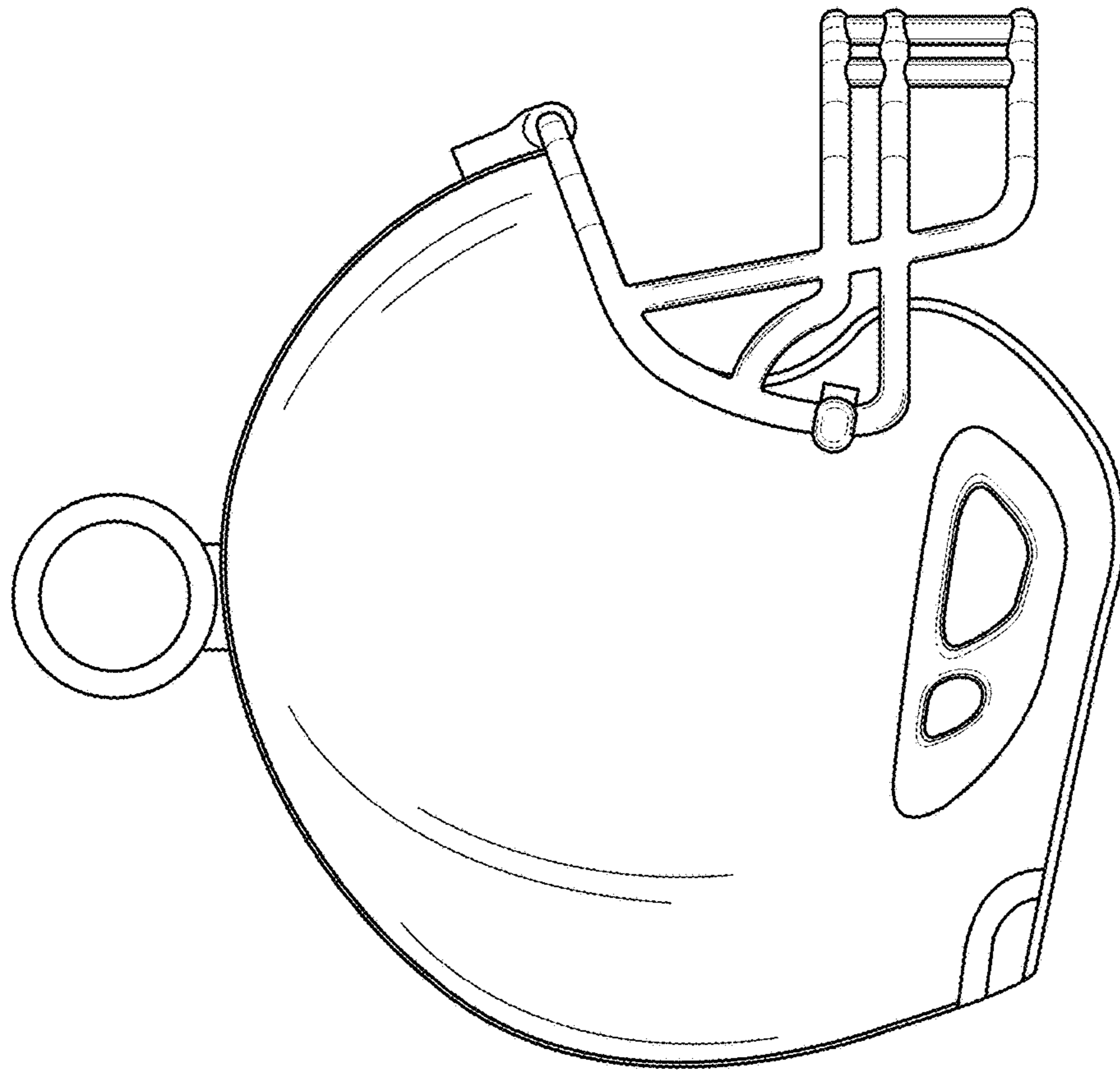

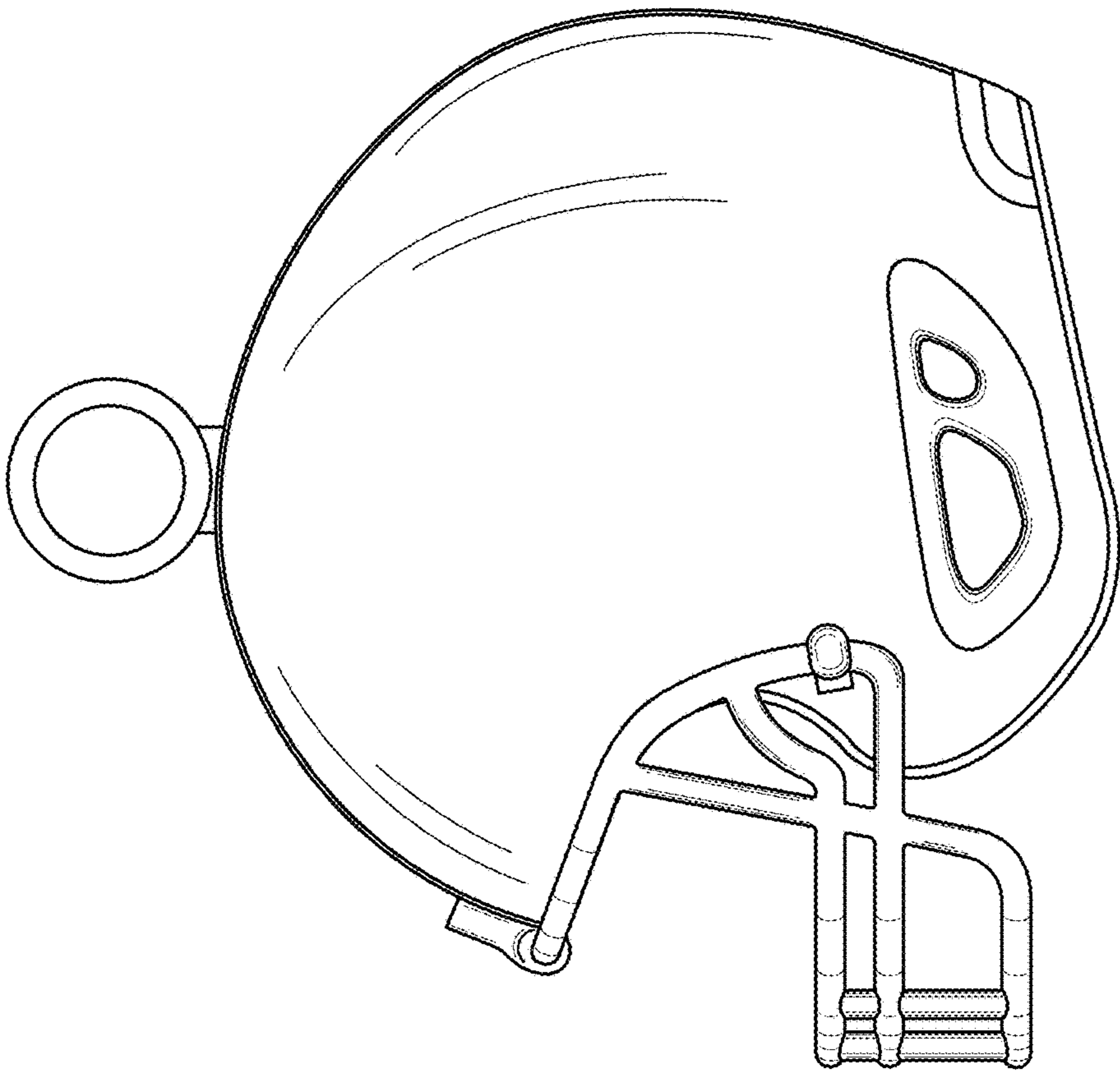

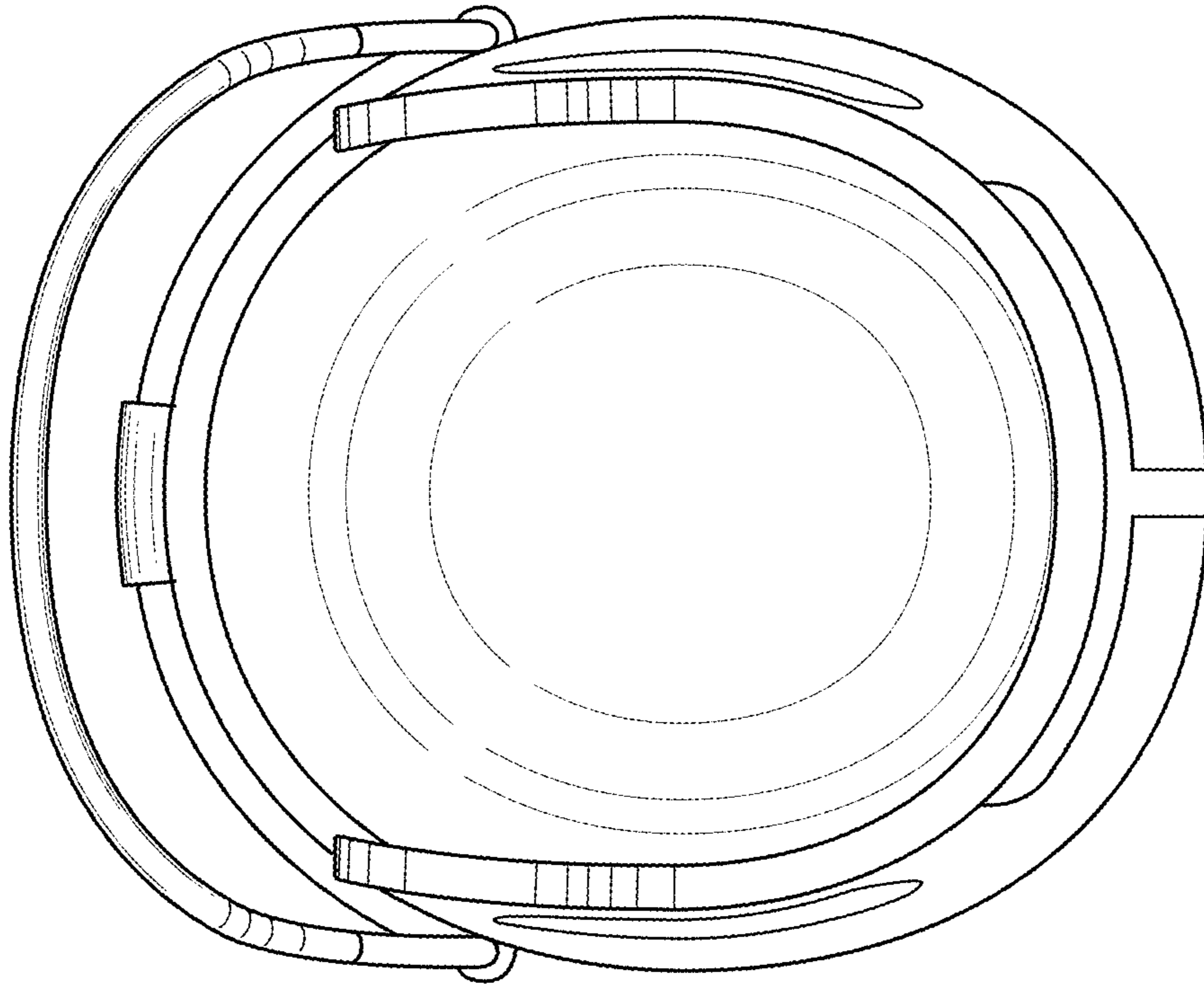

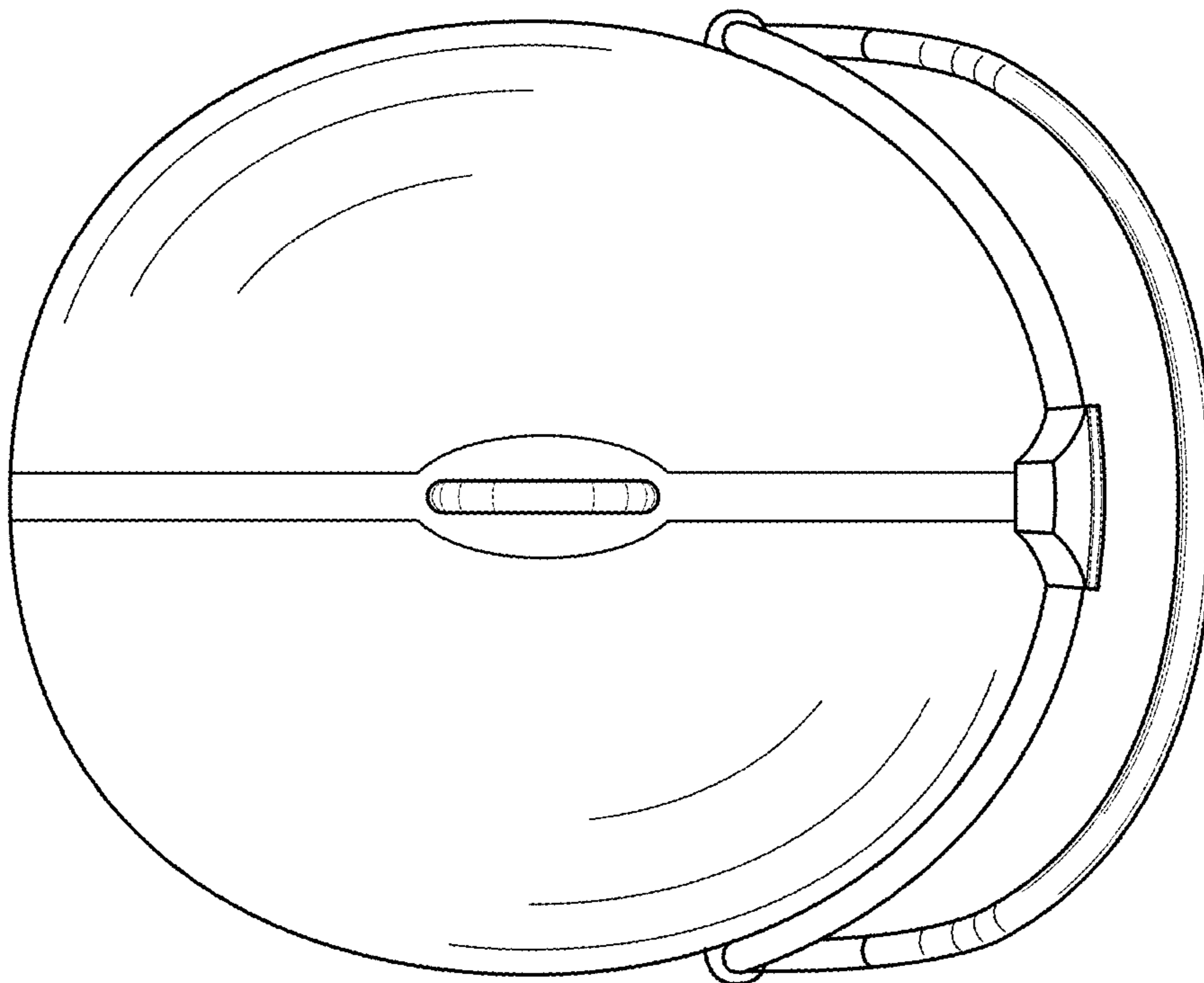

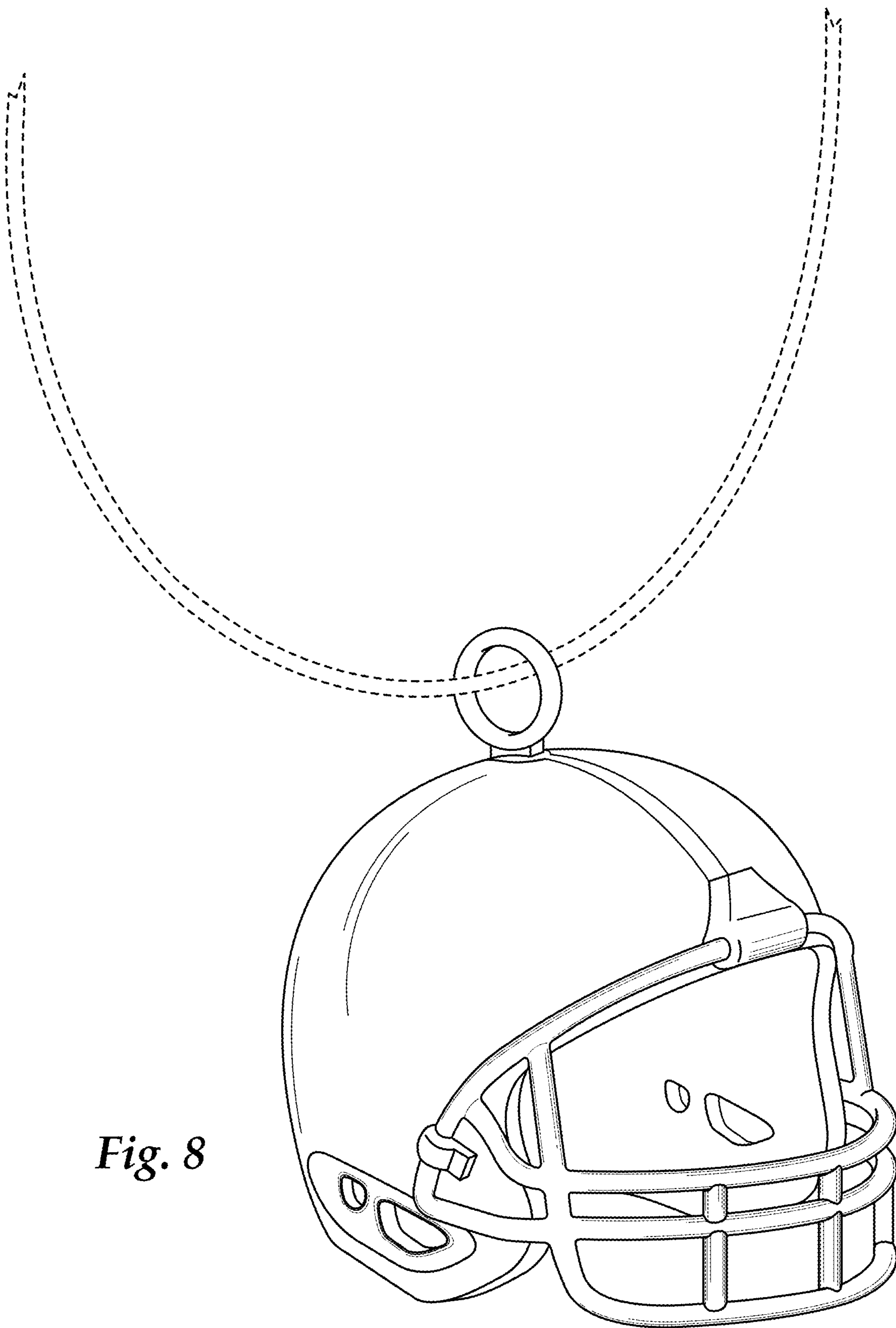
