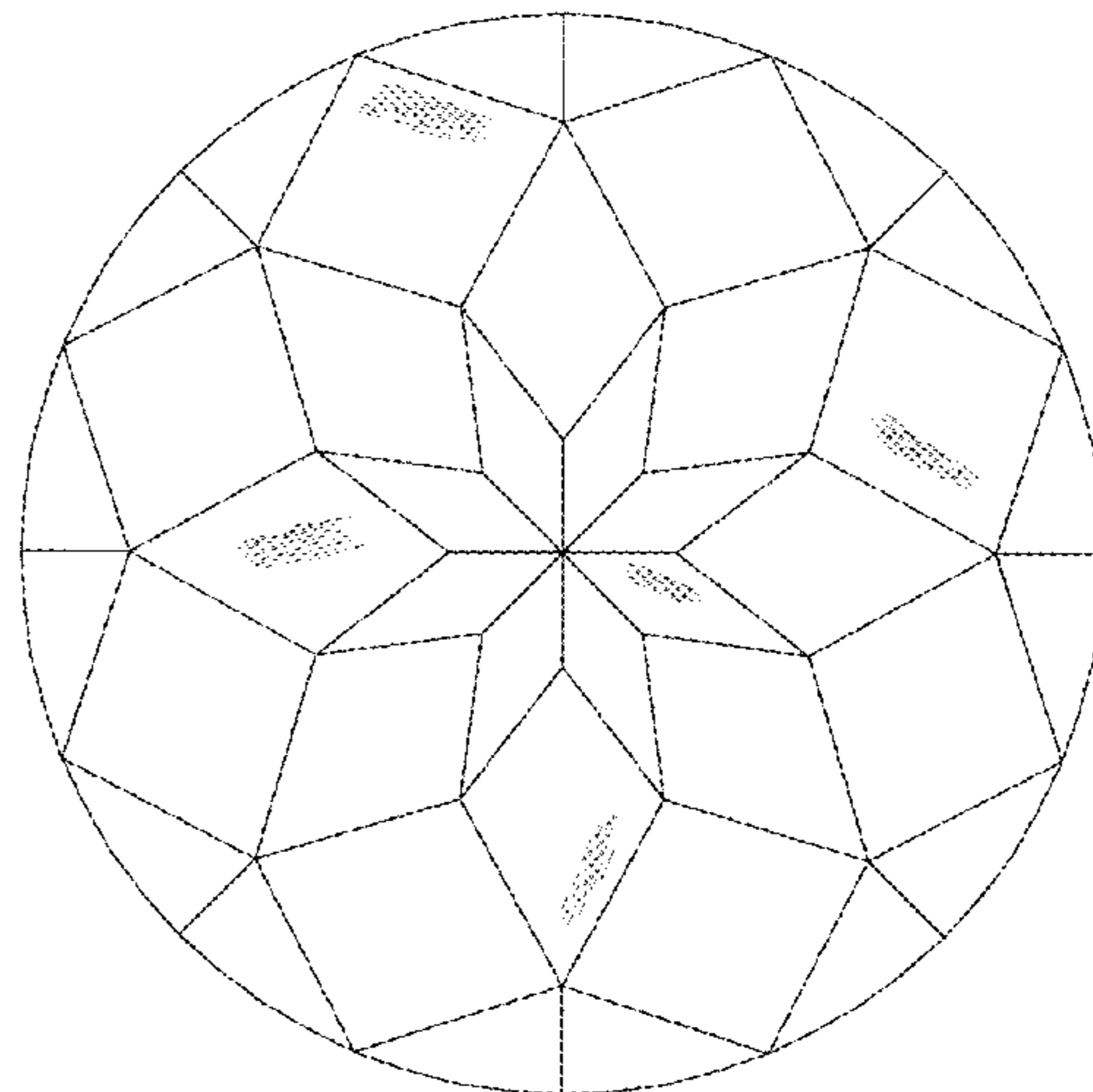
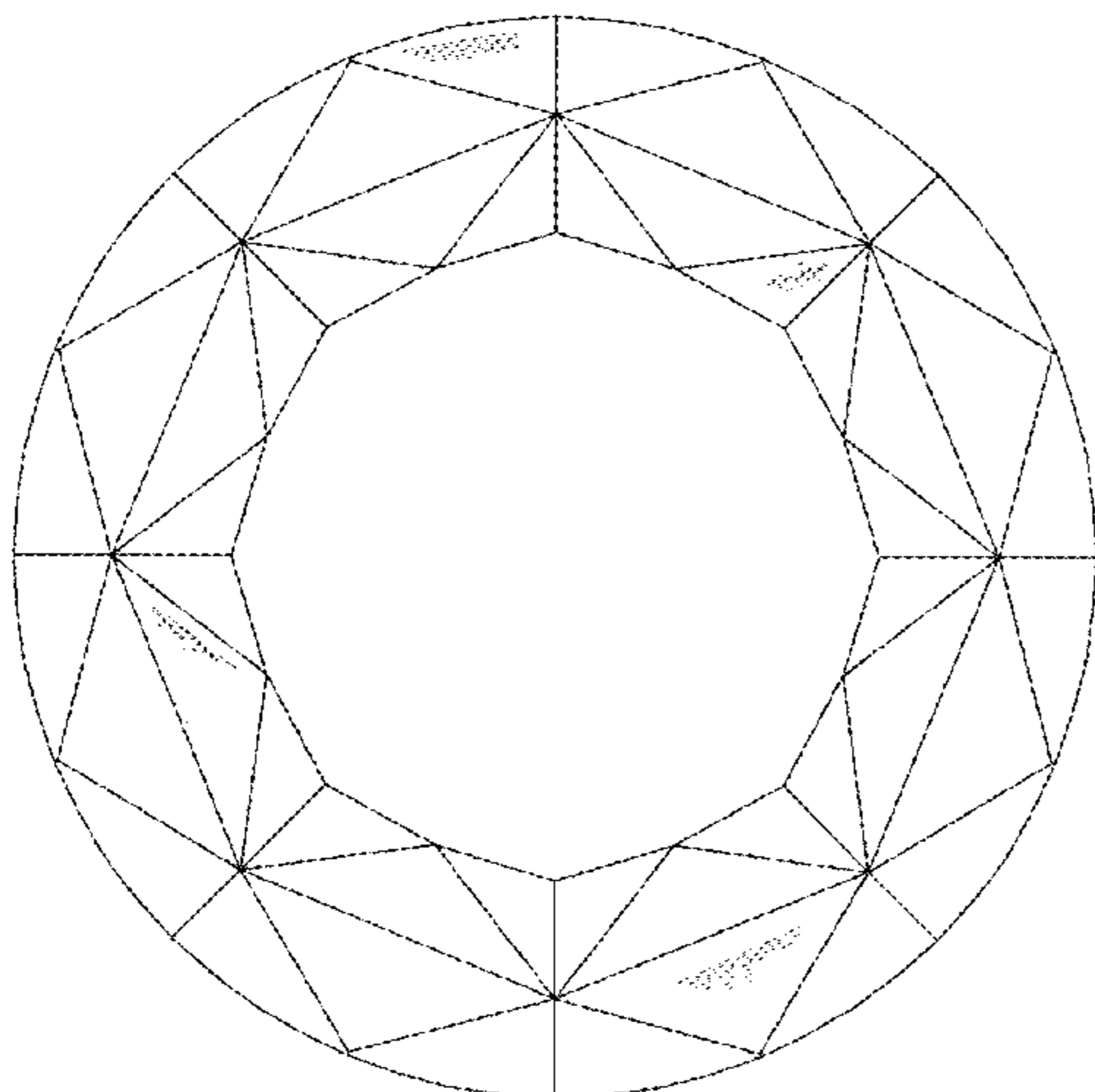
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective of a gemstone showing my new design;
FIG. 2 is another perspective of the gemstone of FIG. 1, with the table tilted away from the viewer;
FIG. 3 is a top view of the gemstone of FIG. 1;
FIG. 4 is a bottom view of the gemstone of FIG. 1; and,
FIG. 5 is a side view of the gemstone of FIG. 1, with the opposed side view being symmetrical.

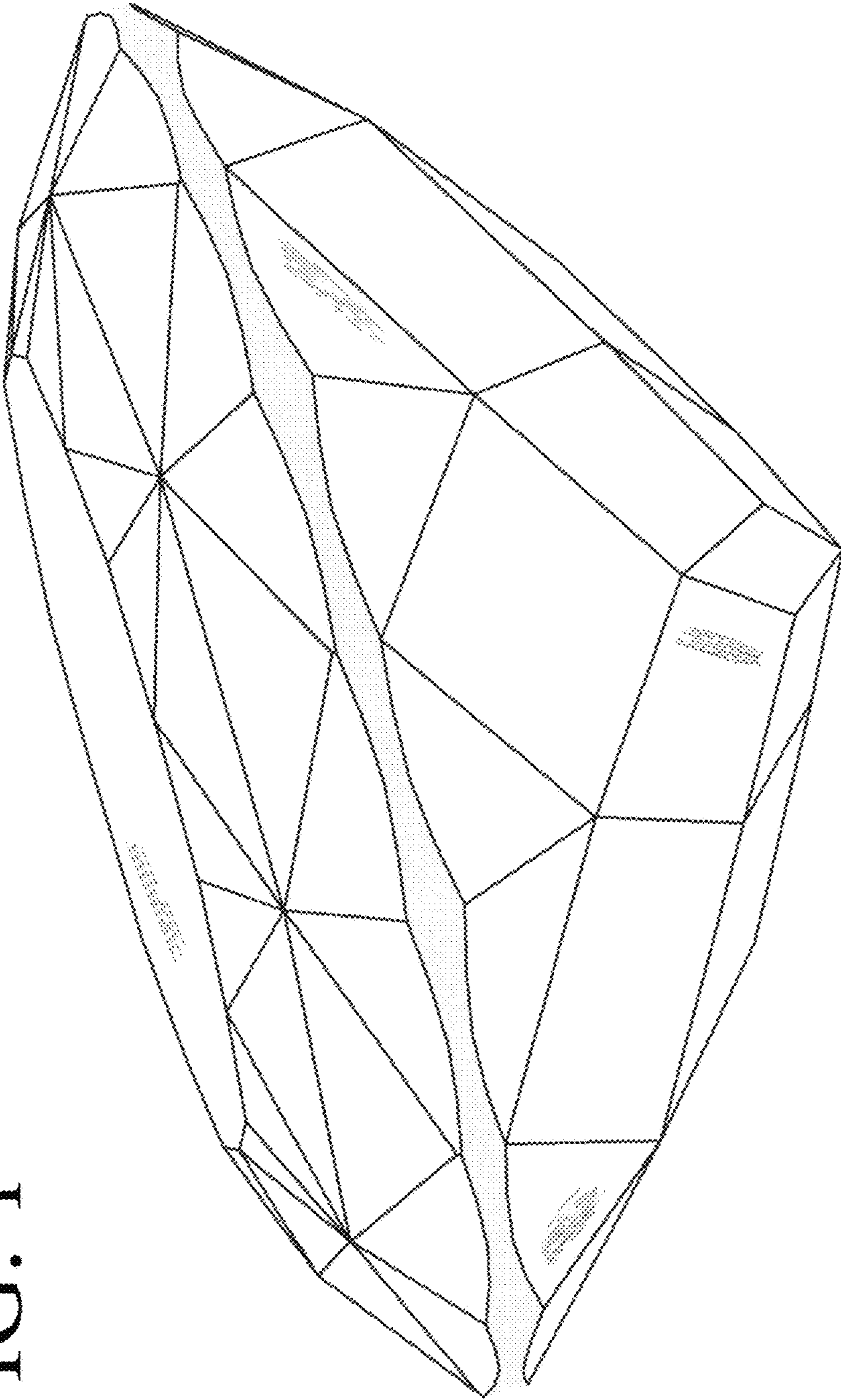

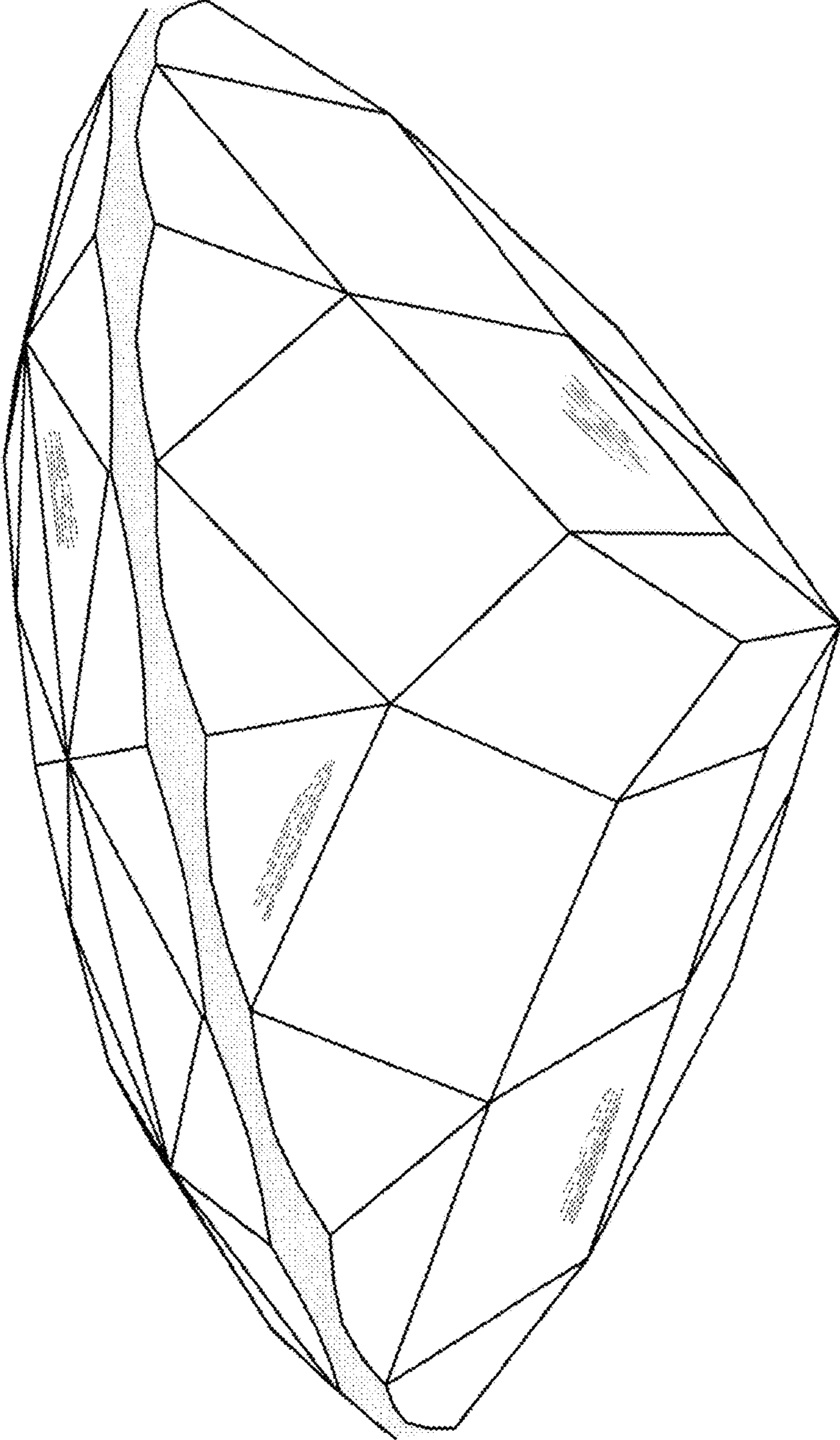

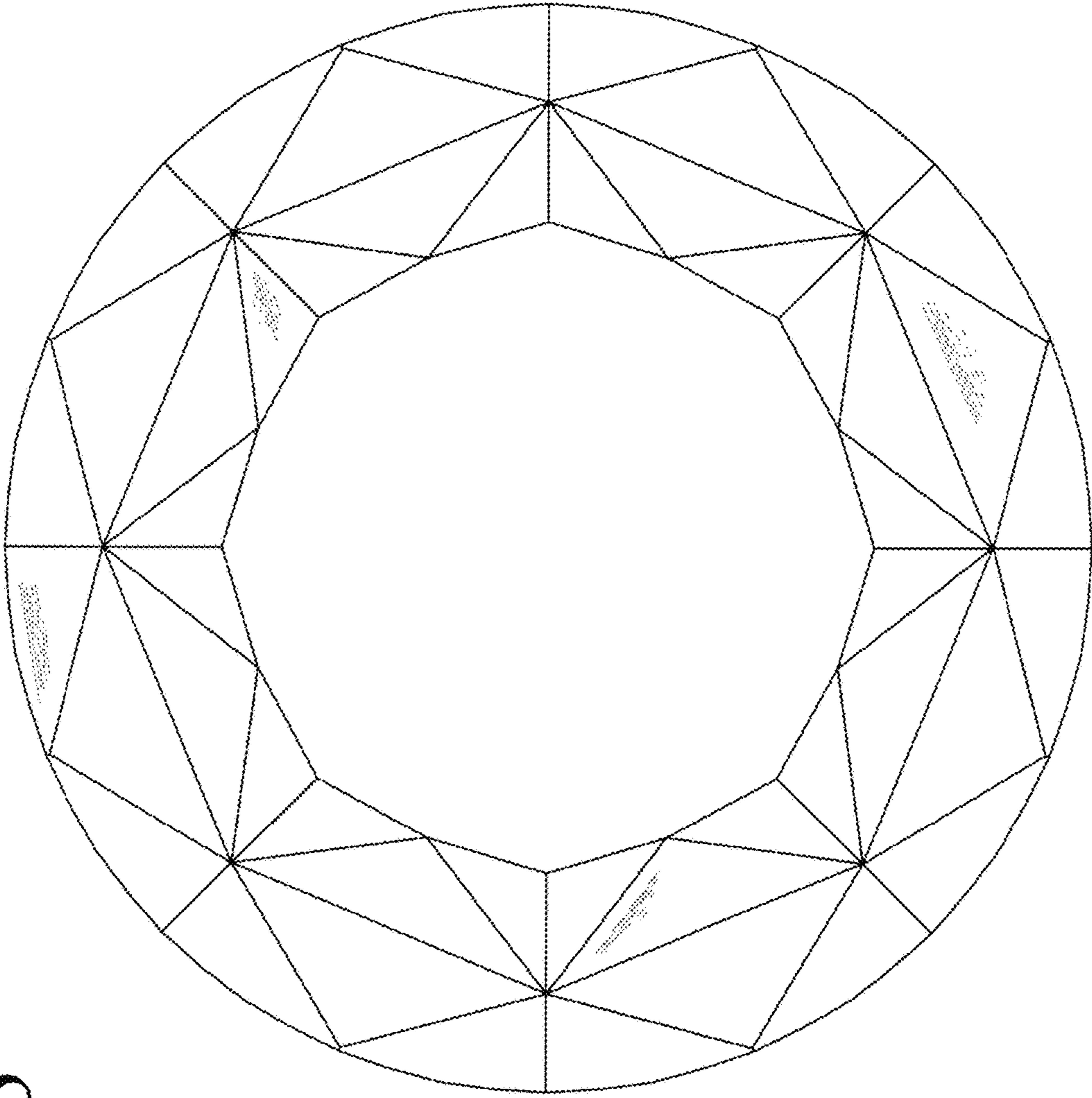

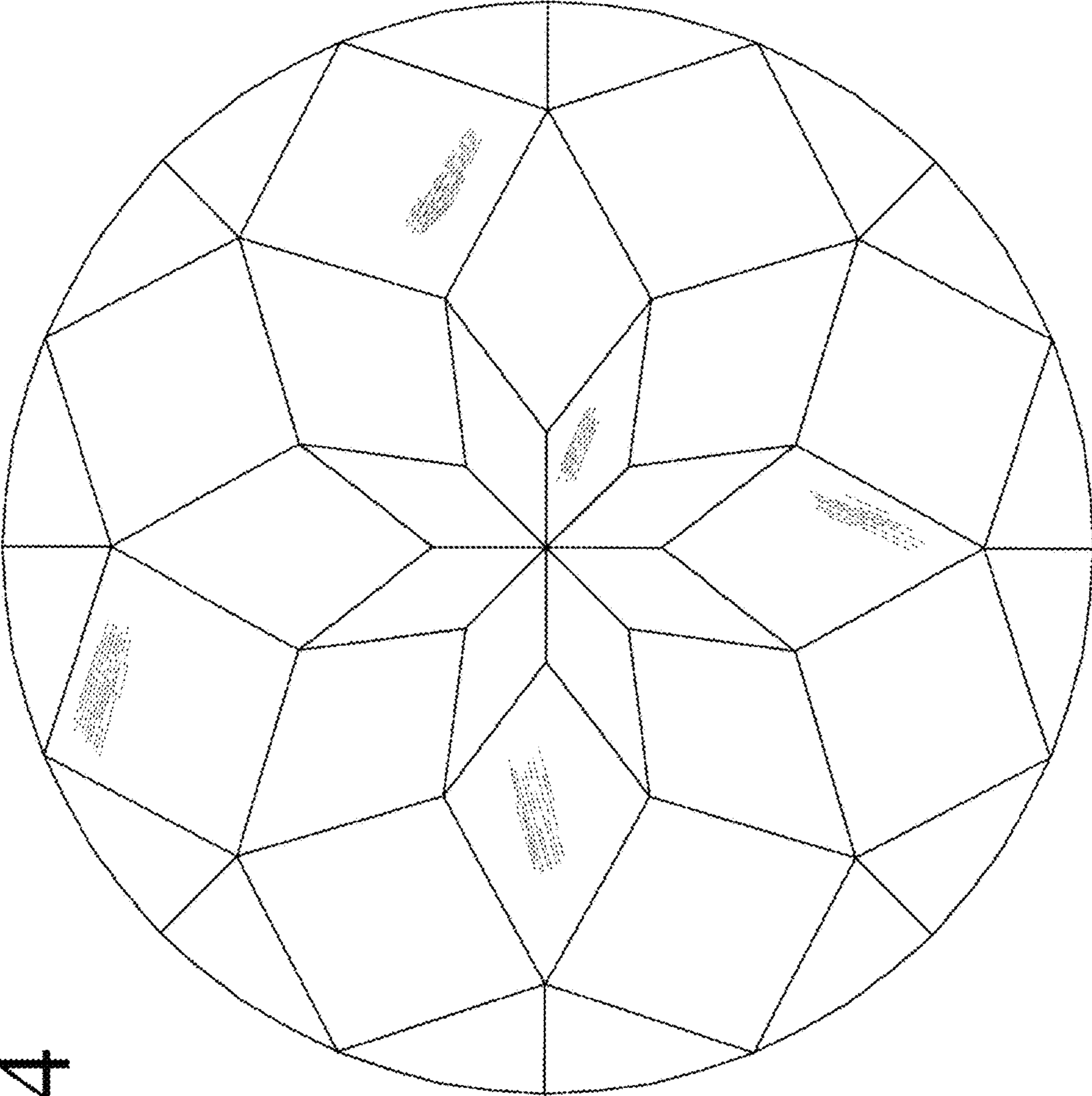
