(57) **CLAIM**

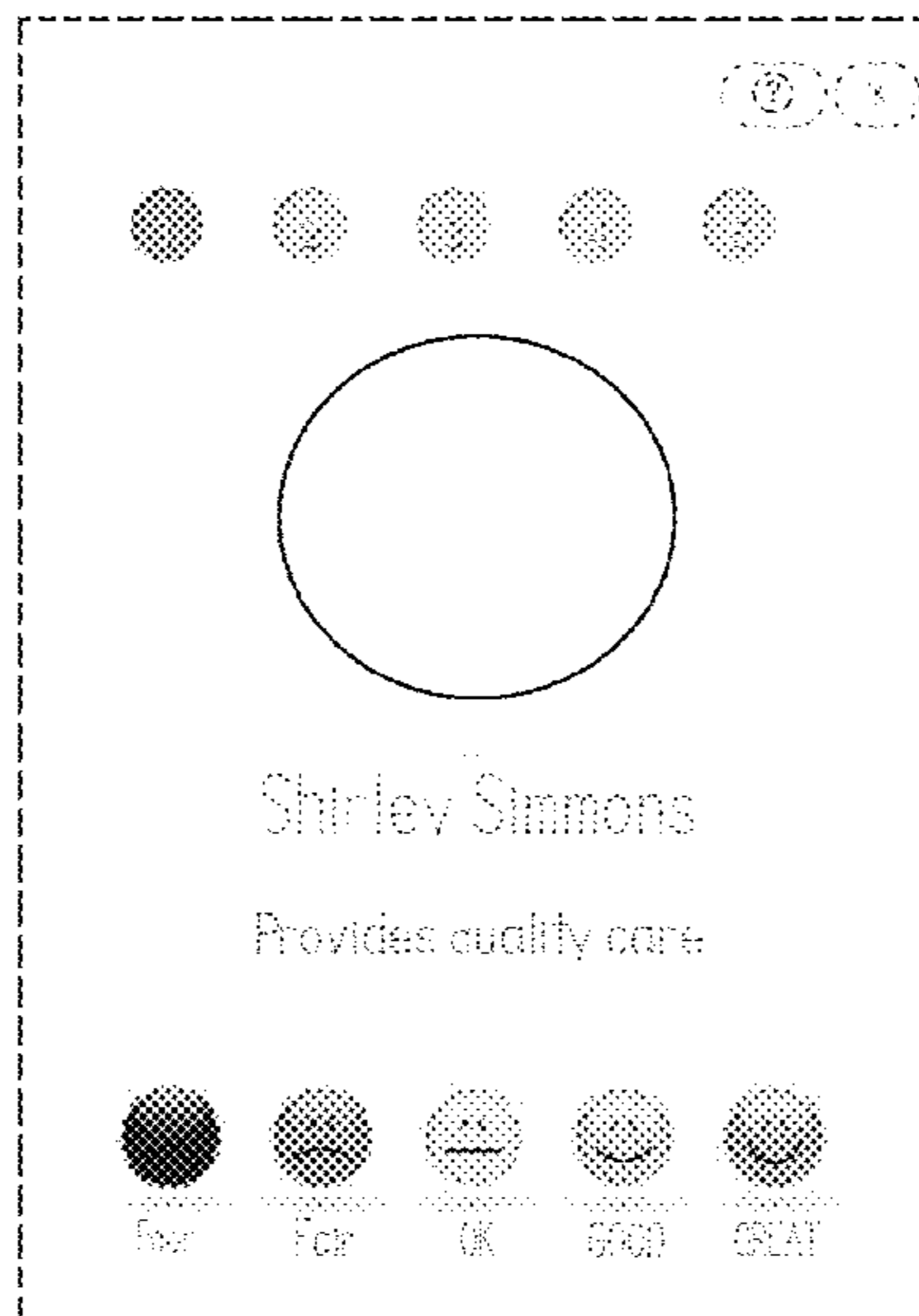
The ornamental design for a display screen with employee survey graphical user interface, as shown and described.
