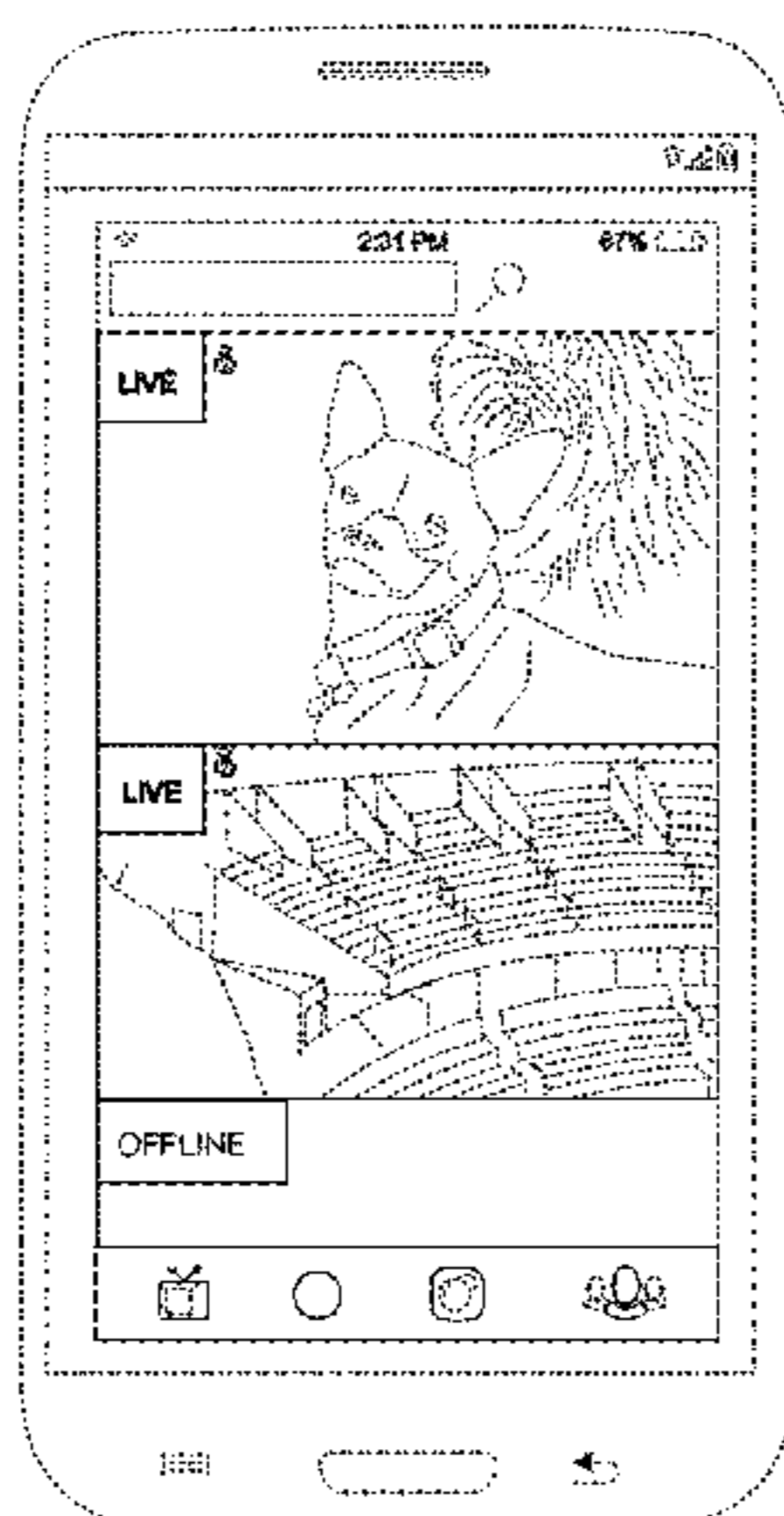
(57) **CLAIM**

What is claimed is an ornamental design for a user interface design for live video sharing, as shown and described herein.

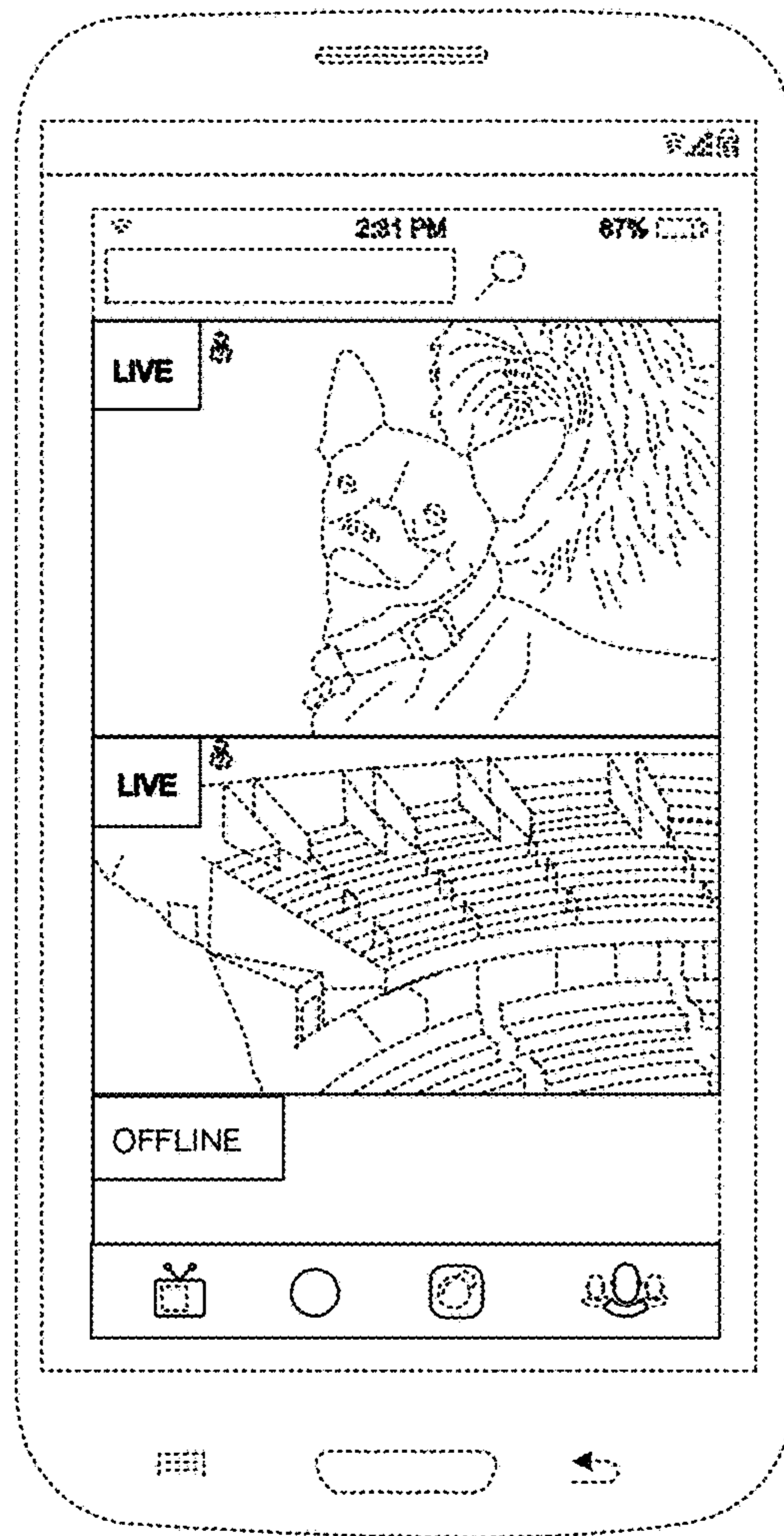

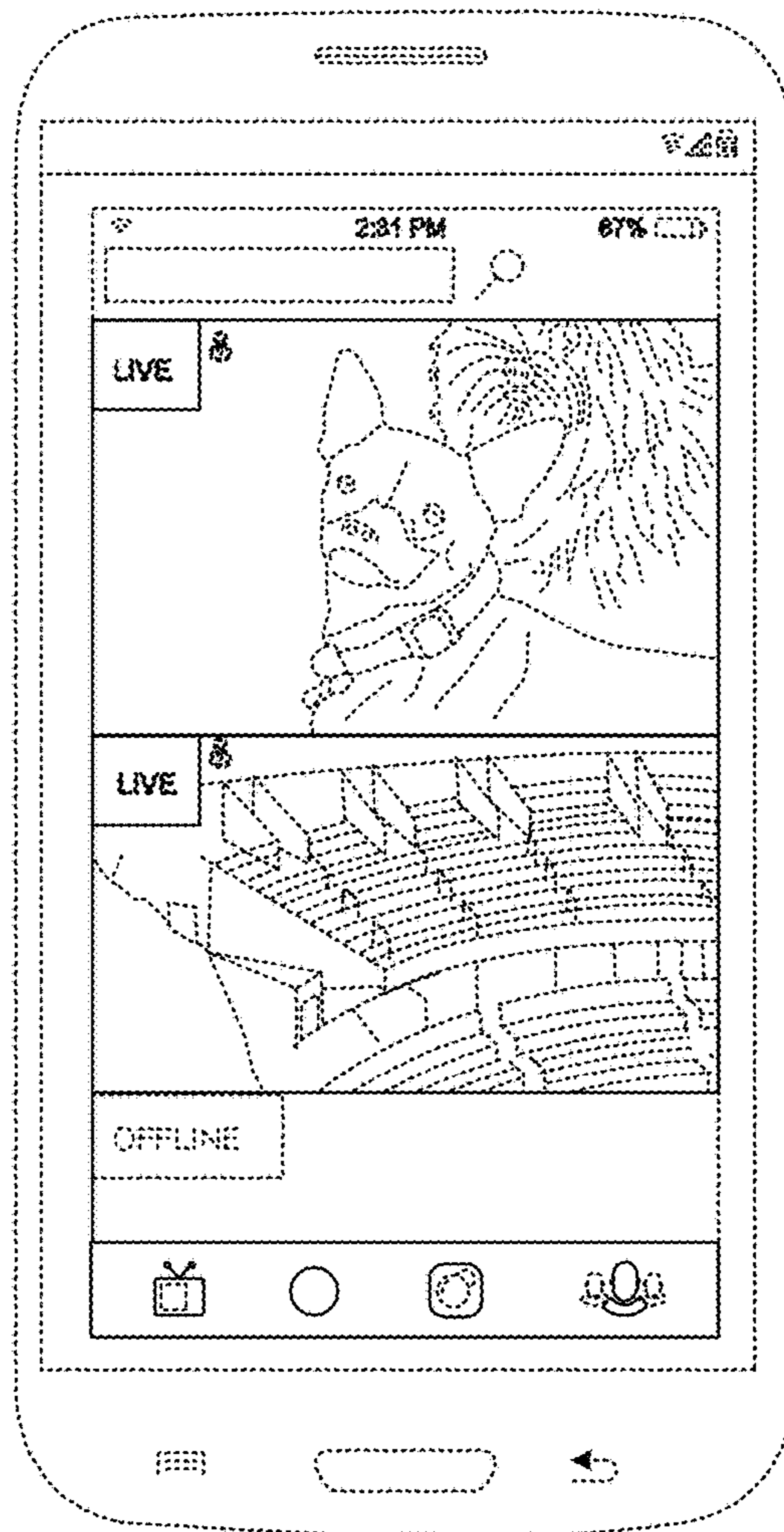

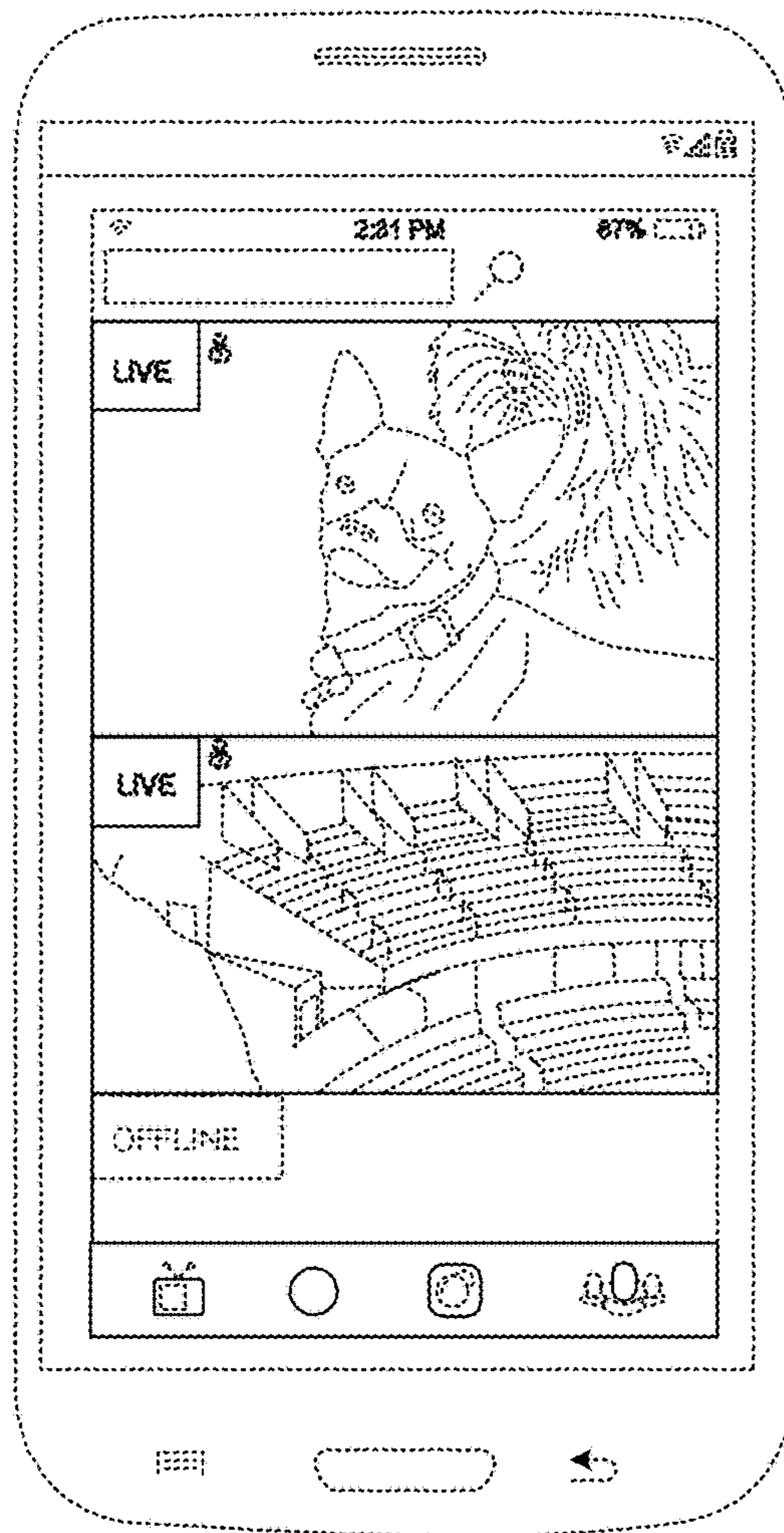
