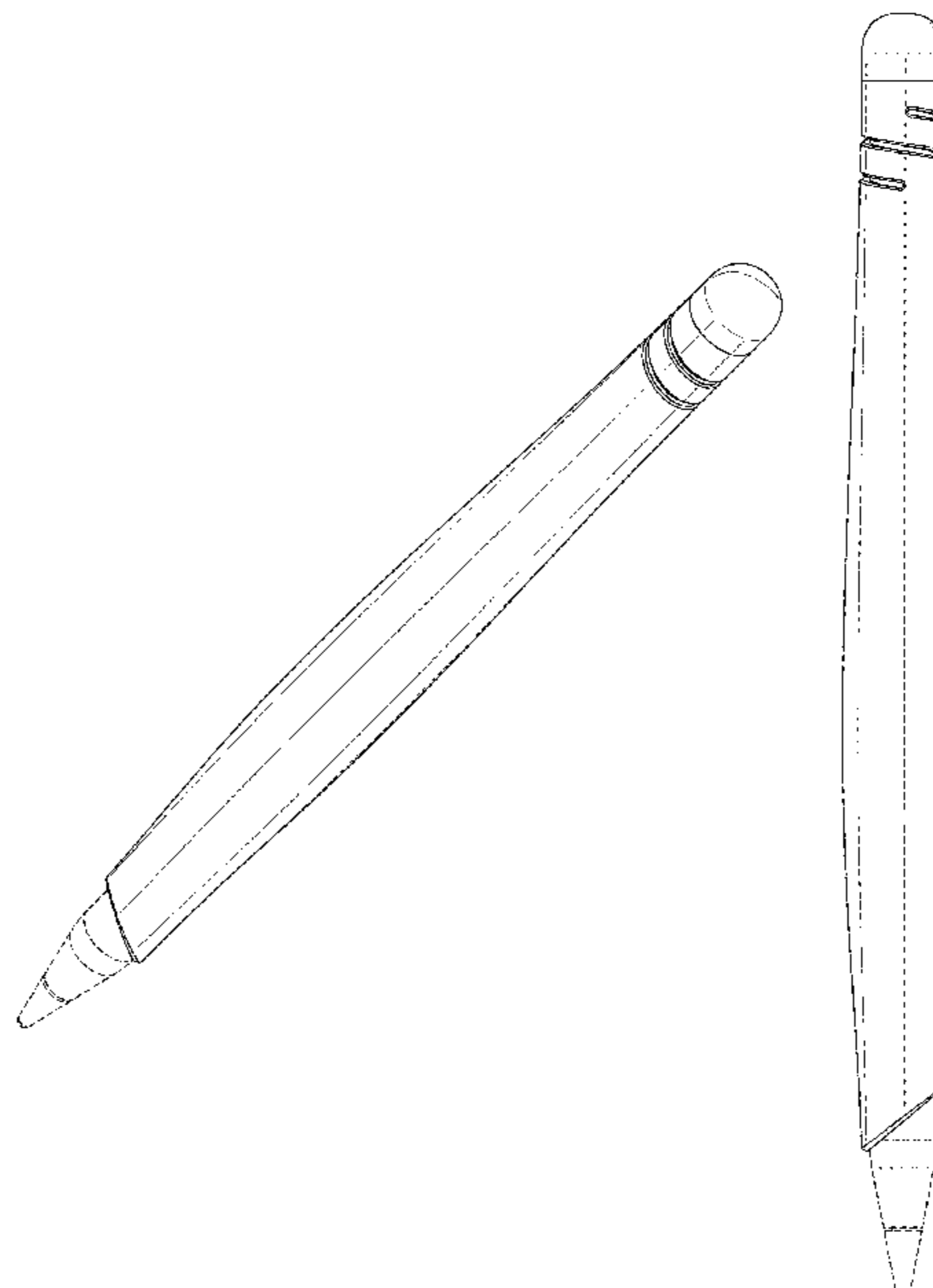
(57) **CLAIM**

I claim the ornamental design for a sleeve for stylus, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sleeve for stylus showing my new design;
FIG. 2 is a front view of the sleeve for stylus of FIG. 1;
FIG. 3 is a left side view of the sleeve for stylus of FIG. 1;
FIG. 4 is a right side view of the sleeve for stylus of FIG. 1;
FIG. 5 is a rear view of the sleeve for stylus of FIG. 1;
FIG. 6 is a top view of the sleeve for stylus of FIG. 1; and
FIG. 7 is a bottom view of the sleeve for stylus of FIG. 1.
FIG. 8 is another perspective view of the sleeve for stylus of FIG. 1;
FIG. 9 is a front view of the sleeve for stylus of FIG. 8;
FIG. 10 is a left side view of the sleeve for stylus of FIG. 8;
FIG. 11 is a right side view of the sleeve for stylus of FIG. 8;
FIG. 12 is a rear view of the sleeve for stylus of FIG. 8;
FIG. 13 is a top view of the sleeve for stylus of FIG. 8; and,
FIG. 14 is a bottom view of the sleeve for stylus of FIG. 8.

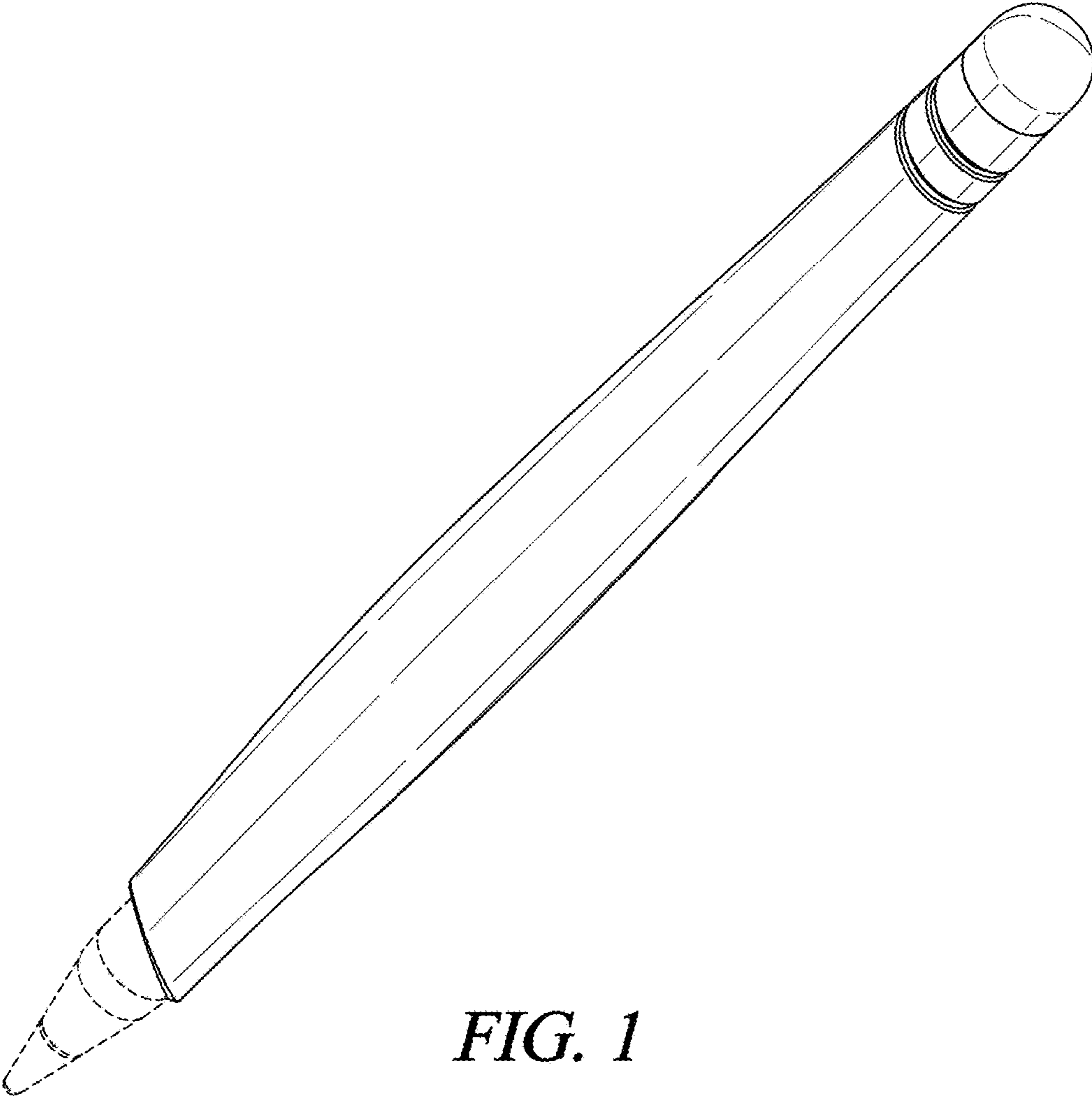

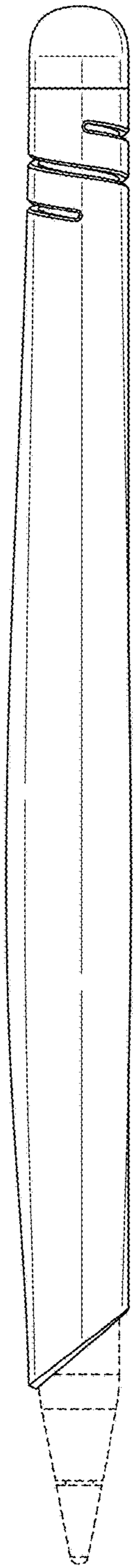

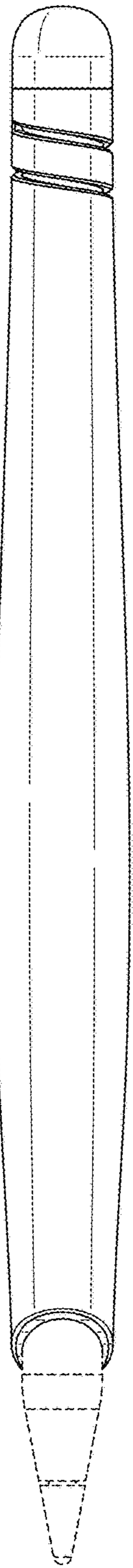

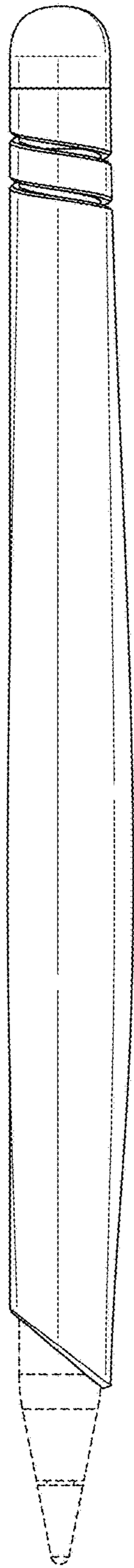

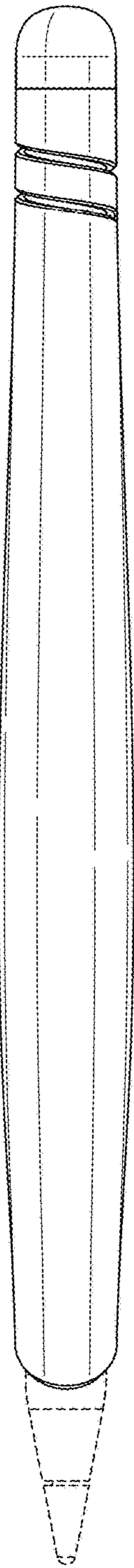

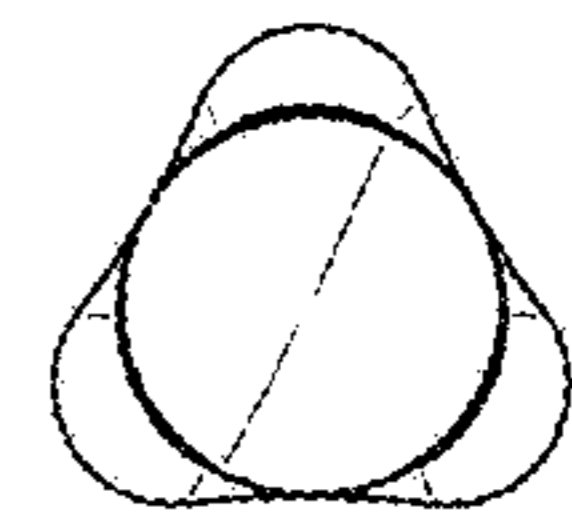

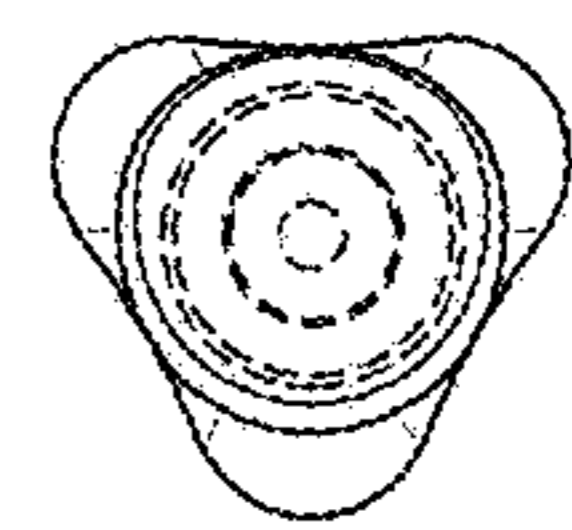

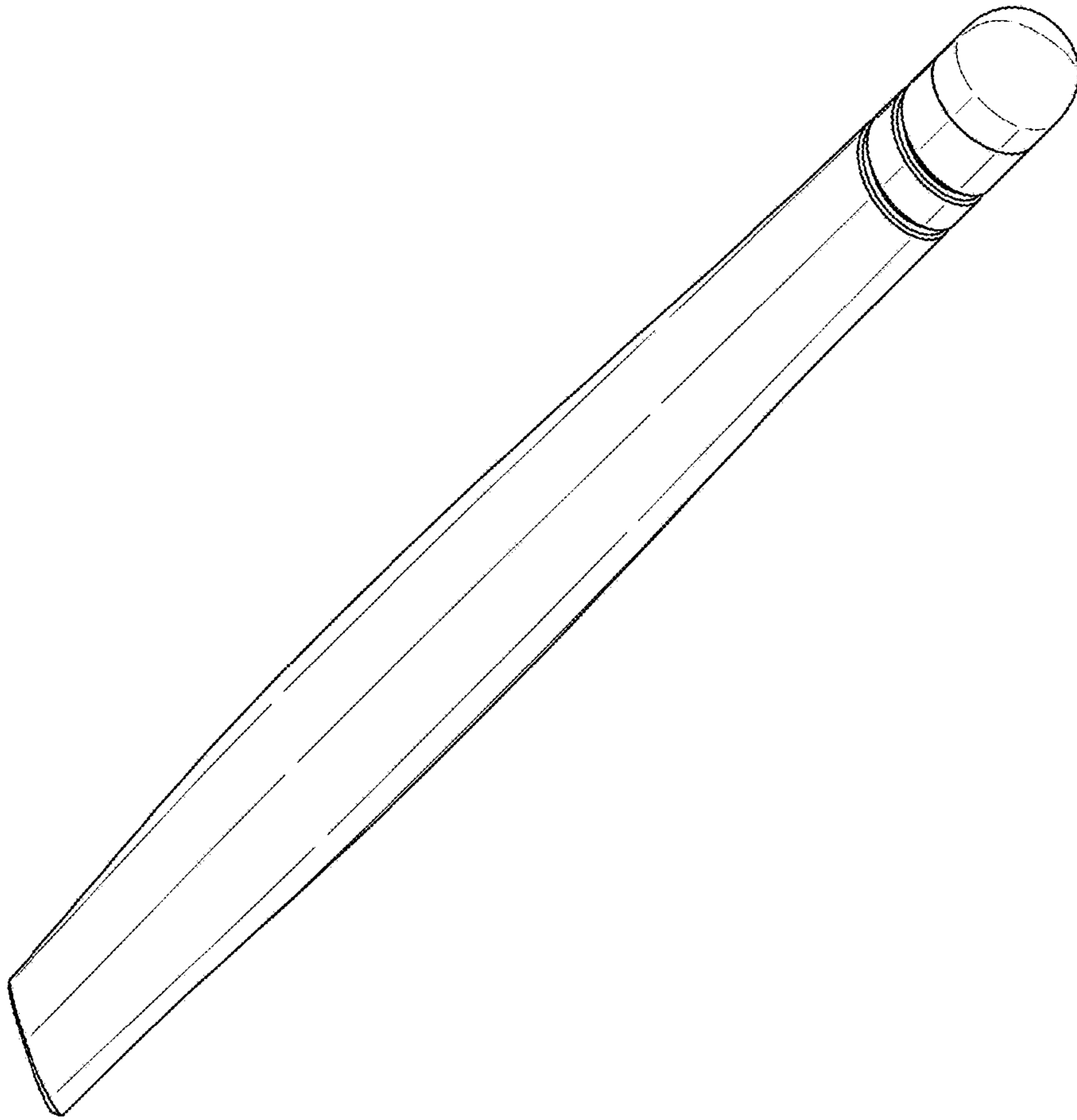

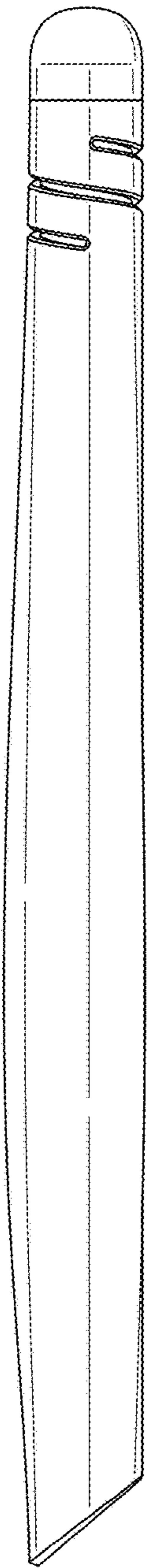

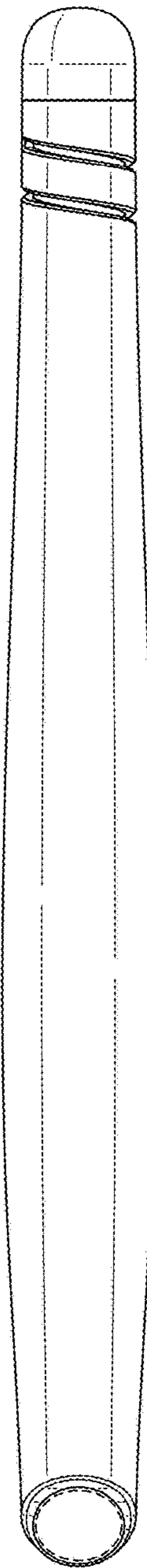

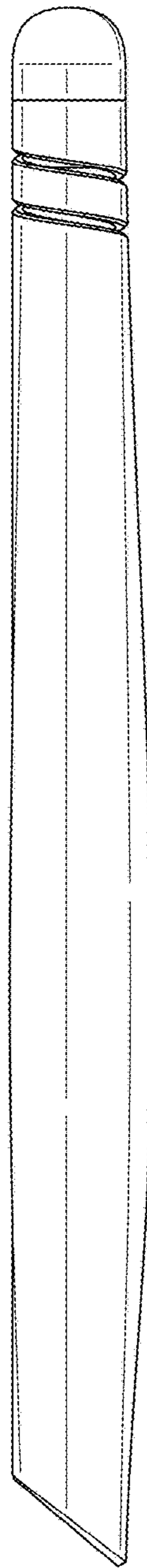

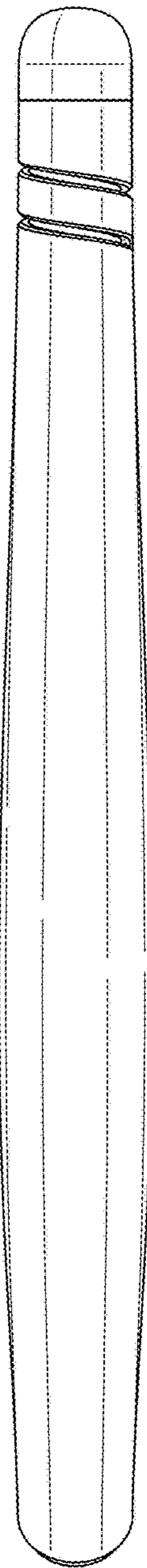

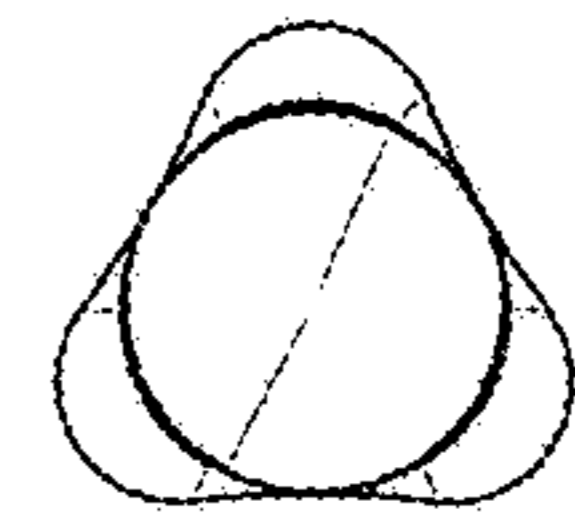

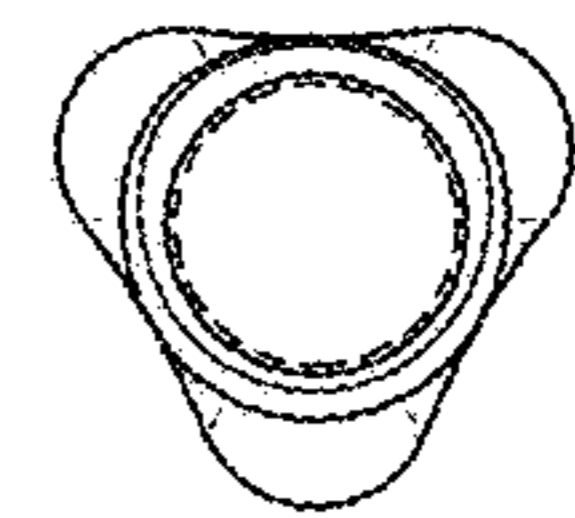
