(57) **CLAIM**

I claim the ornamental design for a coverlifter-outfitted spa, as shown and described.

DESCRIPTION

FIG. 1 of the drawings is a perspective view showing the front, the top, and a first side of a coverlifter-outfitted spa embodying the present invention;

FIG. 2 is an elevation view of the front of the coverlifter-outfitted spa;

FIG. 3 is an elevation view of the first side of the coverlifter-outfitted spa;

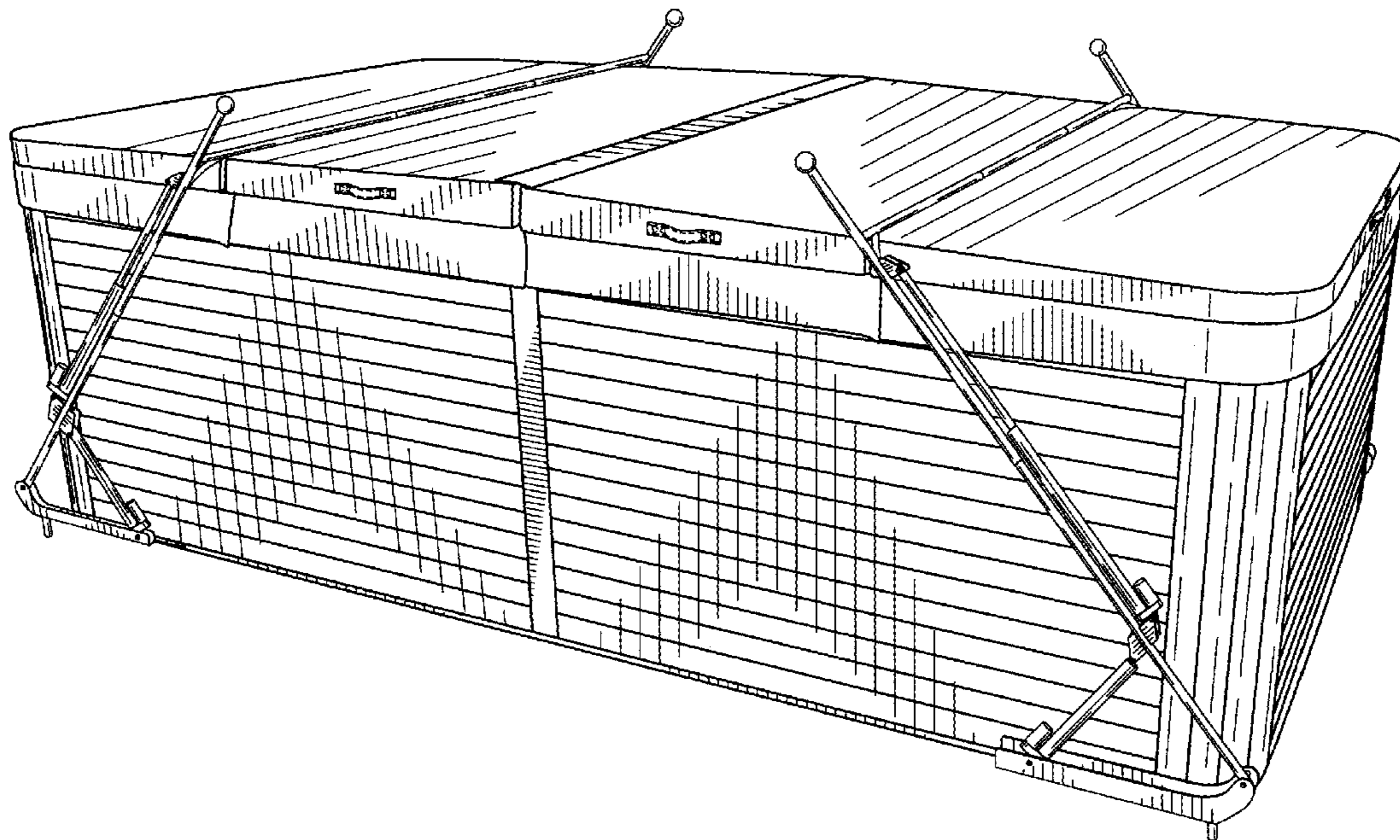
FIG. 4 is a top plan view of the coverlifter-outfitted spa;

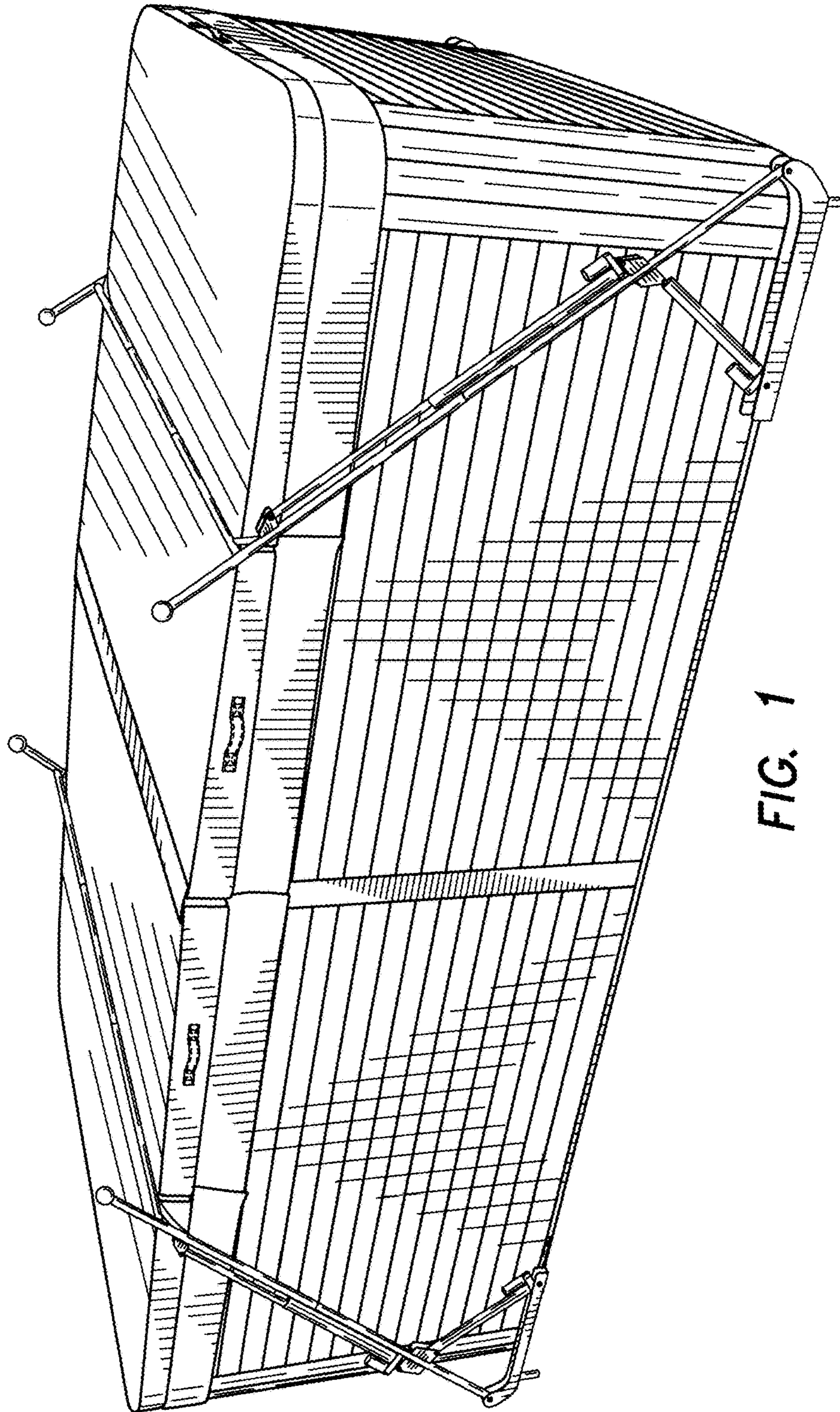

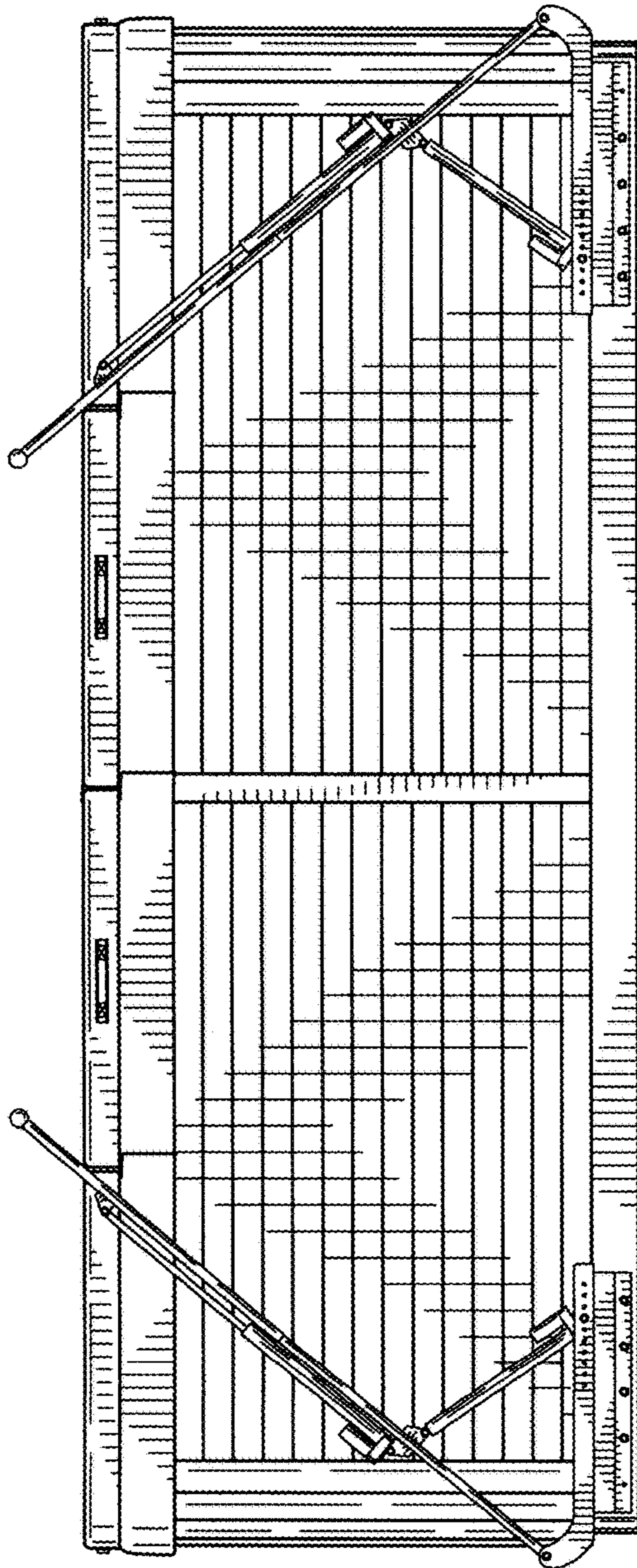

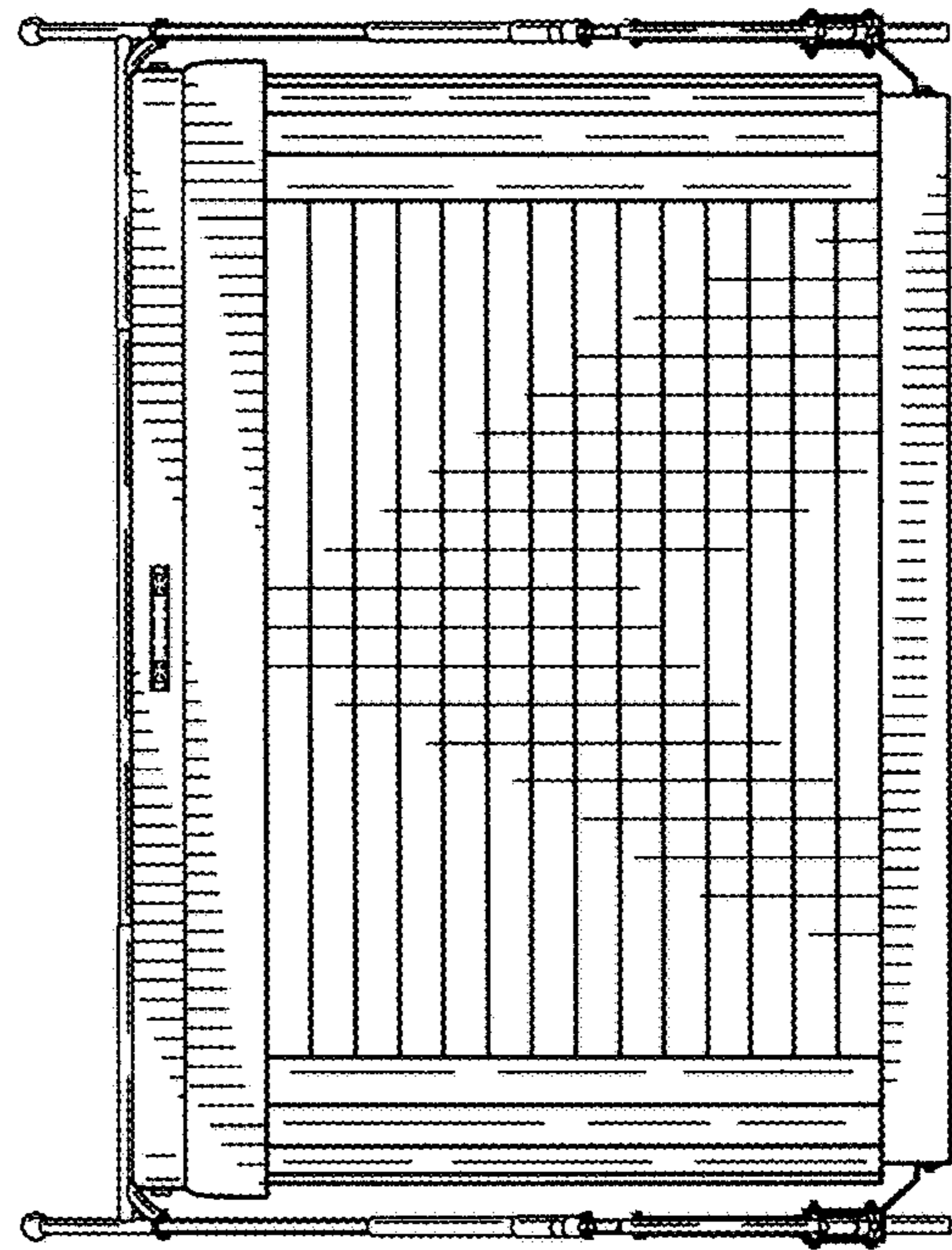

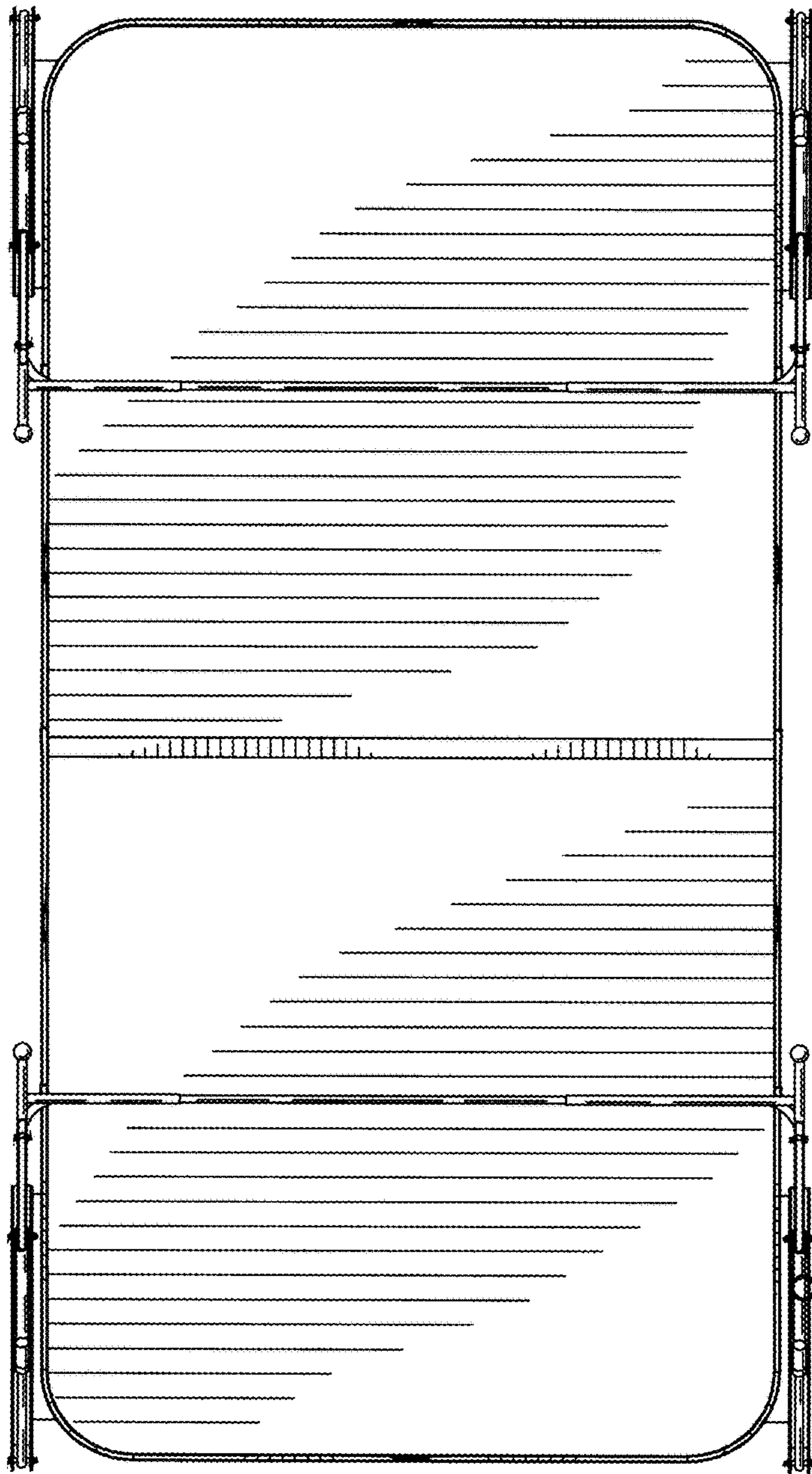

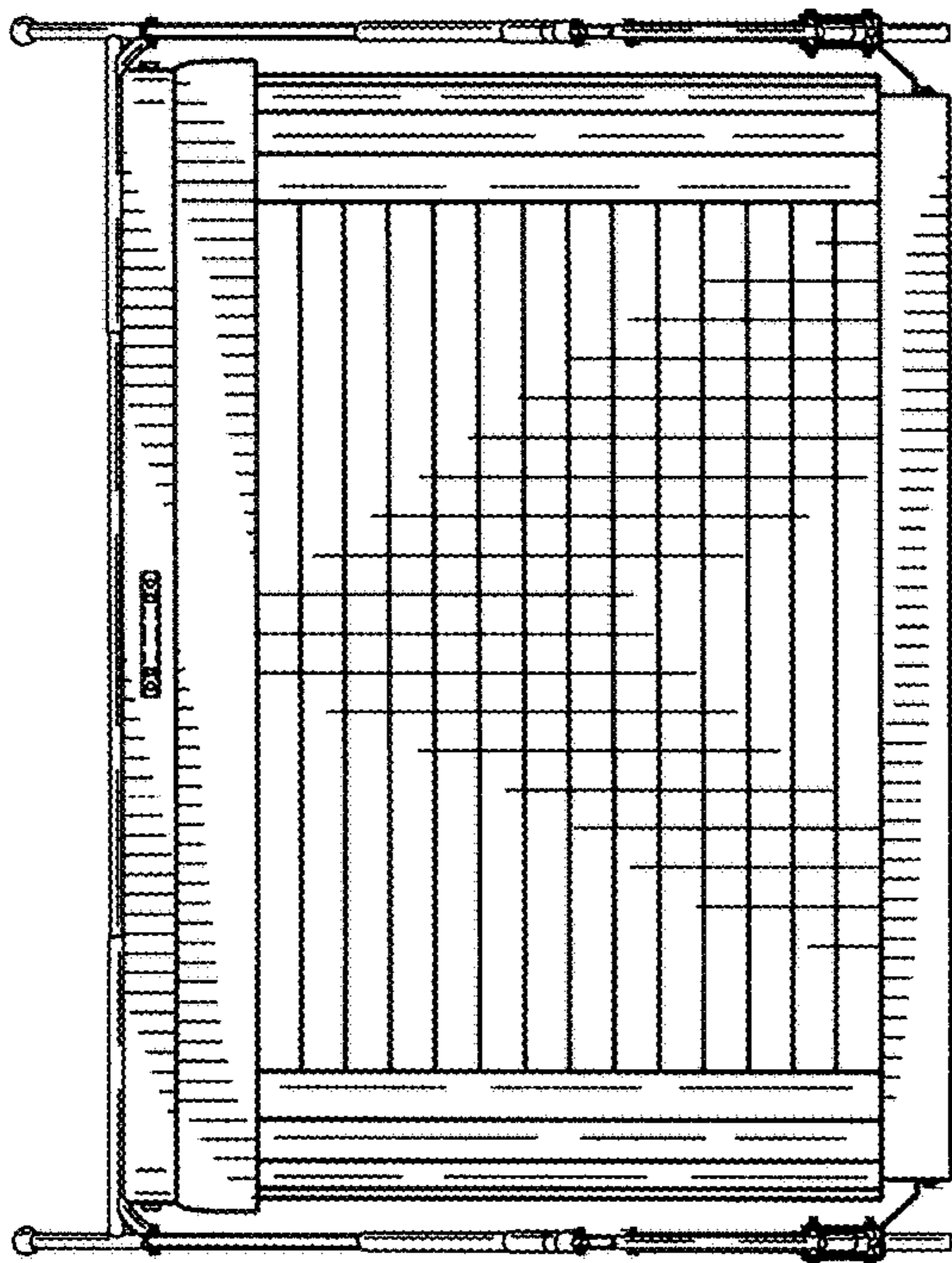
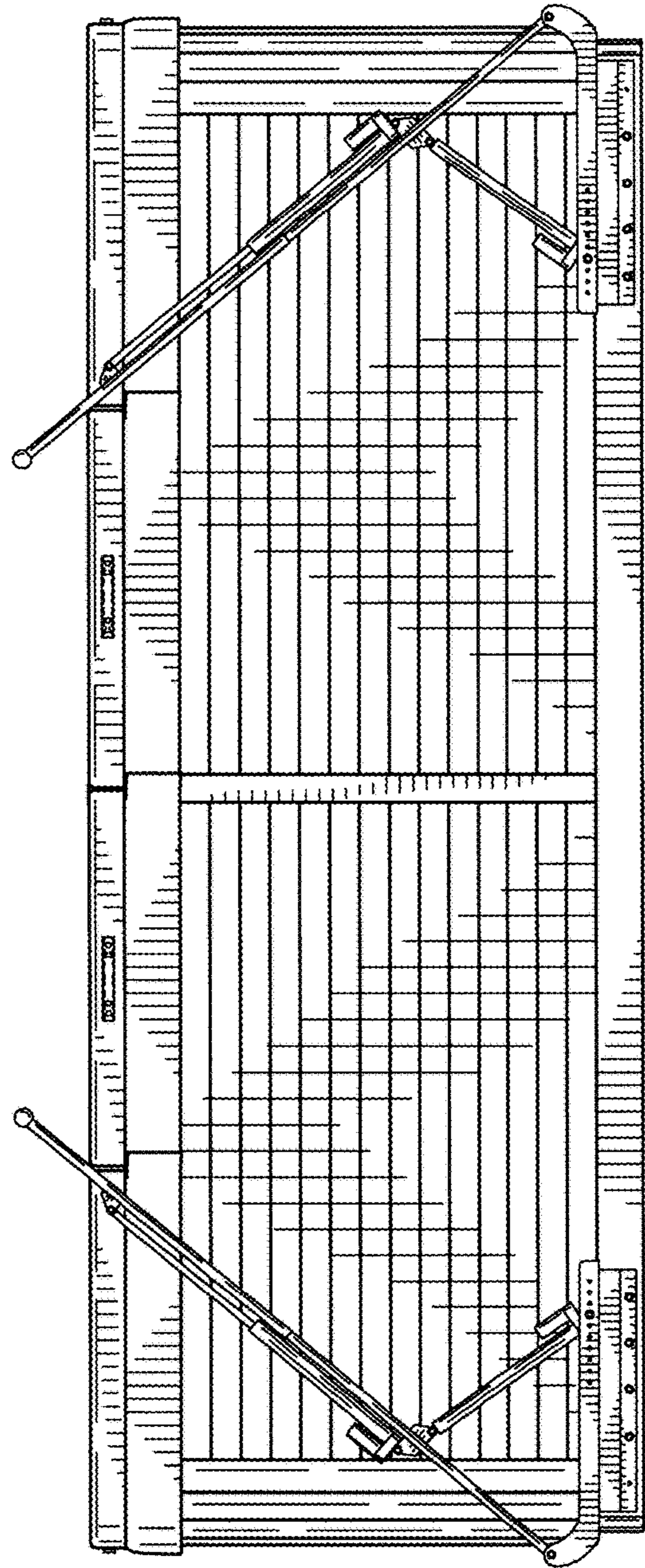

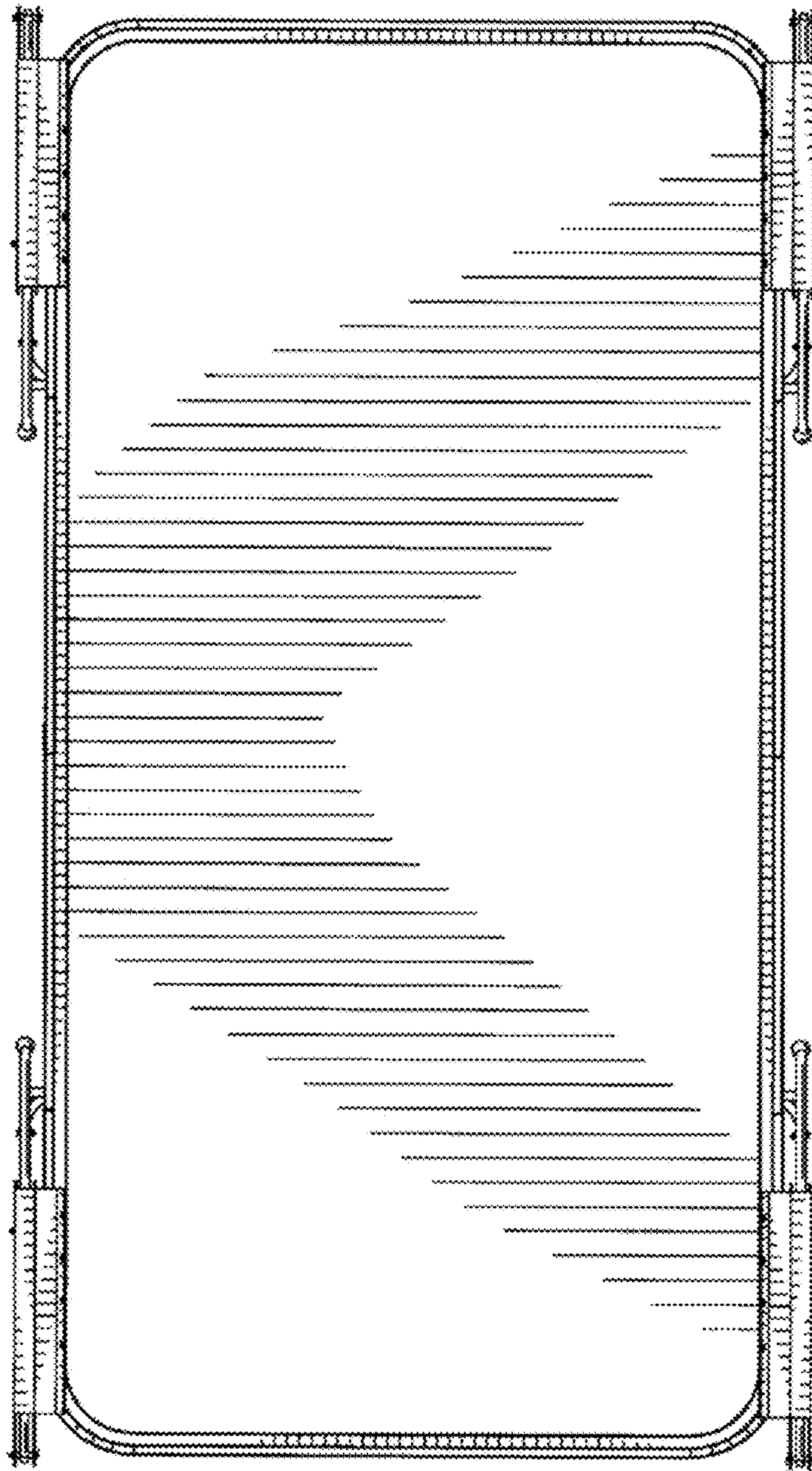
