(57) **CLAIM**

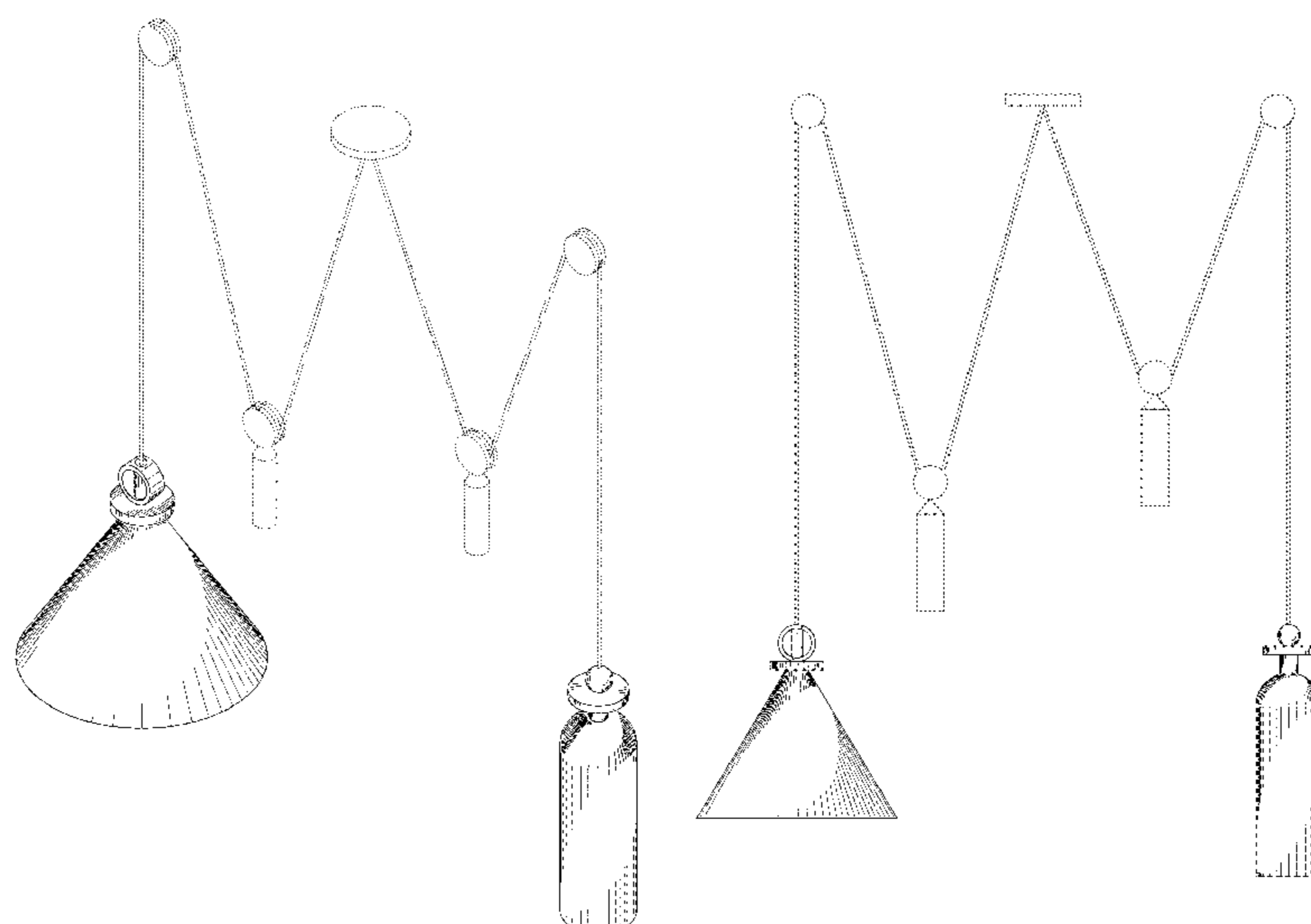
The ornamental design for a lighting fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is front top and one side perspective view of a lighting fixture in accordance with the present invention; FIG. 2 is a front elevation view thereof; and, FIG. 3 is a rear, bottom and opposite side perspective view thereof.

The broken lines shown on the drawings depict portions of the lighting fixture that form no part of the claimed design.

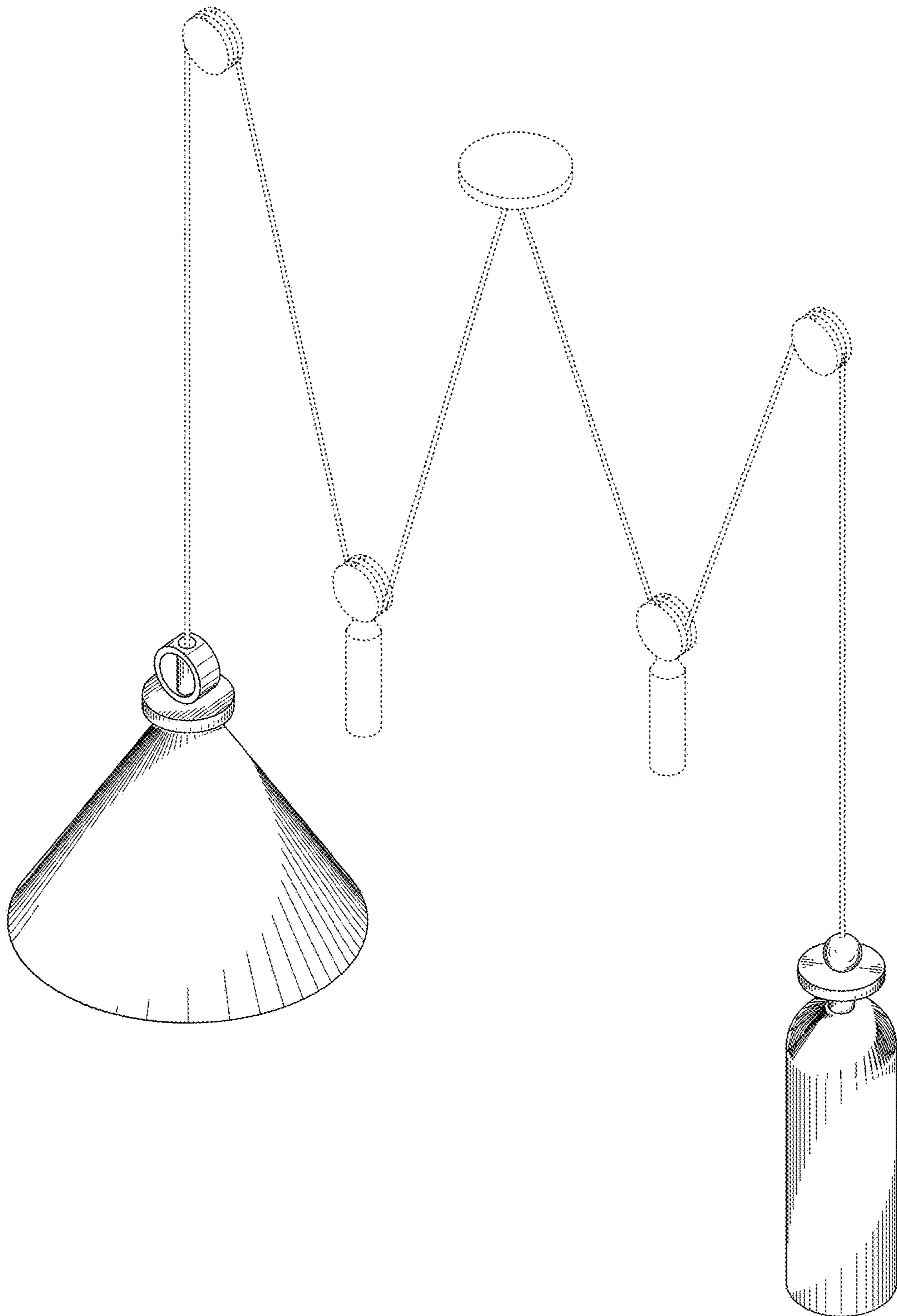

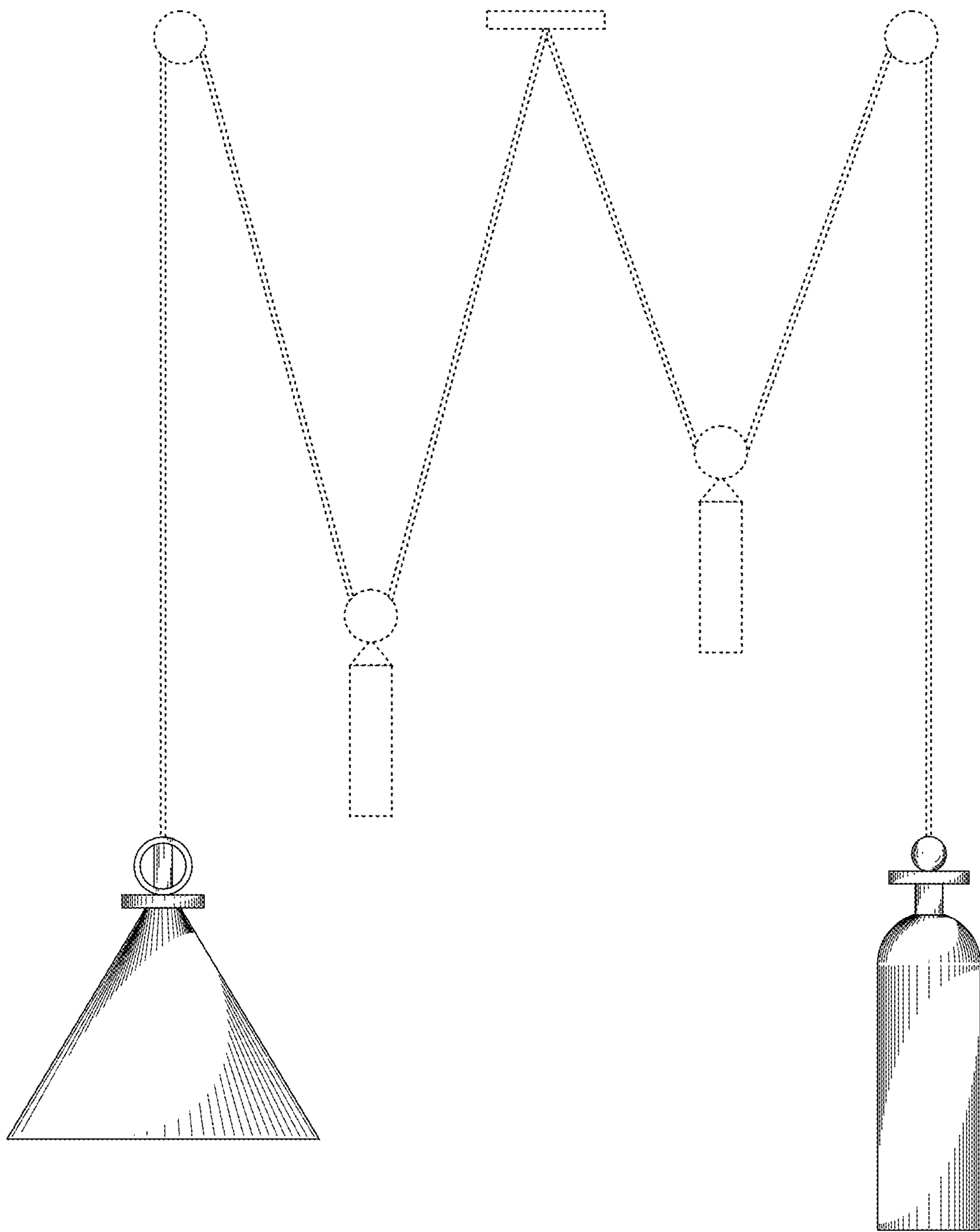

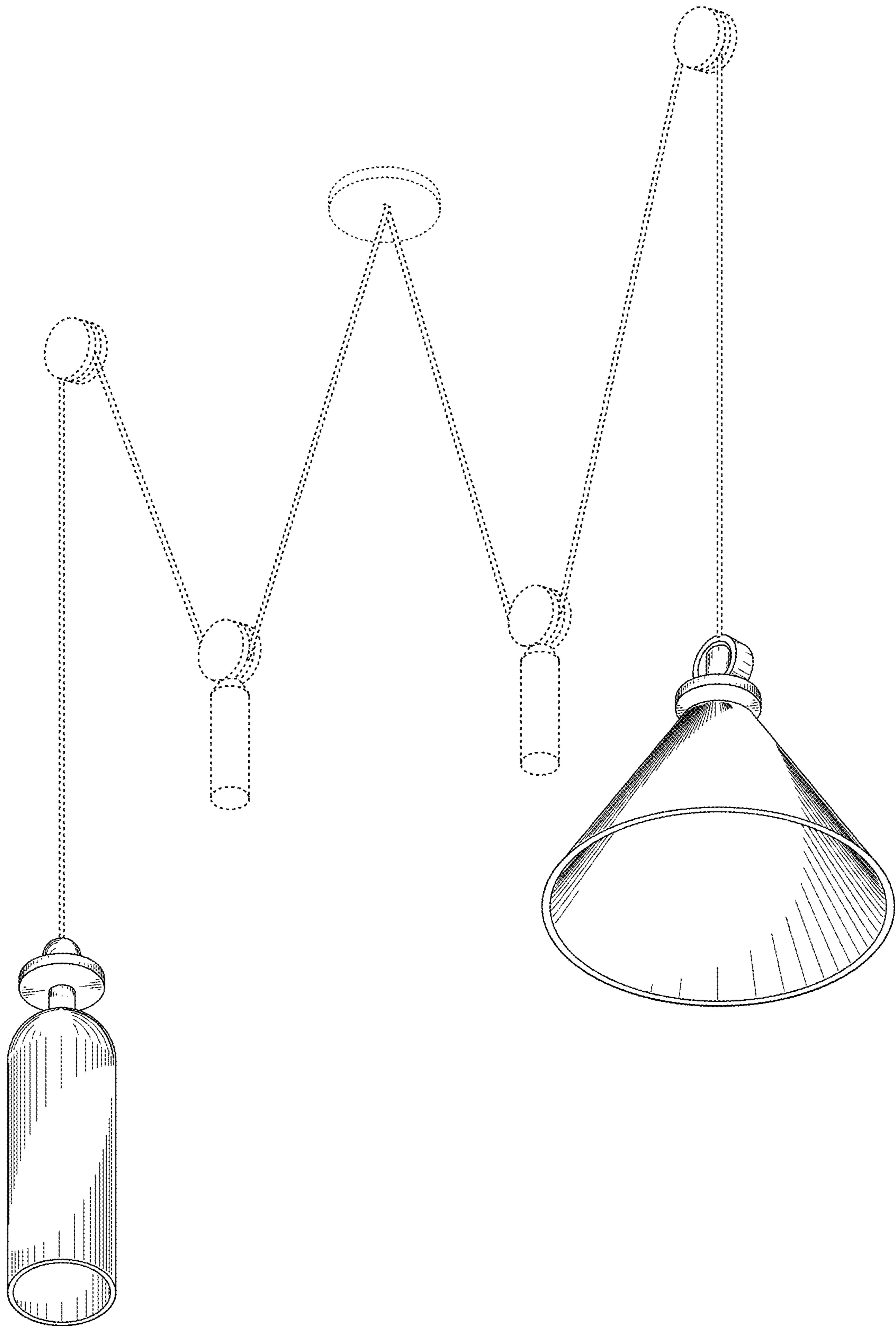
