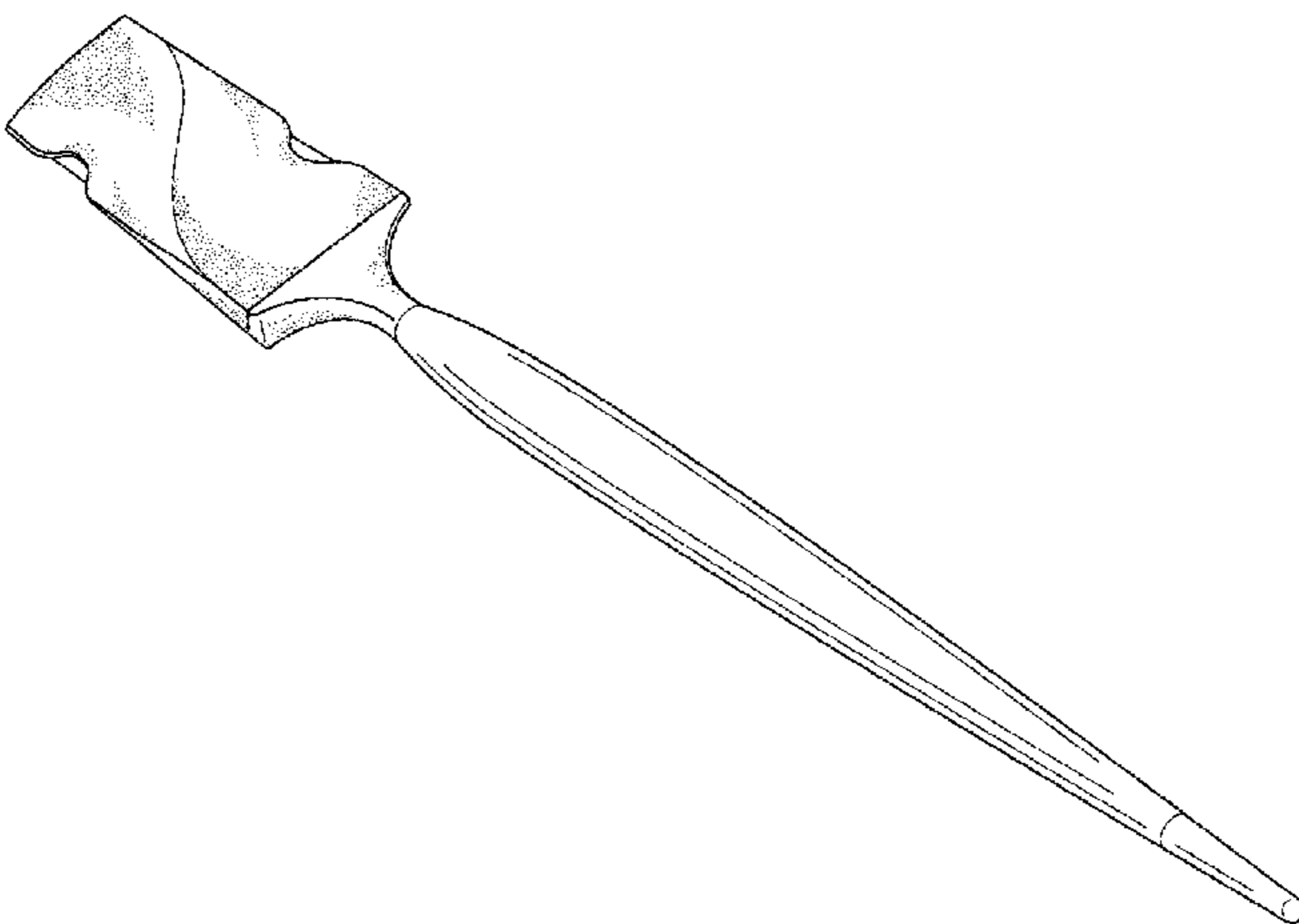
(57) **CLAIM**

I claim the ornamental design for a haircutter, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective view of a haircutter according to the present invention;
FIG. 2 is a front end view of the haircutter of FIG. 1;
FIG. 3 is a back end view of the haircutter of FIG. 1;
FIG. 4 is a right side view of the haircutter of FIG. 1;
FIG. 5 is a left side view of the haircutter of FIG. 1;
FIG. 6 is a top side view of the haircutter of FIGS. 1; and
FIG. 7 is a bottom side view of the haircutter of FIG. 1; and,

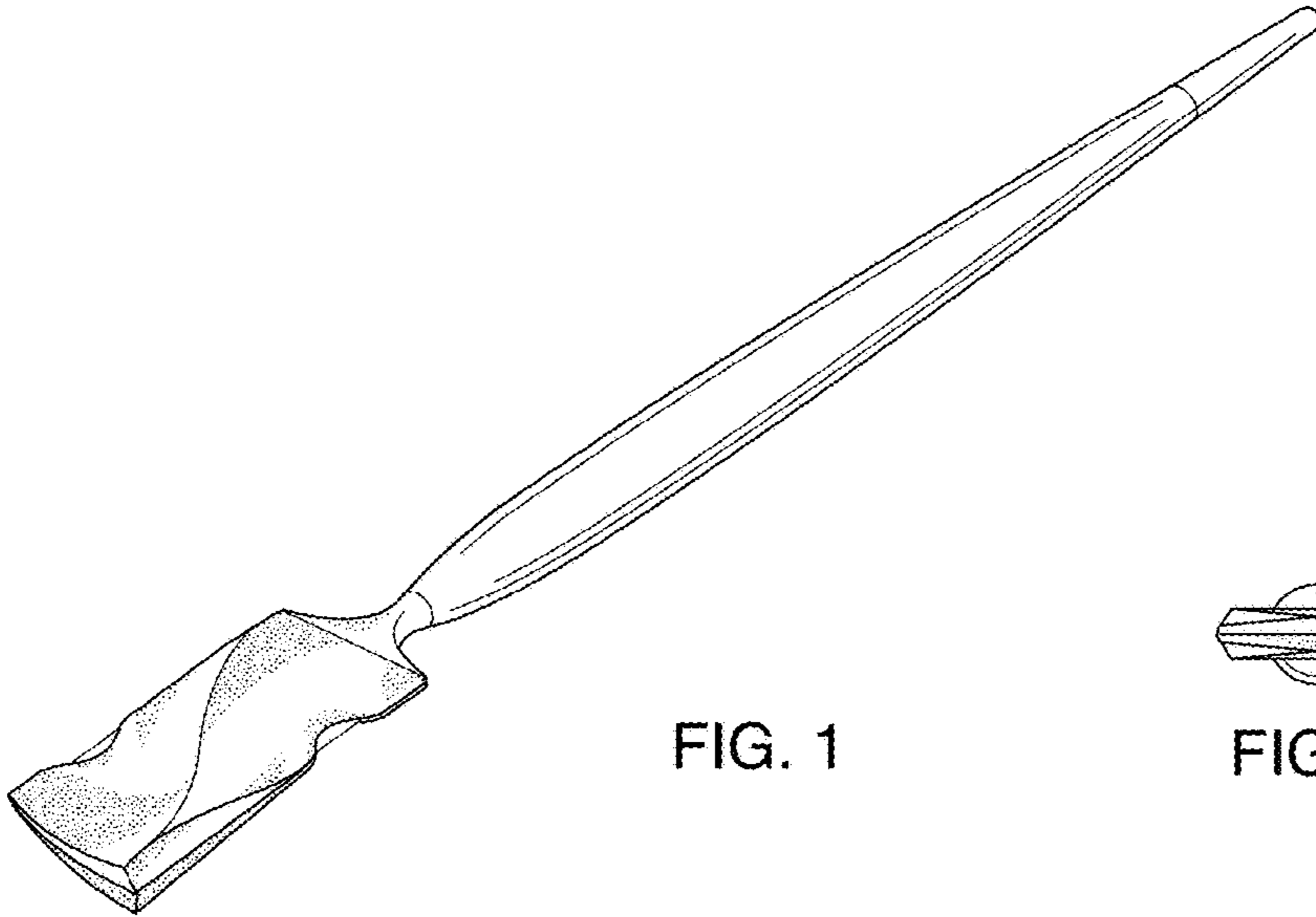

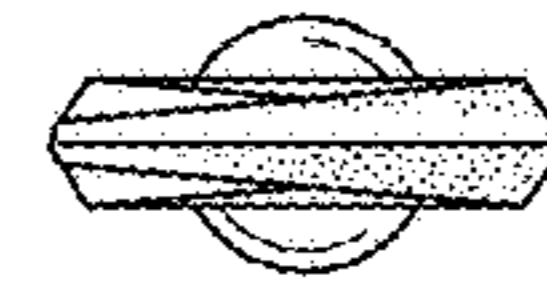

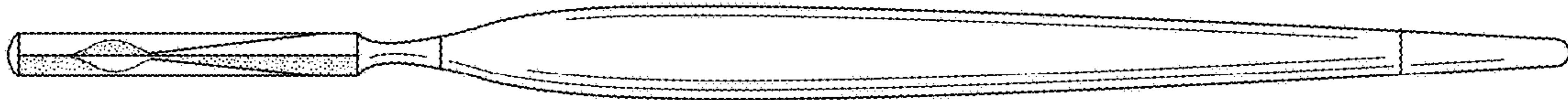

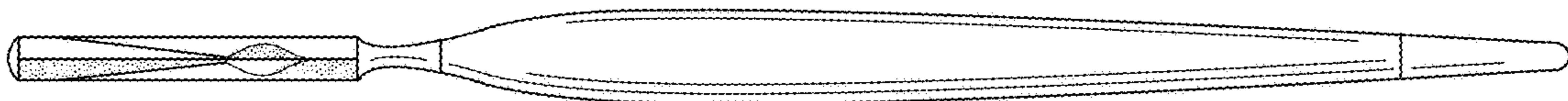

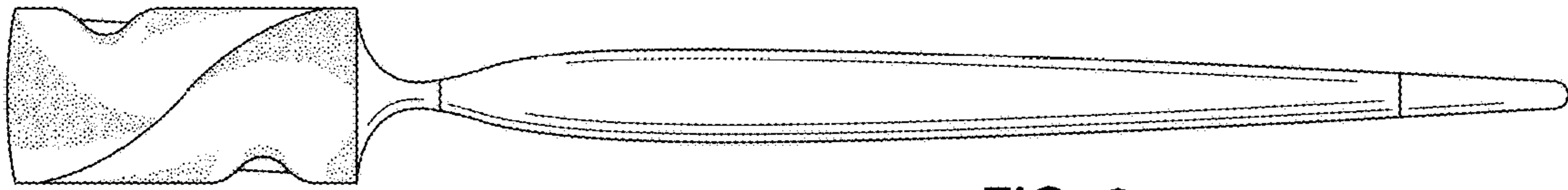

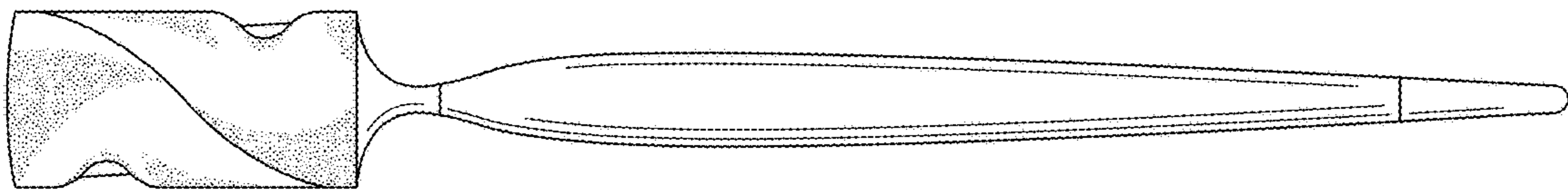

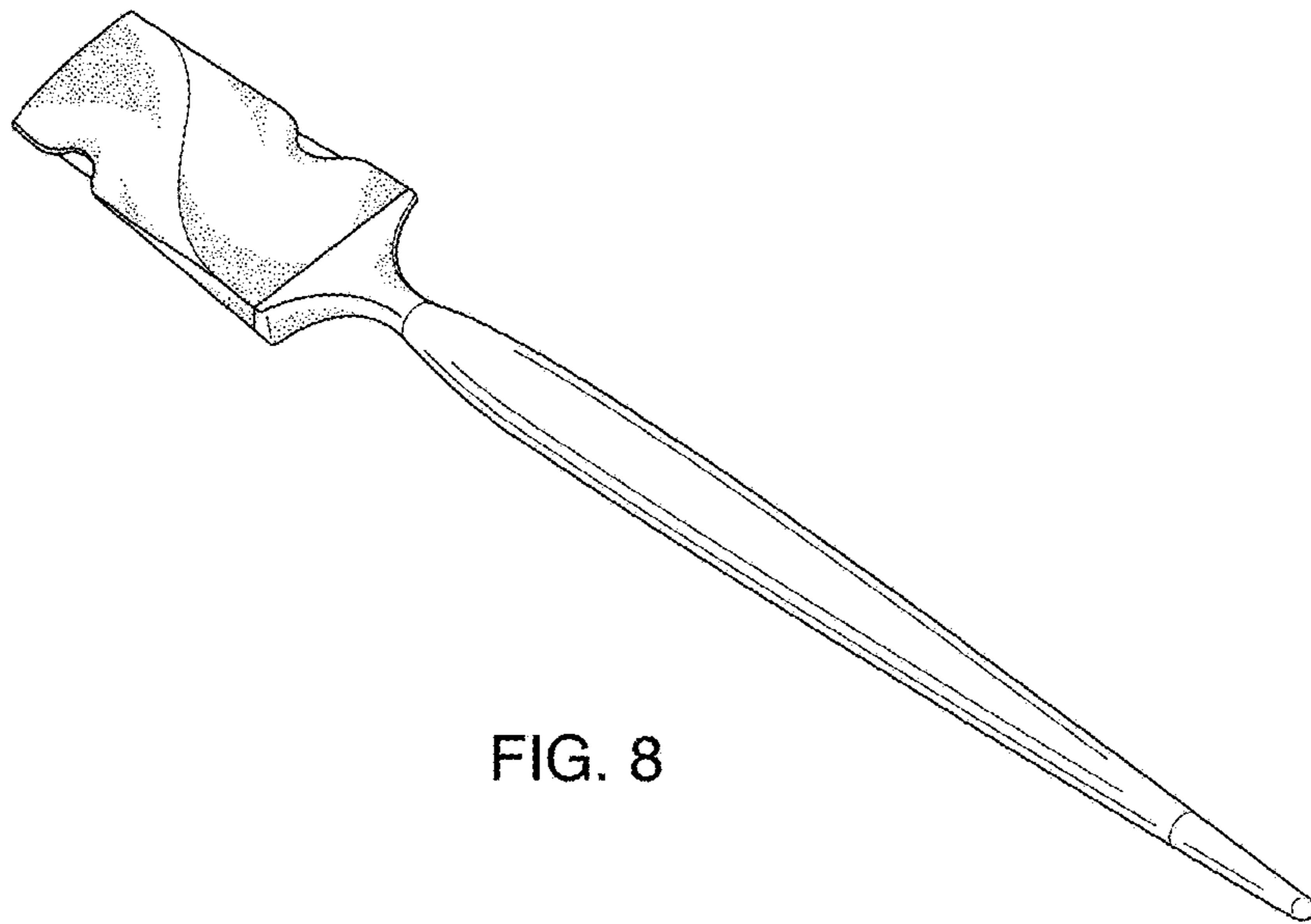
