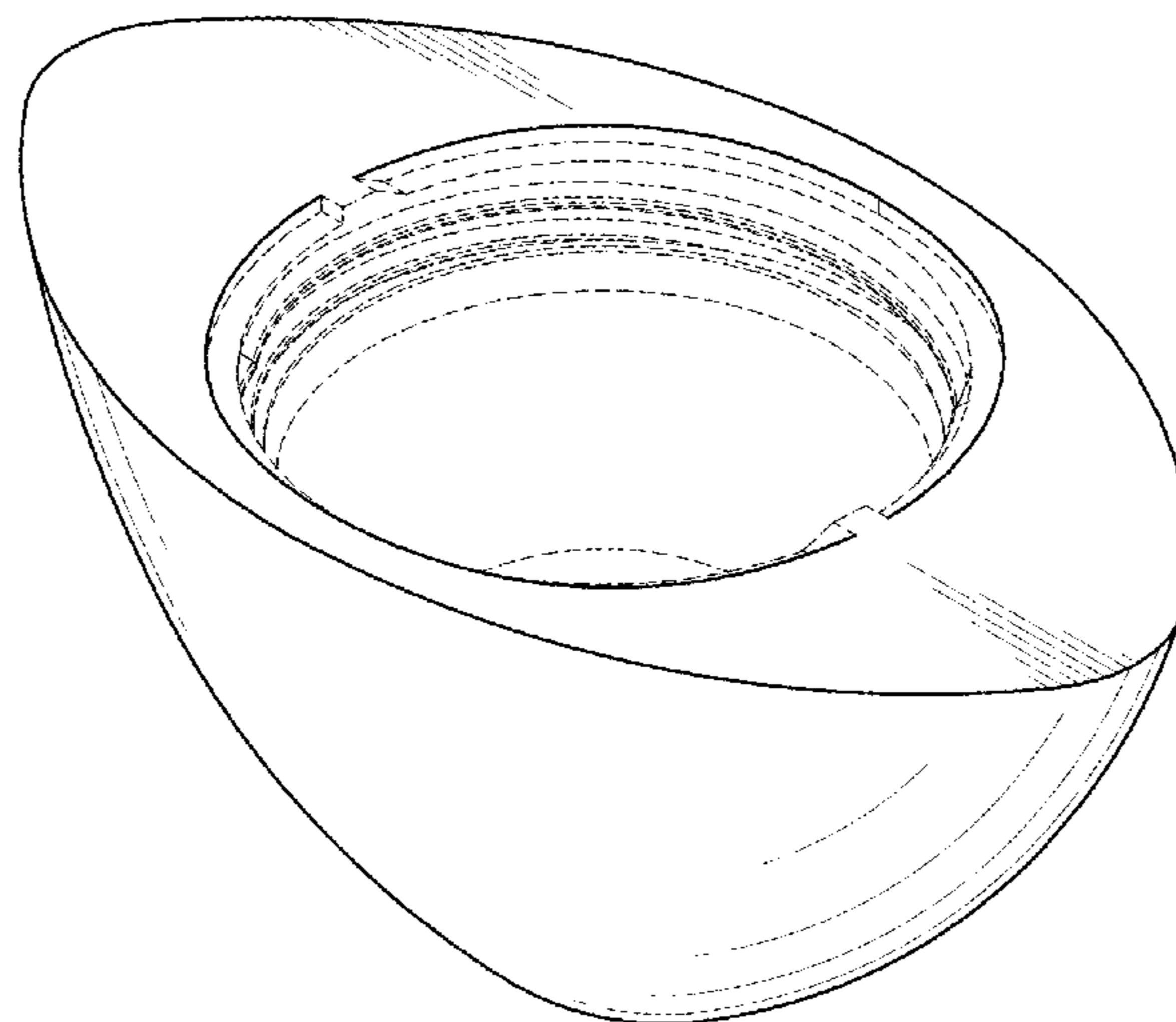
(57) **CLAIM**

The ornamental design for a heart-shaped lip balm container bottom, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a heart-shaped lip balm container bottom, showing my new design.
FIG. 2 is a front and rear elevational view thereof.
FIG. 3 is a side elevational view thereof.
FIG. 4 is a top plan view thereof; and,
FIG. 5 is a bottom plan view thereof.
The broken lines showing the threading are for the purpose of illustrating environmental structure which forms no part of the claimed design.

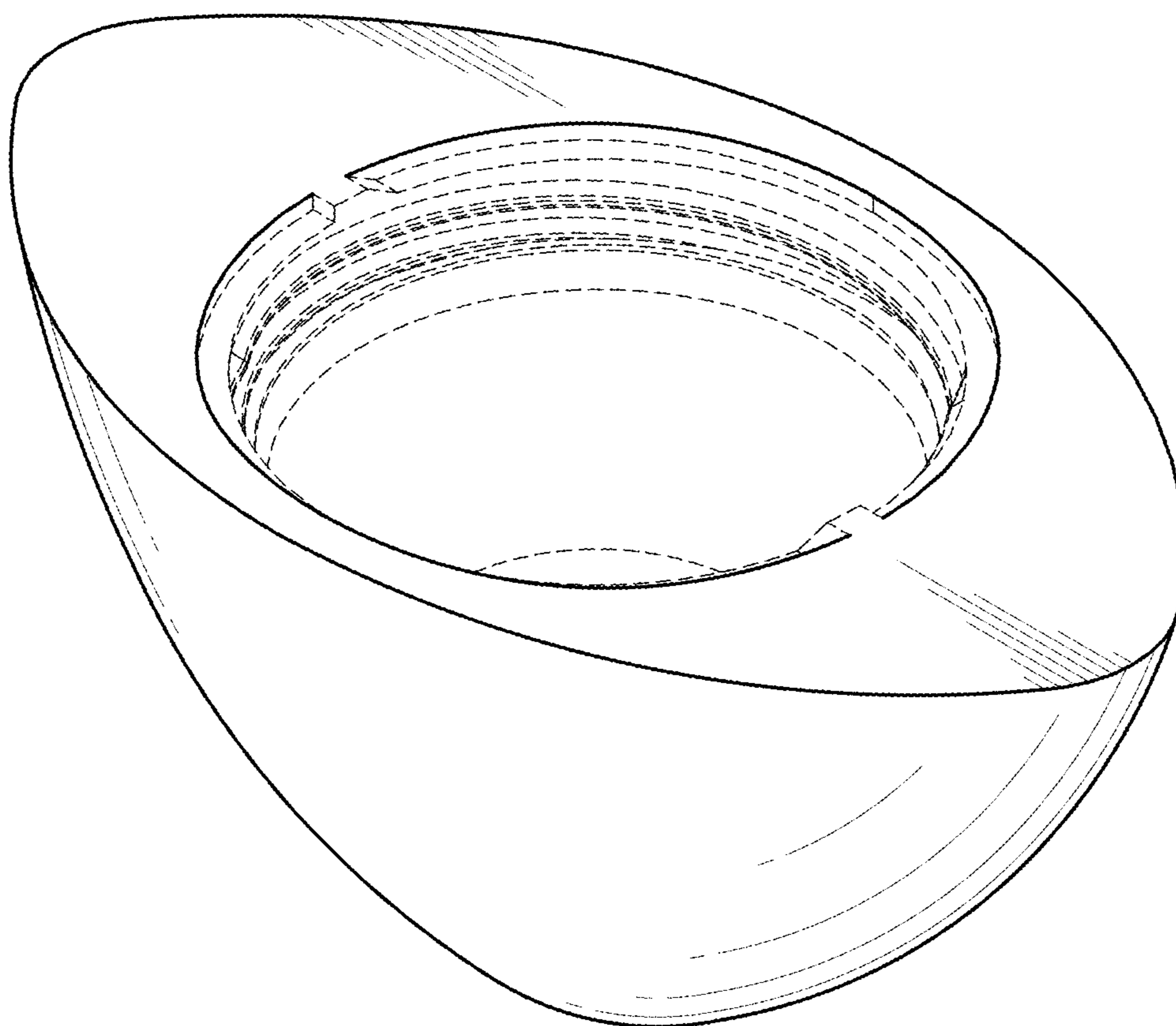

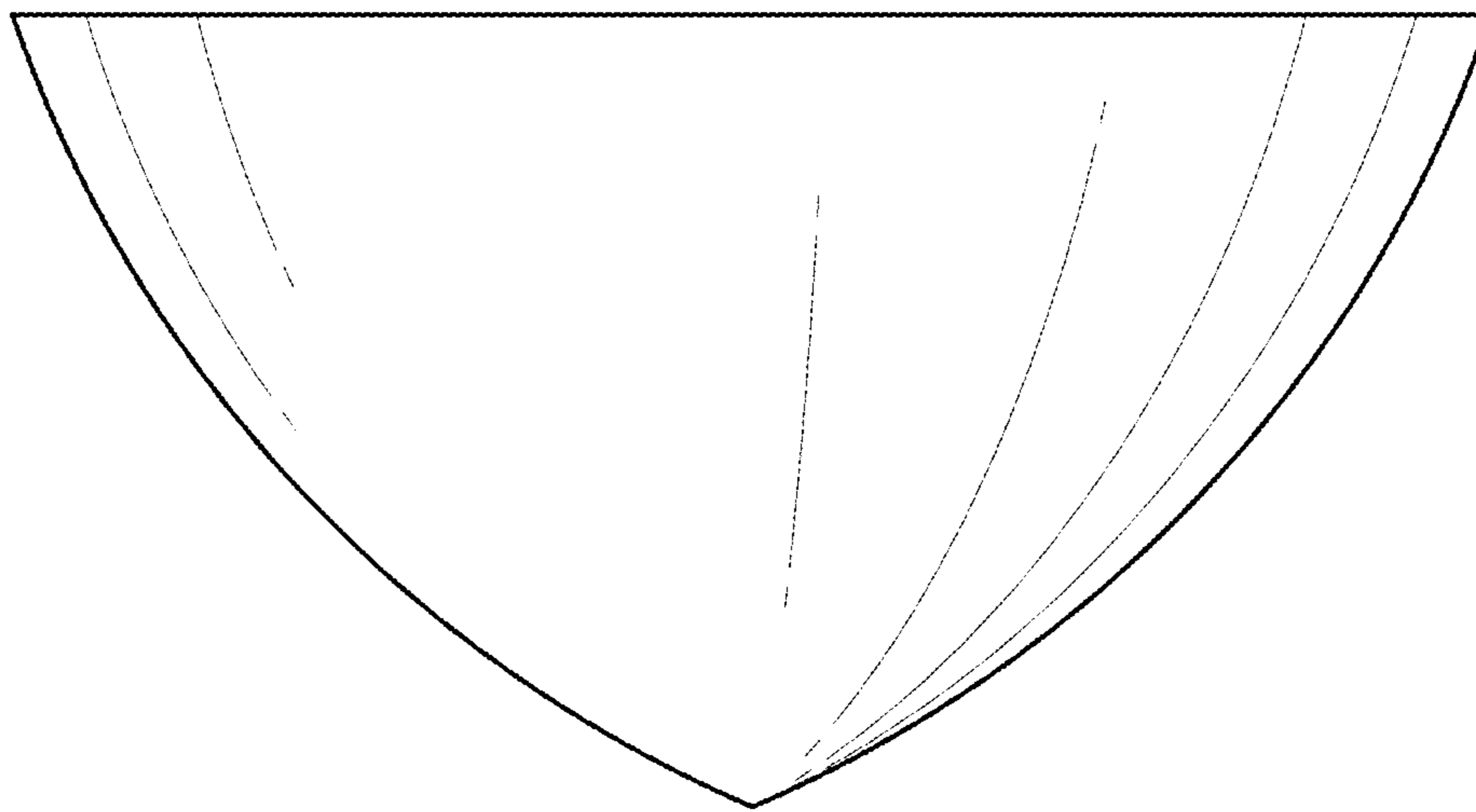

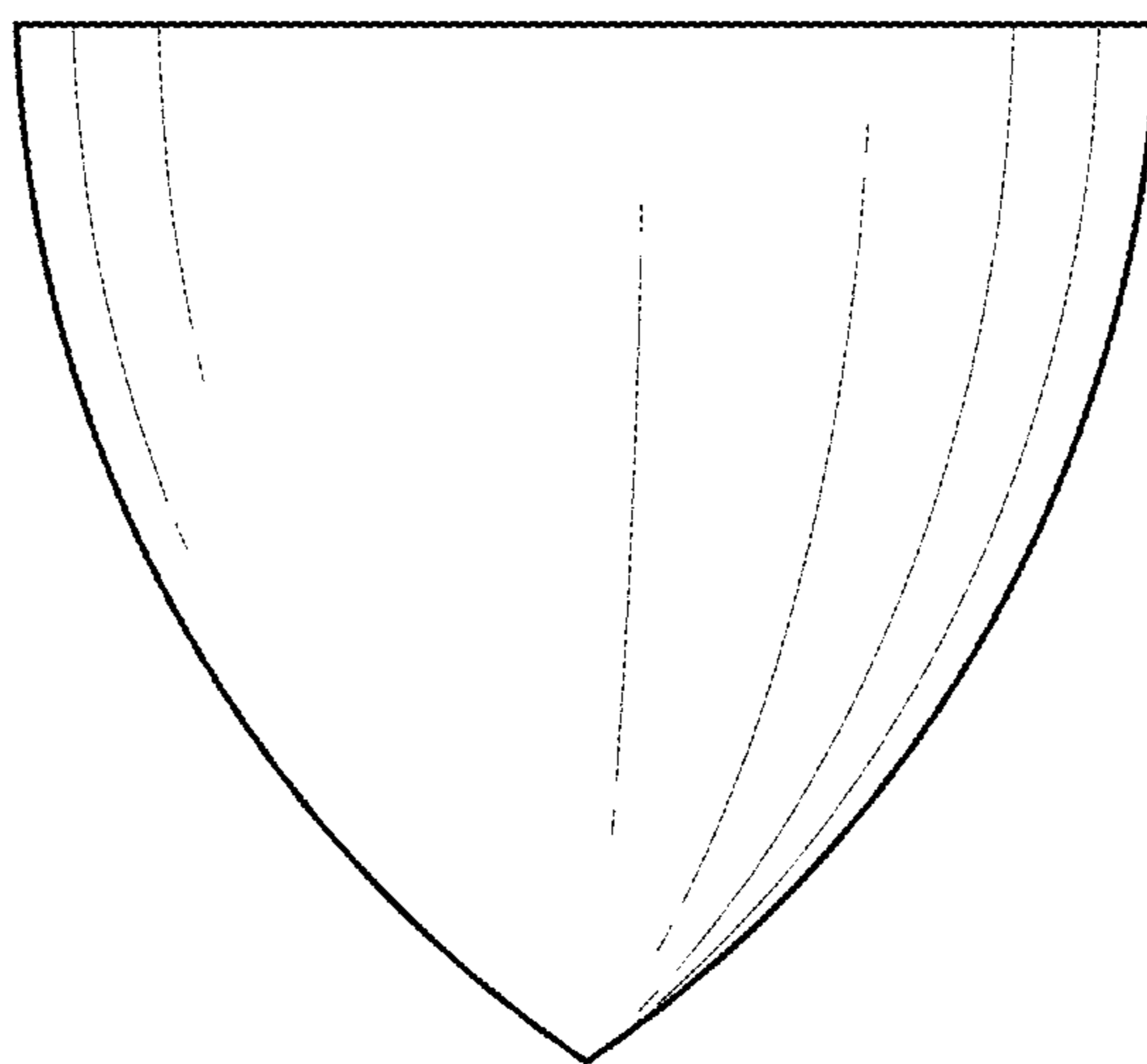

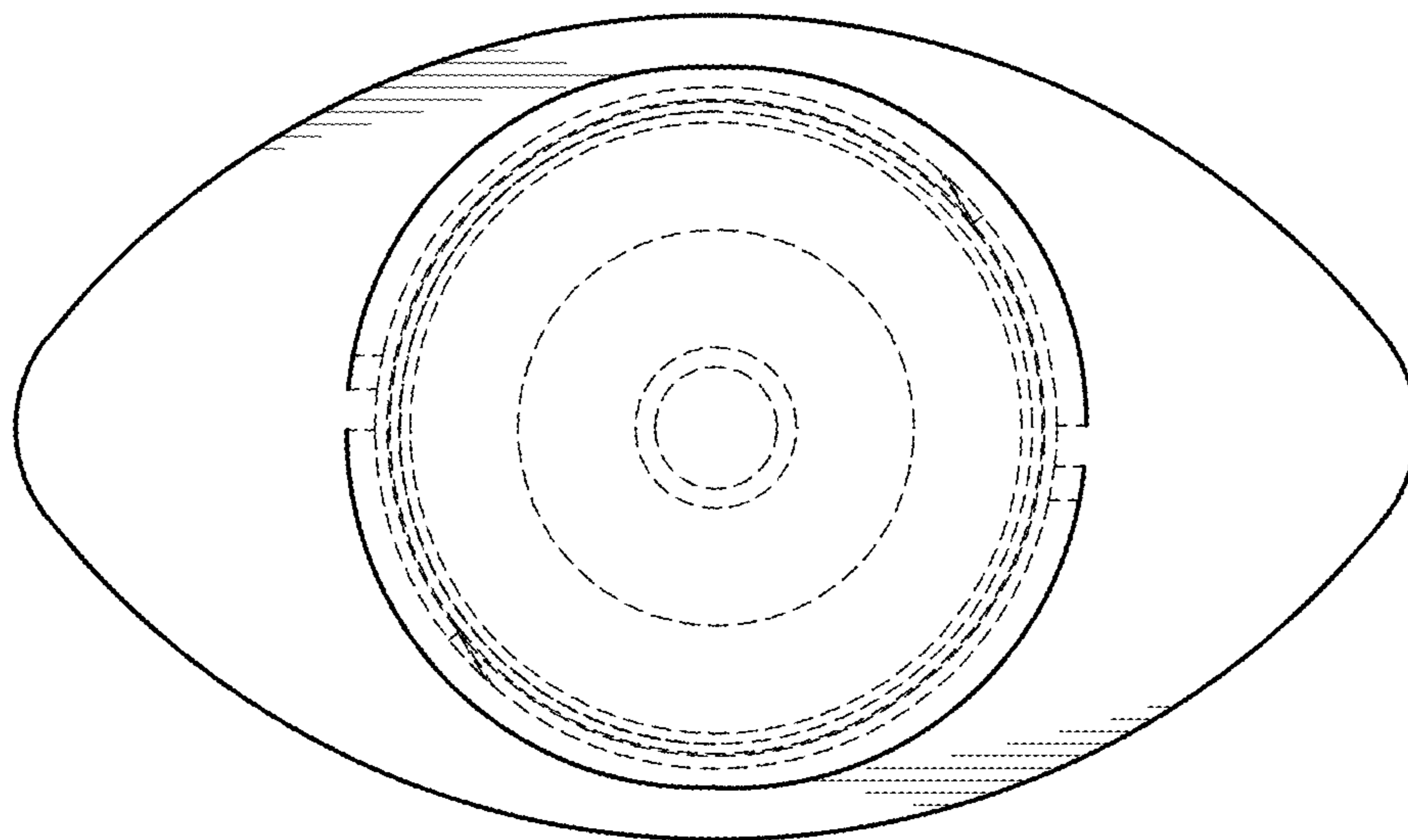

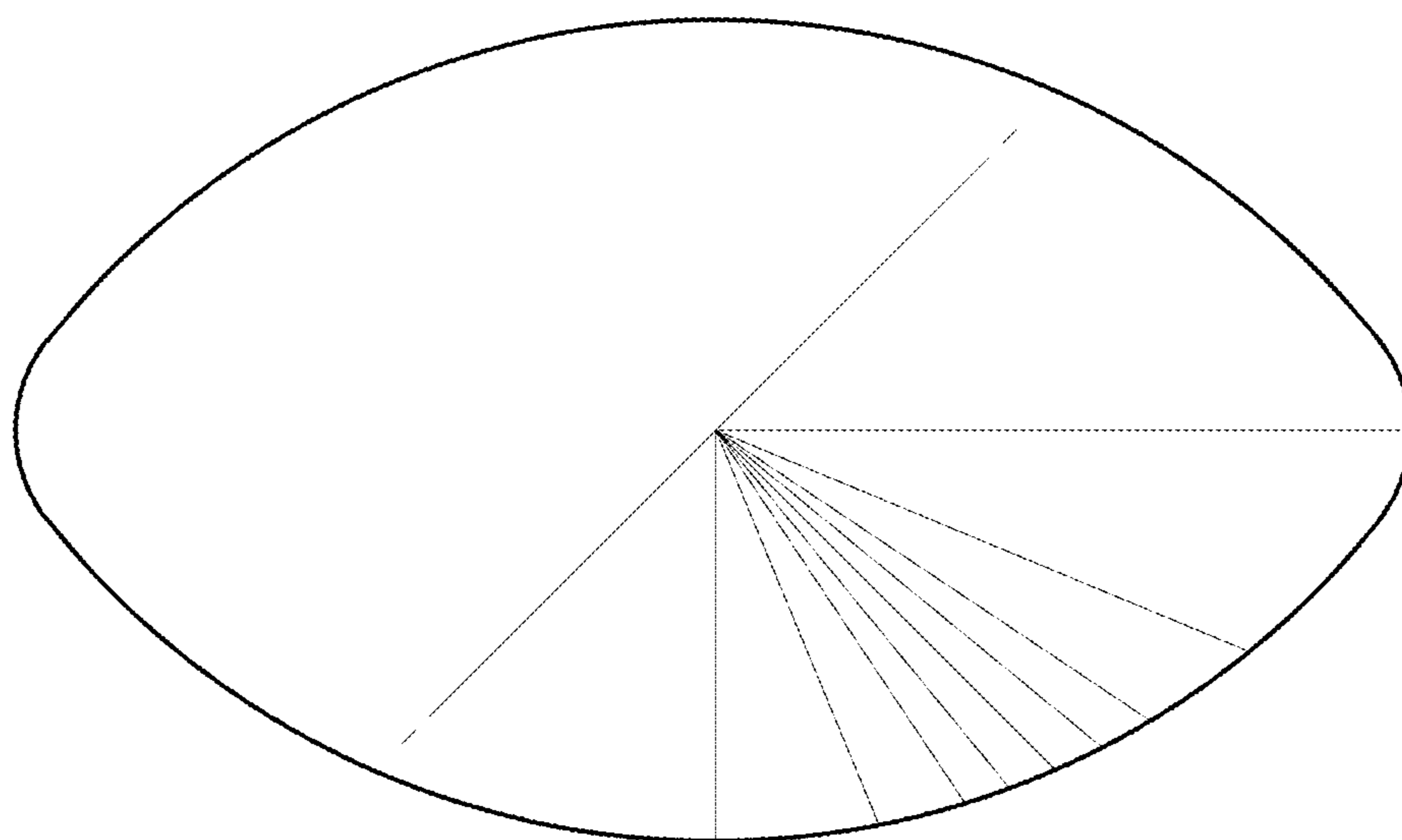
