DESCRIPTION

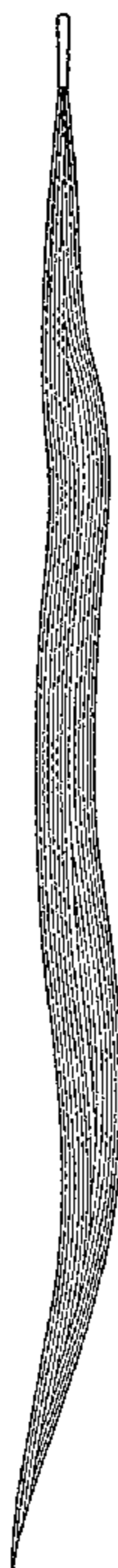
FIG. 1 is a front view of a hair extension showing my new design;

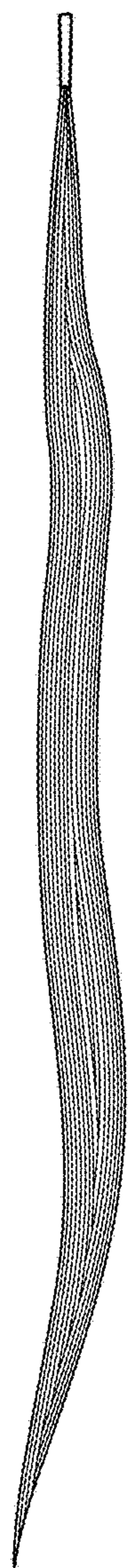

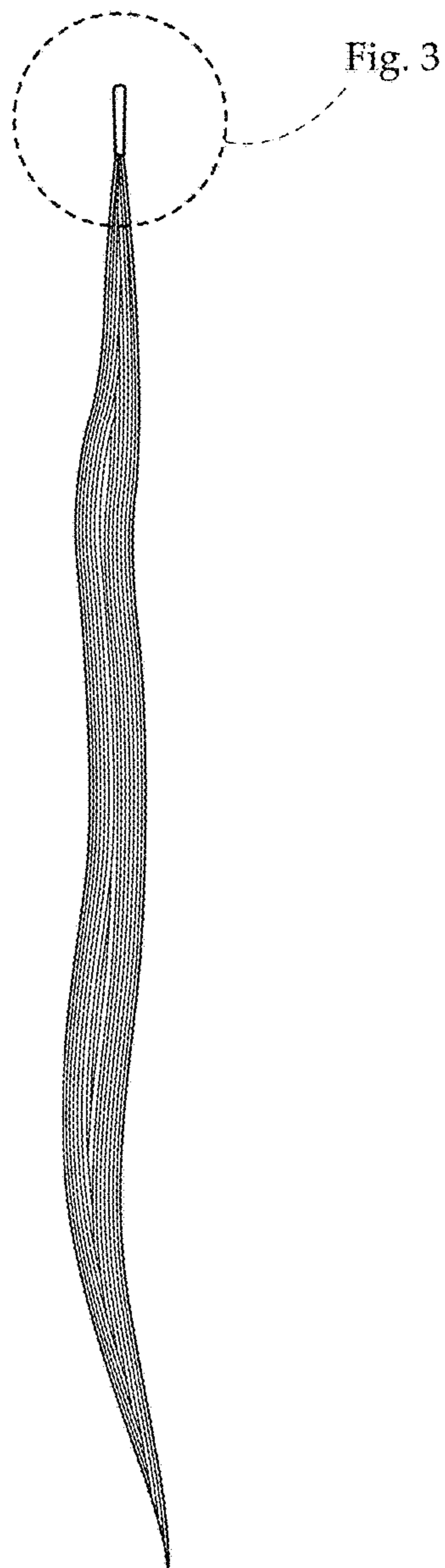

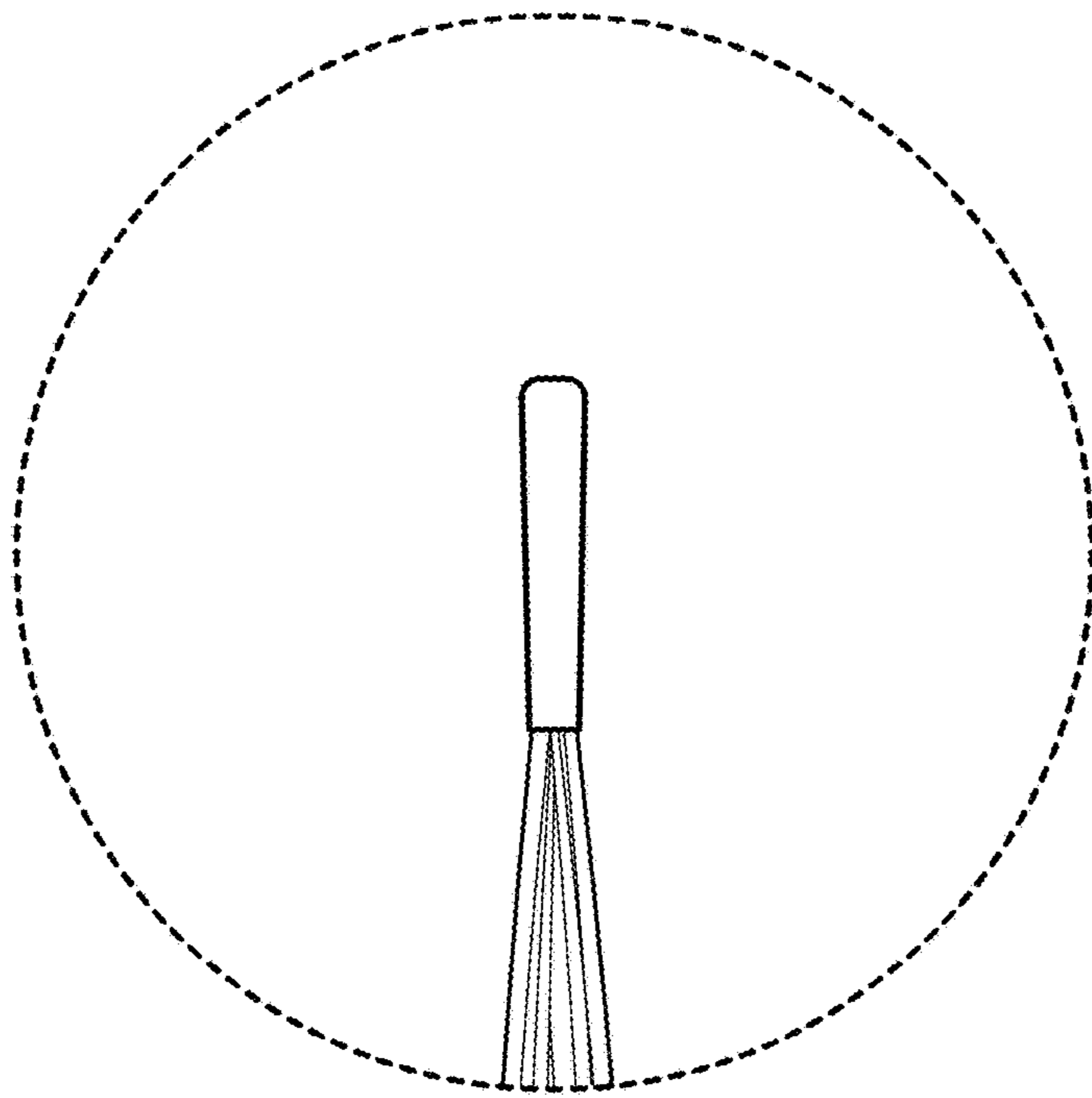
