DESCRIPTION

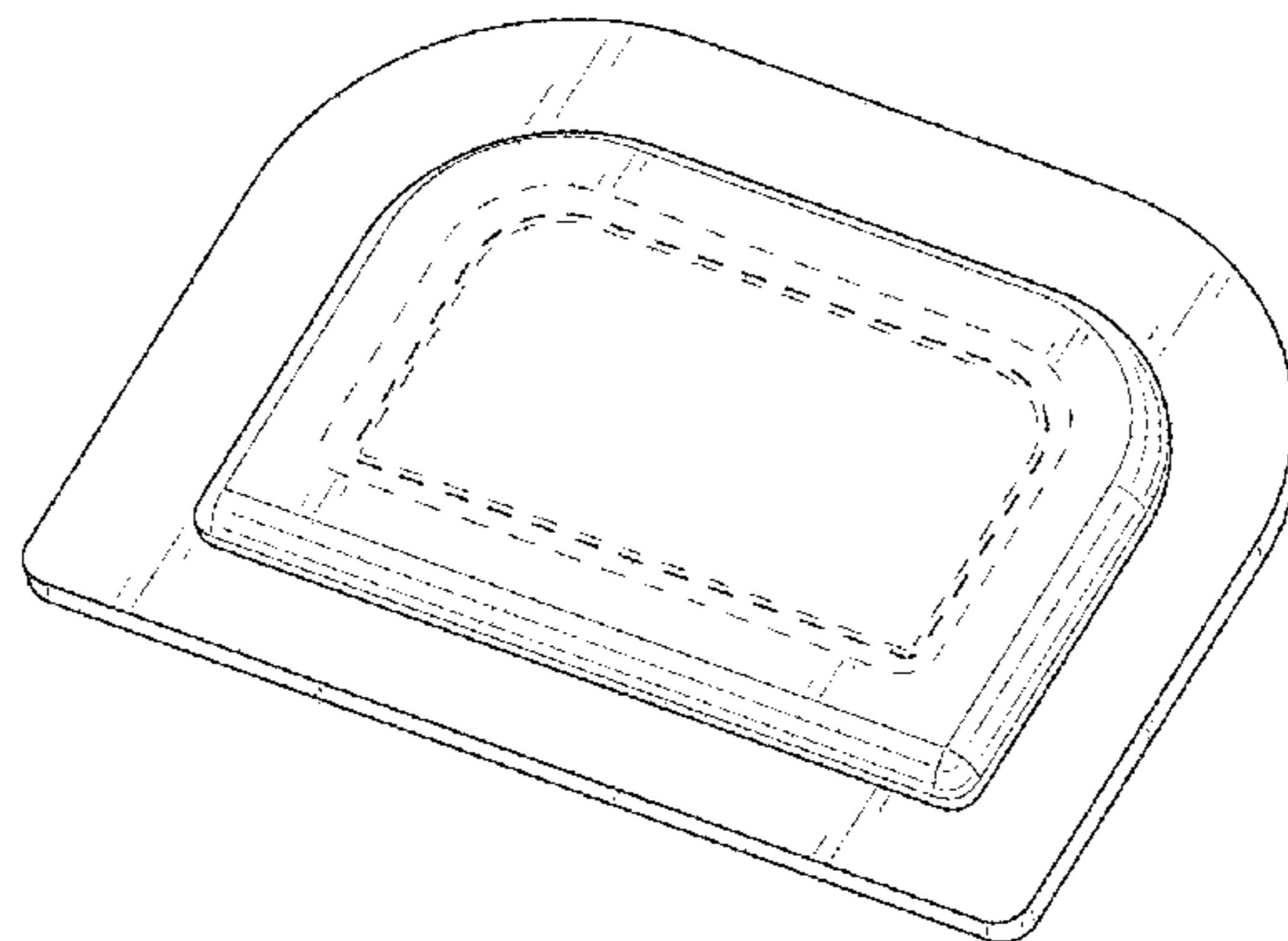
FIG. 1 is a perspective view of the handheld detailer showing my new design;

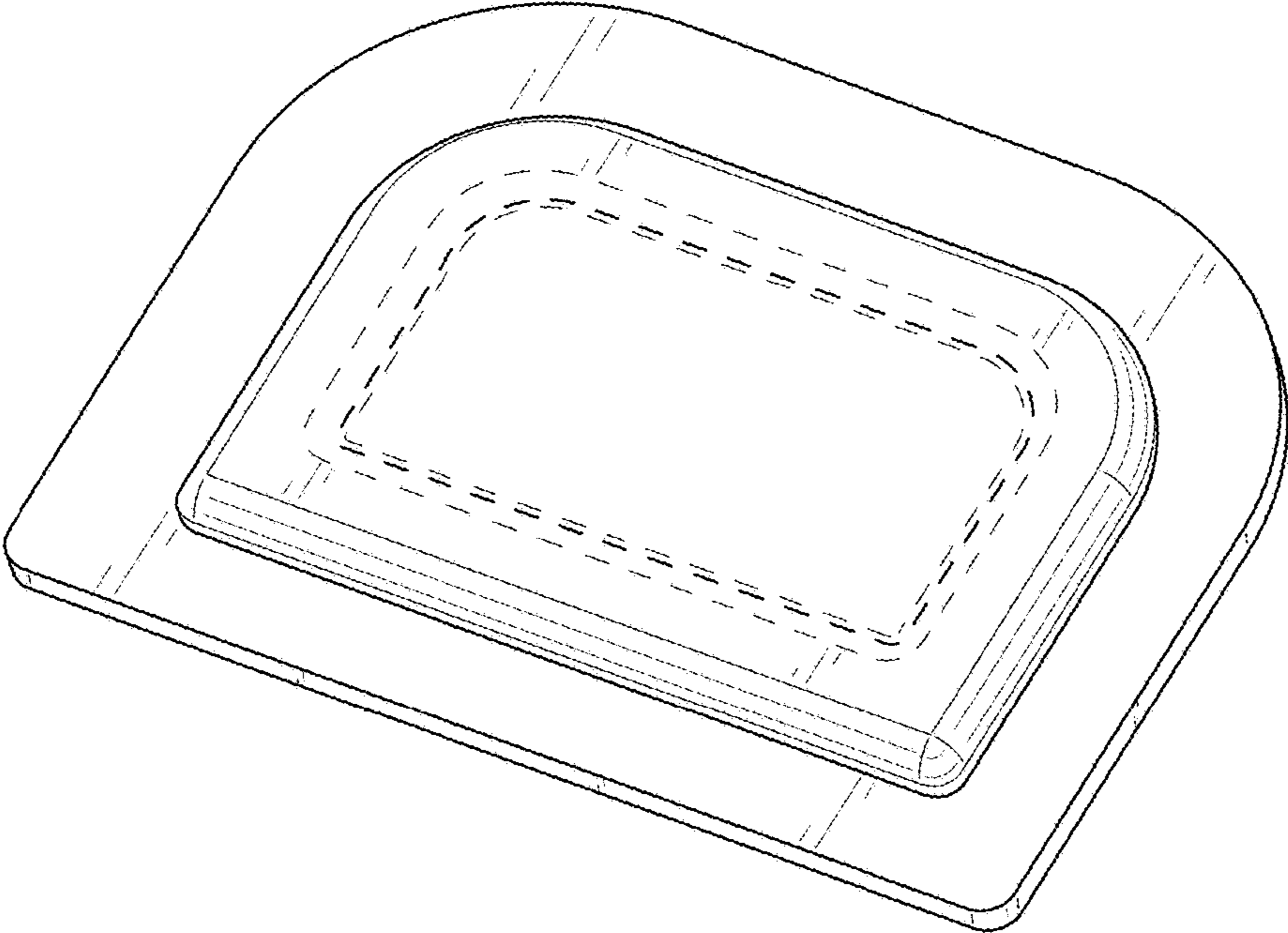

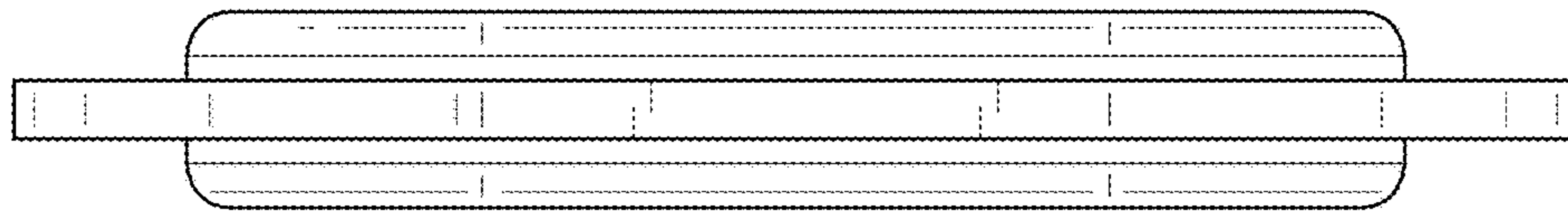

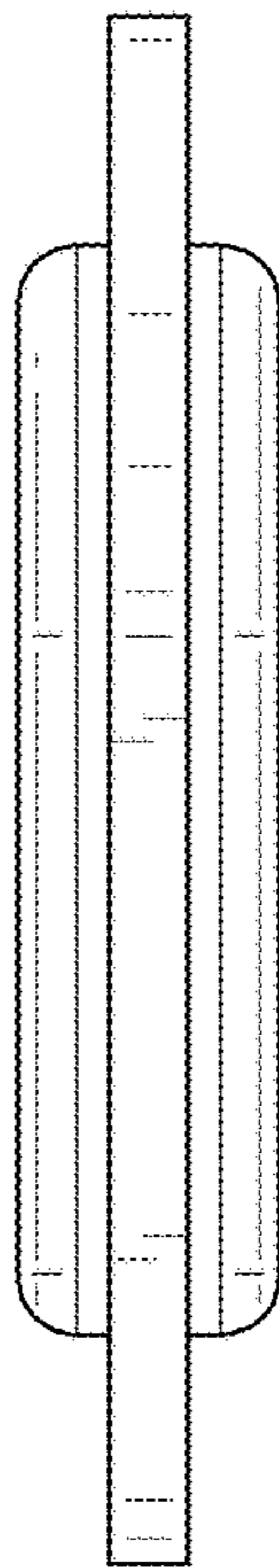

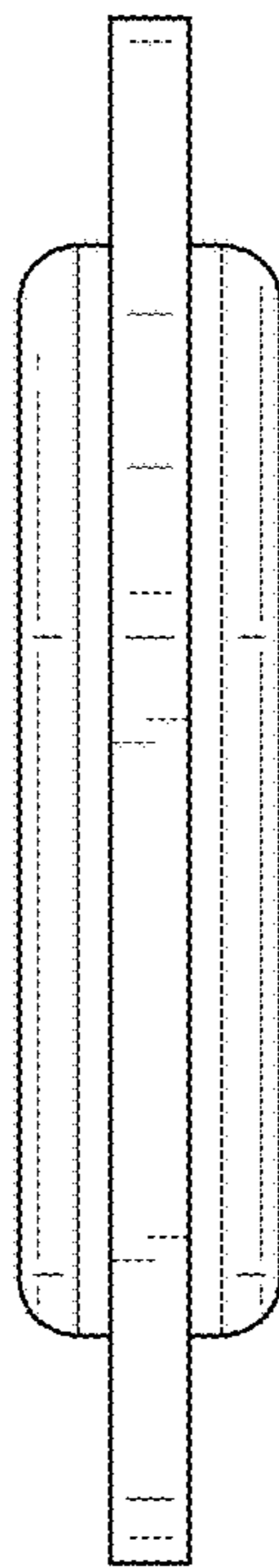

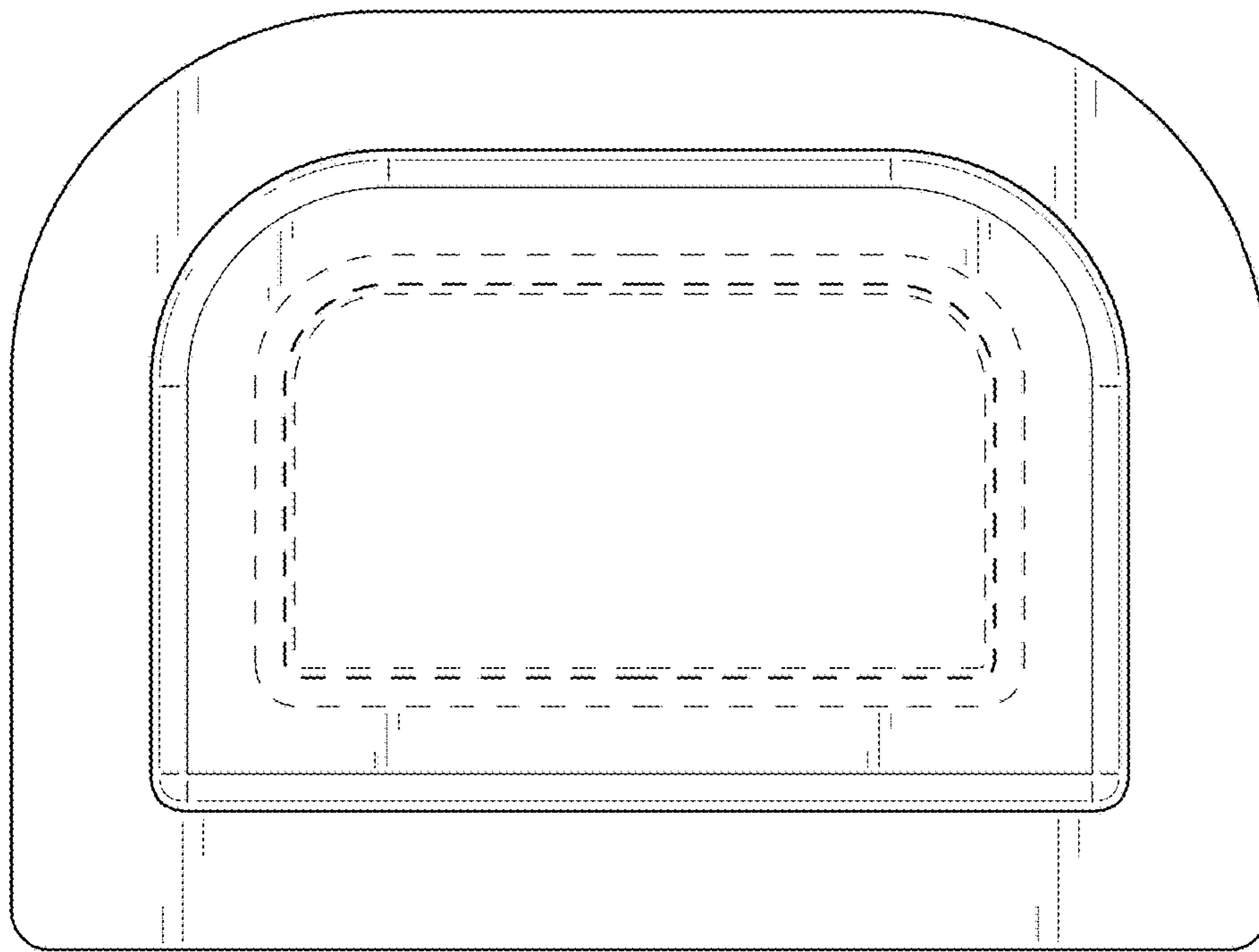

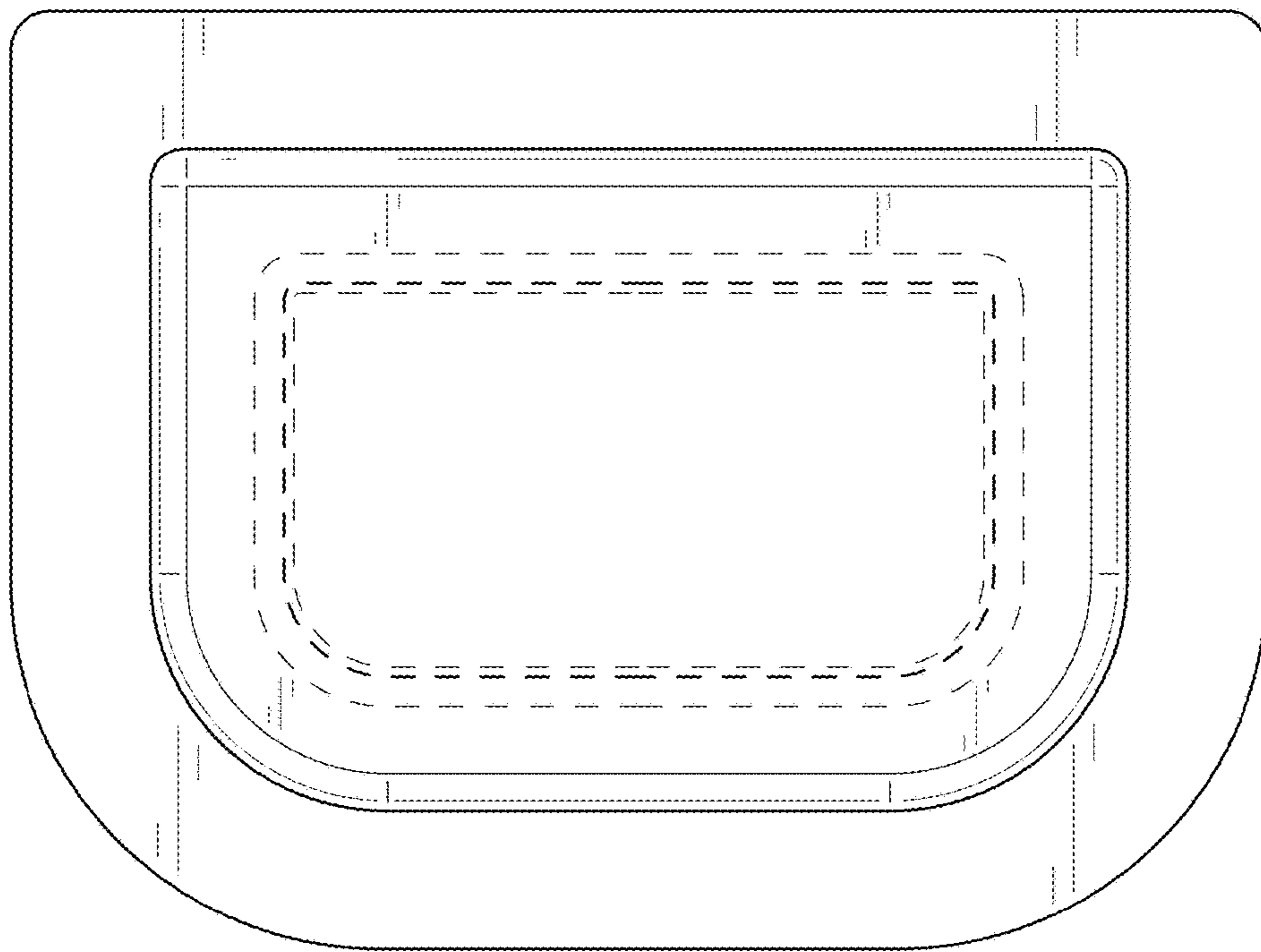
