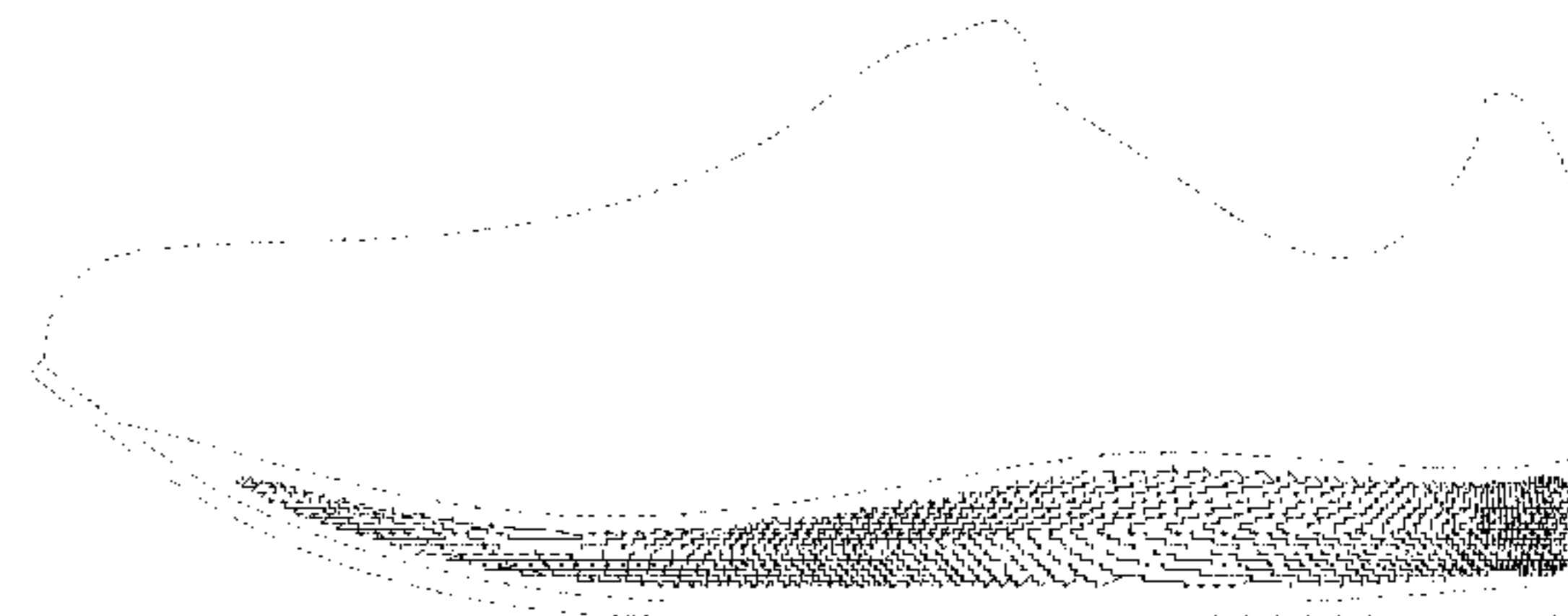
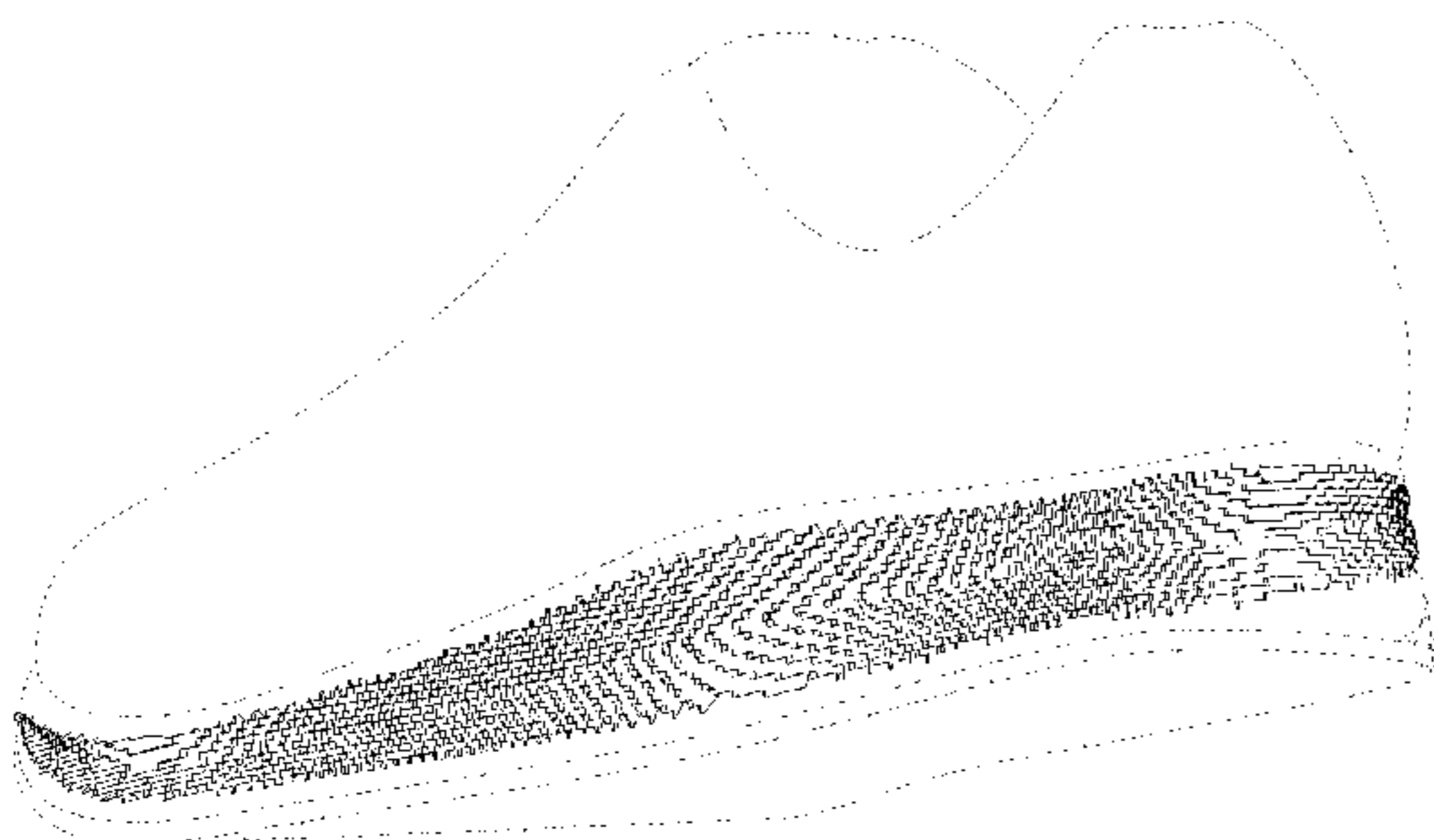
The ornamental design for footwear sole, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of the footwear sole embodying the new design;
FIG. 2 is a second perspective view thereof;
FIG. 3 is a third perspective view thereof;
FIG. 4 is a top plan view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a front elevational view thereof; and,
FIG. 8 is a rear elevational view thereof.

FIGS. 1-8 show portions of the footwear in broken lines, which portions are not included in the claim, or which depict environment that is not included in the claim. The broken lines around the perimeter, and immediately adjacent the

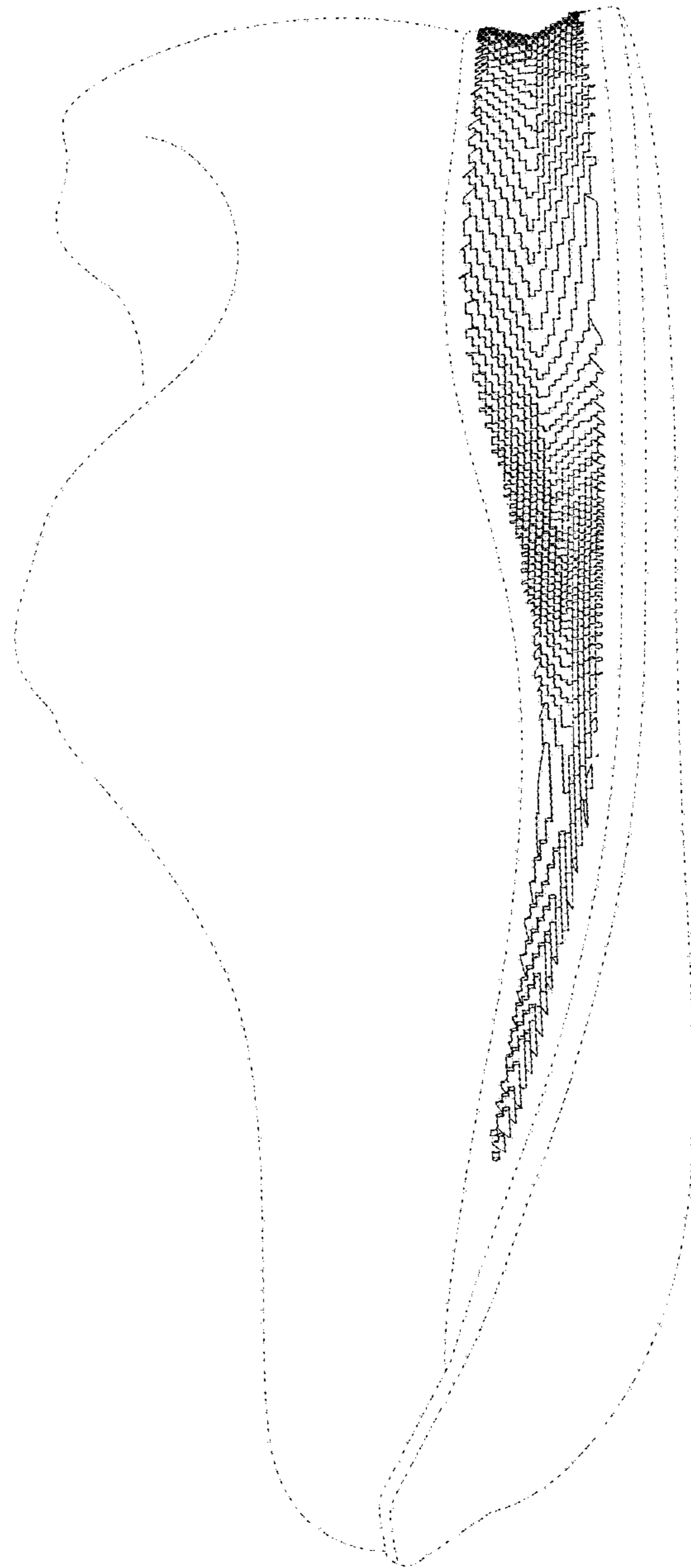

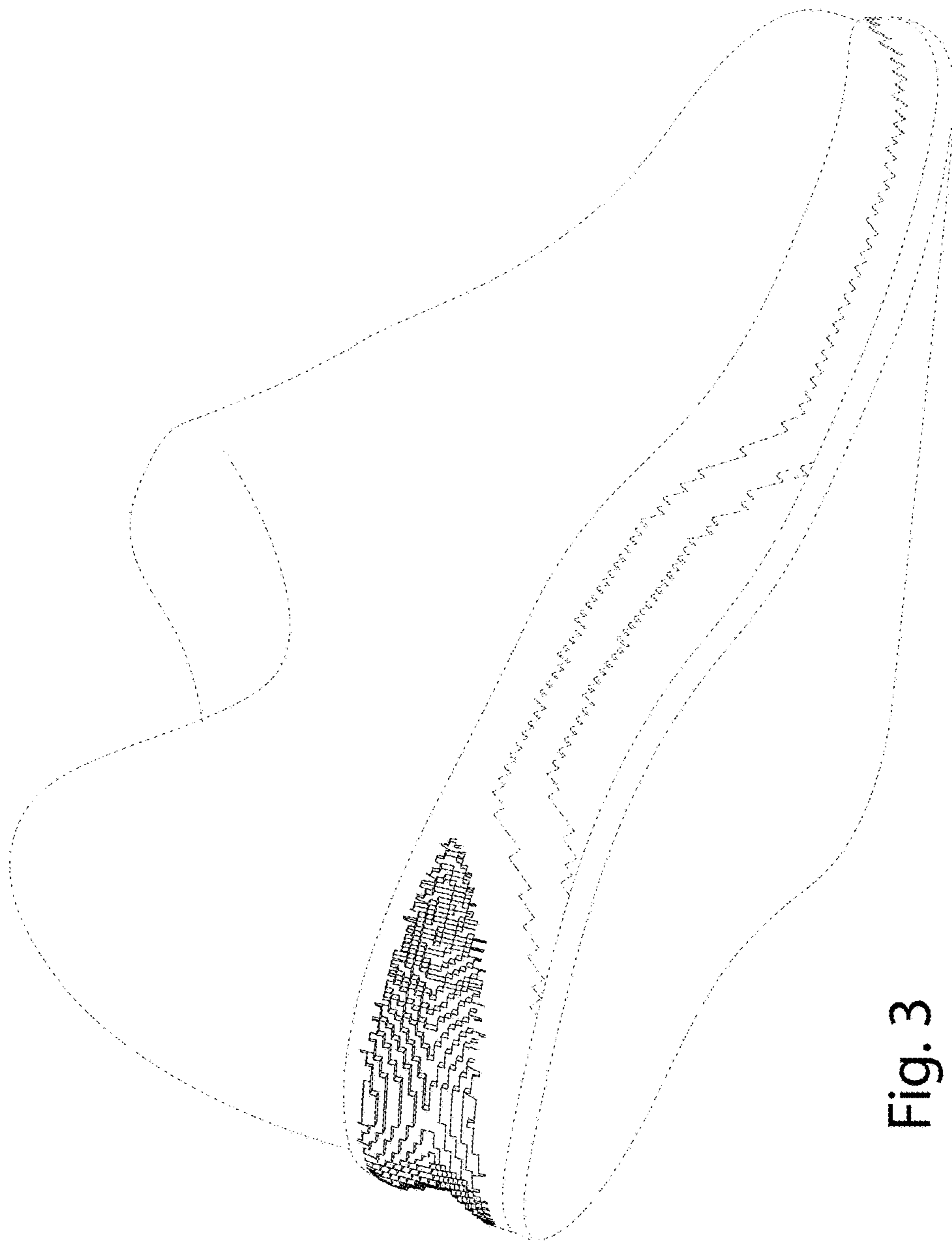

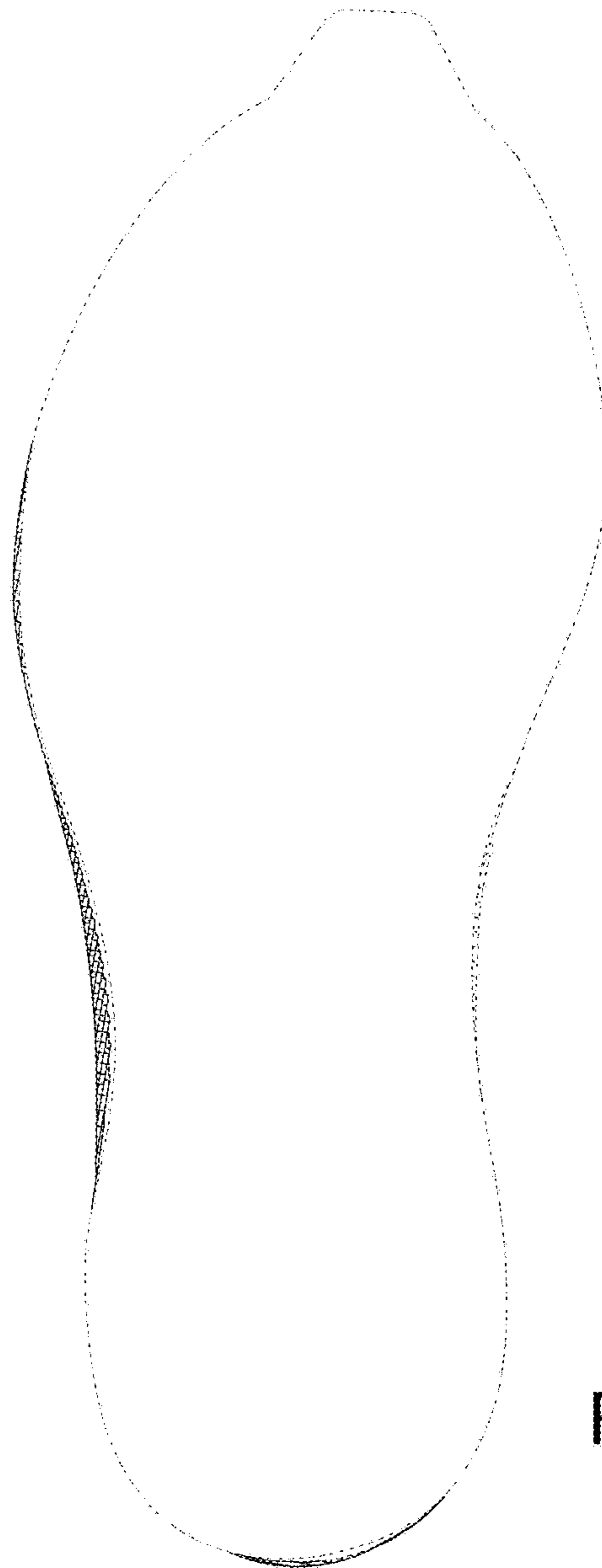

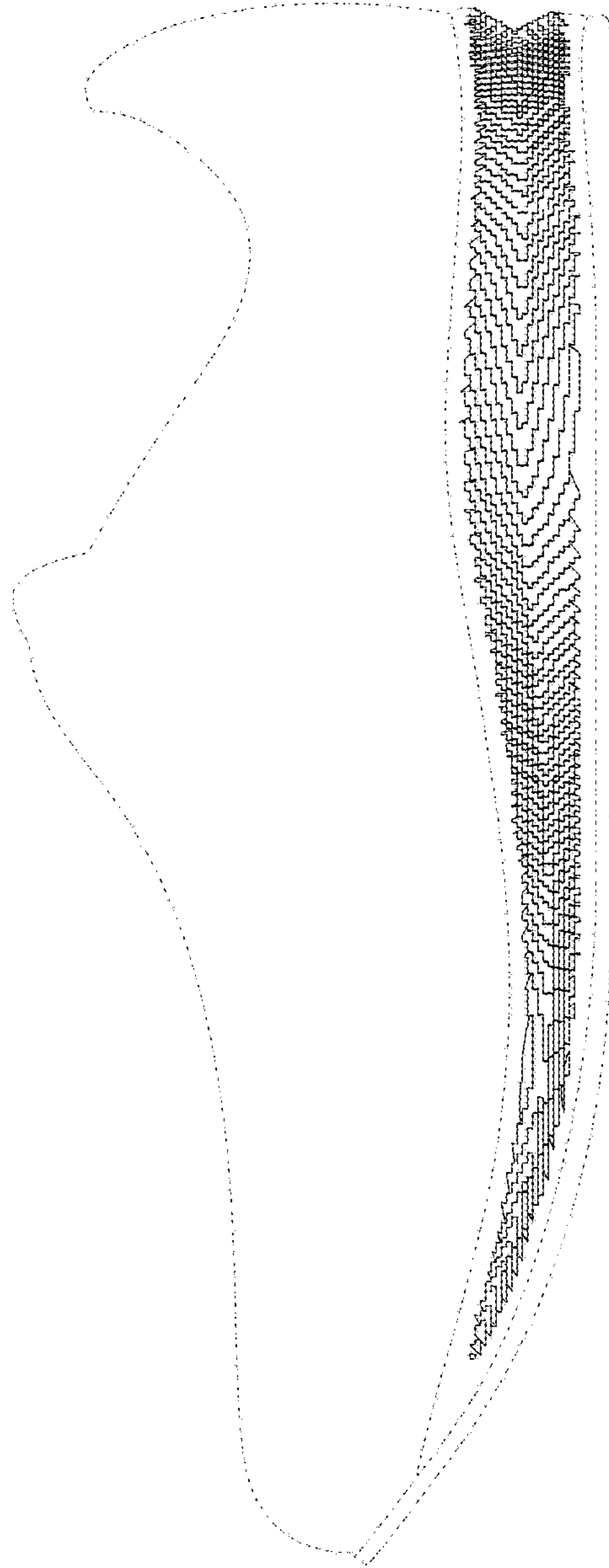

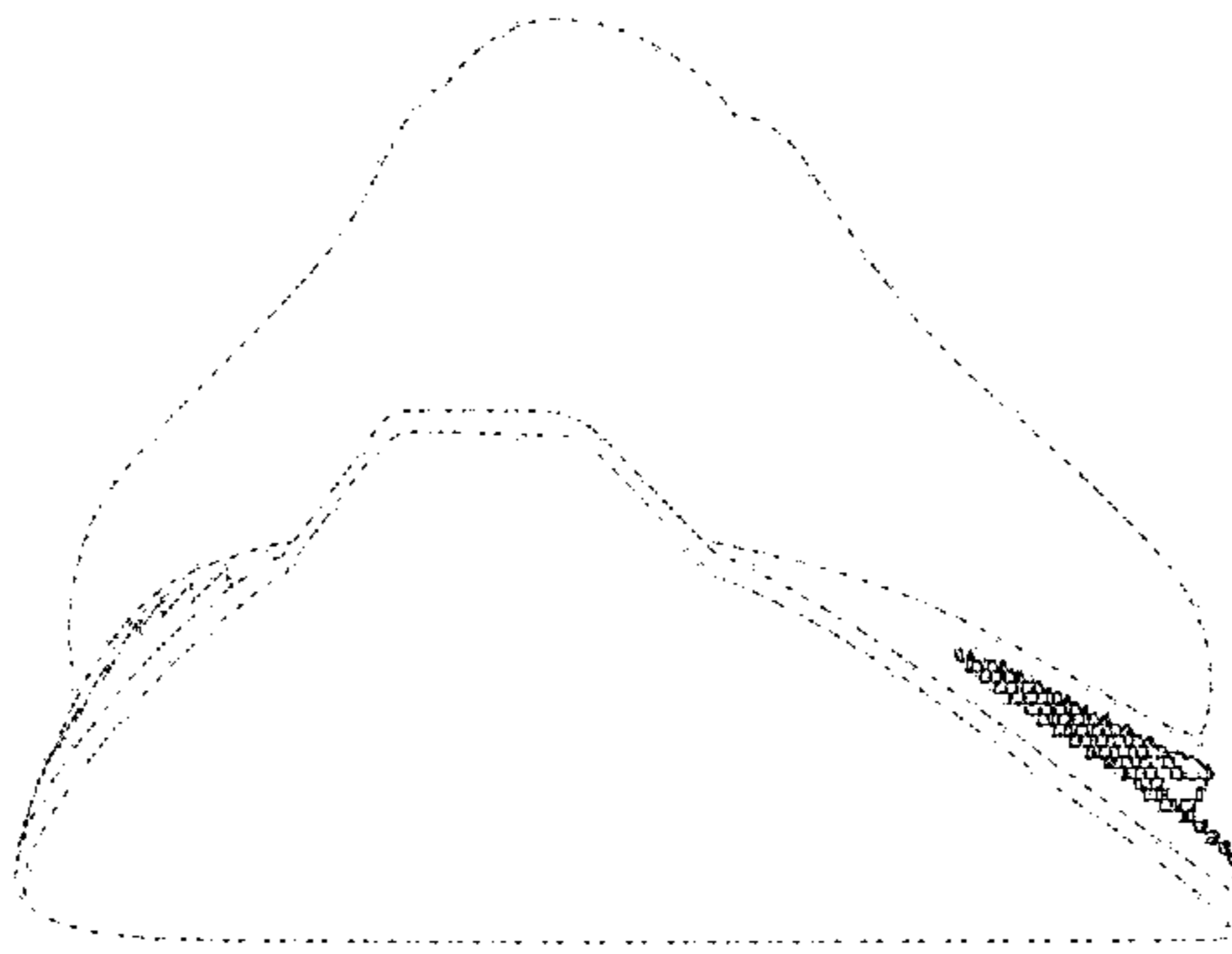

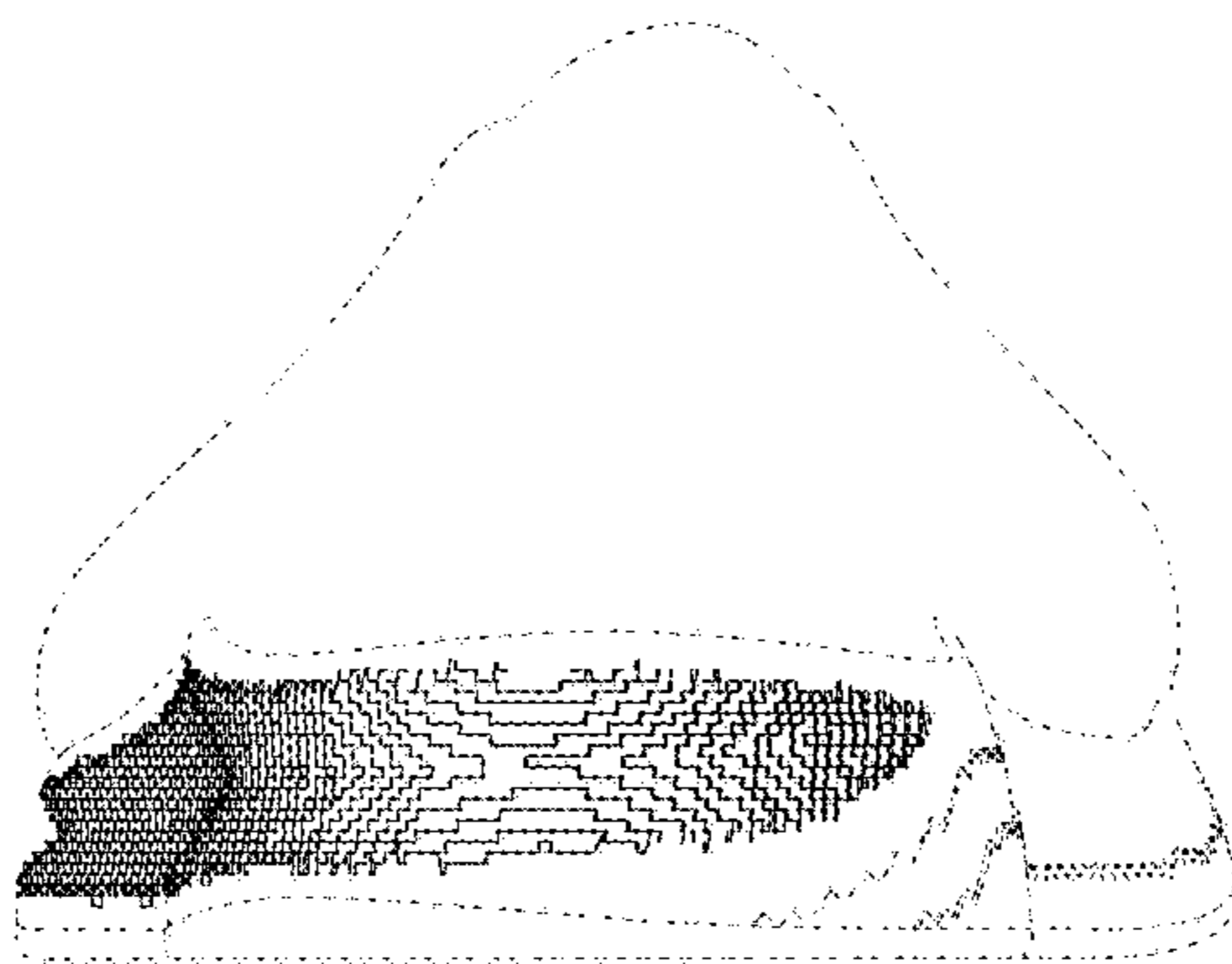
