(57) **CLAIM**

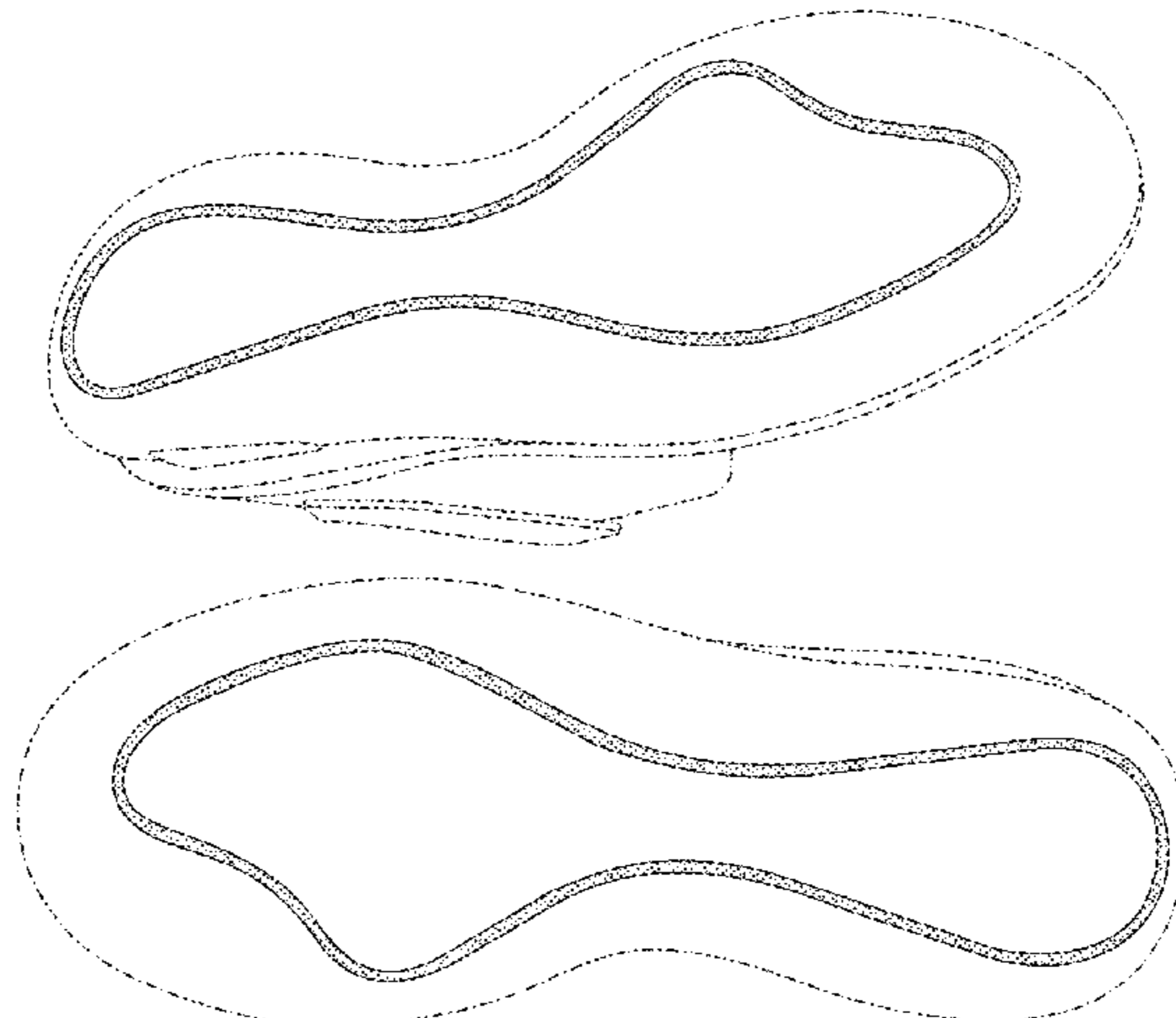
The ornamental design for a shoe outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front lateral perspective view of a shoe outsole showing my new design;  
FIG. 2 is a front medial perspective view thereof;

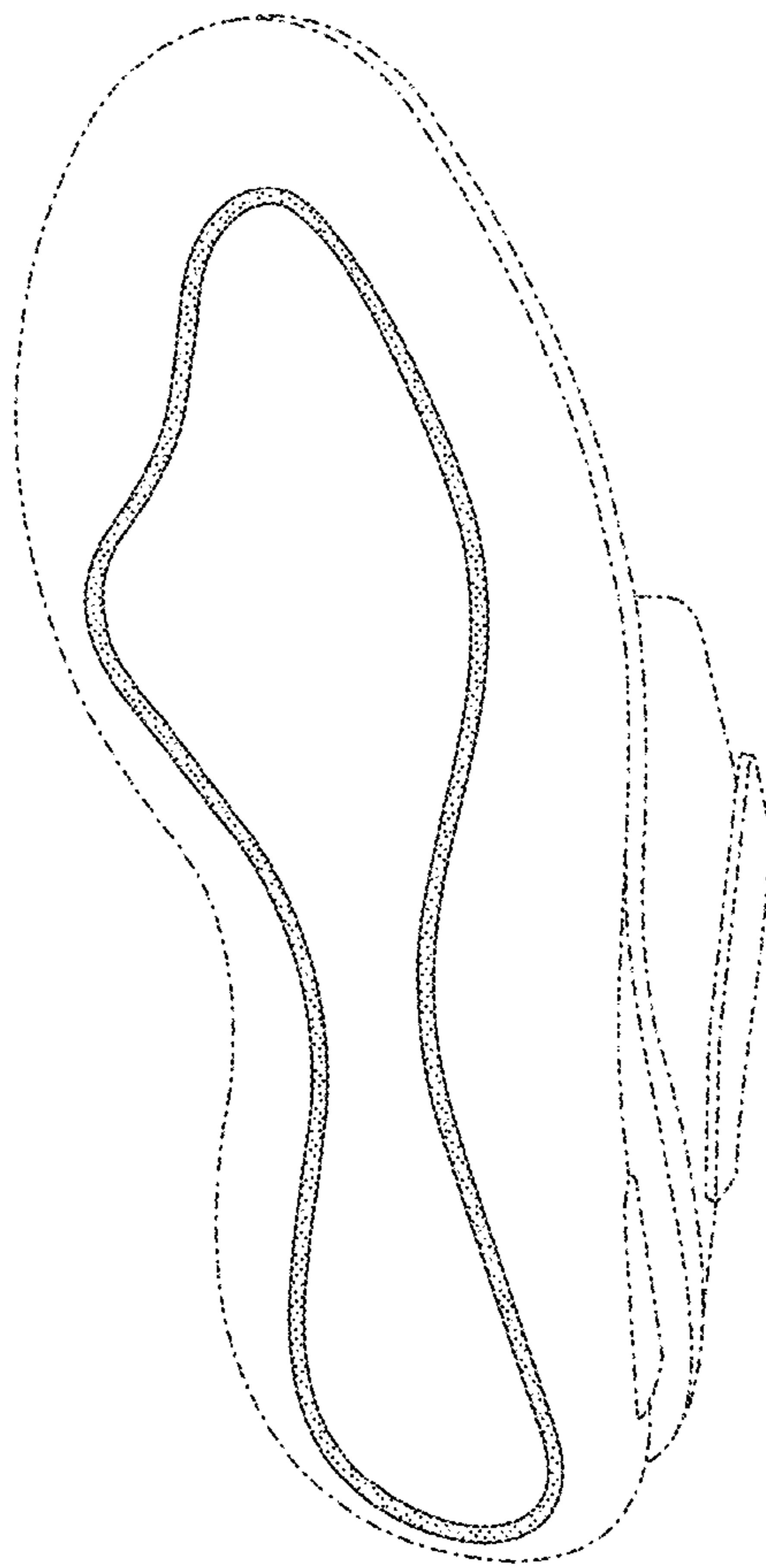

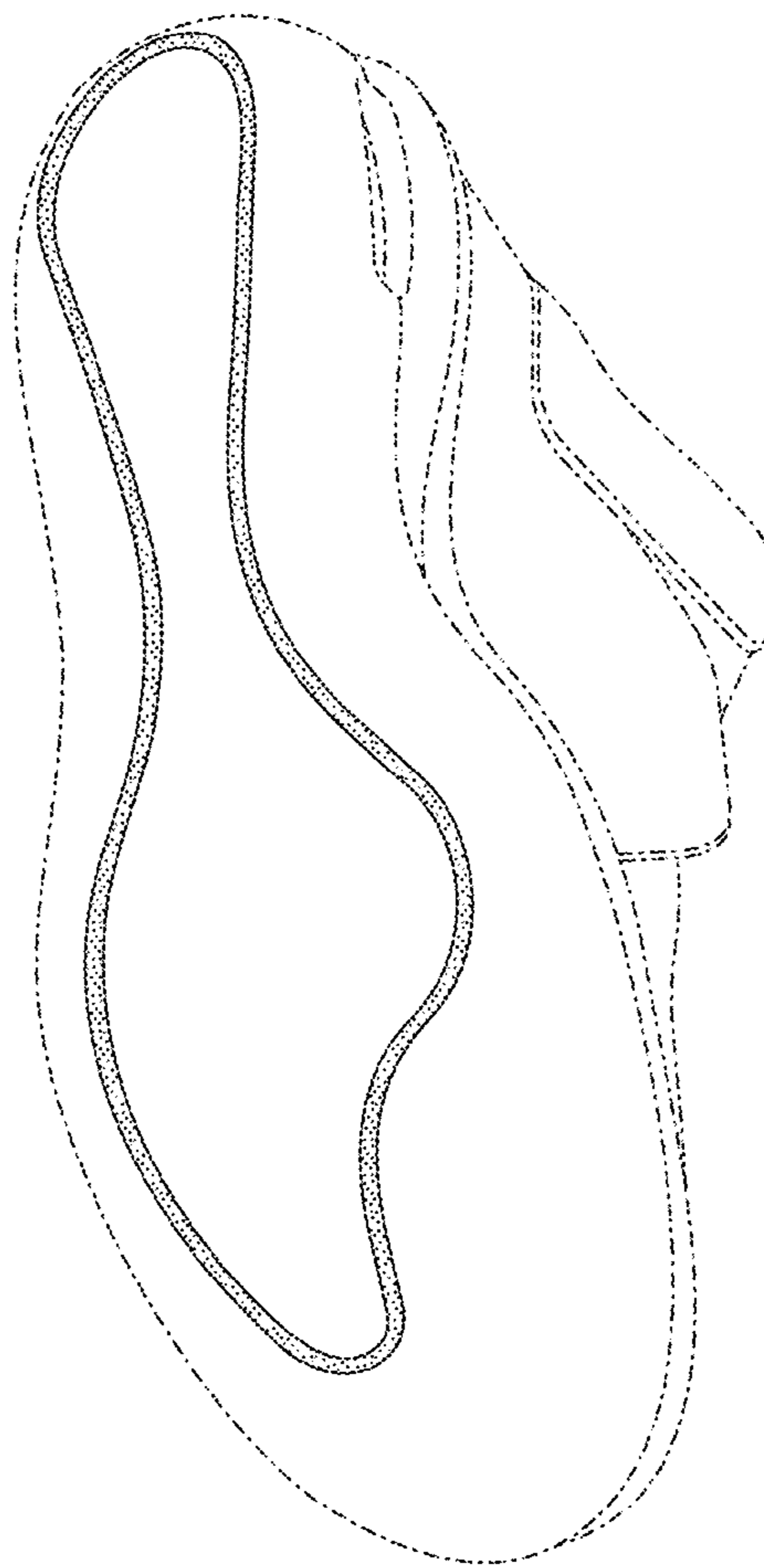

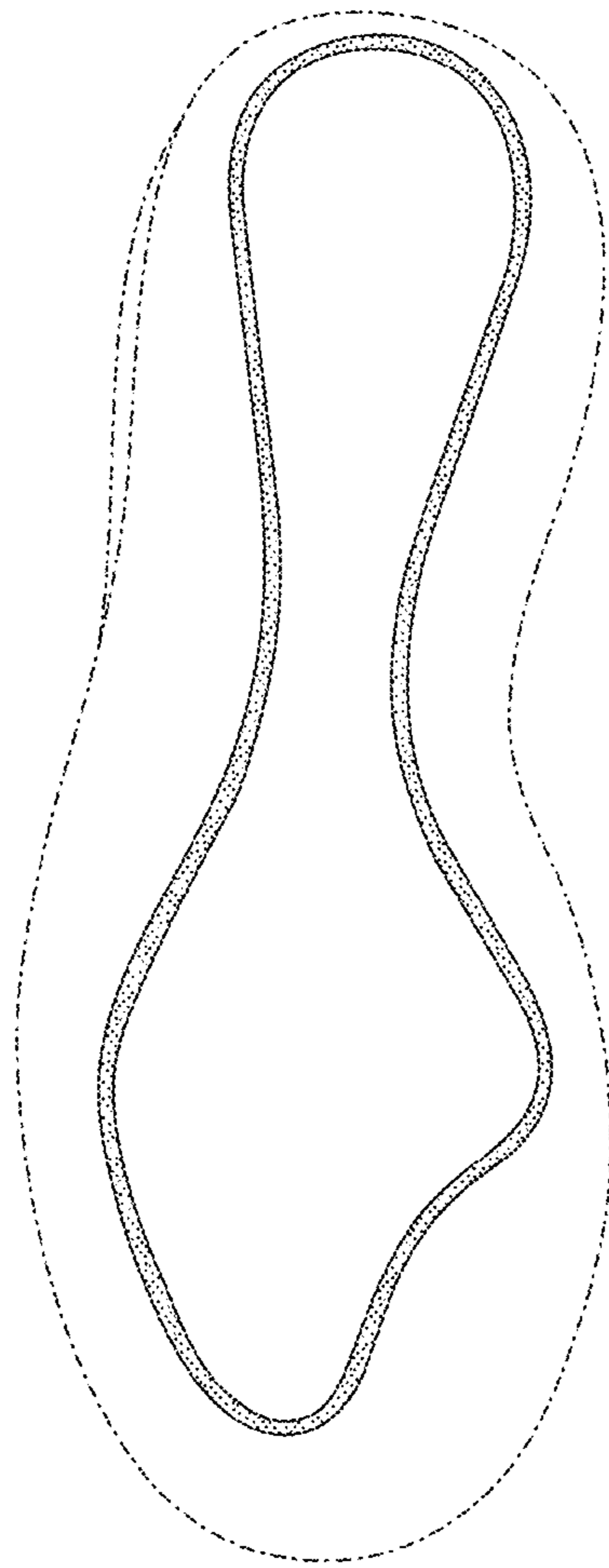

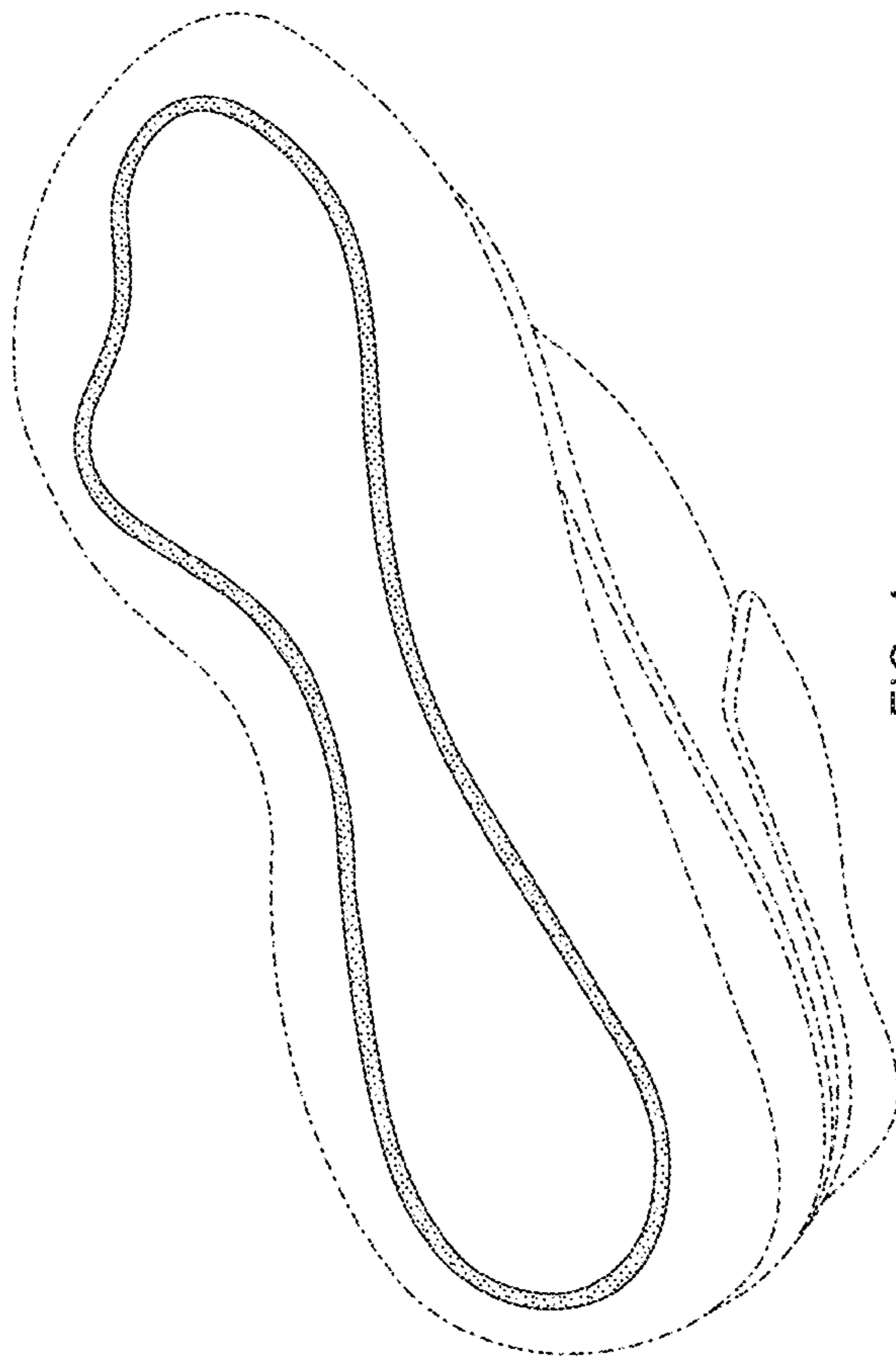

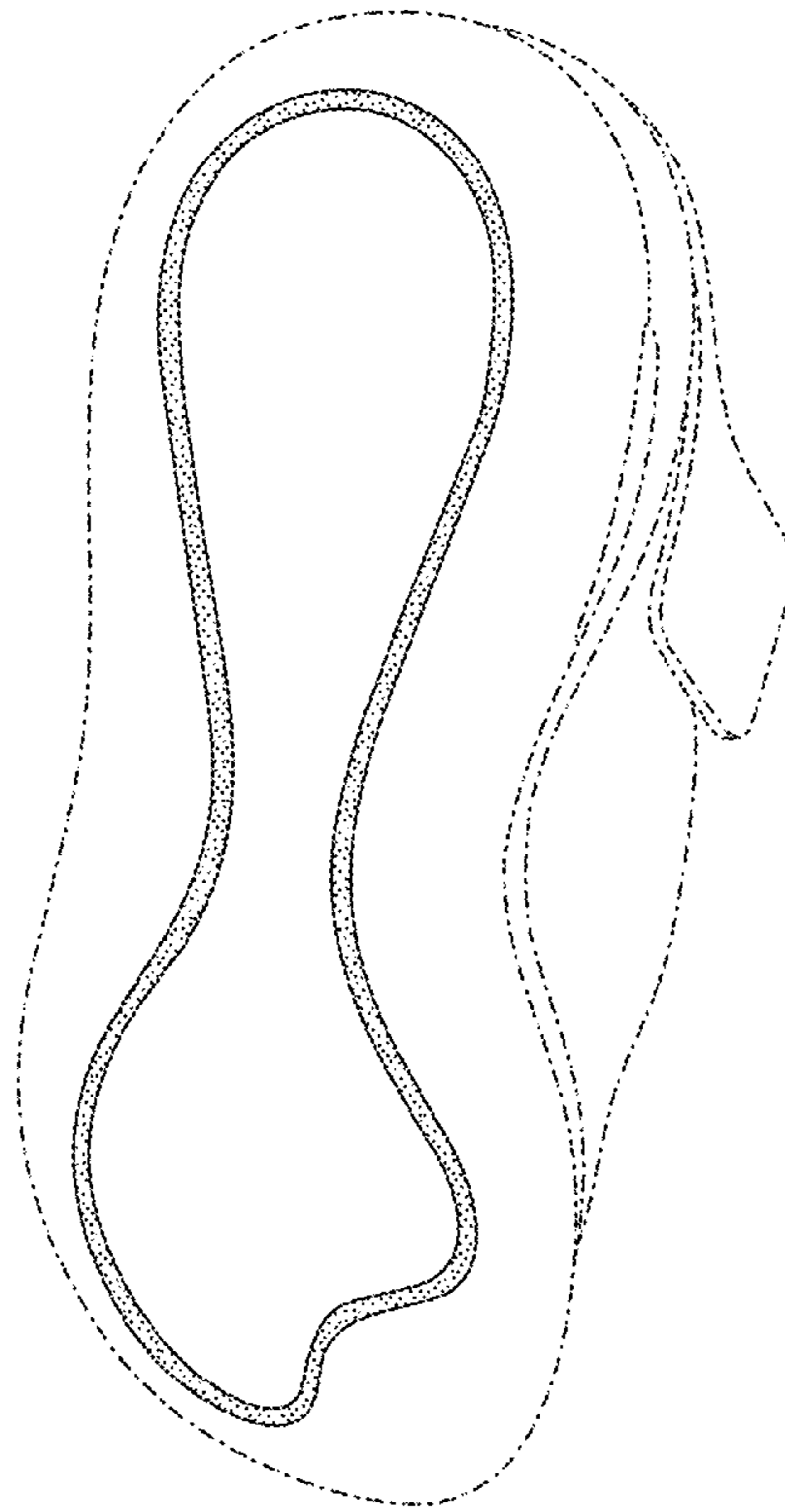

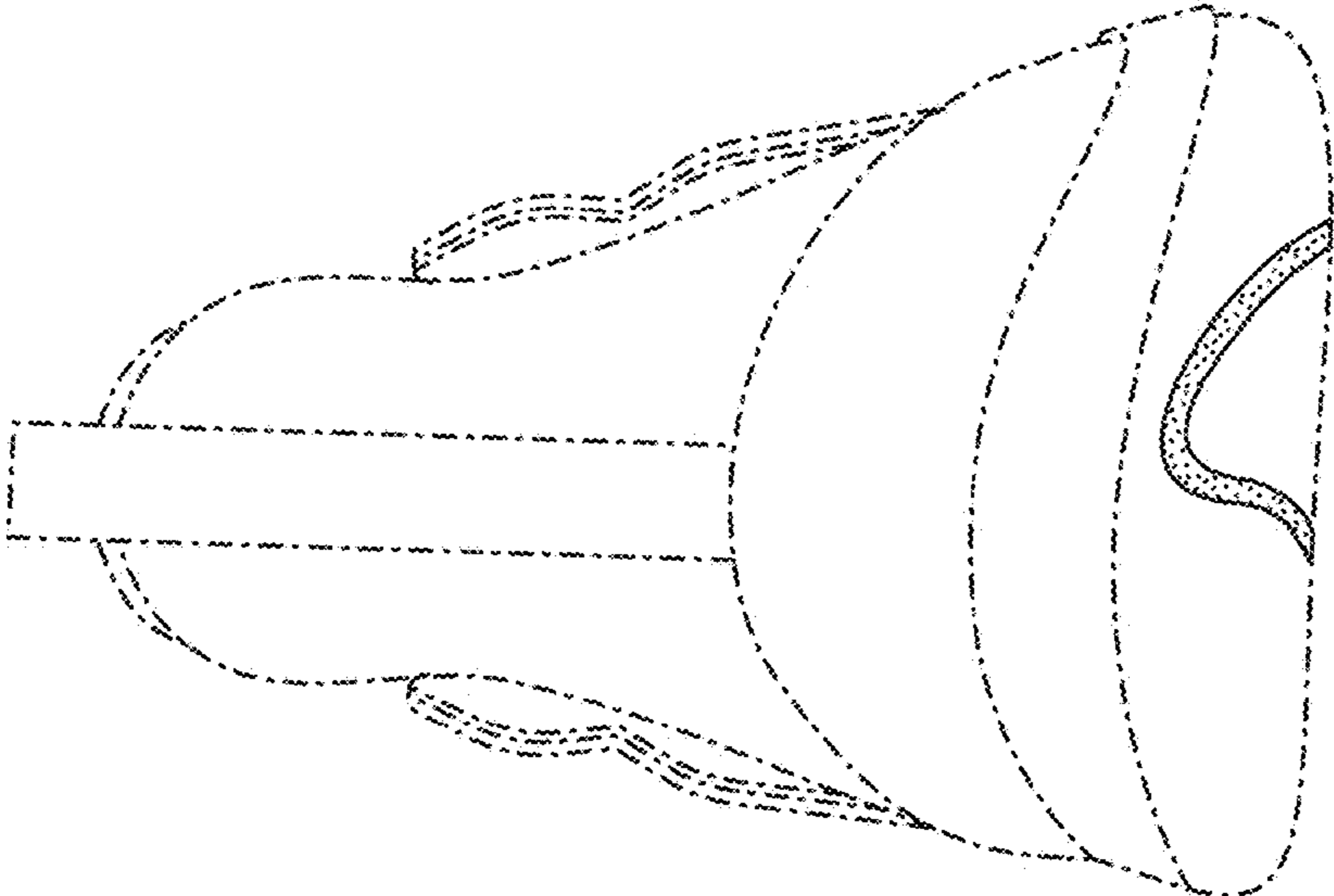
