DESCRIPTION

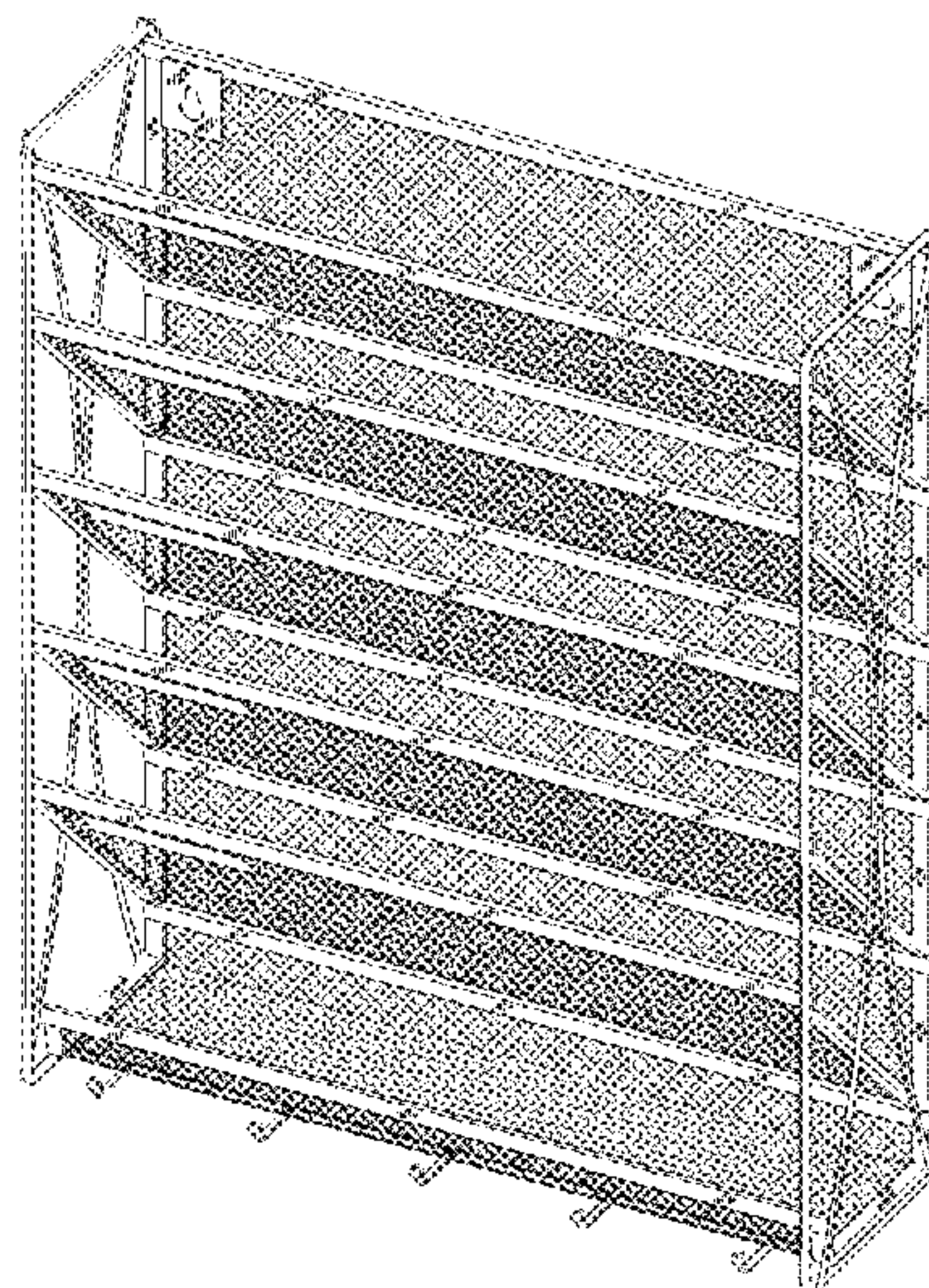
FIG. 1 is a perspective view of a wall mounted organizer, showing the new design;

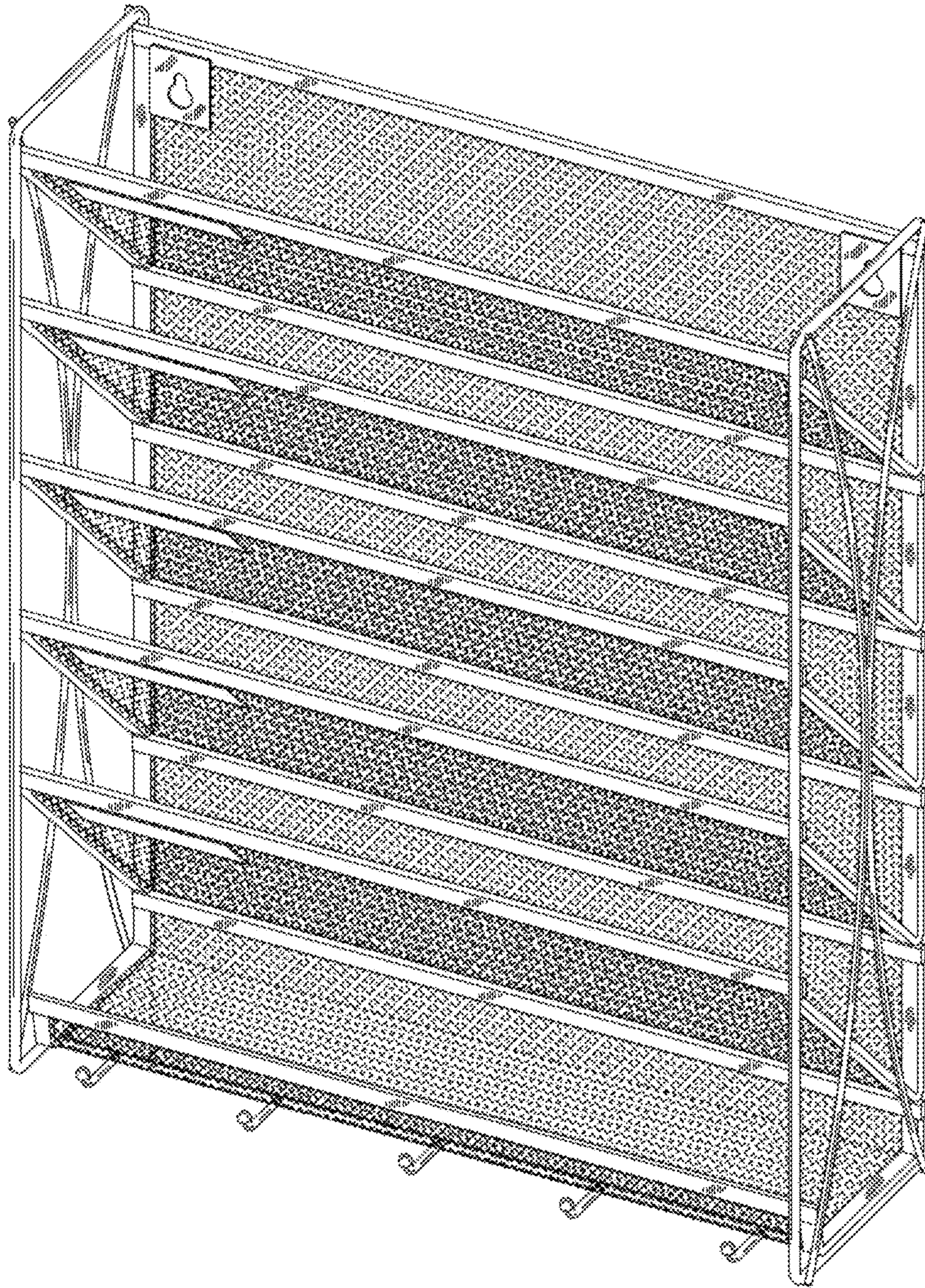

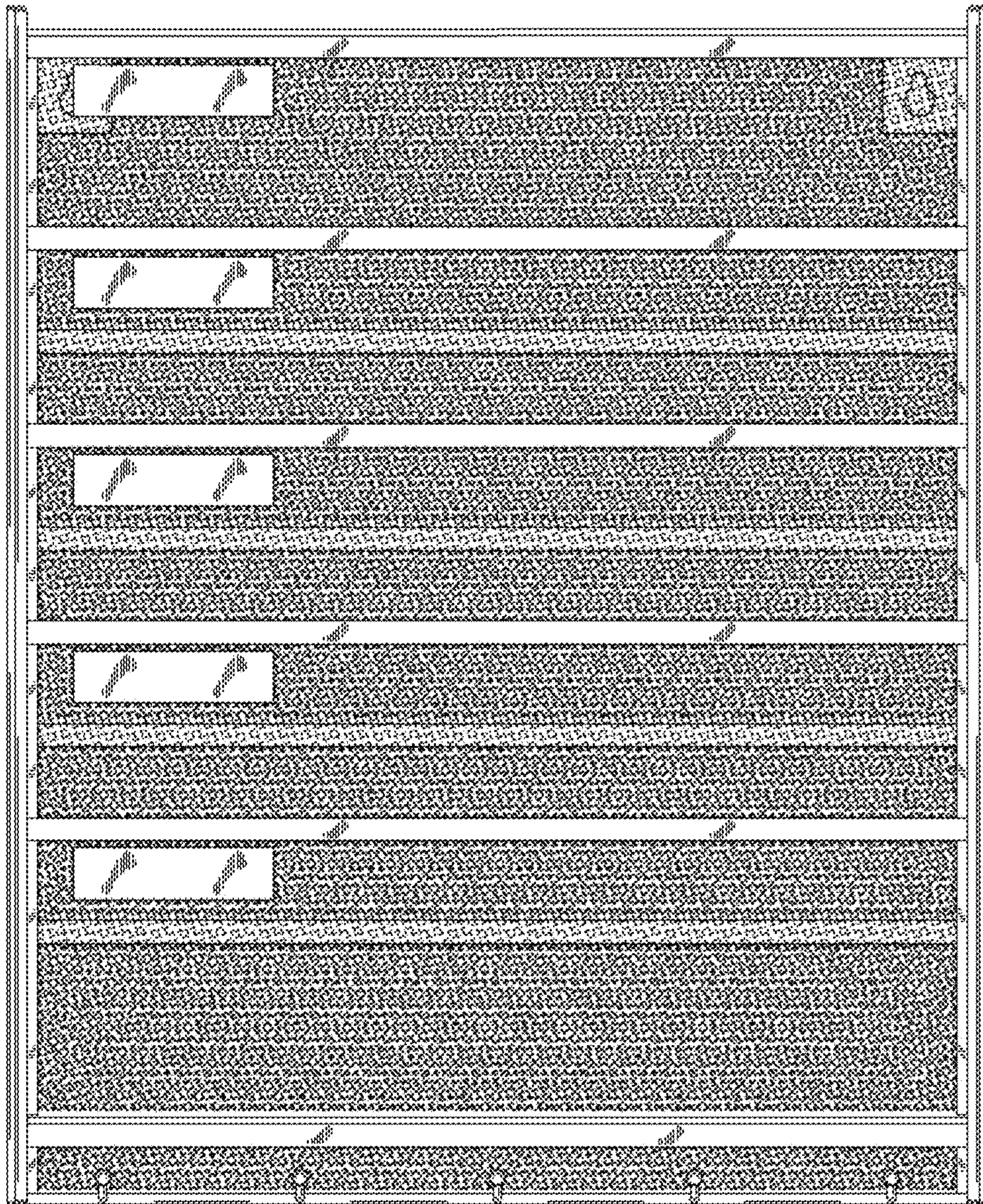

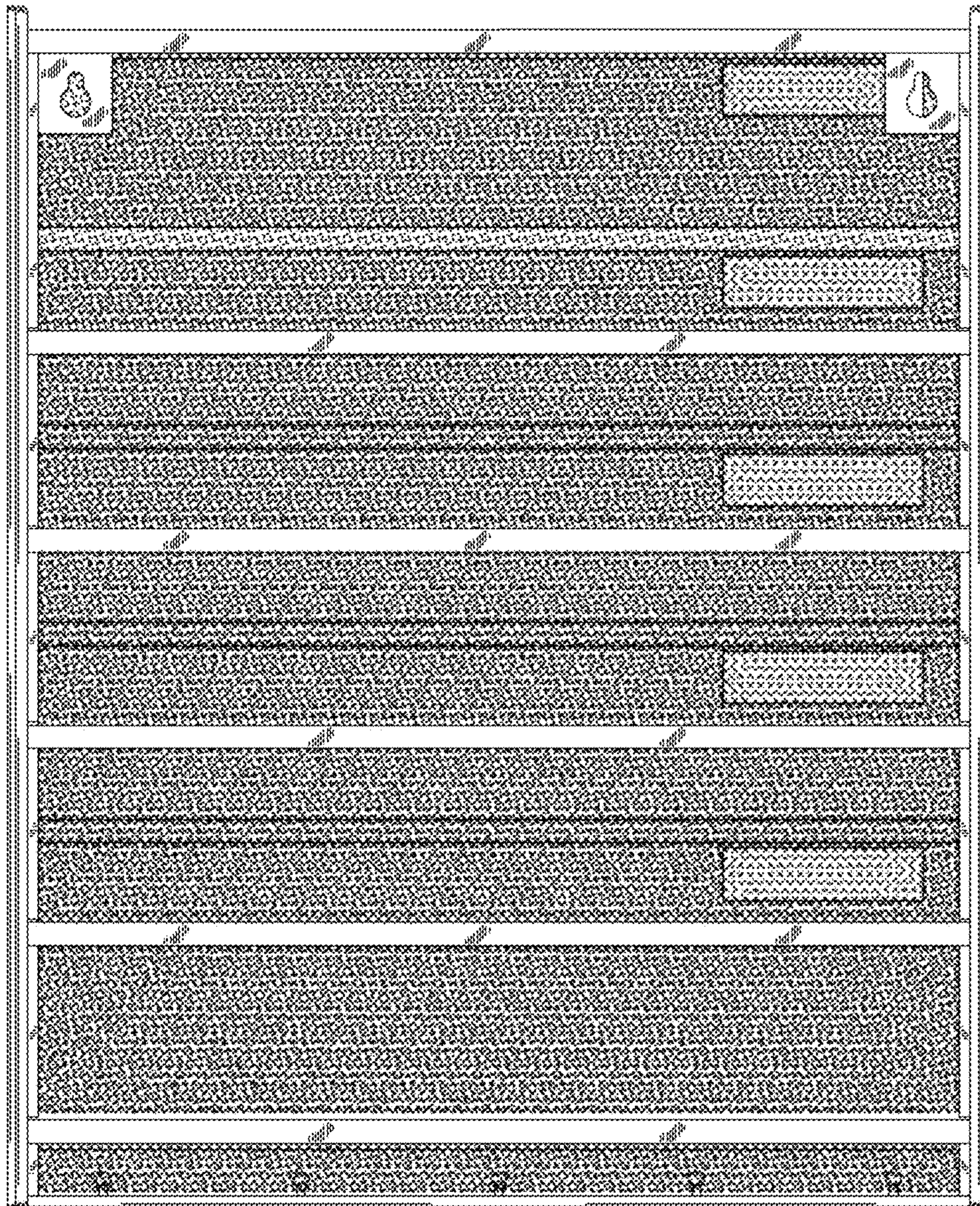

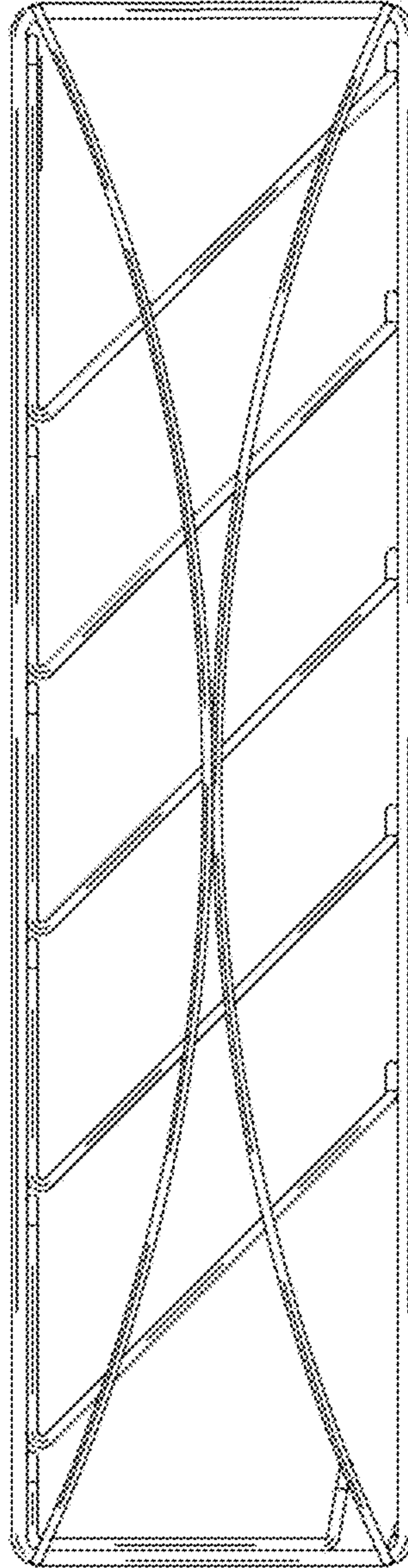

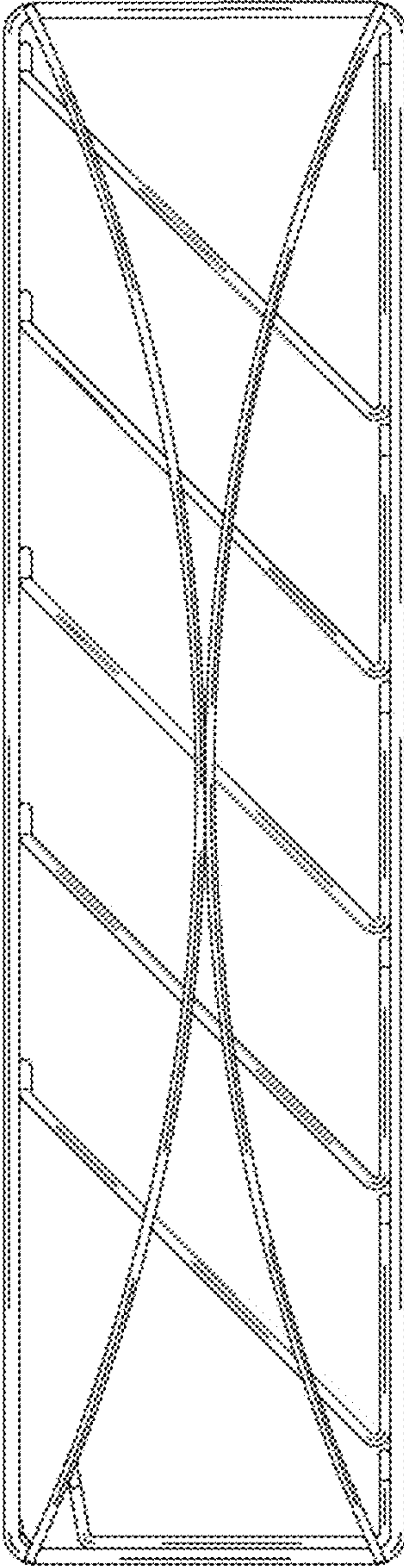

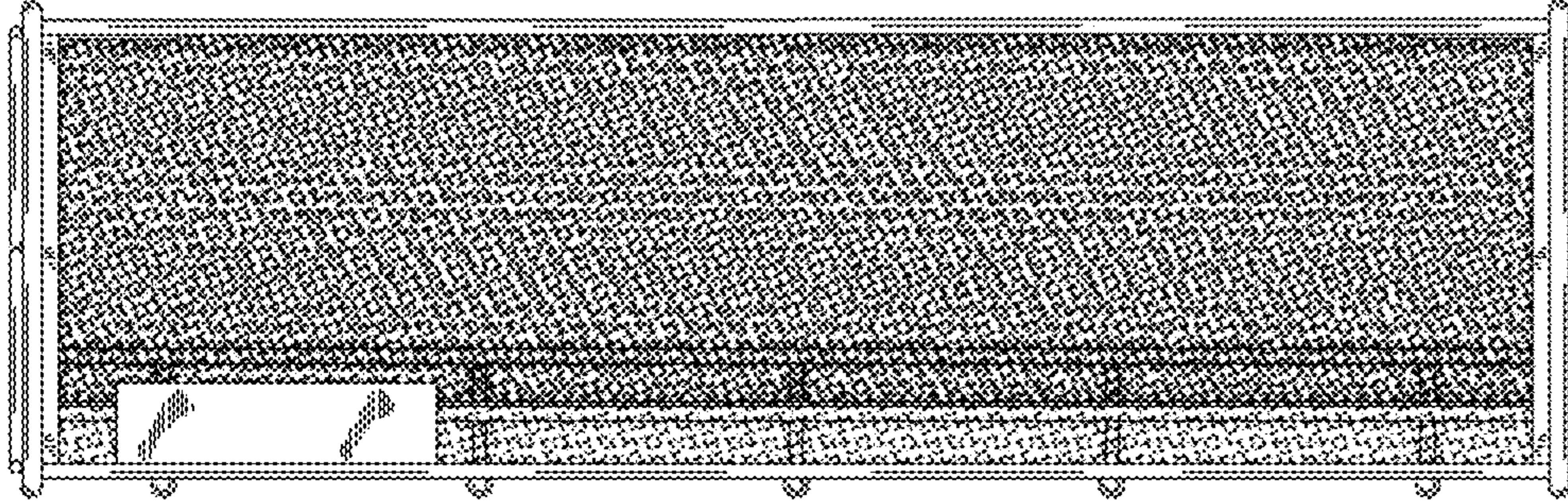

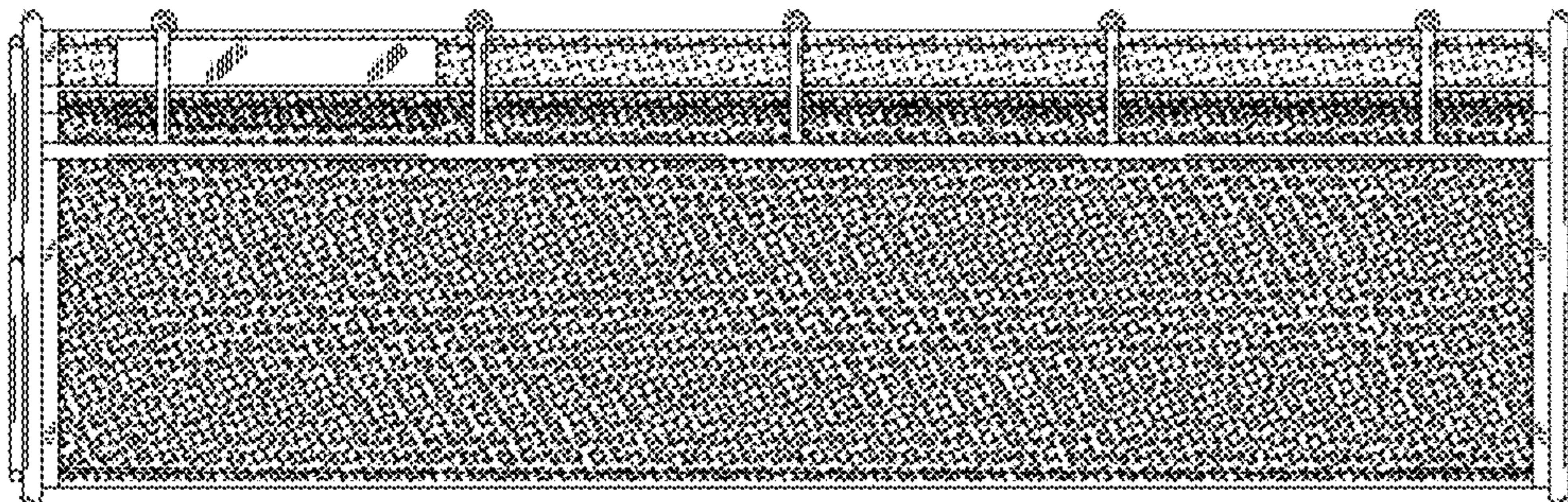
