The ornamental design for a deployable merchandise display unit, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of the deployable merchandise display unit of the present invention showing my new design;

FIG. 2 is a front elevational view of the deployable merchandise display unit;

FIG. 3 is a top view of the deployable merchandise display unit;

FIG. 4 is a bottom view of the deployable merchandise display unit;

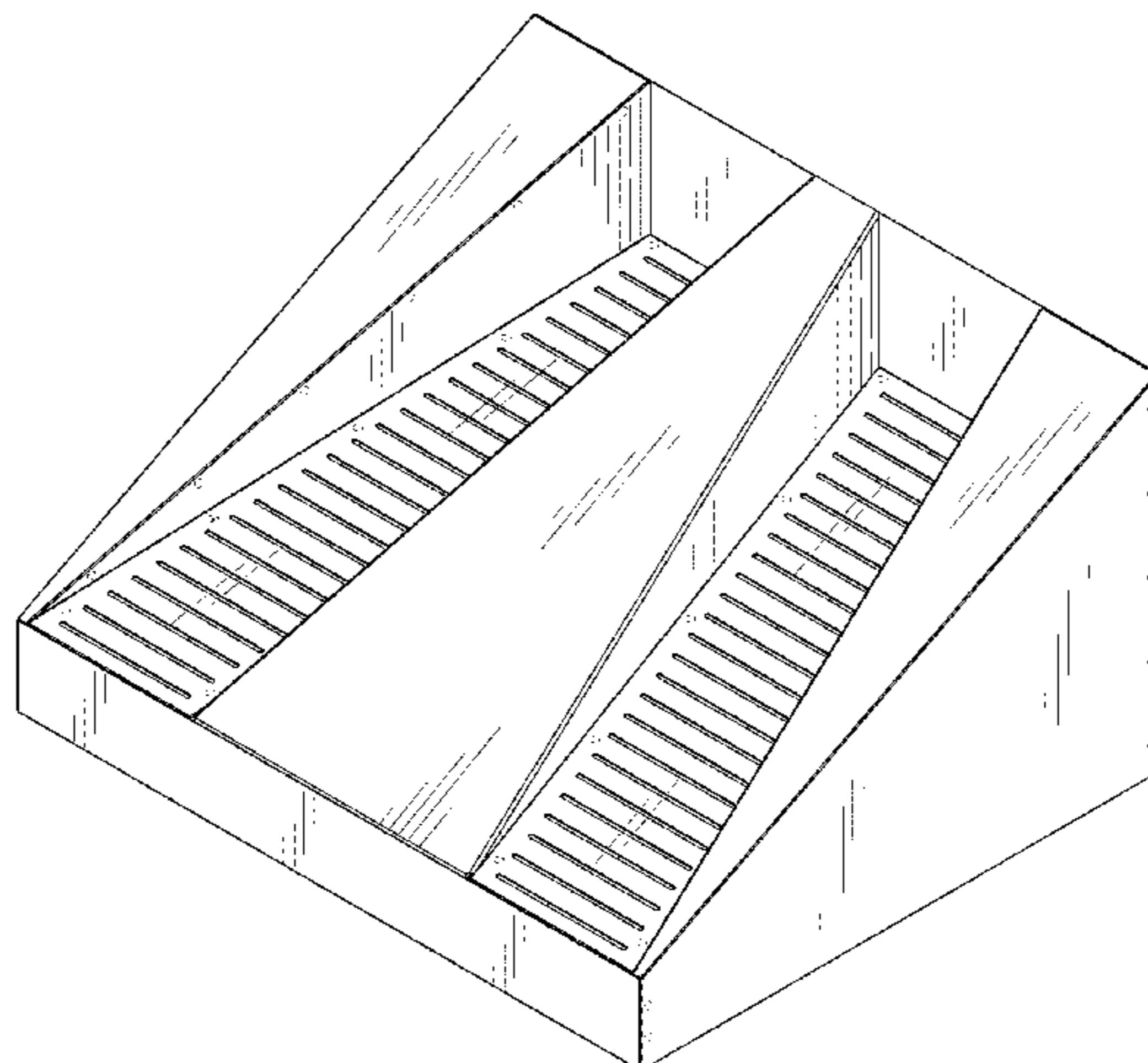
FIG. 5 is a first side view of the deployable merchandise display unit;

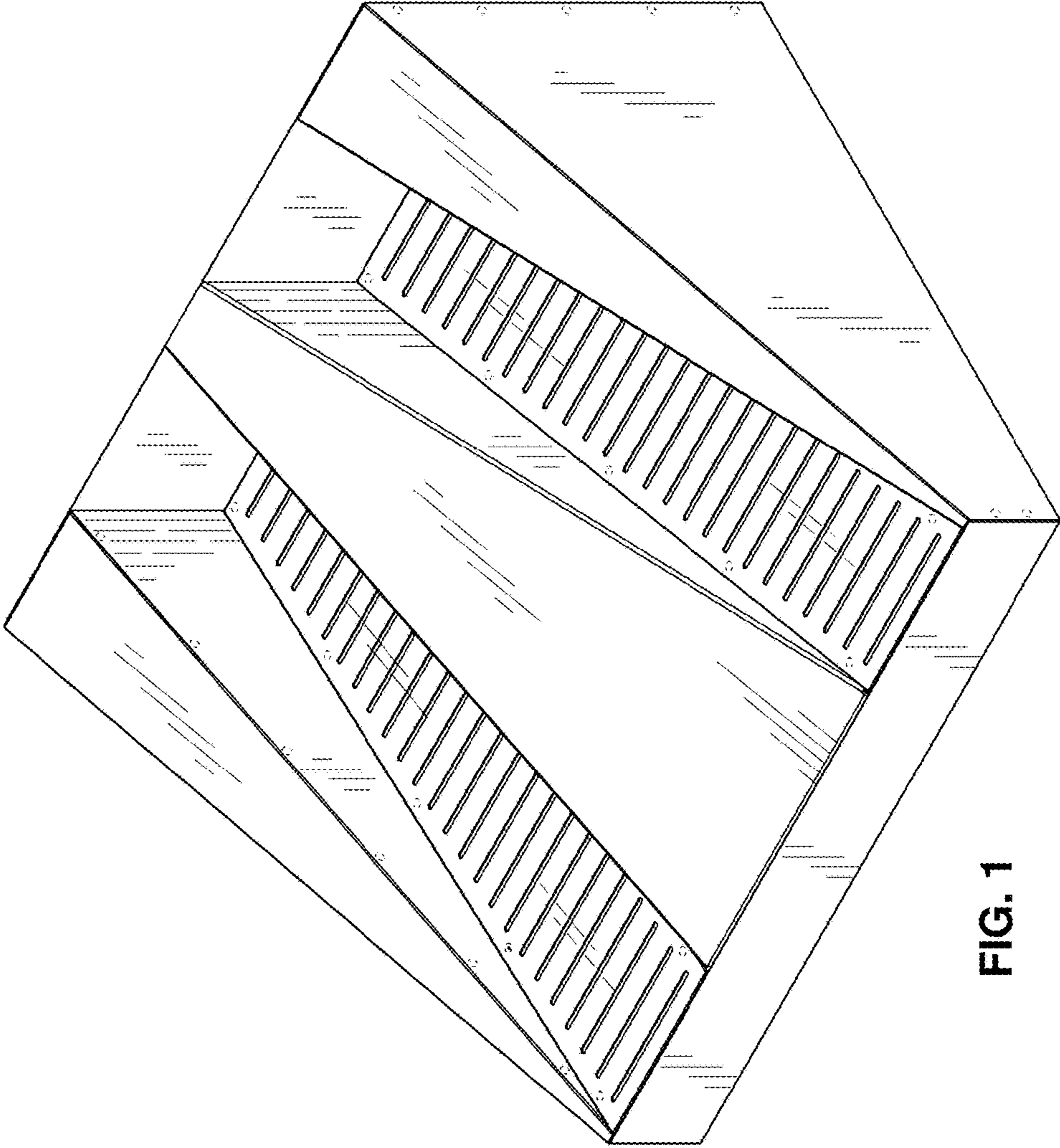

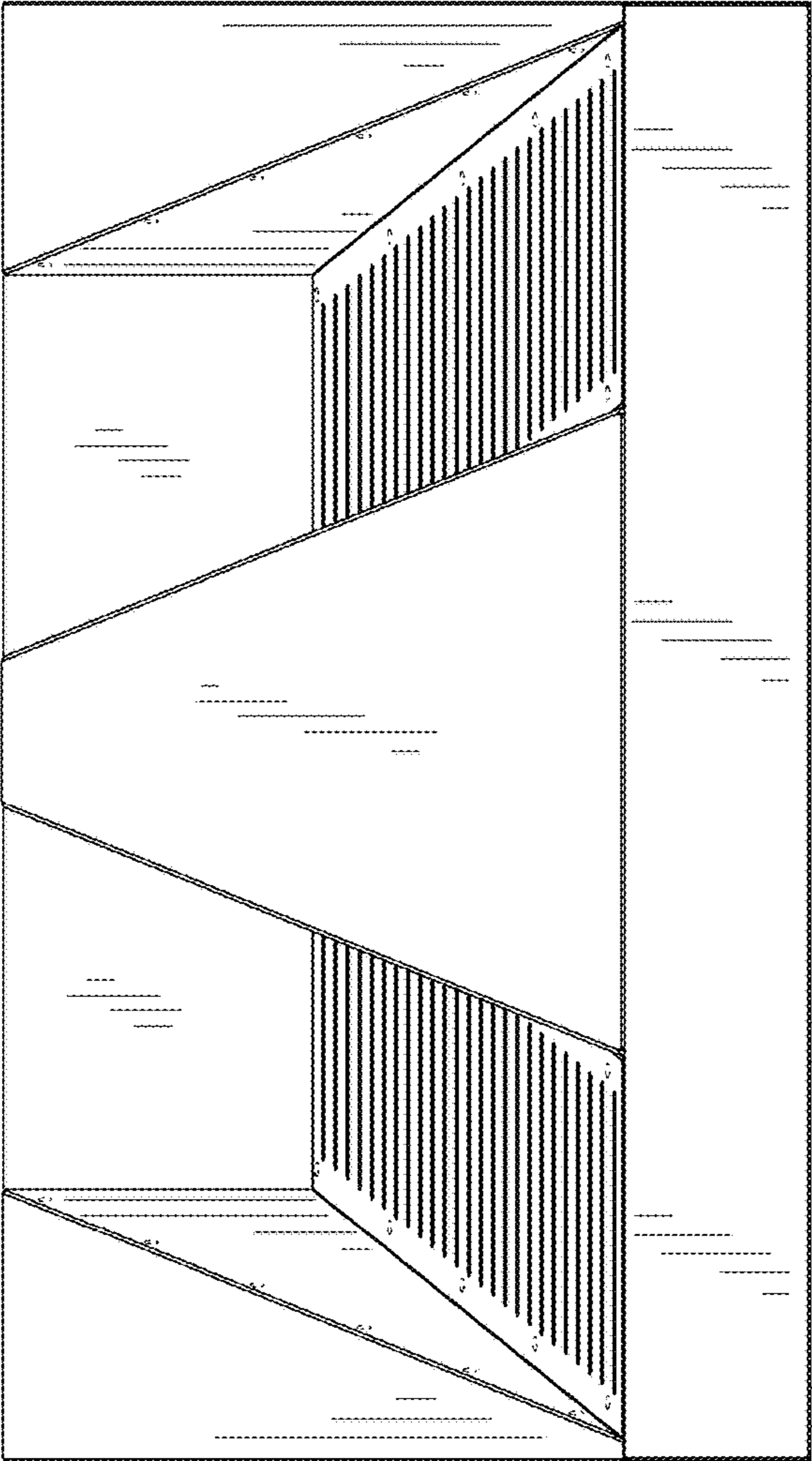

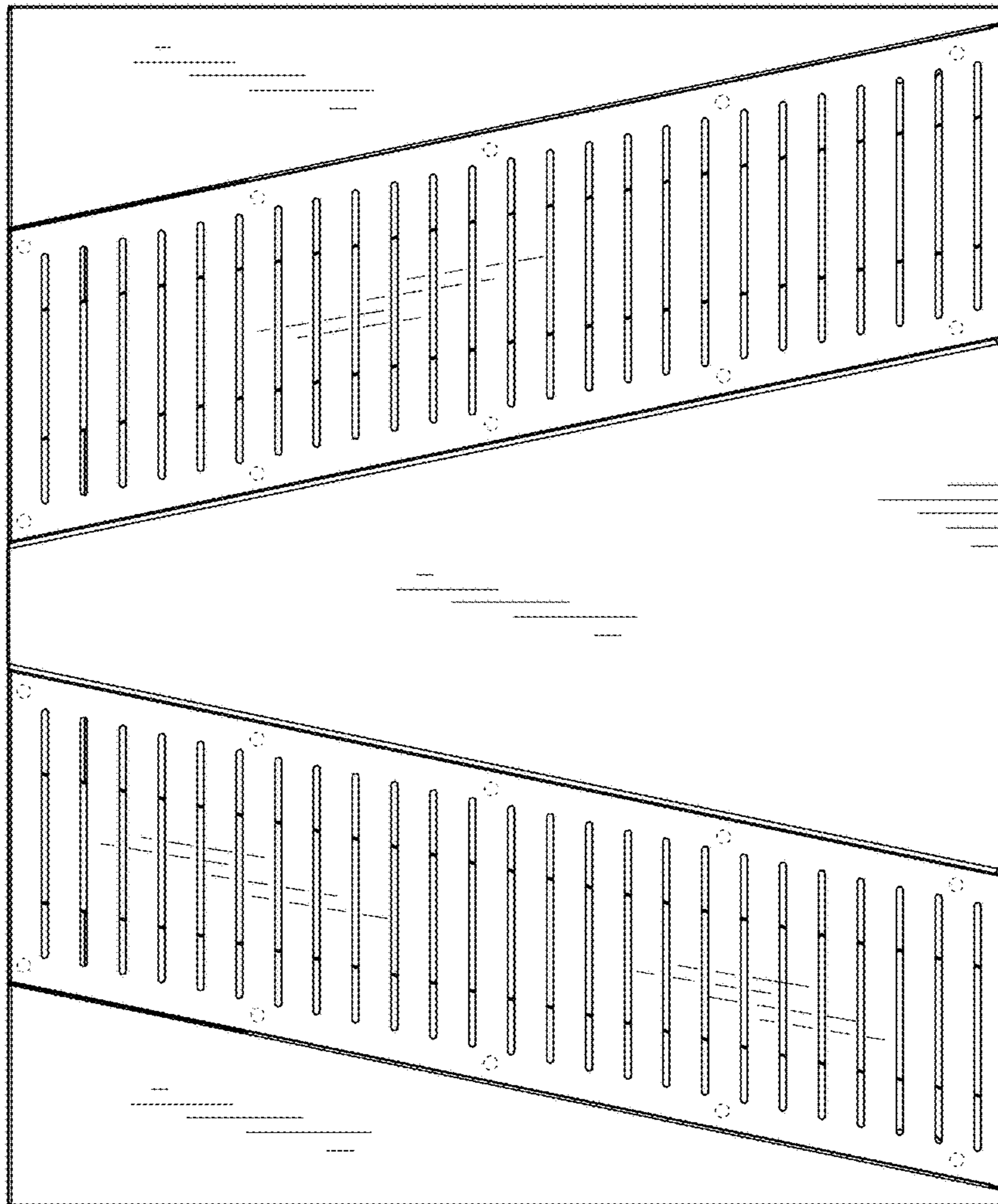

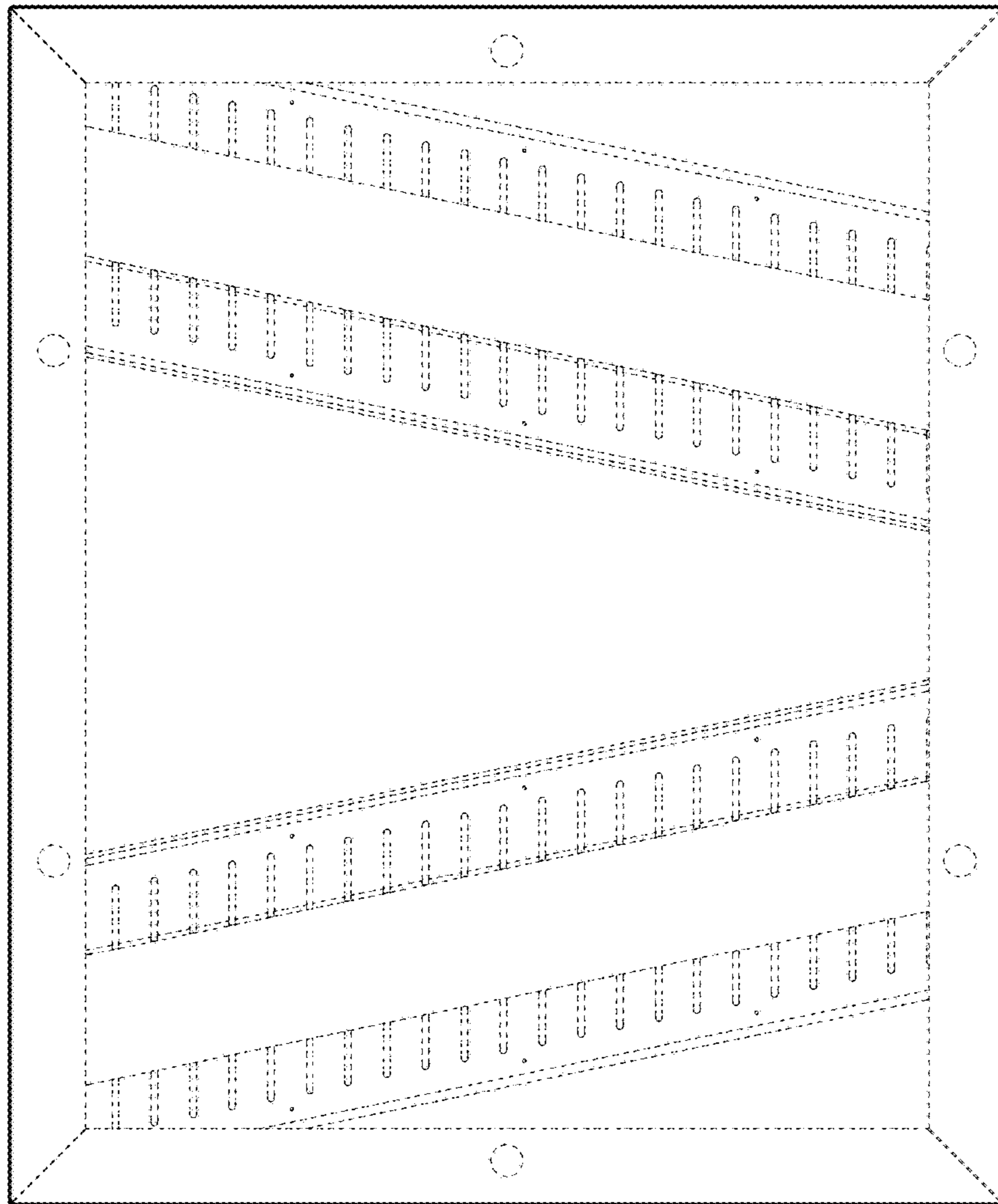

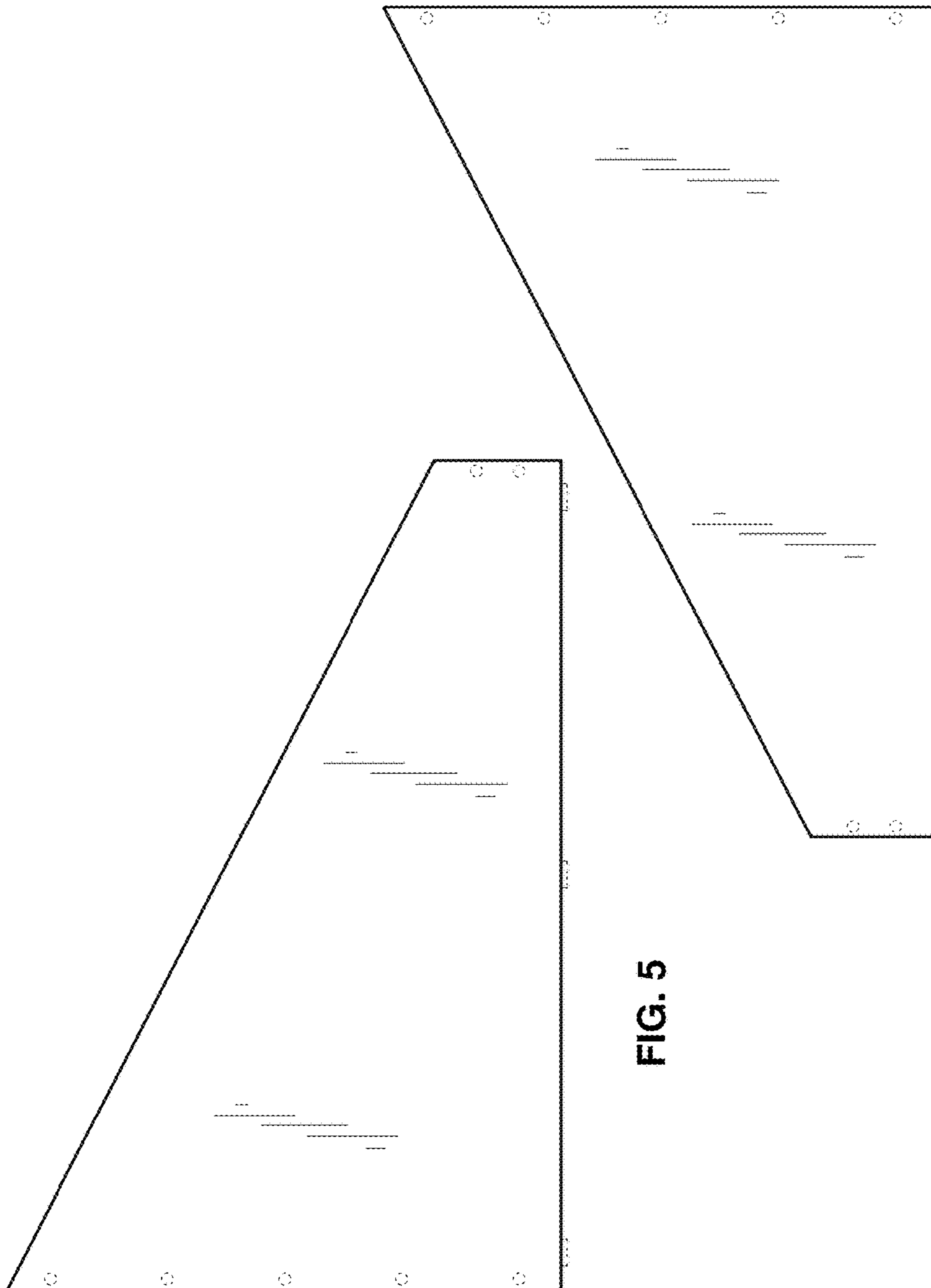

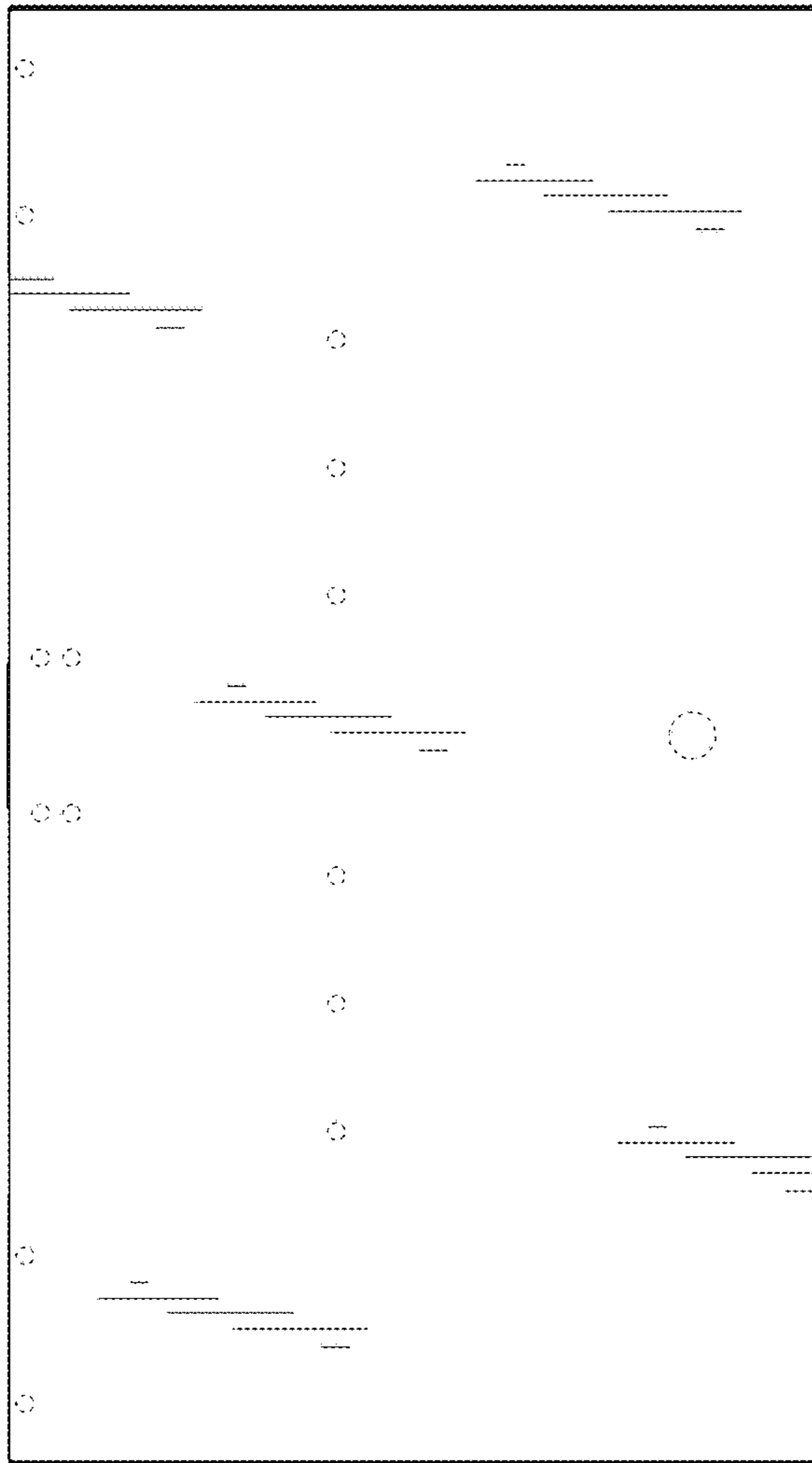
