DESCRIPTION

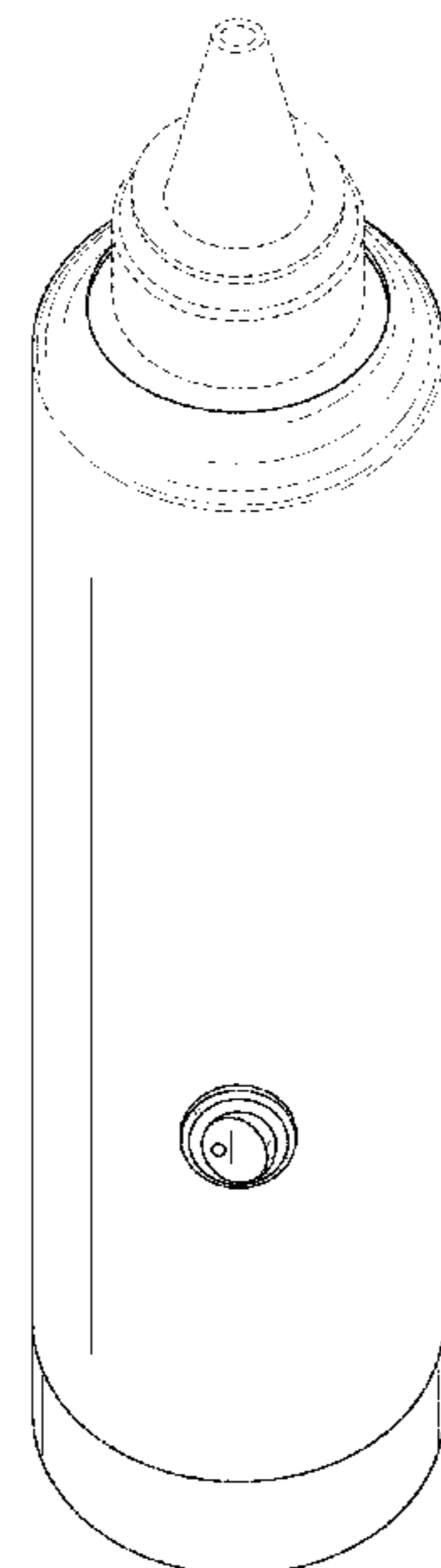
FIG. 1 is a perspective view of a bottle warmer, showing my new design;

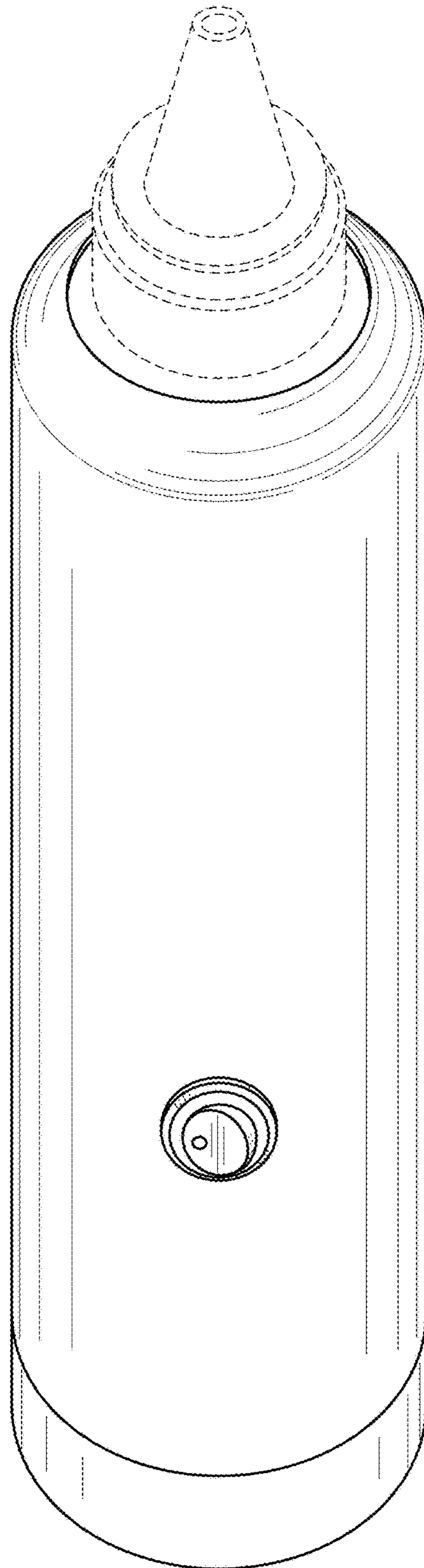

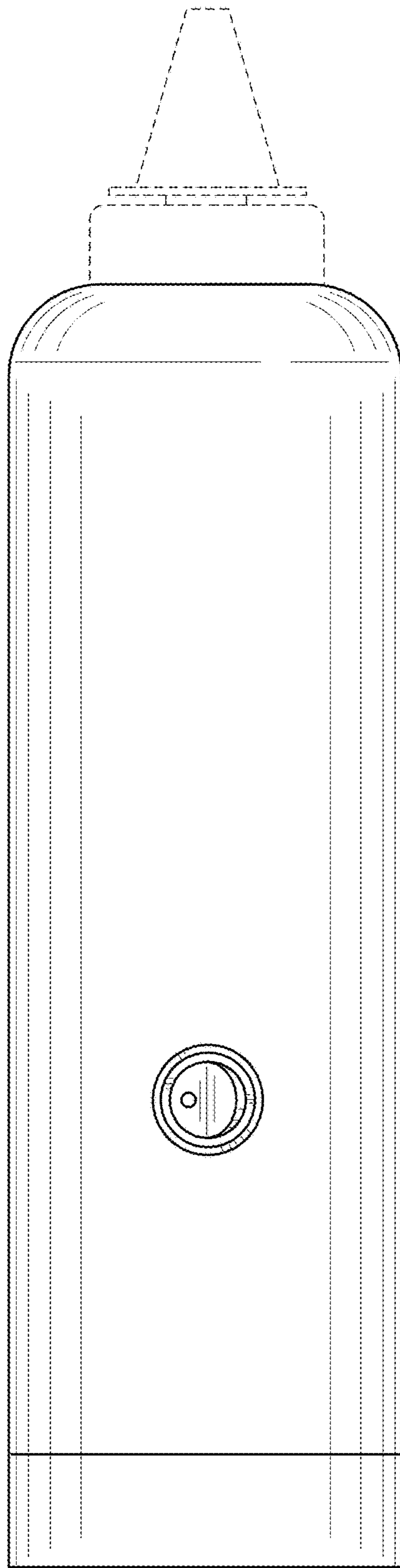

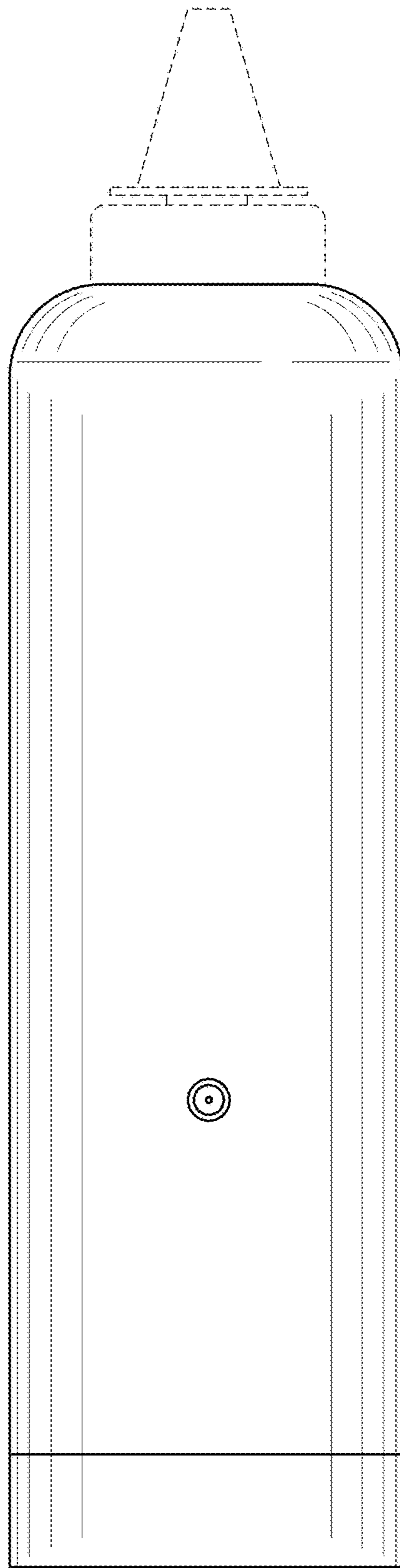

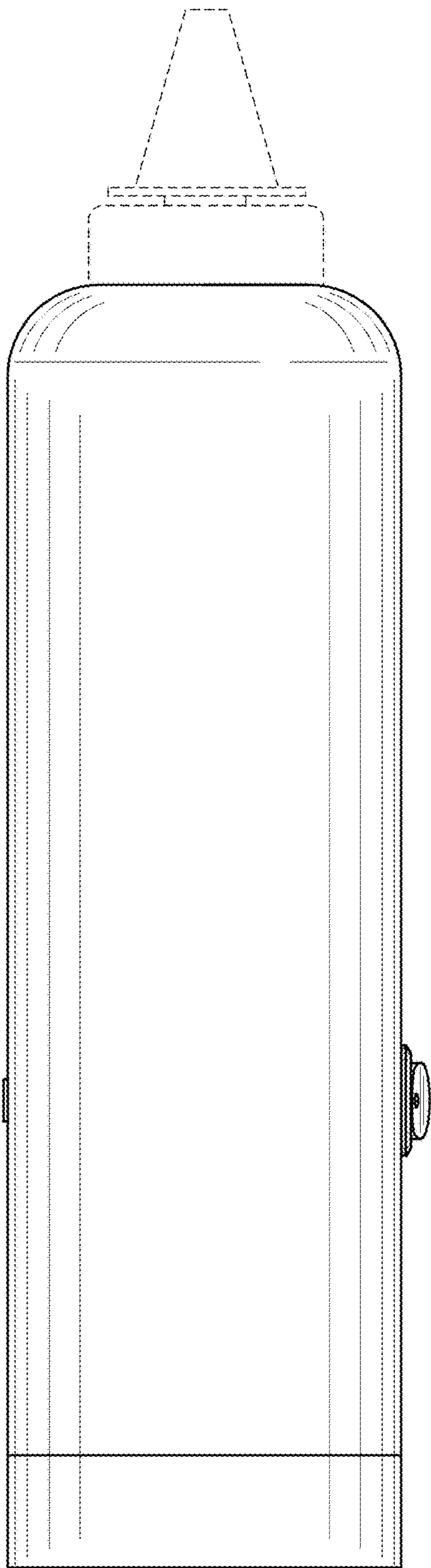

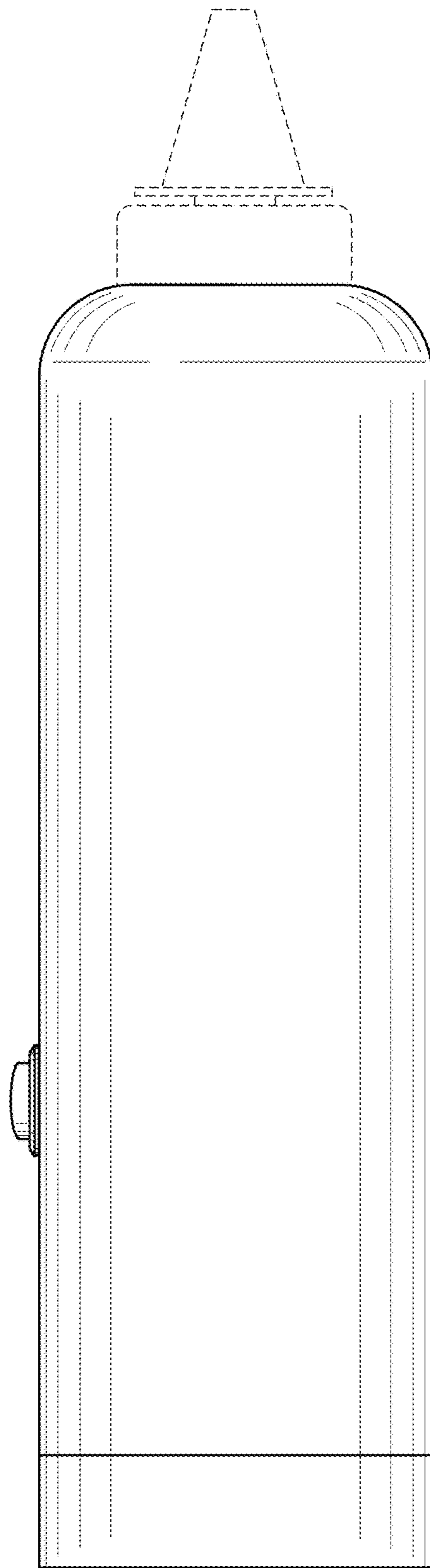

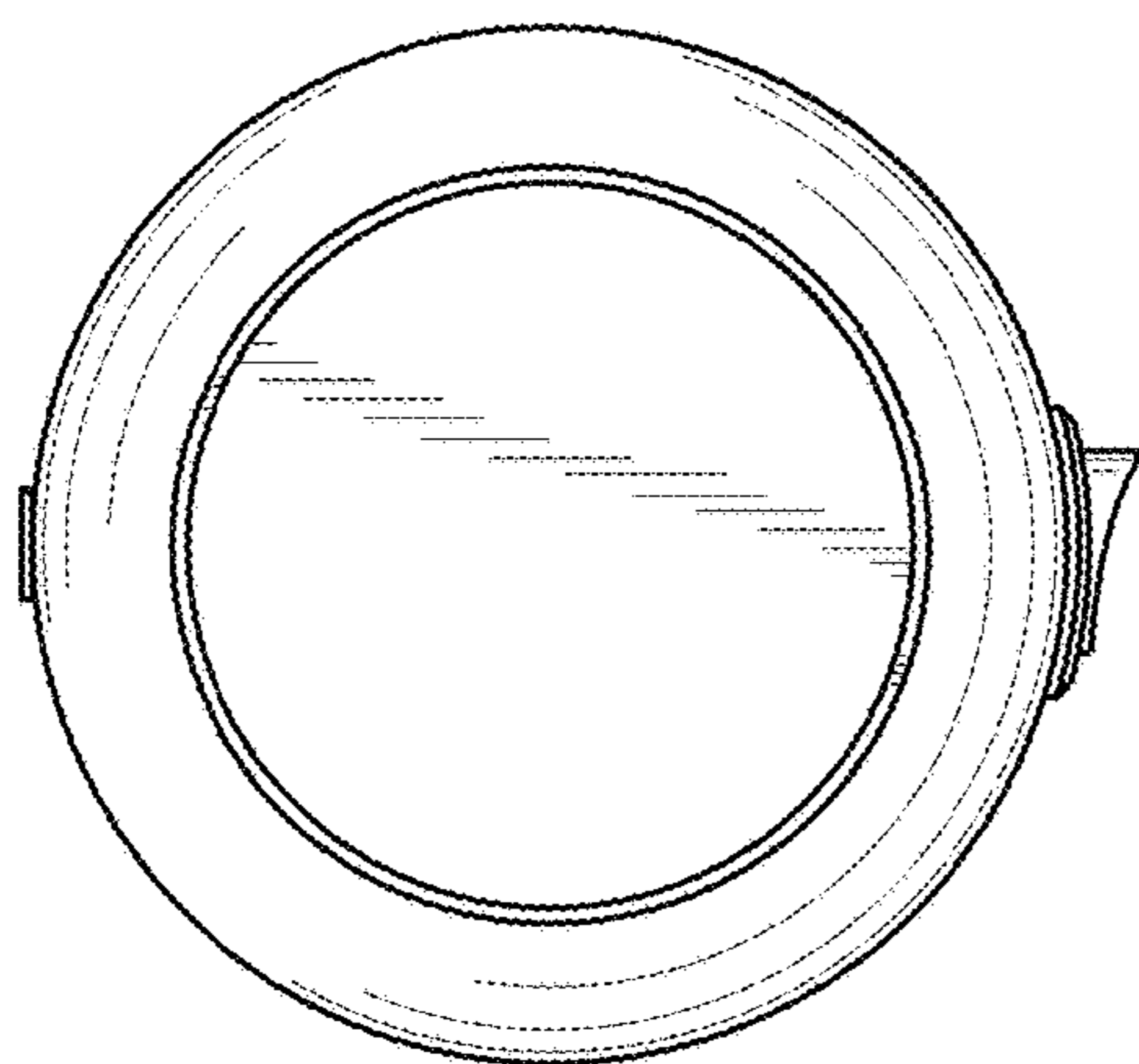

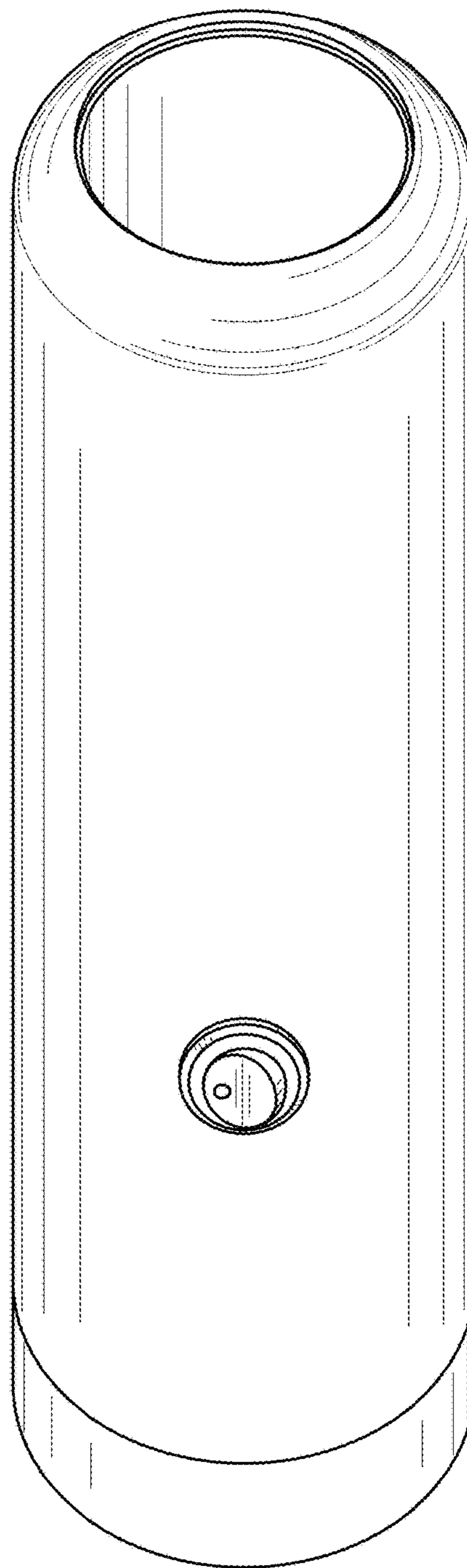
