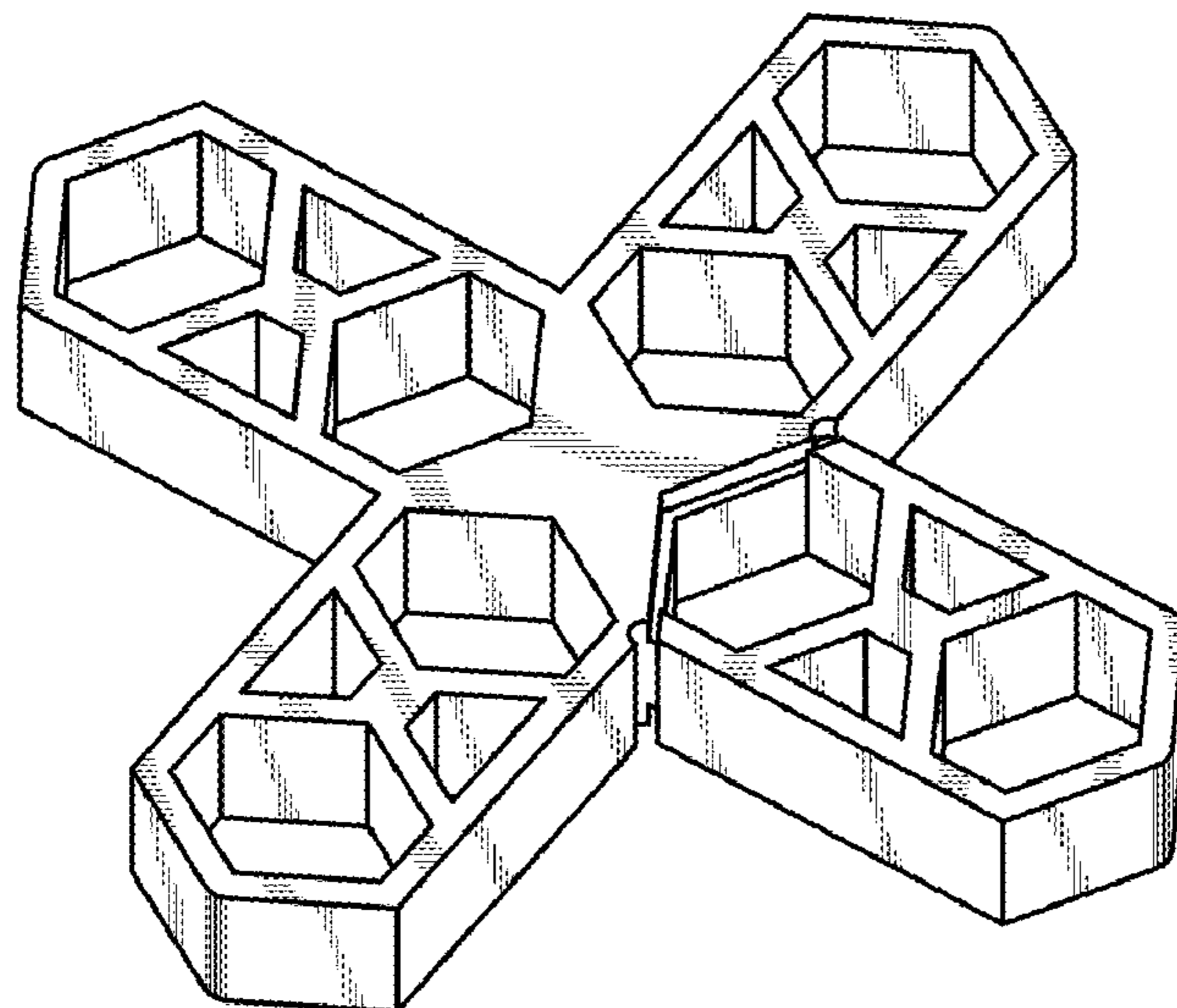

DESCRIPTION

FIG. 1 is a front perspective view of a tile spacing device; FIG. 2 is a top plan view of the tile spacing device shown in FIG. 1, which includes top-bottom symmetry; FIG. 3 is a front elevation view of the tile spacing device shown in FIG. 1; FIG. 4 is a right side elevation view of the tile spacing device shown in FIG. 1; FIG. 5 is a left side elevation view of the tile spacing device as shown in FIG. 1; and, FIG. 6 is a rear elevation view of the tile spacing device as shown in FIG. 1.

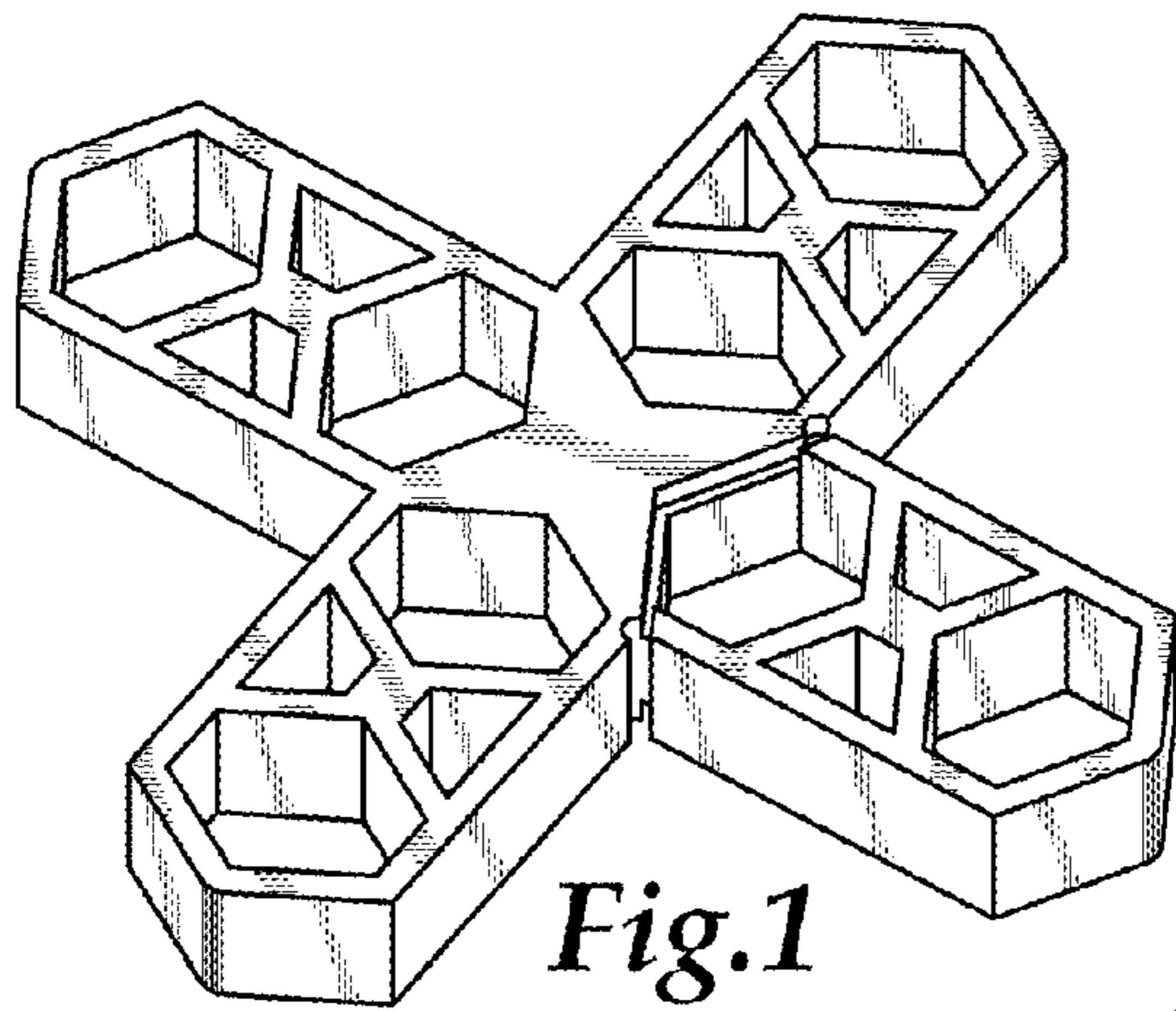

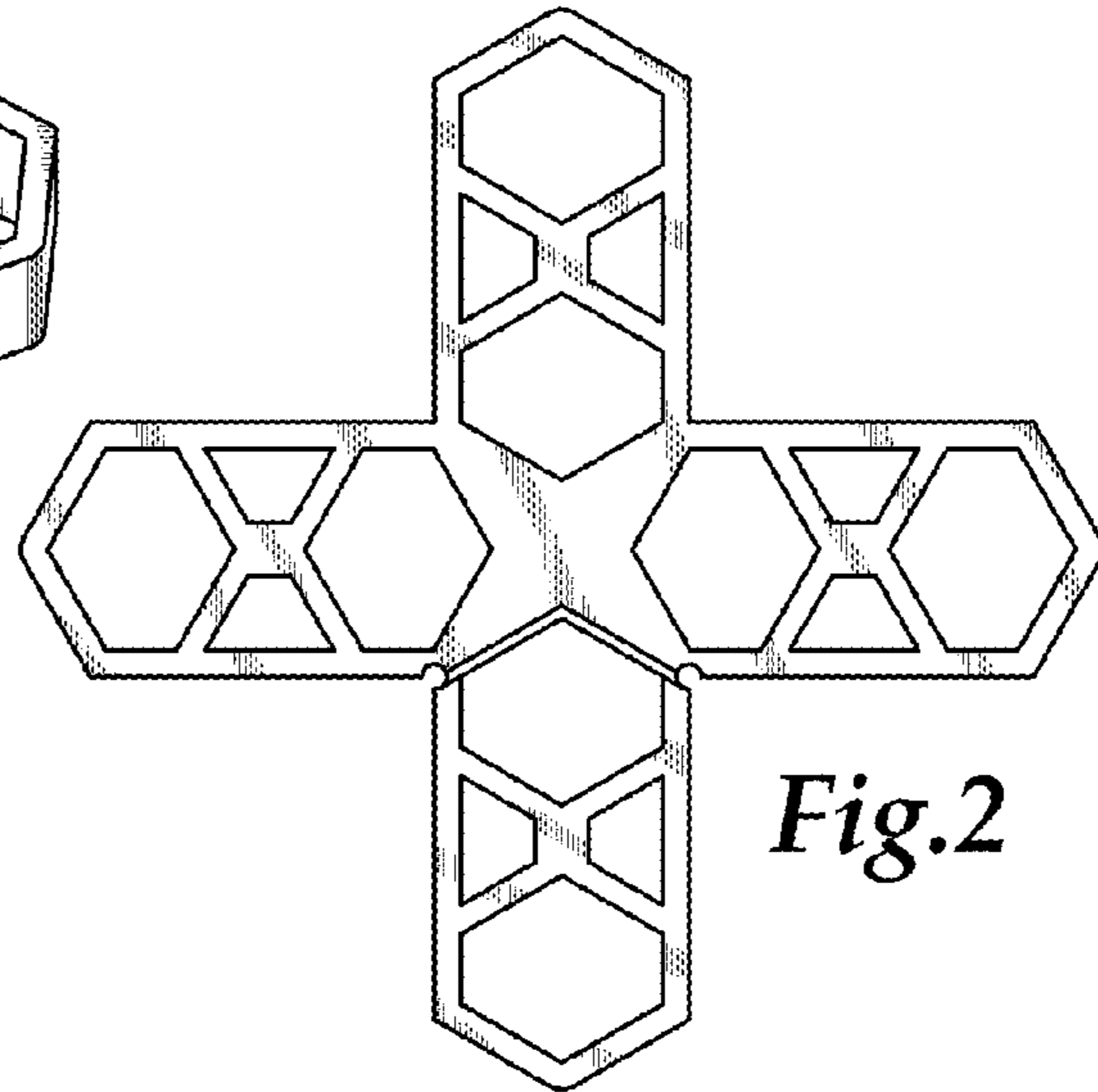

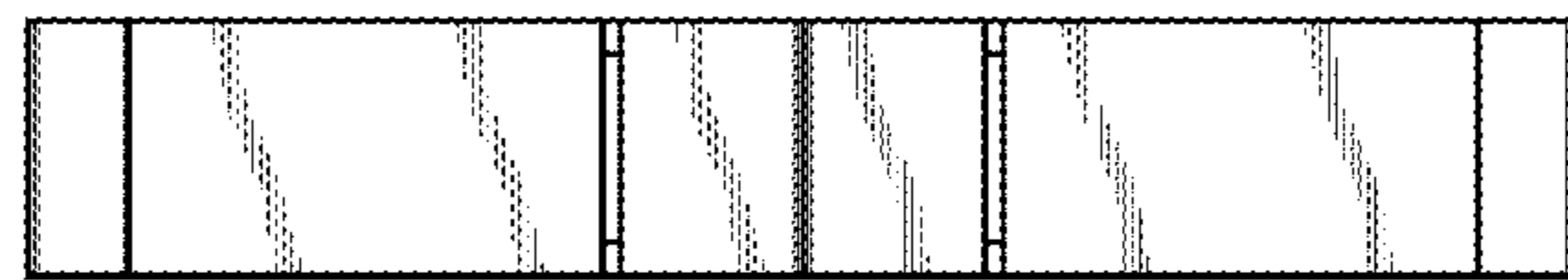

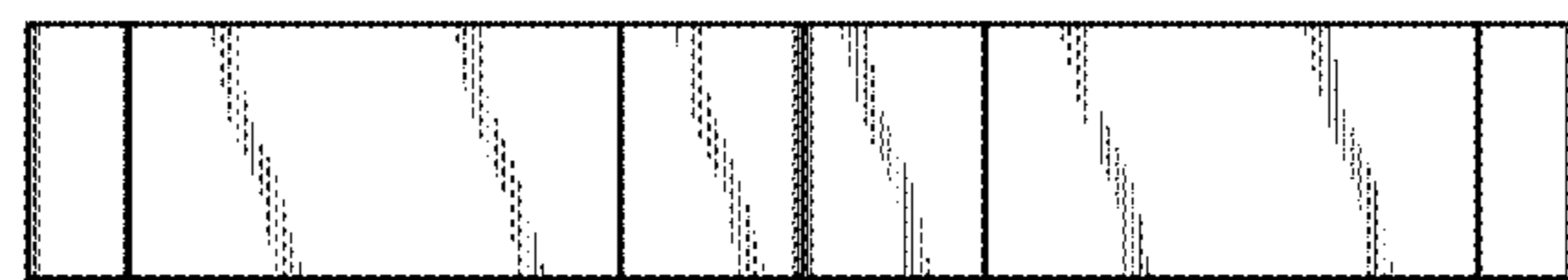

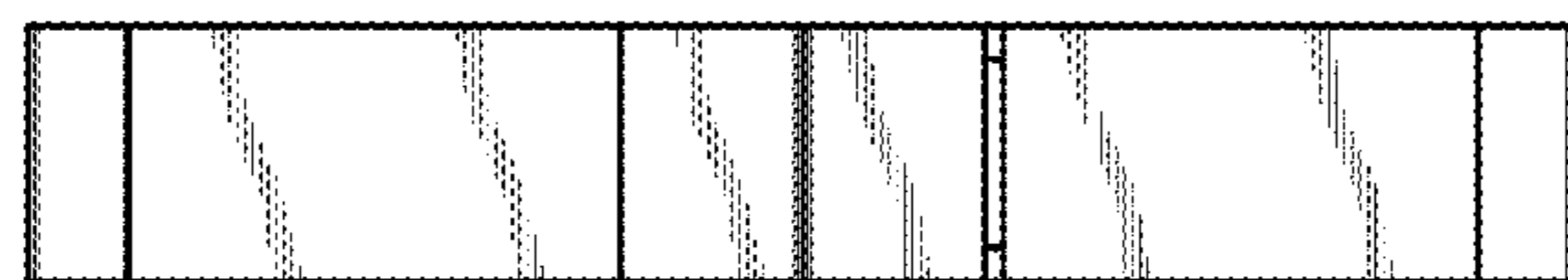

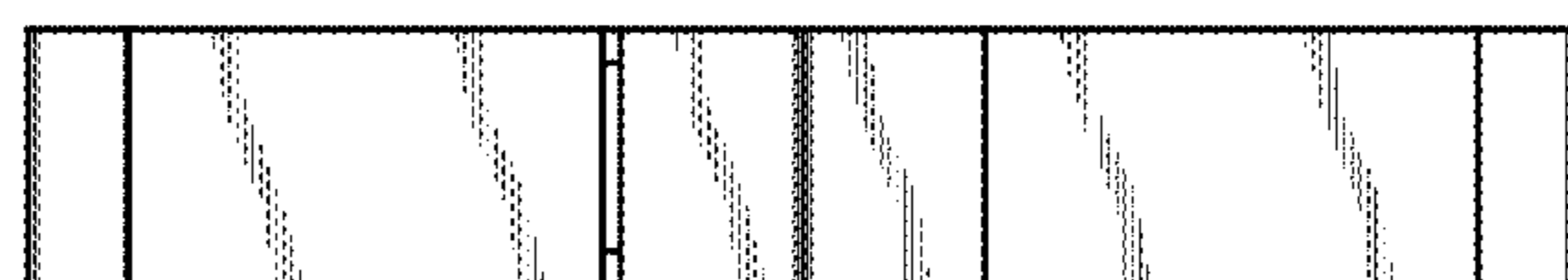
