**DESCRIPTION**

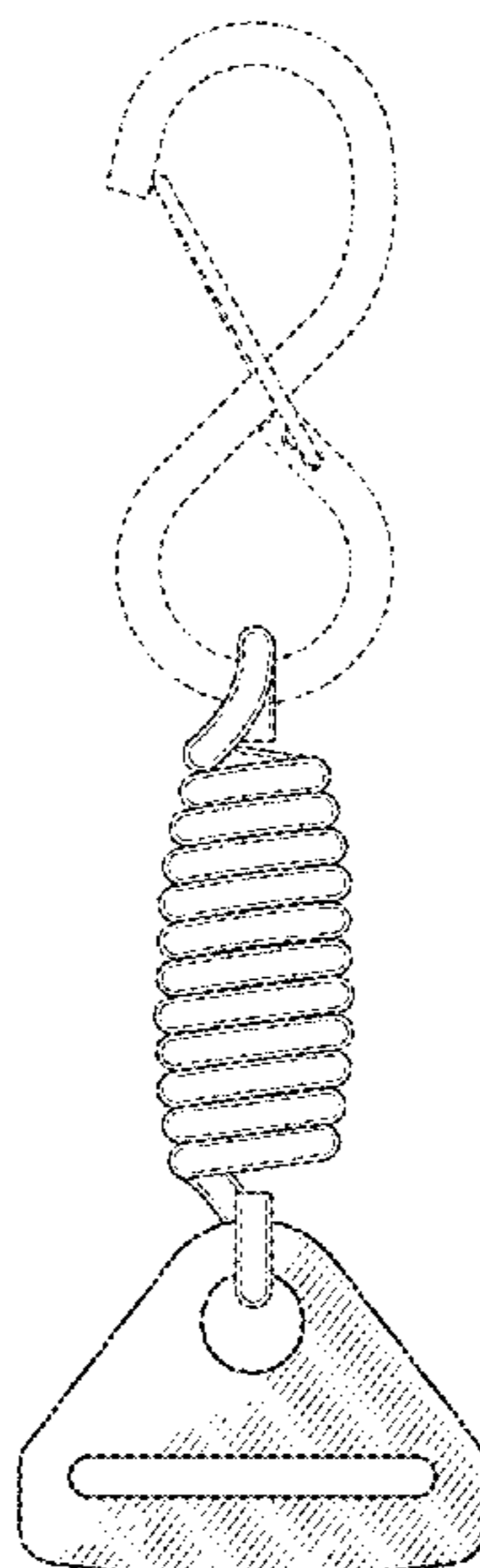
FIG. 1 is a plan view of a spring hook showing my new design;

 FIG. 9 is a view similar to FIG. 3 of the FIG. 7 embodiment;  
 FIG. 10 is a view similar to FIG. 6 of the different embodiment;  
 FIG. 11 is a view similar to FIG. 5 of the FIG. 7 embodiment; and,  
 FIG. 12 is a view similar to FIG. 6 of the FIG. 7 embodiment.

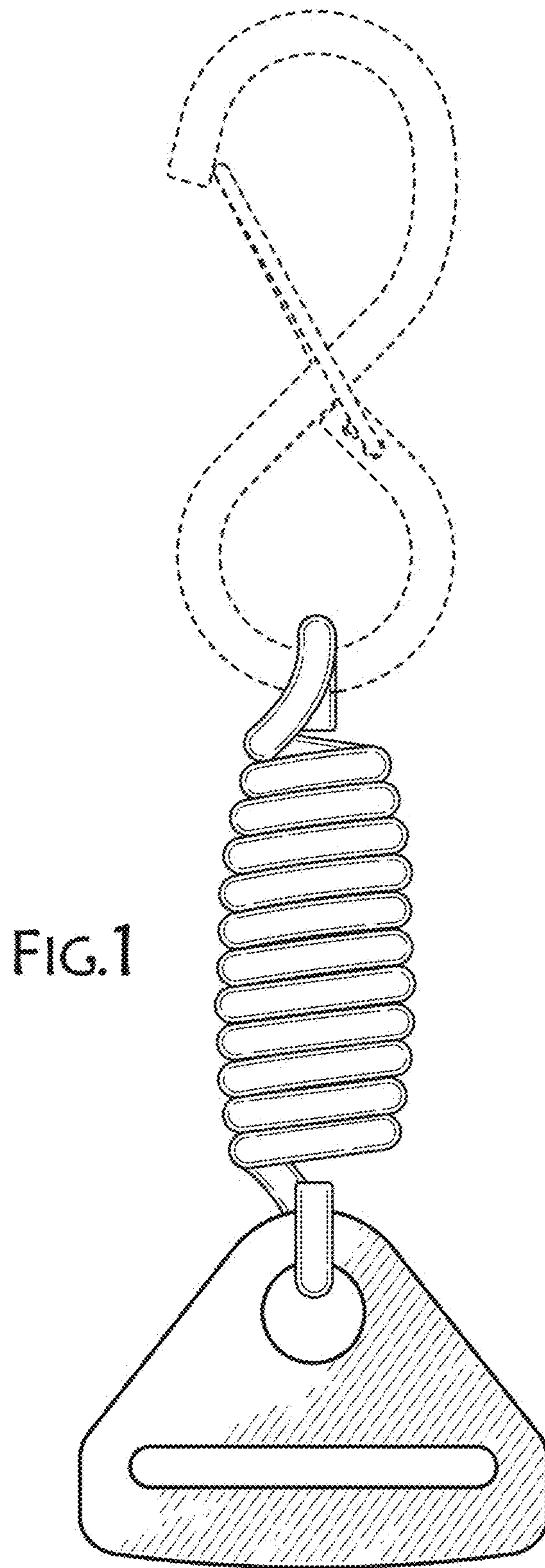
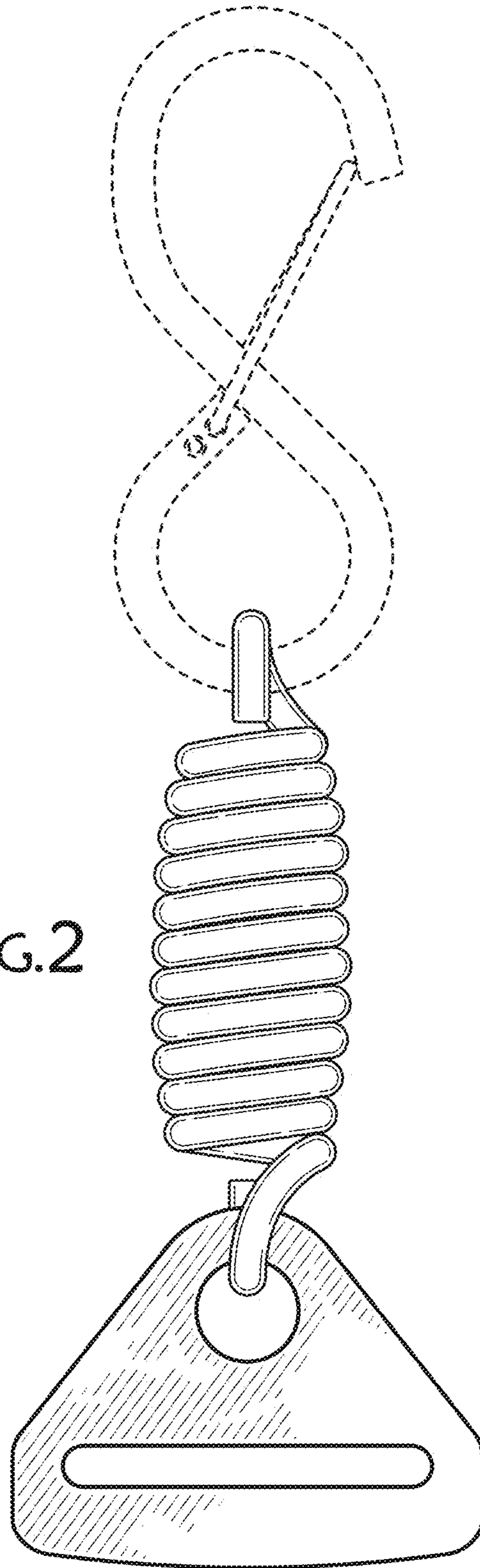
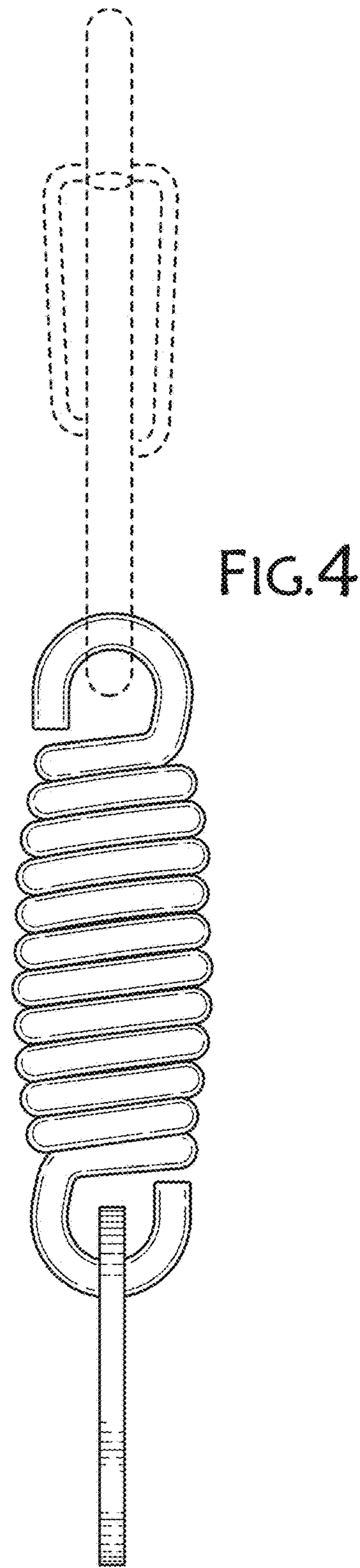
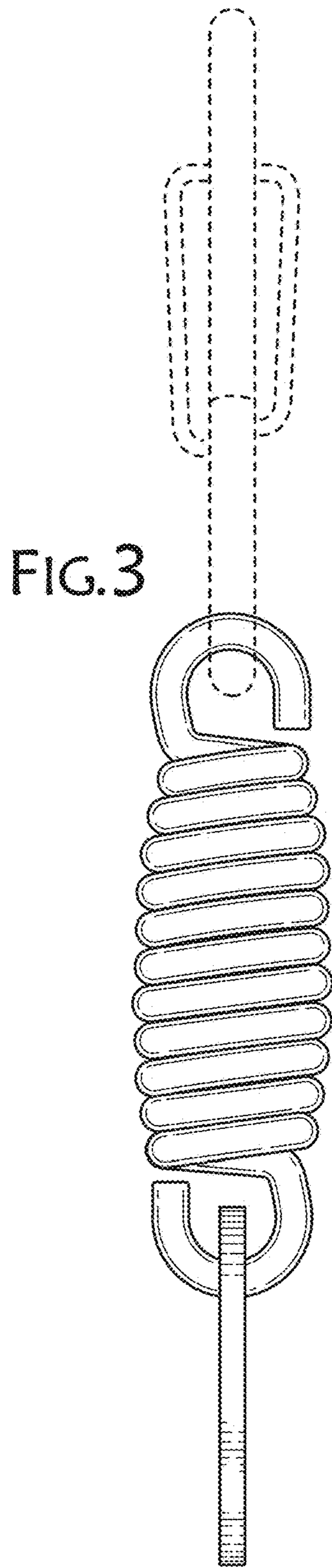

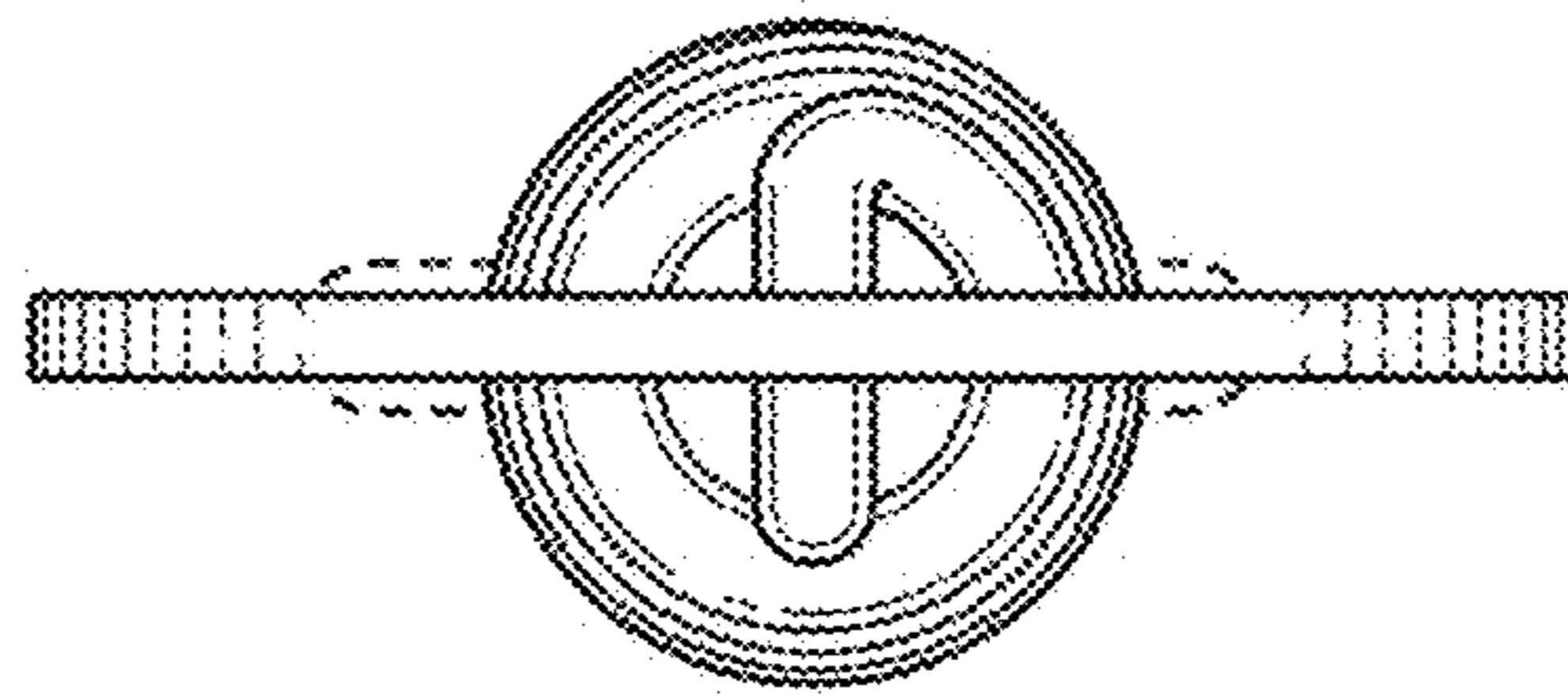

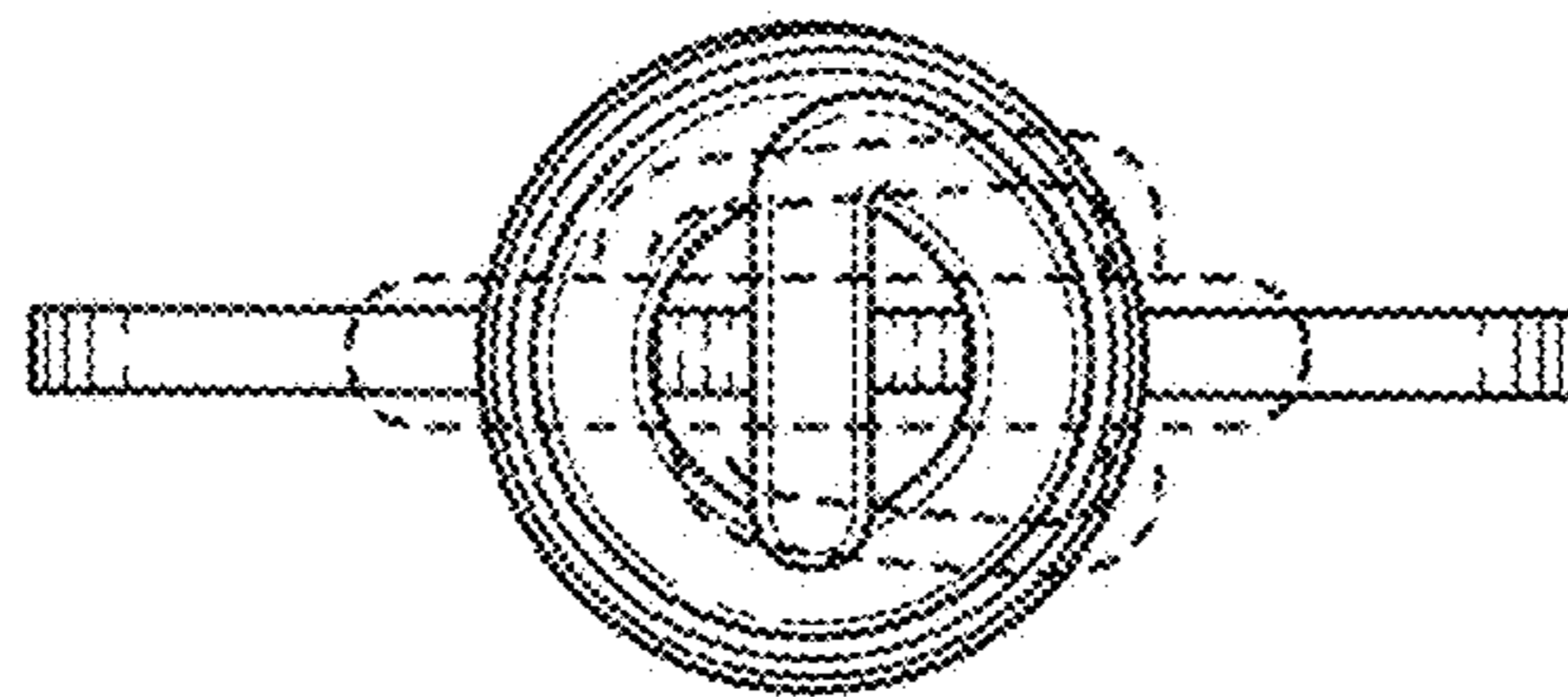
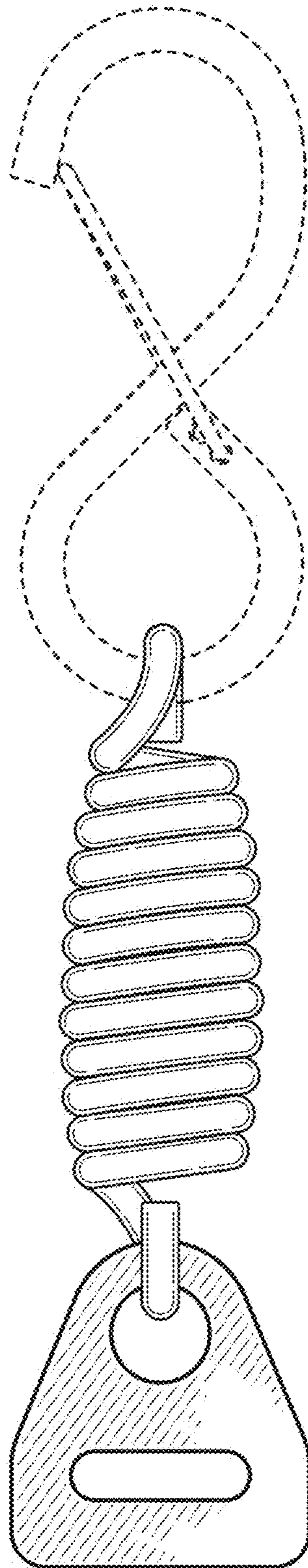

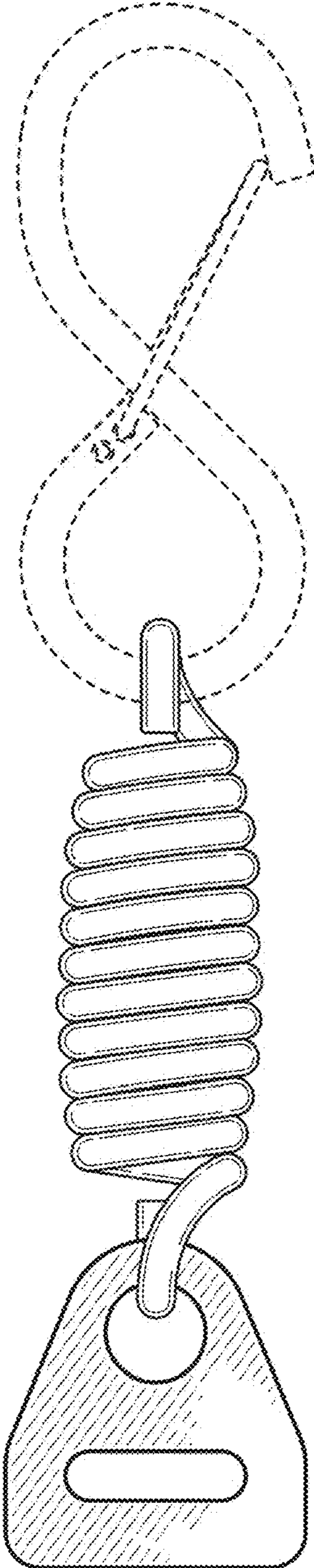
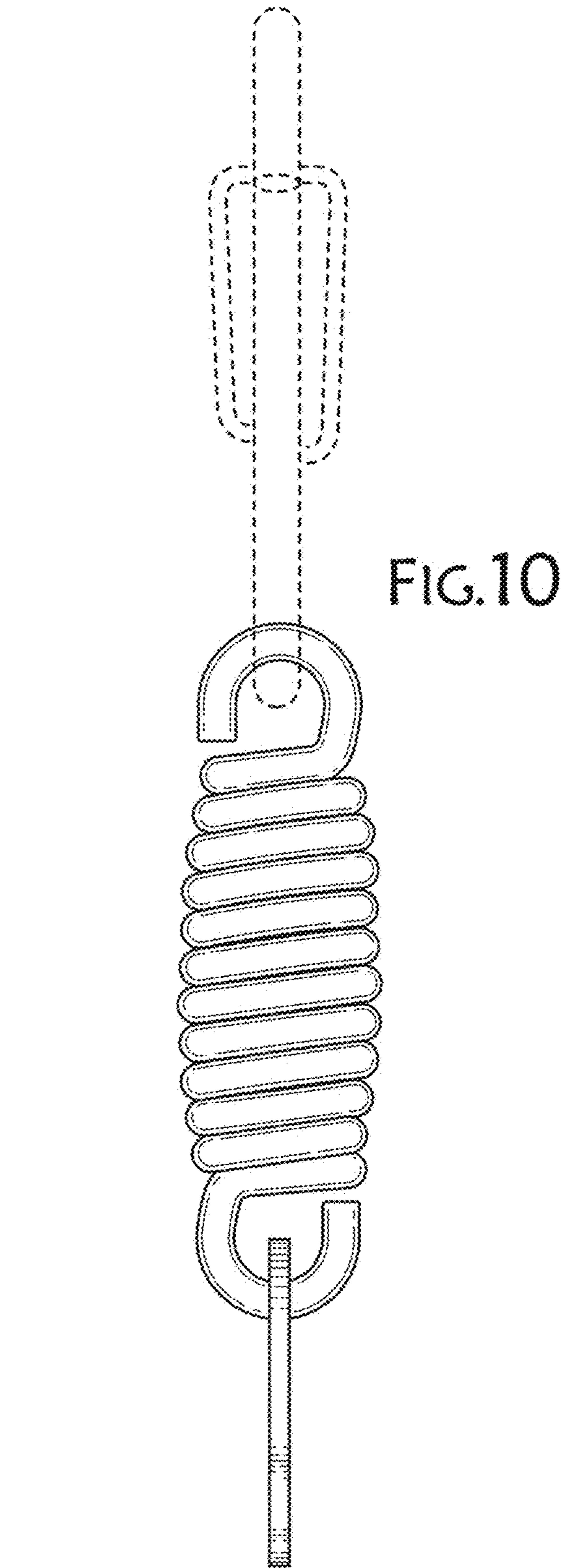
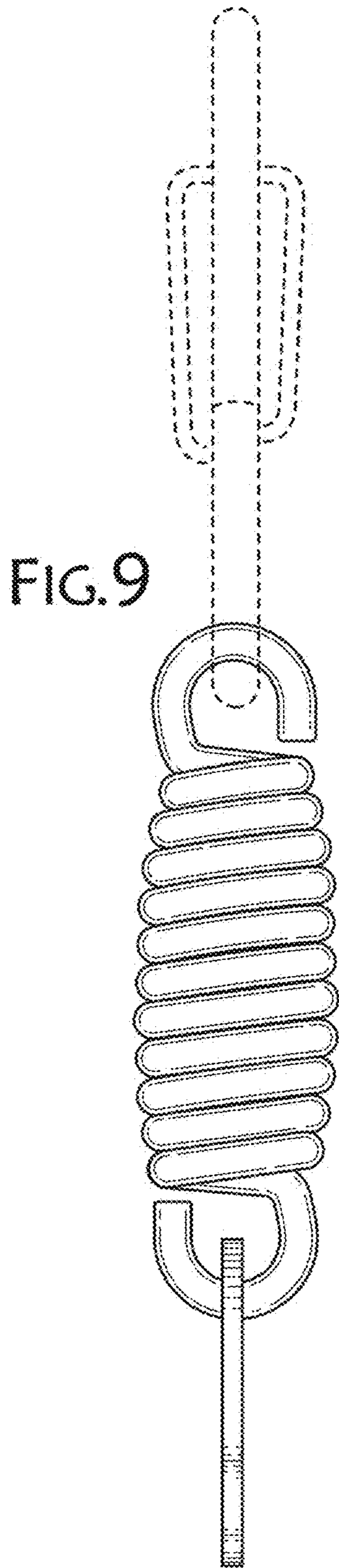

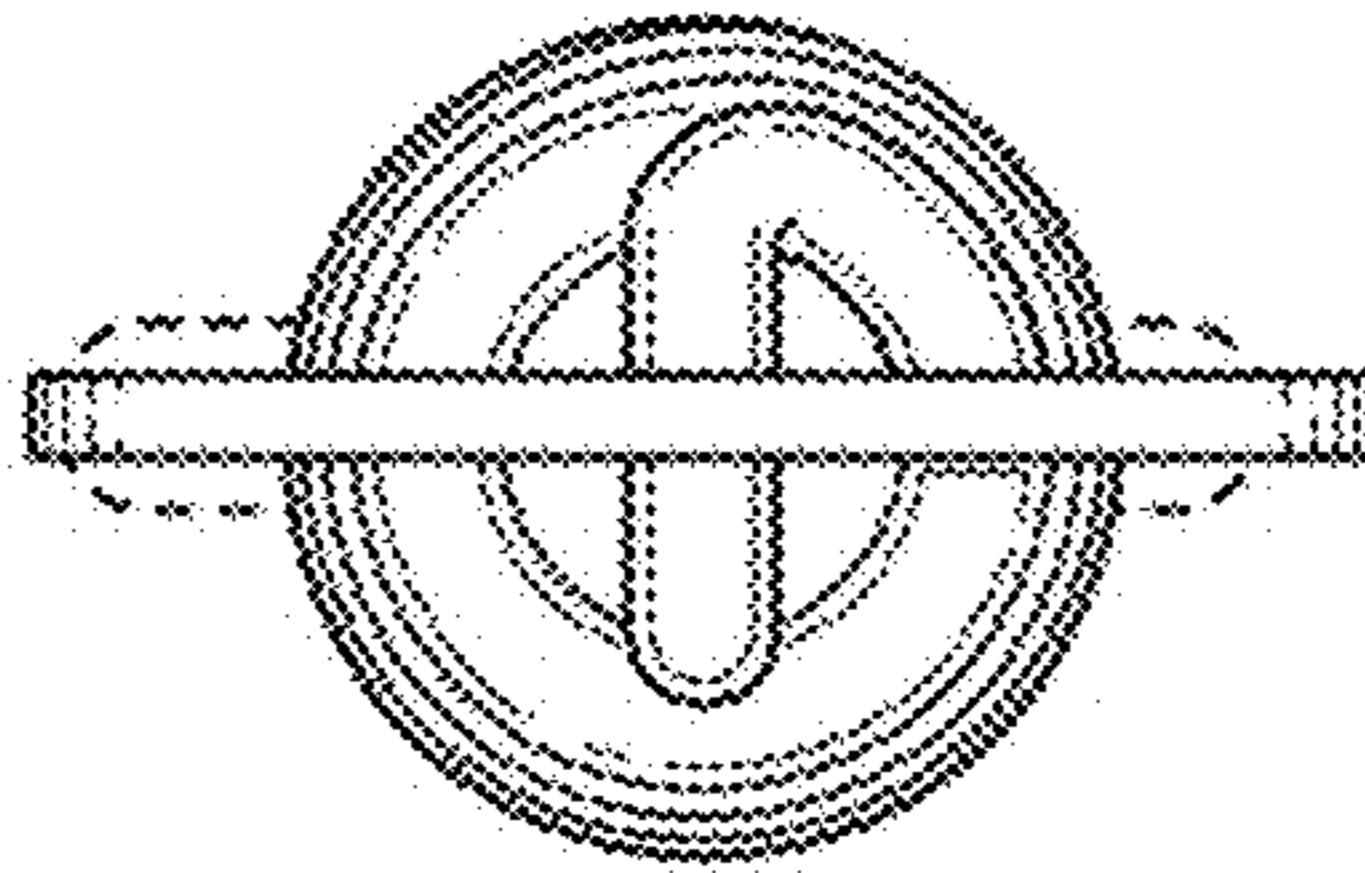

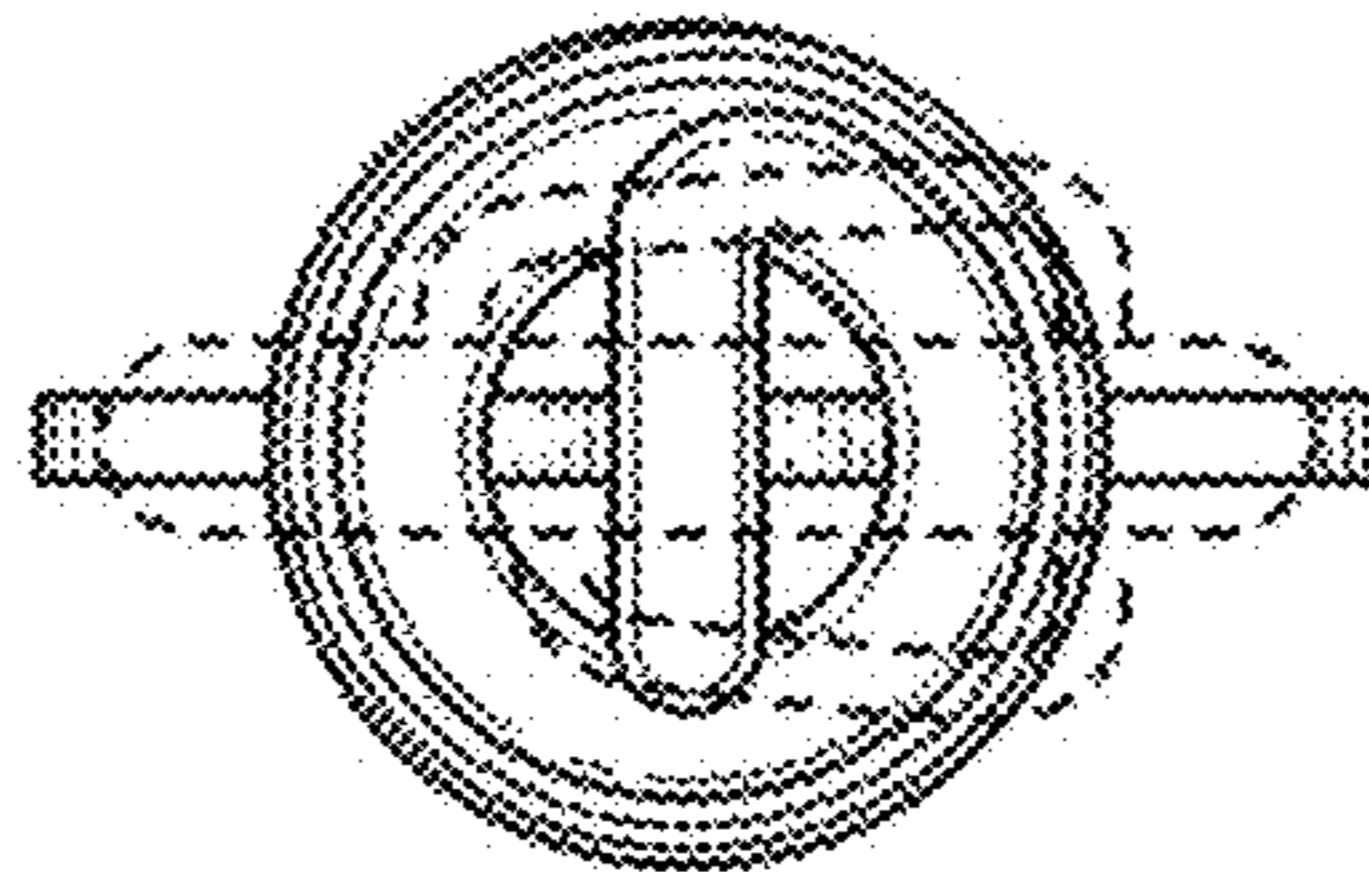
