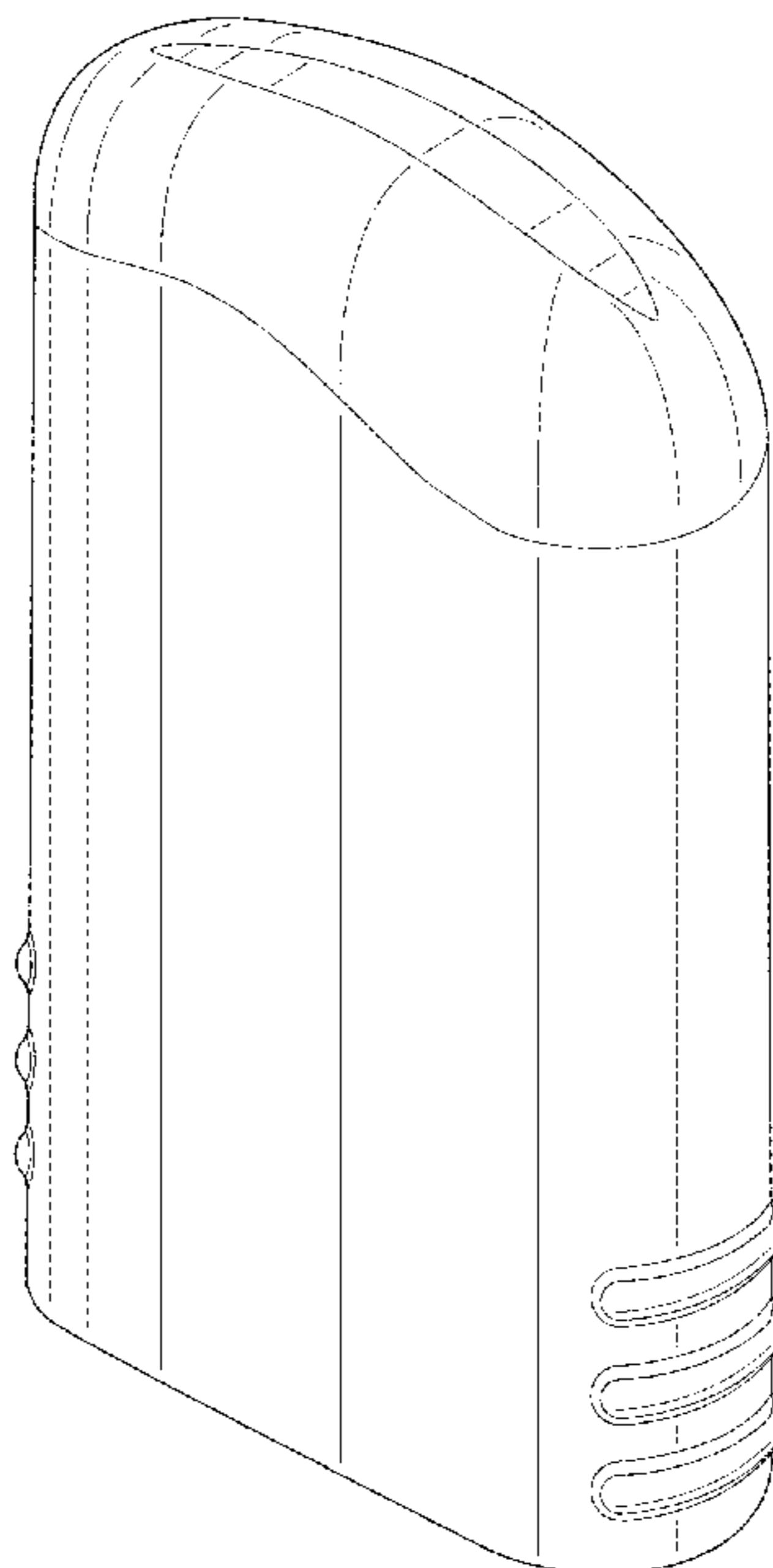
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a container cap, showing our new design;

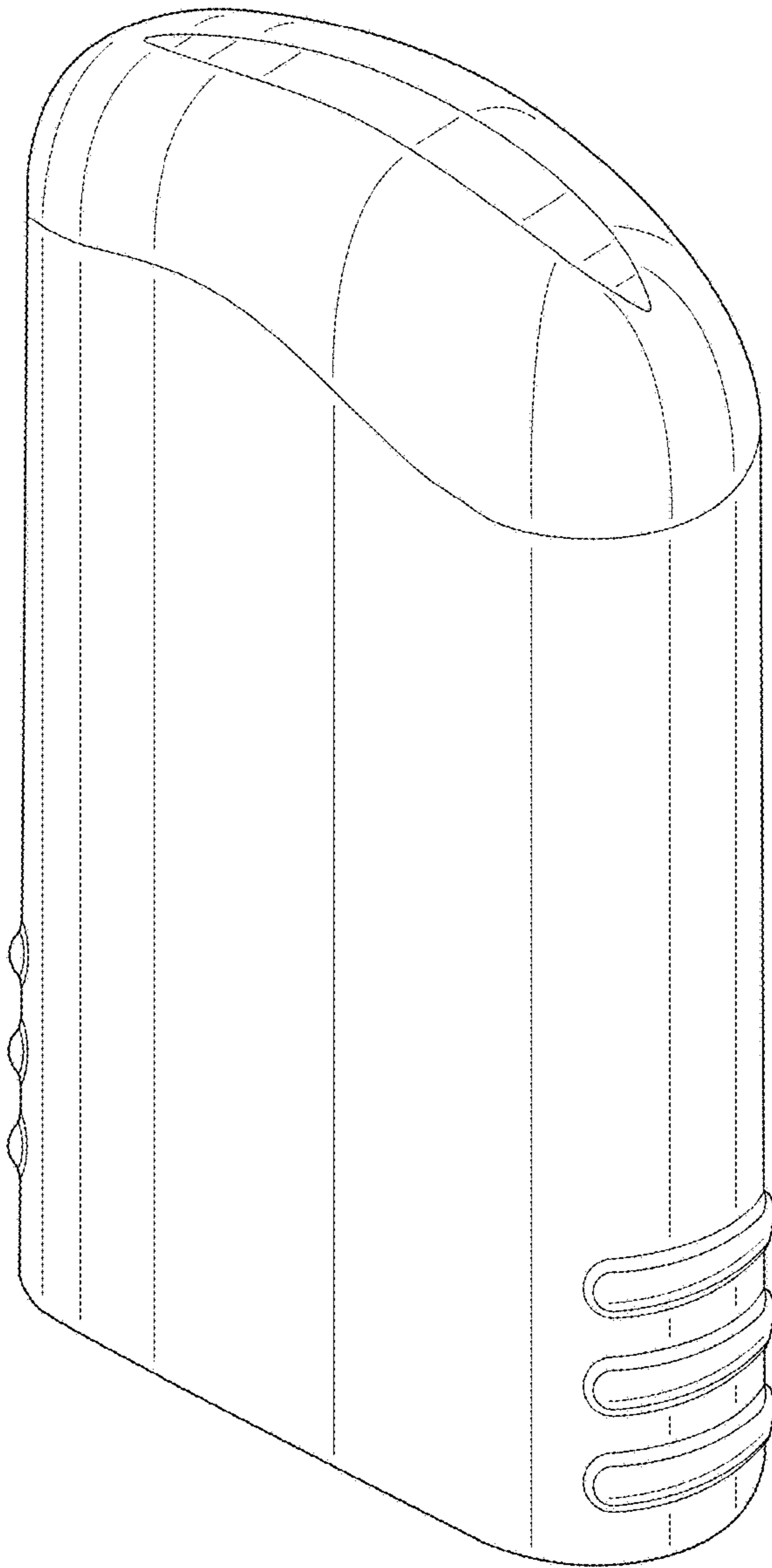

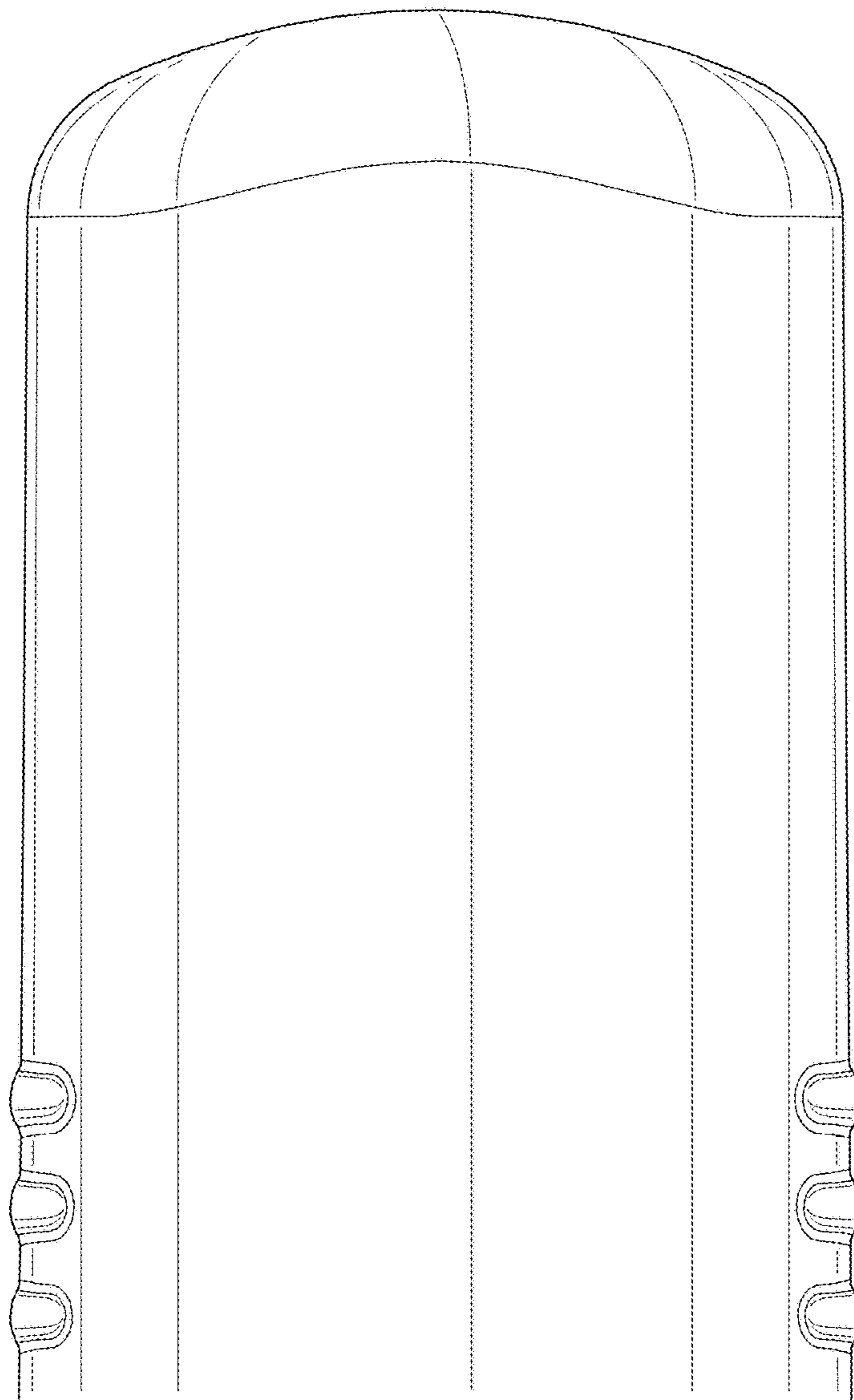

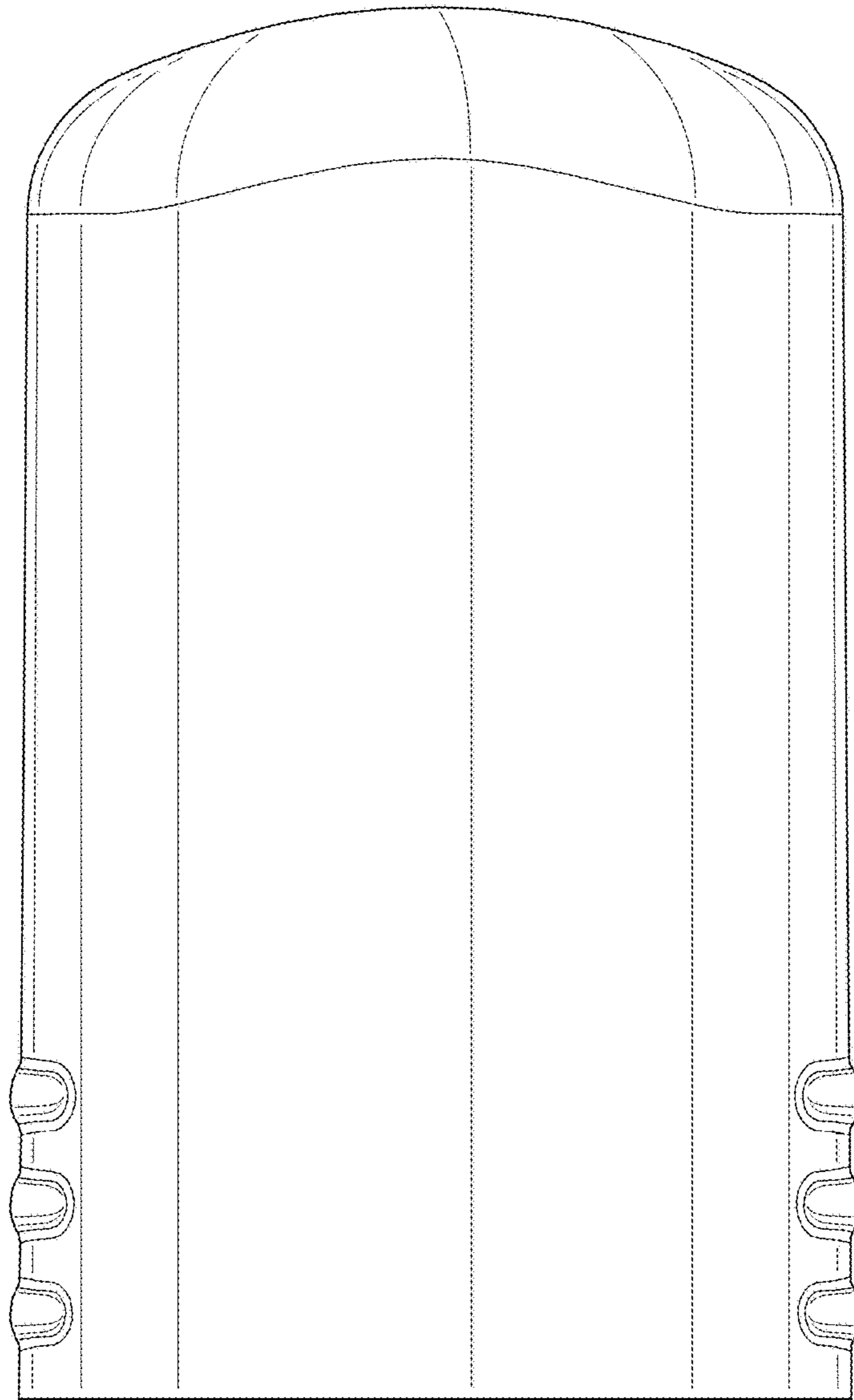

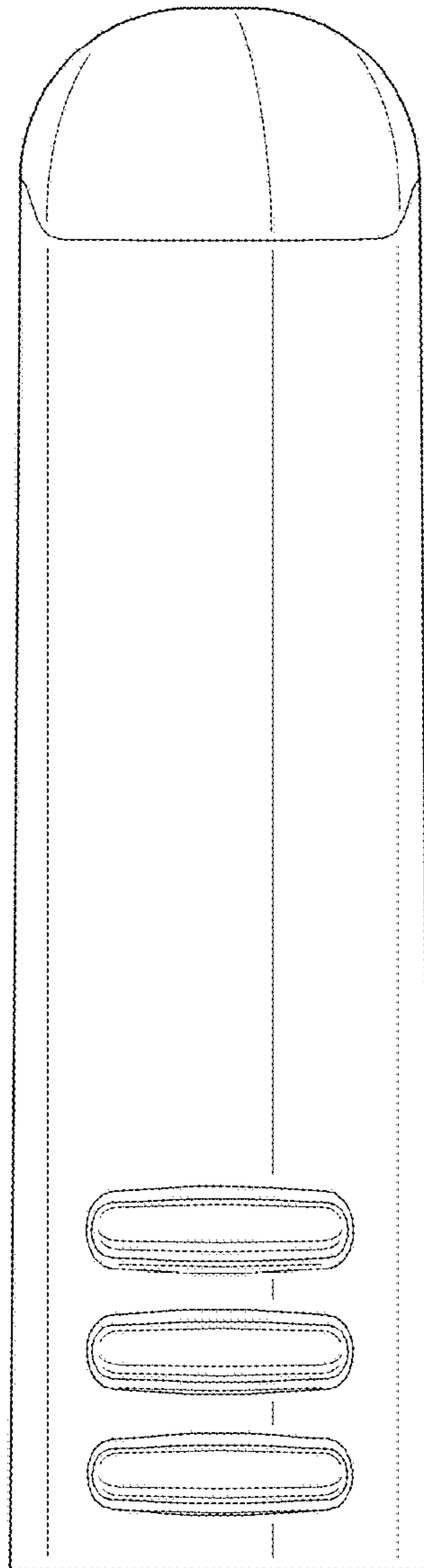

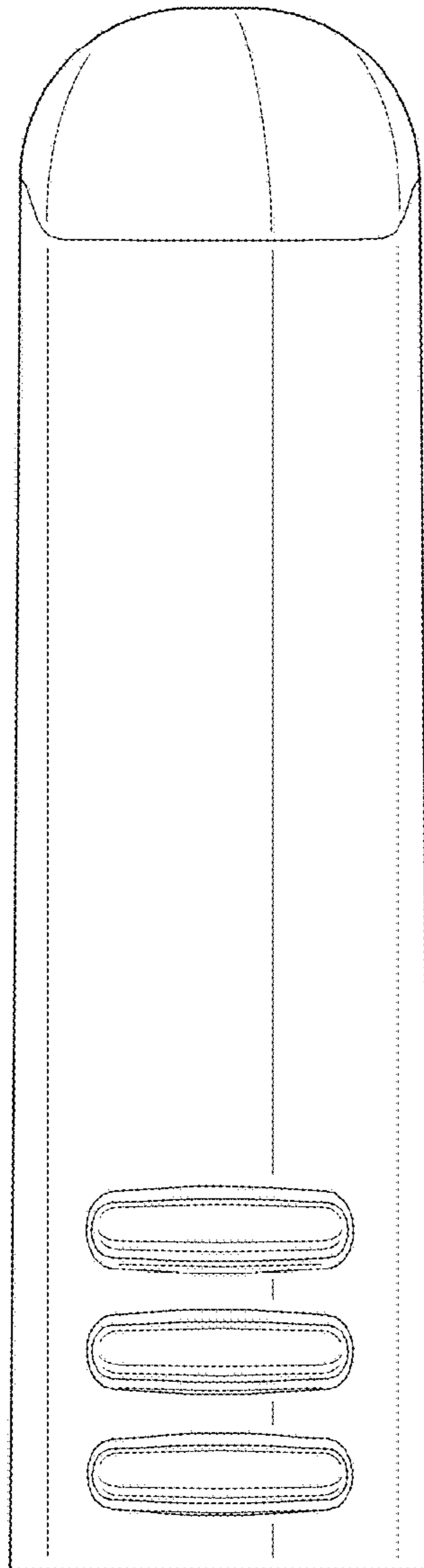

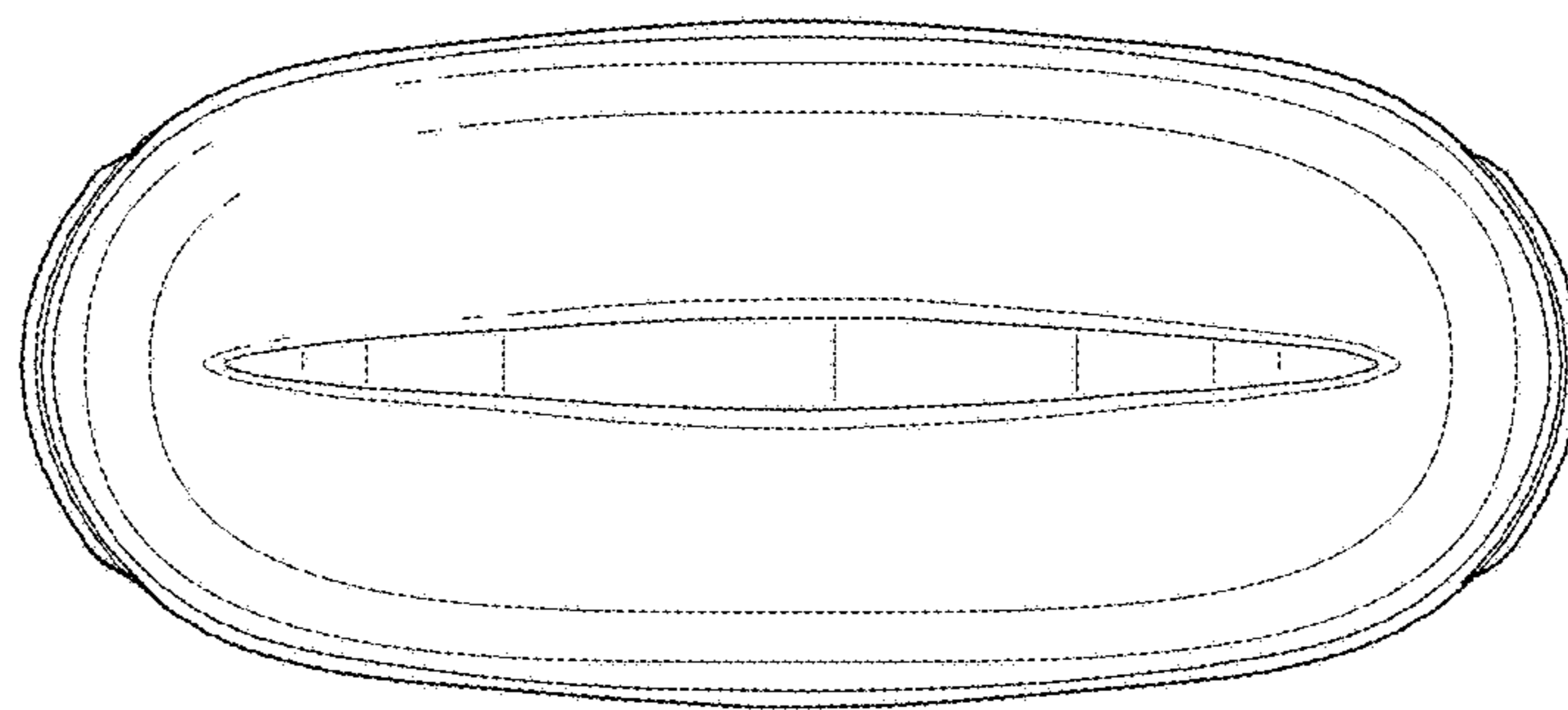

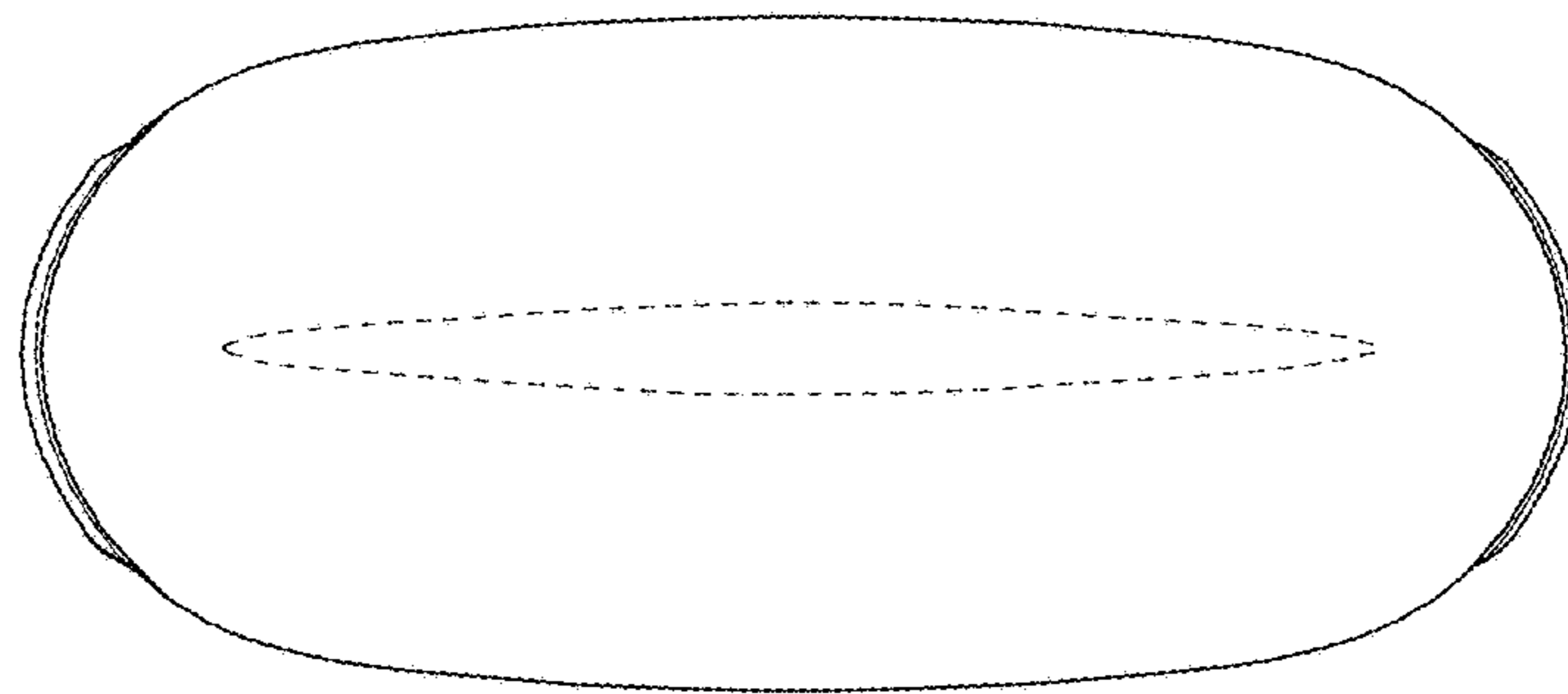
