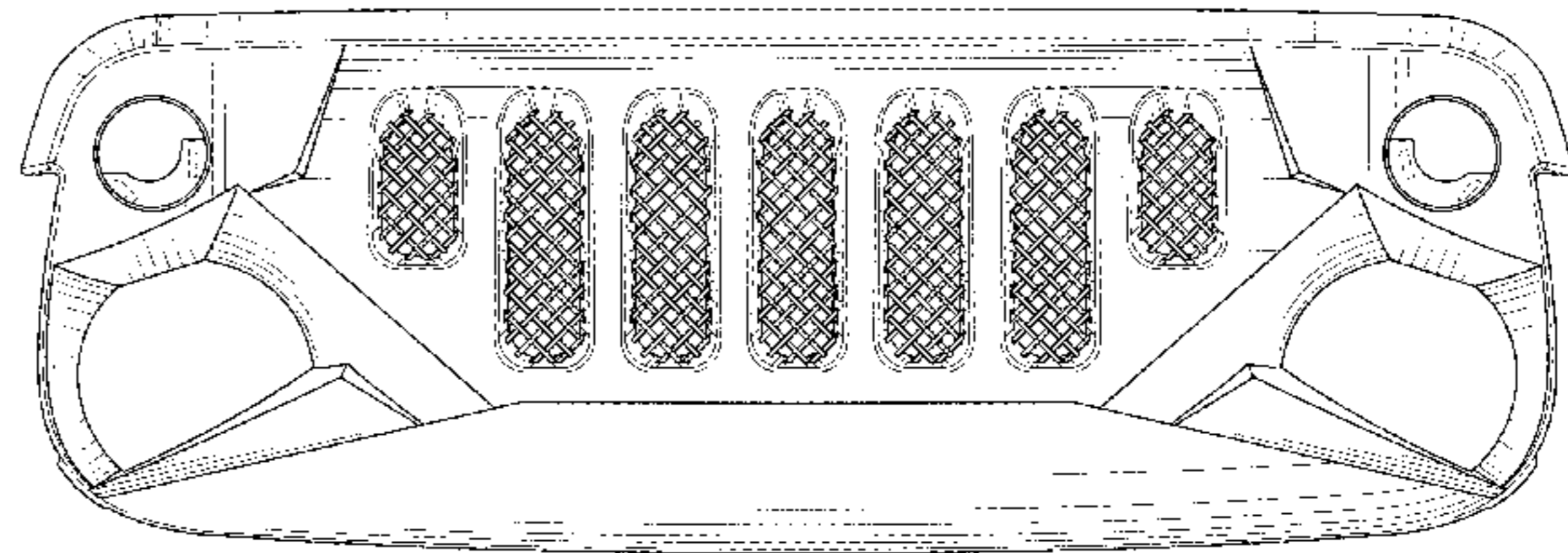
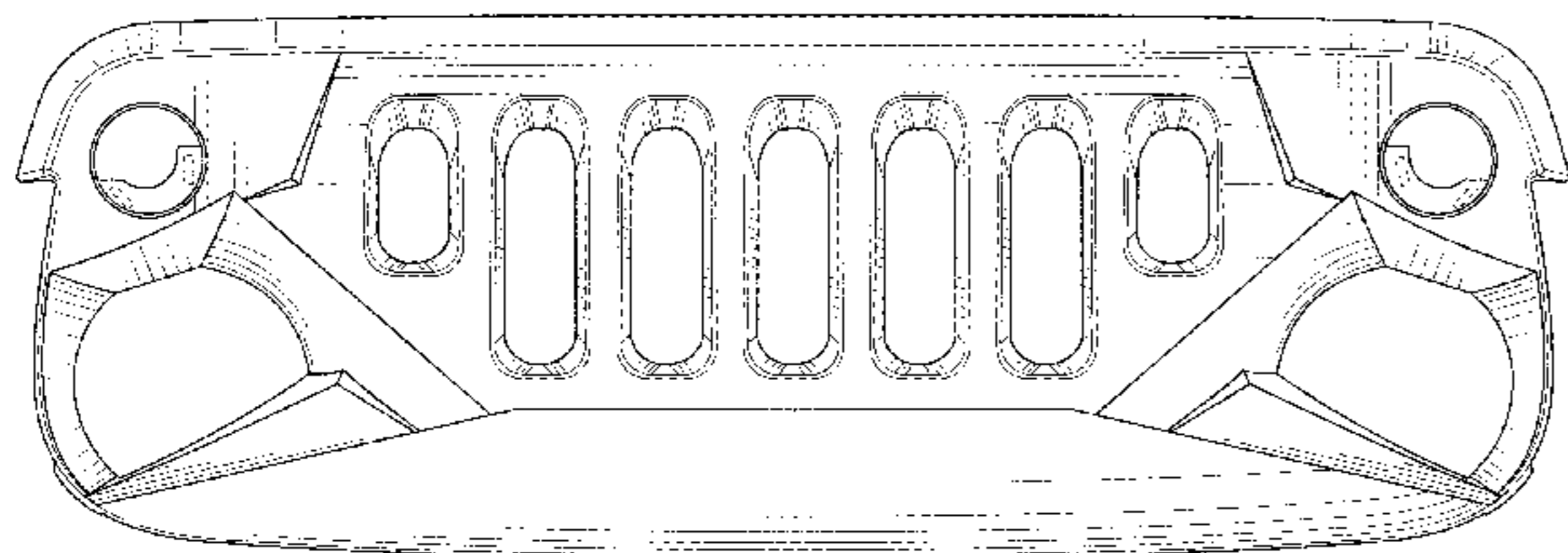
**CLAIM**

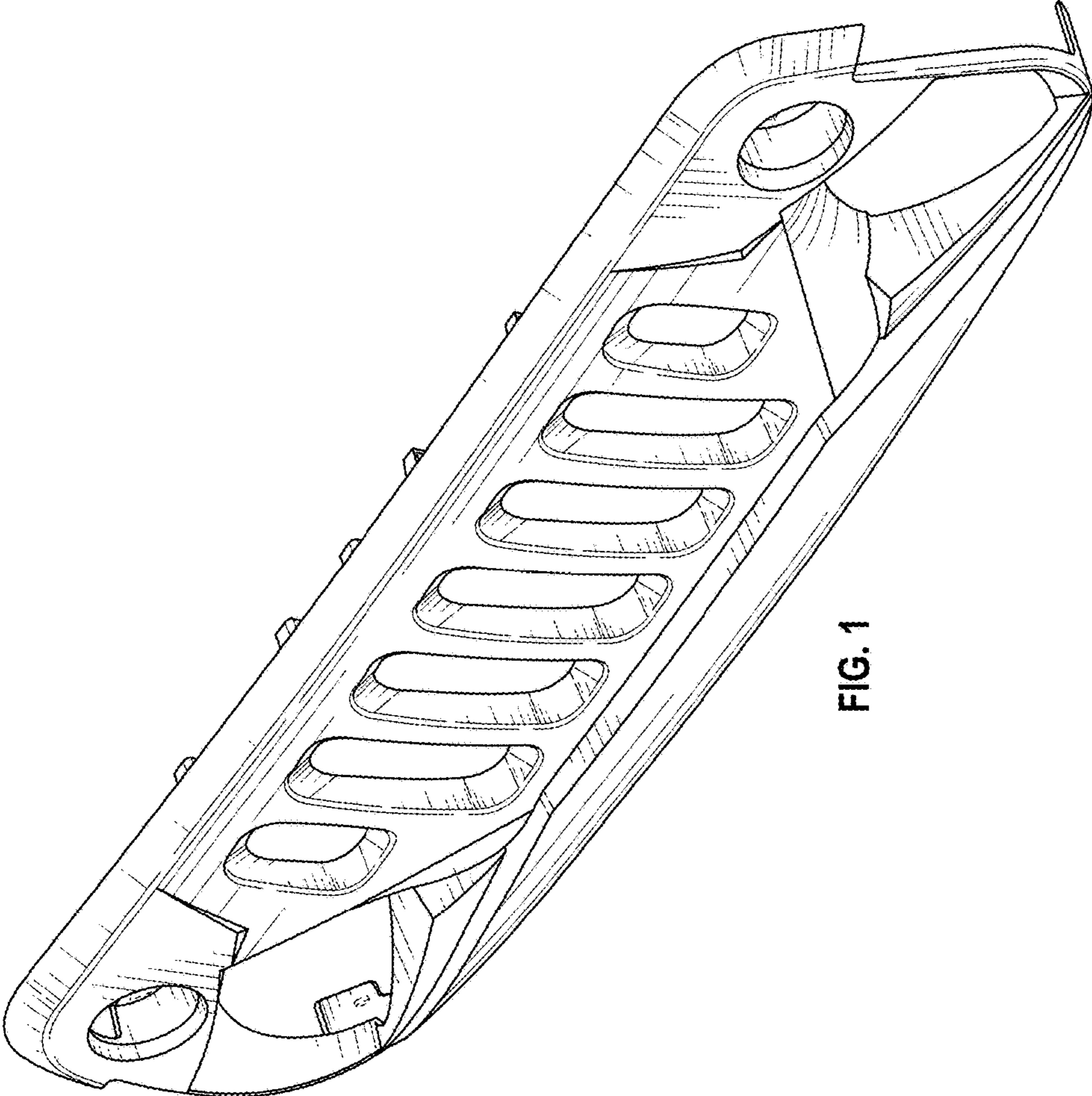

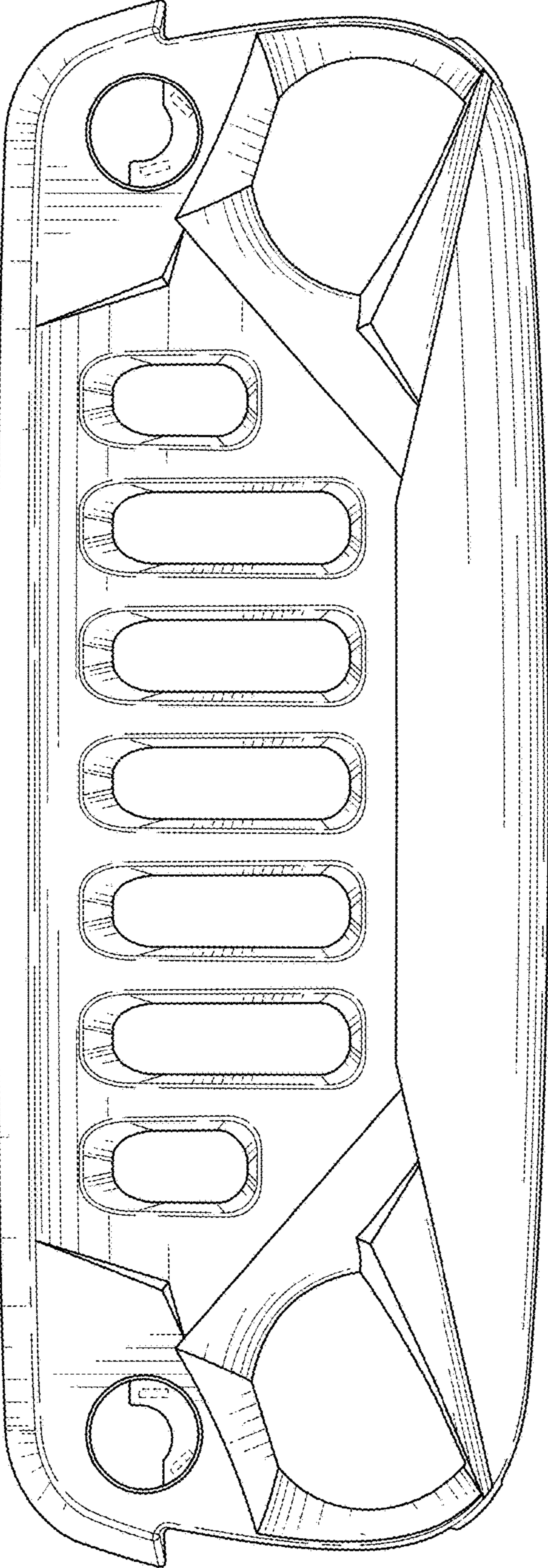

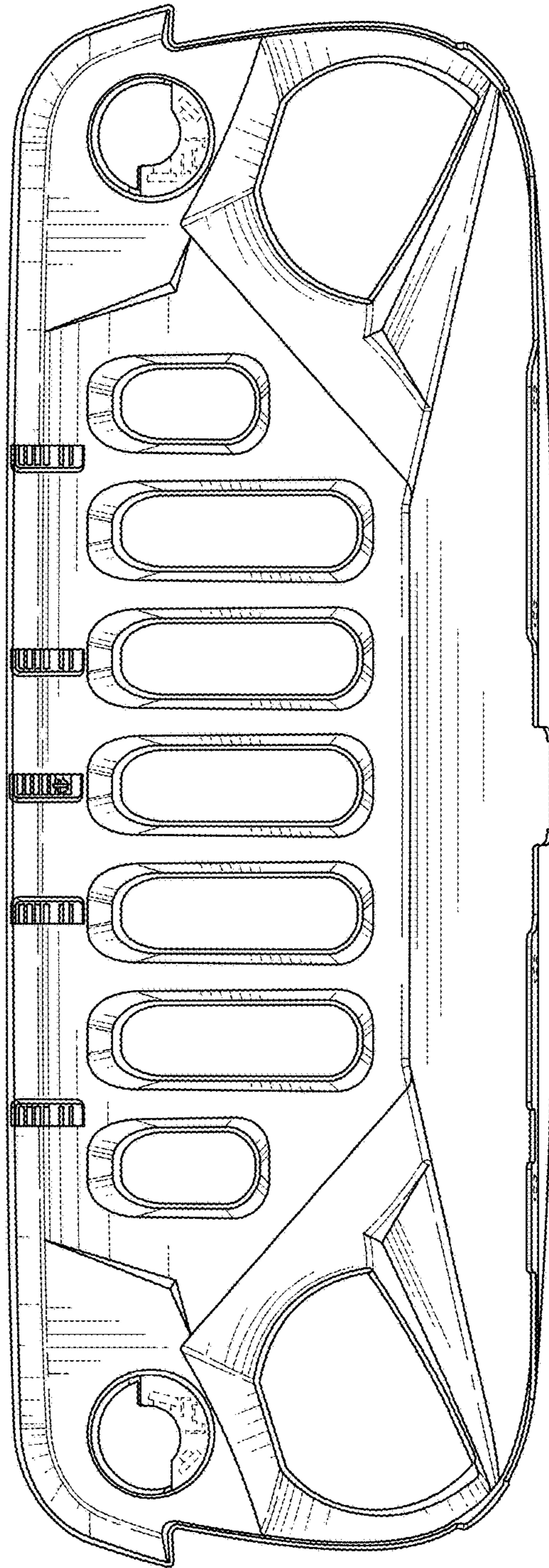

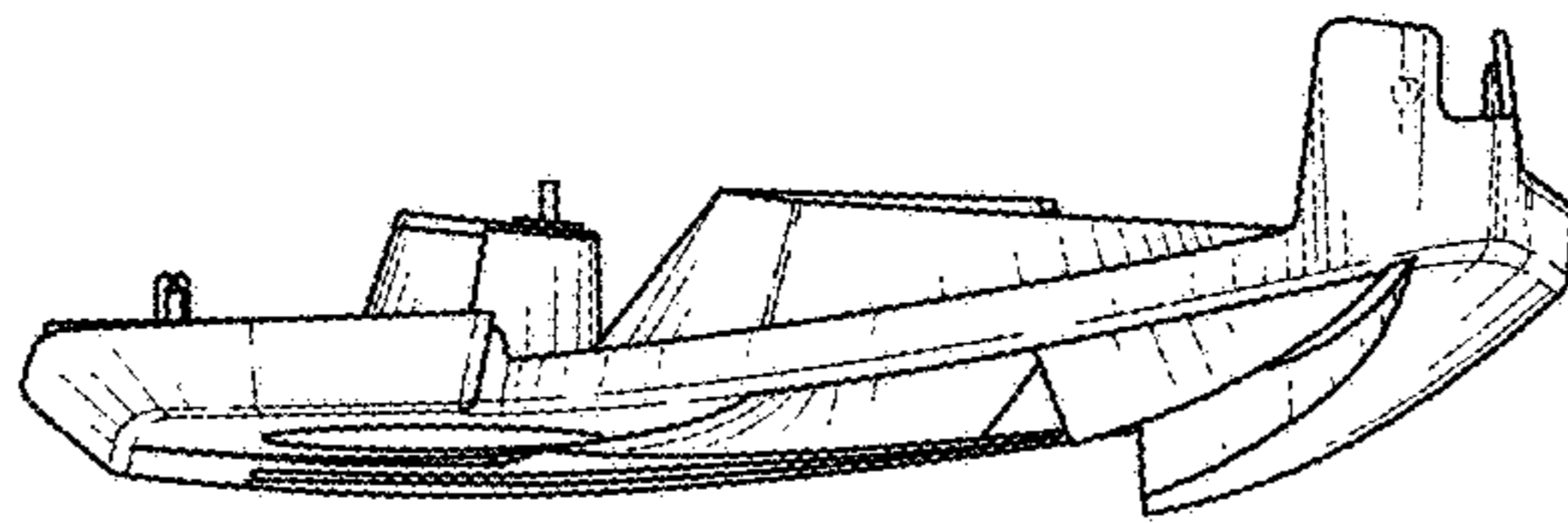

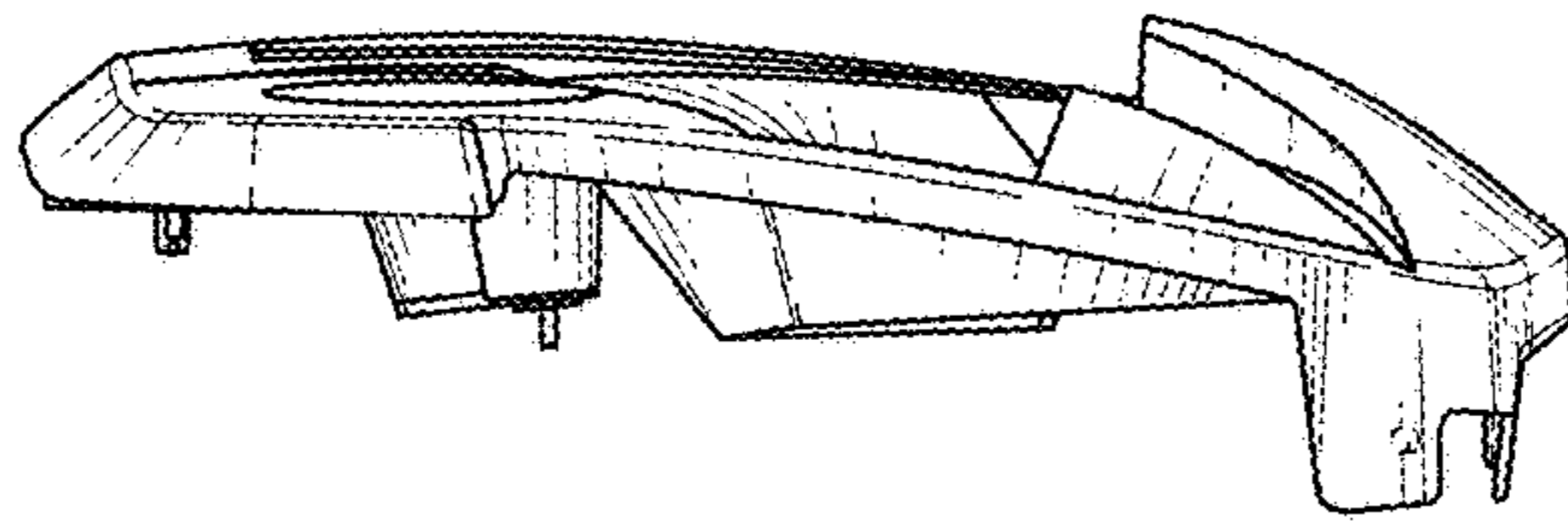

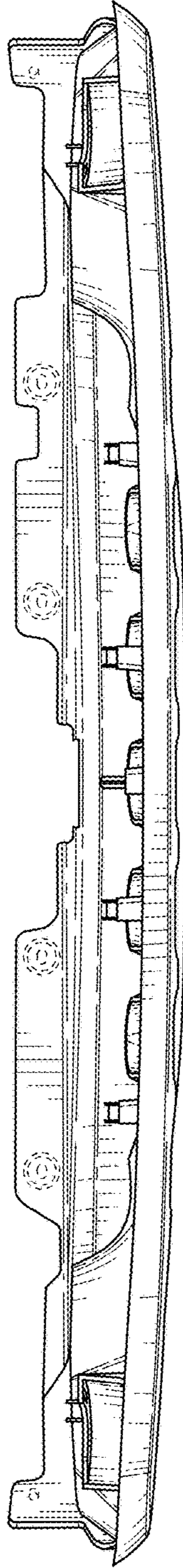

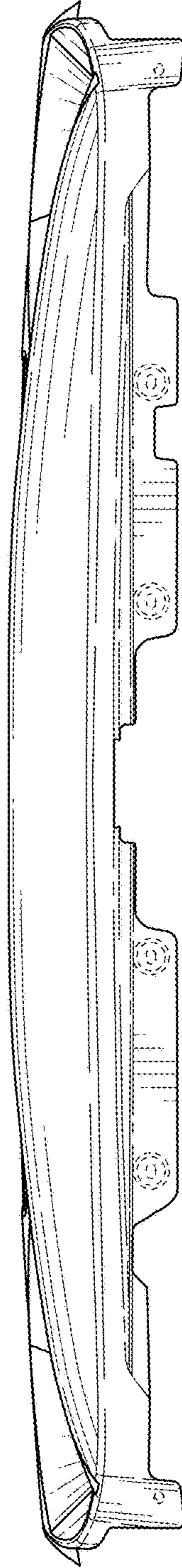

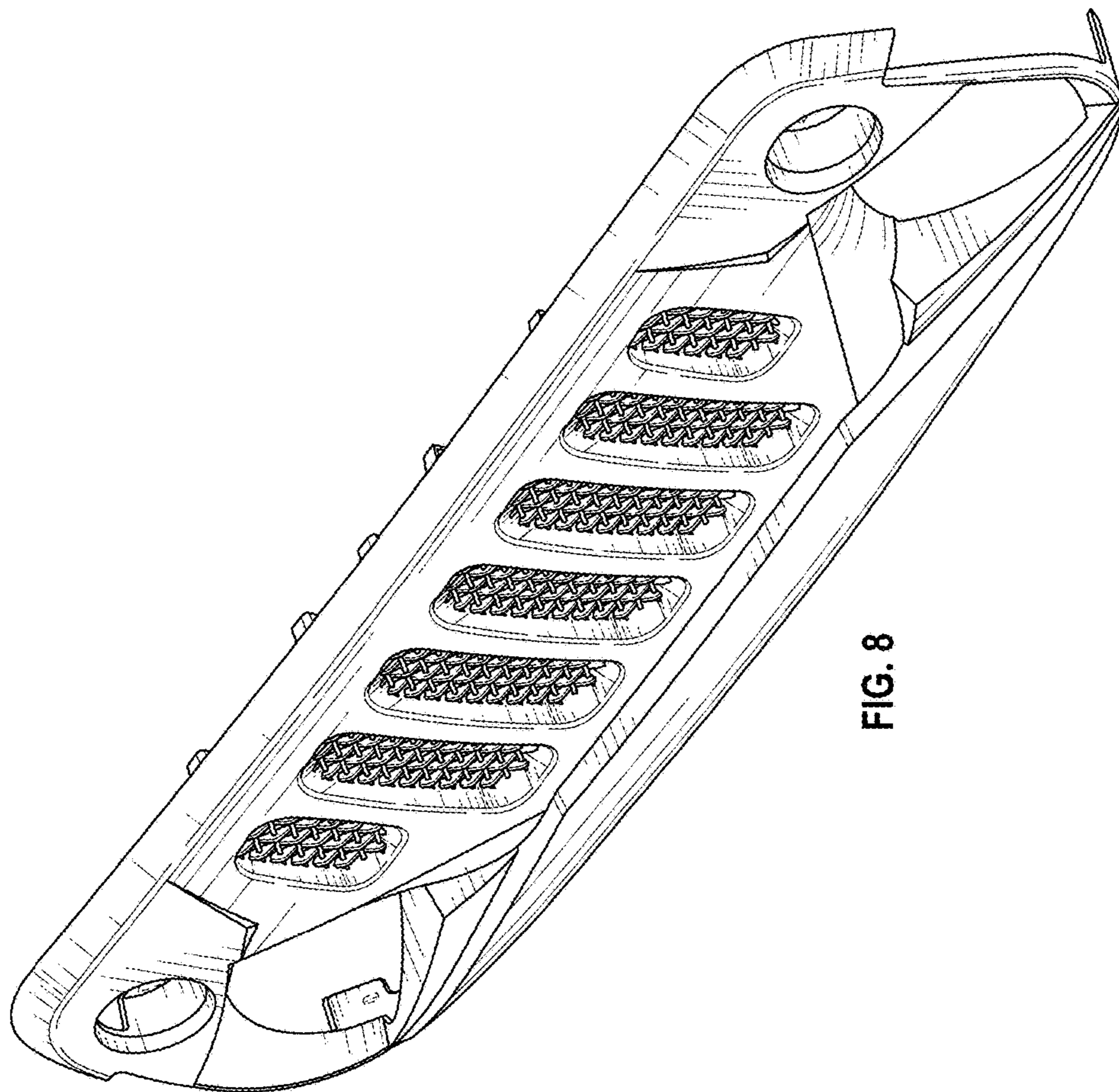

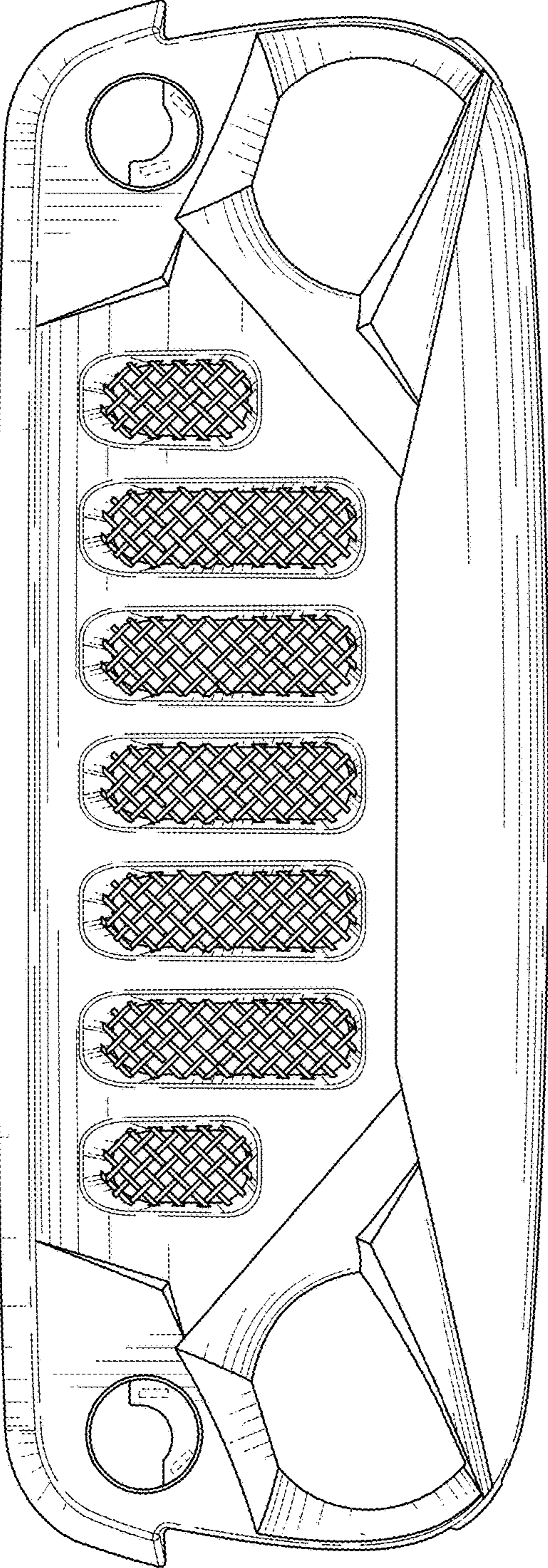

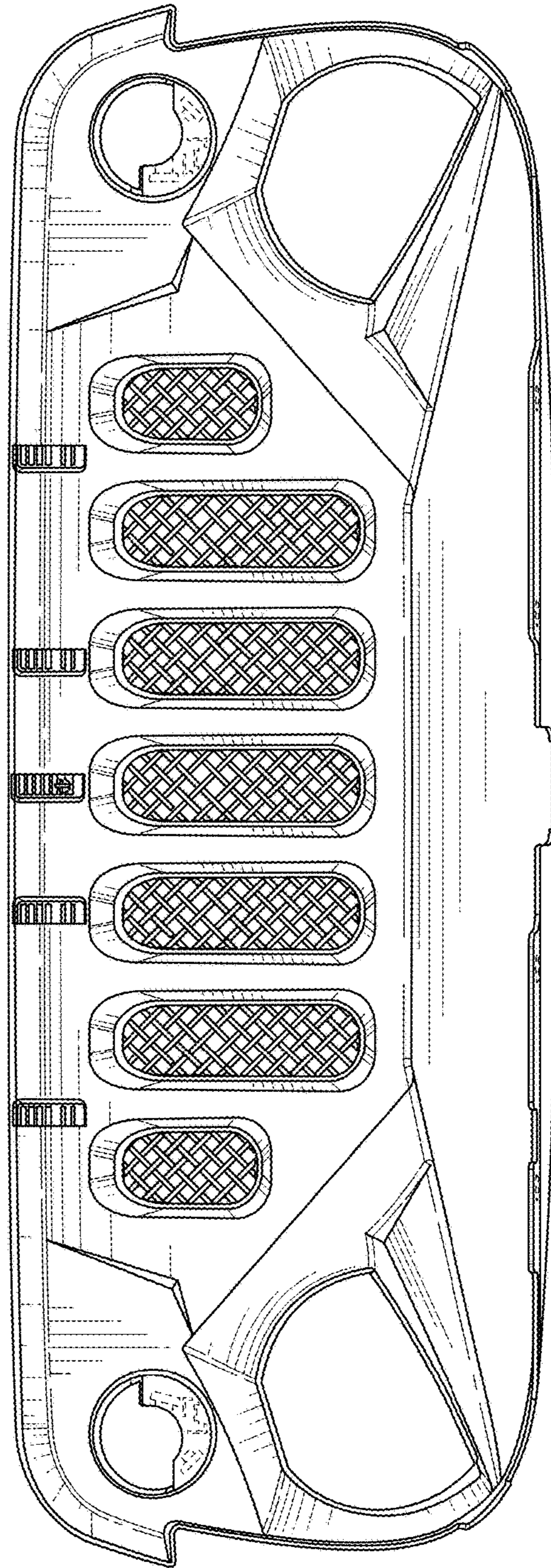

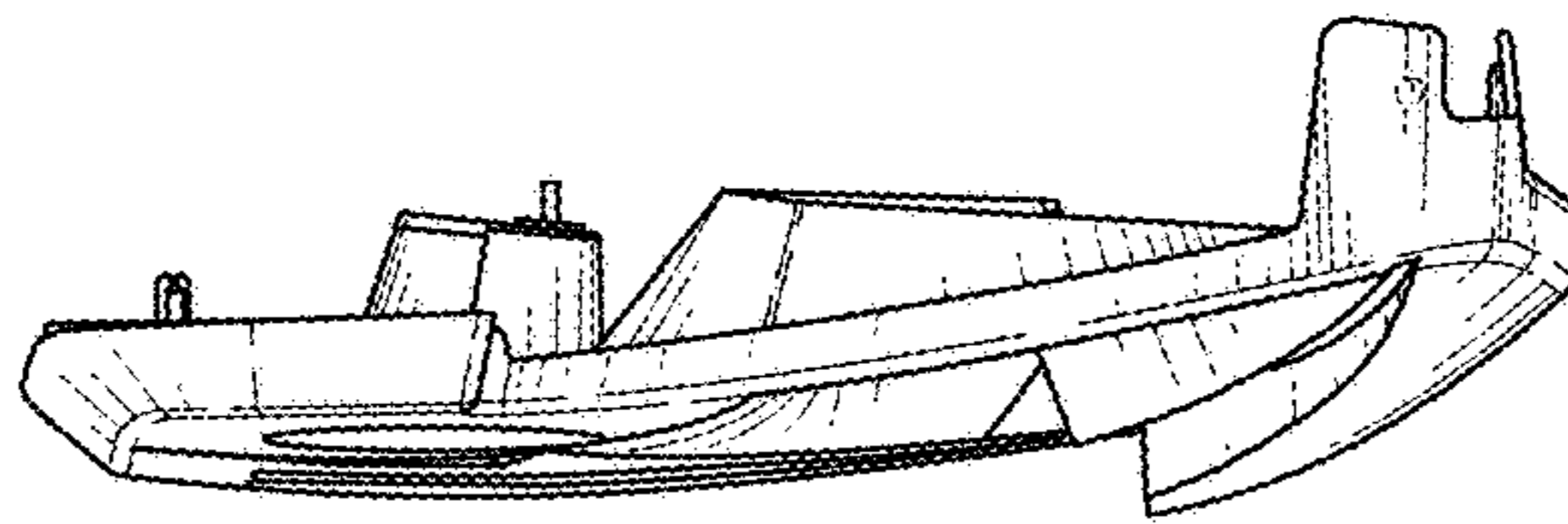

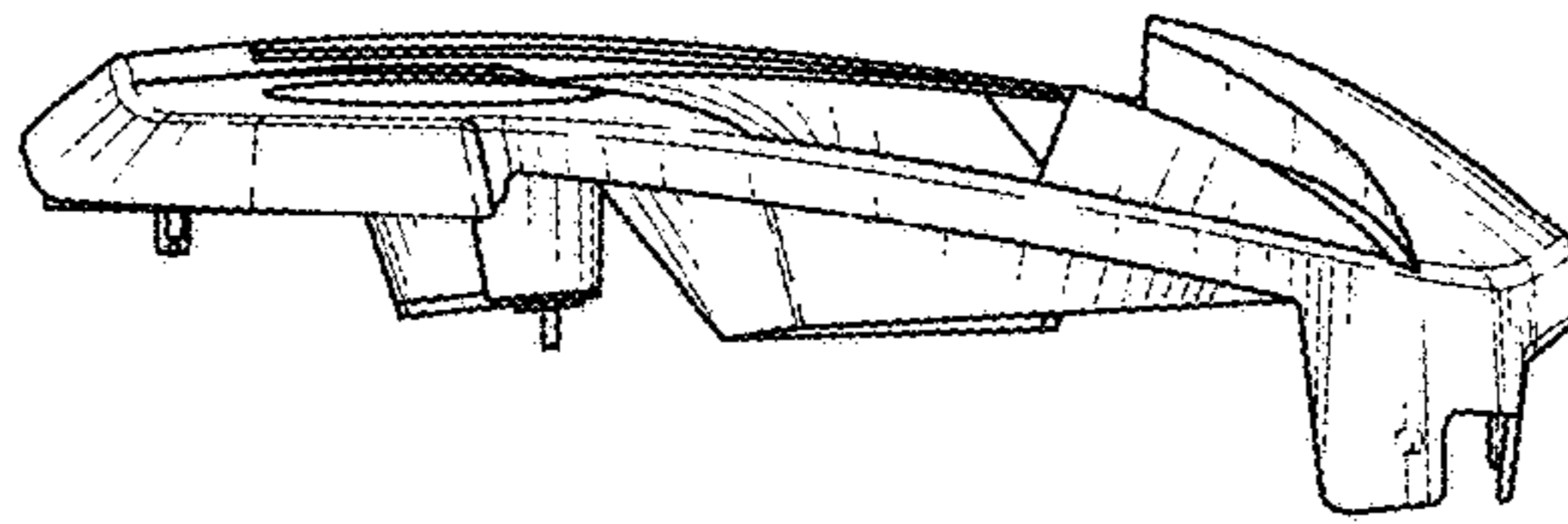

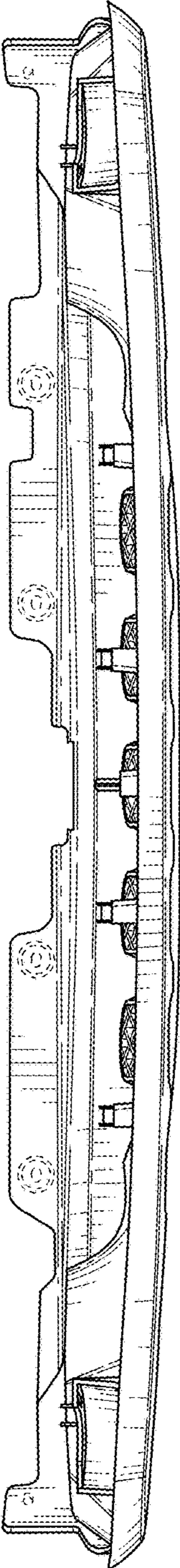

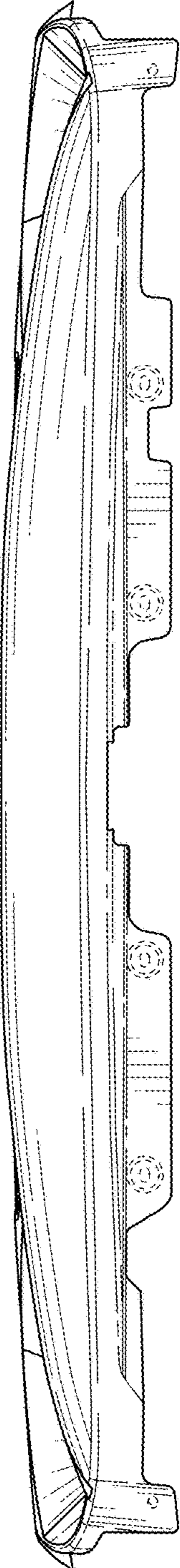
