(57) **CLAIM**

The ornamental design for an all-terrain vehicle awning, as shown and described.

DESCRIPTION

FIG. 1 illustrates a top left perspective view of an all-terrain vehicle awning incorporating the new design as illustrated in the environmental setting of an exemplary side-by-side all-terrain vehicle;

FIG. 2 illustrates a top plan view of the all-terrain vehicle awning incorporating the new design;

FIG. 4 illustrates a bottom plan view thereof;

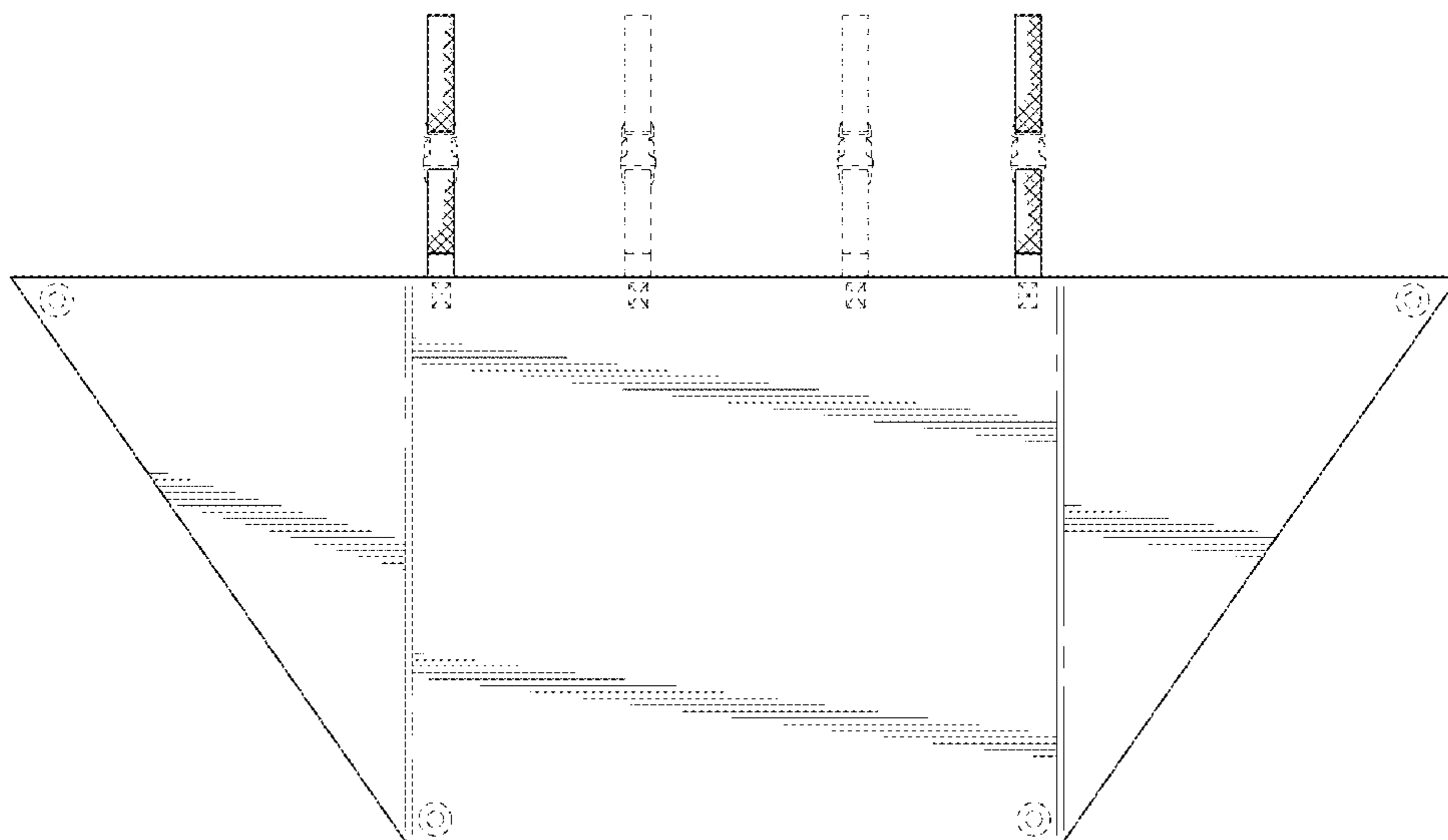
FIG. 5 illustrates a rear elevation view thereof;

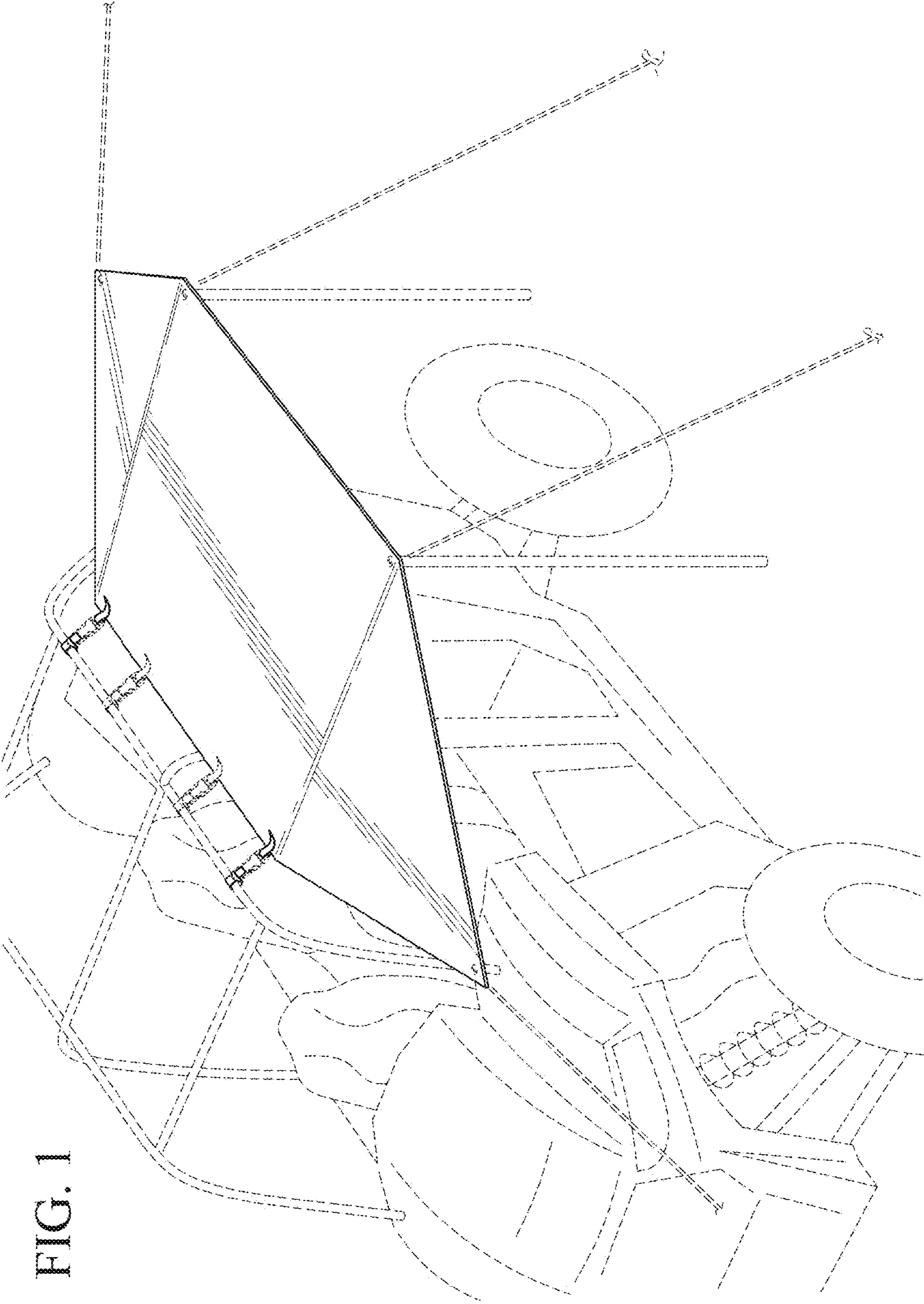

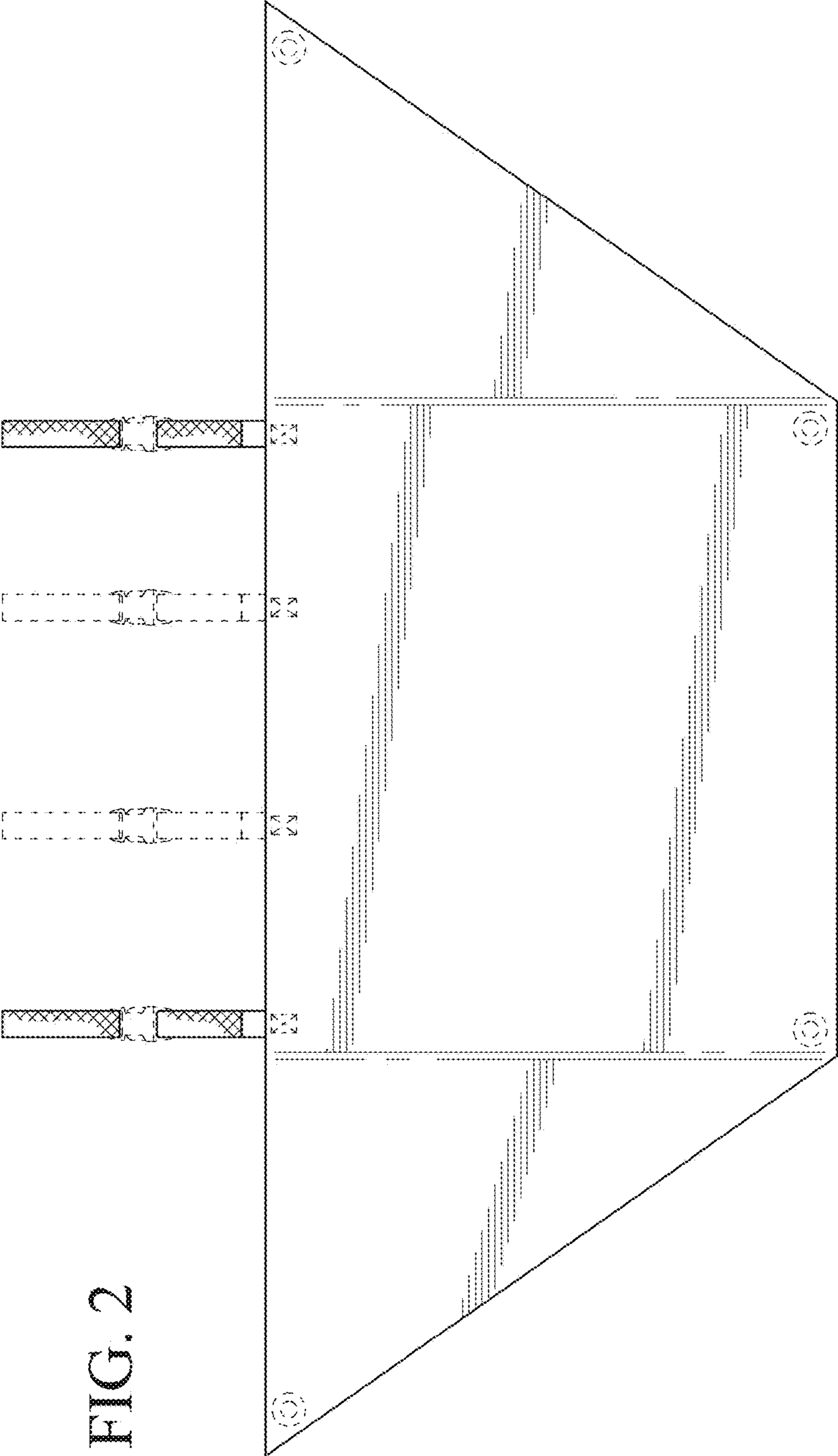

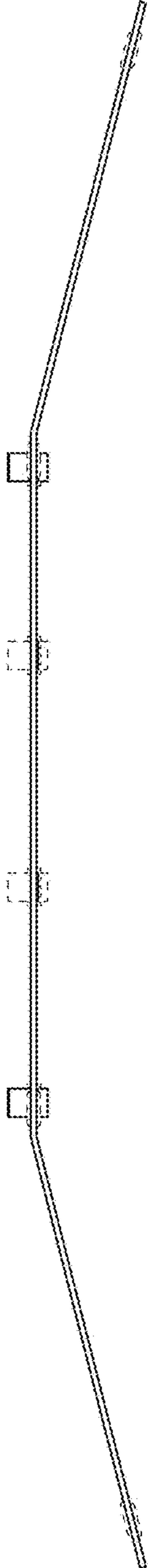

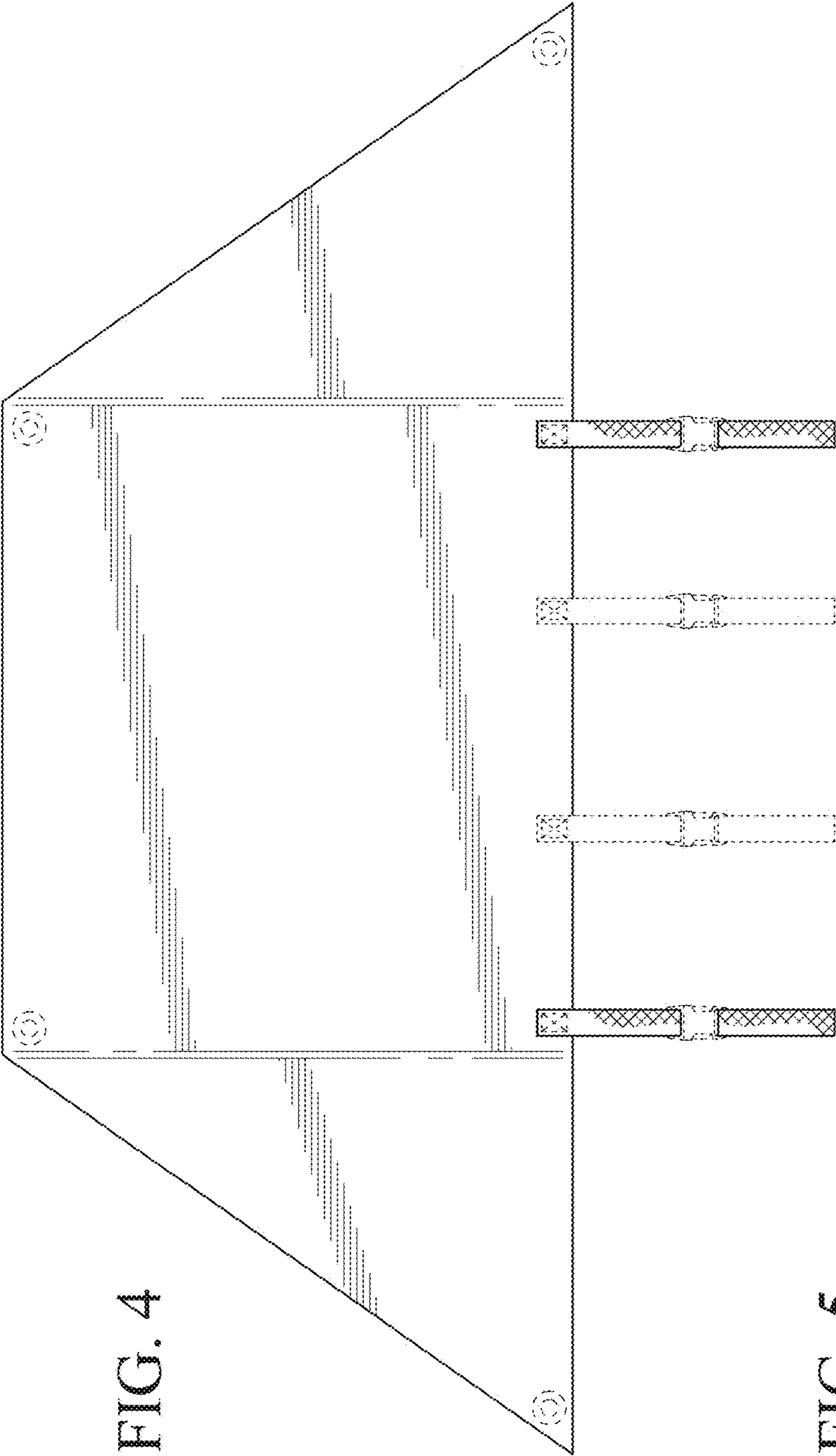

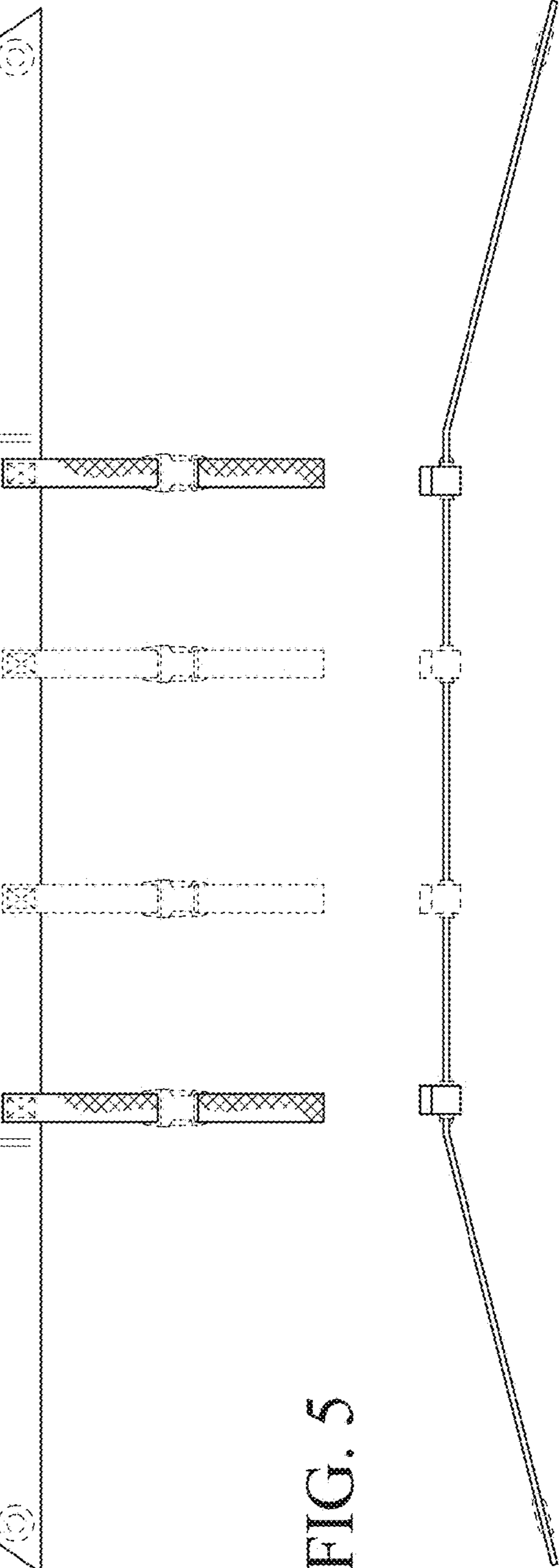

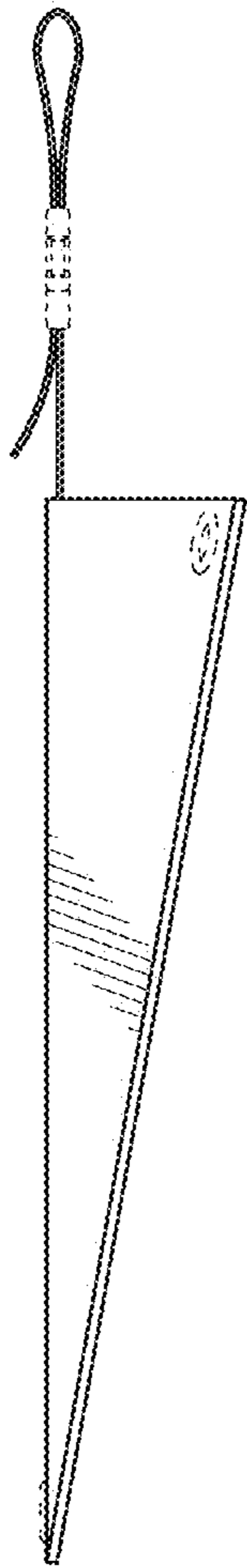

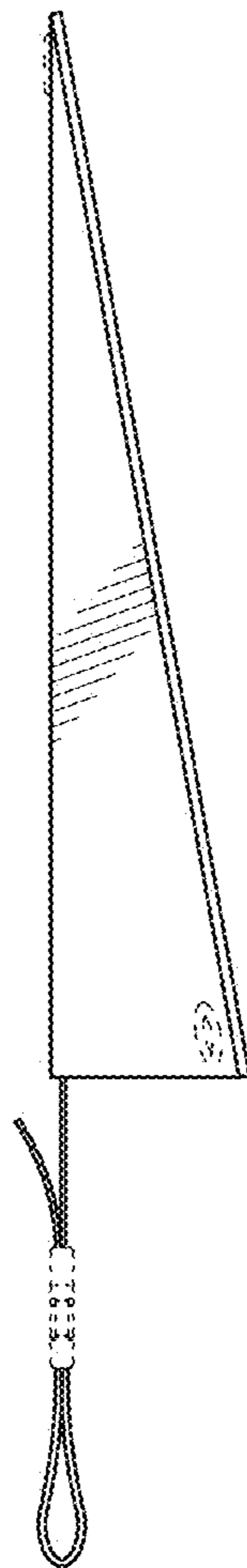
