DESCRIPTION

FIG. 7 is a bottom plan view thereof; and,

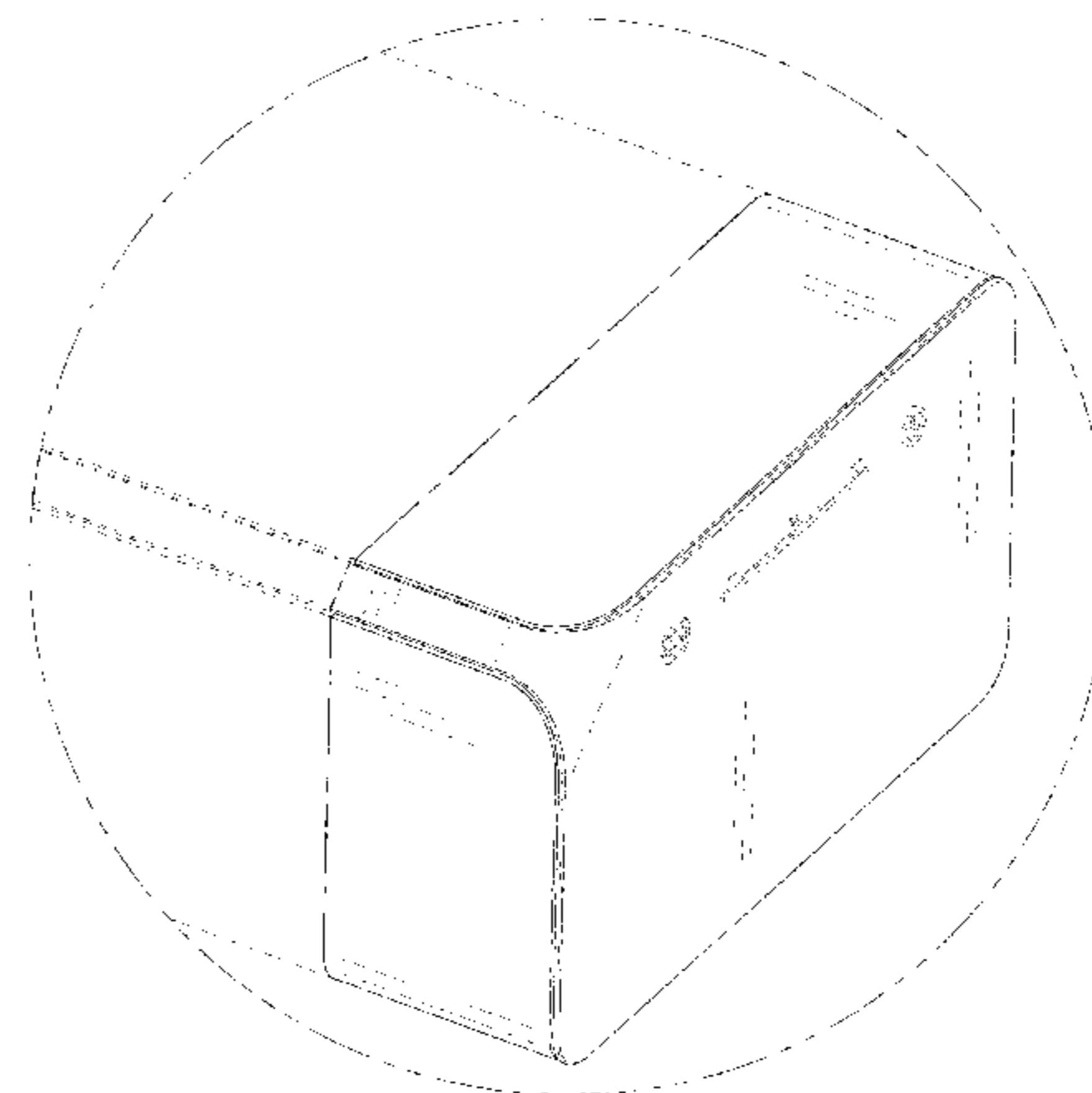
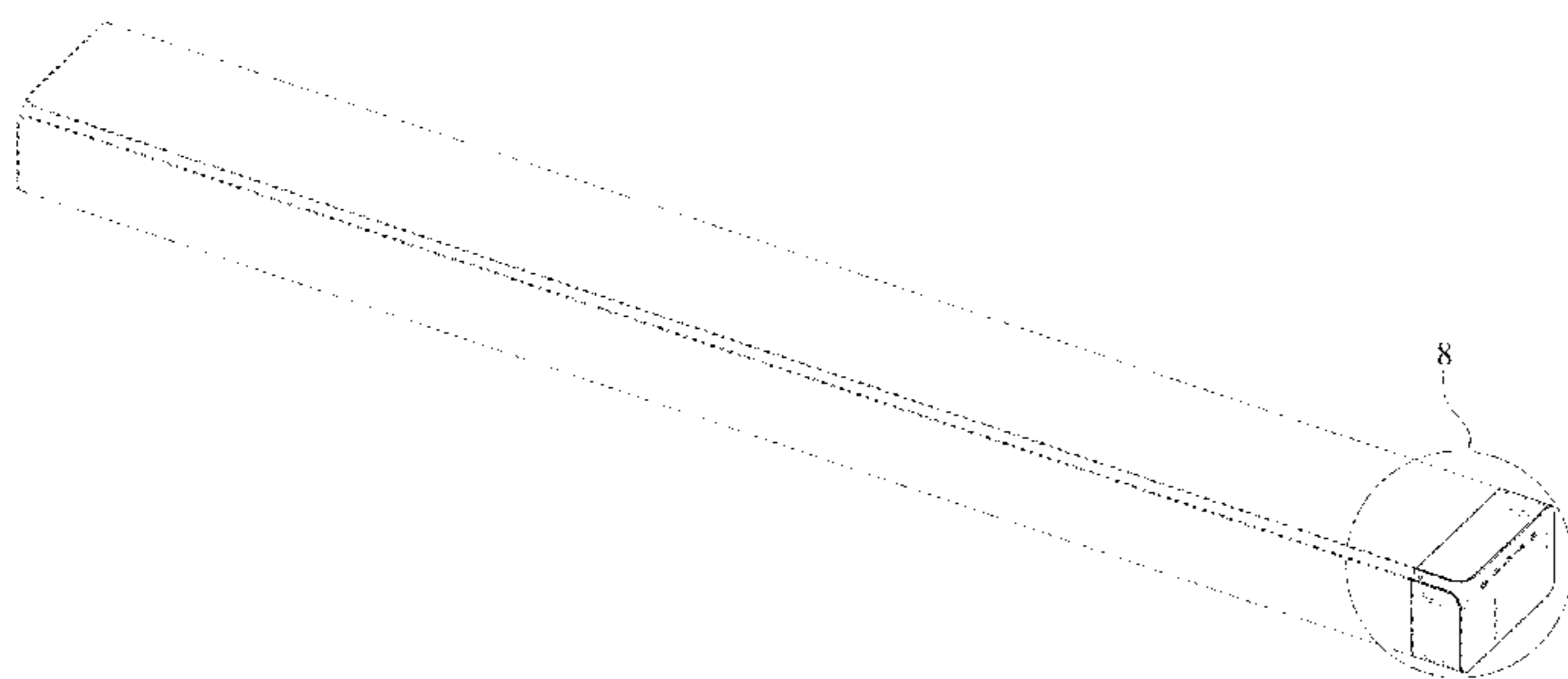
FIG. 8 is an enlarged front perspective view of the portion encircled in FIG. 1.

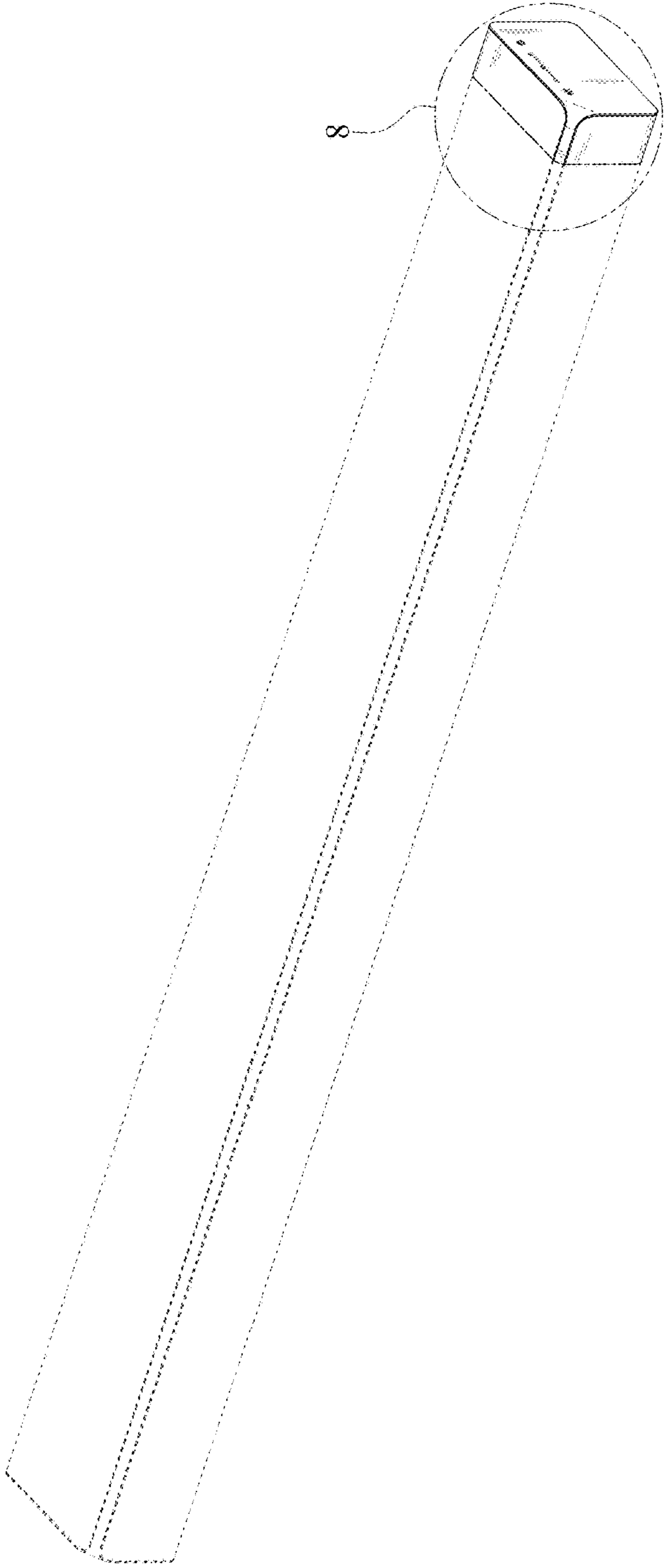

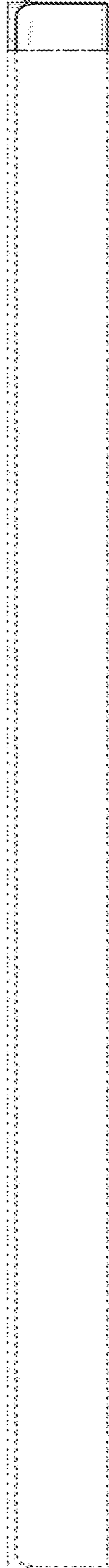

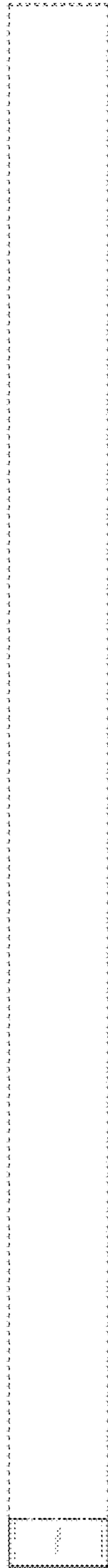

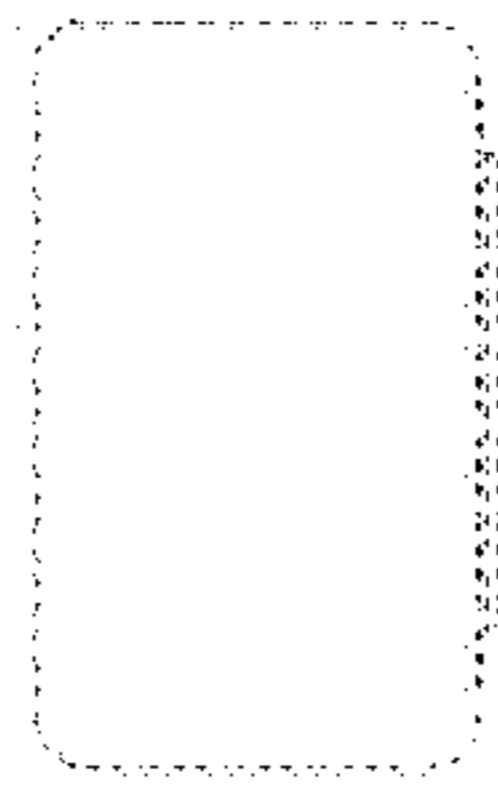

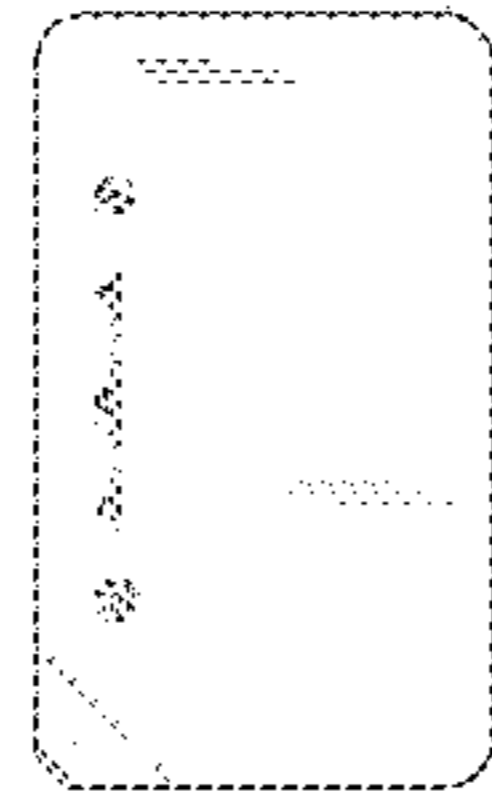

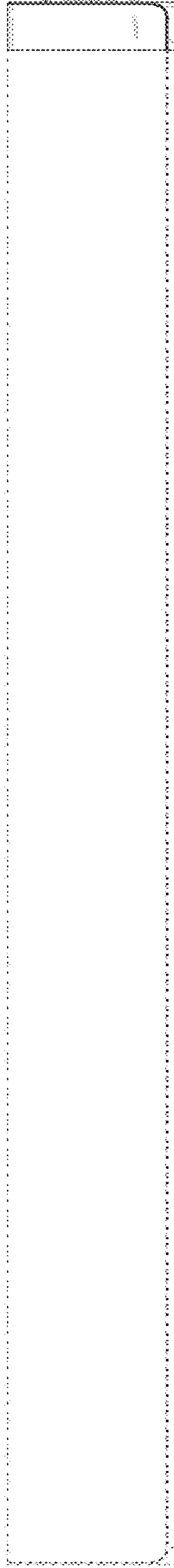

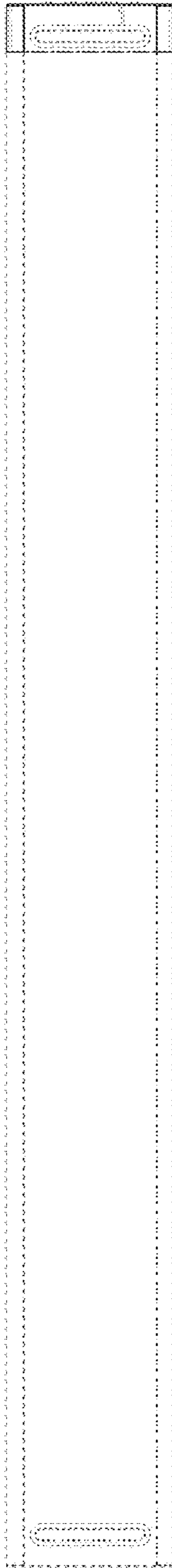
