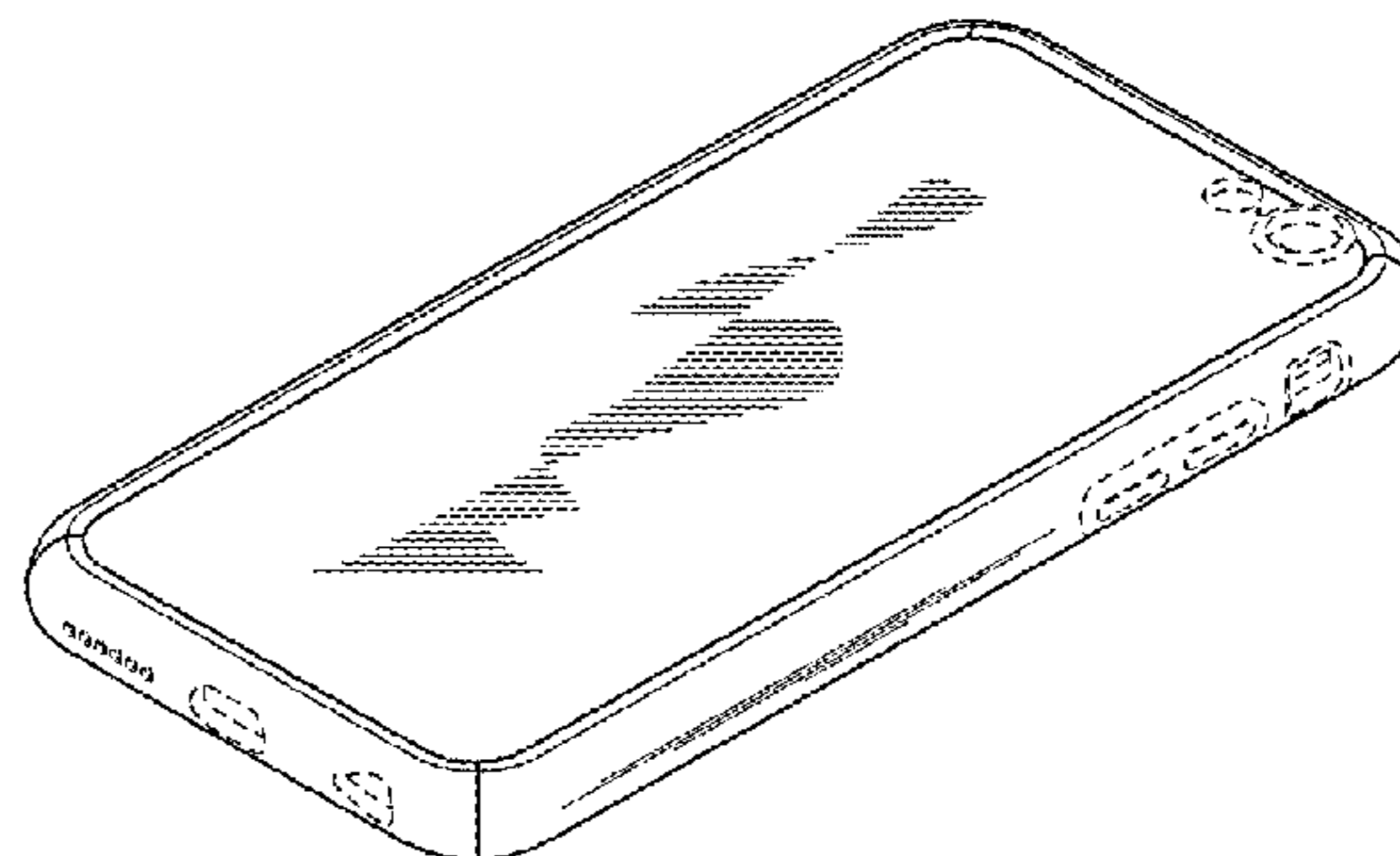
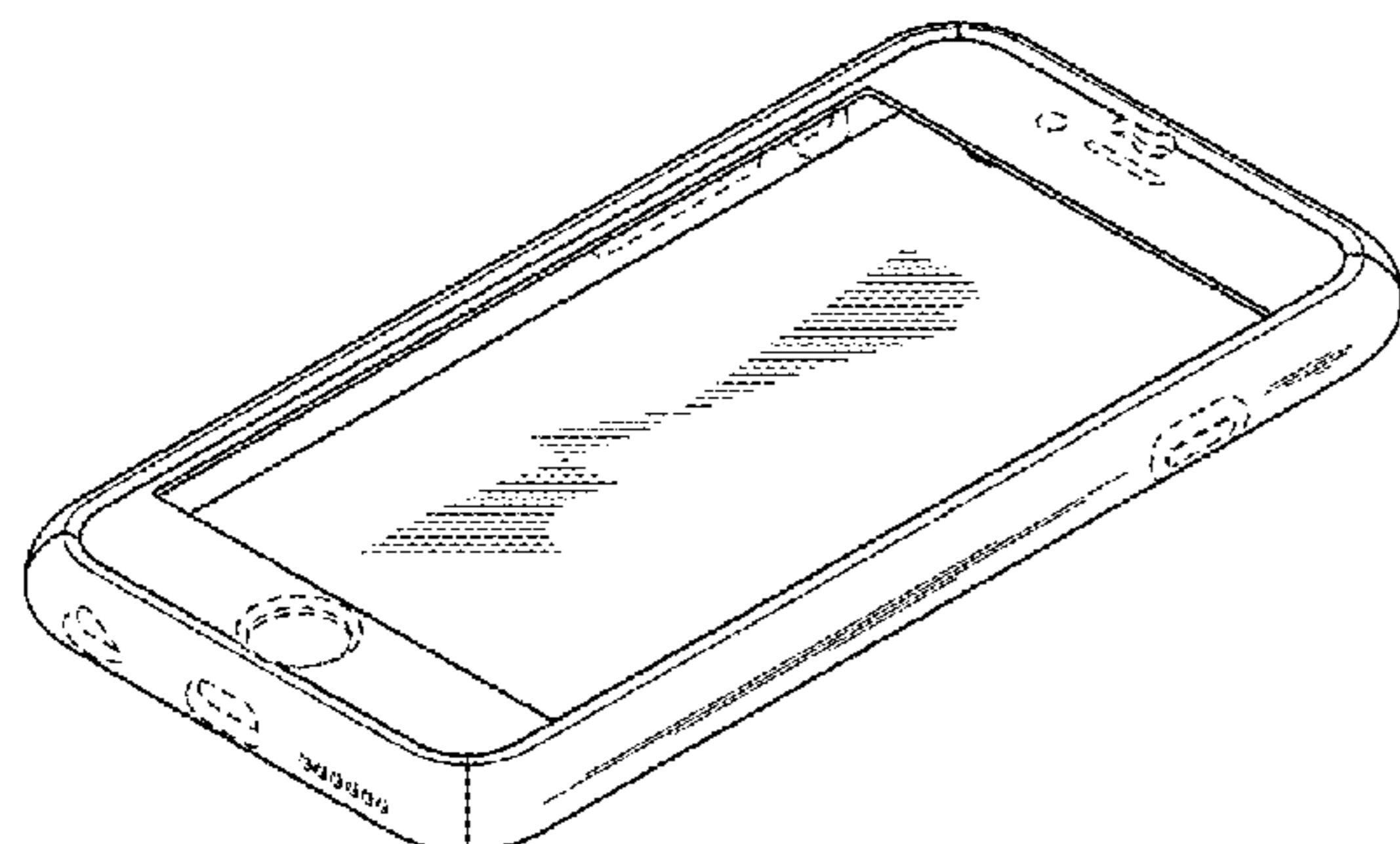


FIG. 30 is a cross-sectional view thereof, taken along line 30-30 of FIG. 22;

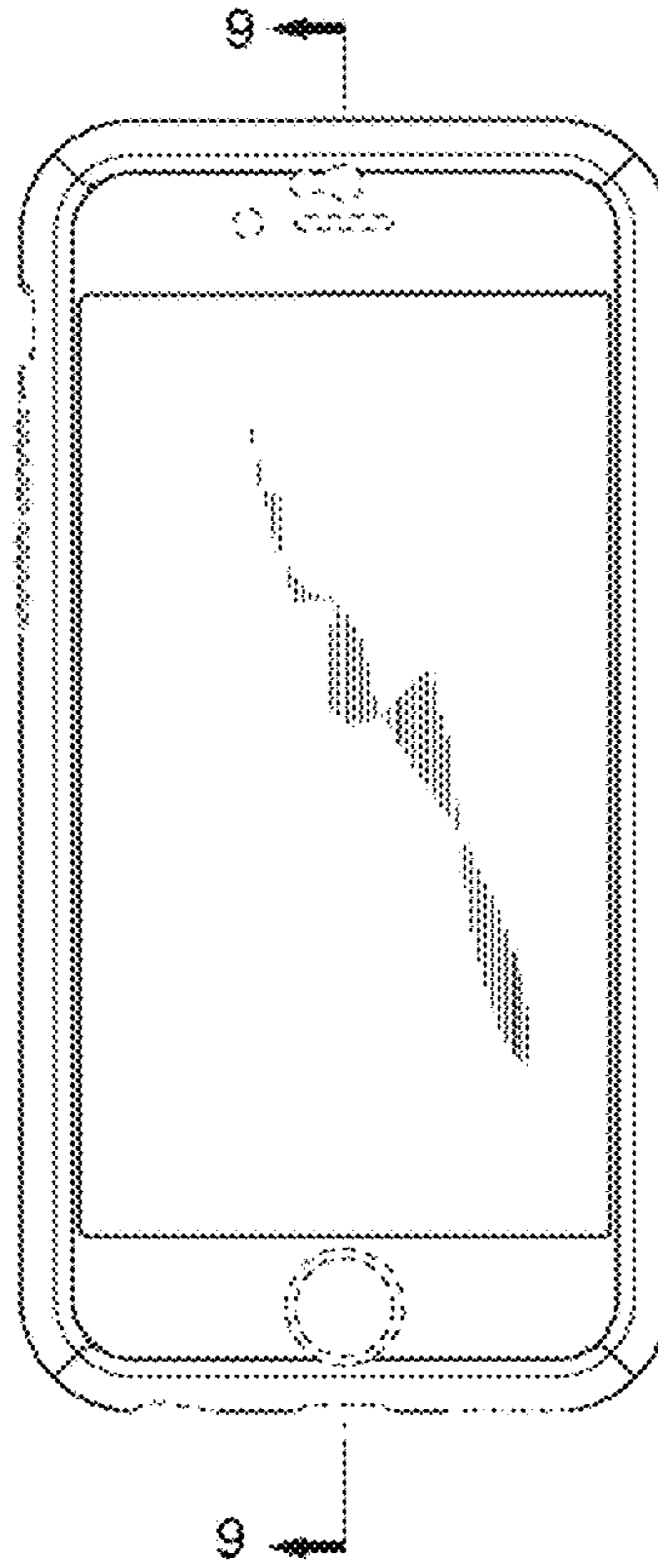

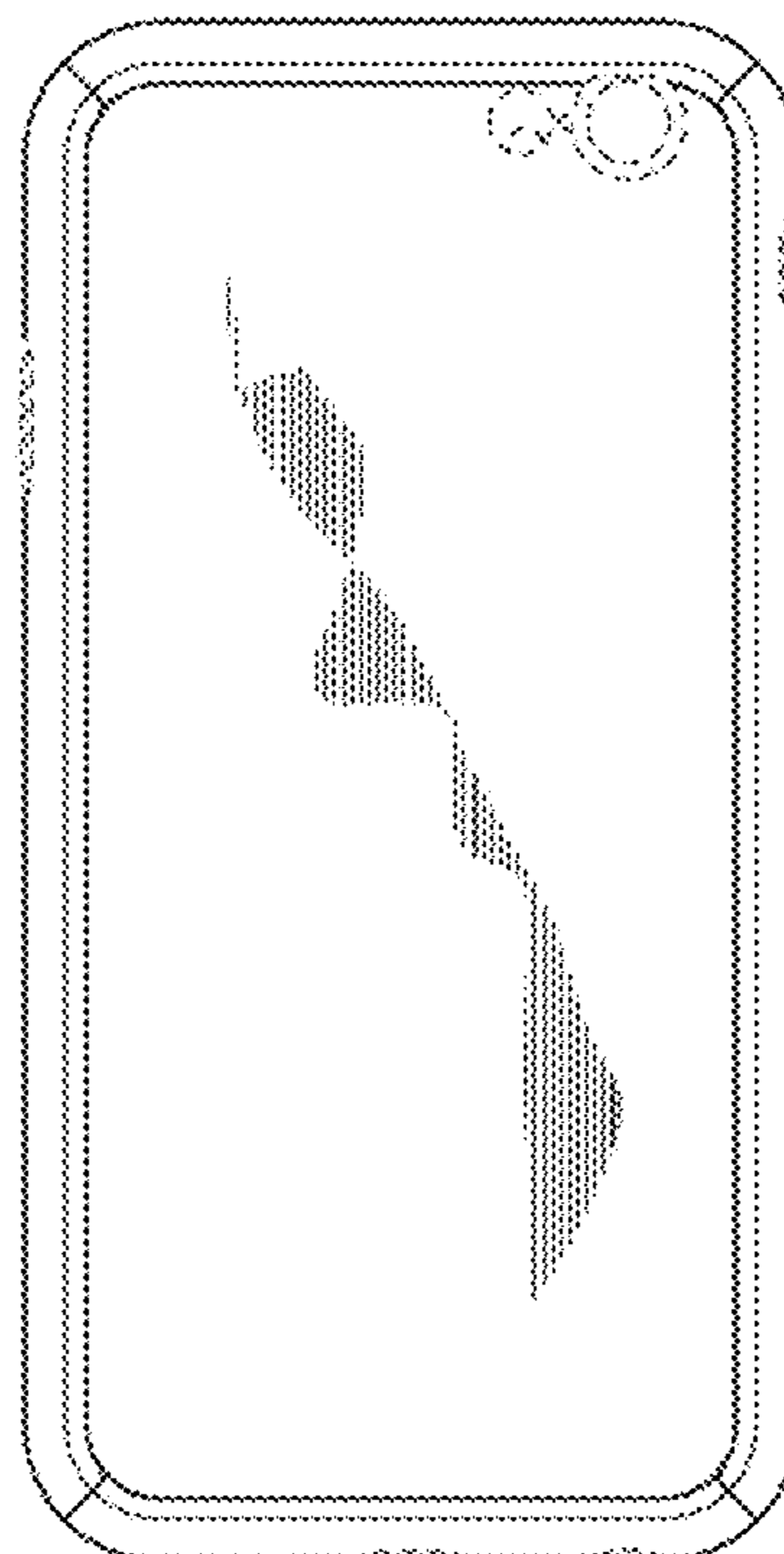

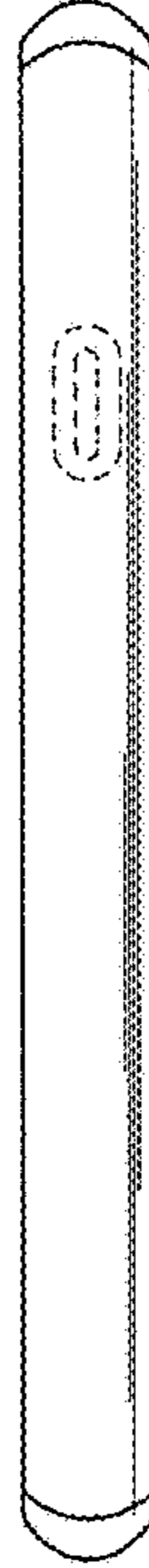

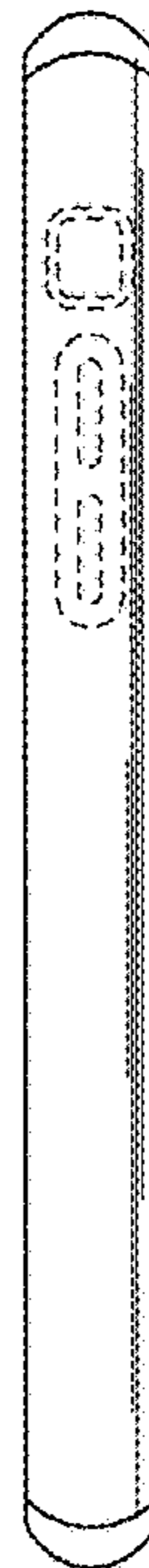

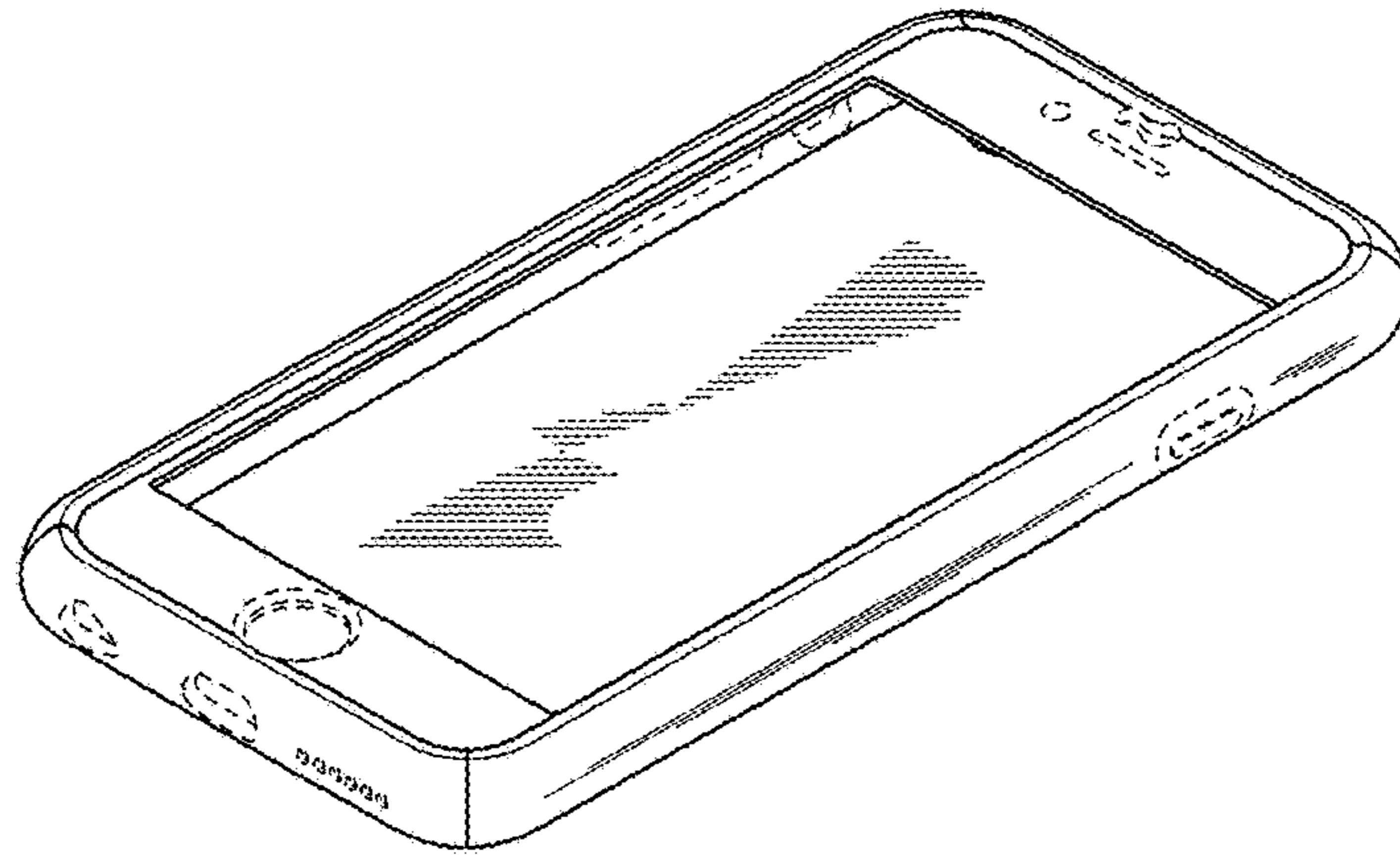

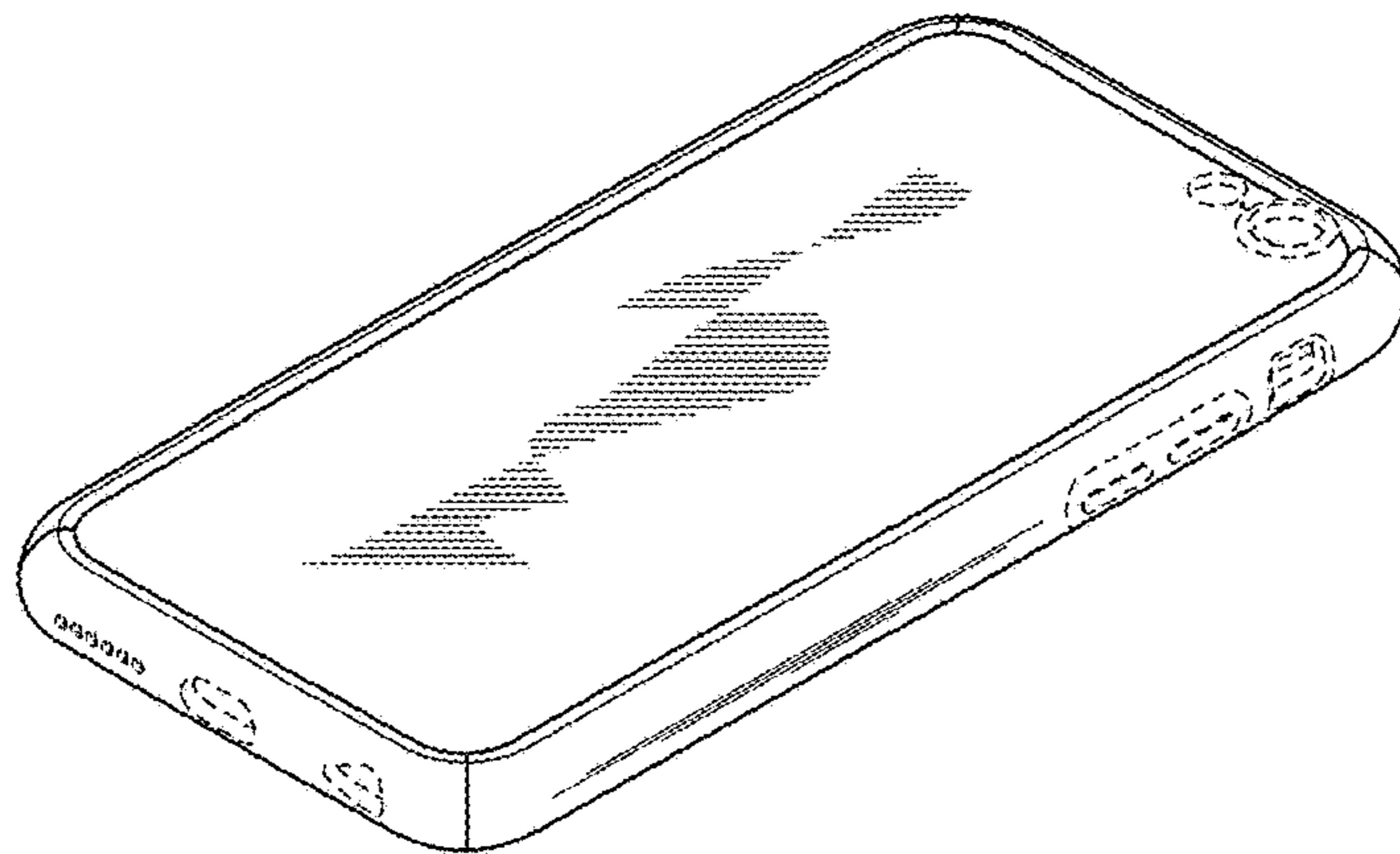

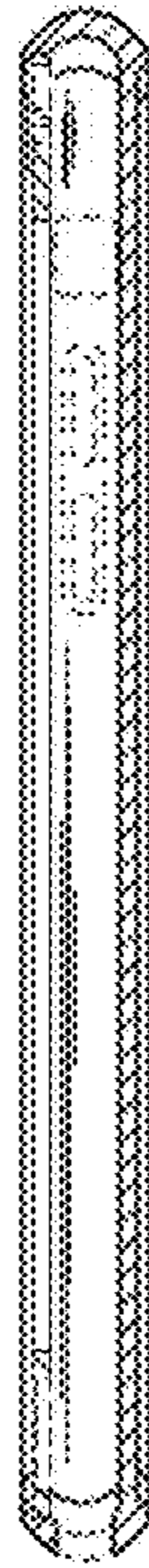

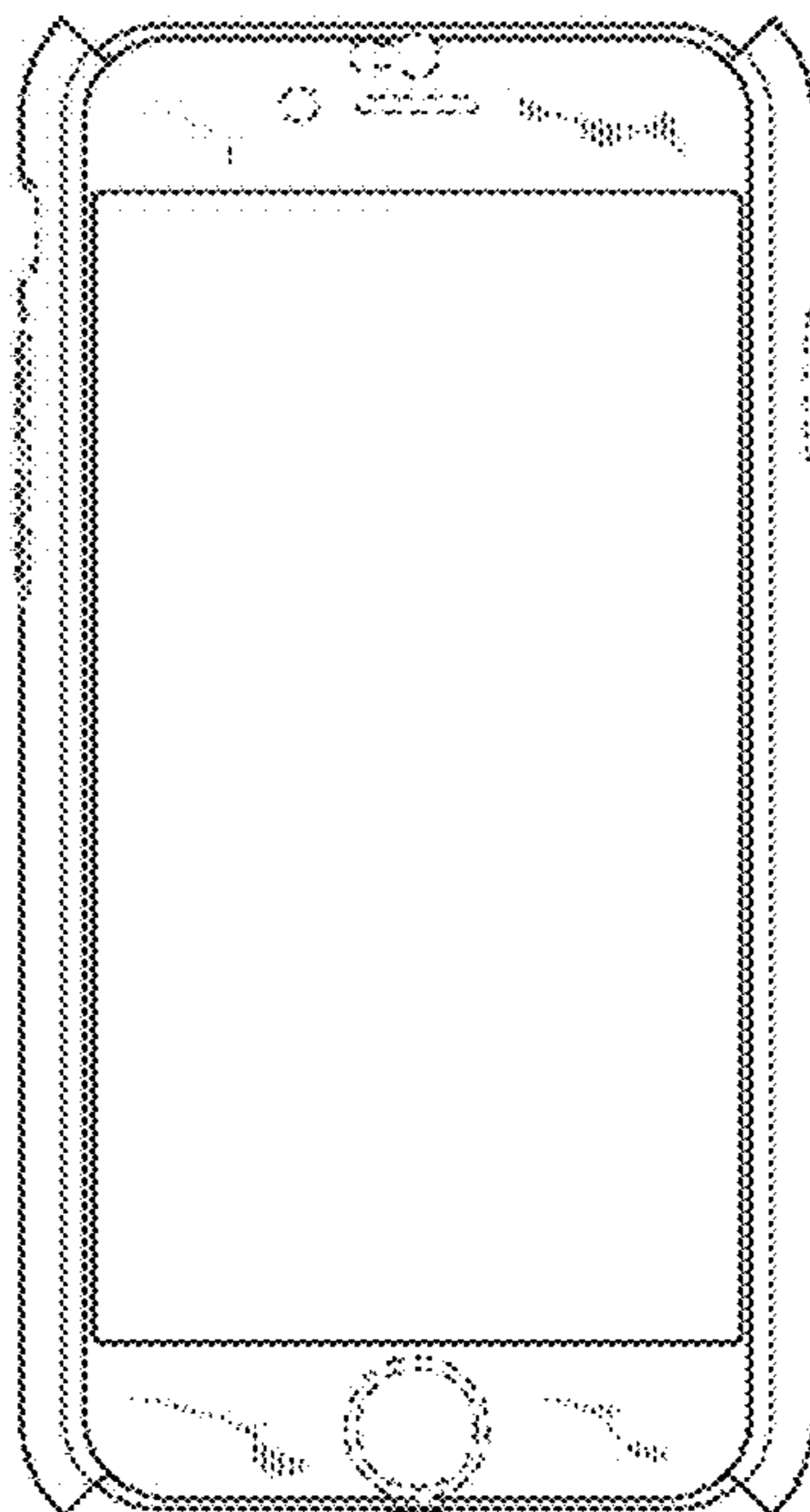

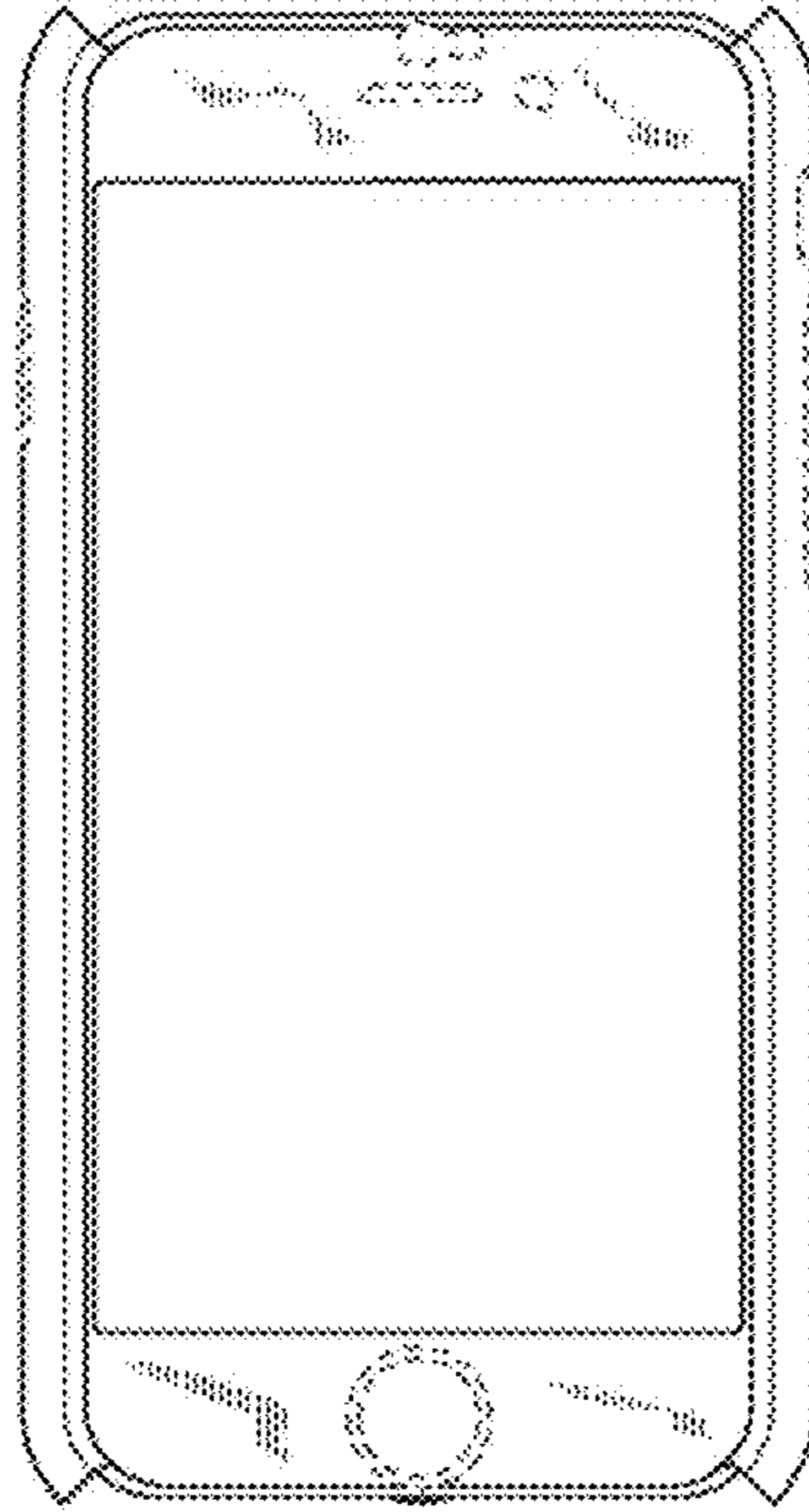

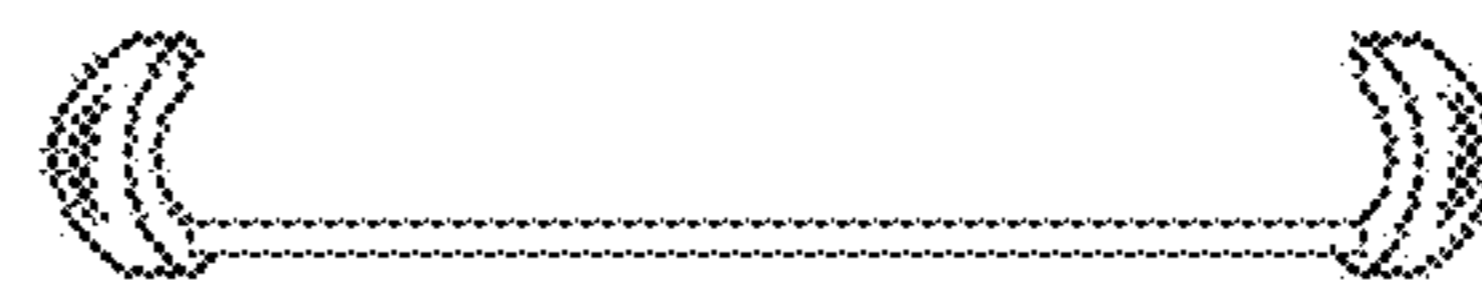

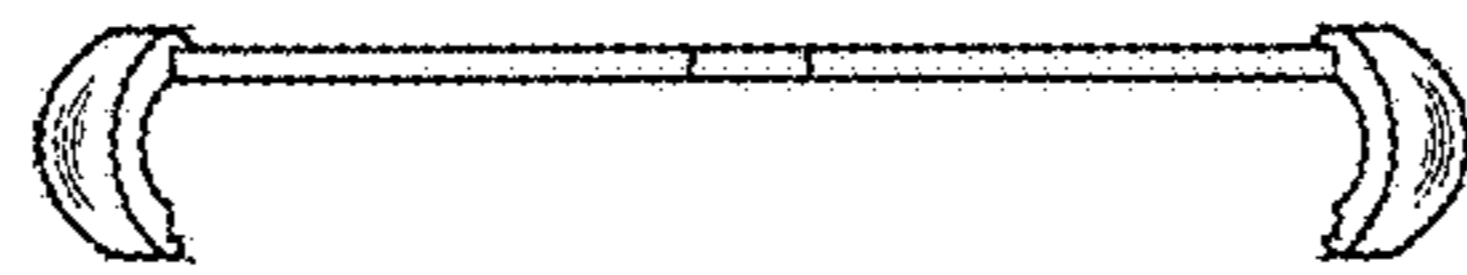

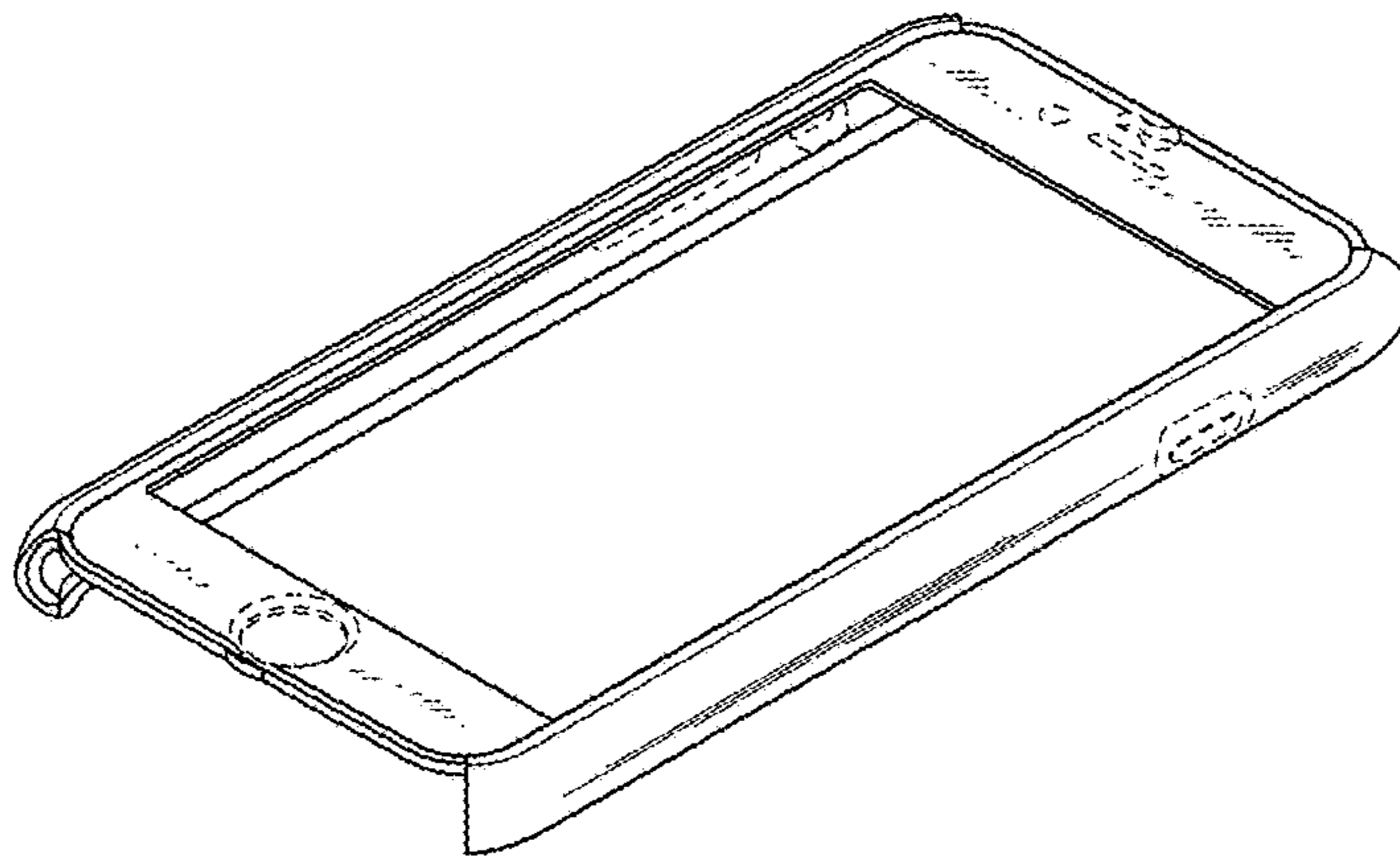

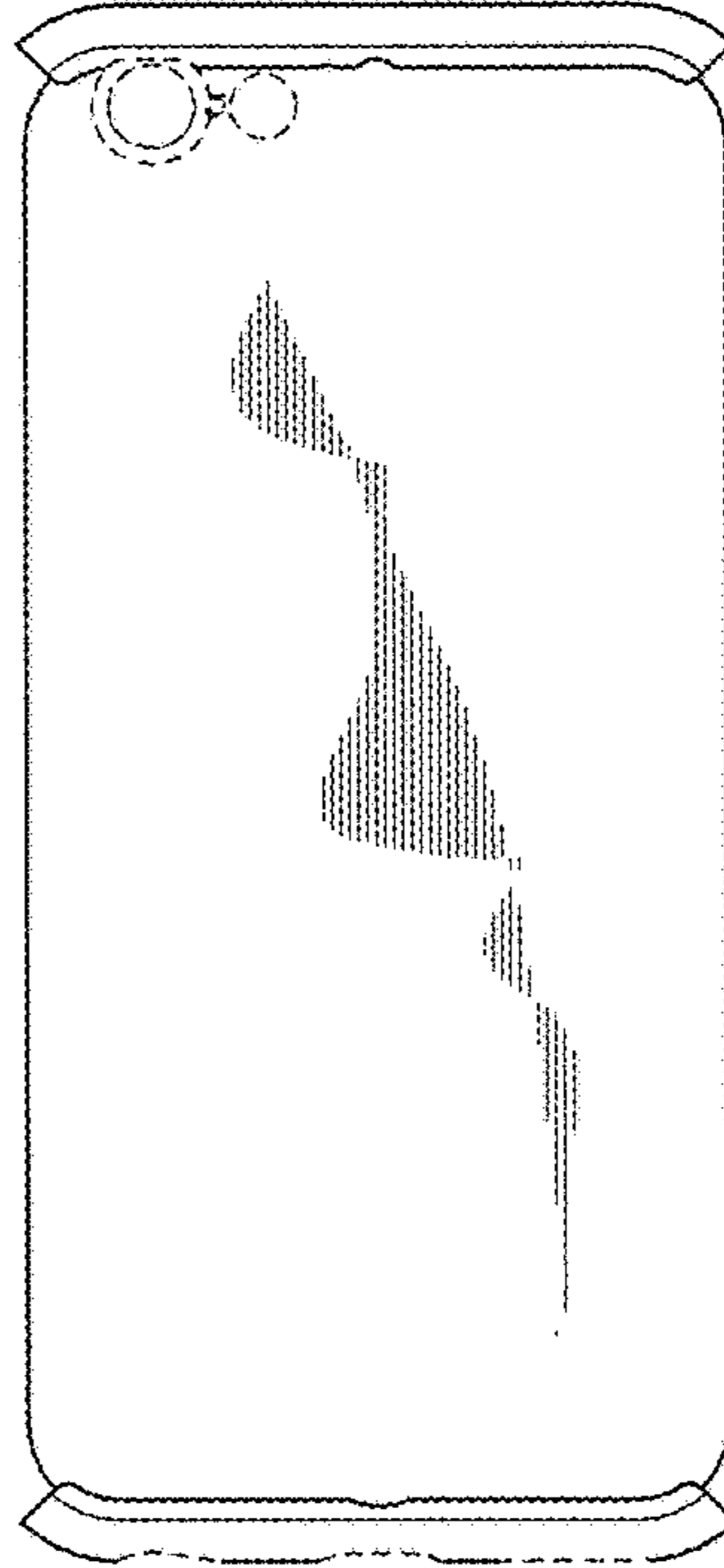

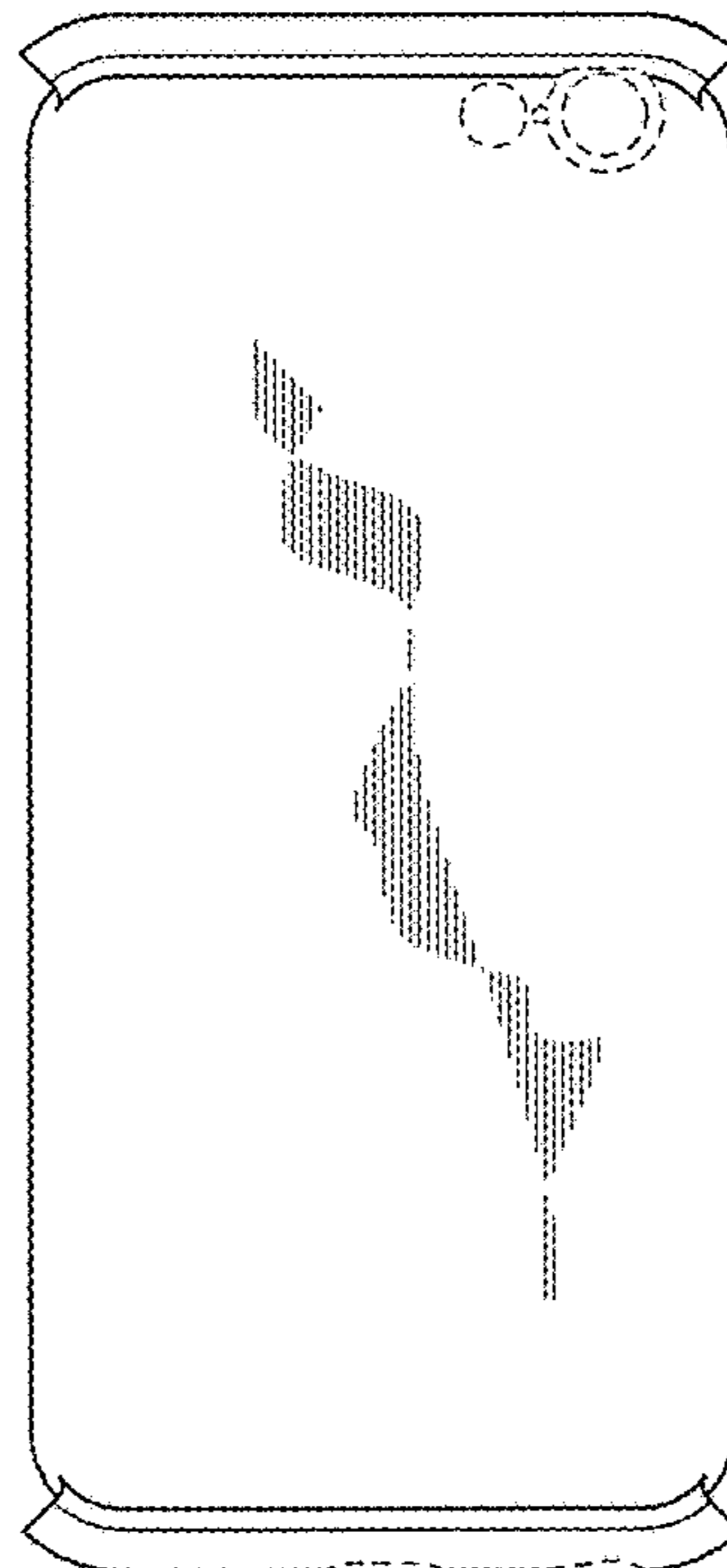

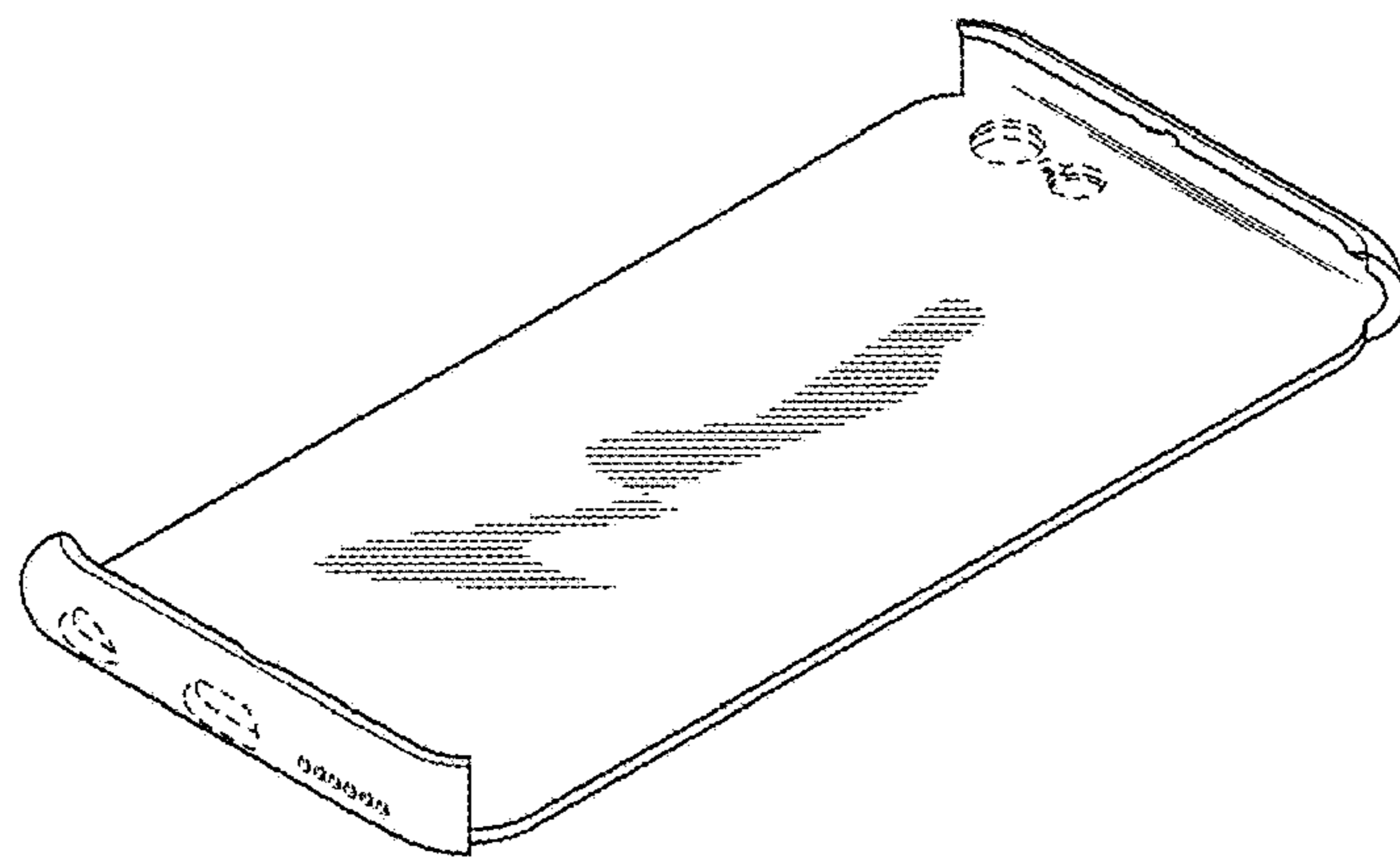

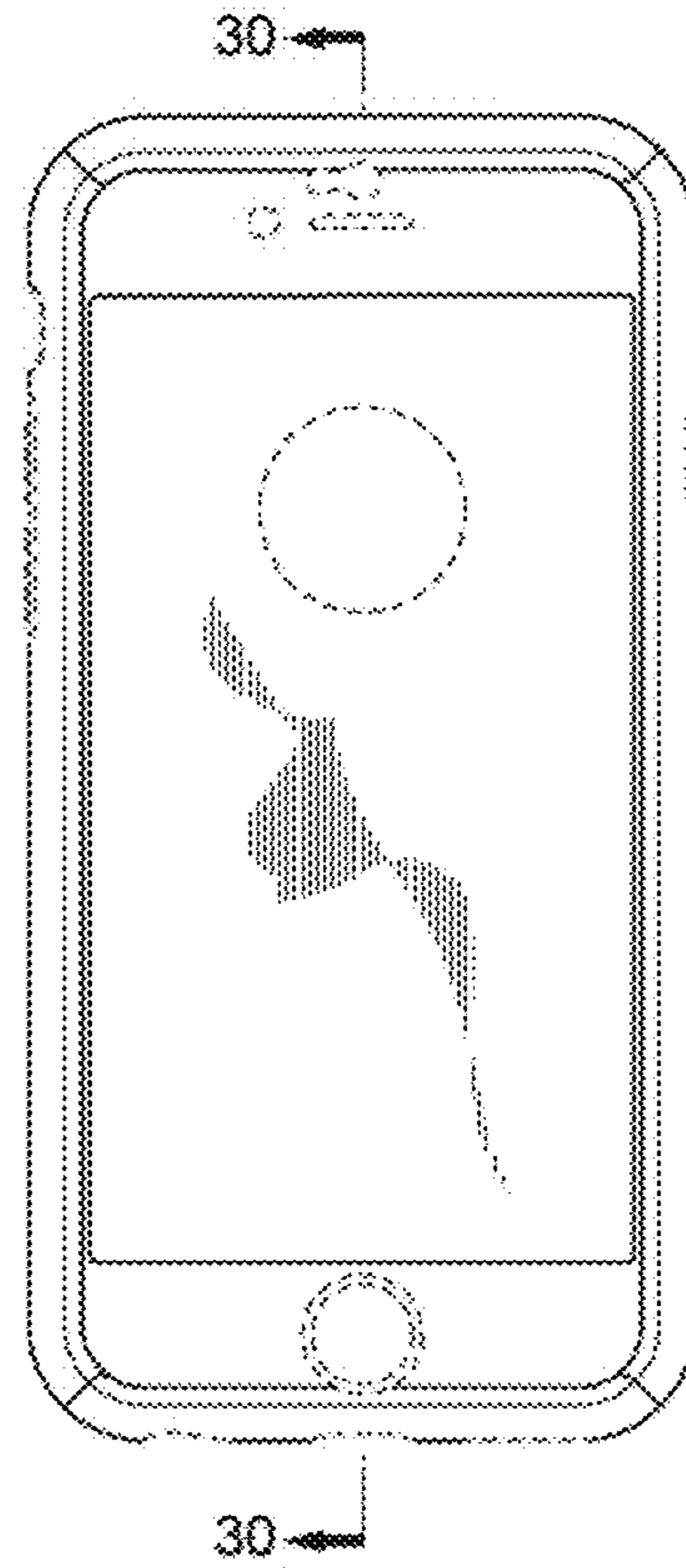

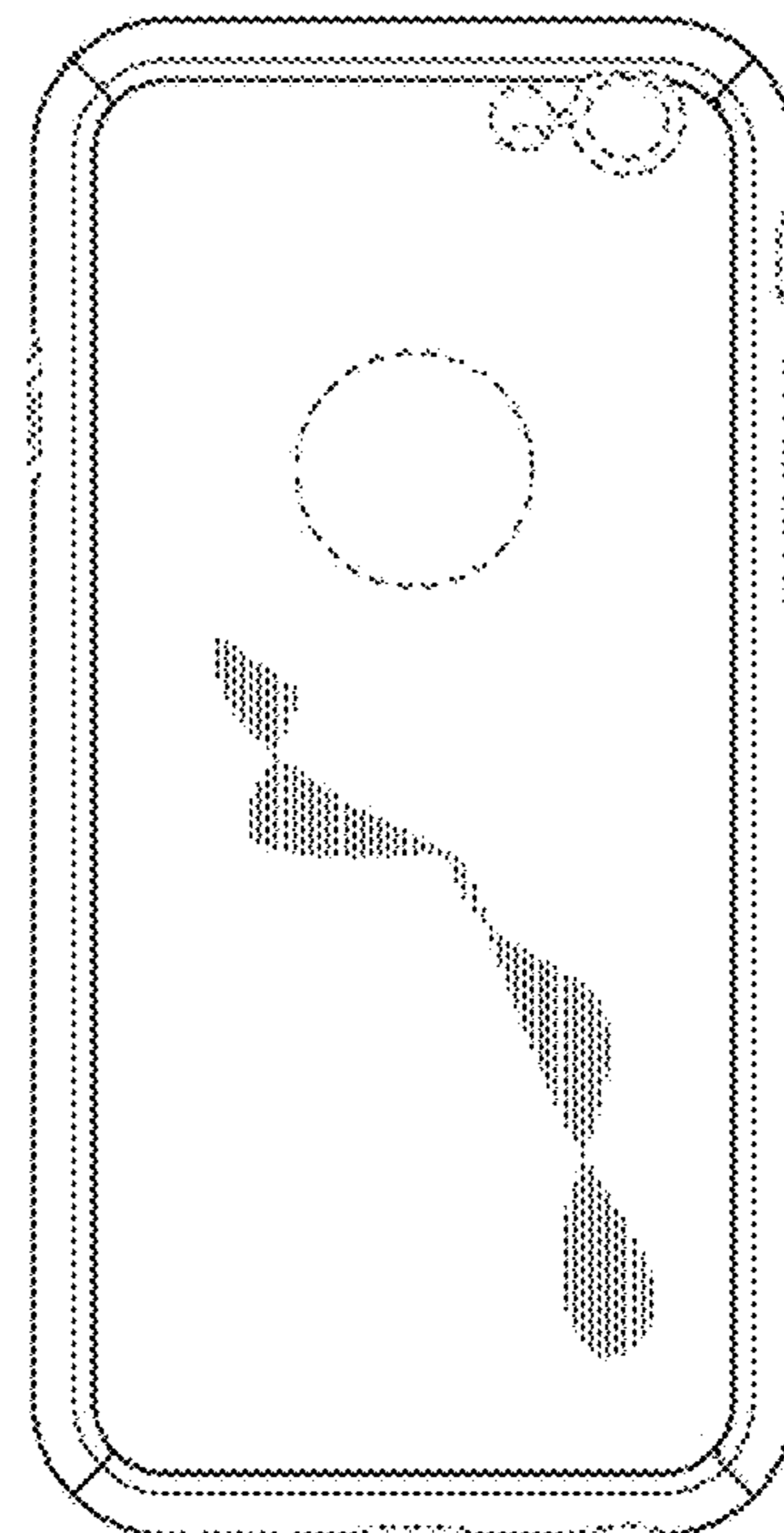

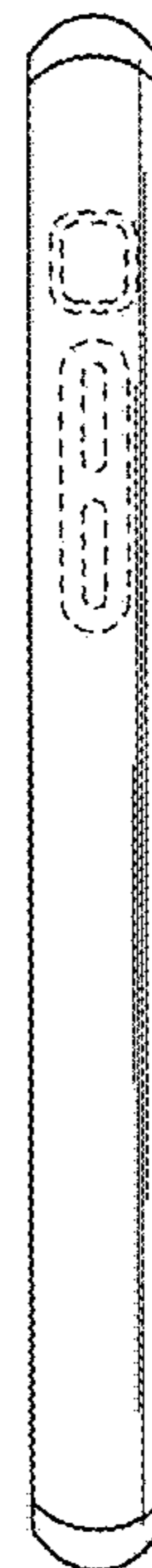

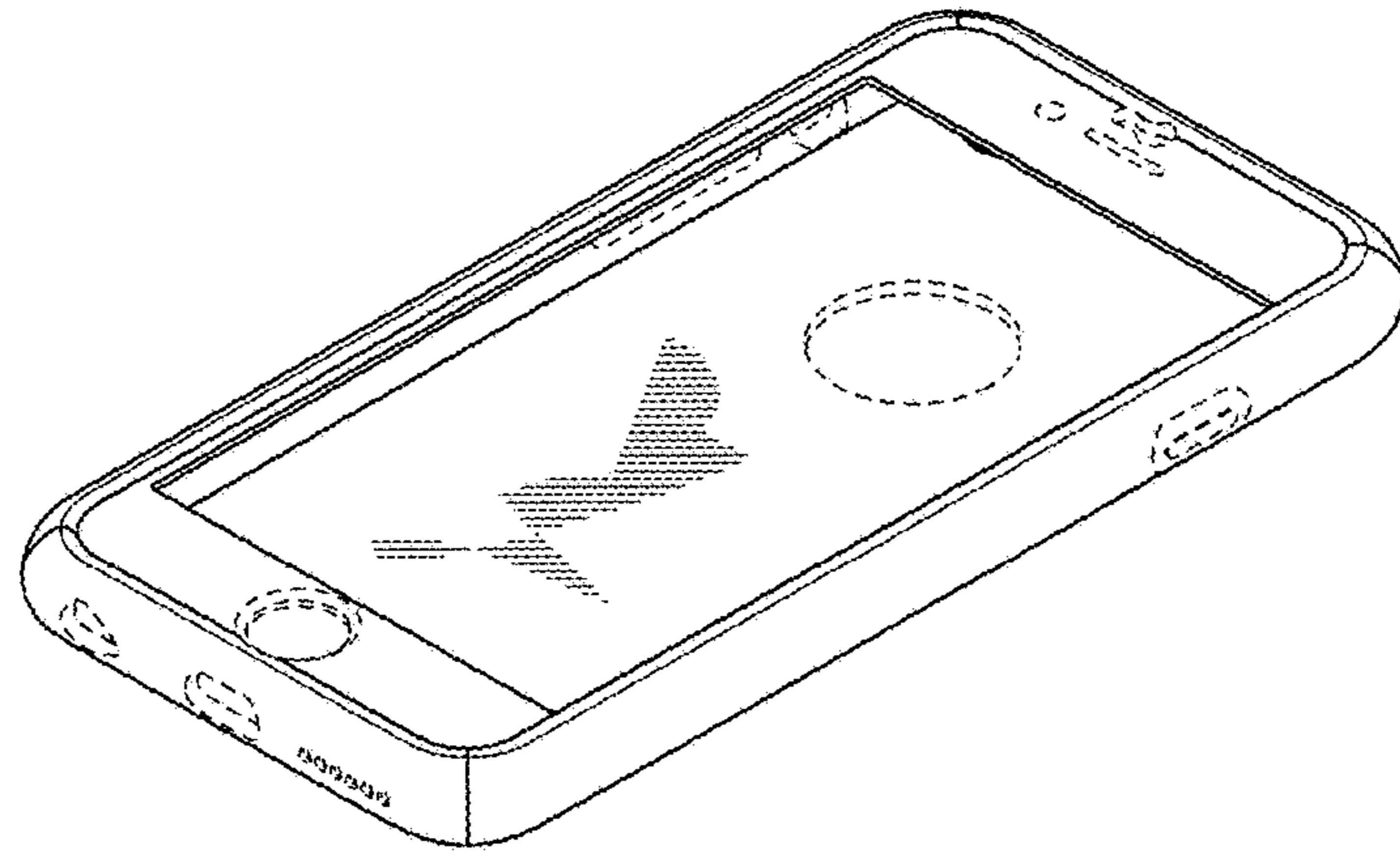

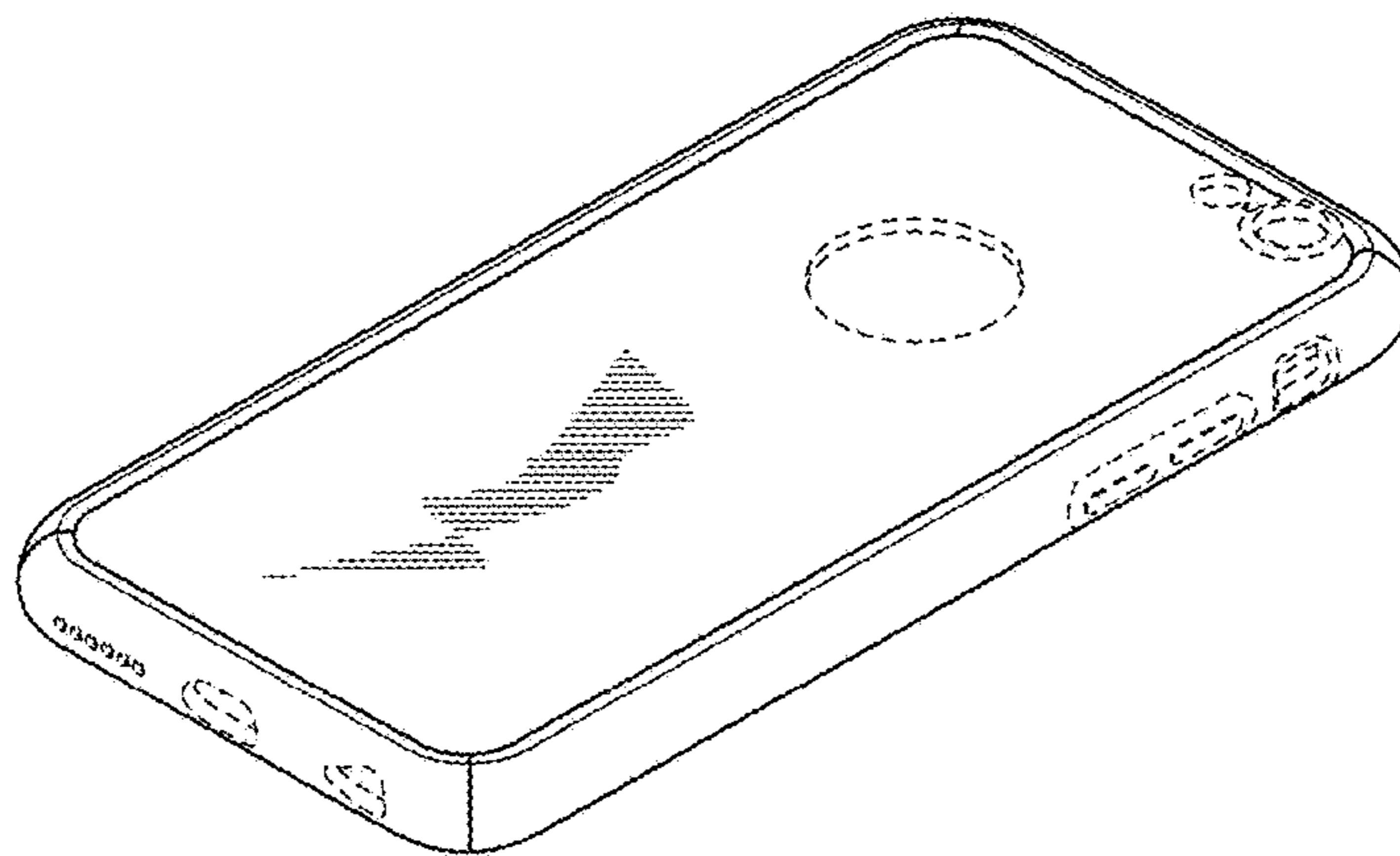

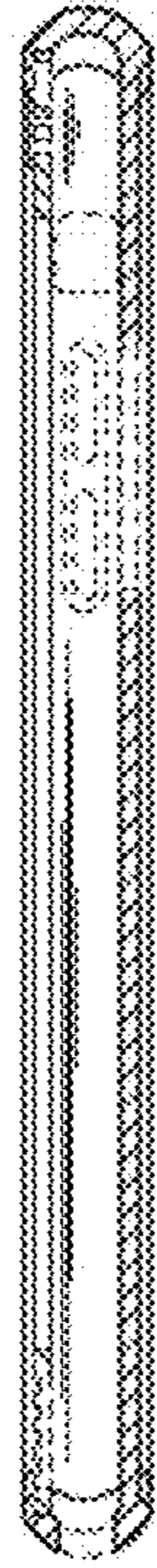

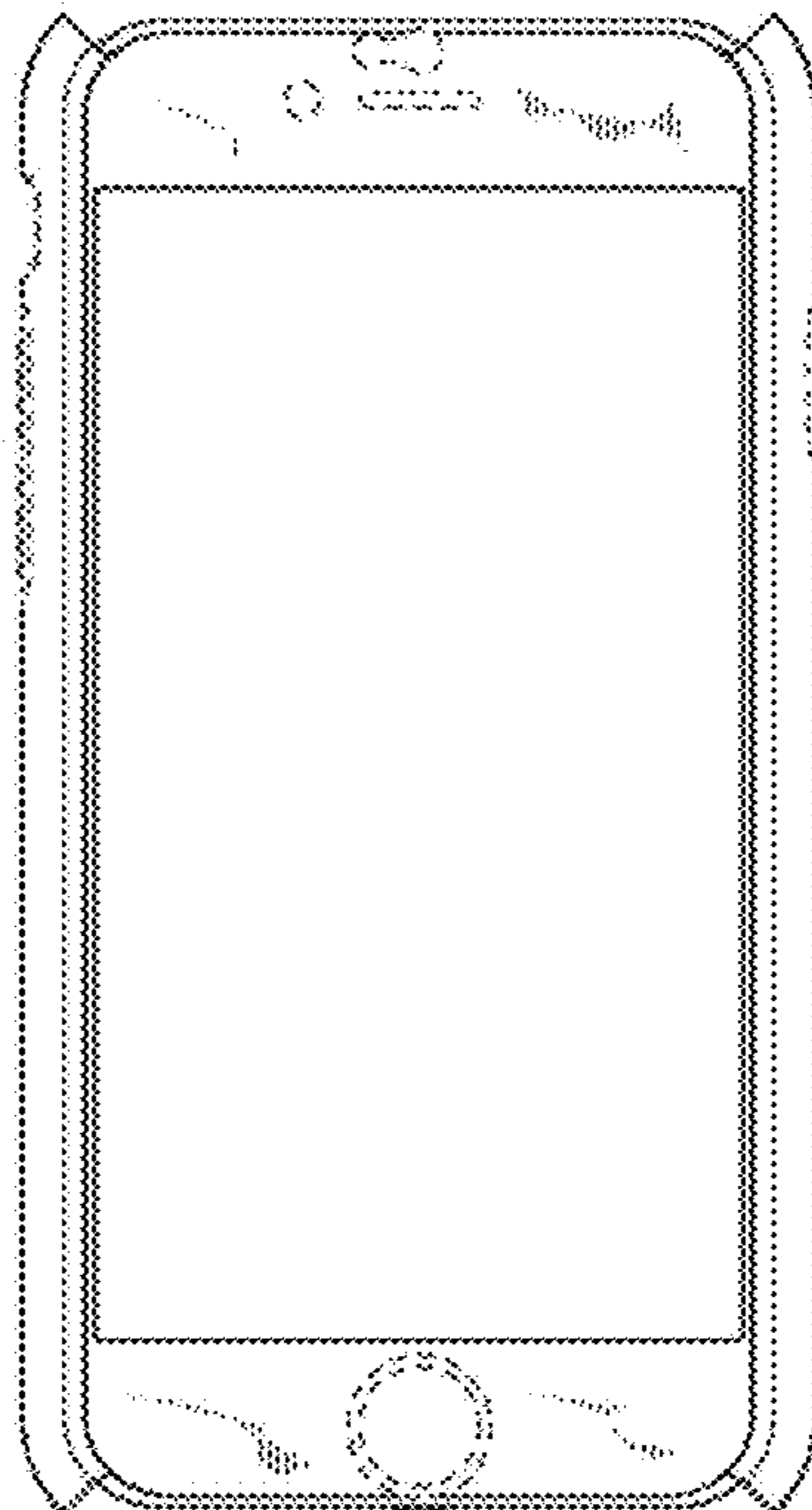

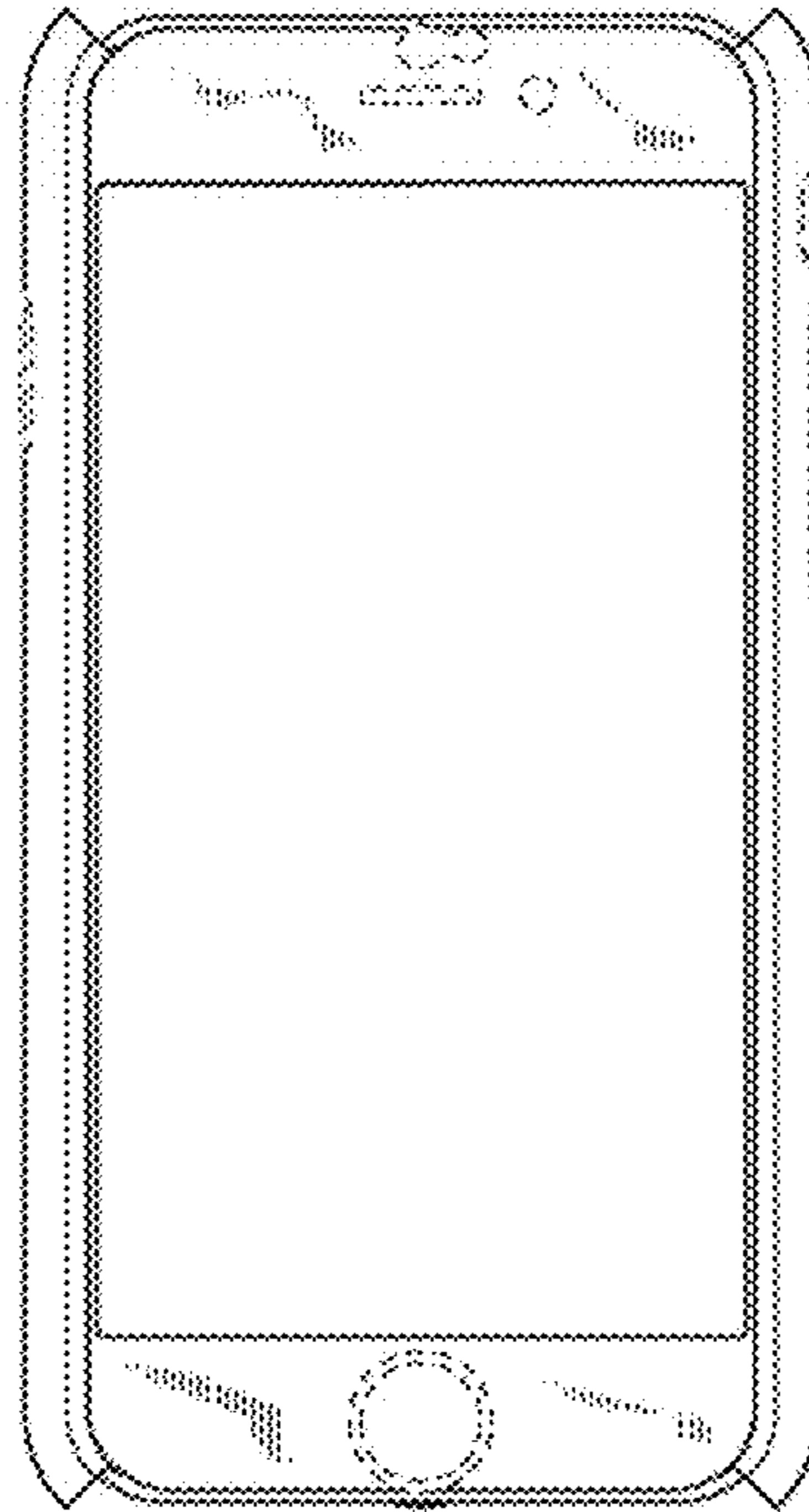

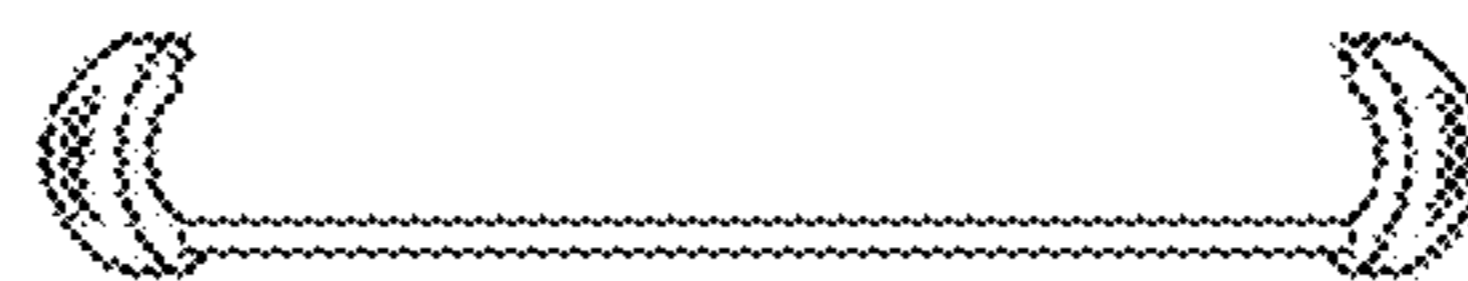

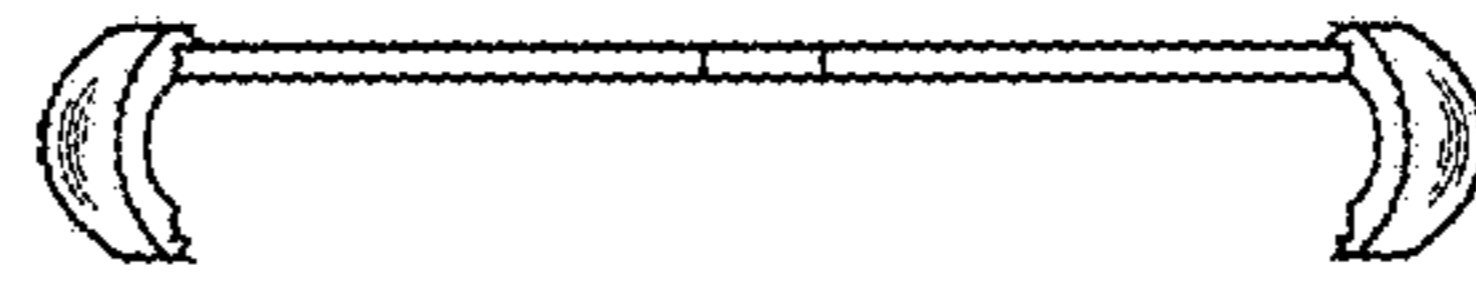

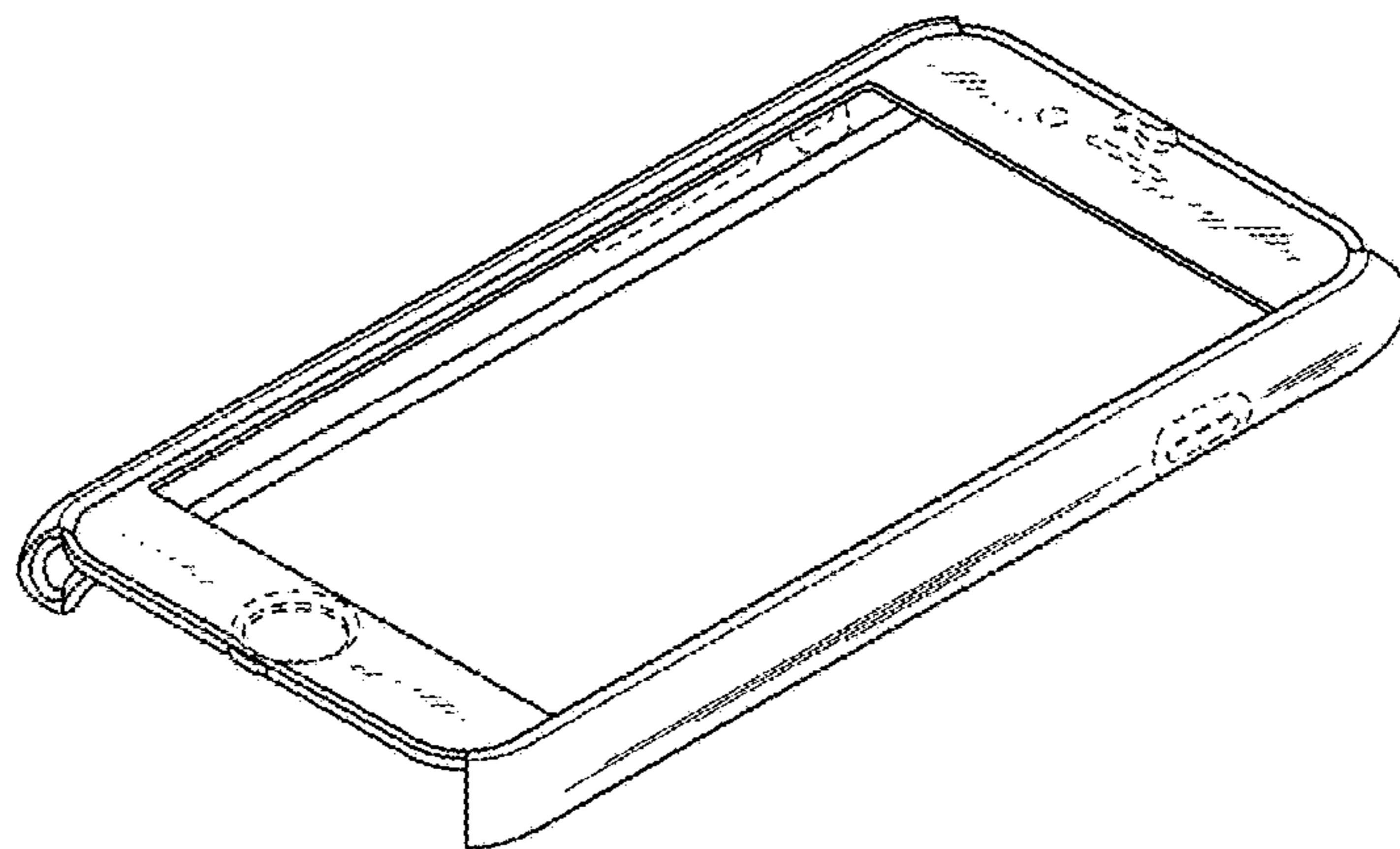

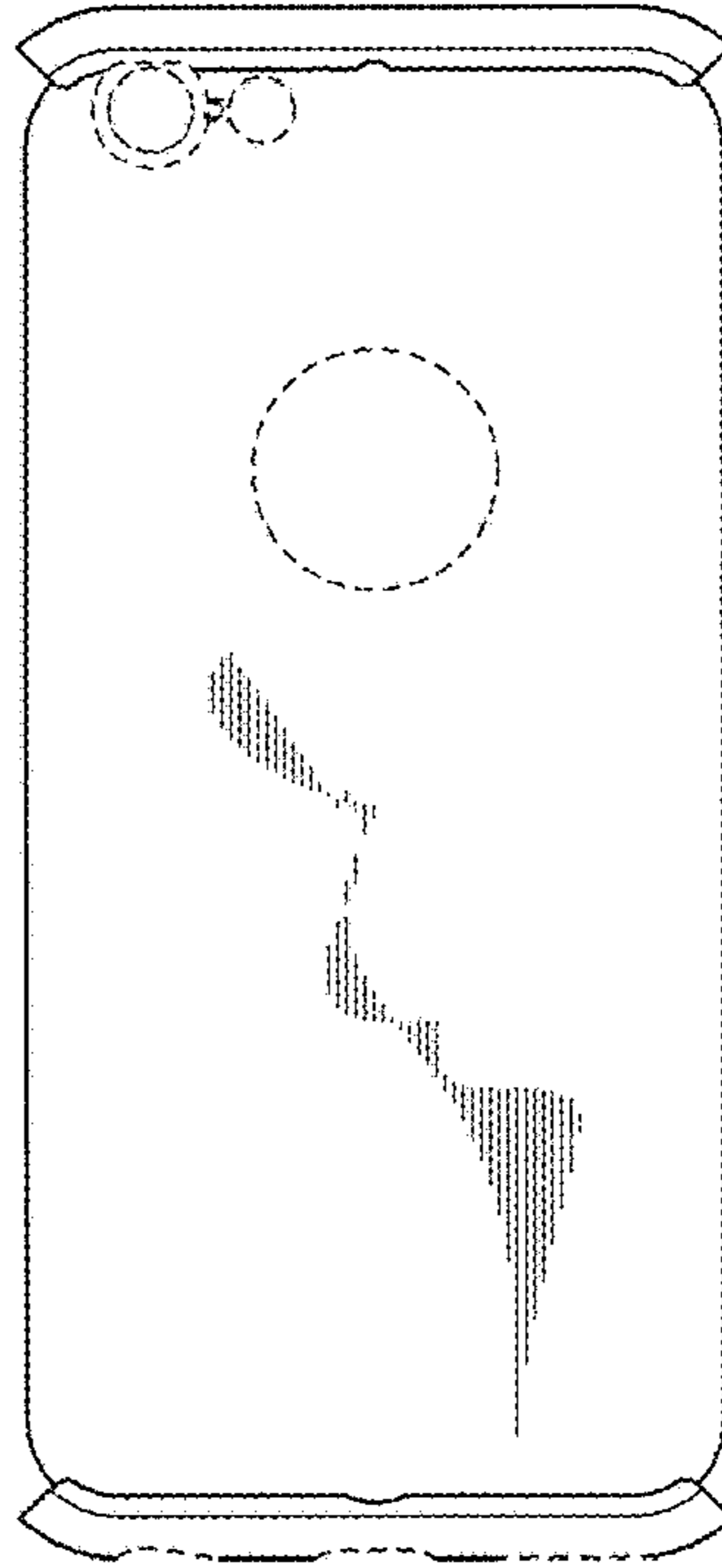

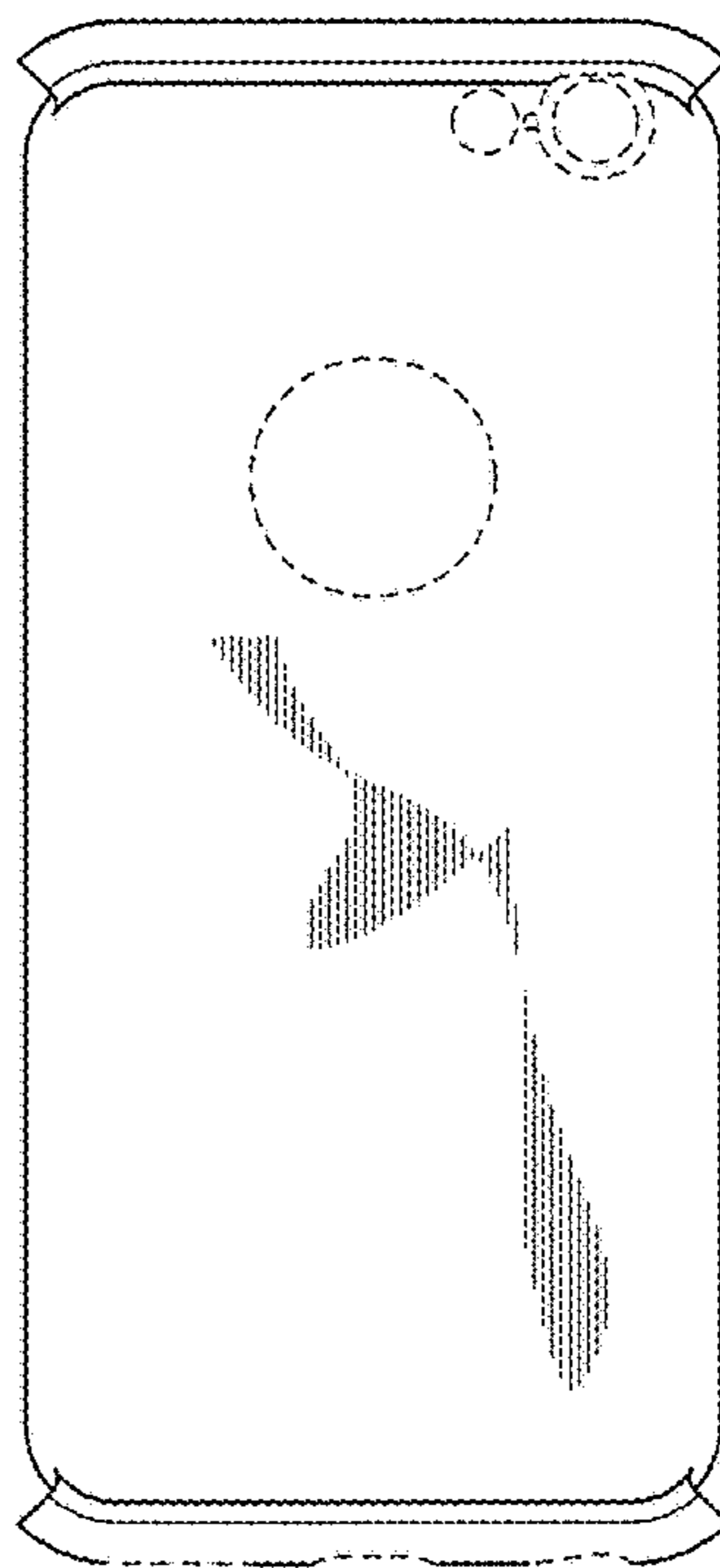

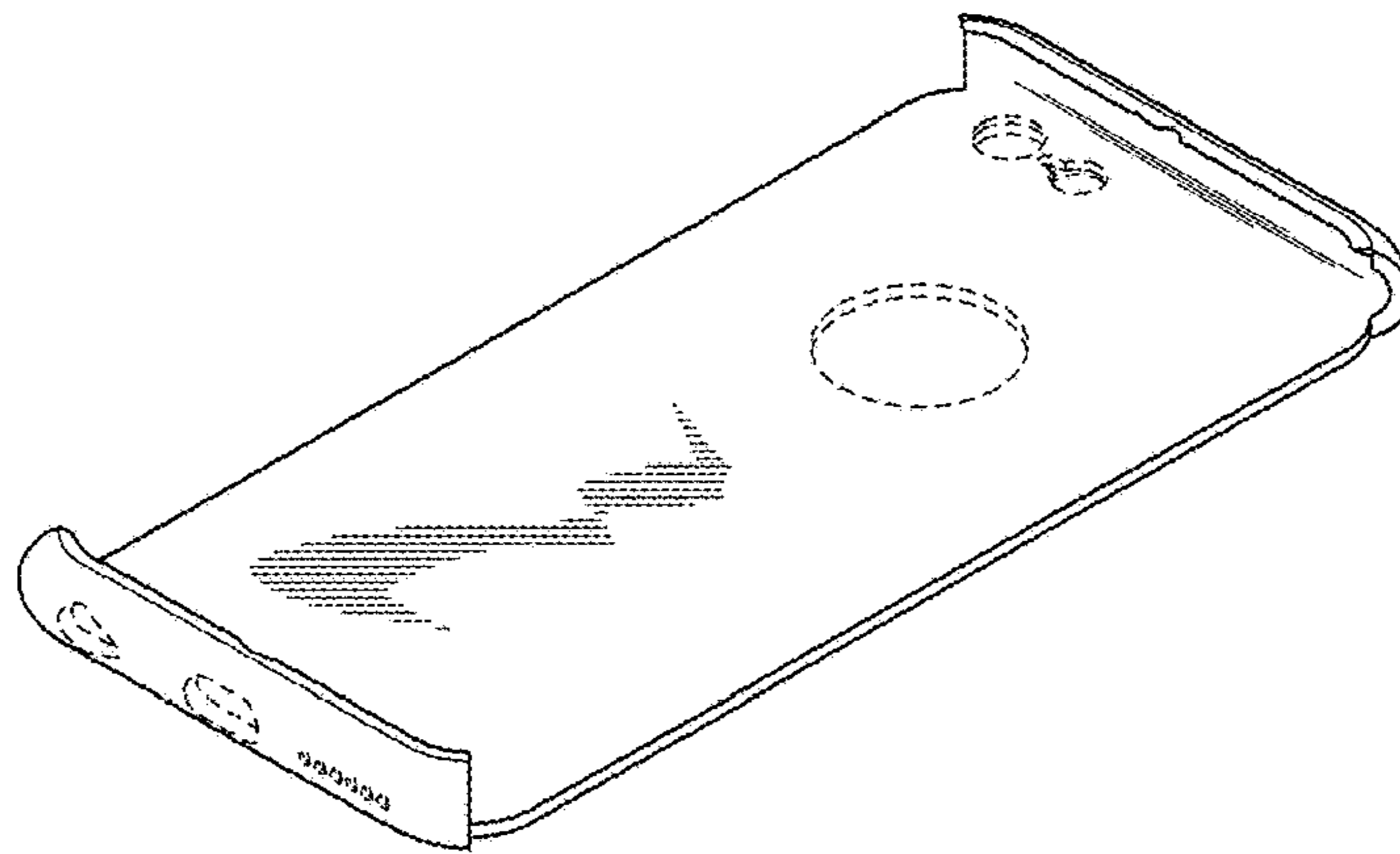

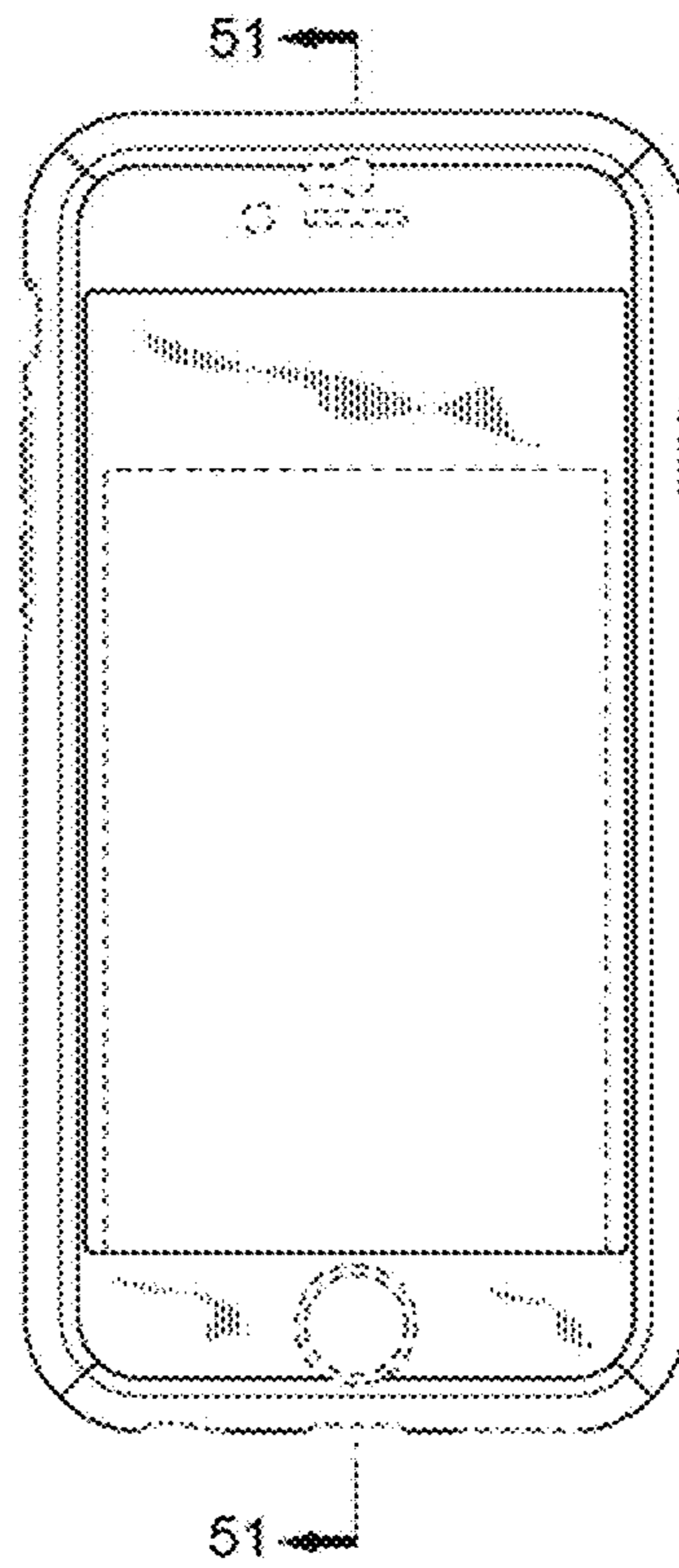

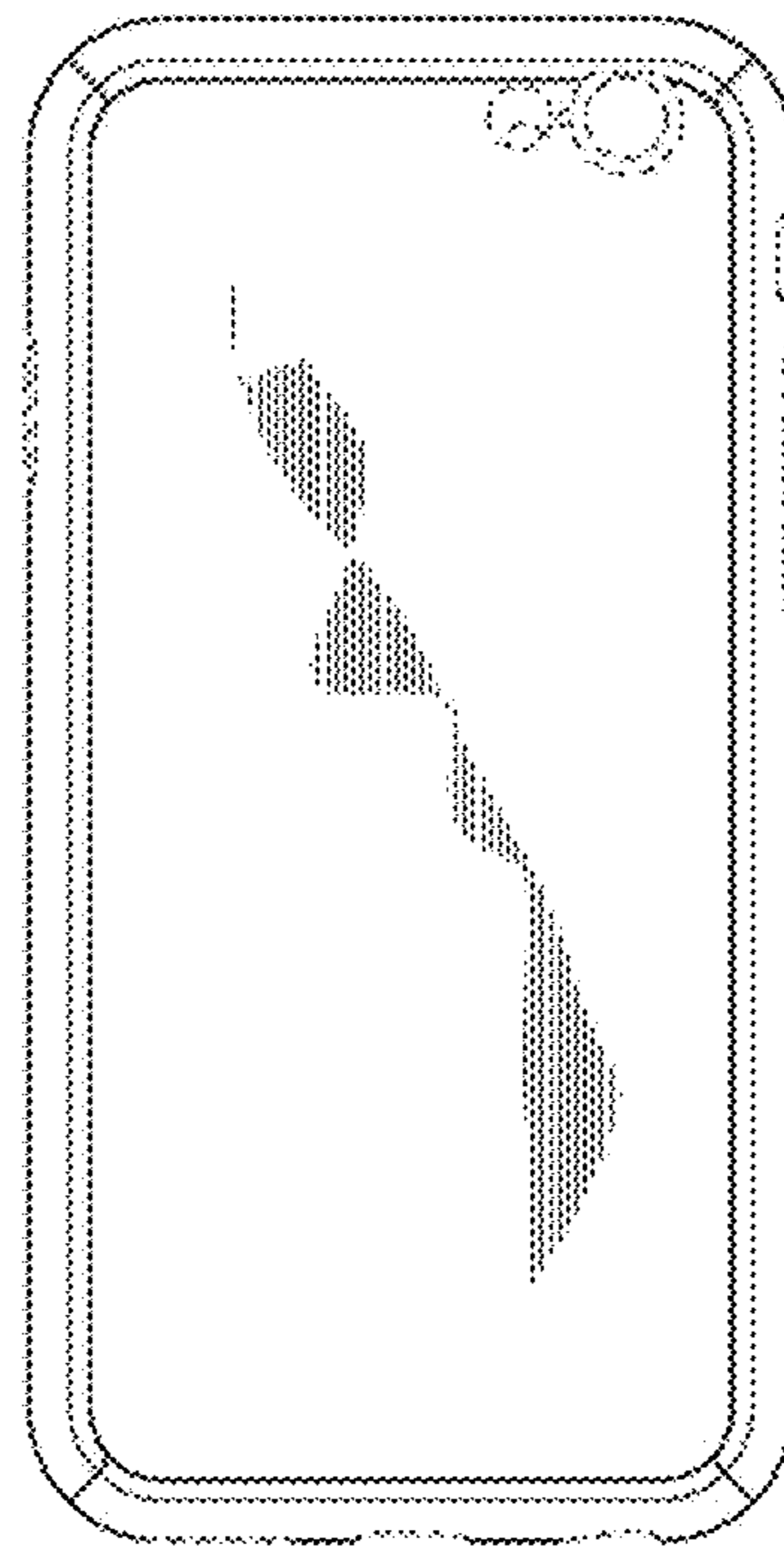

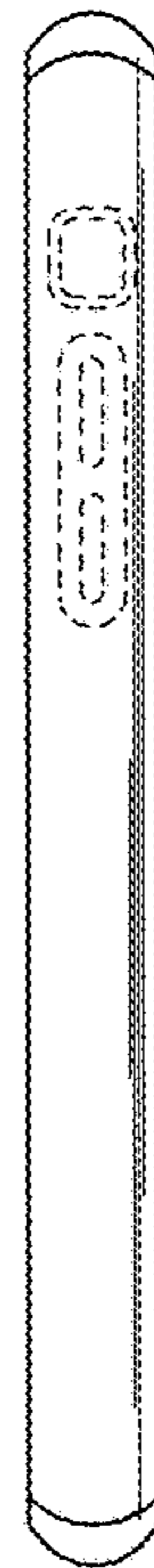

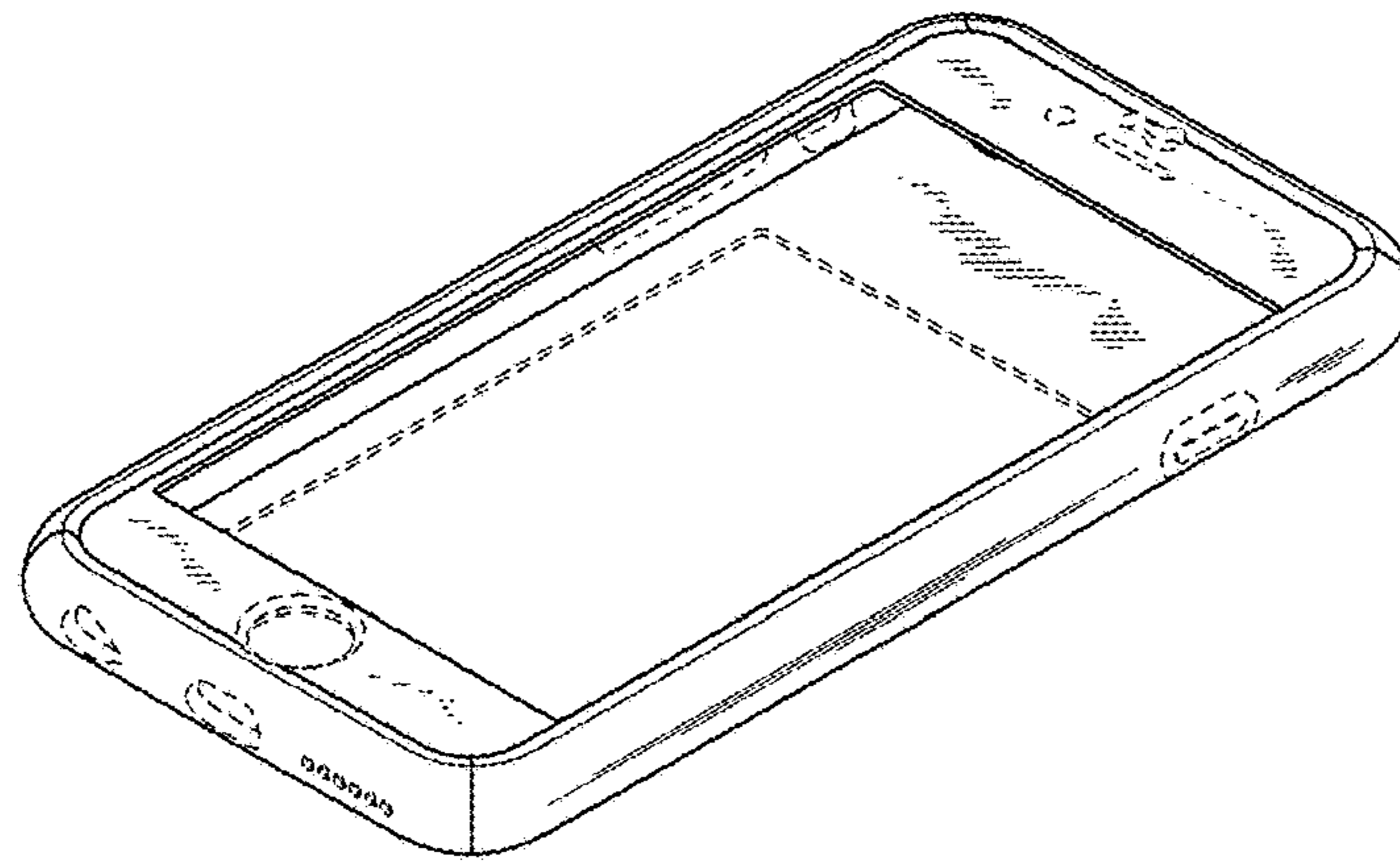

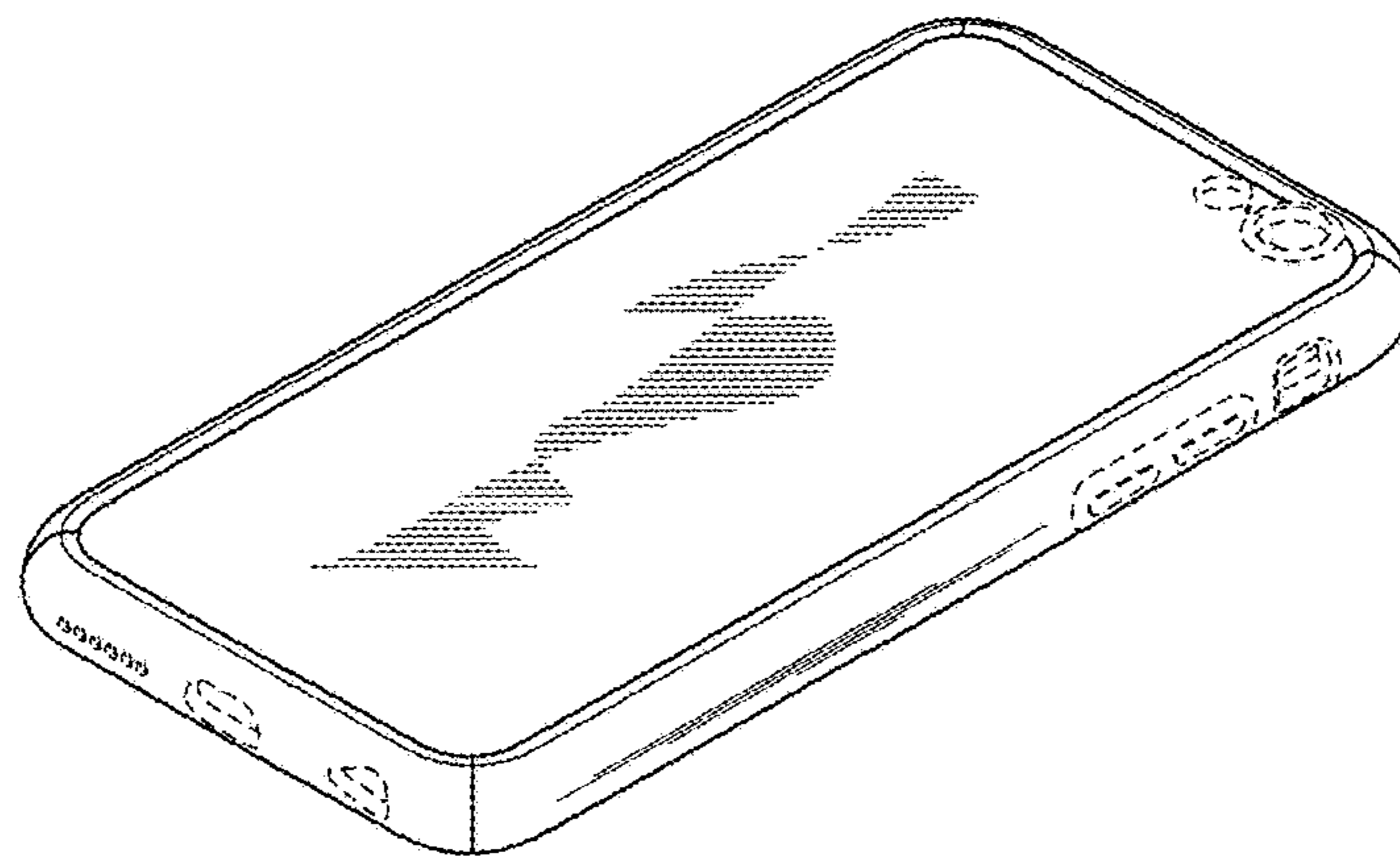

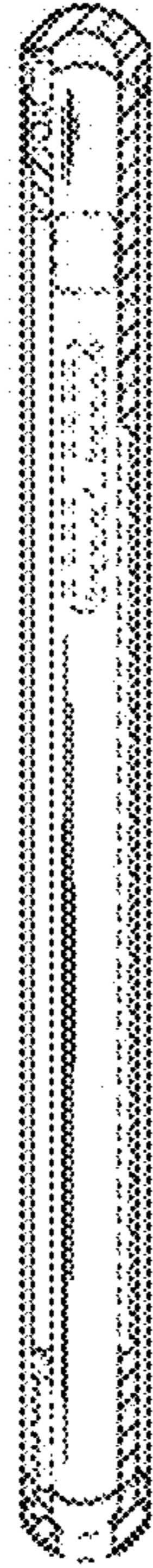

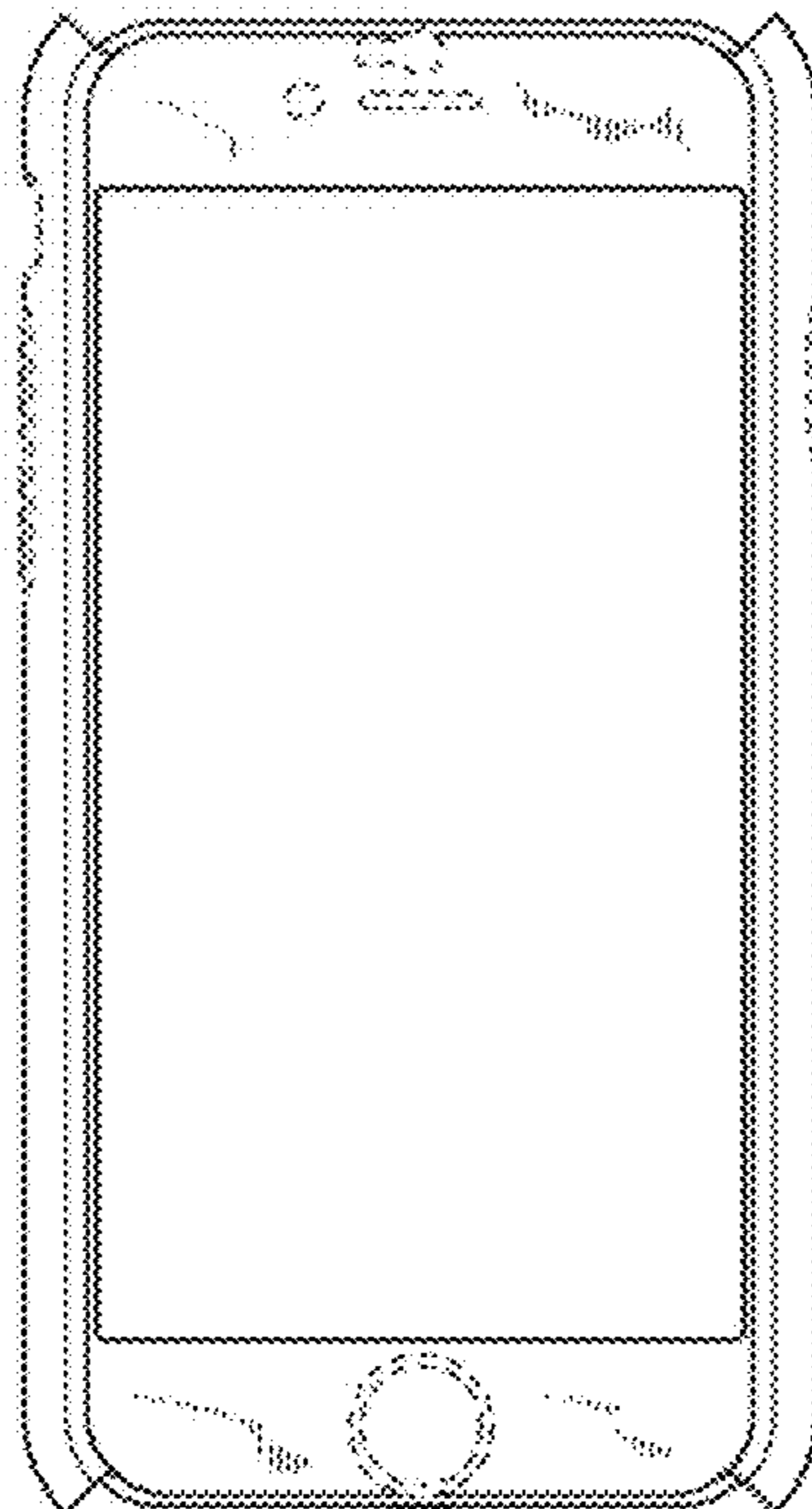

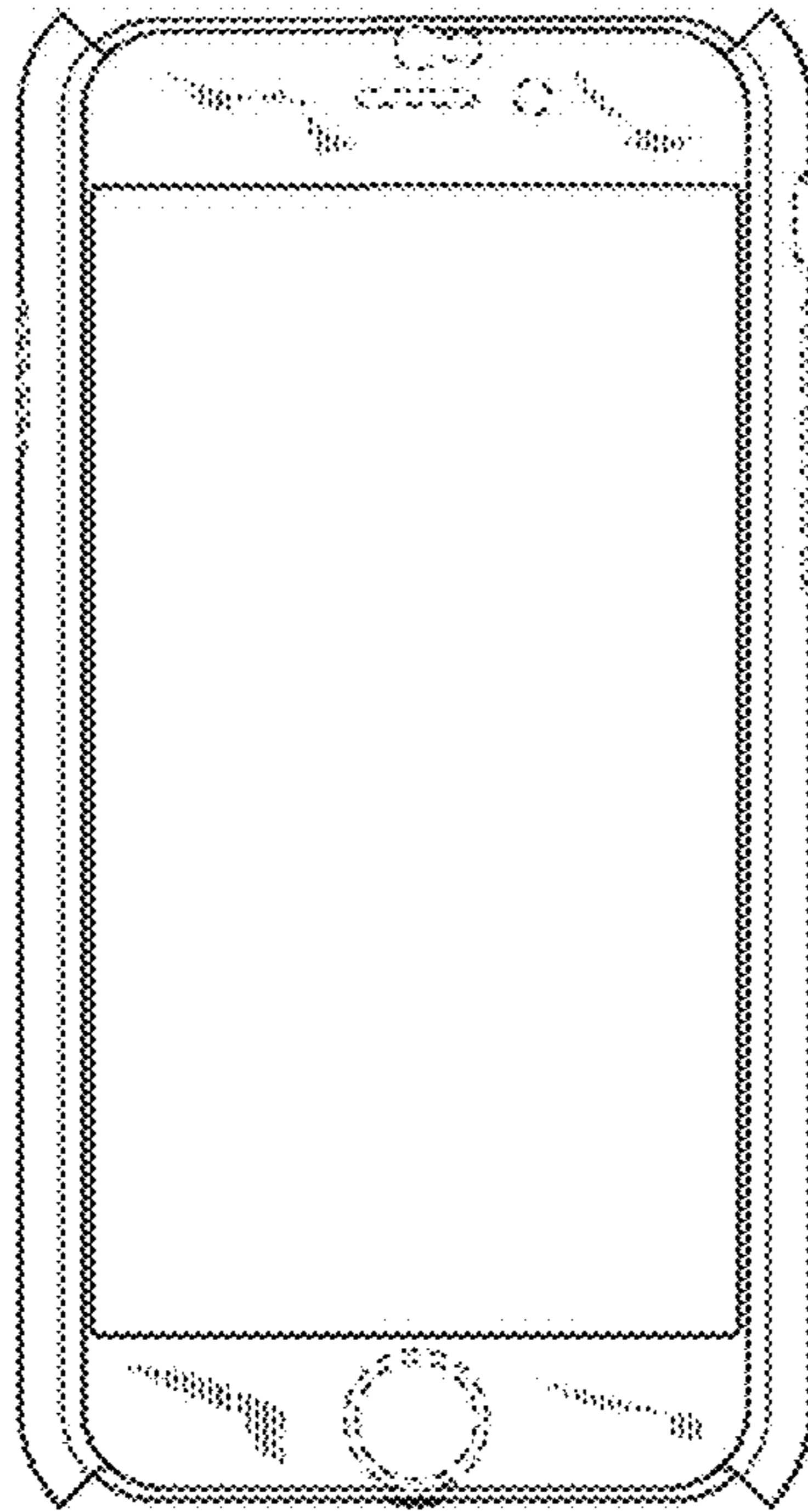

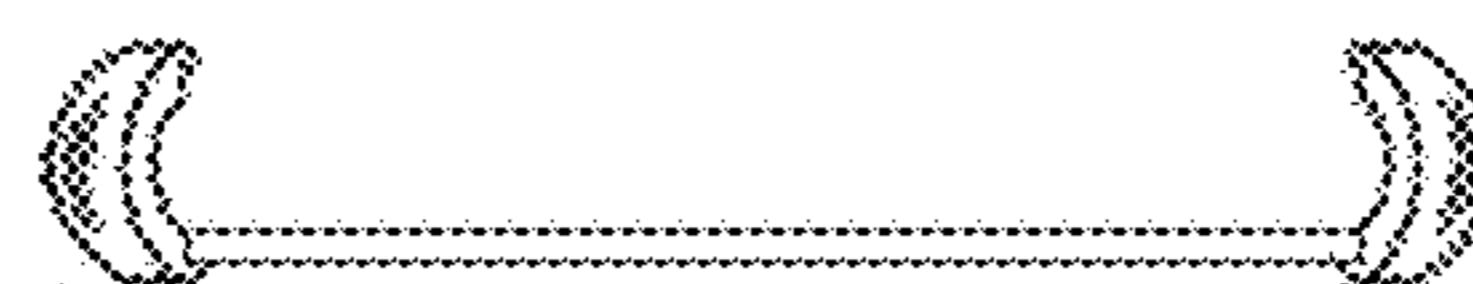

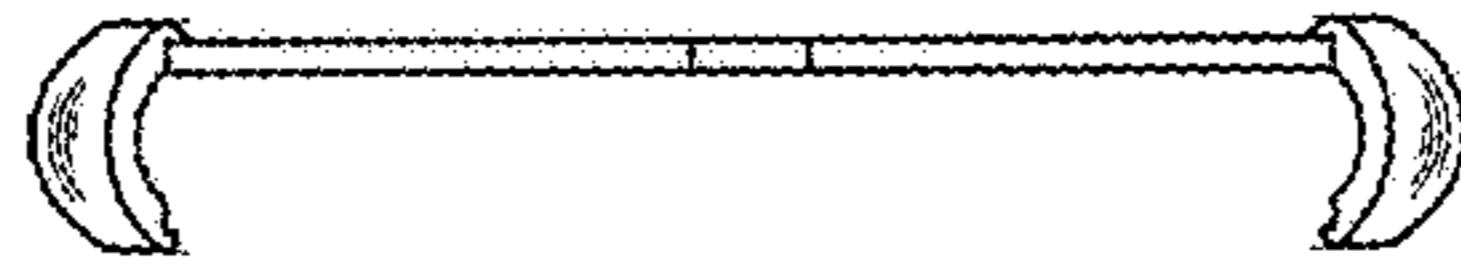

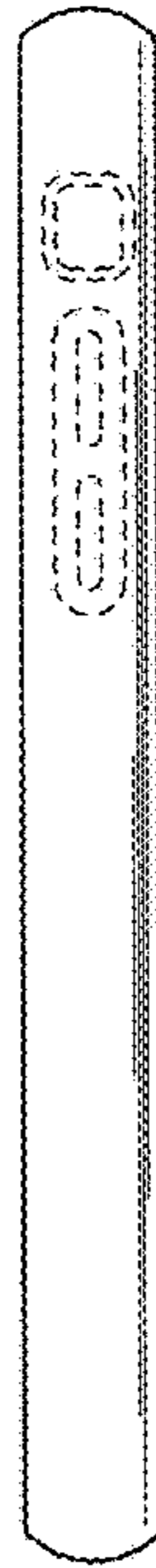

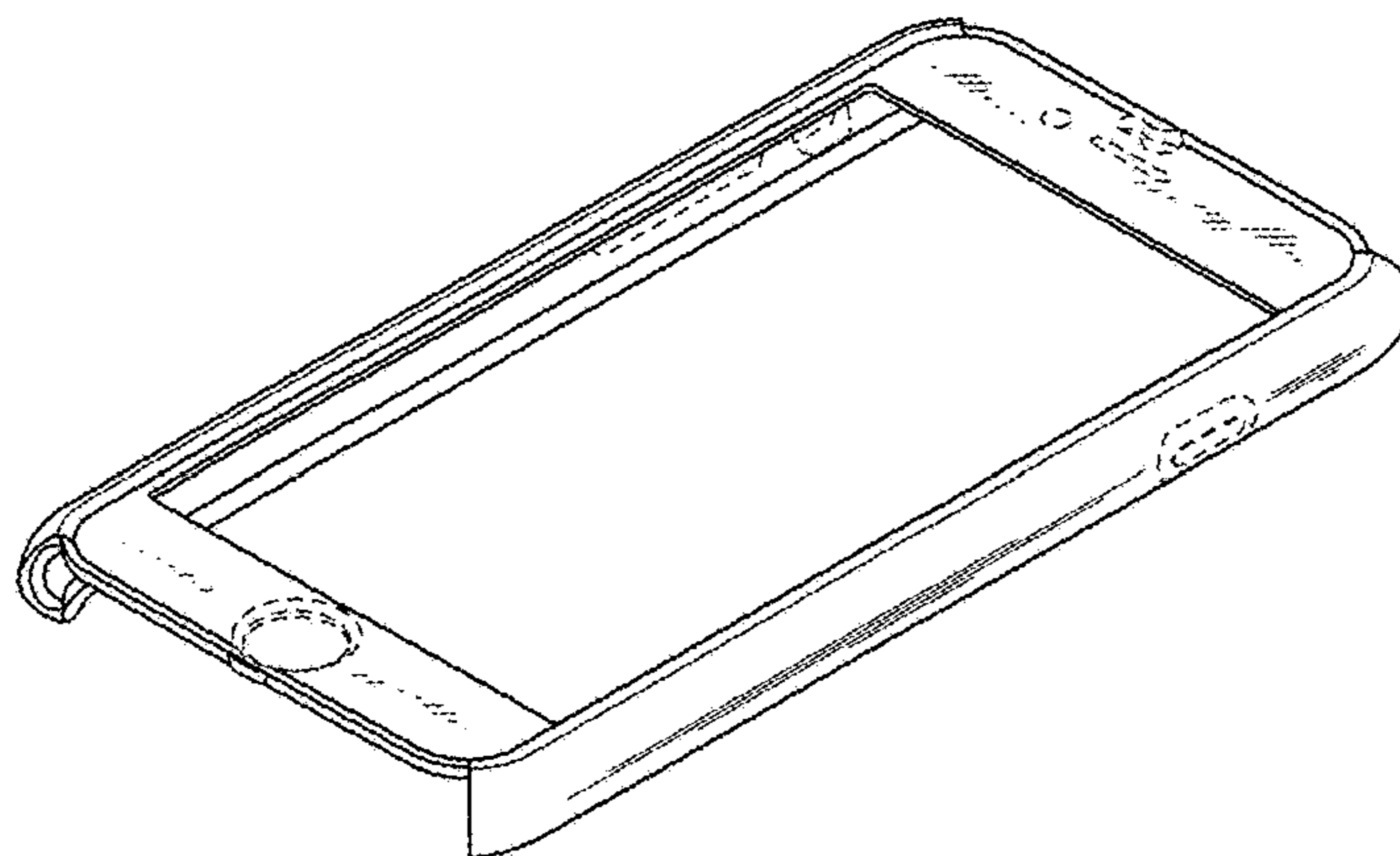

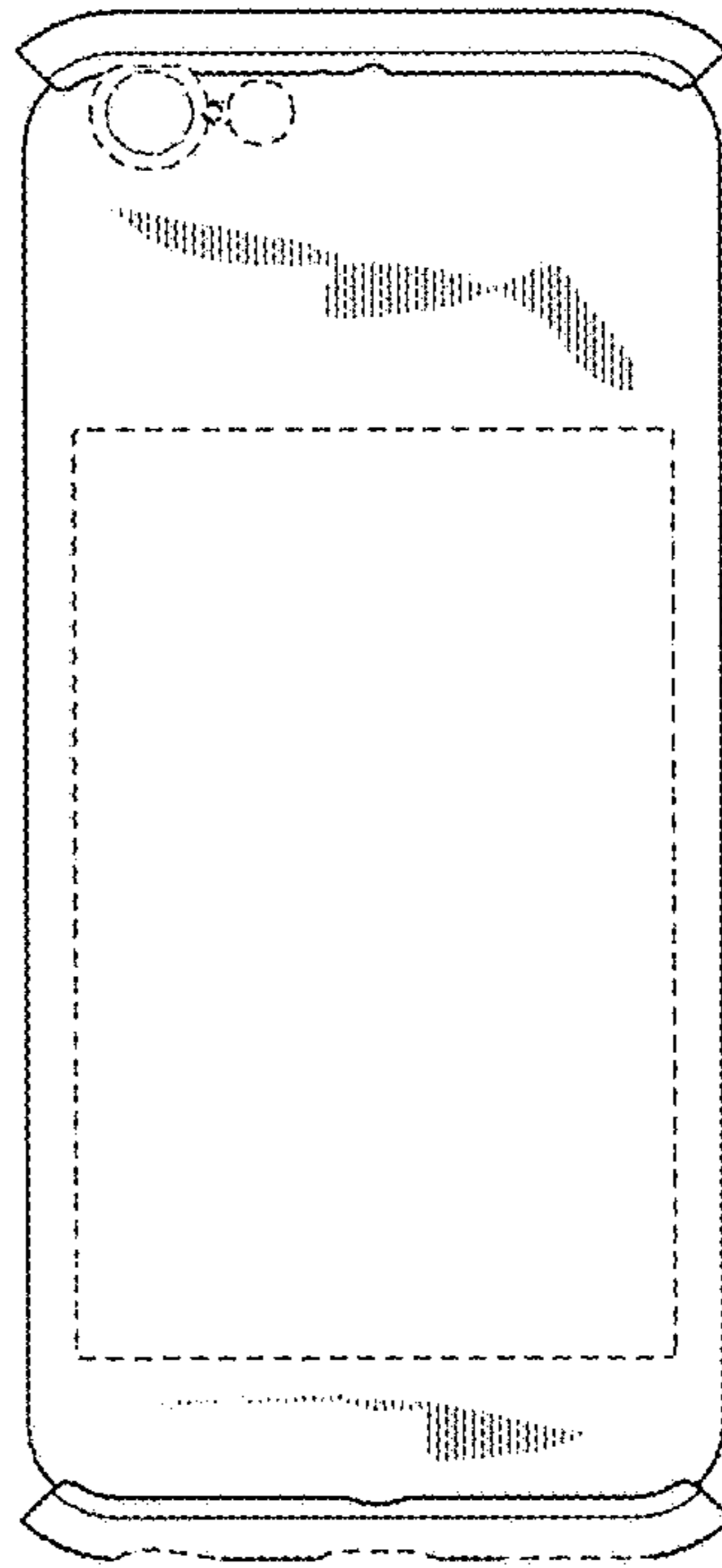

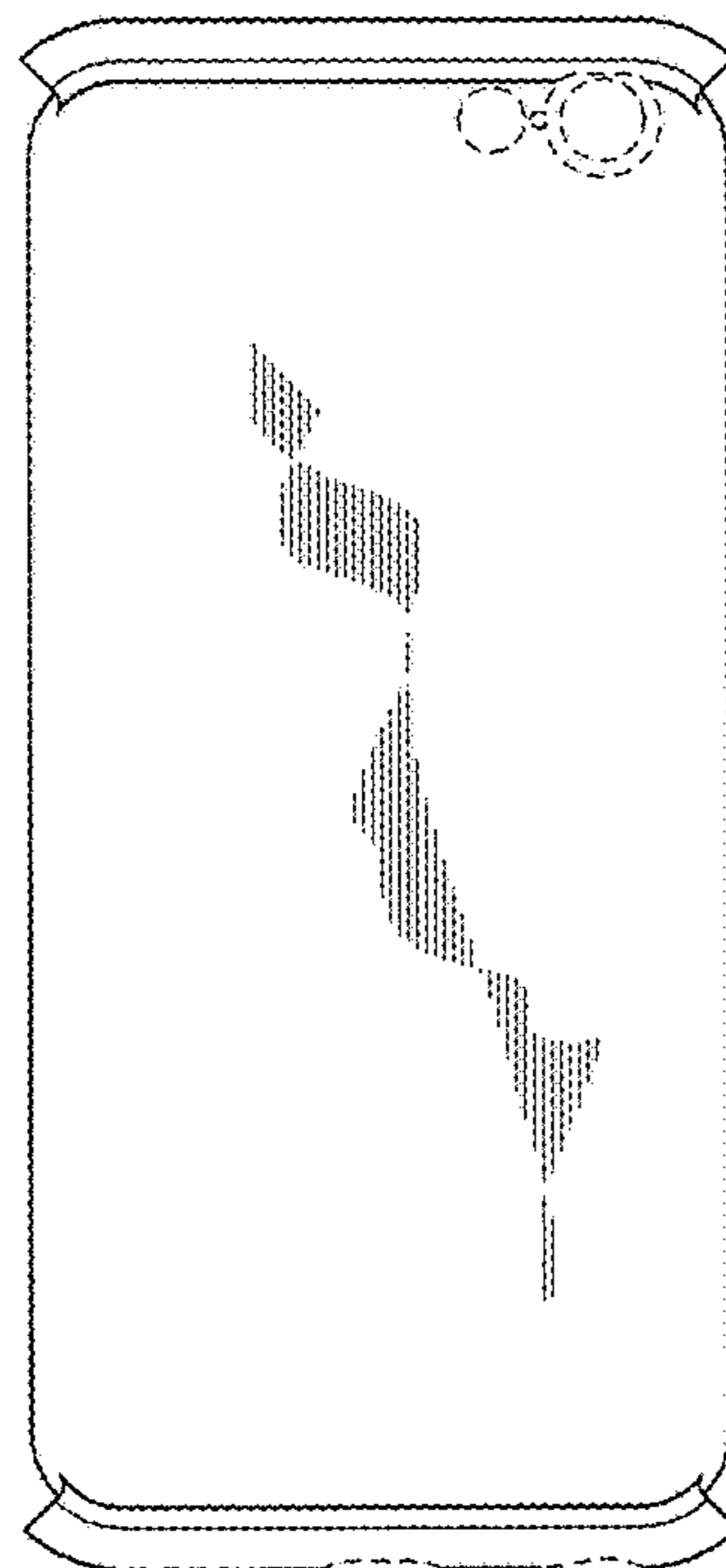

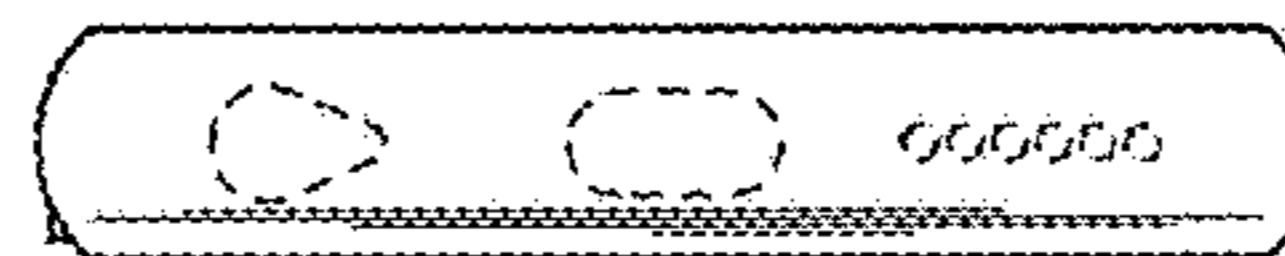
