(57) **CLAIM**

The ornamental design for a cake greeting card, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the cake greeting card of the present invention, in a closed position.

FIG. 2 is a front view of the cake greeting card of FIG. 1.

FIG. 3 is a rear view of the cake greeting card of FIG. 1.

FIG. 4 is a left side view of the cake greeting card of FIG. 1.

FIG. 5 is a right side view of the cake greeting card of FIG. 1.

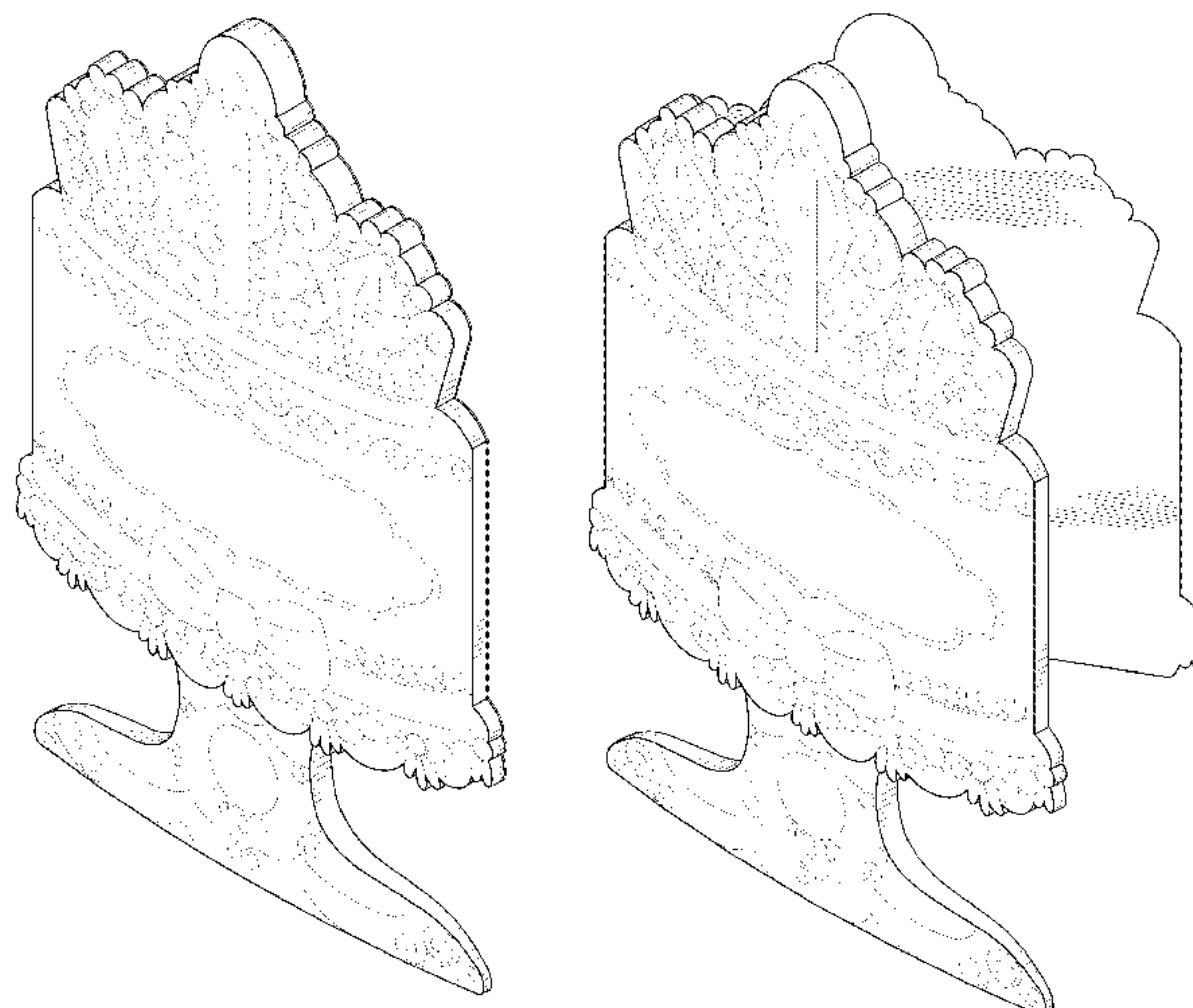
FIG. 6 is a top down view of the cake greeting card of FIG. 1.

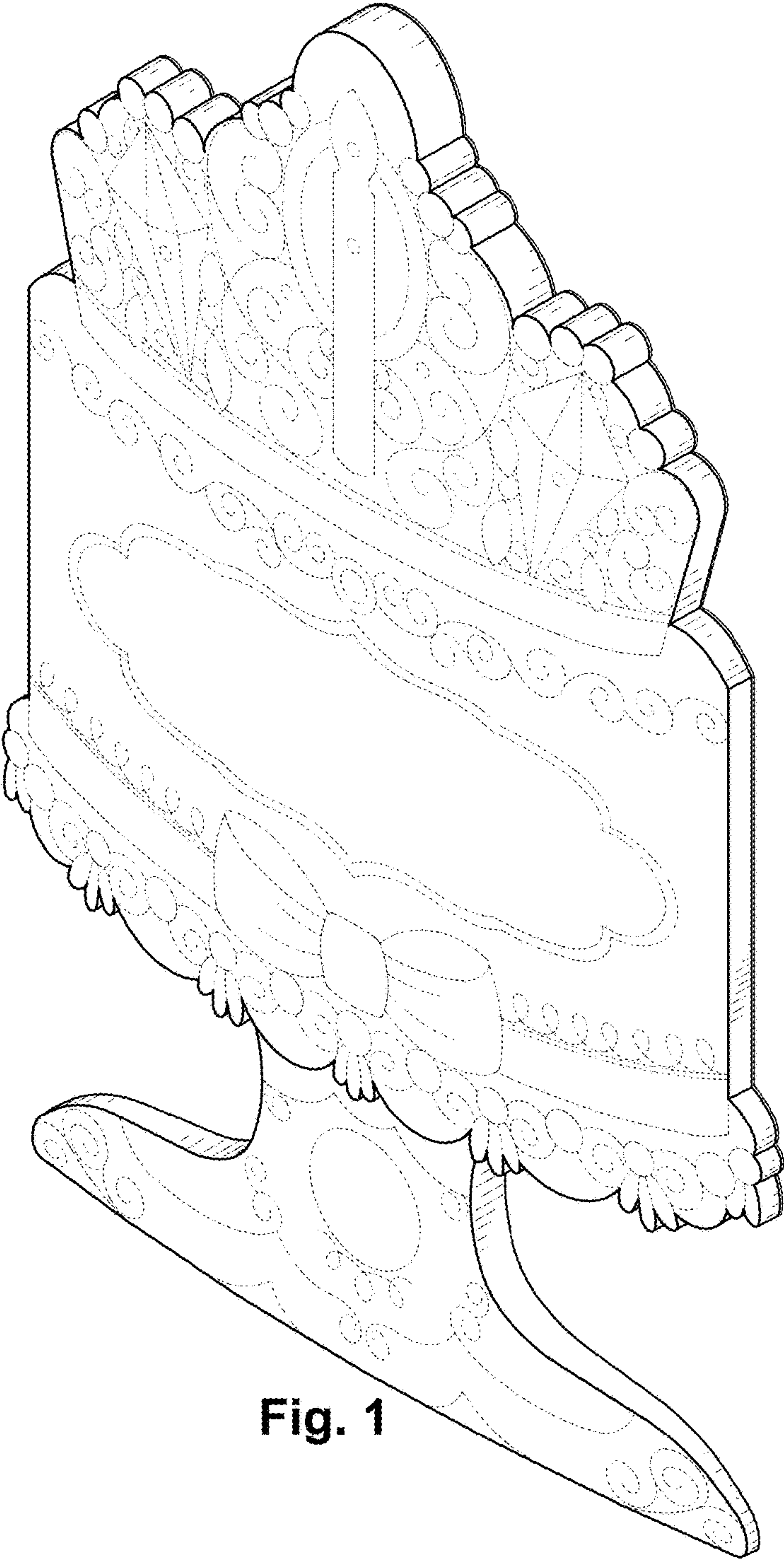

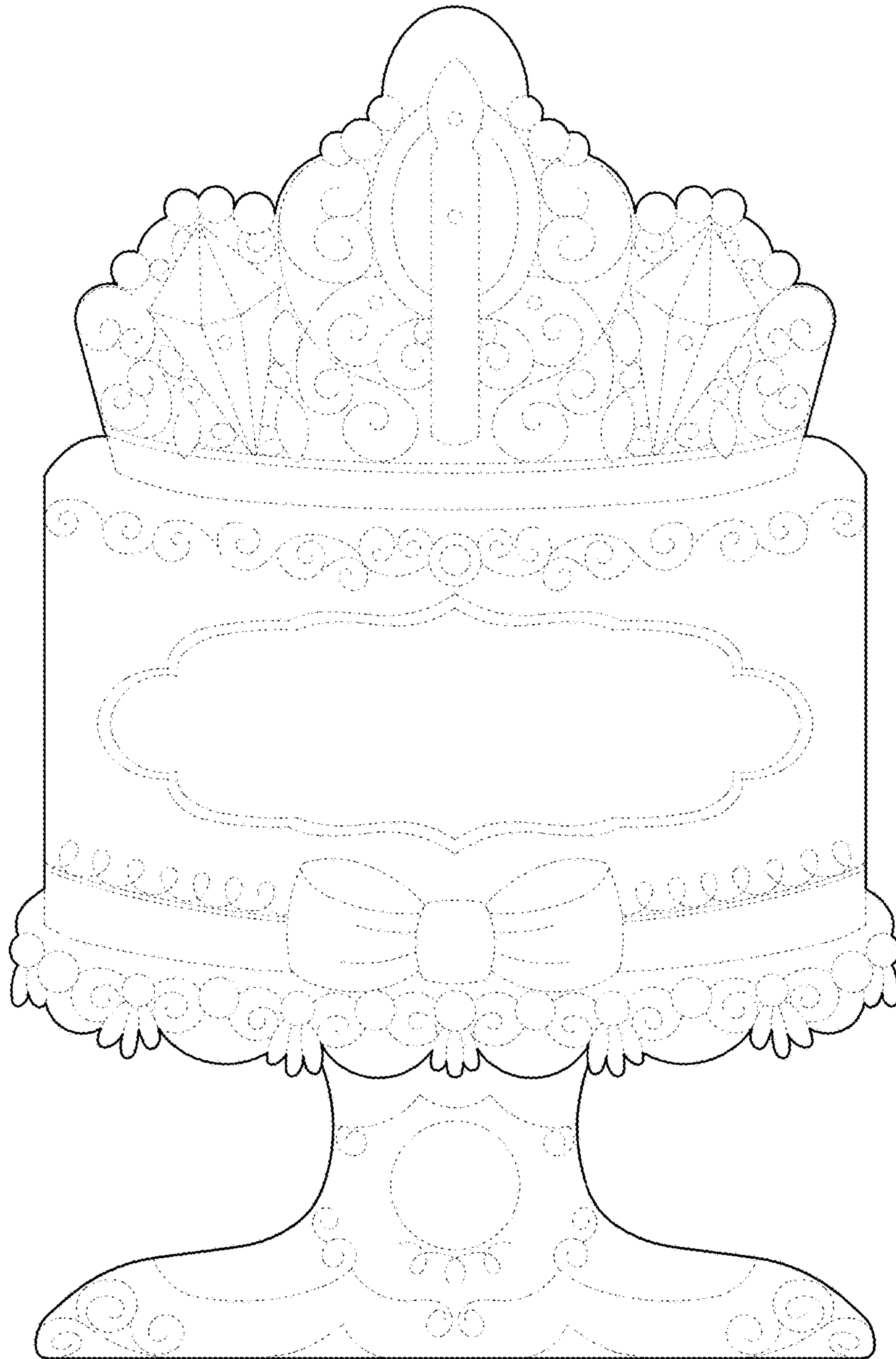

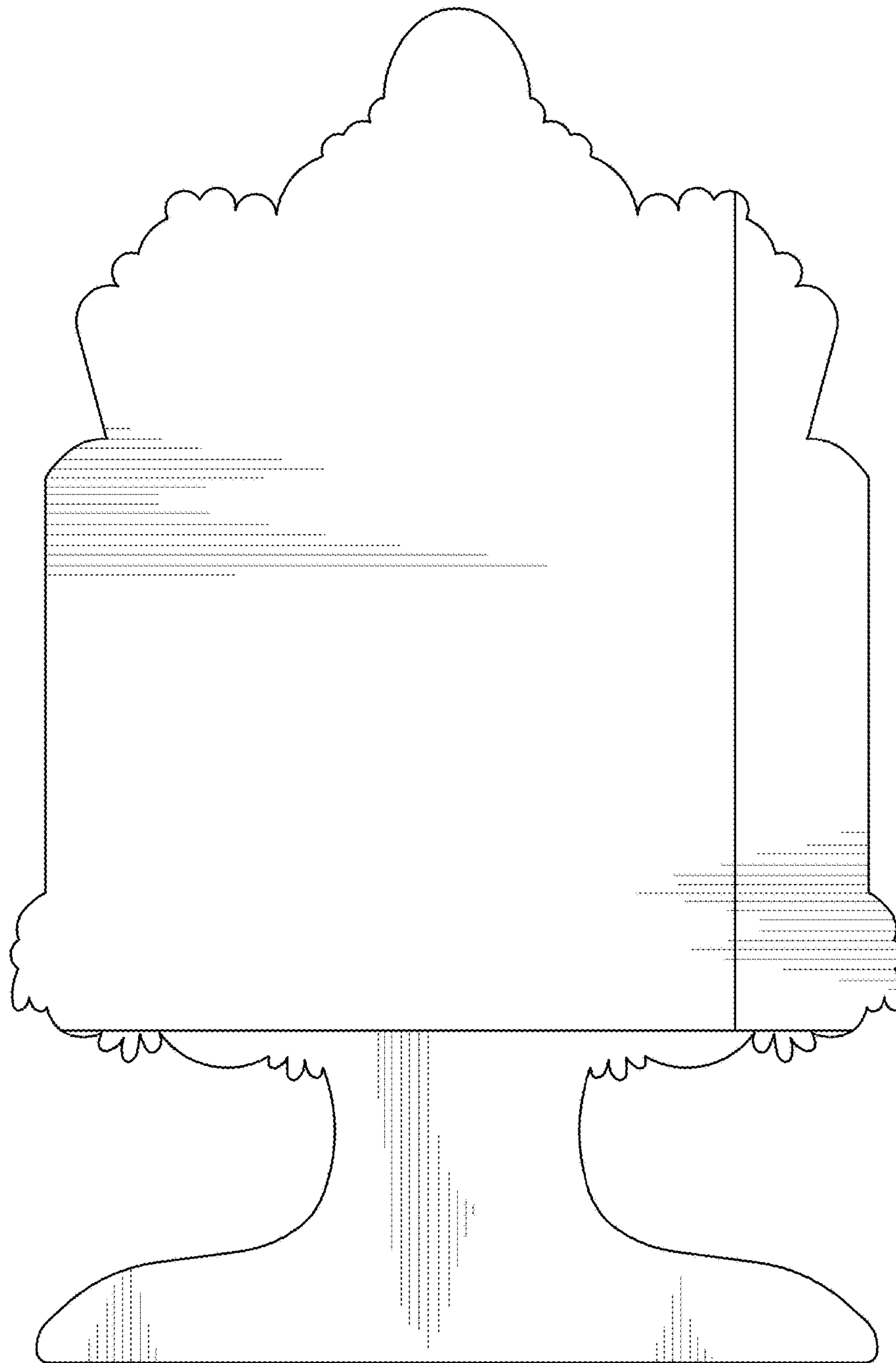

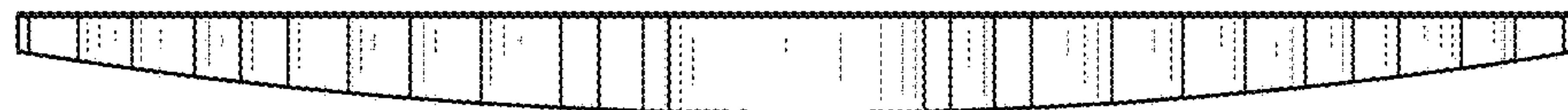

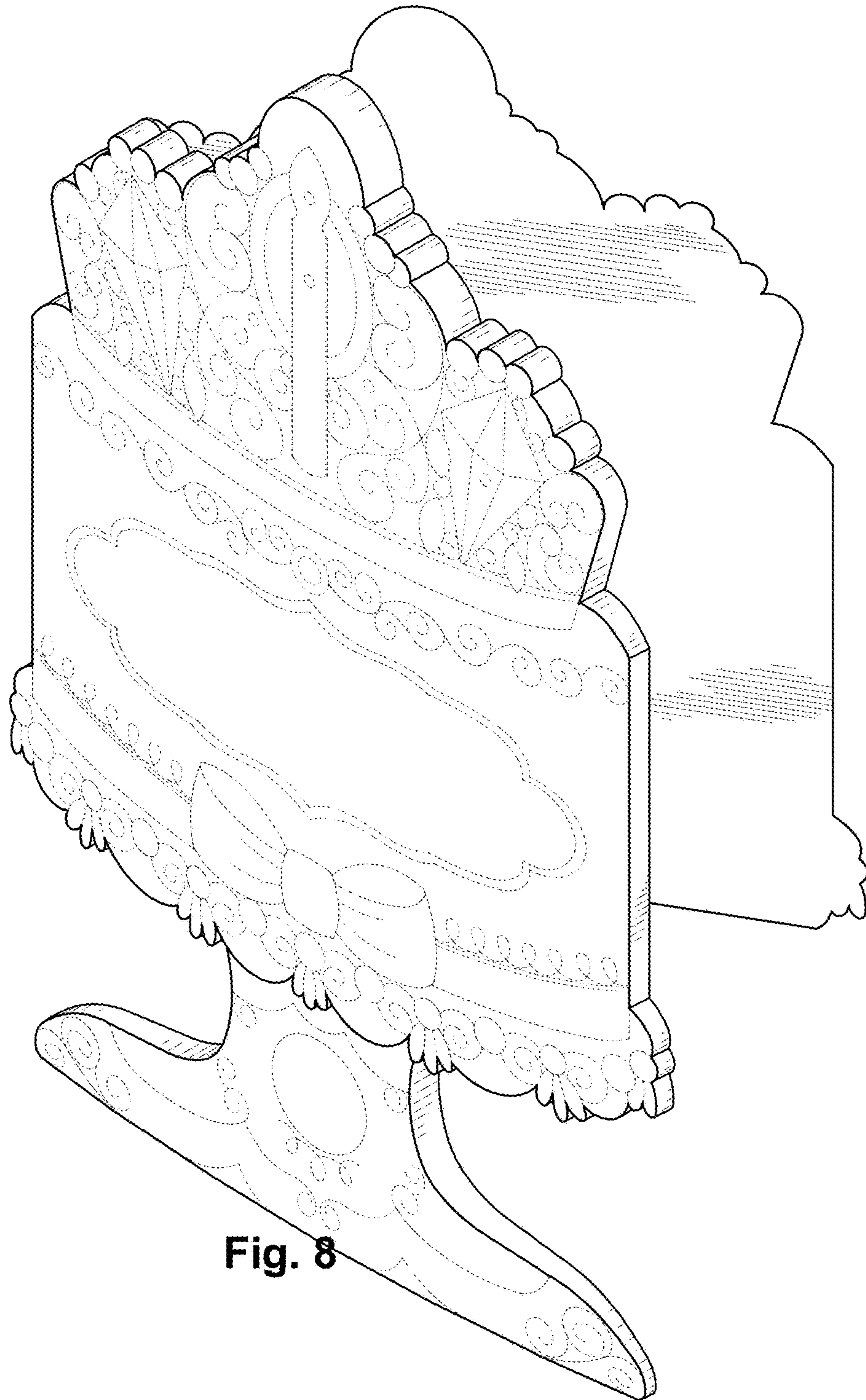
