DESCRIPTION

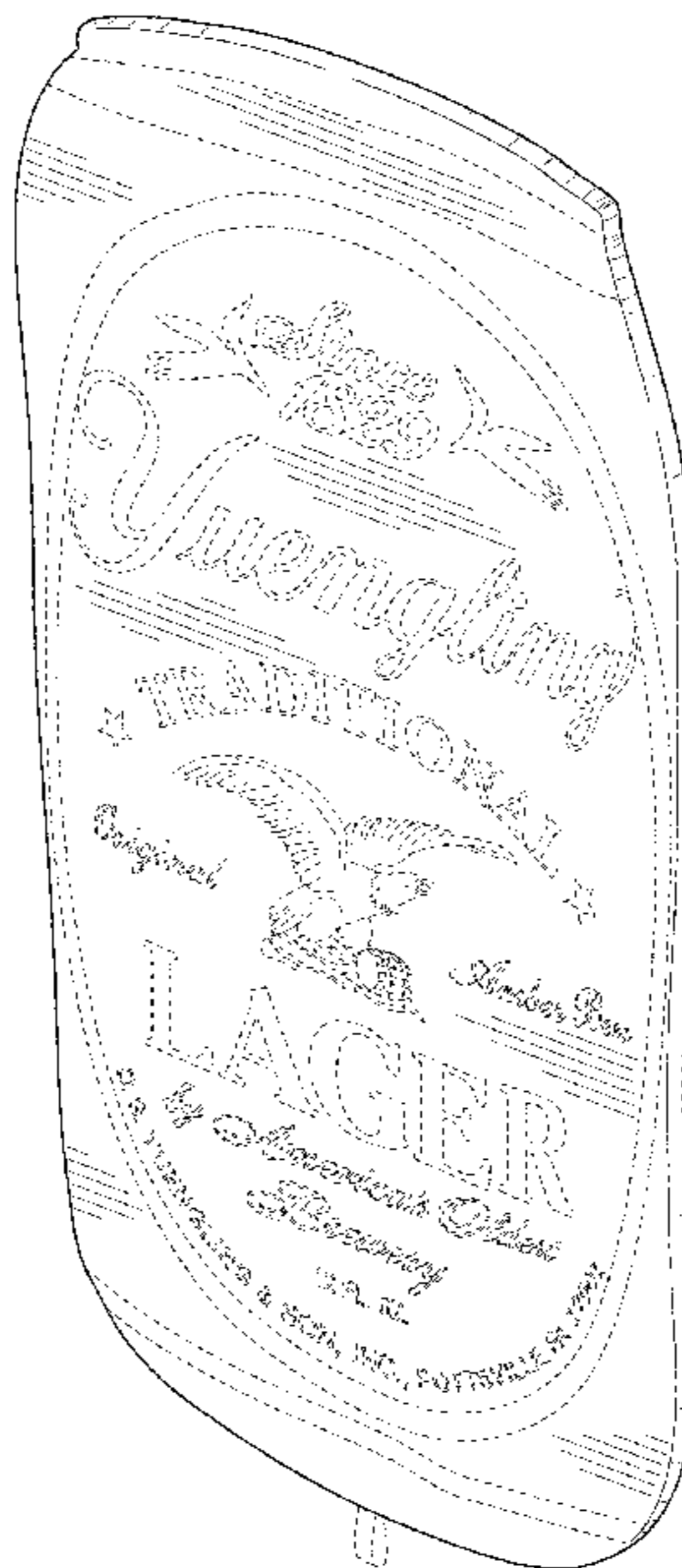
FIG. 1 is an isometric view of a top, front and right side of a can display, showing my new design;

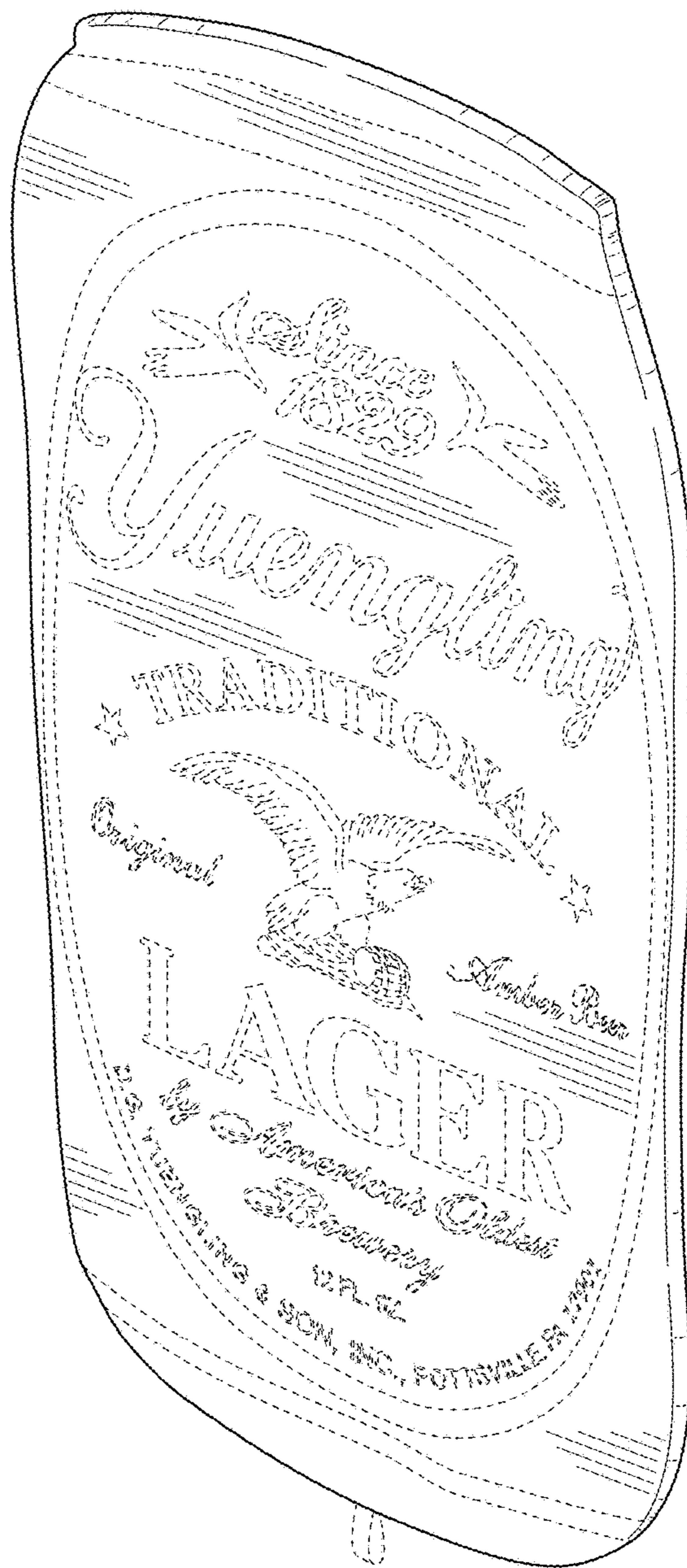

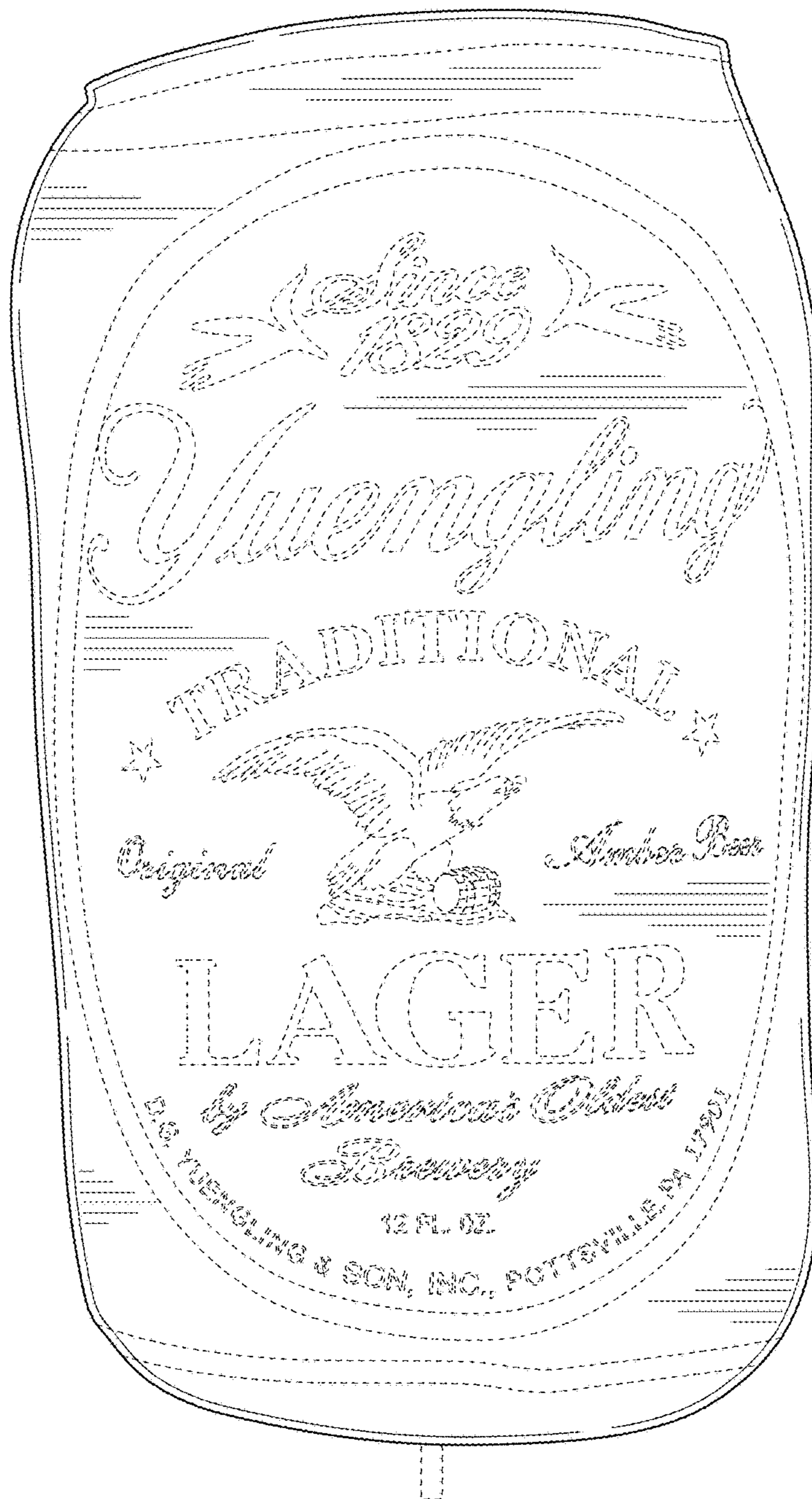

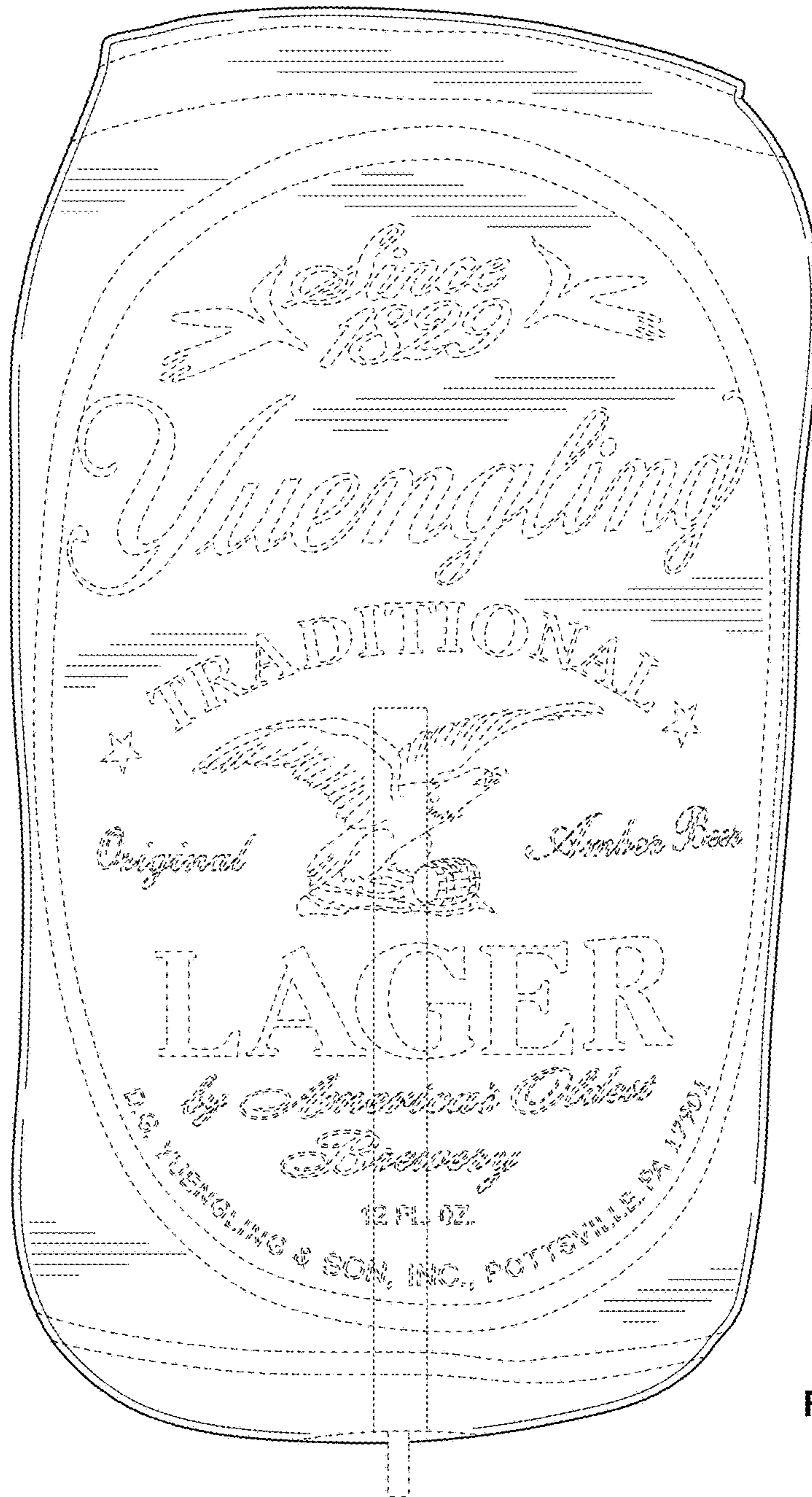

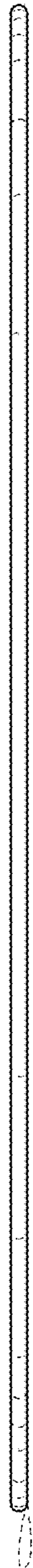

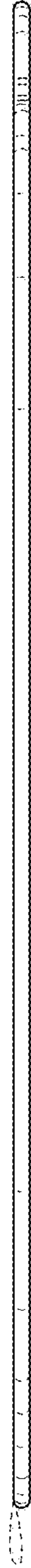

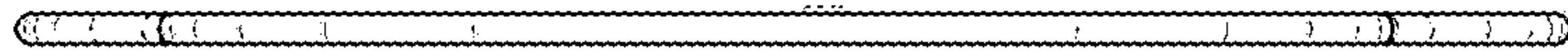

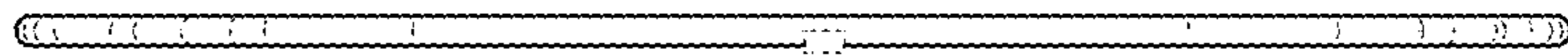
