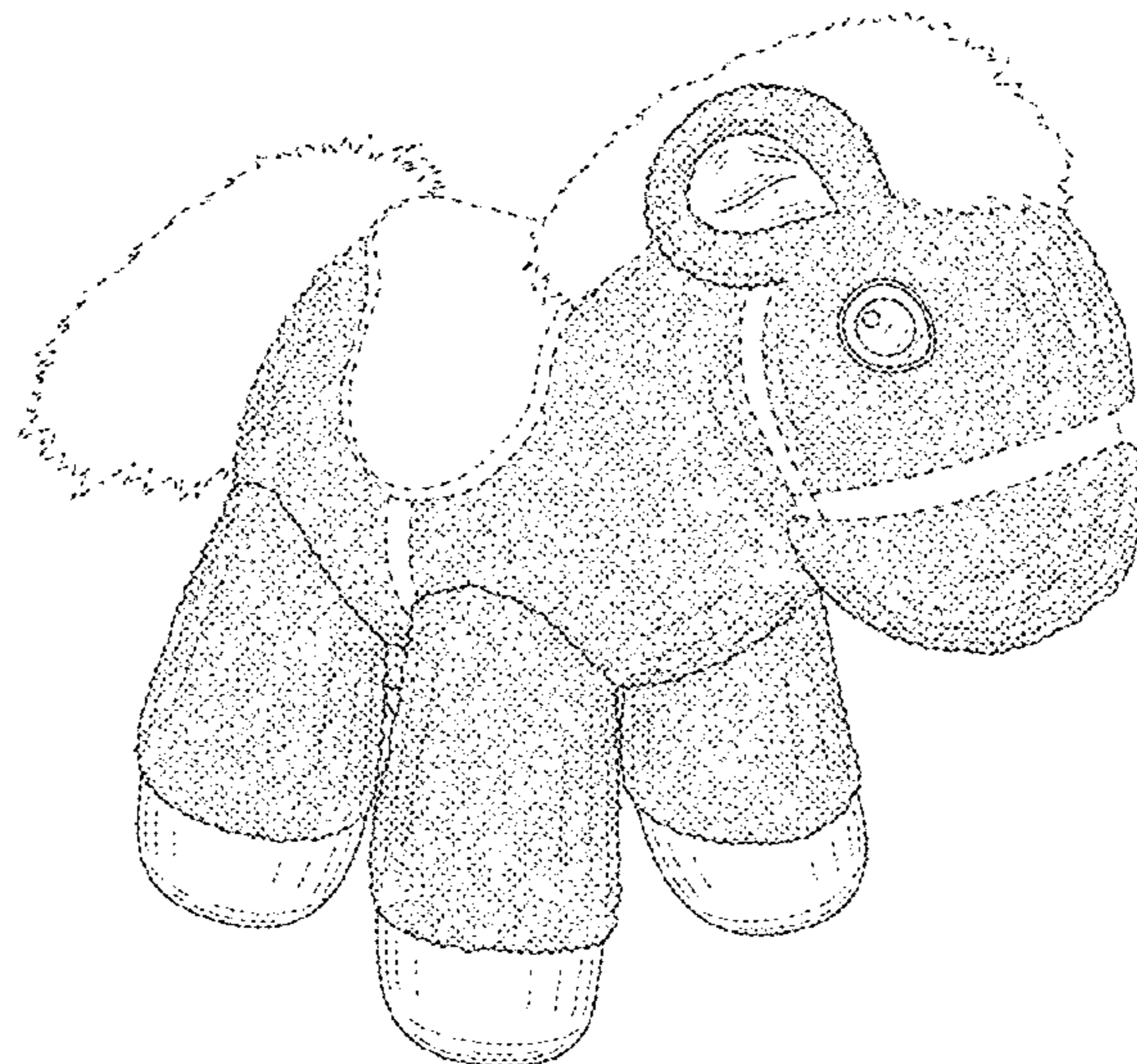
(57) **CLAIM**

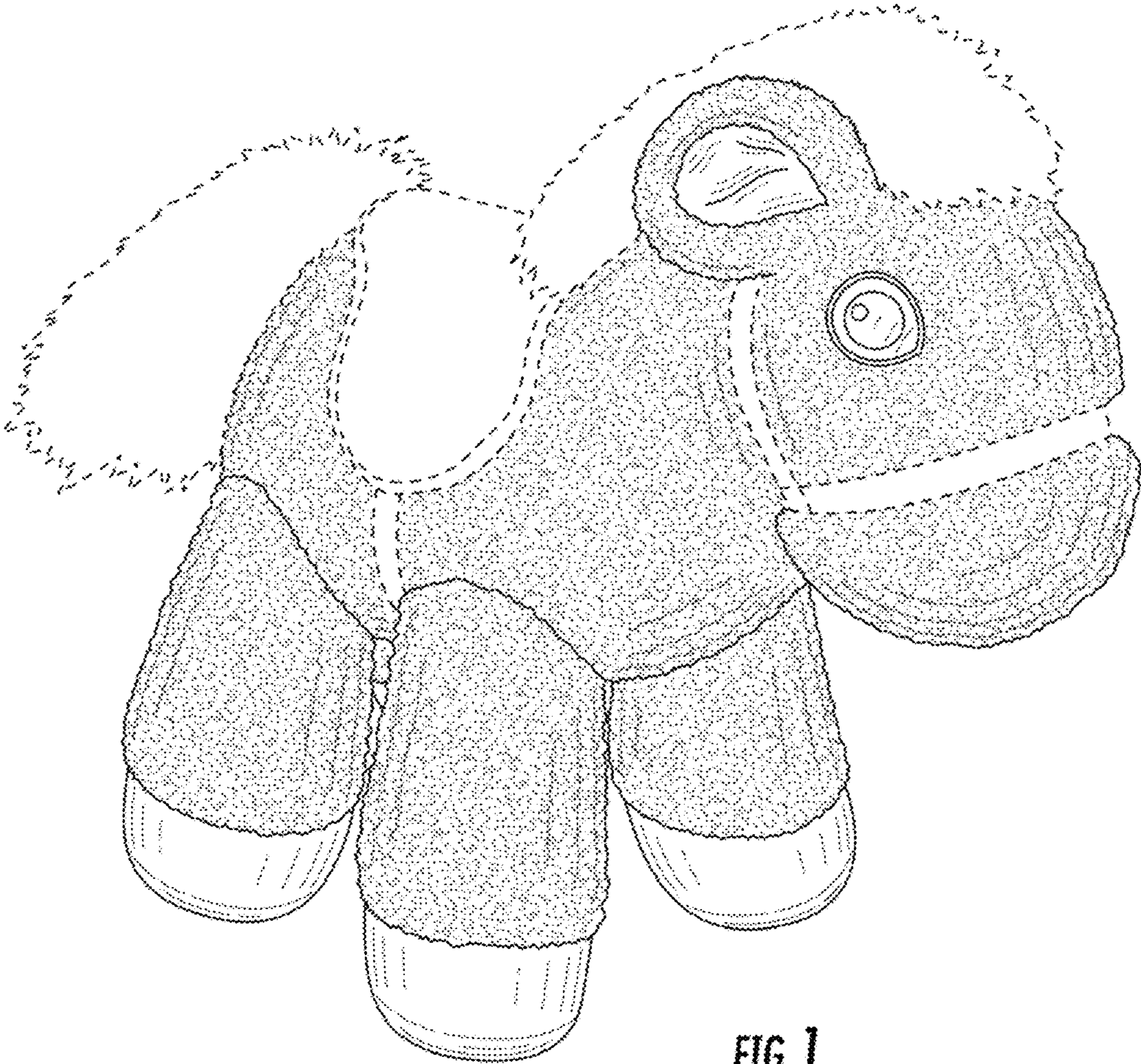
The ornamental design for a plush horse toy, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a new plush horse toy; FIG. 2 is a front elevation view thereof; FIG. 3 is a back elevation view thereof; FIG. 4 is a right elevational view thereof; FIG. 5 is a left elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view of the plush horse toy in which certain optional, disclaimed features have been removed; FIG. 9 is a front elevation view thereof; FIG. 10 is a back elevation view thereof; FIG. 11 is a right elevational view thereof; FIG. 12 is a left elevation view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof. The broken line disclosures in the views represent portions of the plush horse toy which form no part of the claimed design.

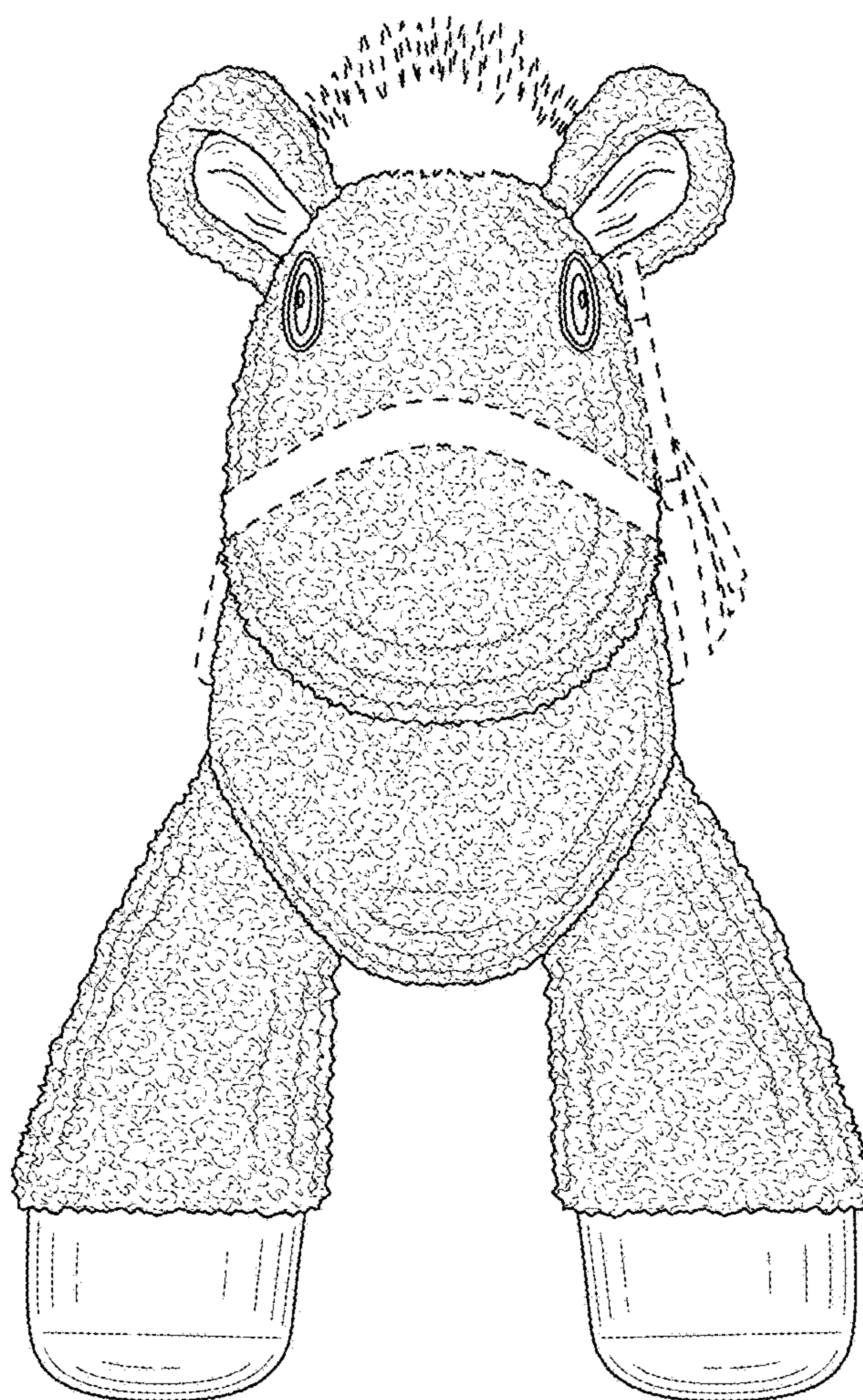

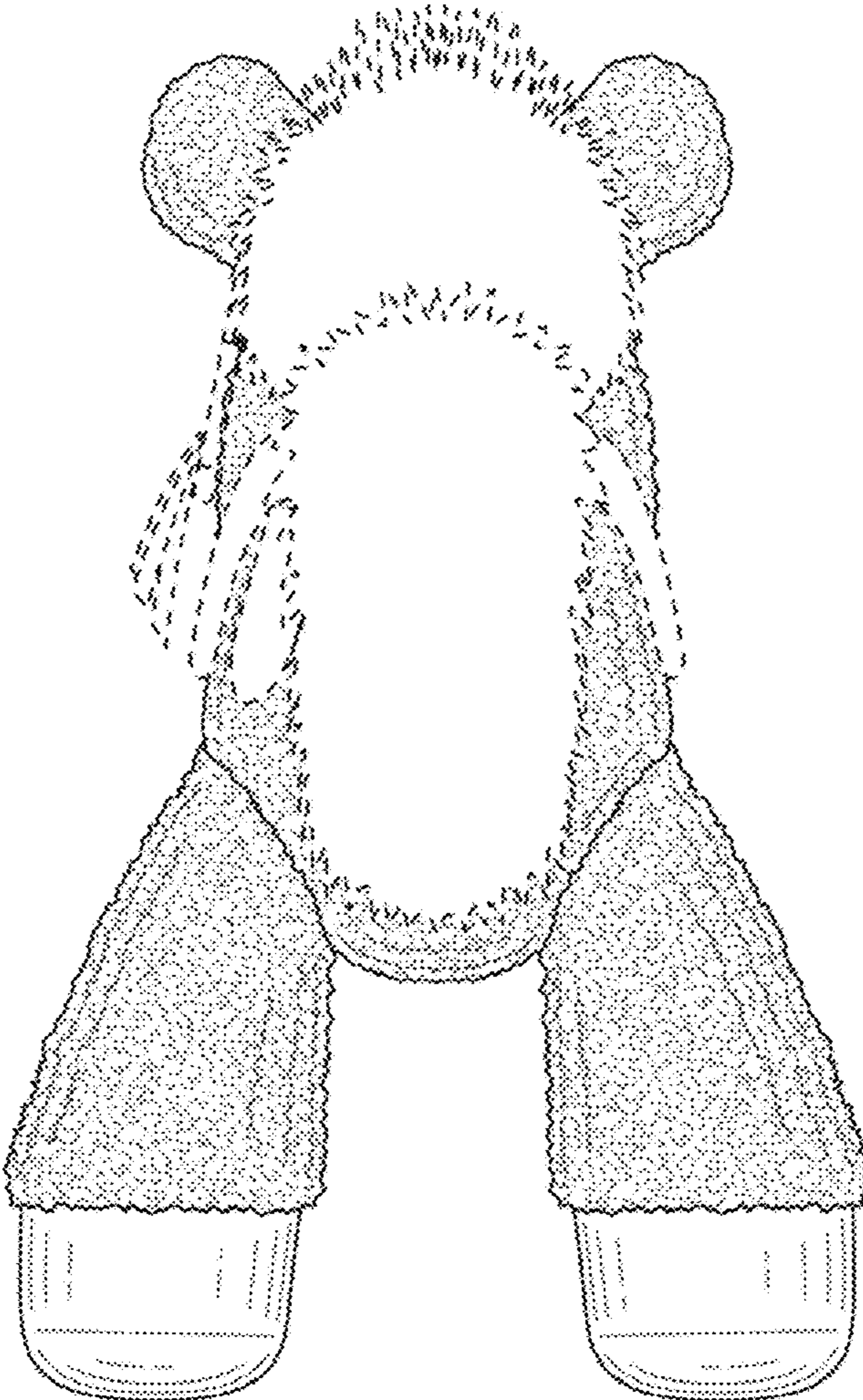

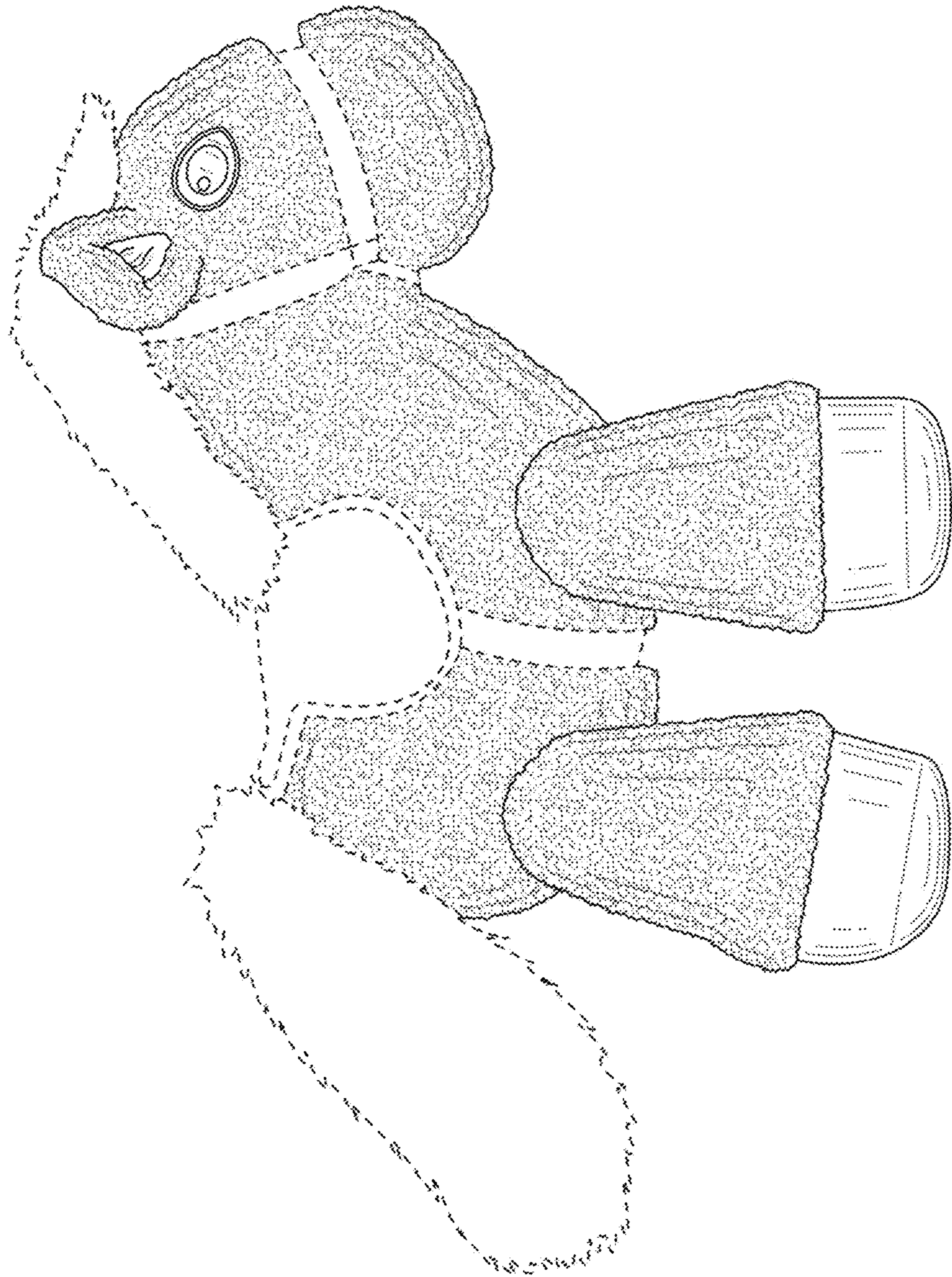

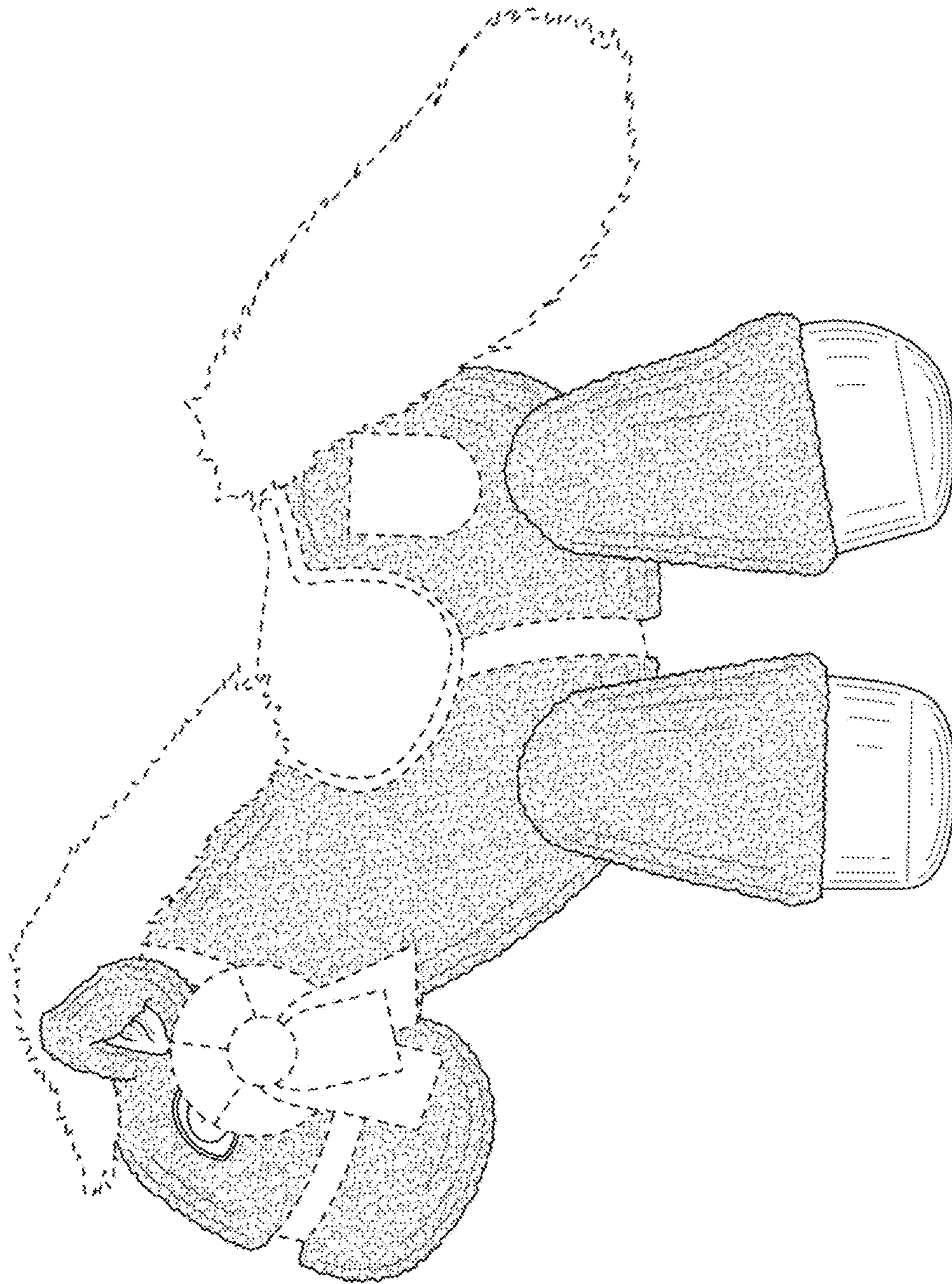
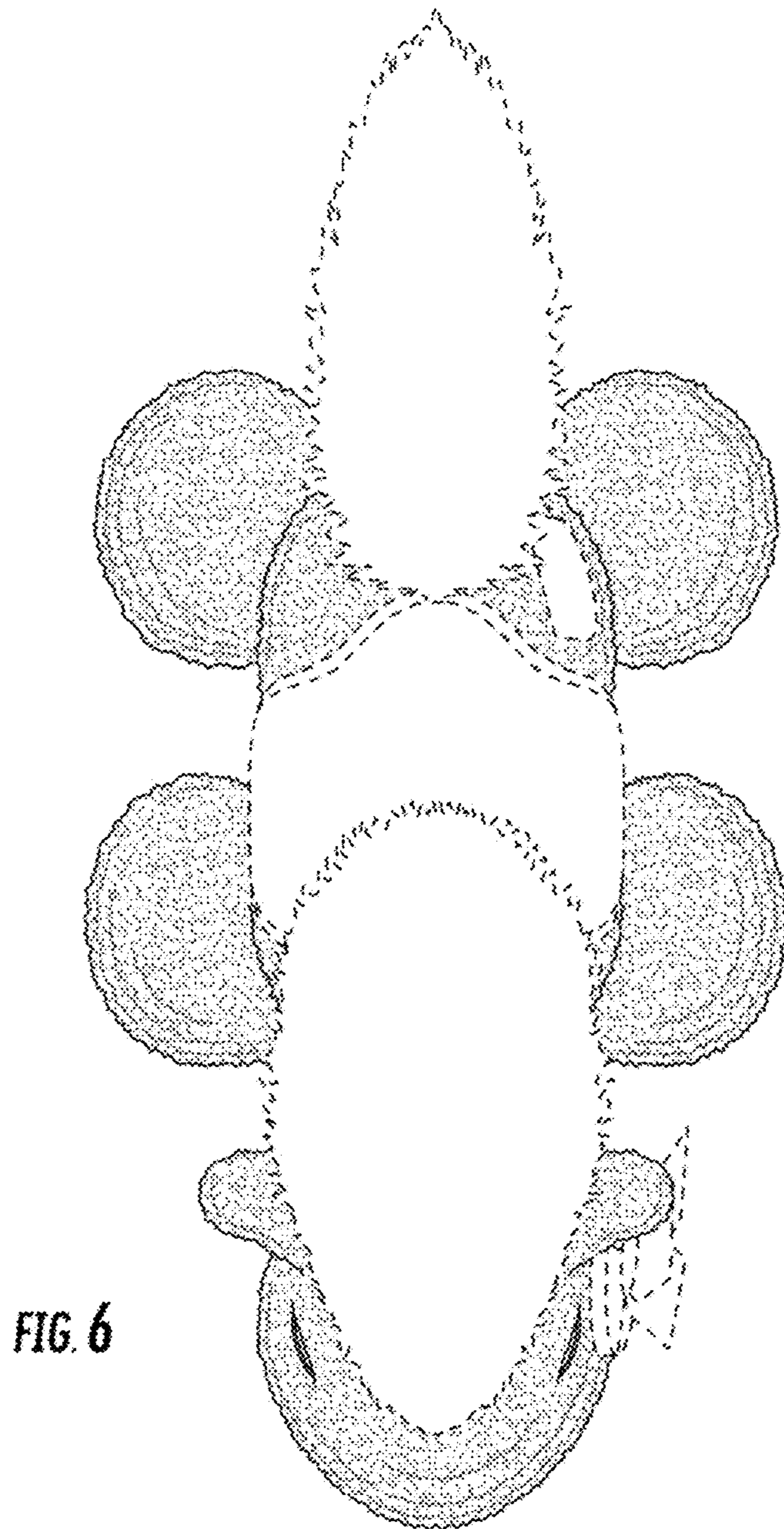

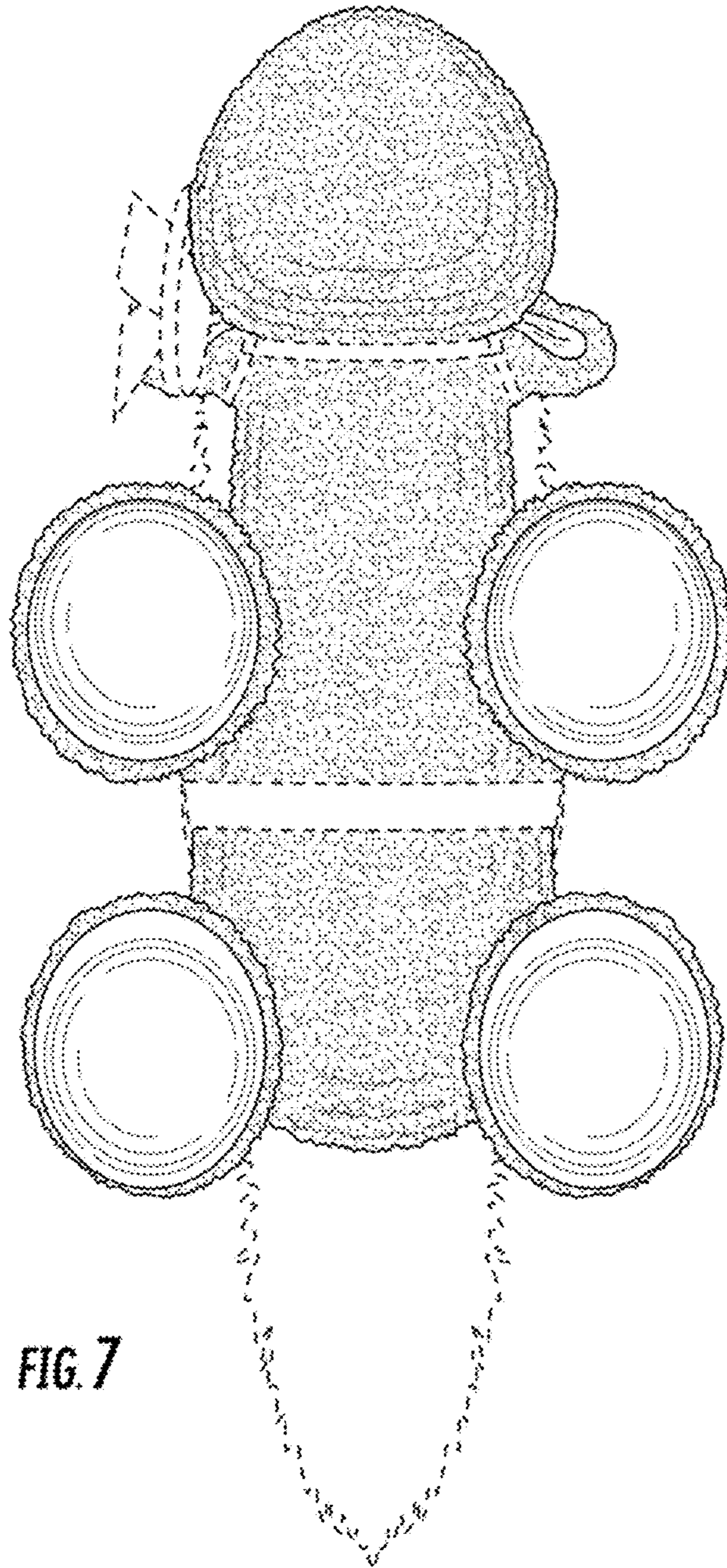

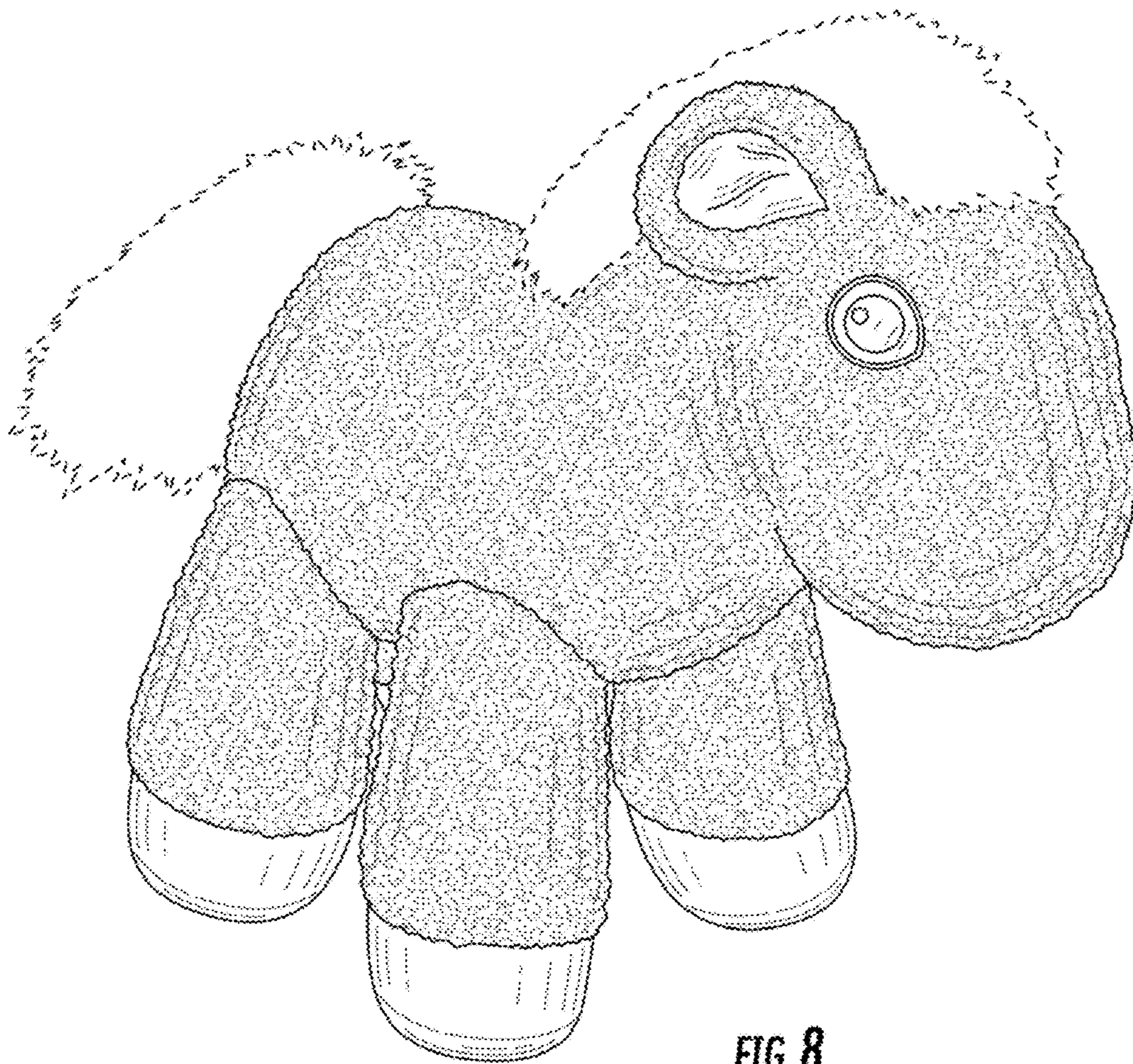

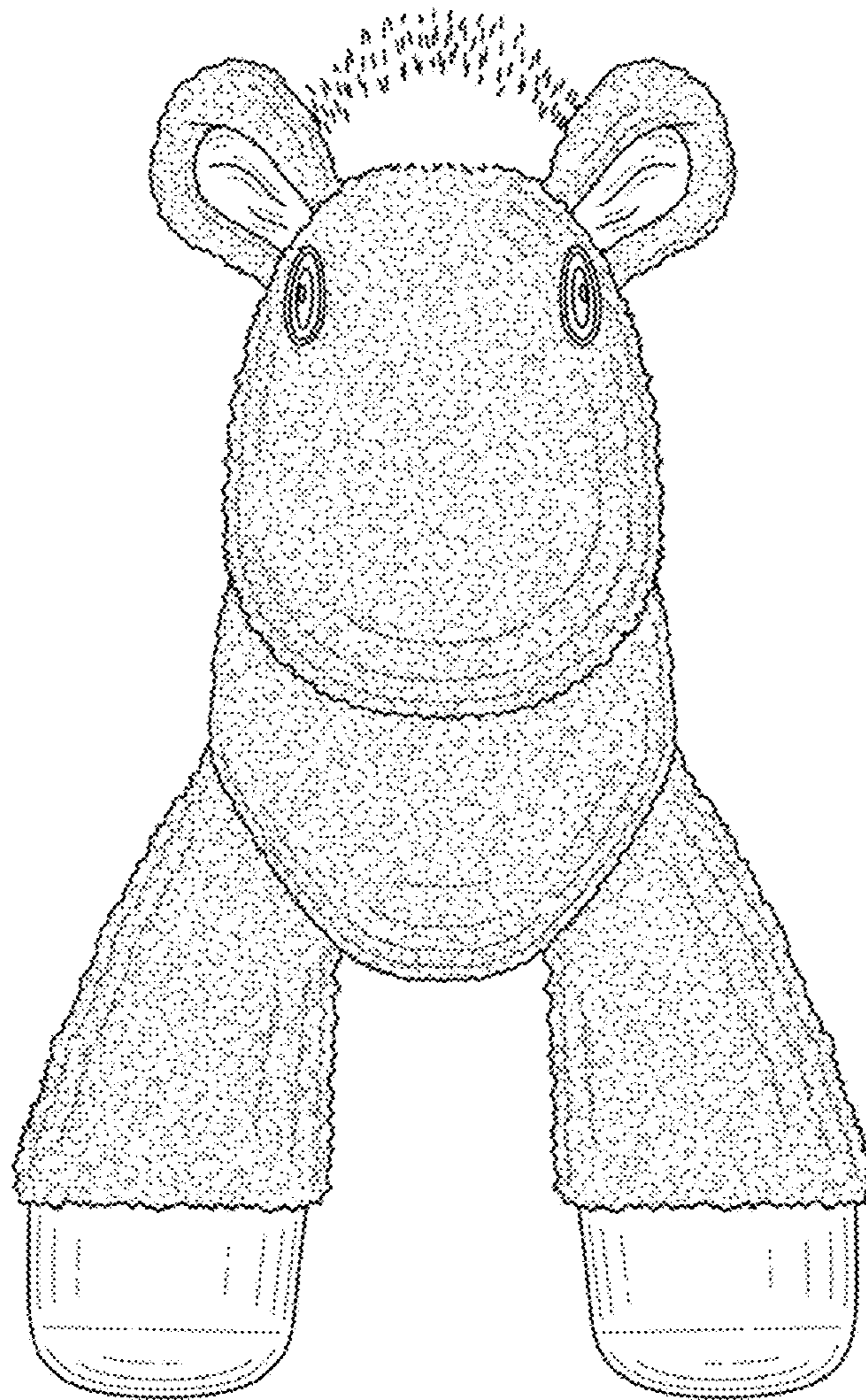

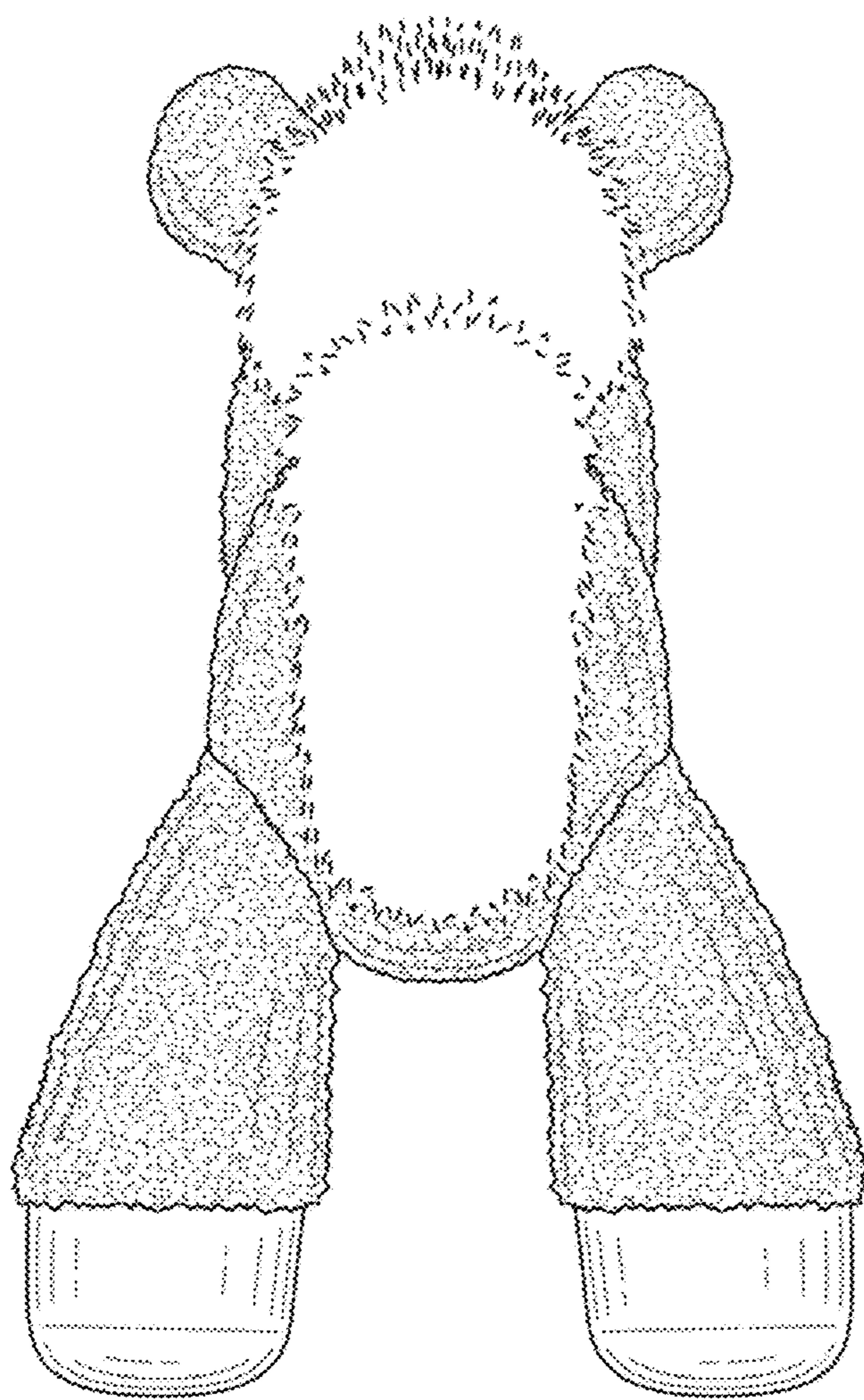

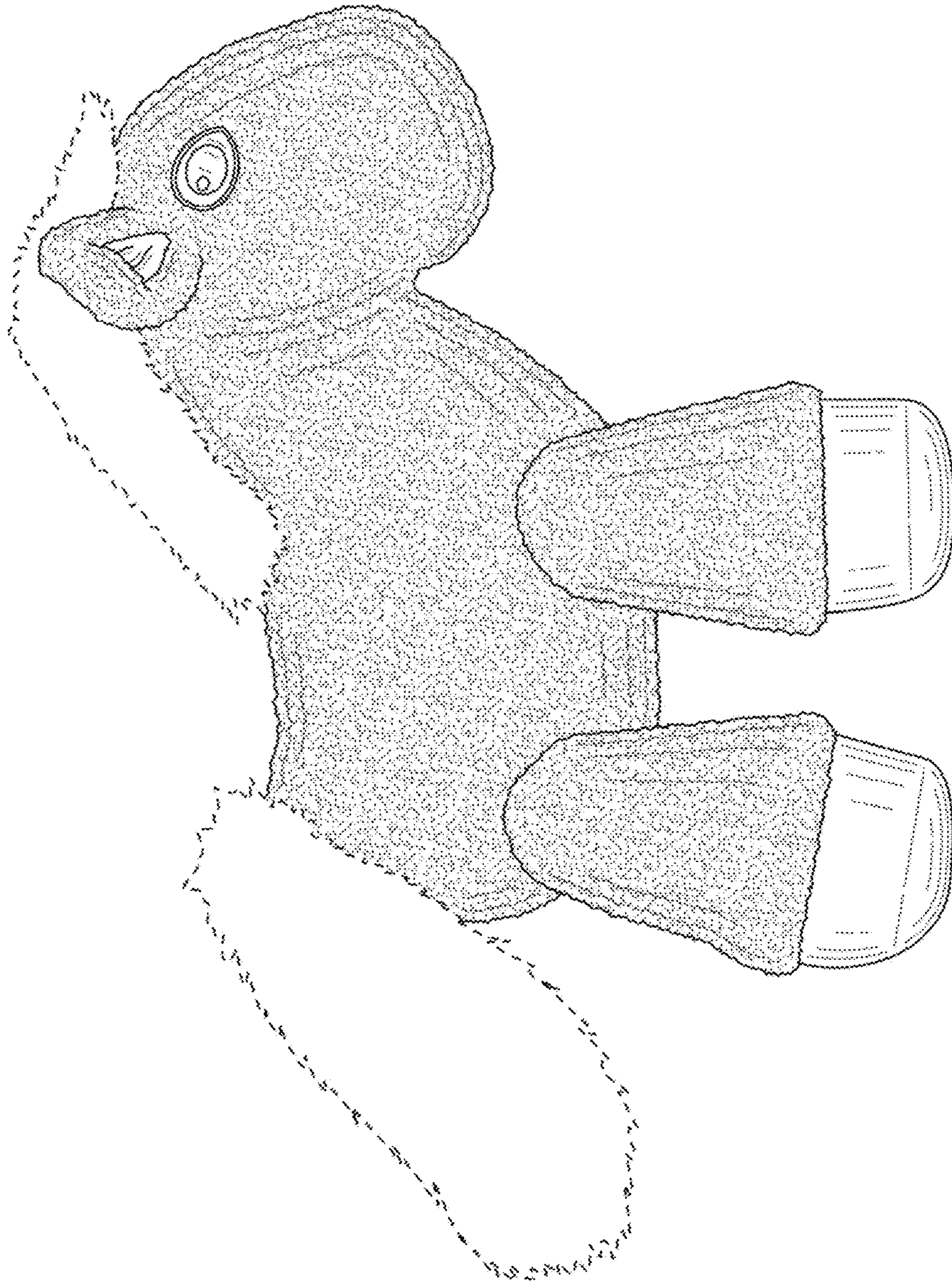

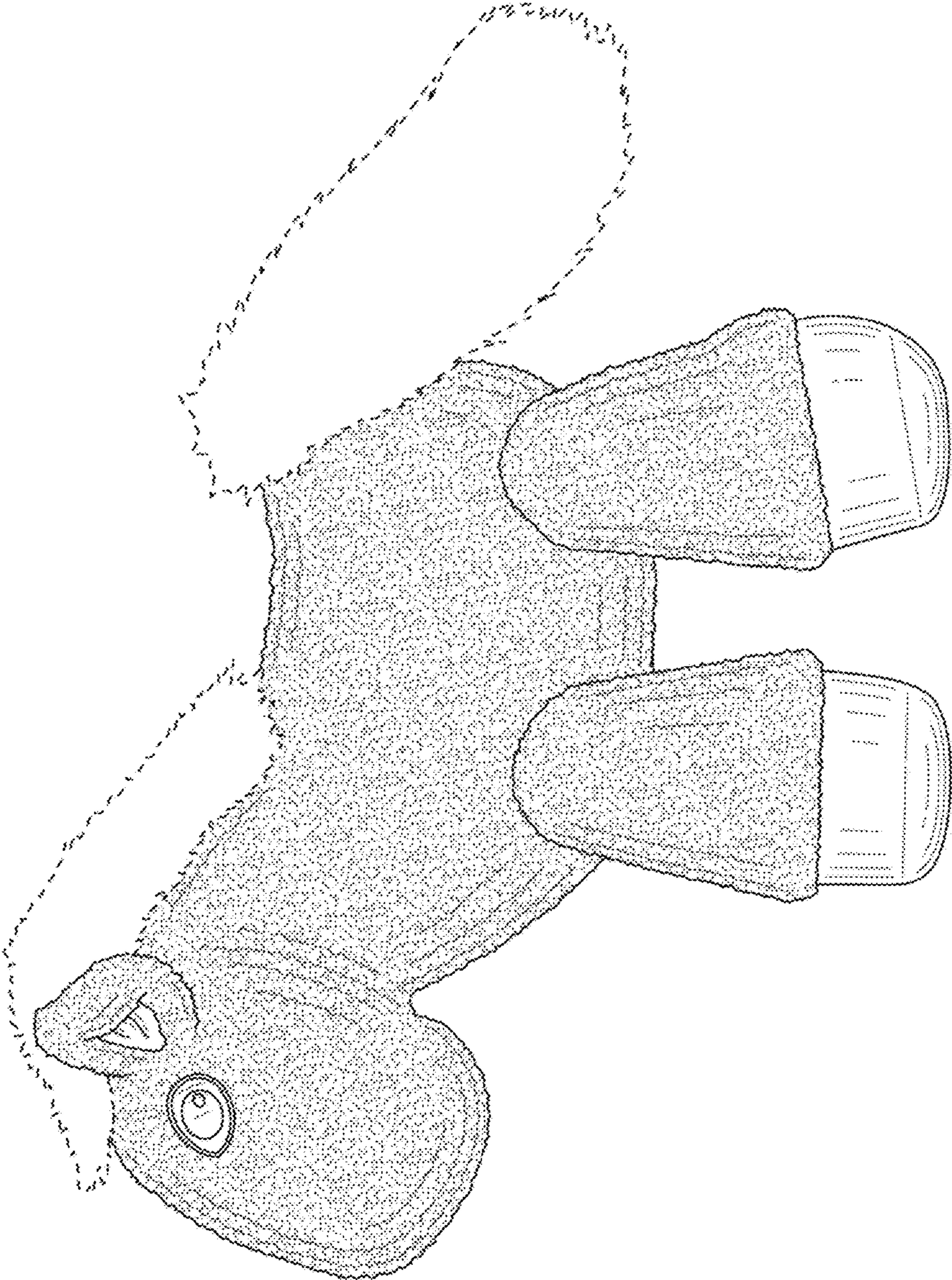

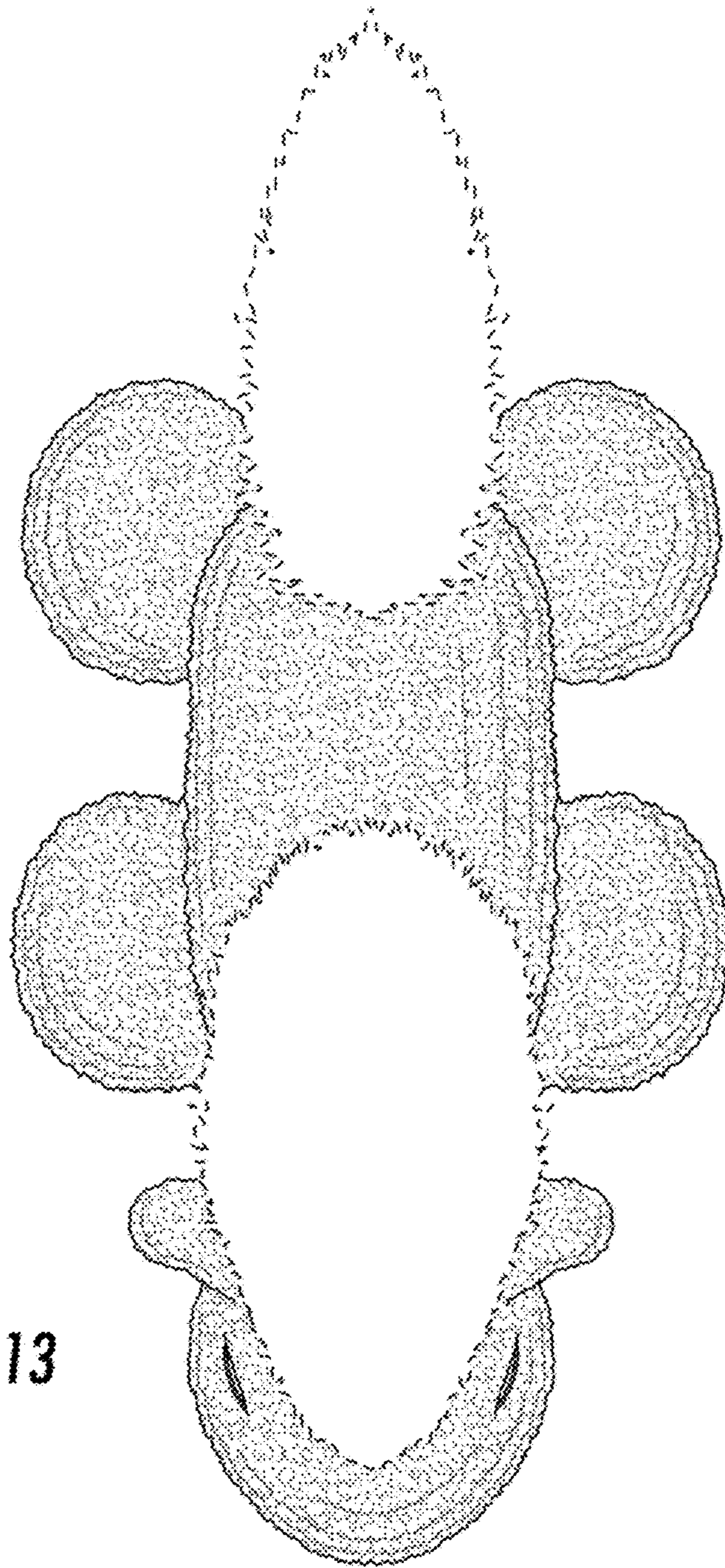

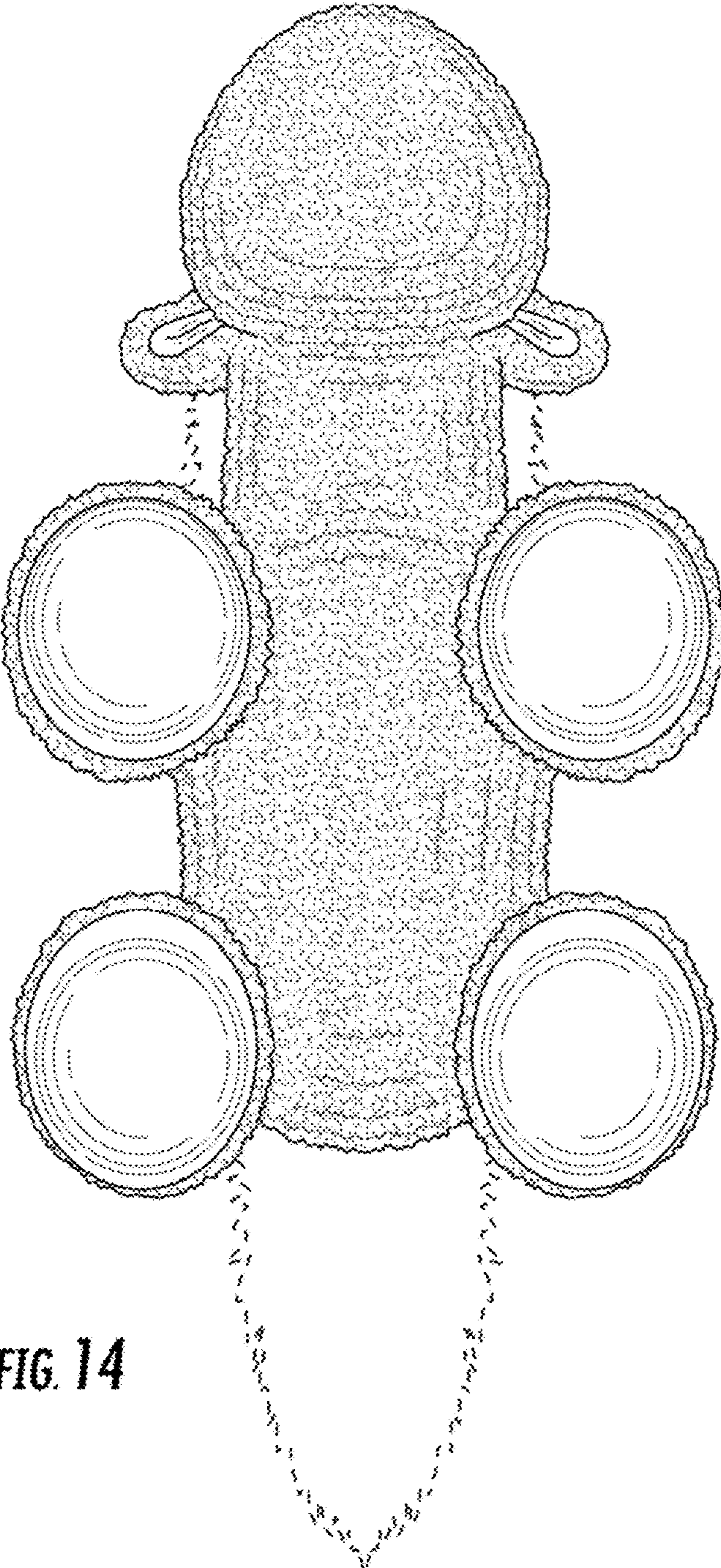
