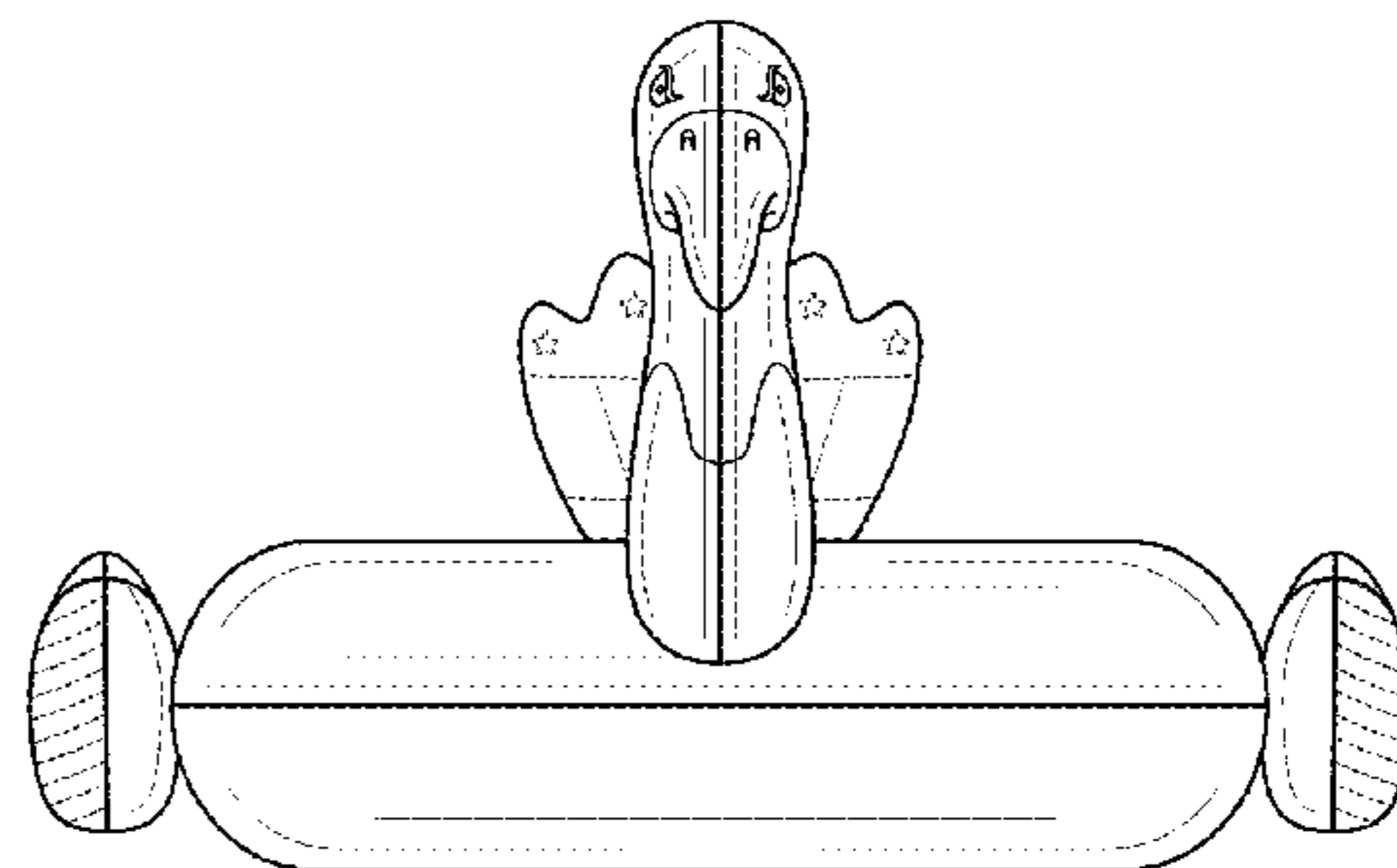
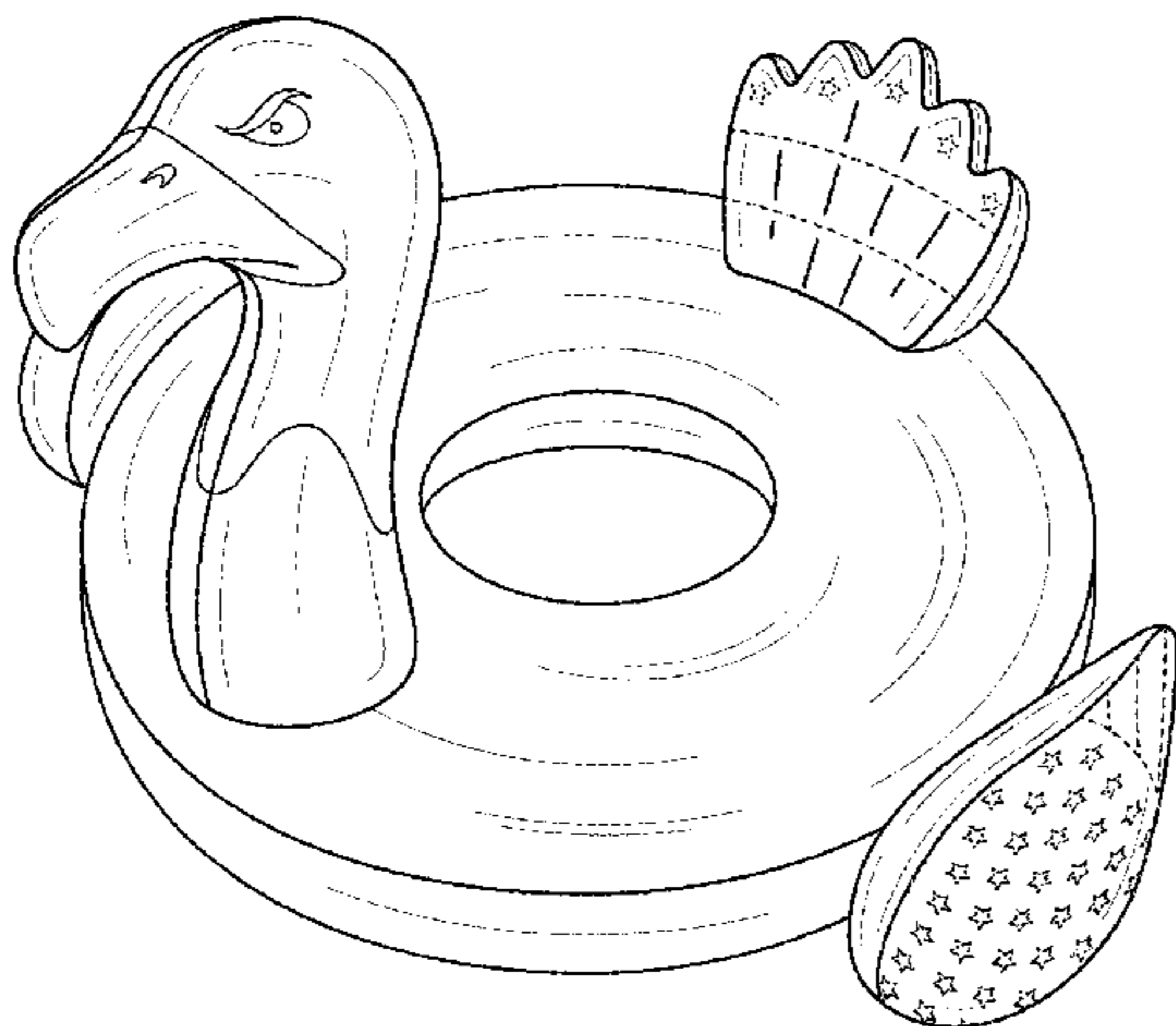
(57) **CLAIM**

The ornamental design for a bald eagle ring float, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bald eagle ring float; FIG. 2 is a front elevational view of the bald eagle ring float. FIG. 3 is a rear elevational view thereof. FIG. 4 is a right side elevational view thereof. FIG. 5 is a left side elevational view thereof. FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines depict surface indicia that forms no part of the claimed design.

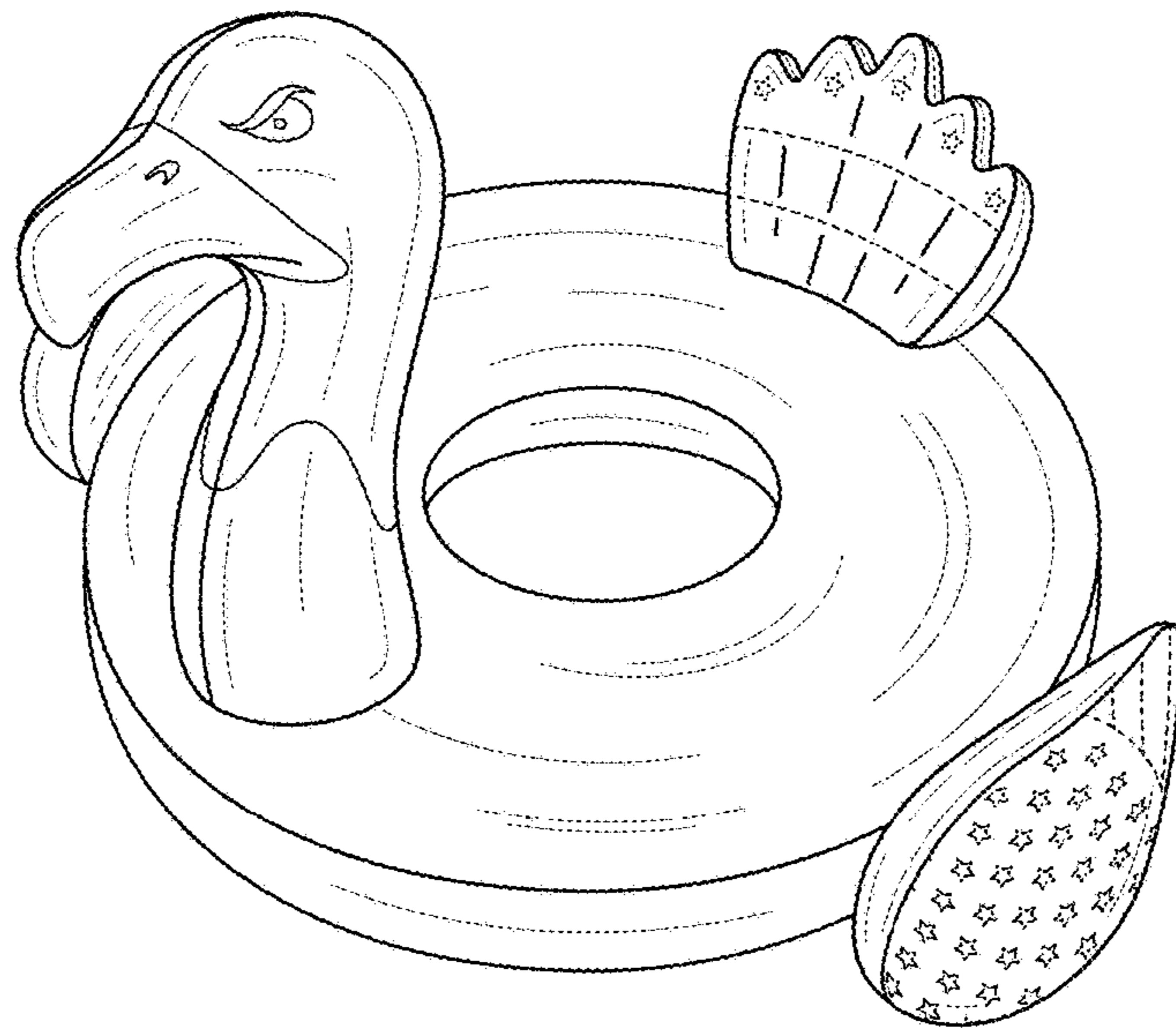

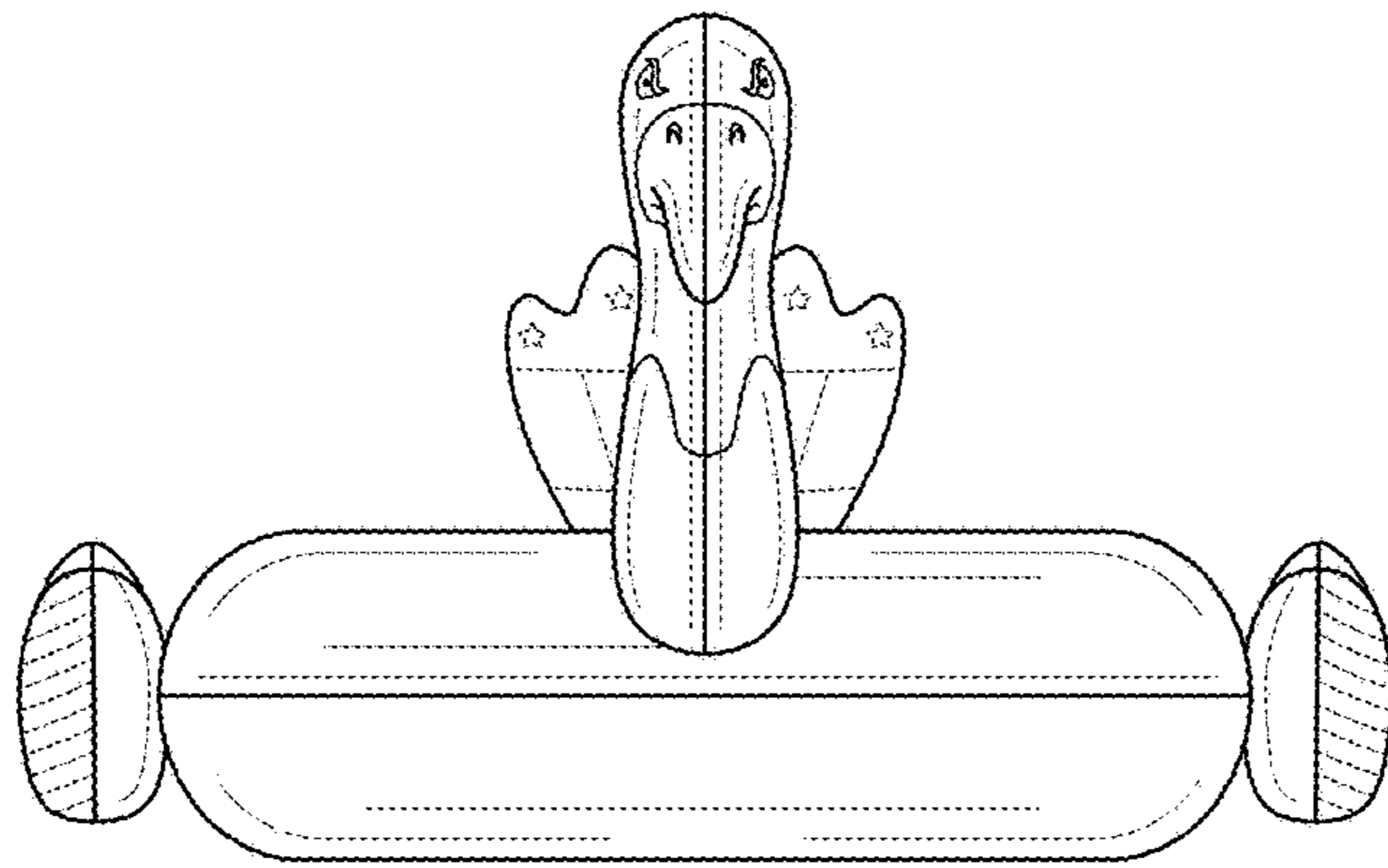

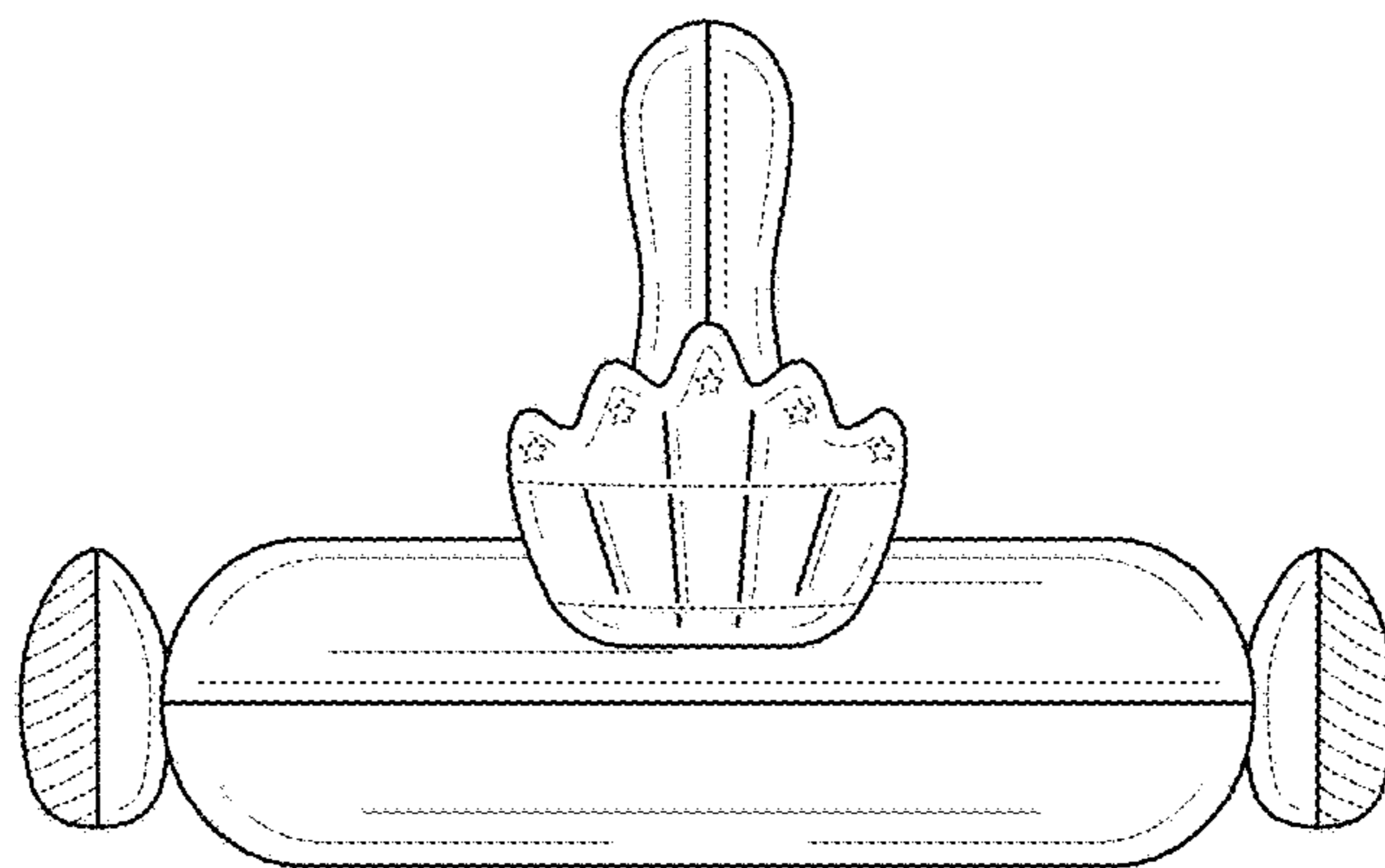

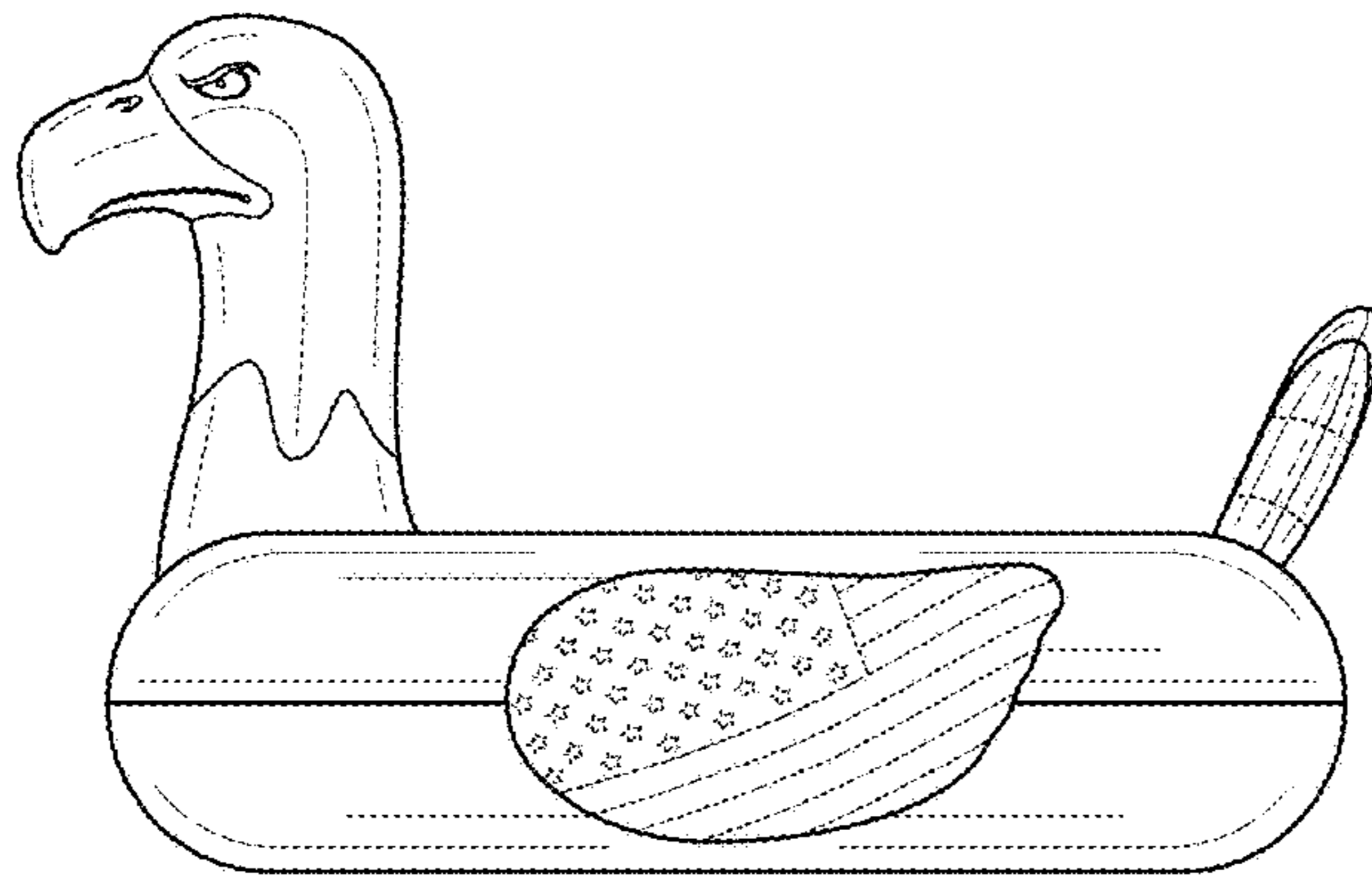

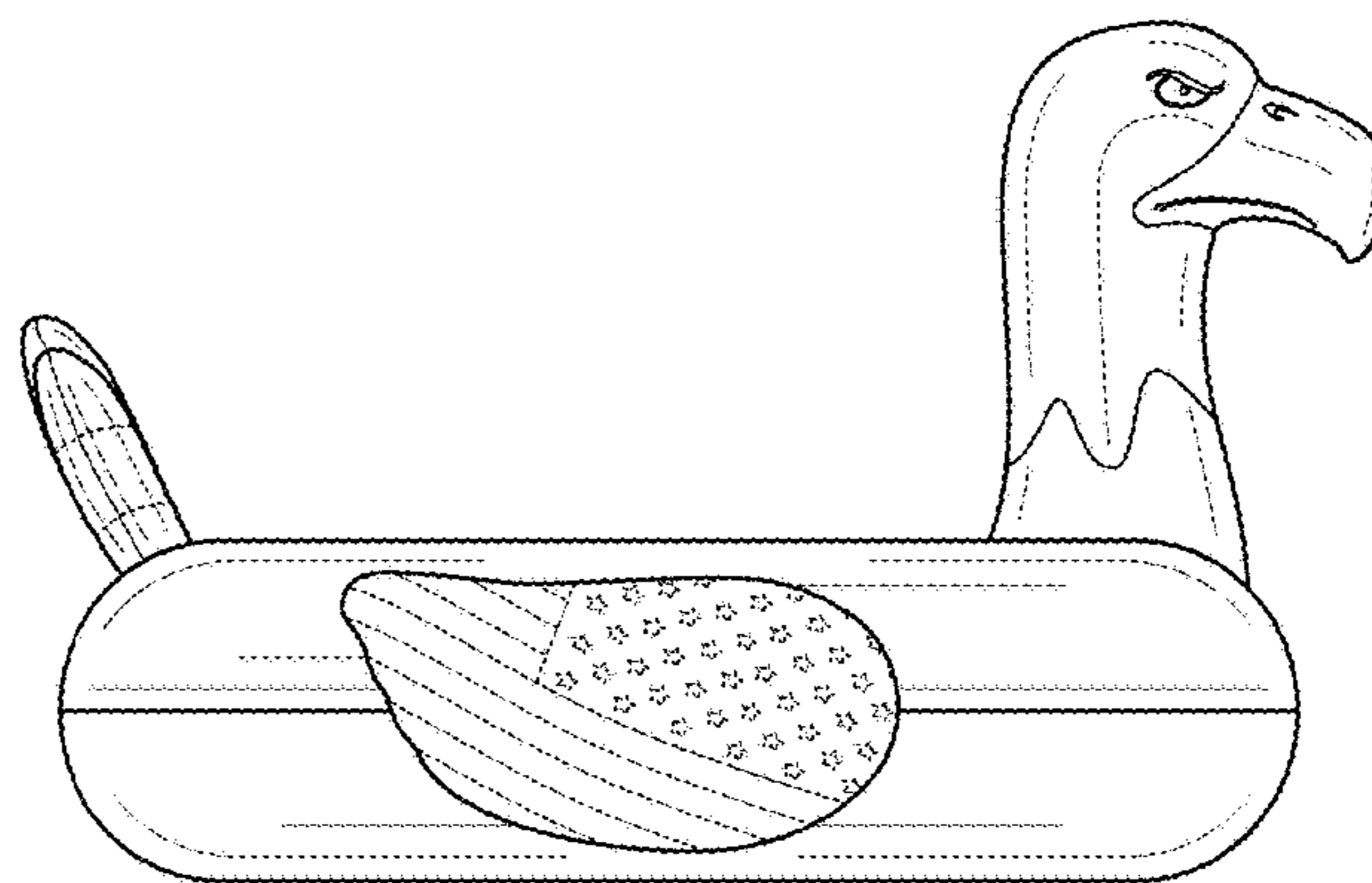

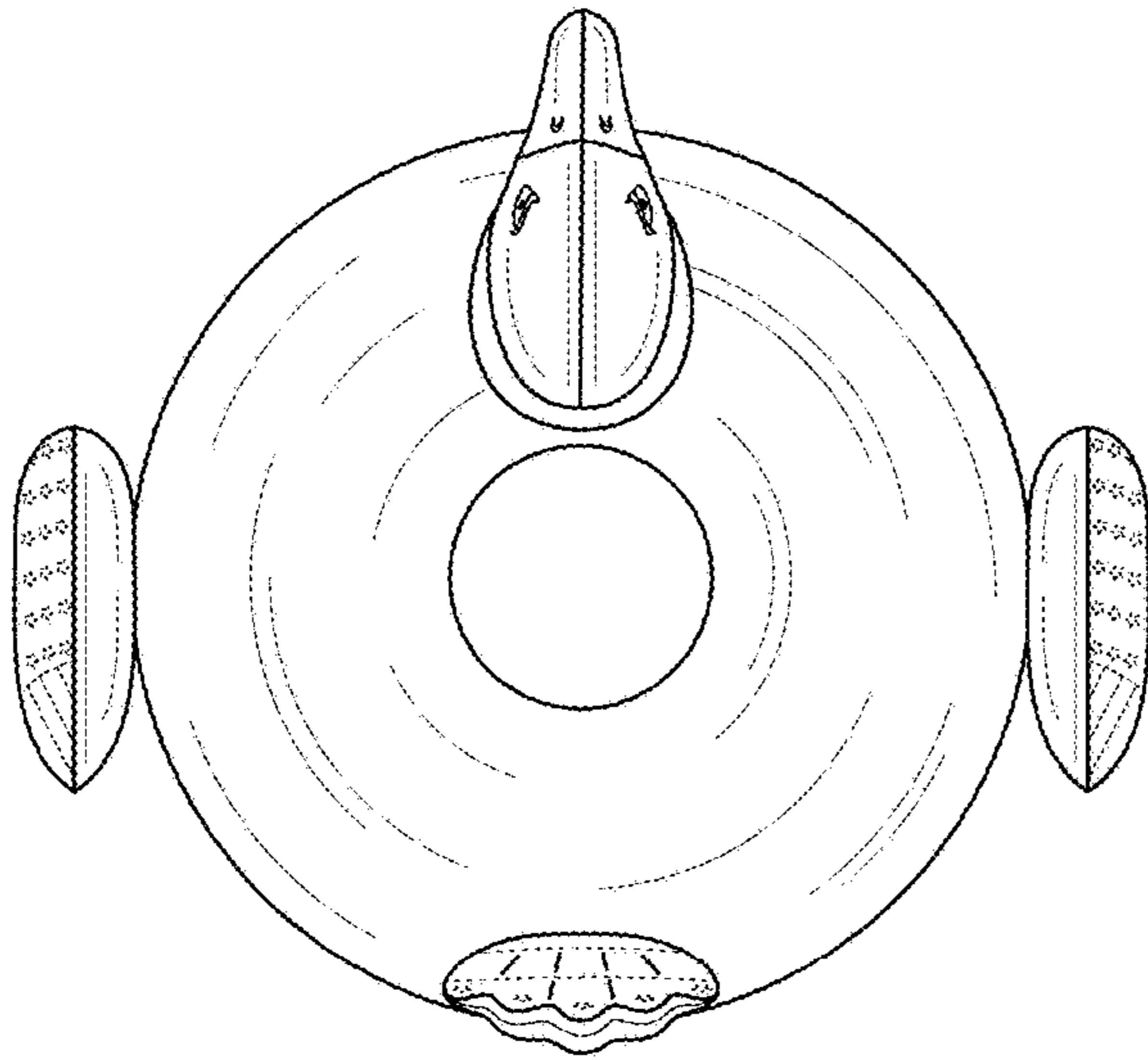

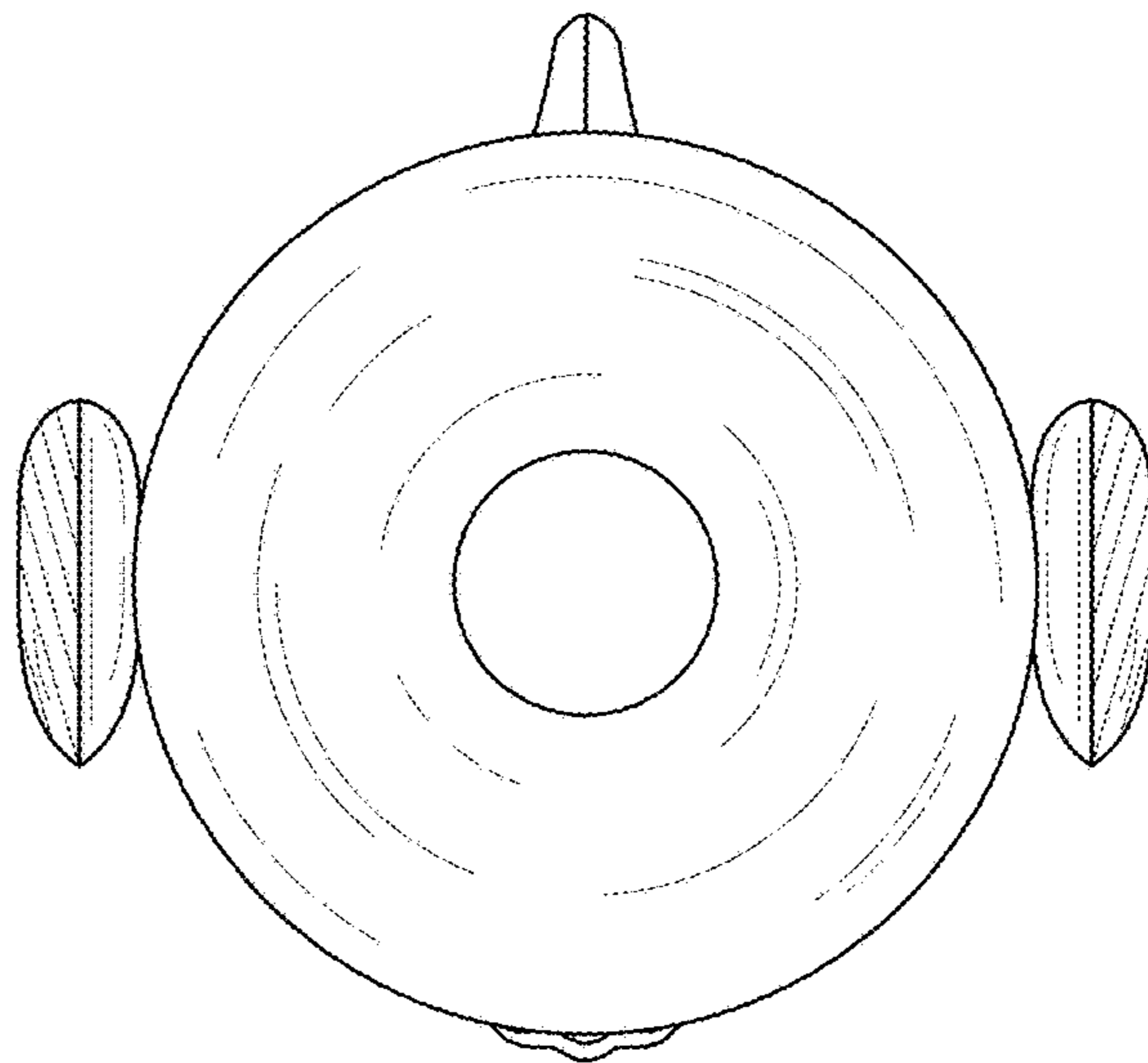
