are identical;

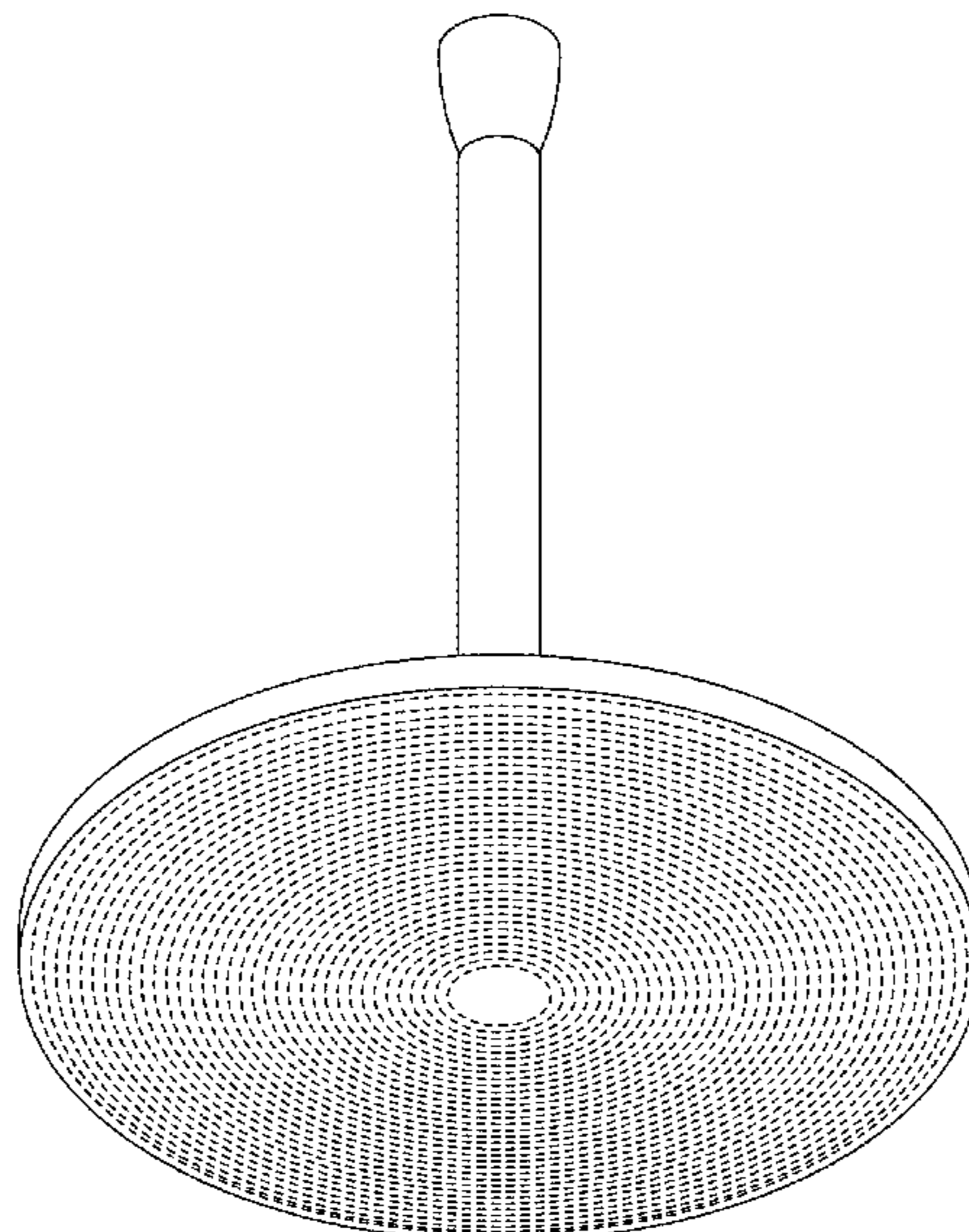
FIG. 3 is a bottom plan view thereof;

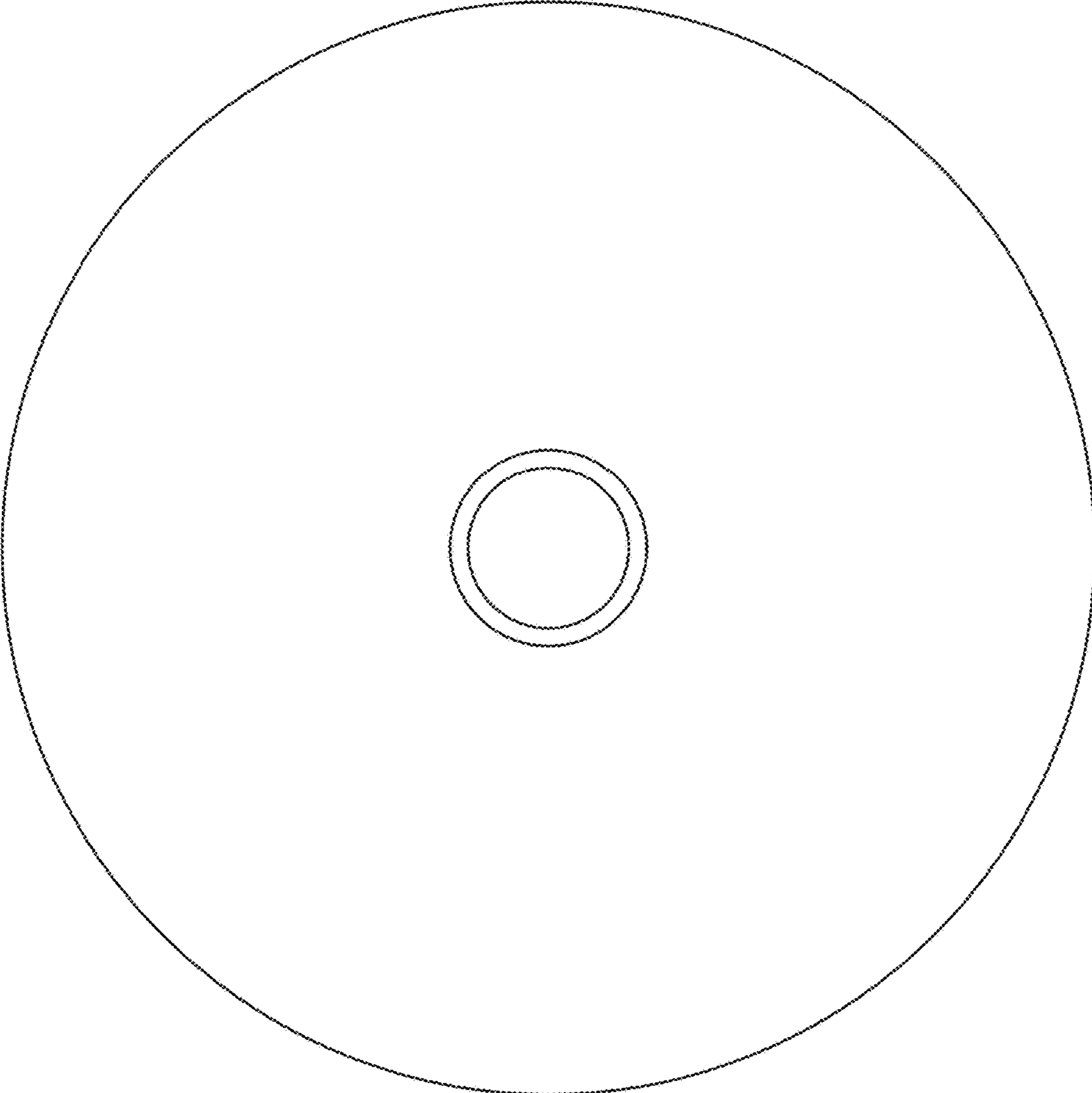

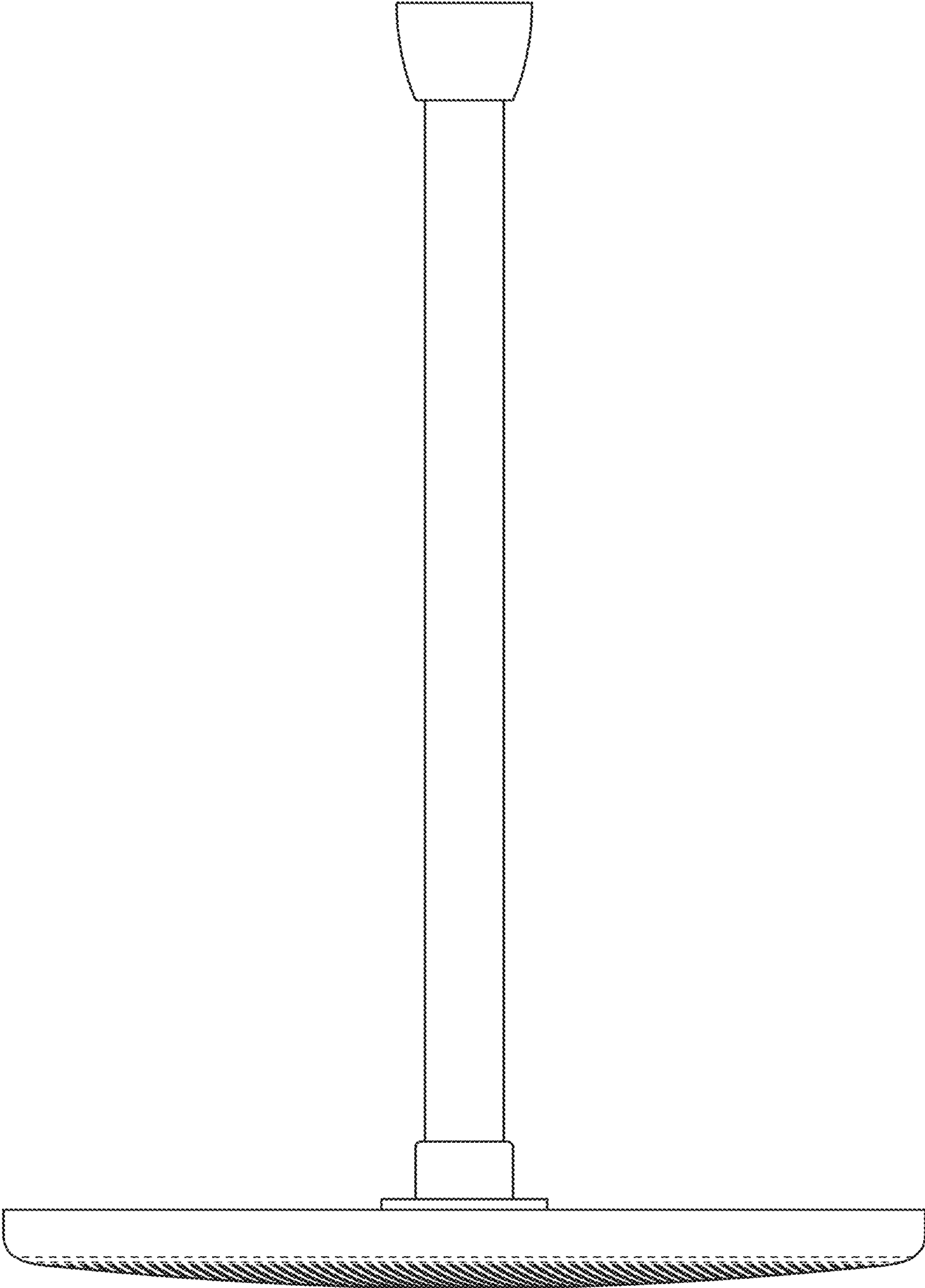

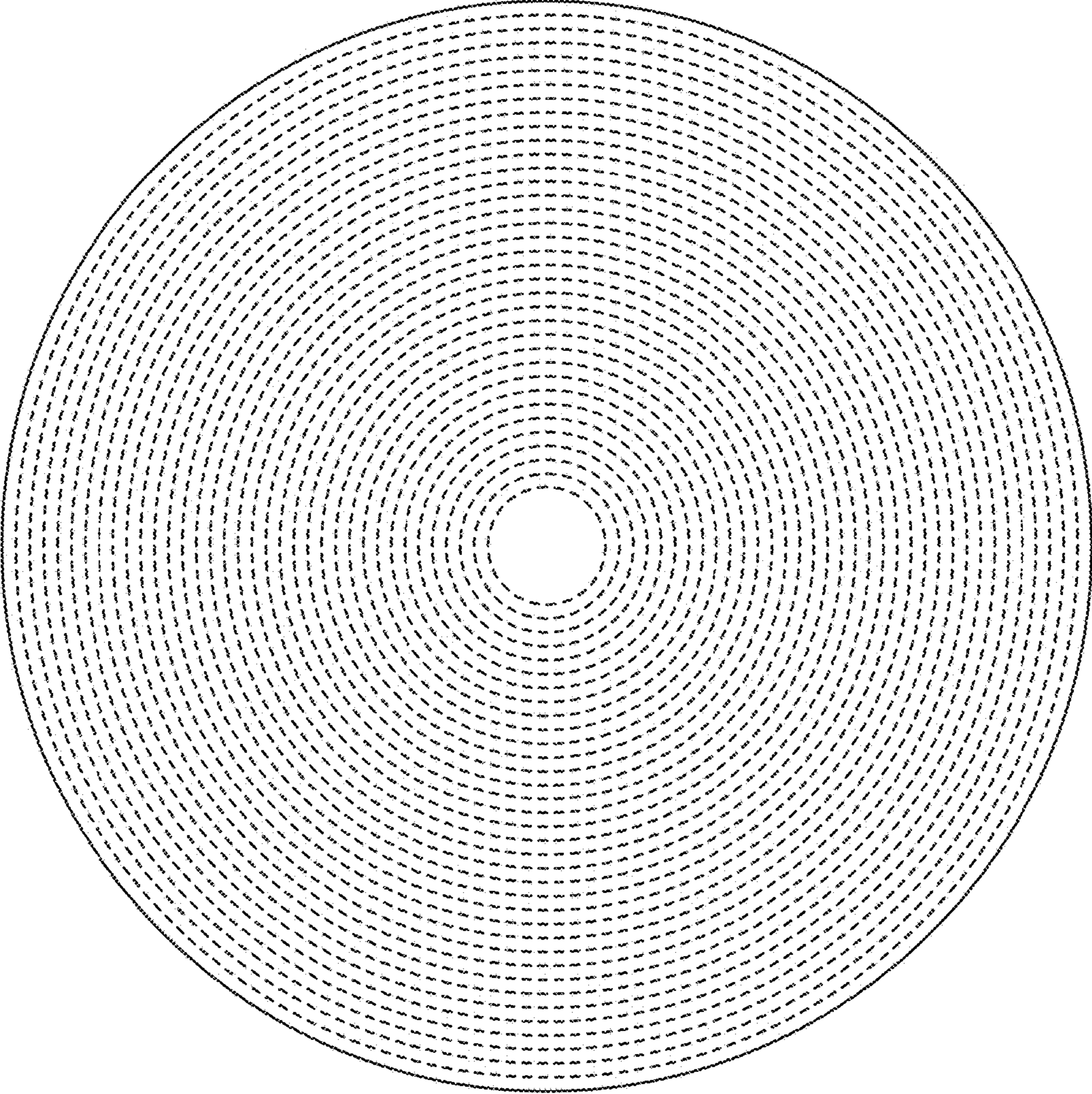

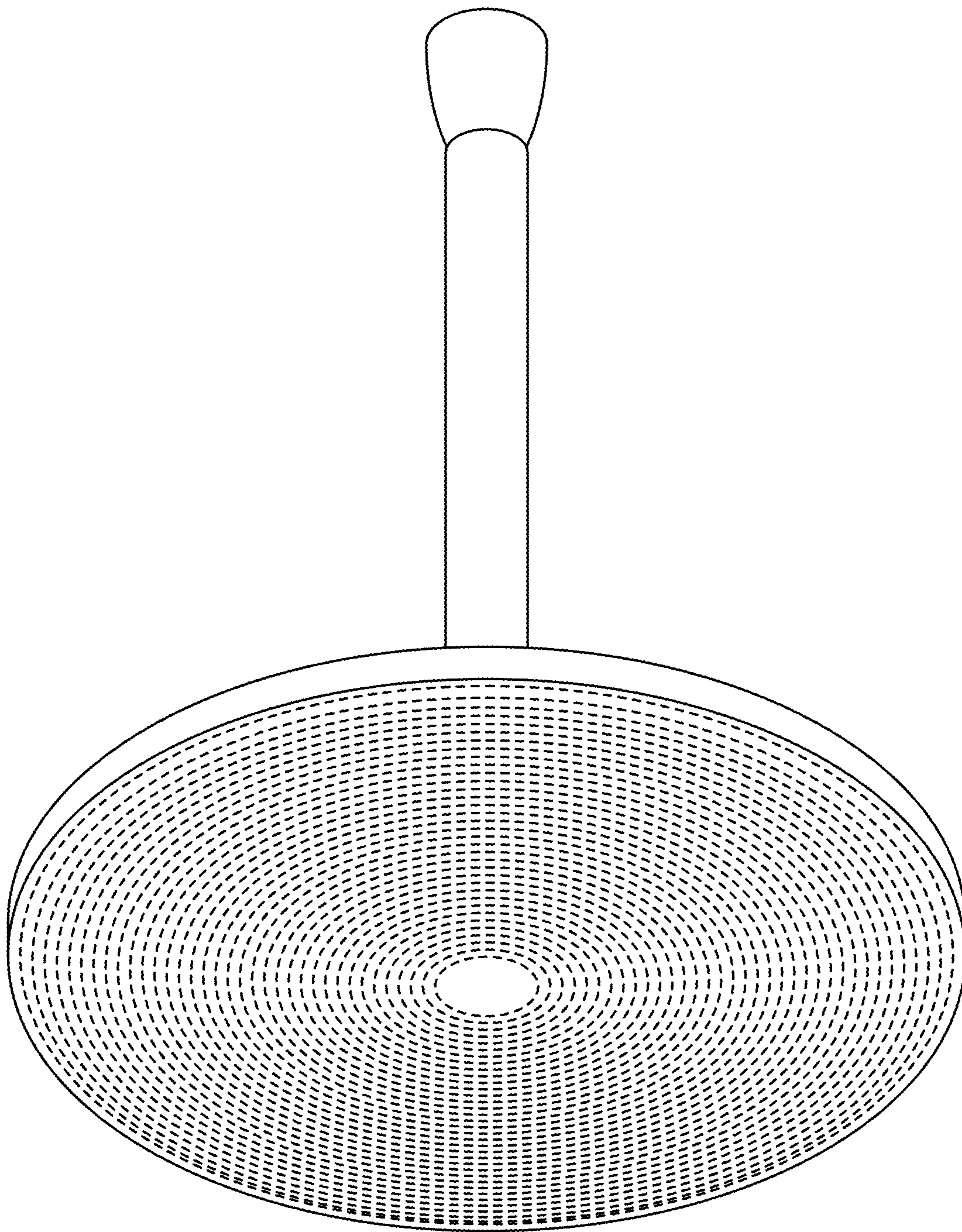

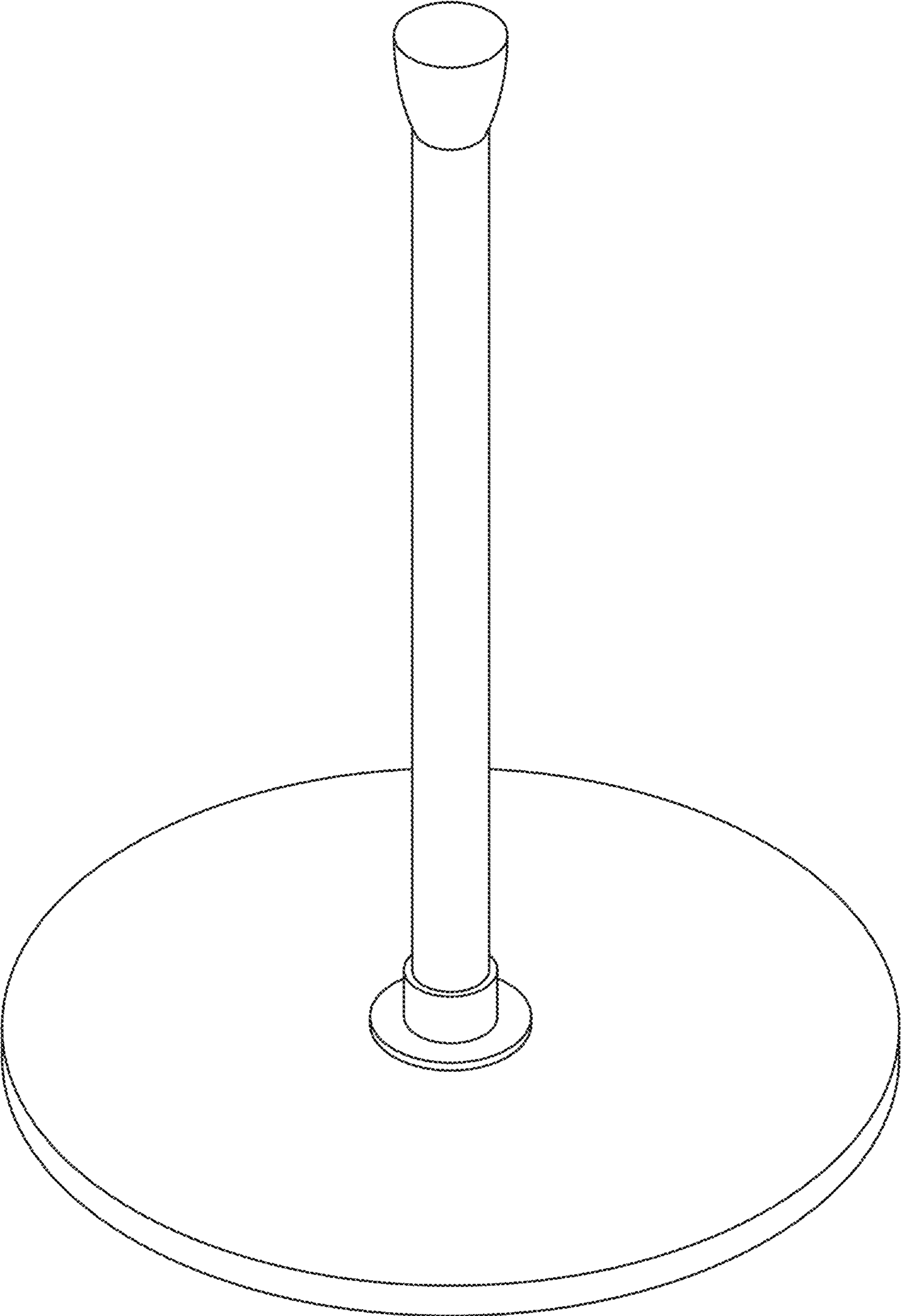
