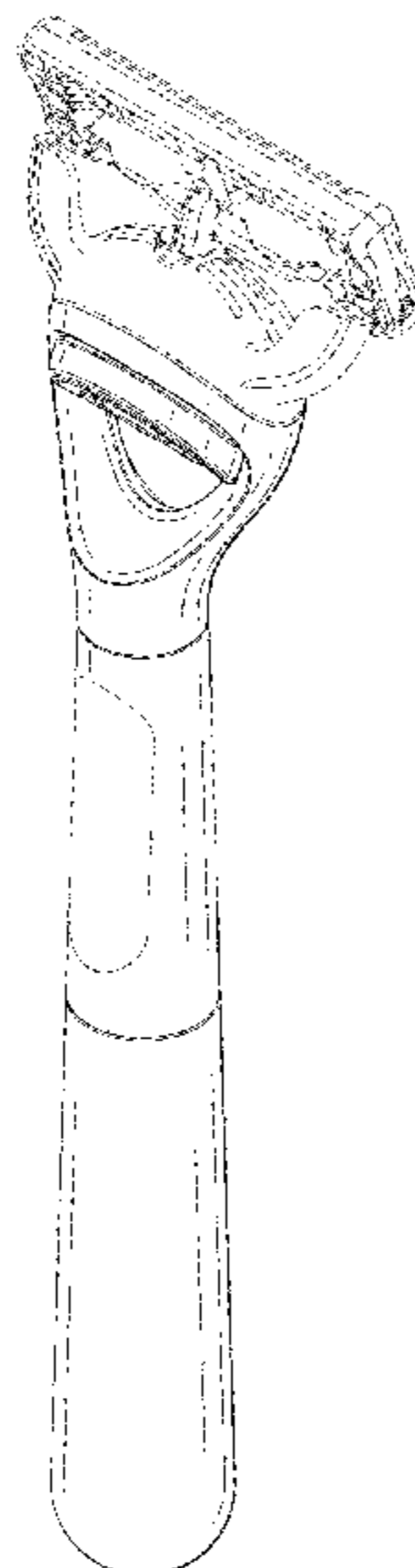
(57) **CLAIM**

The ornamental design for a shaving razor handle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shaving razor handle showing our new design;  
 FIG. 2 is a top view thereof;  
 FIG. 3 is a bottom view thereof;  
 FIG. 4 is a right view thereof;  
 FIG. 5 is a left view thereof;  
 FIG. 6 is a rear view thereof;  
 FIG. 7 is a front view thereof; and,  
 FIG. 8 is a rear perspective view thereof.  
 The broken line disclosure of the razor cartridge illustrates the environment and the remaining broken line disclosure illustrates portions of the handle. None of the broken line disclosure forms part of the claimed design.

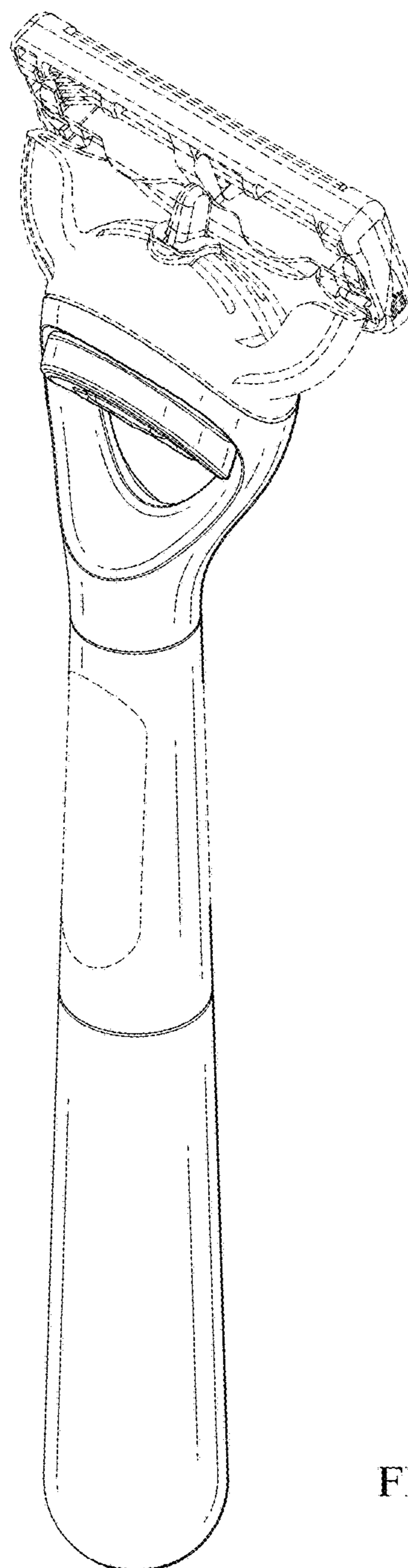
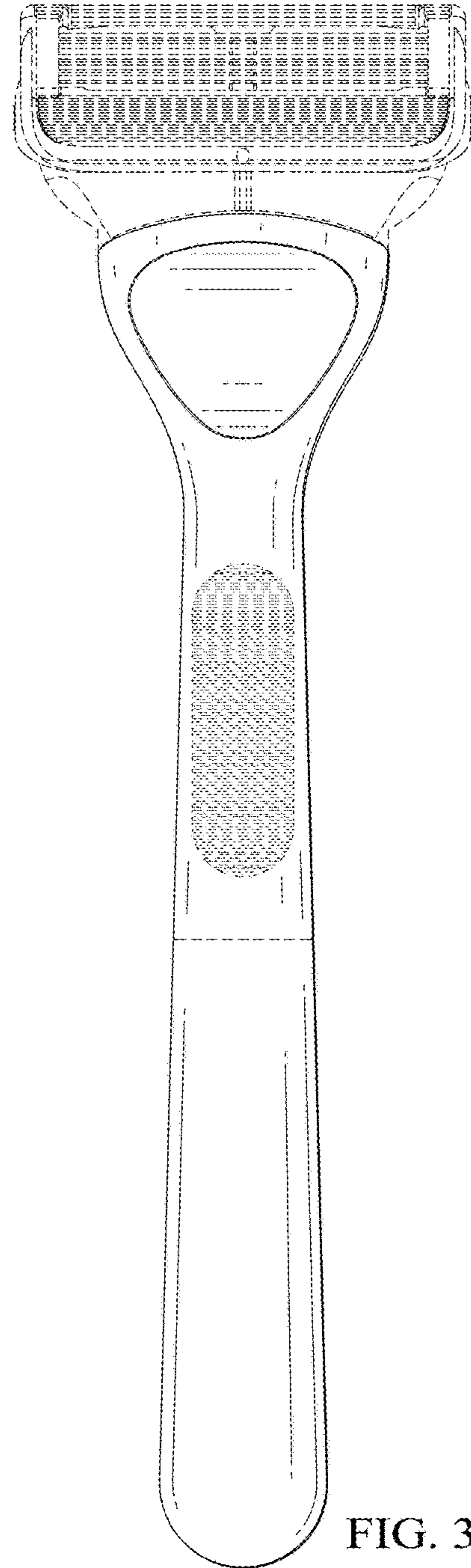
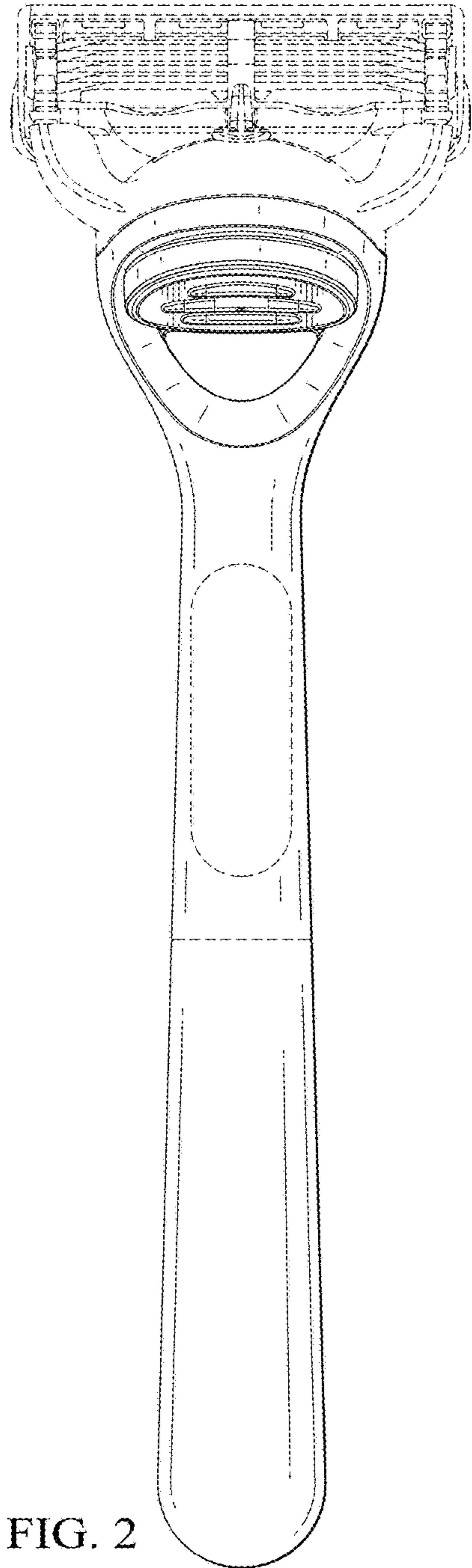

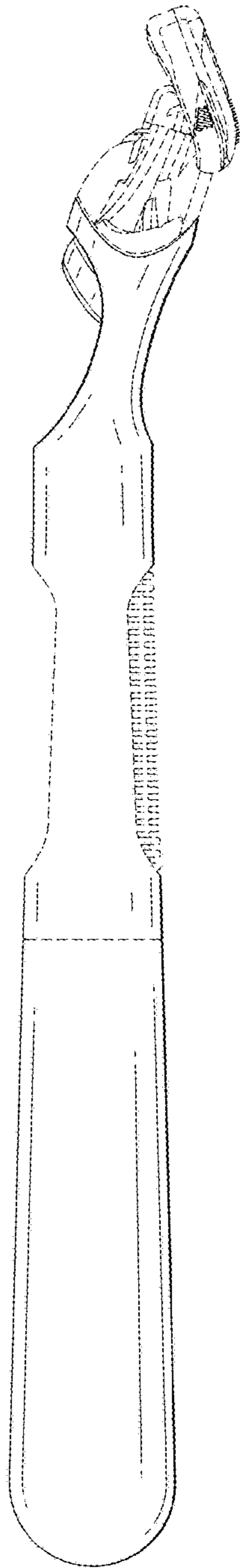

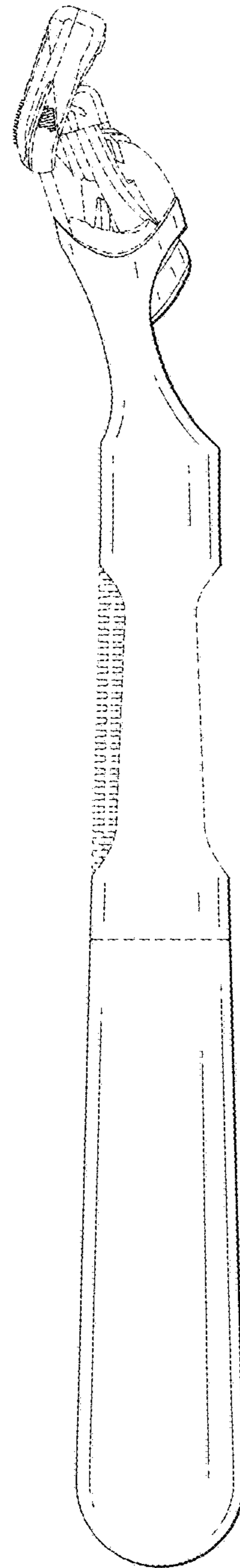

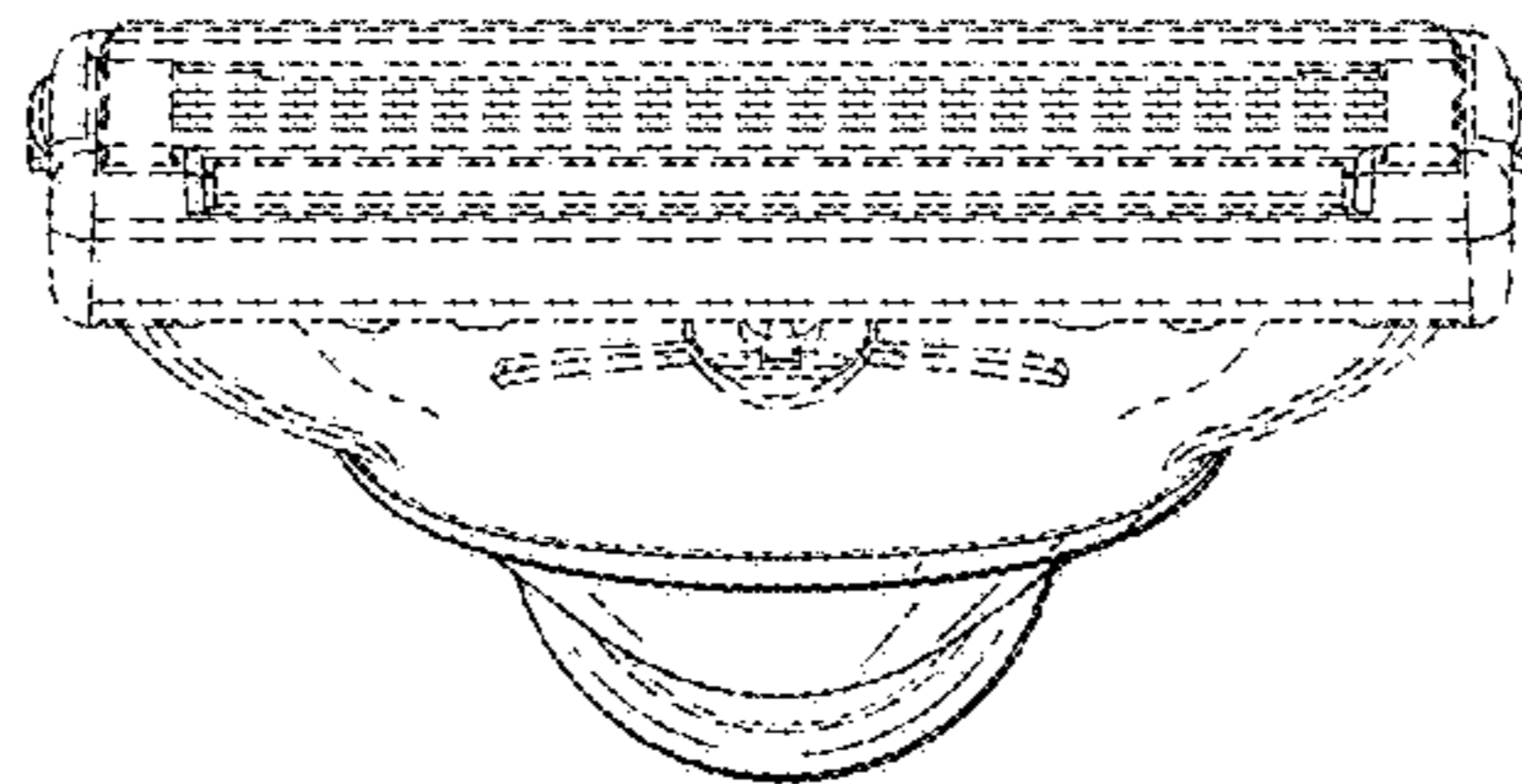

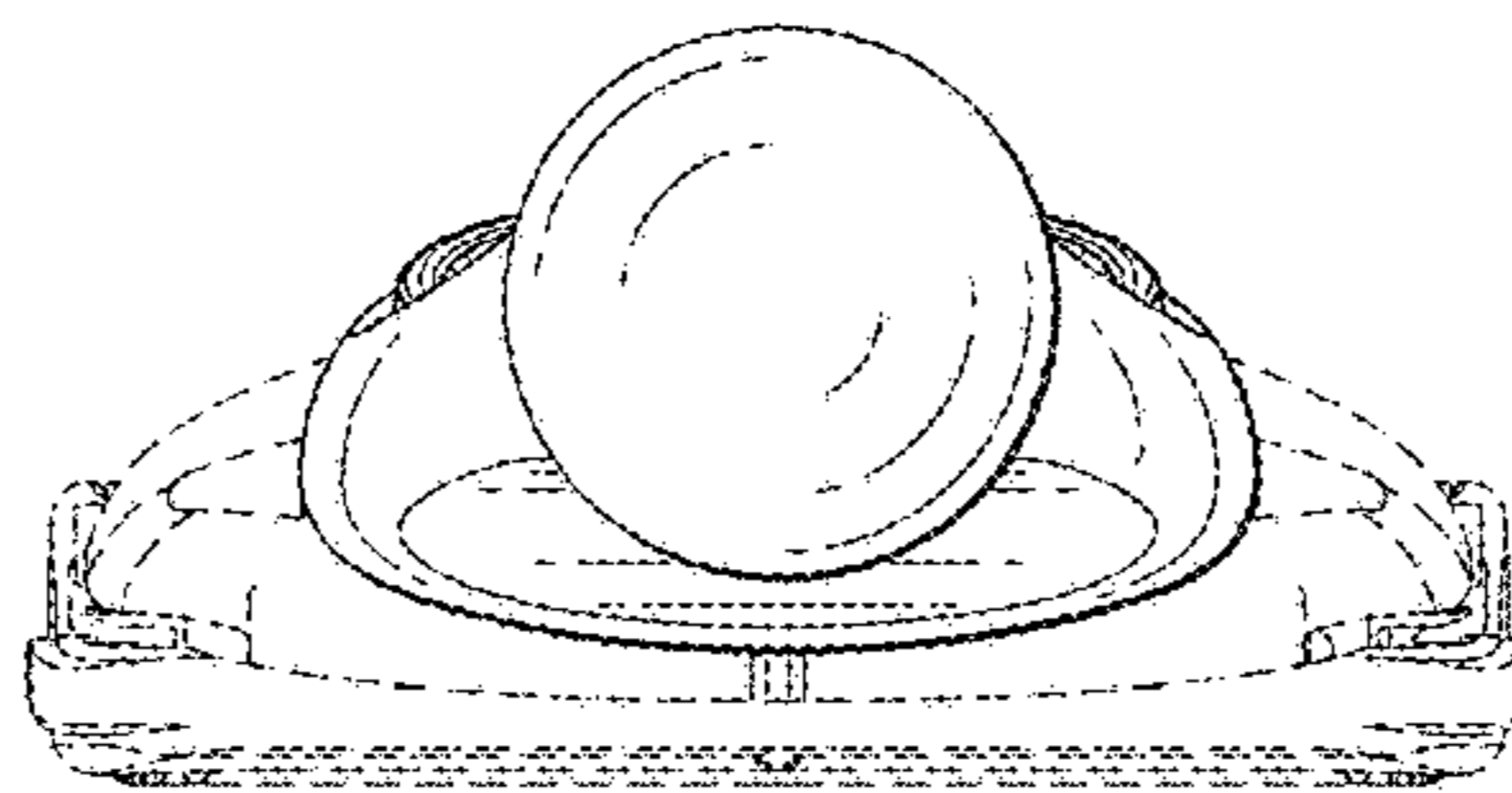

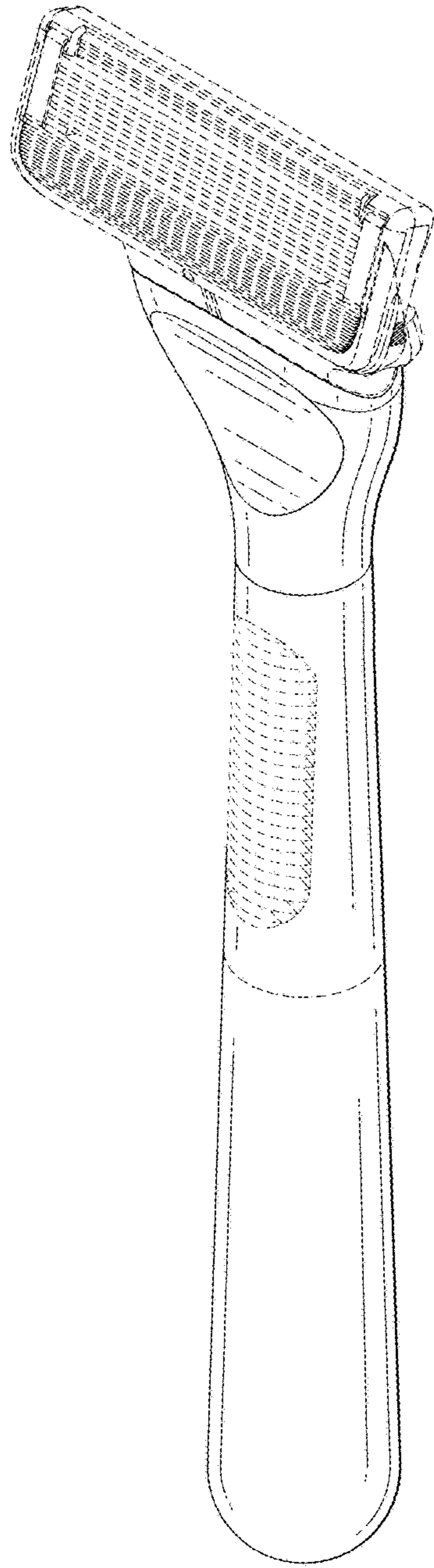
