The ornamental design for a toothbrush, as shown and described.

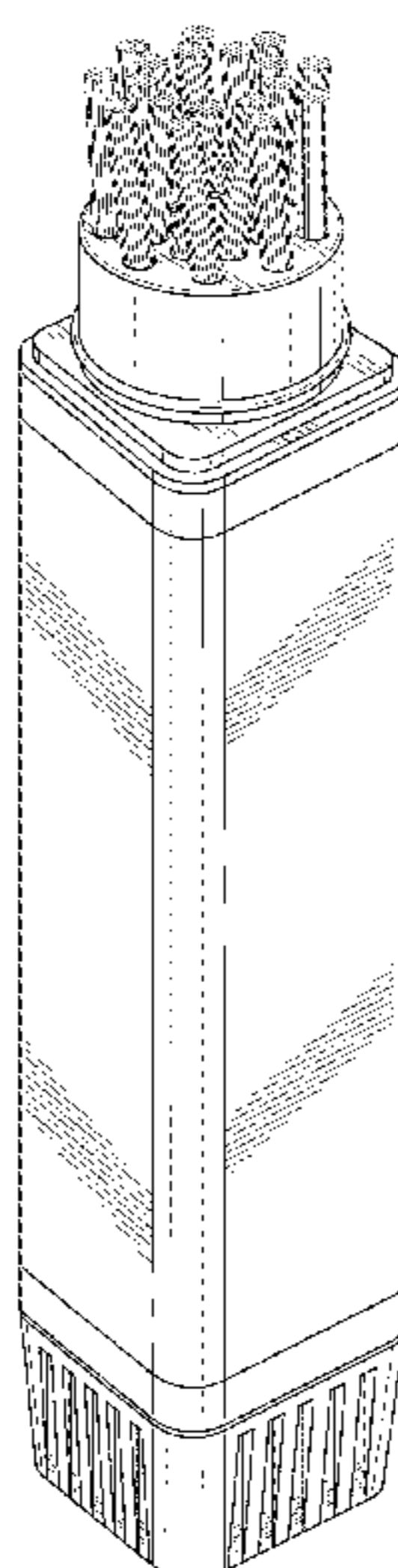
DESCRIPTION

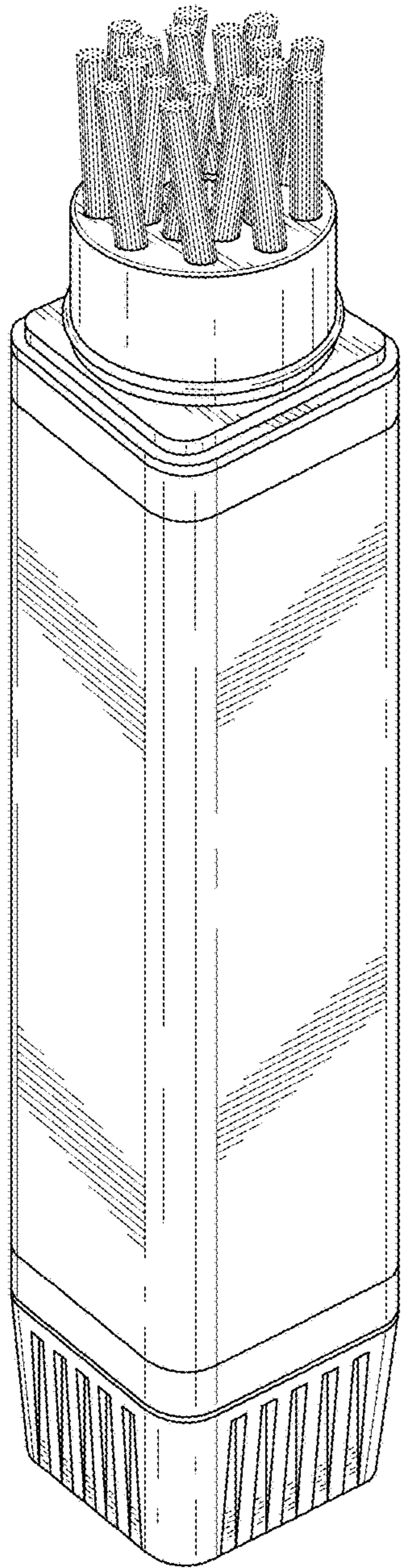

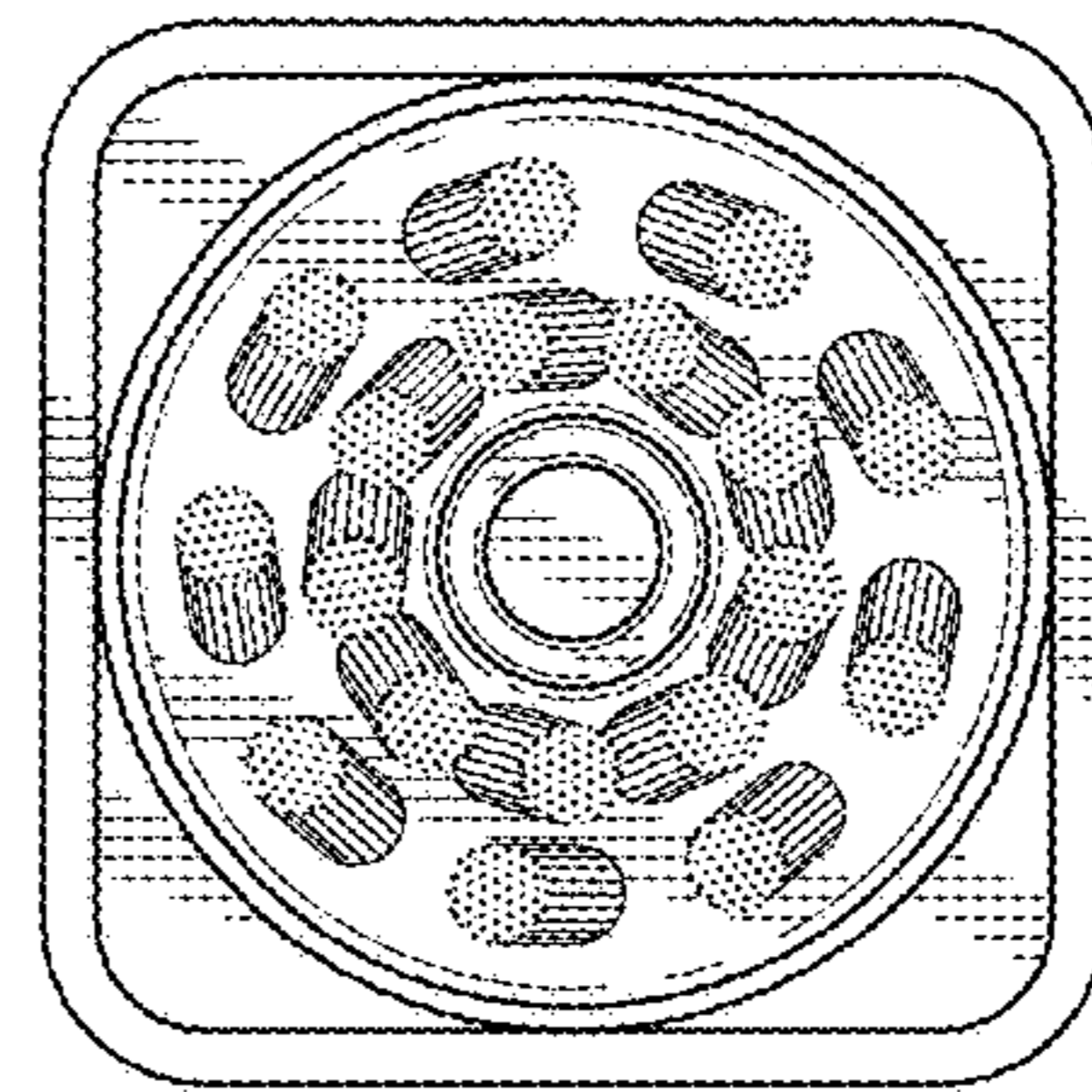

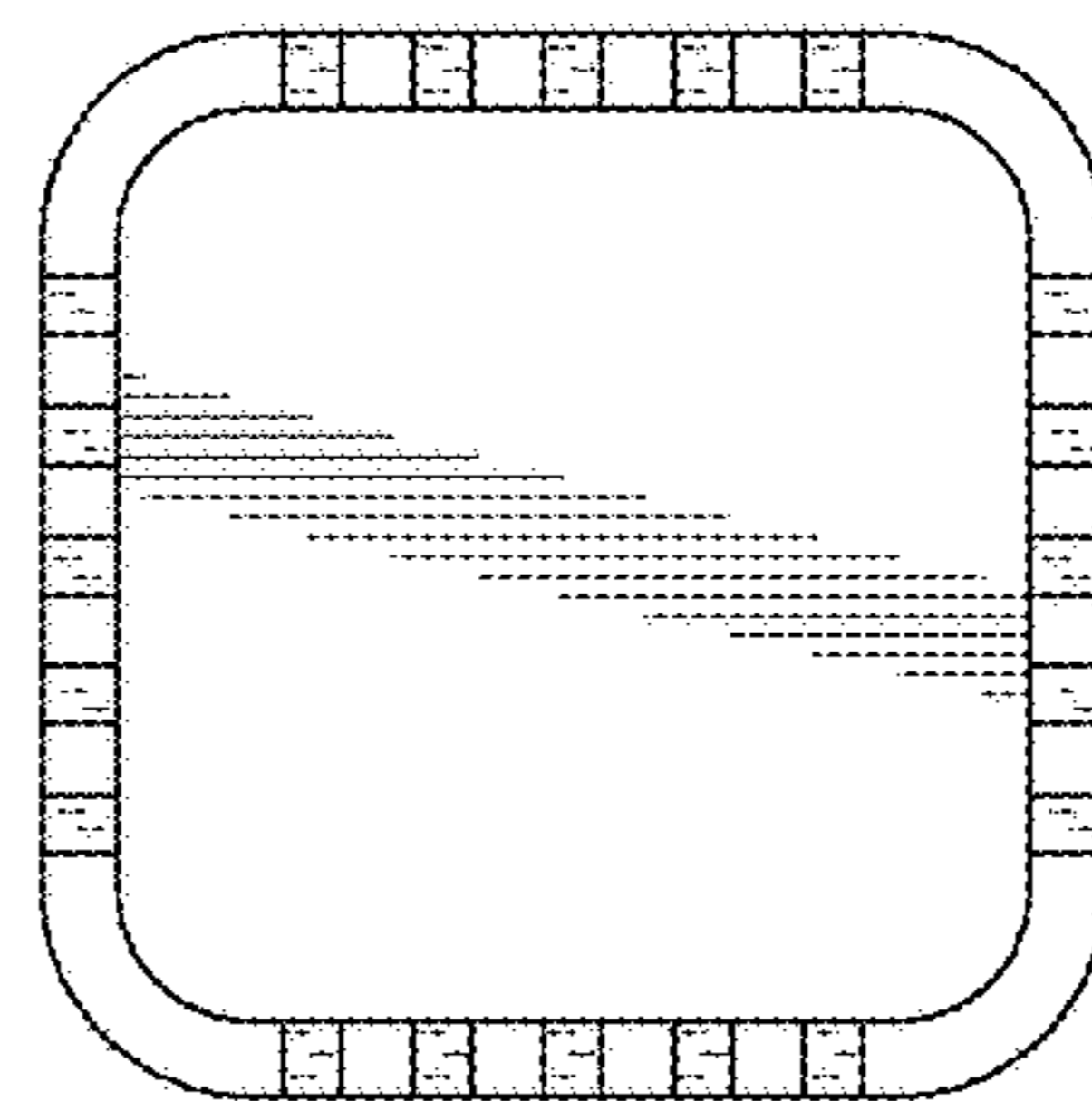

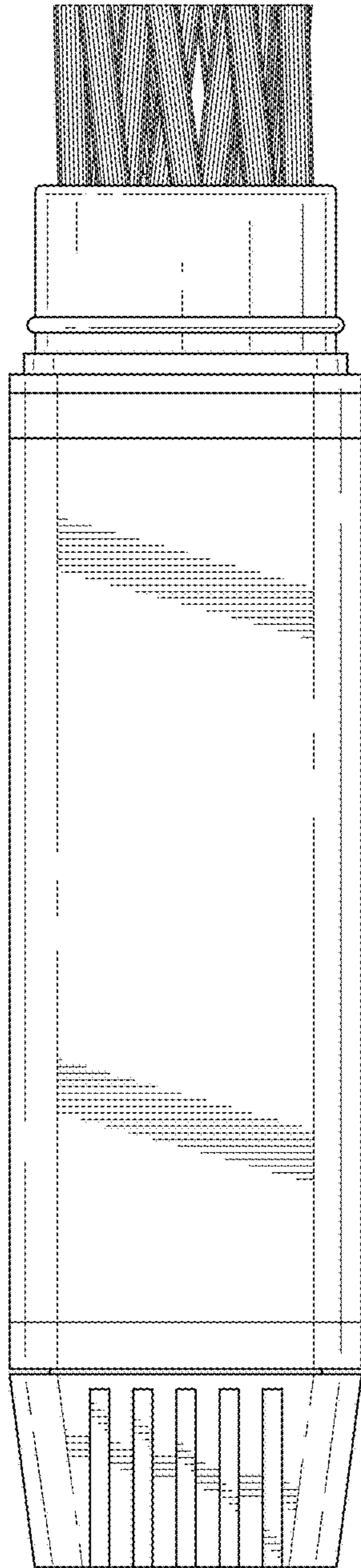

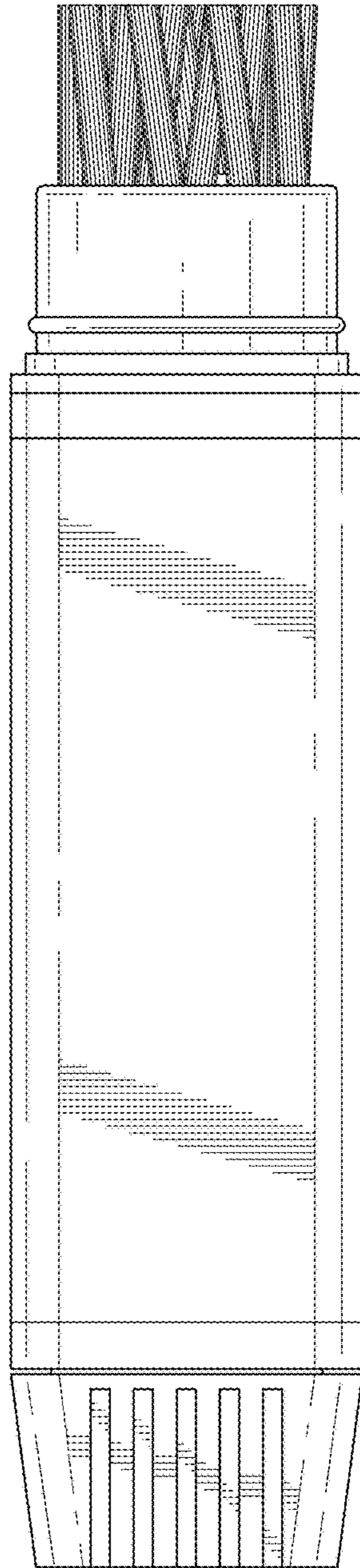

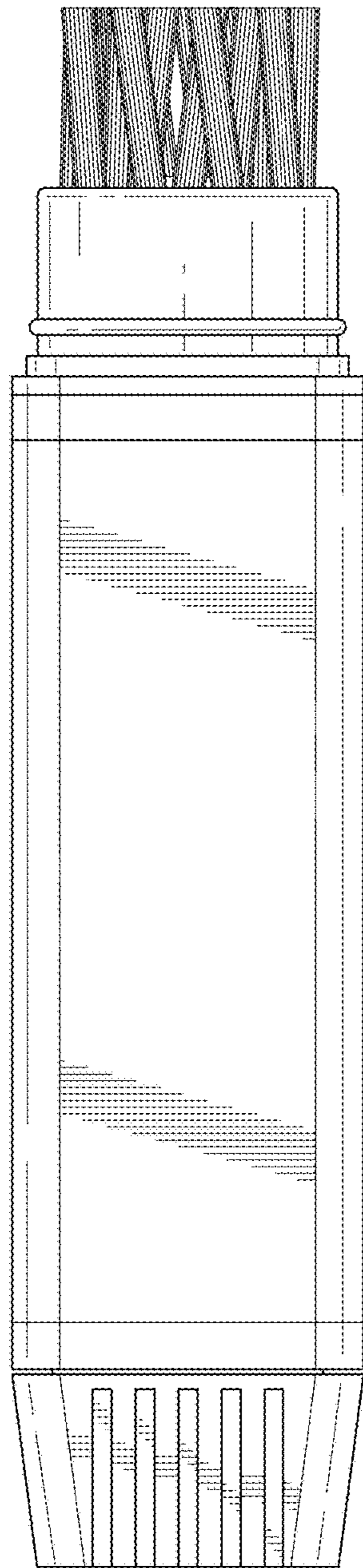

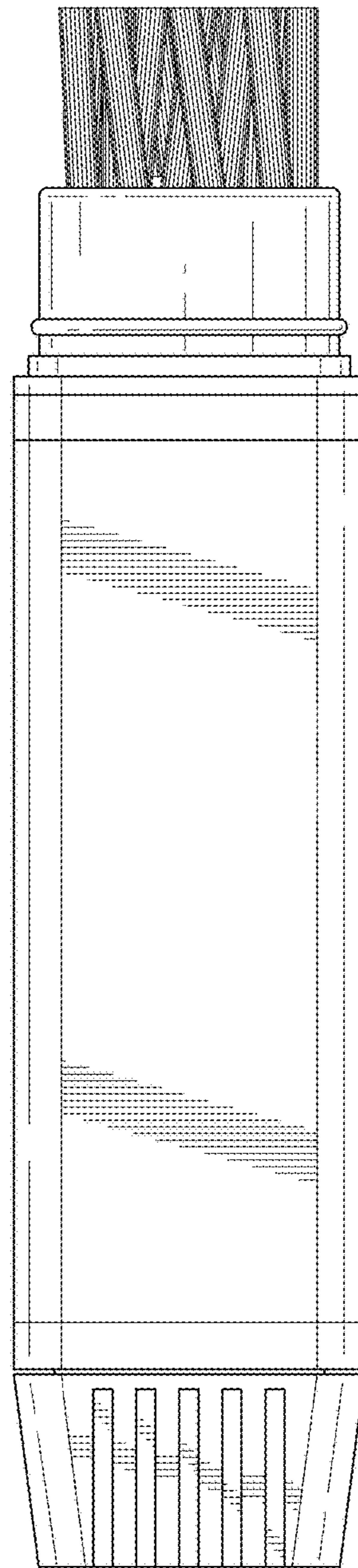
