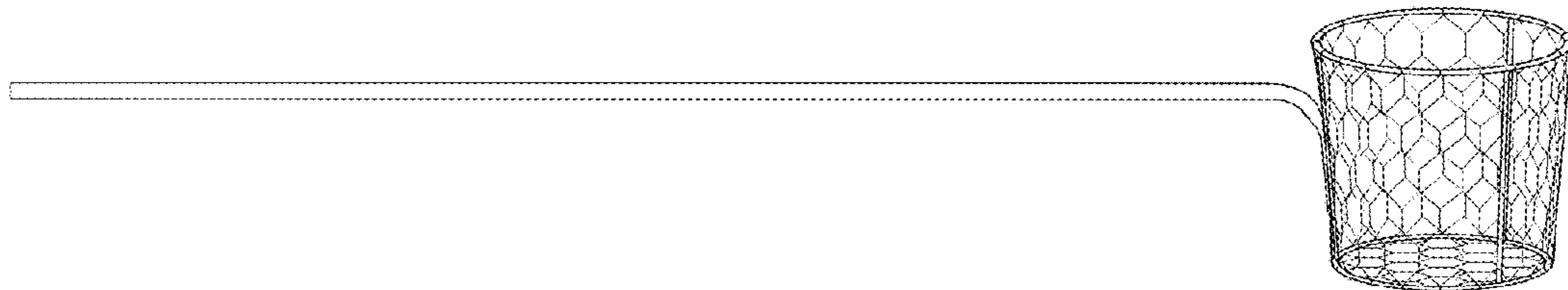
(57) **CLAIM**

The ornamental design for a chicken retrieval basket, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the chicken retrieval basket. FIG. 2 is an enlarged side elevational view of the chicken retrieval basket with the opposite side being a mirror image of the same. FIG. 3 is an enlarged end elevational view of one end of the chicken retrieval basket. FIG. 4 is an enlarged end elevational view of the other end of the chicken retrieval basket. FIG. 5 is an enlarged top plan view of the chicken retrieval basket; and, FIG. 6 is an enlarged bottom plan view of the chicken retrieval basket.

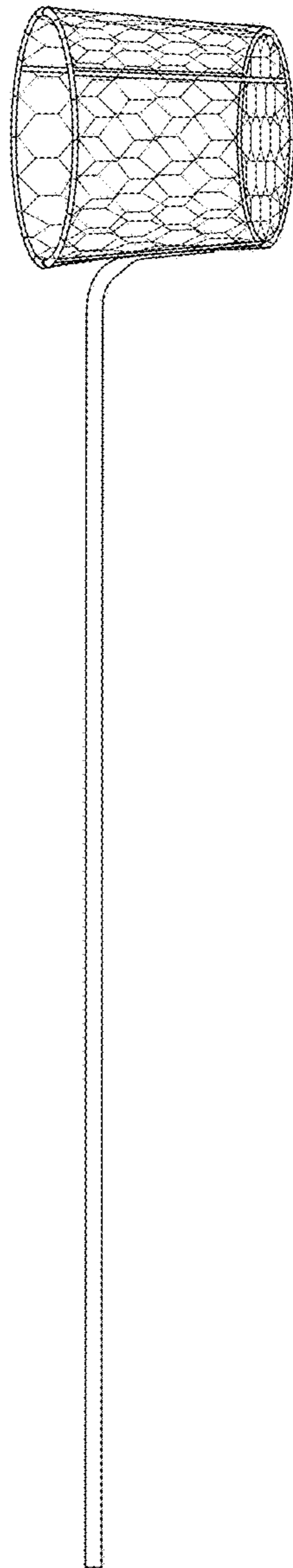

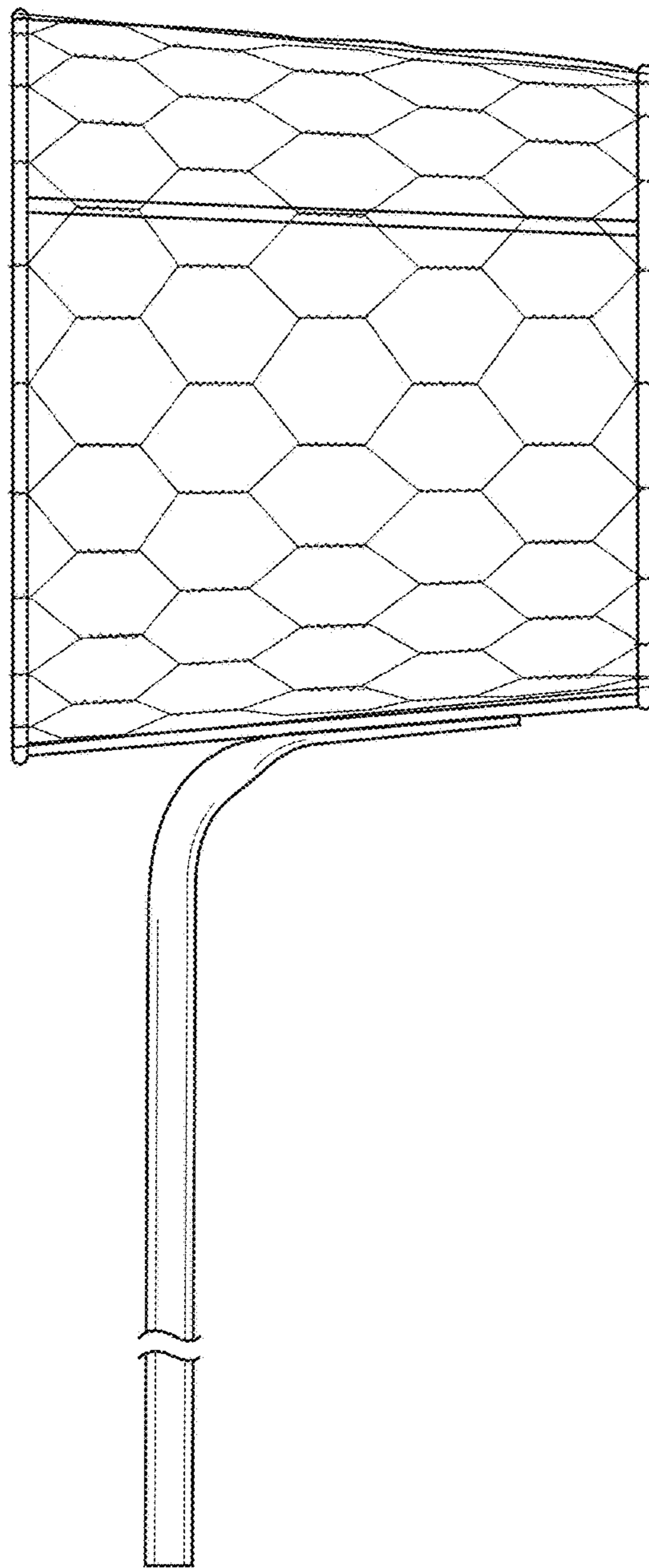

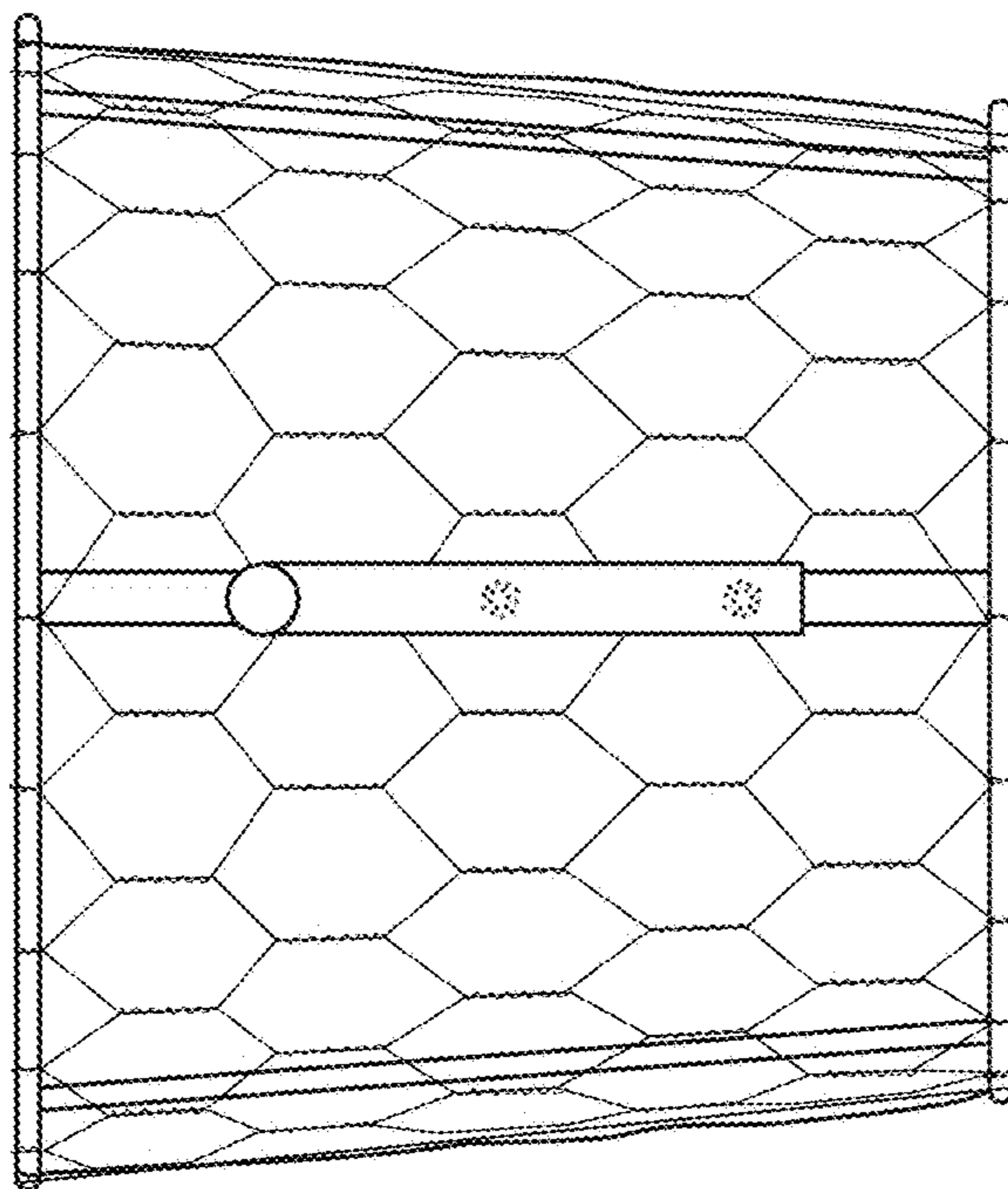

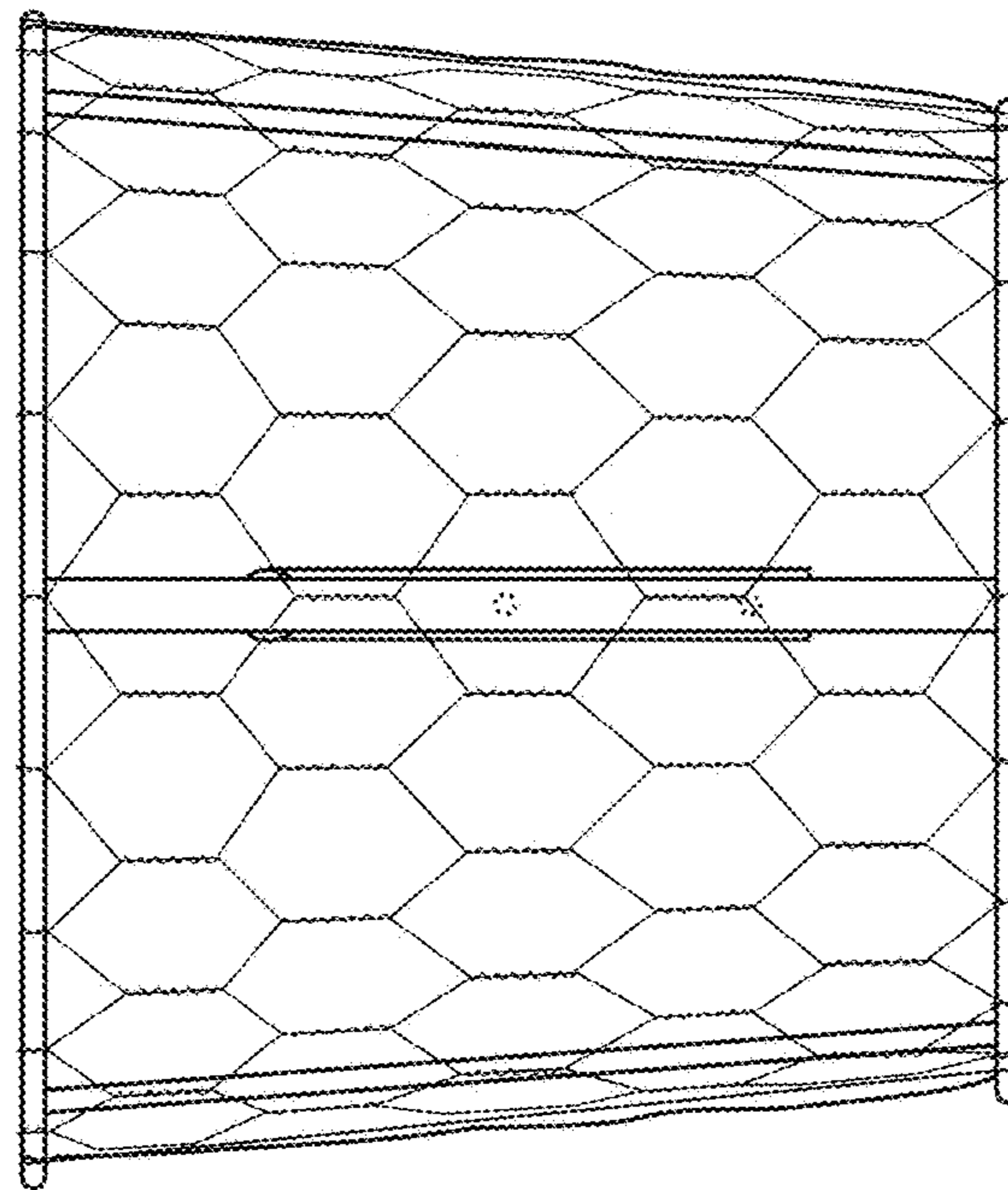

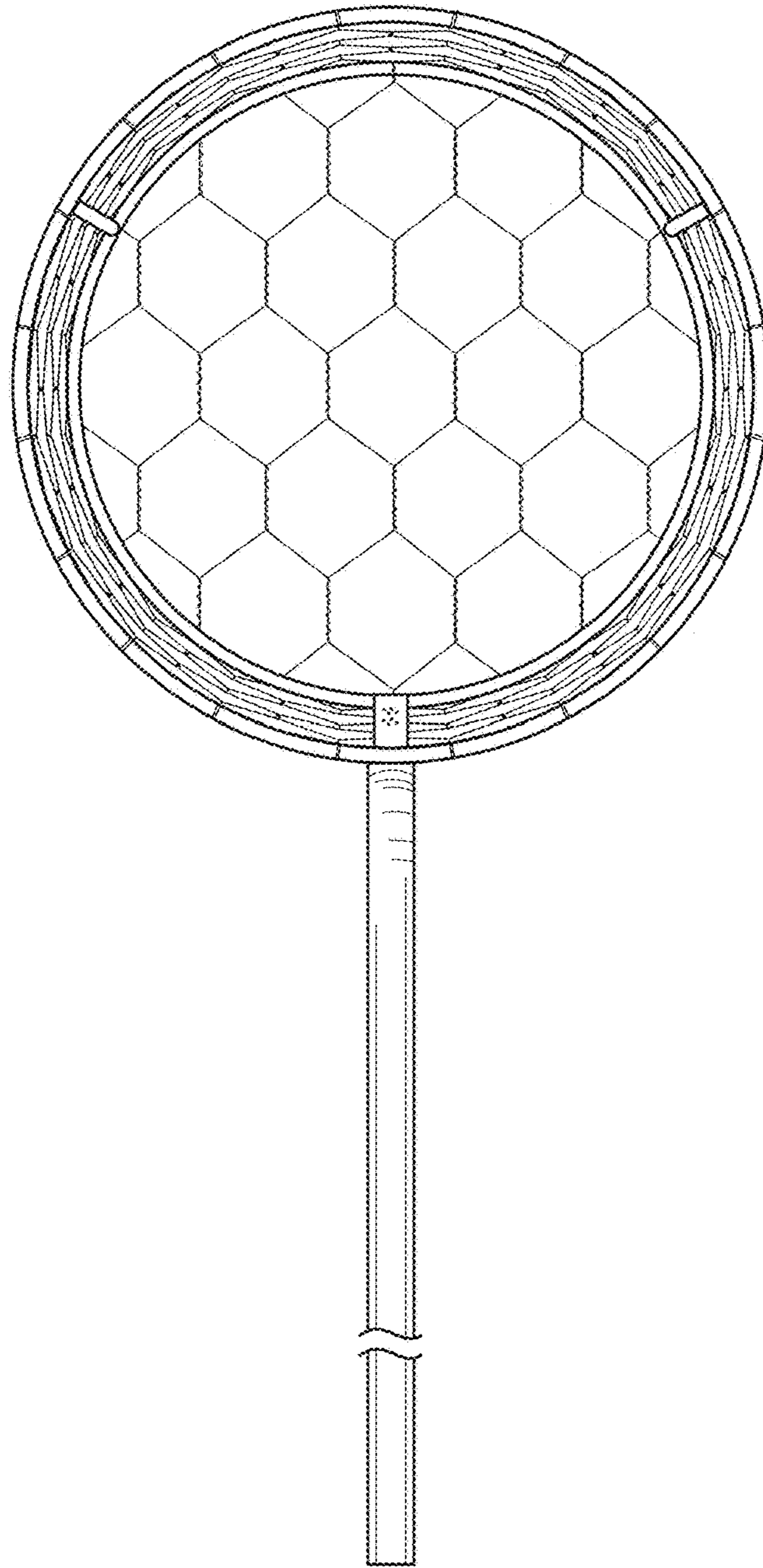

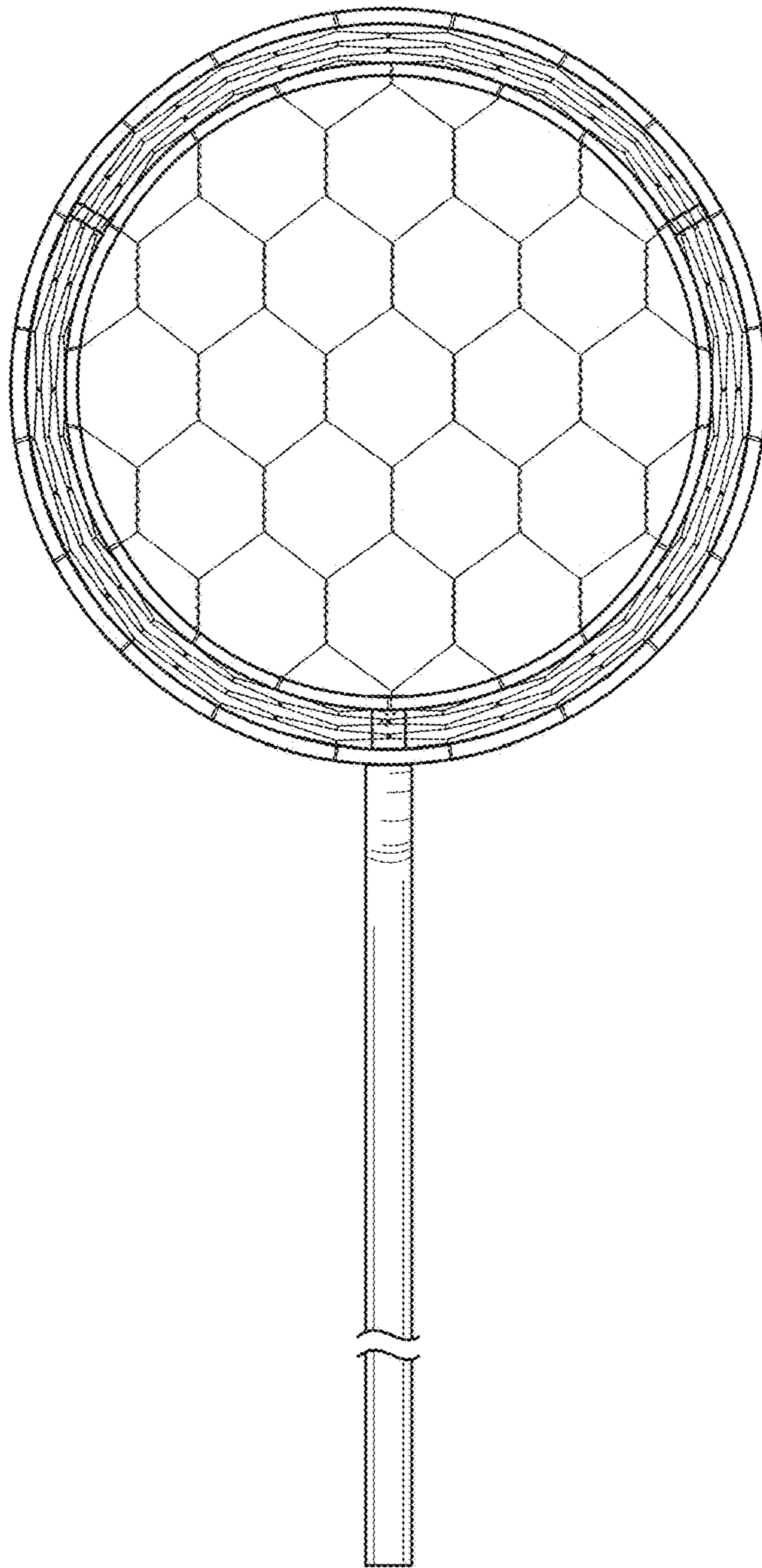
