The ornamental design for a sippy cup, as shown and described.

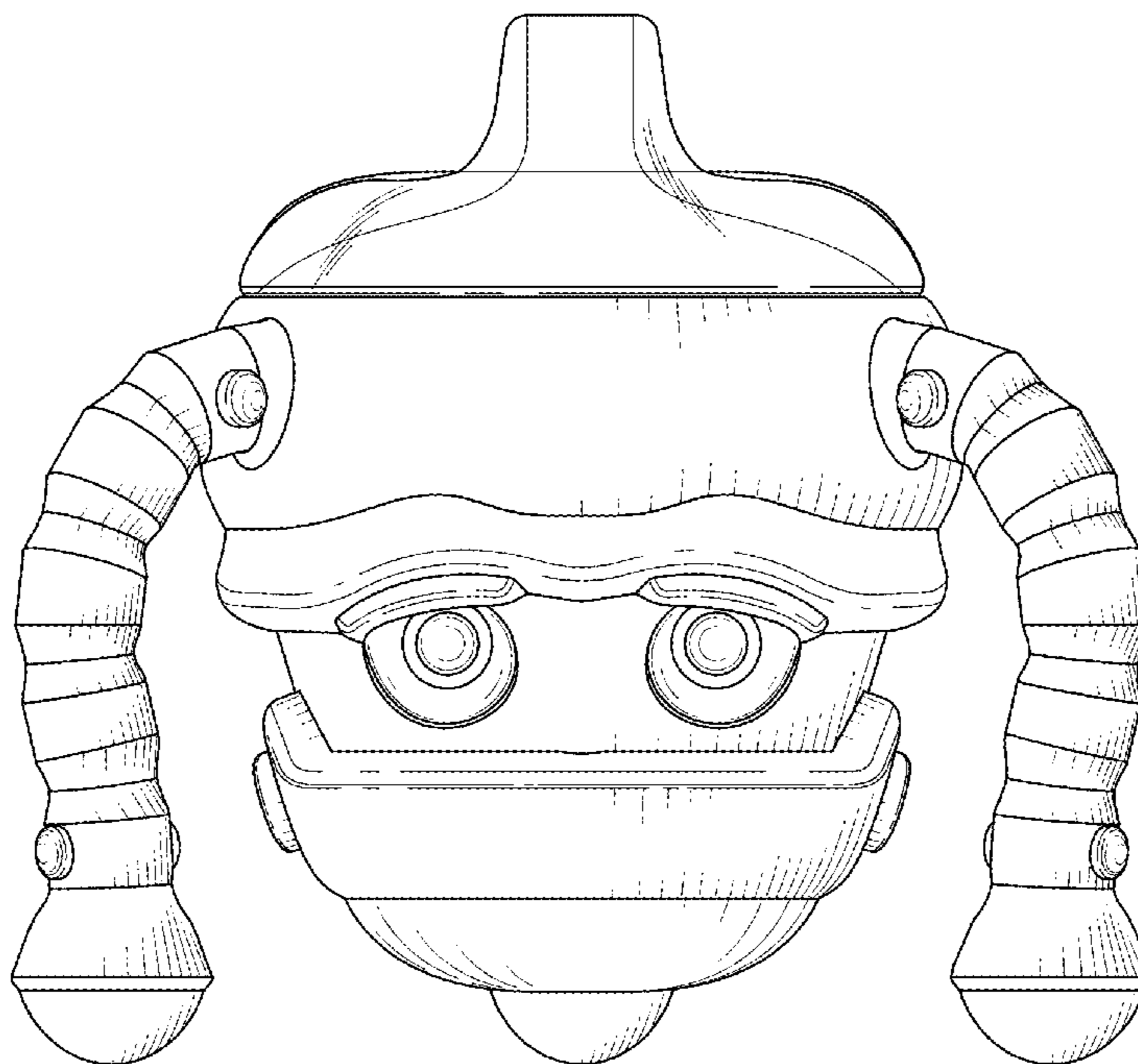
**DESCRIPTION**

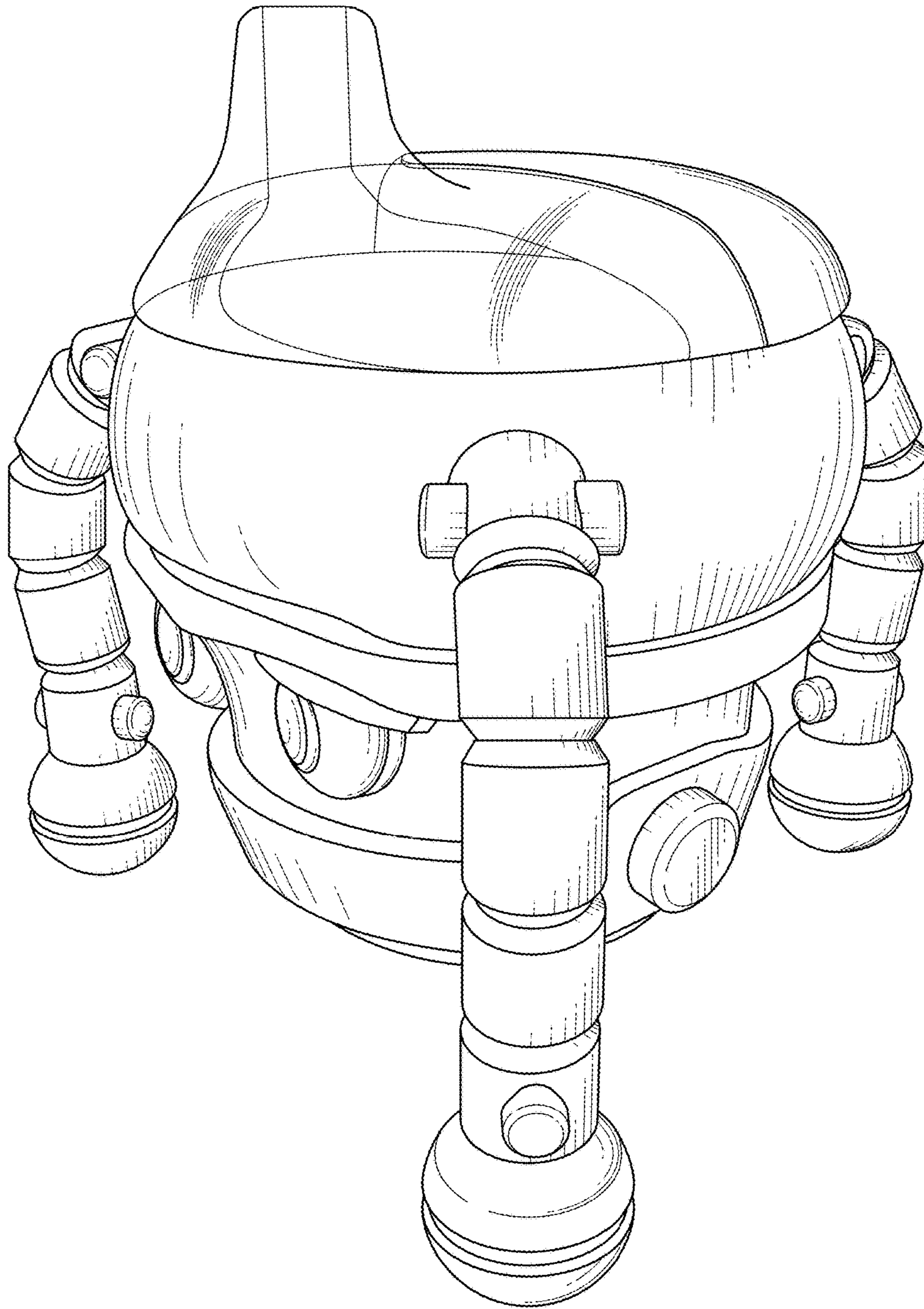

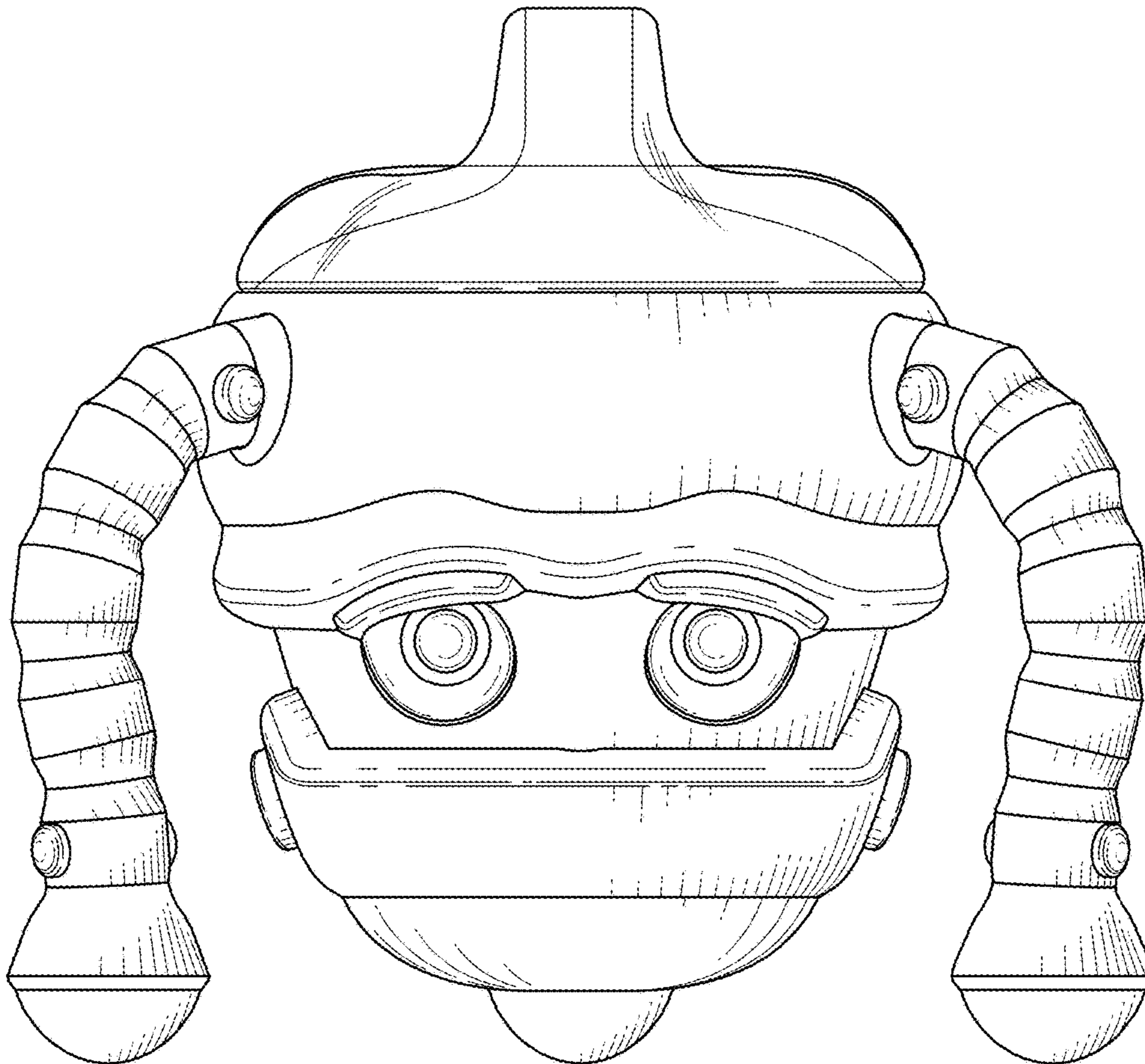

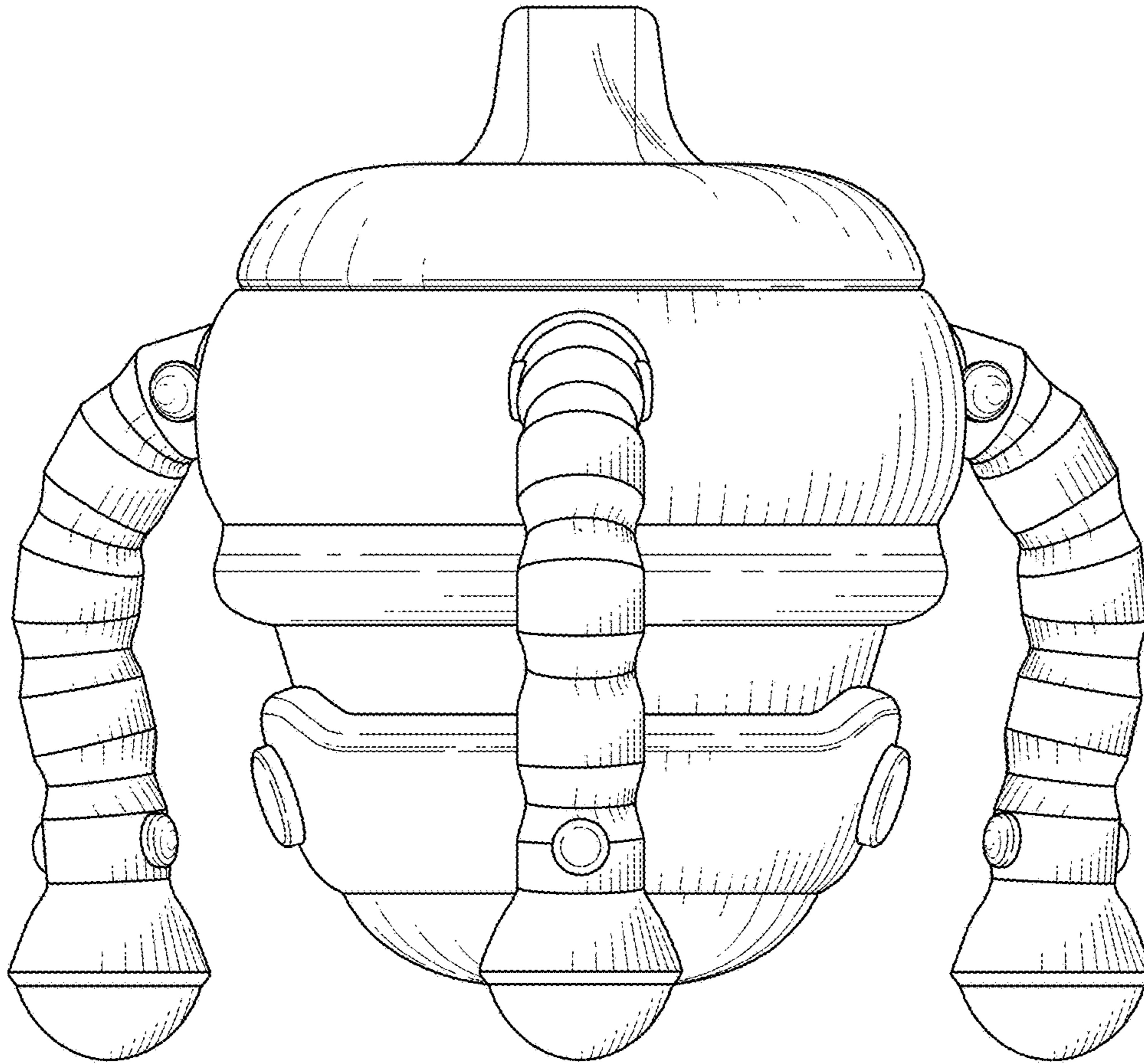

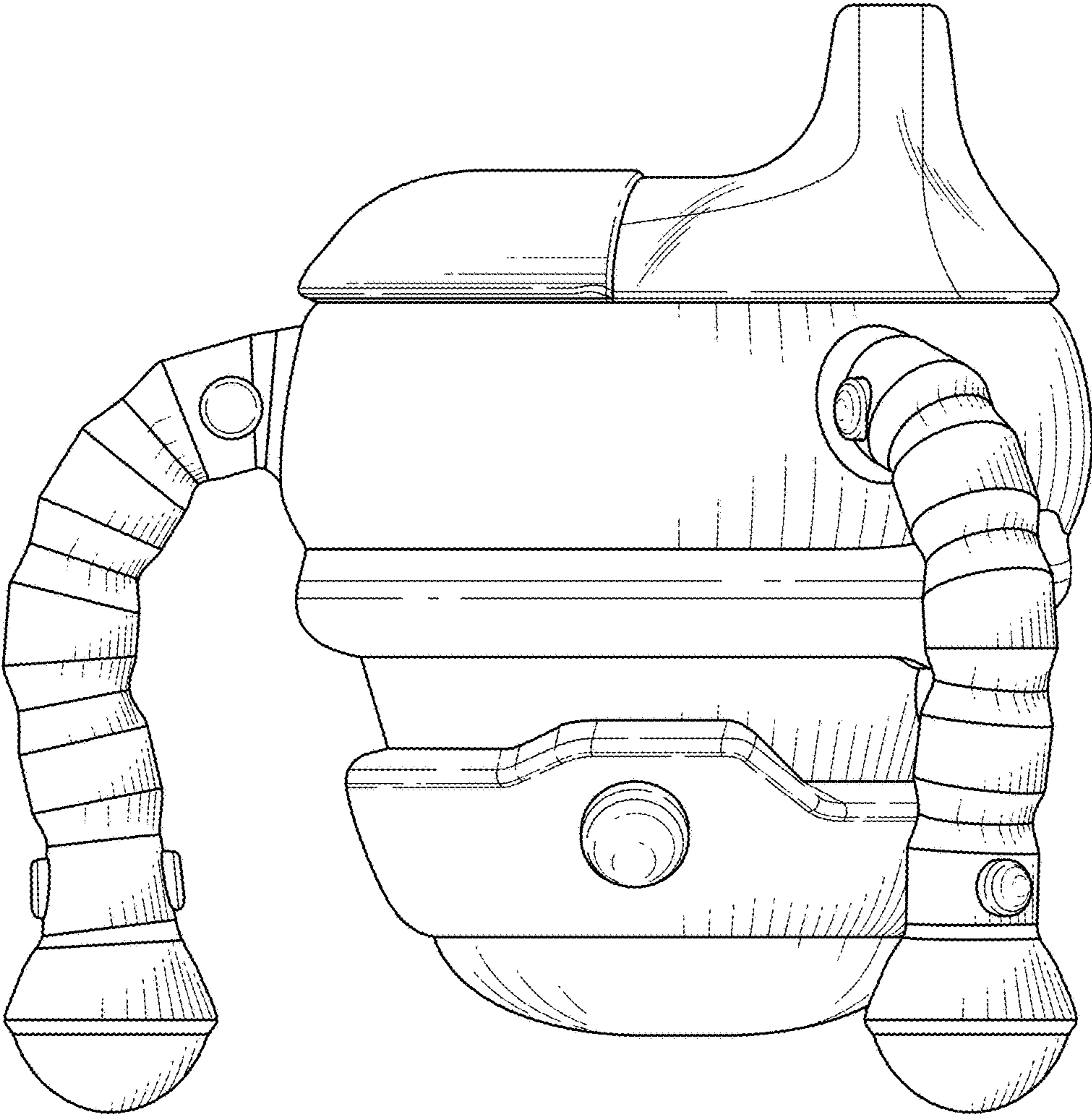

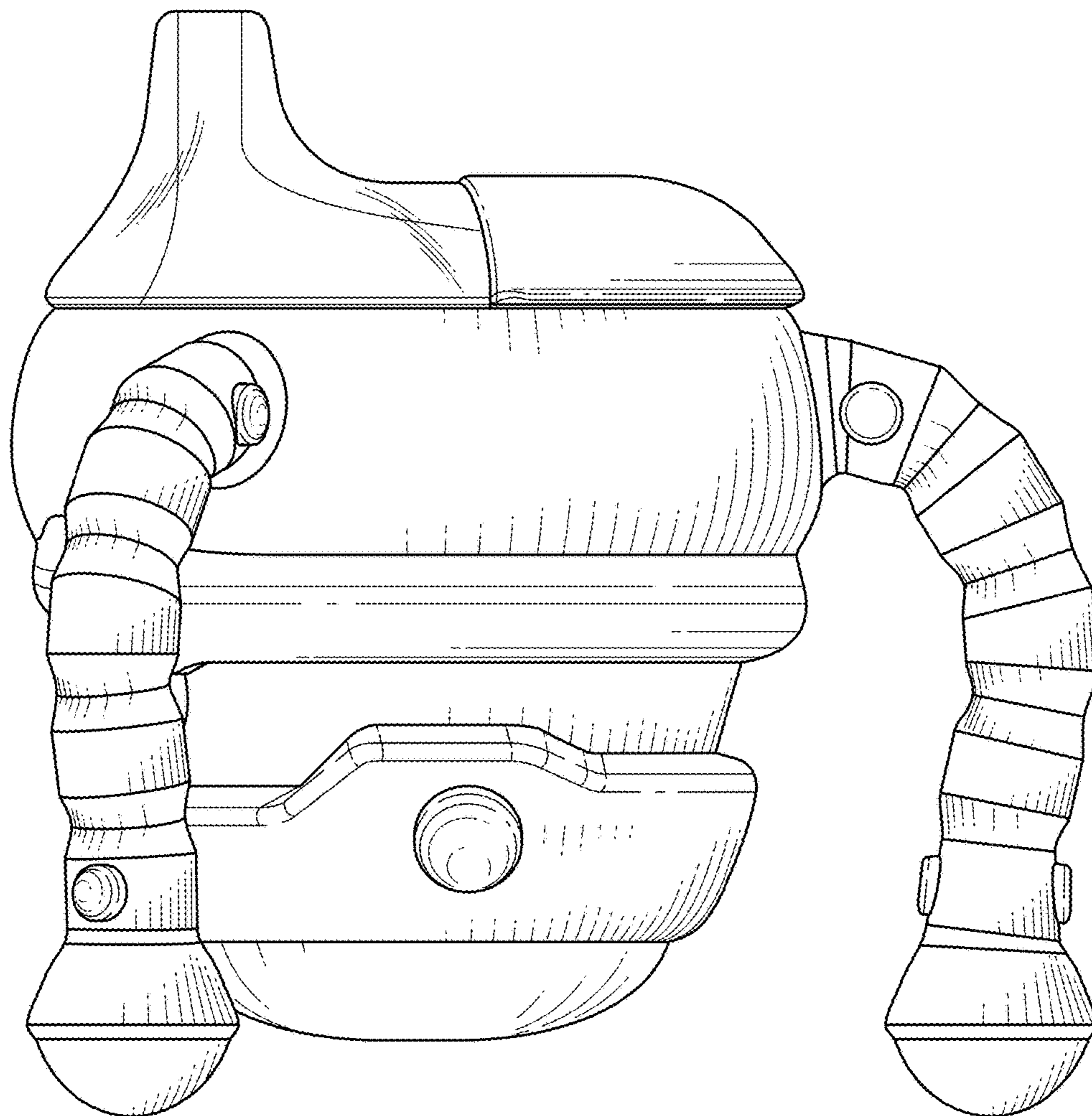

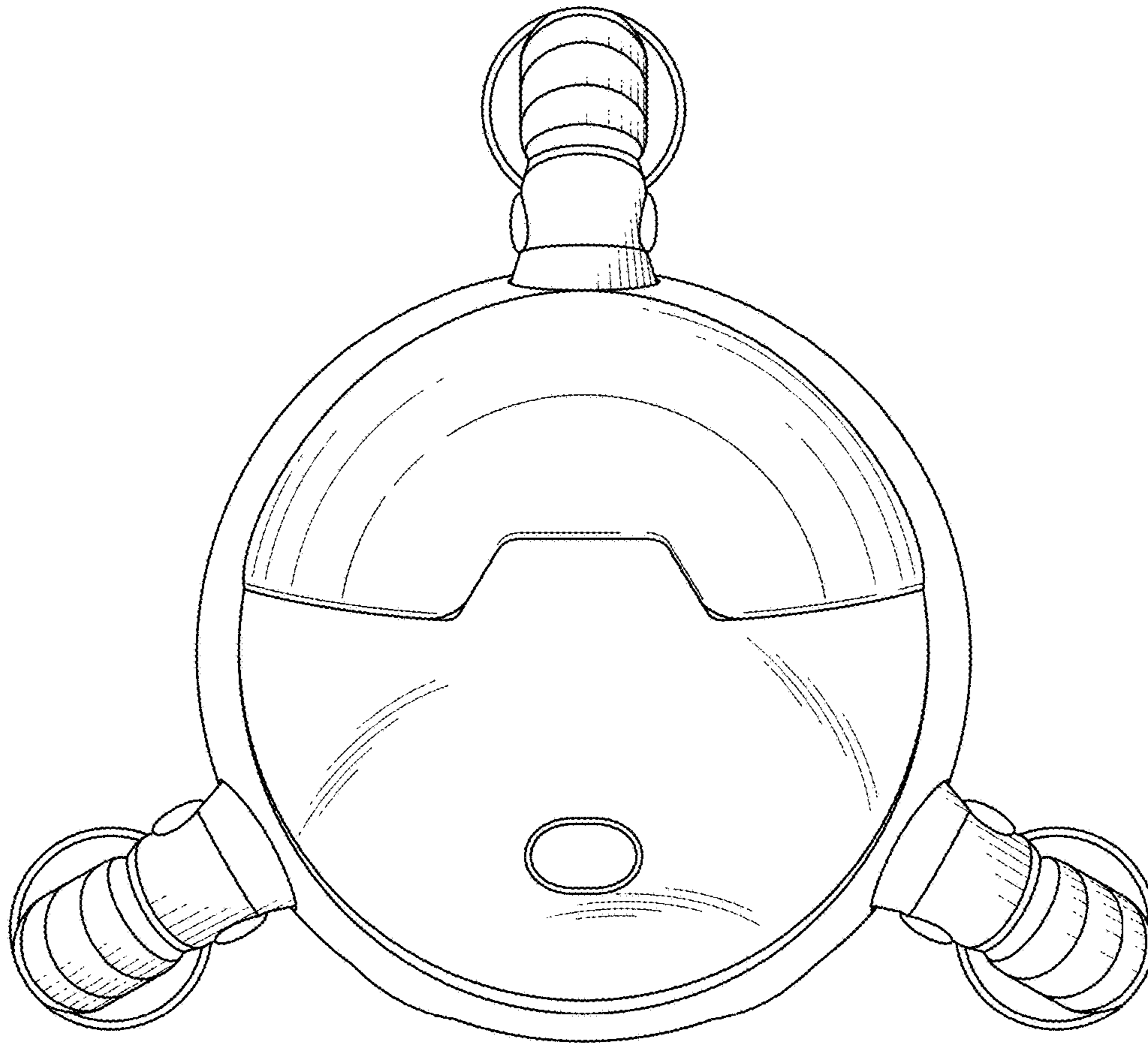

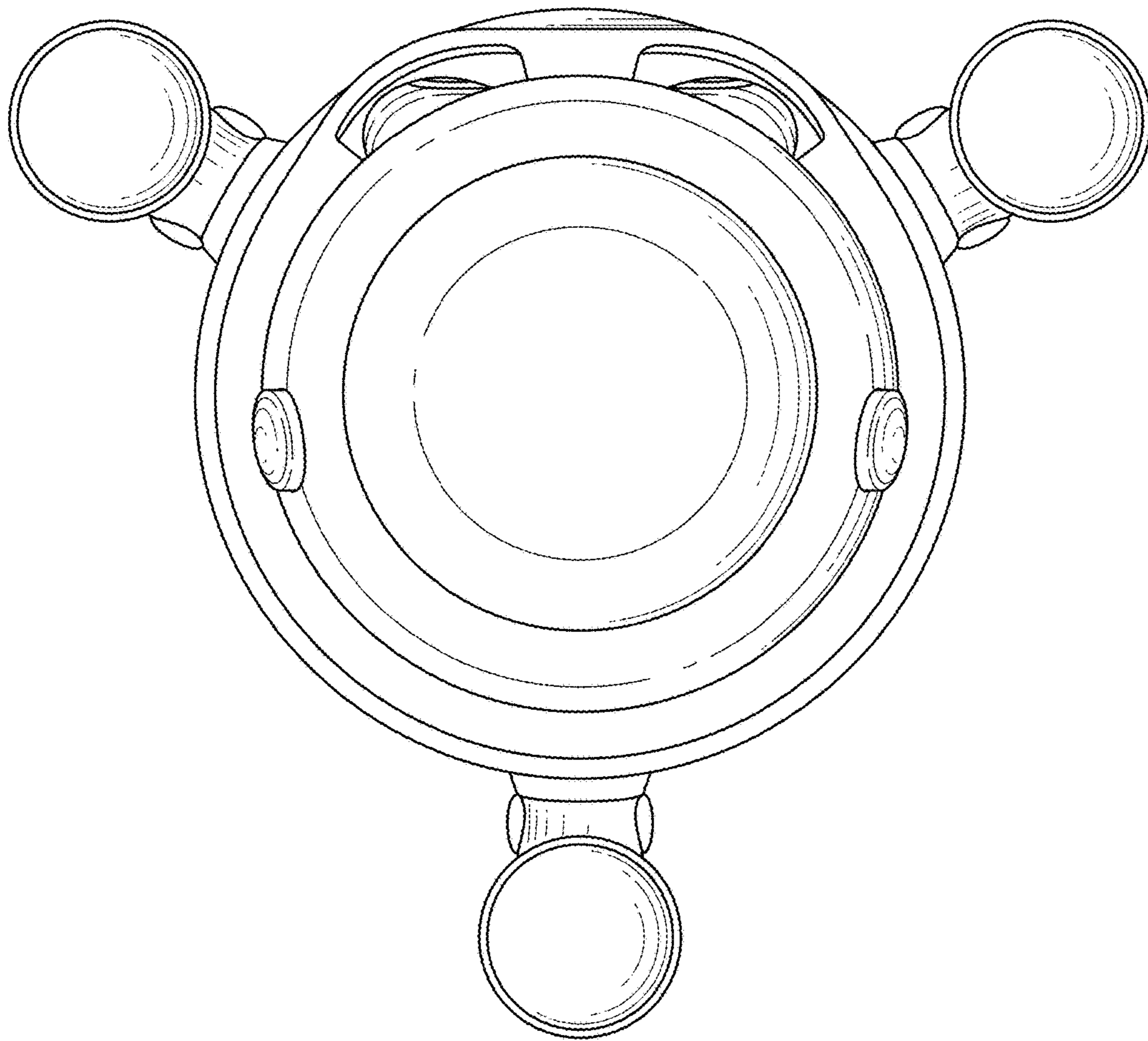

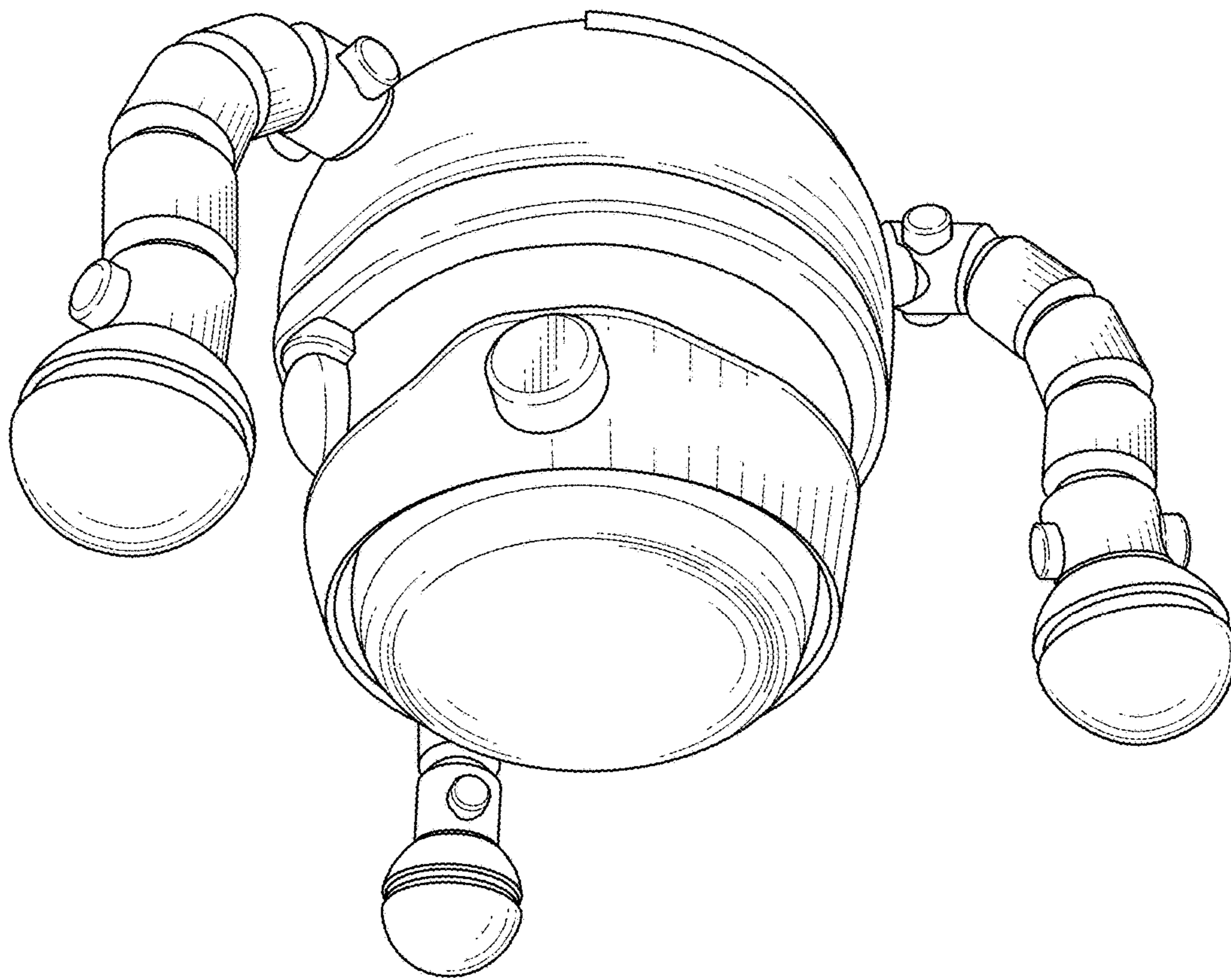
