DESCRIPTION

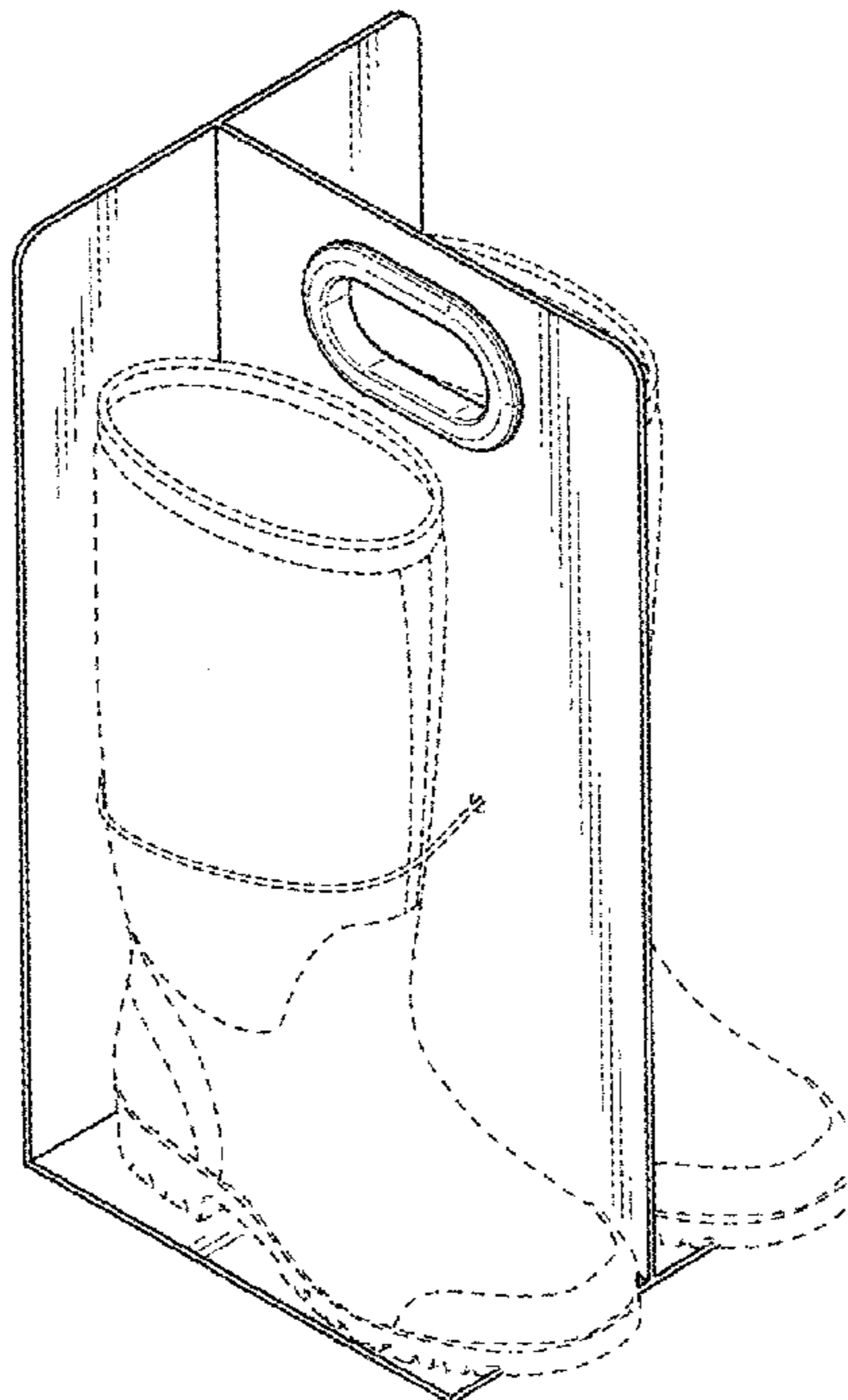
FIG. 1 is a perspective view of a footwear carrier display showing my new design;

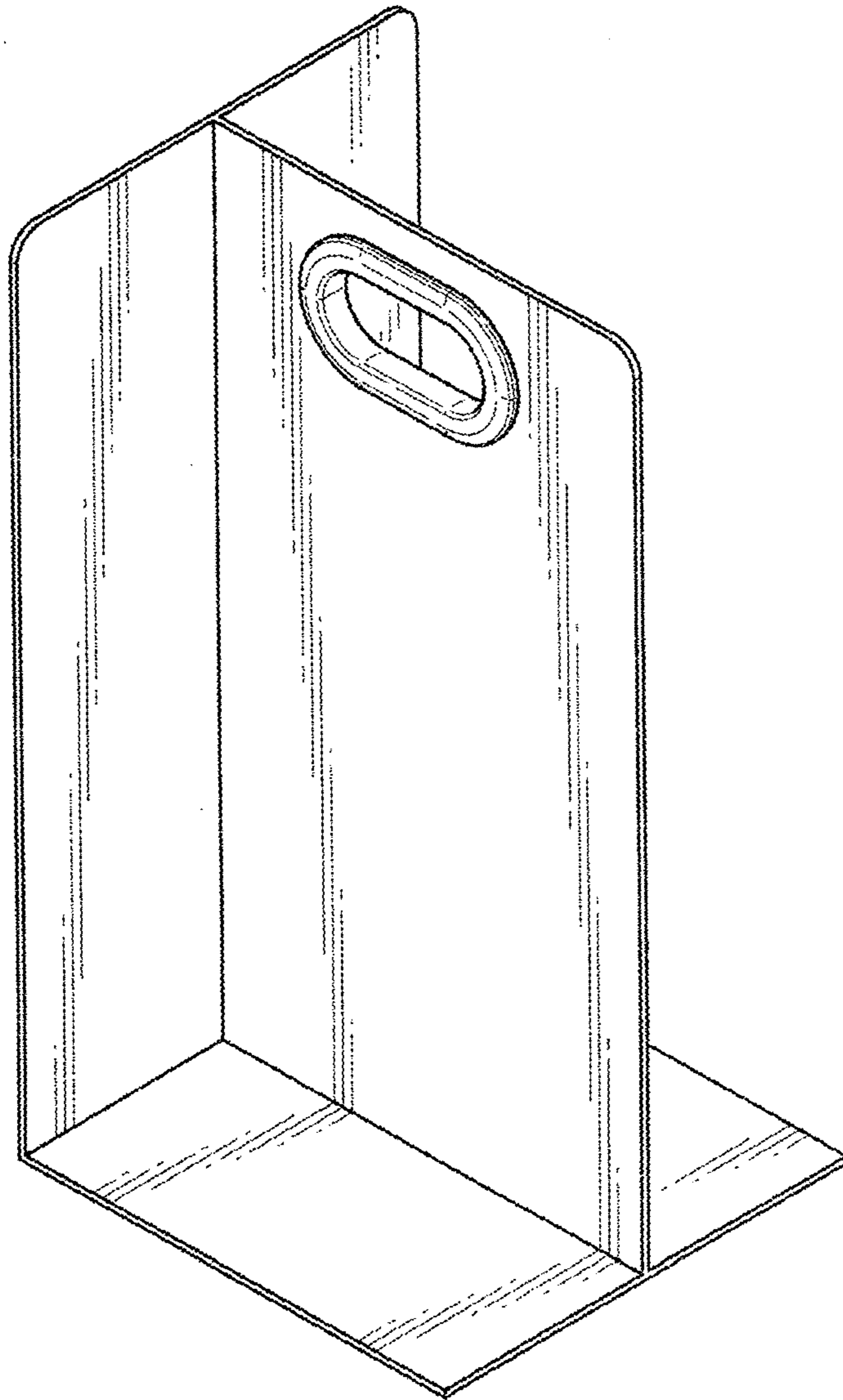

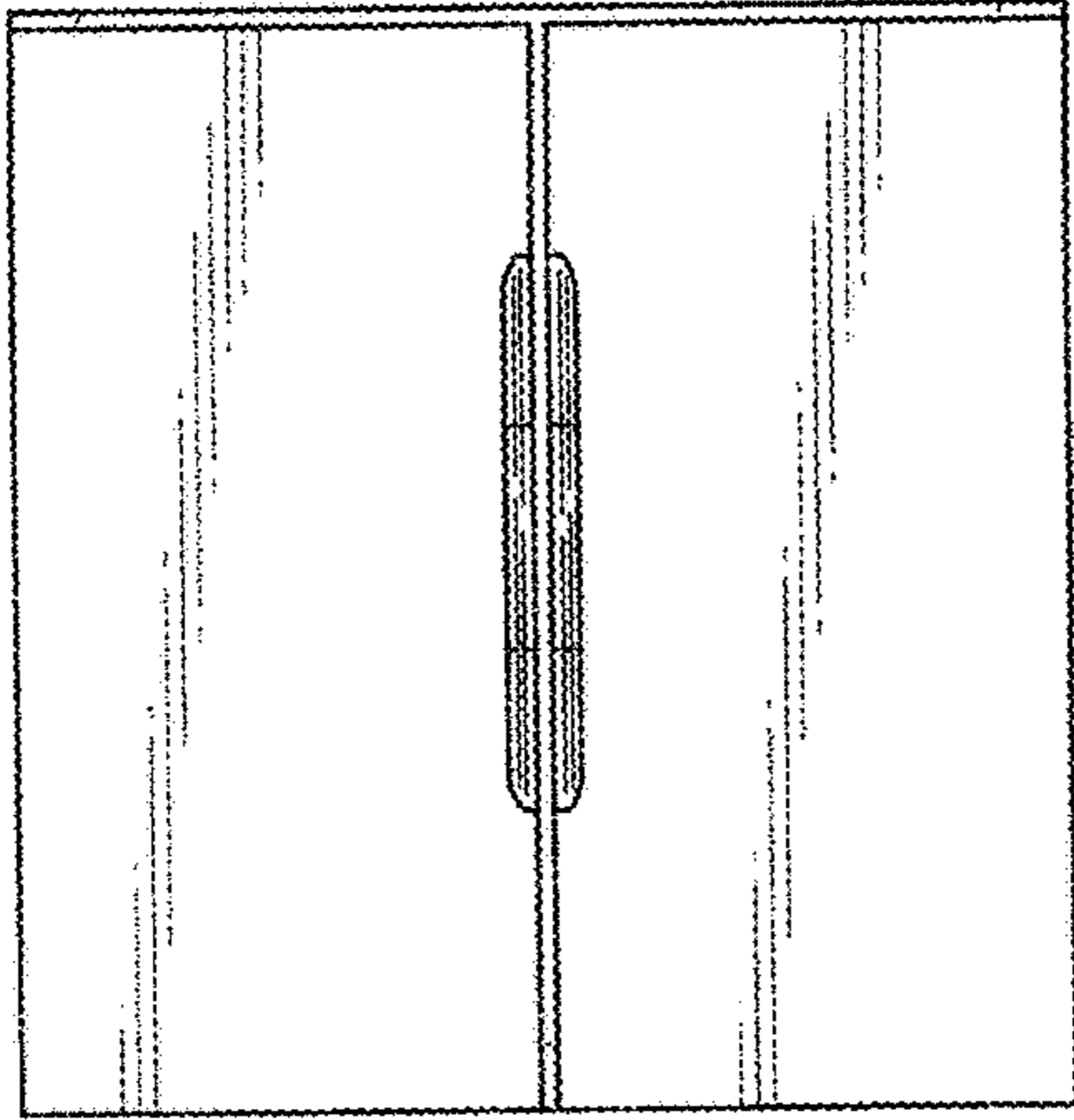

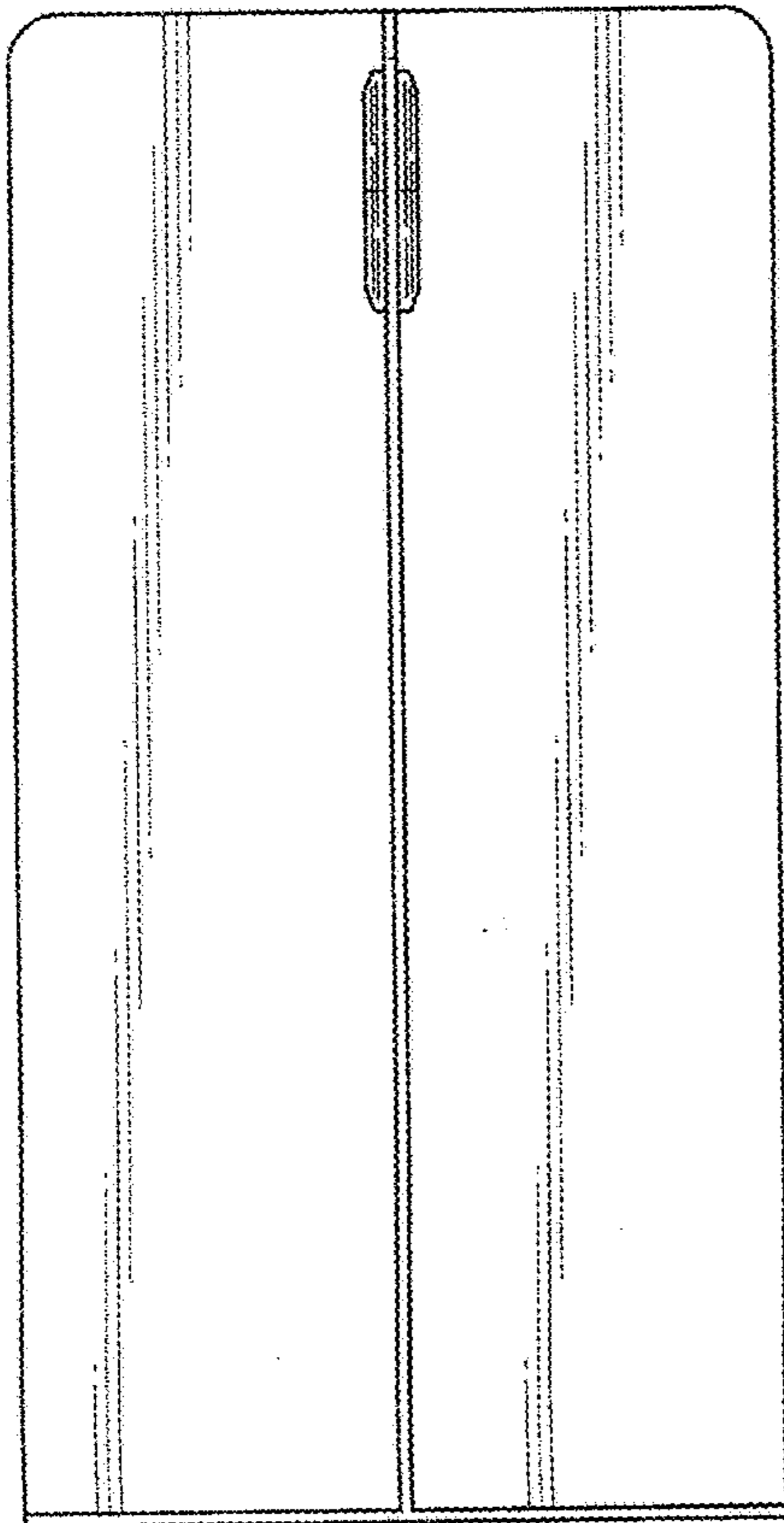

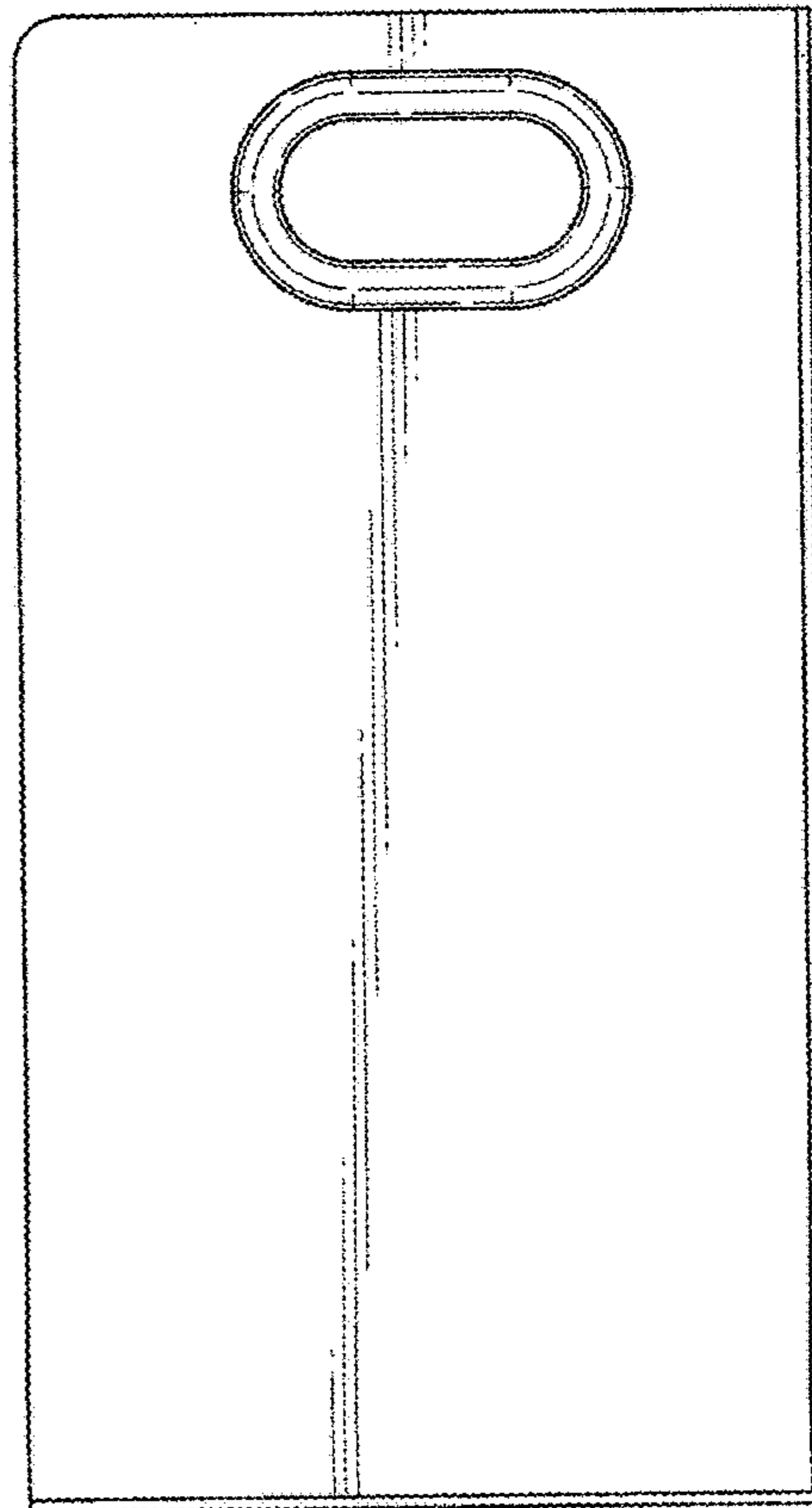

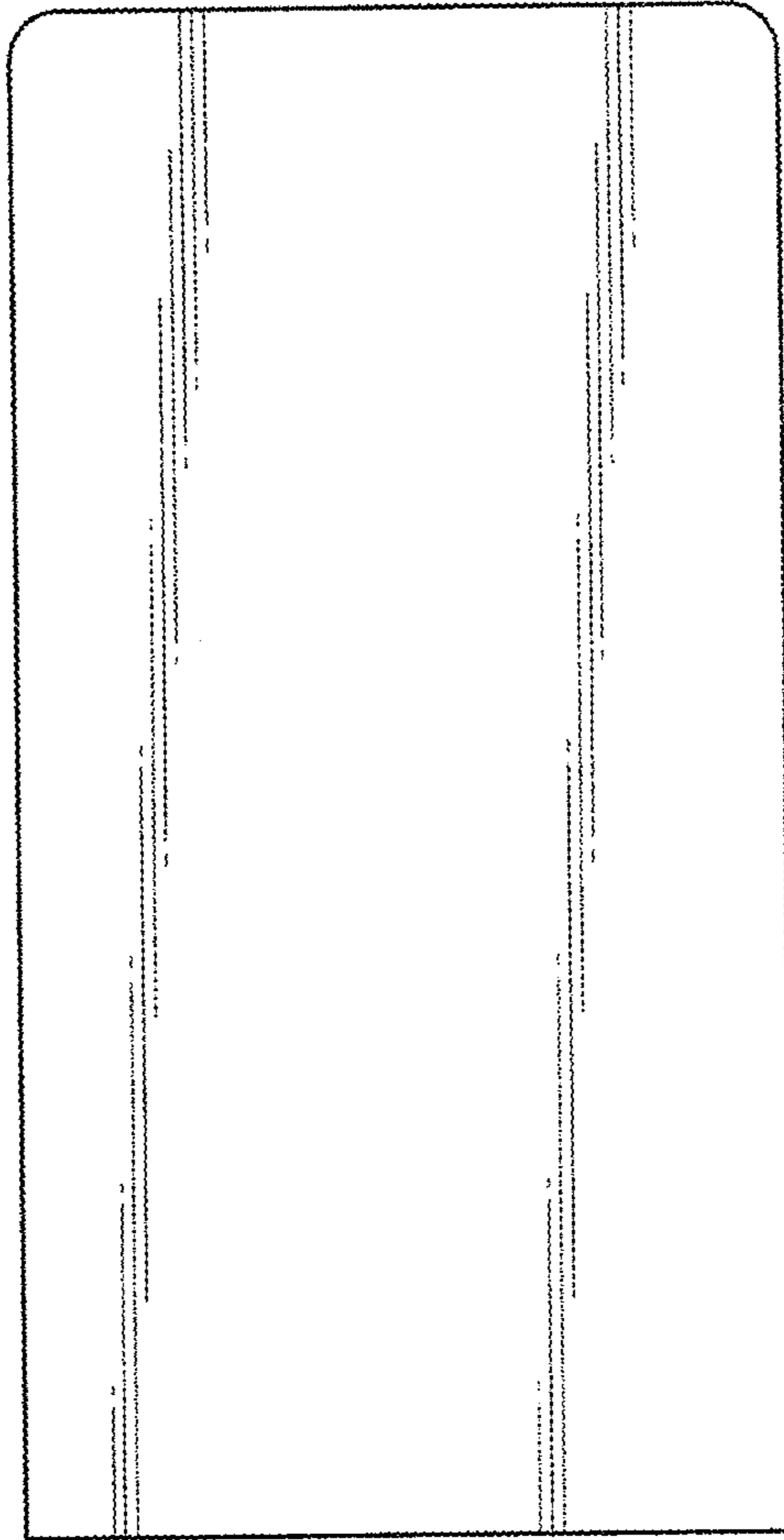

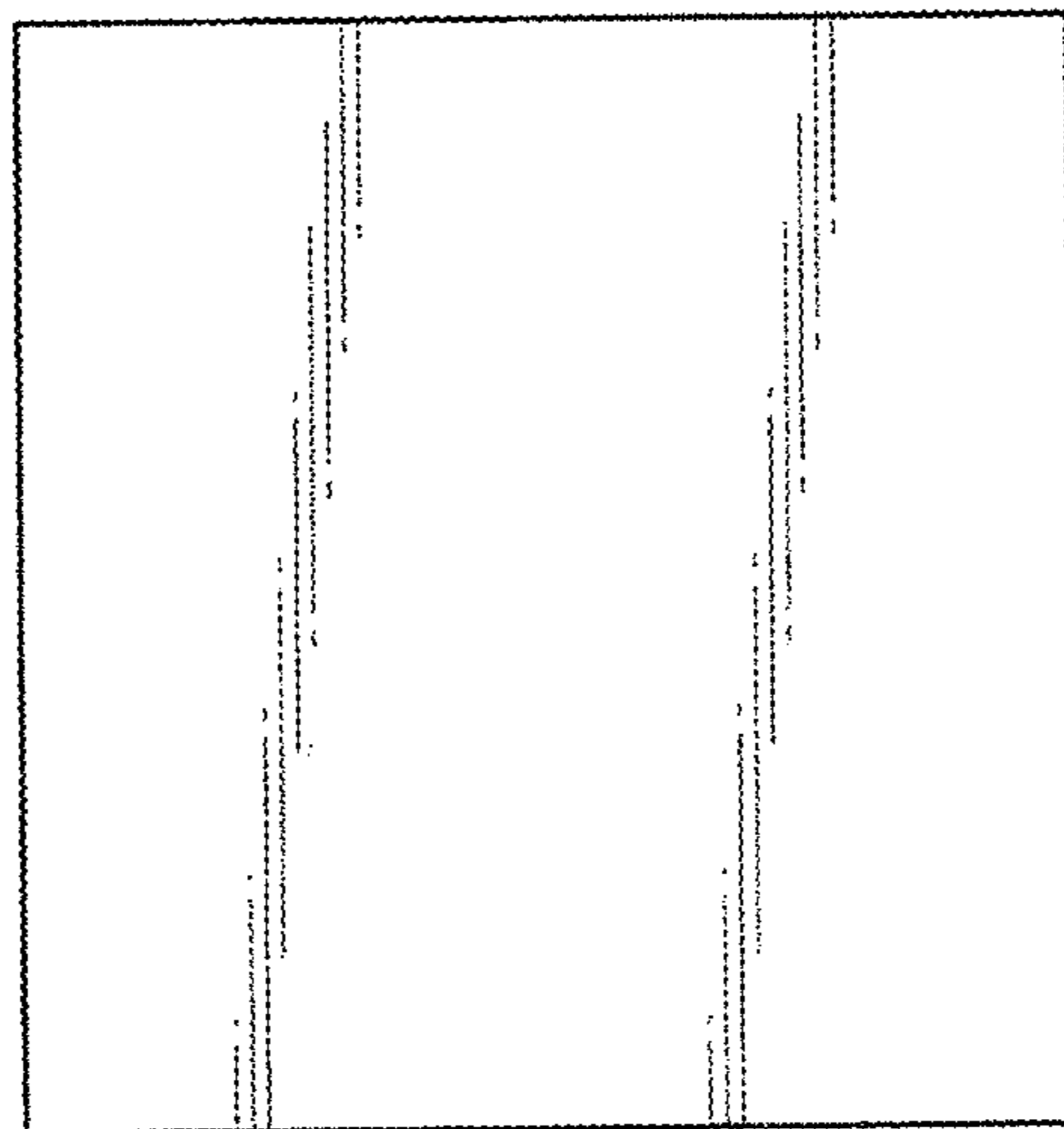

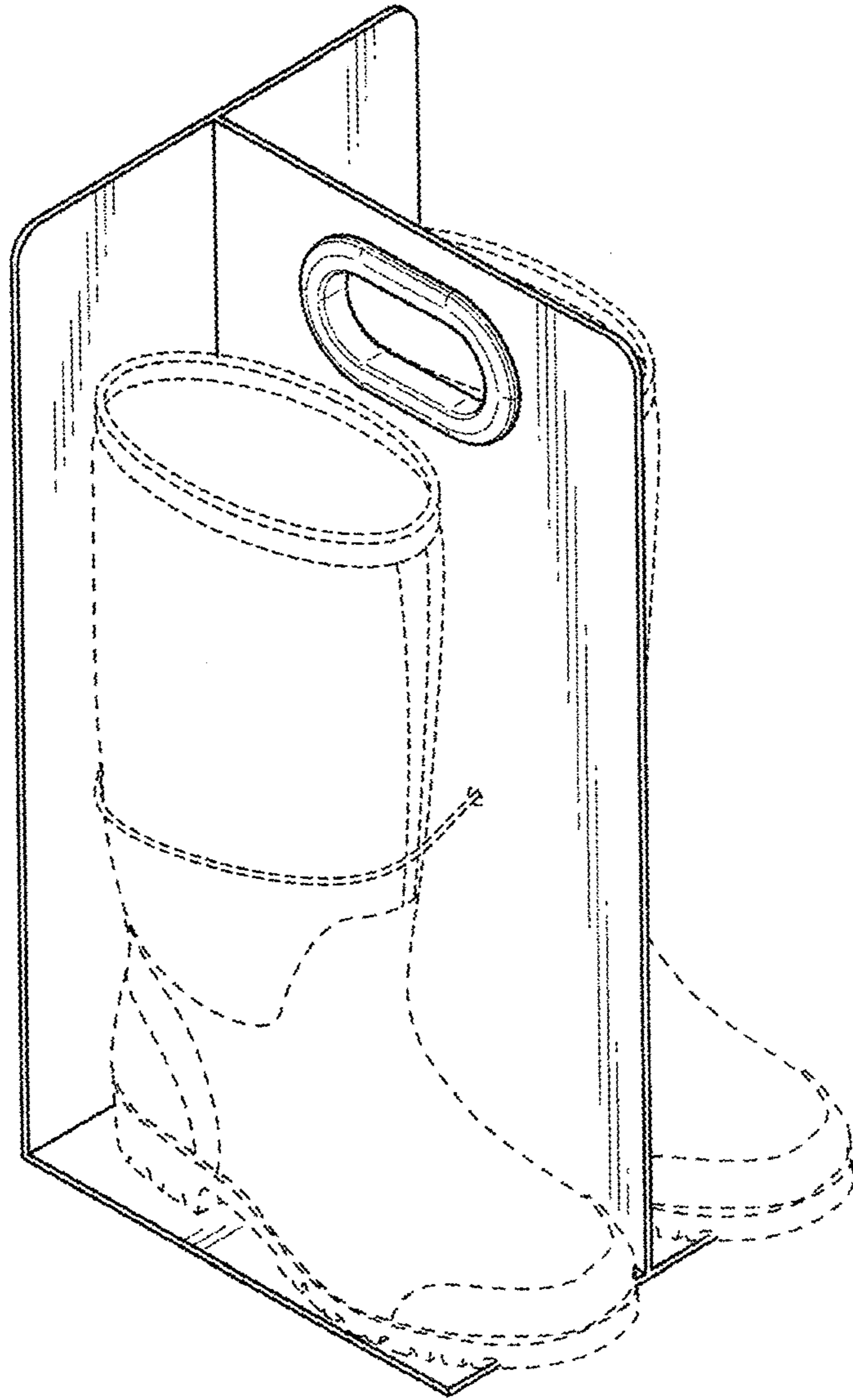
