(57) **CLAIM**

I claim the ornamental design for a rear bumper for an automobile thereof, as shown and described.

DESCRIPTION

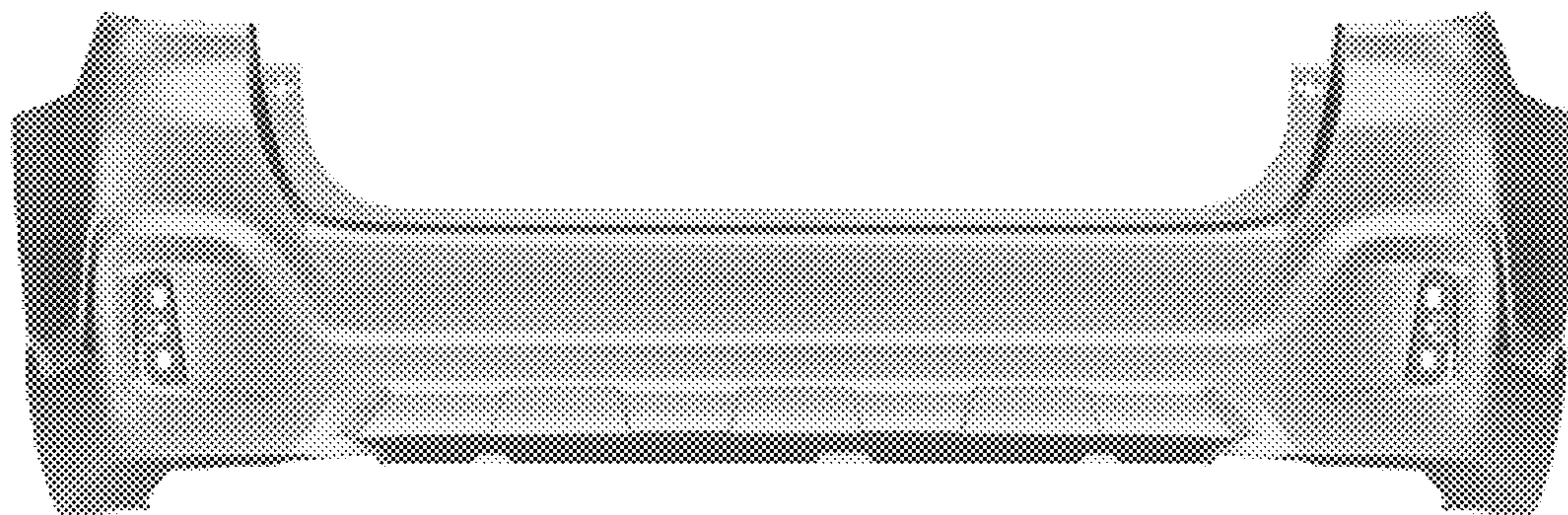

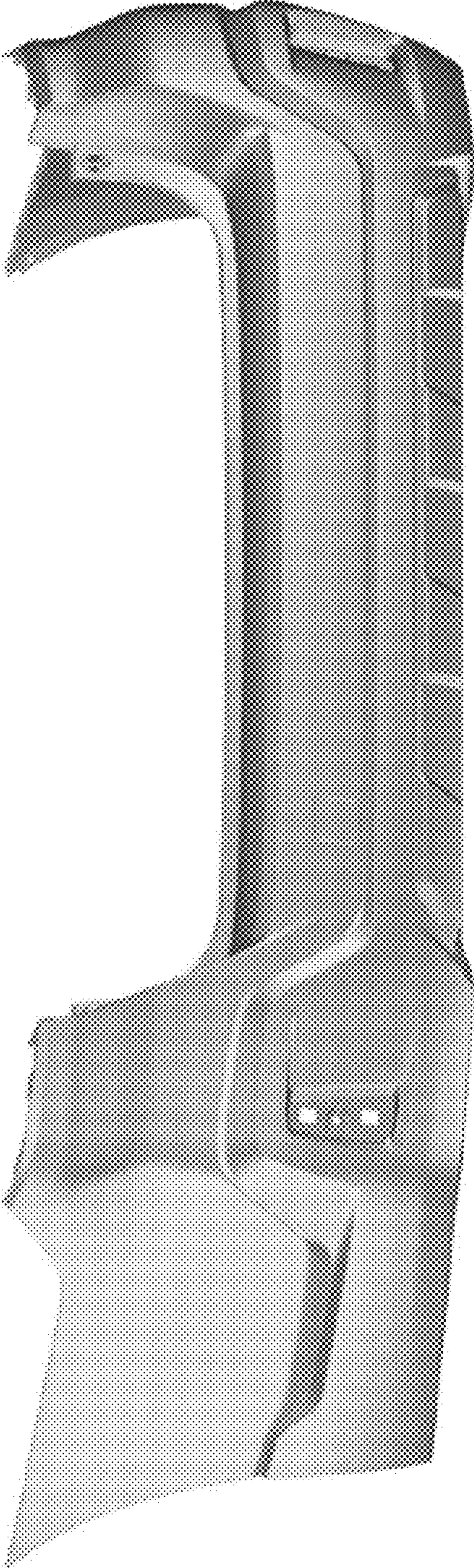

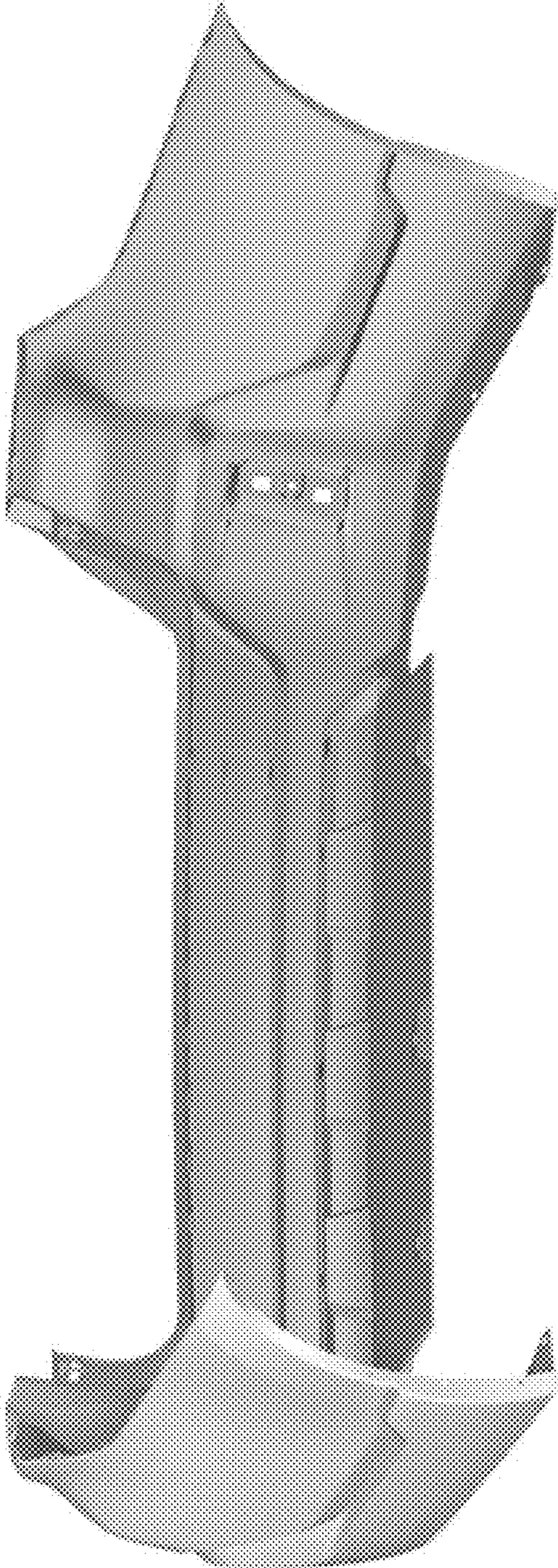

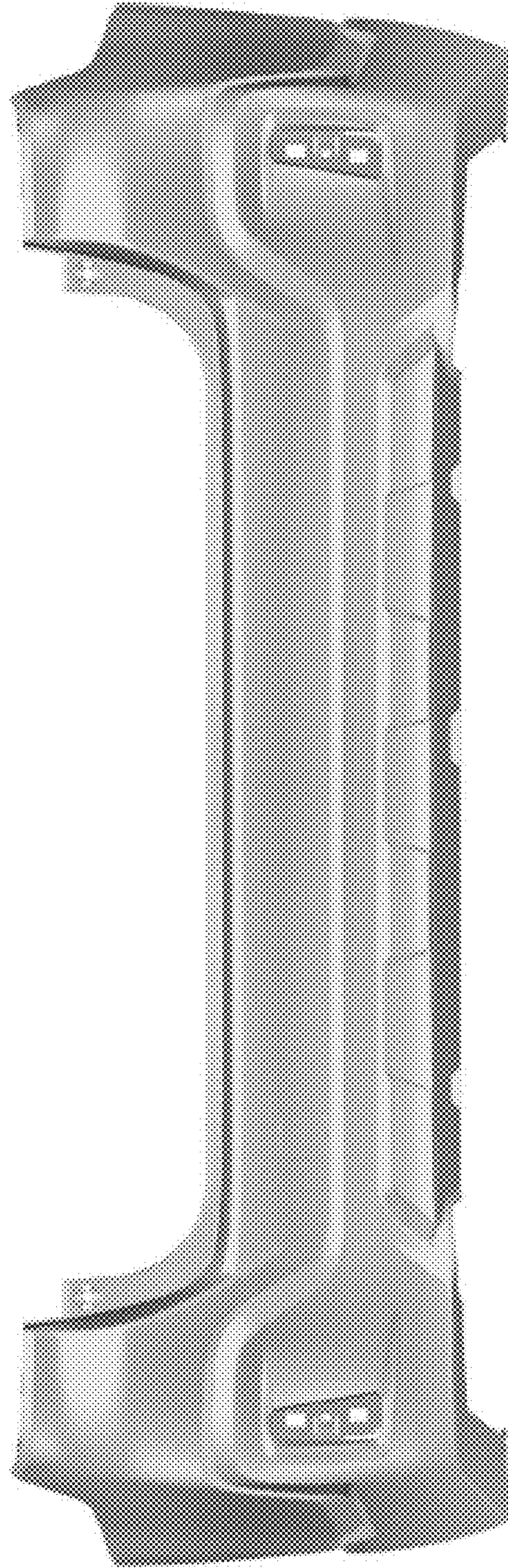

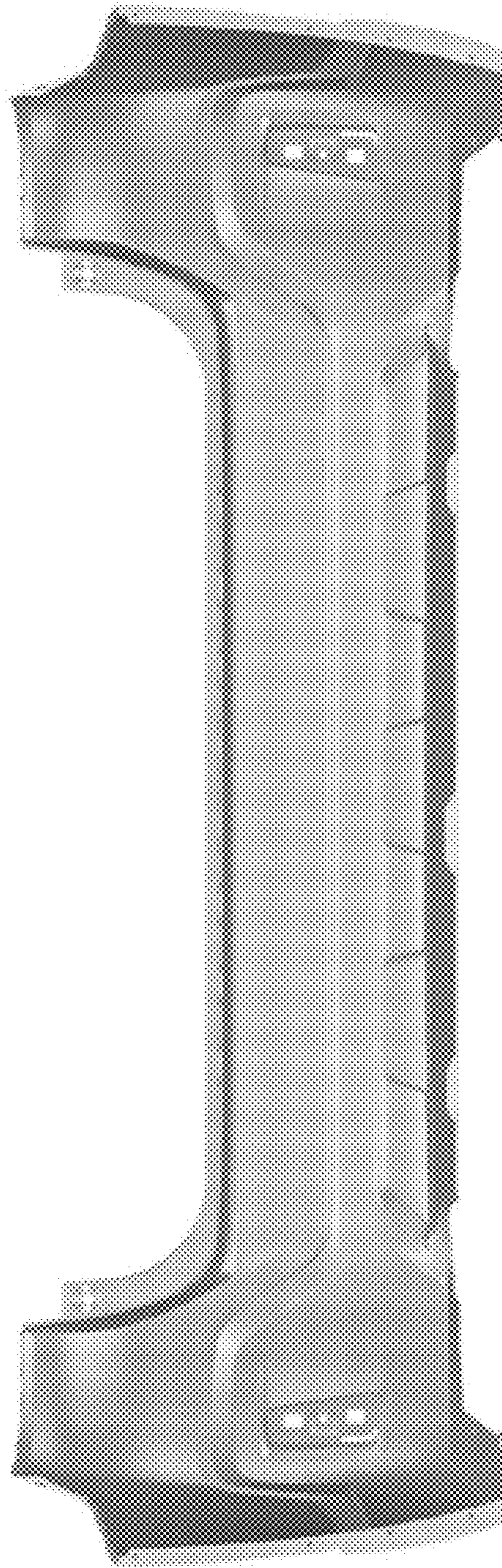

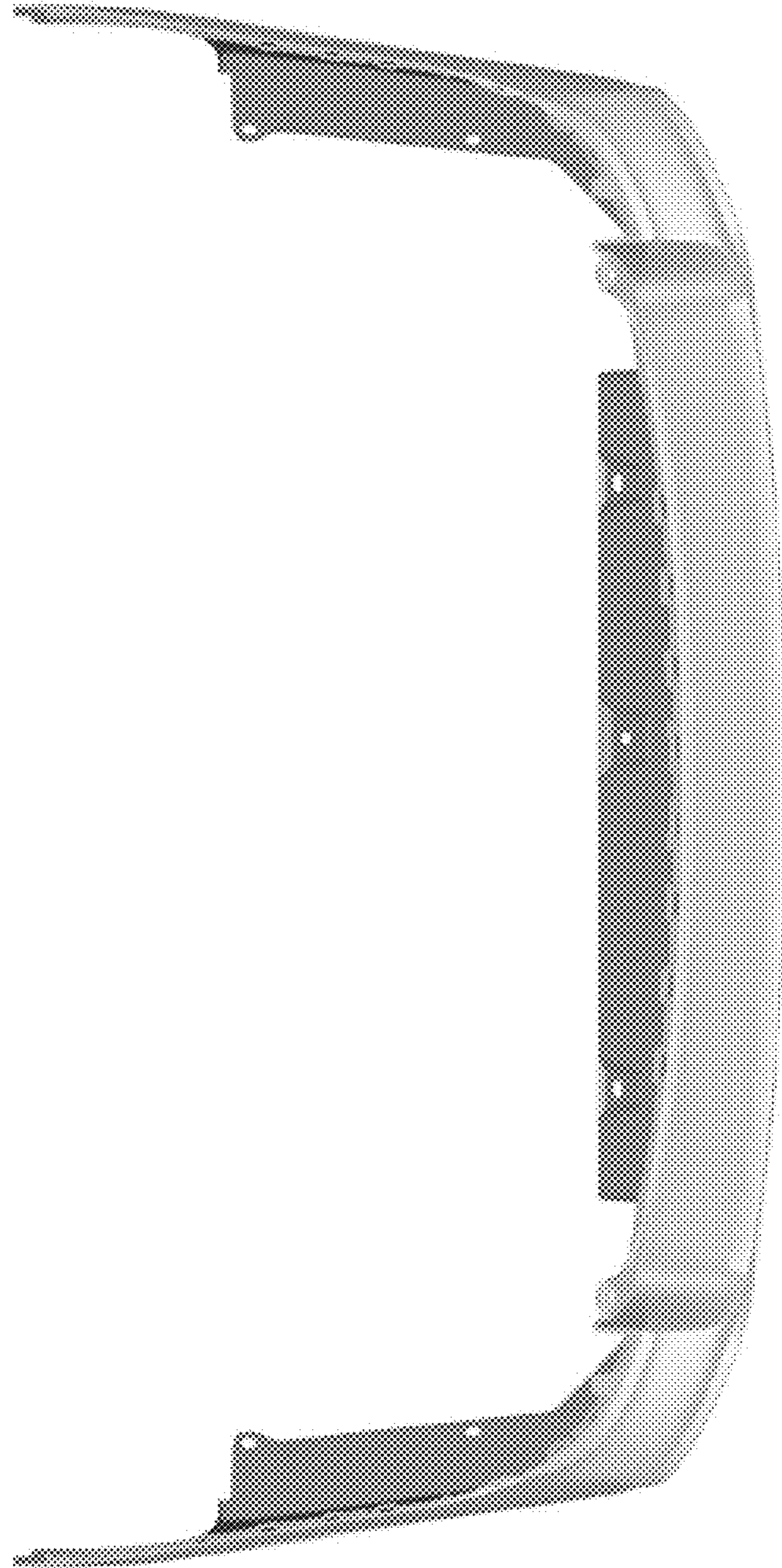

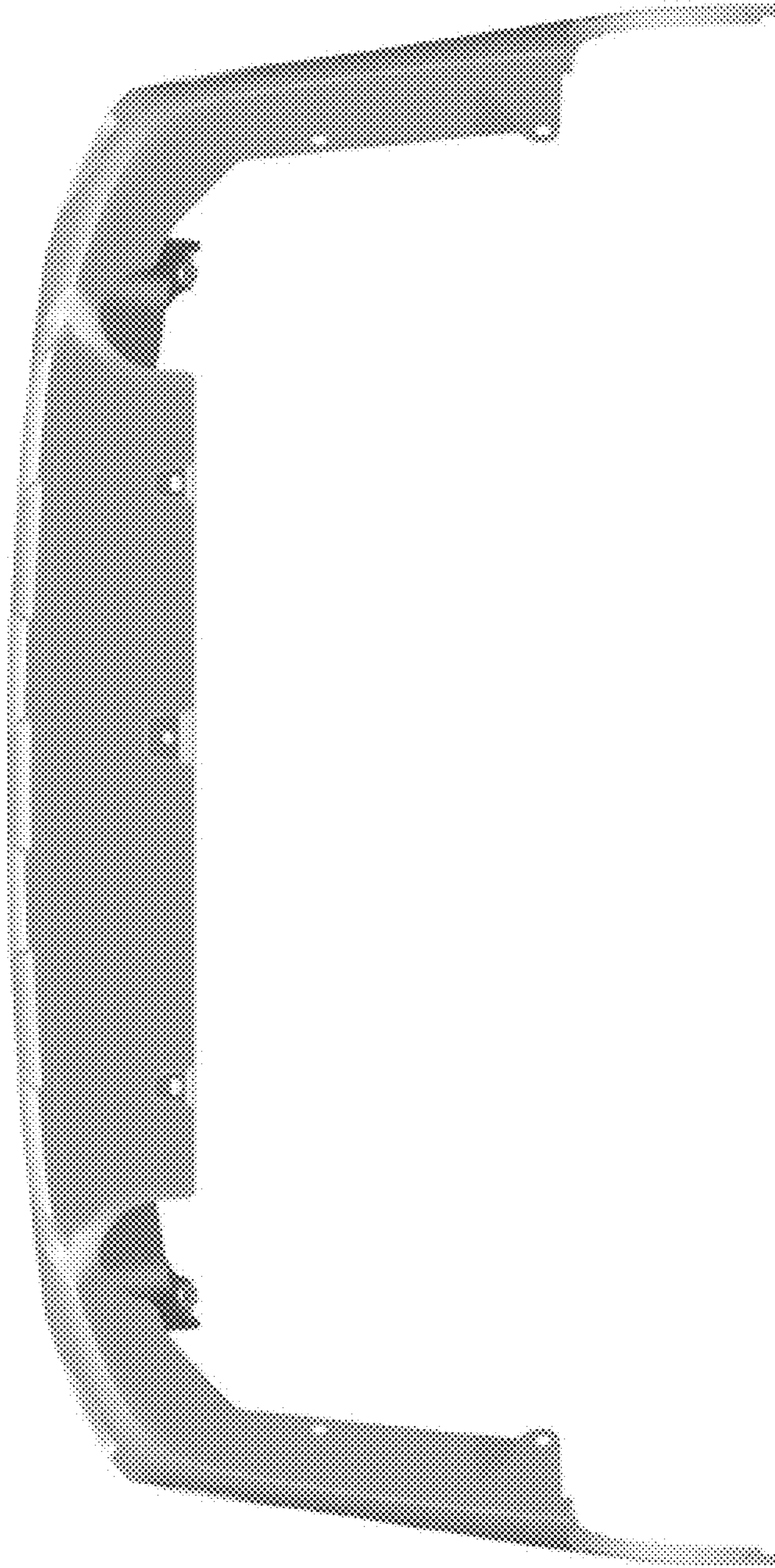

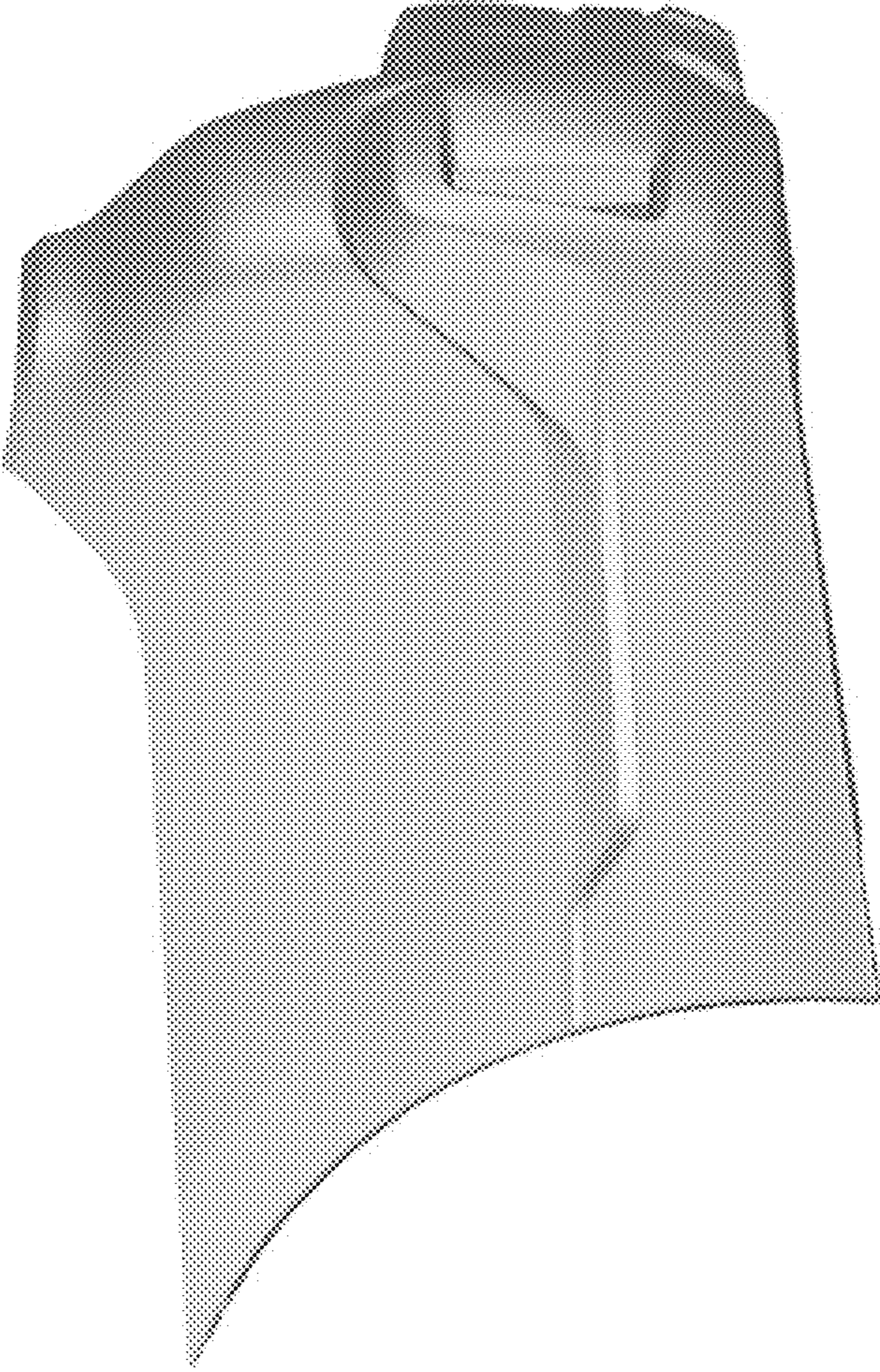
