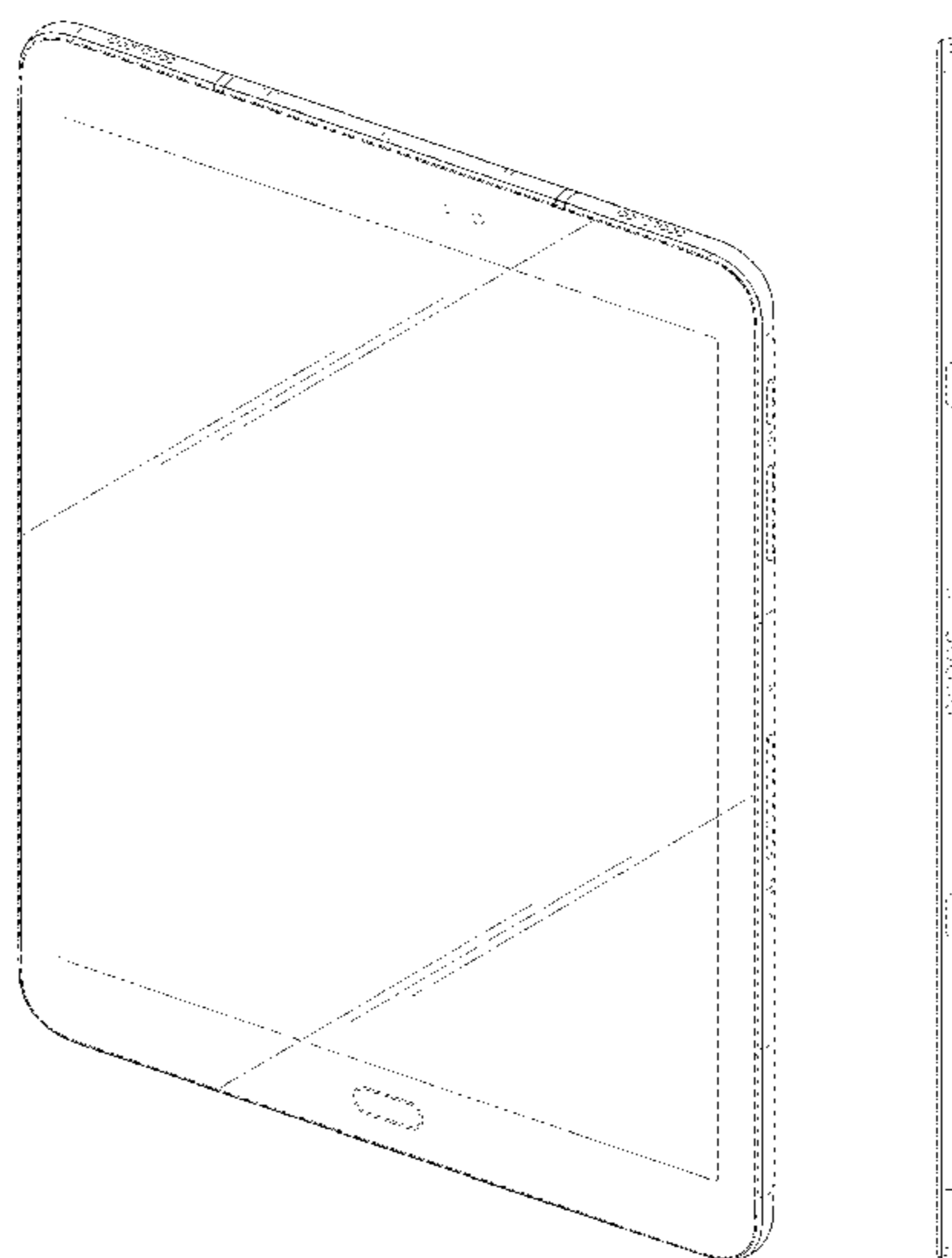
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a tablet PC showing our new design;
FIG. 2 is a front elevation view thereof;

FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;

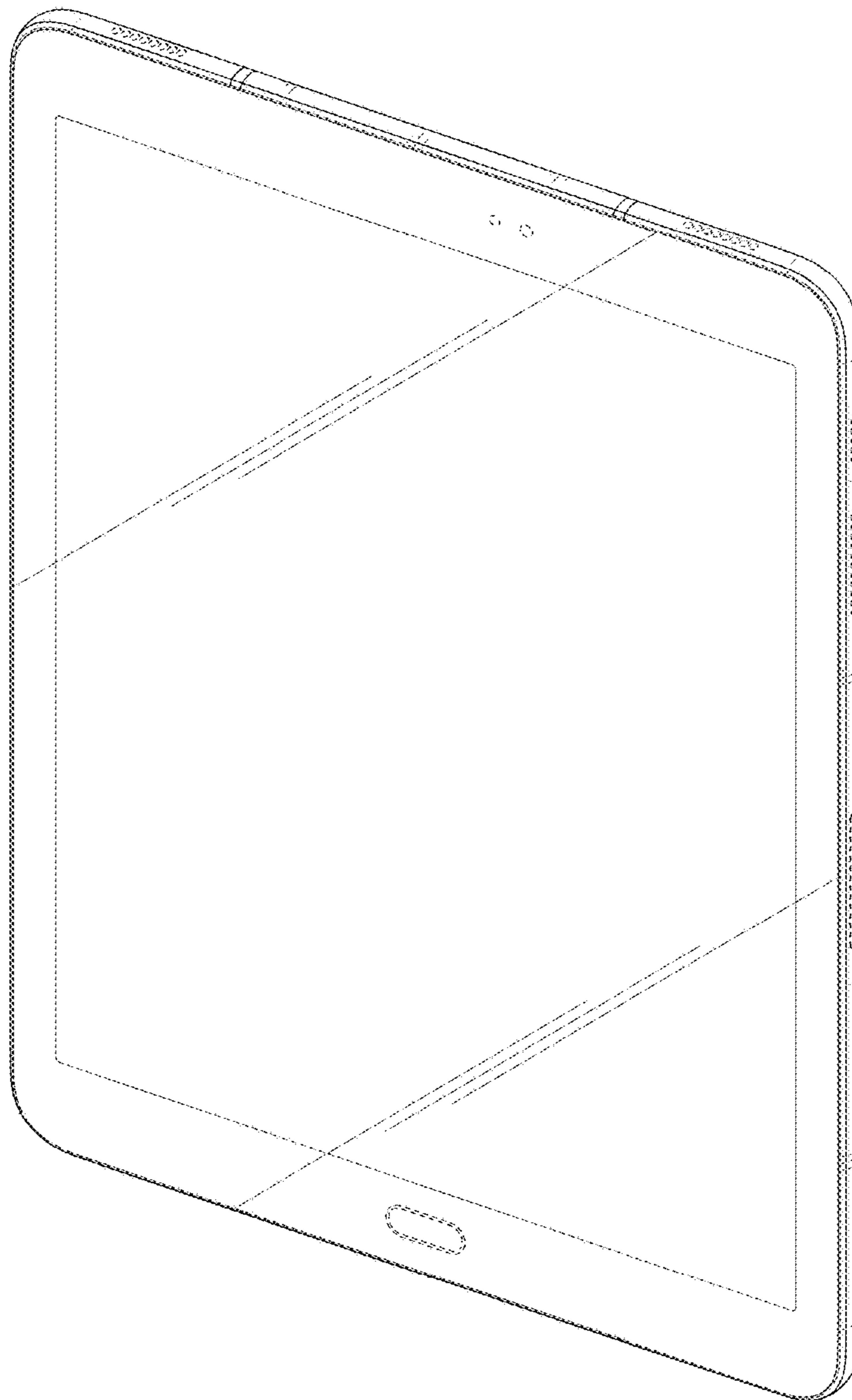

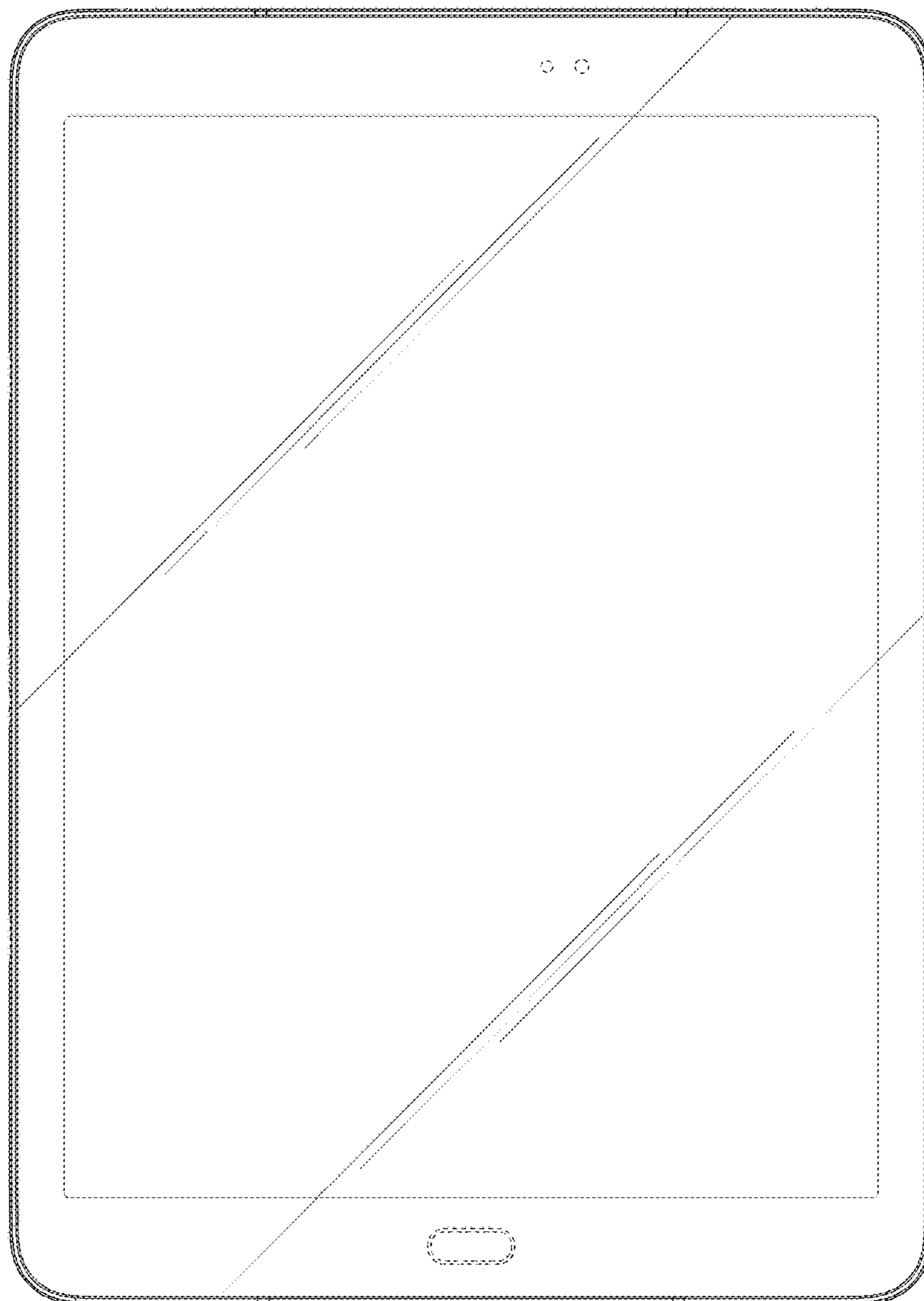

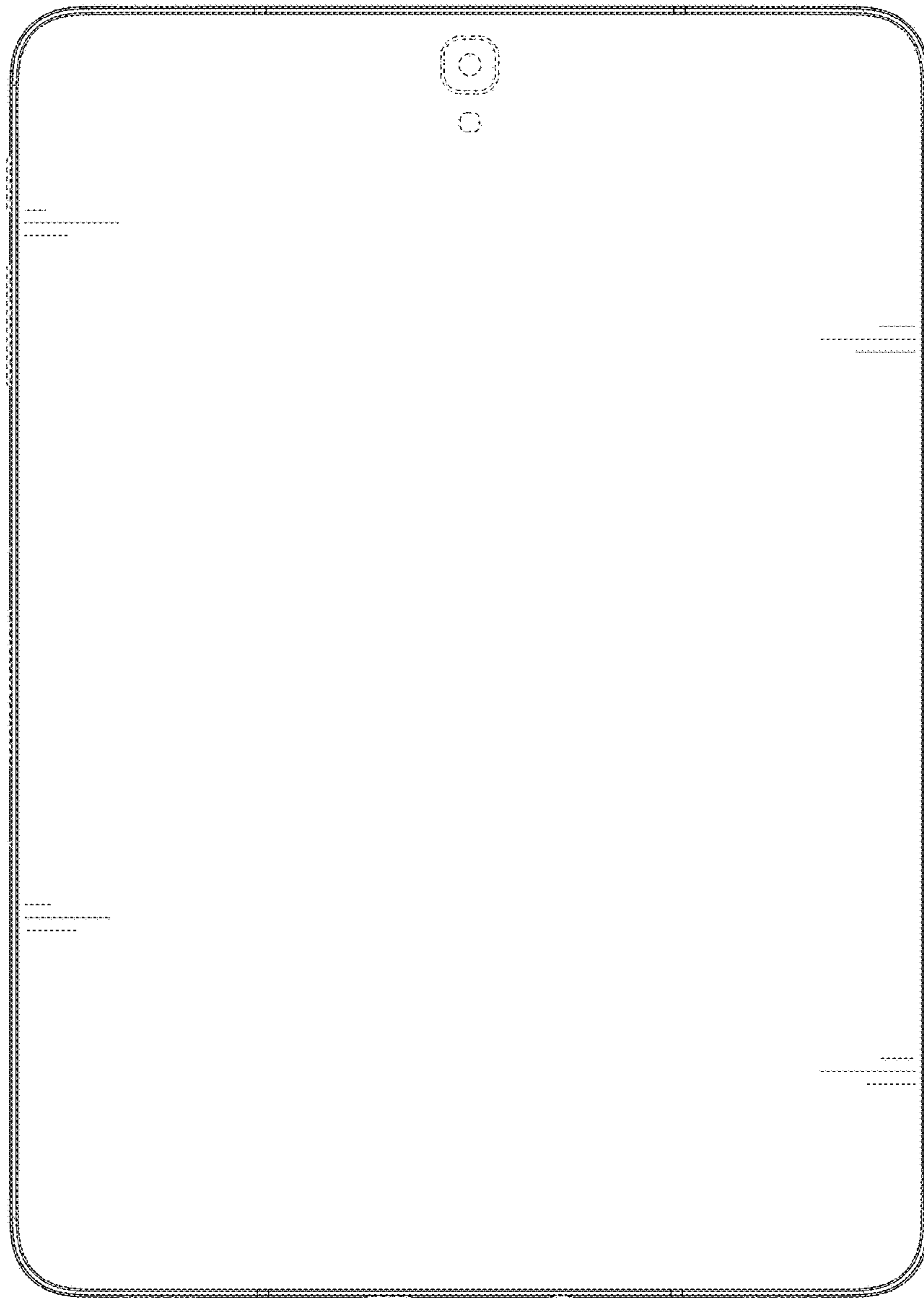

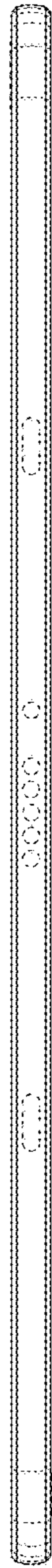

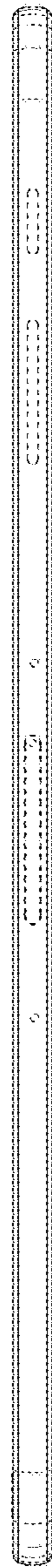

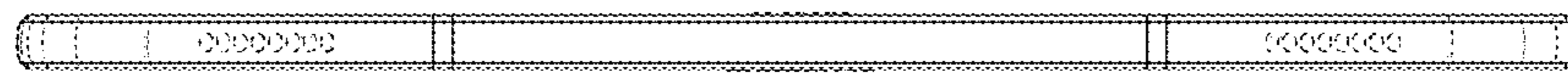

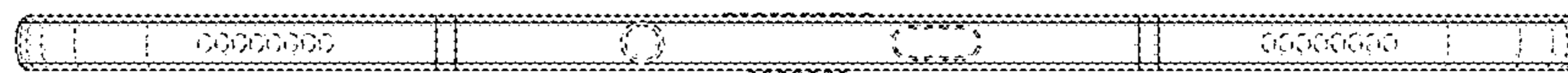
