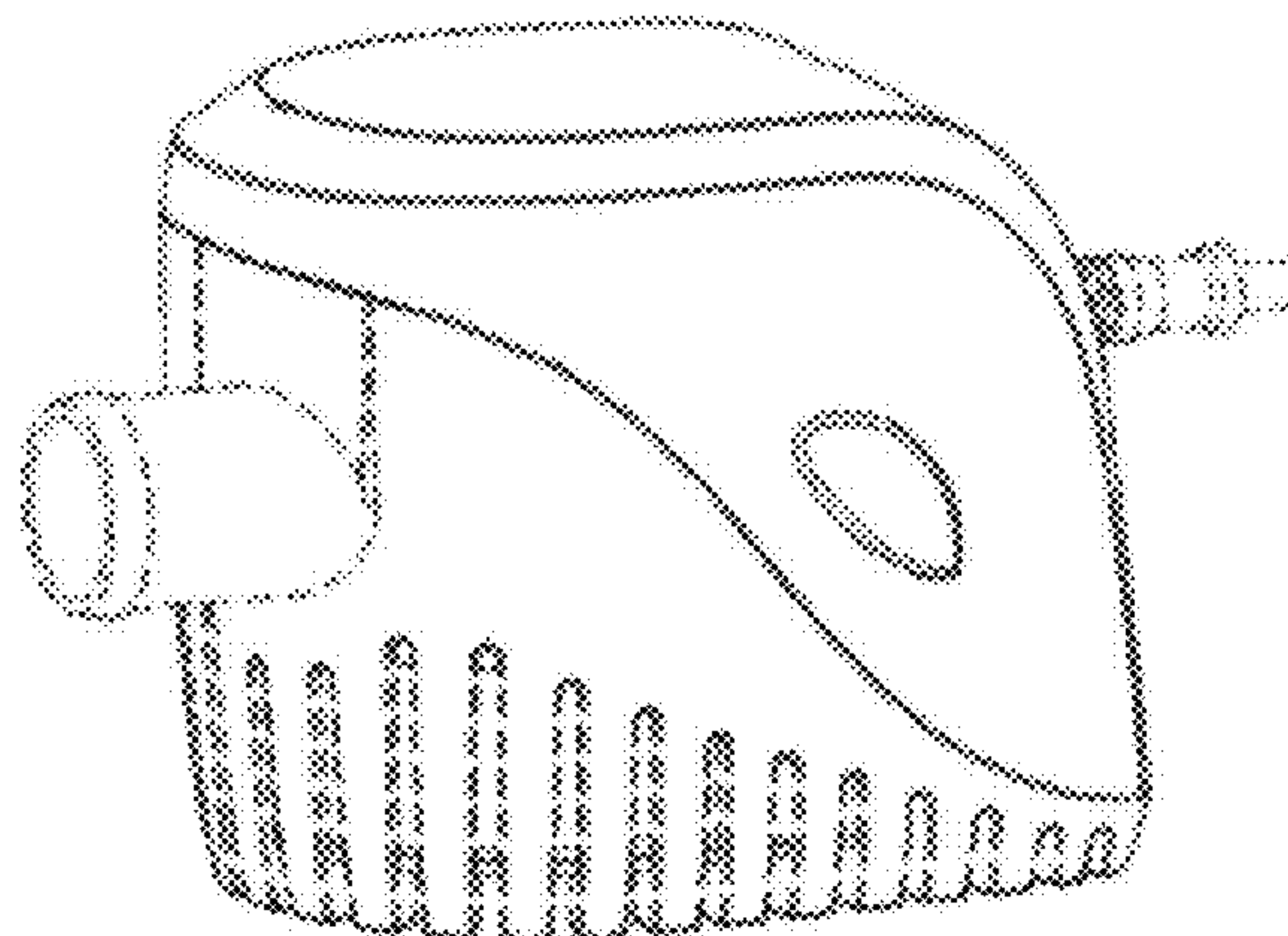
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a bilge pump according to the invention with environment portions shown in broken line, forming no part of the claimed invention.  
FIG. 2 is a front view of a bilge pump according to the invention with environment portions shown in broken line, forming no part of the claimed invention.  
FIG. 3 is a rear view of the bilge pump of FIG. 1 with environment portions shown in broken line, forming no part of the claimed invention.  
FIG. 4 is a right side view of the bilge pump of FIG. 1 with environment portions shown in broken line, forming no part of the claimed invention.  
FIG. 5 is a left side view of the bilge pump of FIG. 1 with environment portions shown in broken line, forming no part of the claimed invention.  
FIG. 6 is a top view of the bilge pump of FIG. 1 with environment portions shown in broken line, forming no part of the claimed invention; and,  
FIG. 7 is a bottom view of the bilge pump of FIG. 1 with environment portions shown in broken line forming no part of the claimed invention and a bottom area circumscribed by broken line forming no part of the claimed invention.

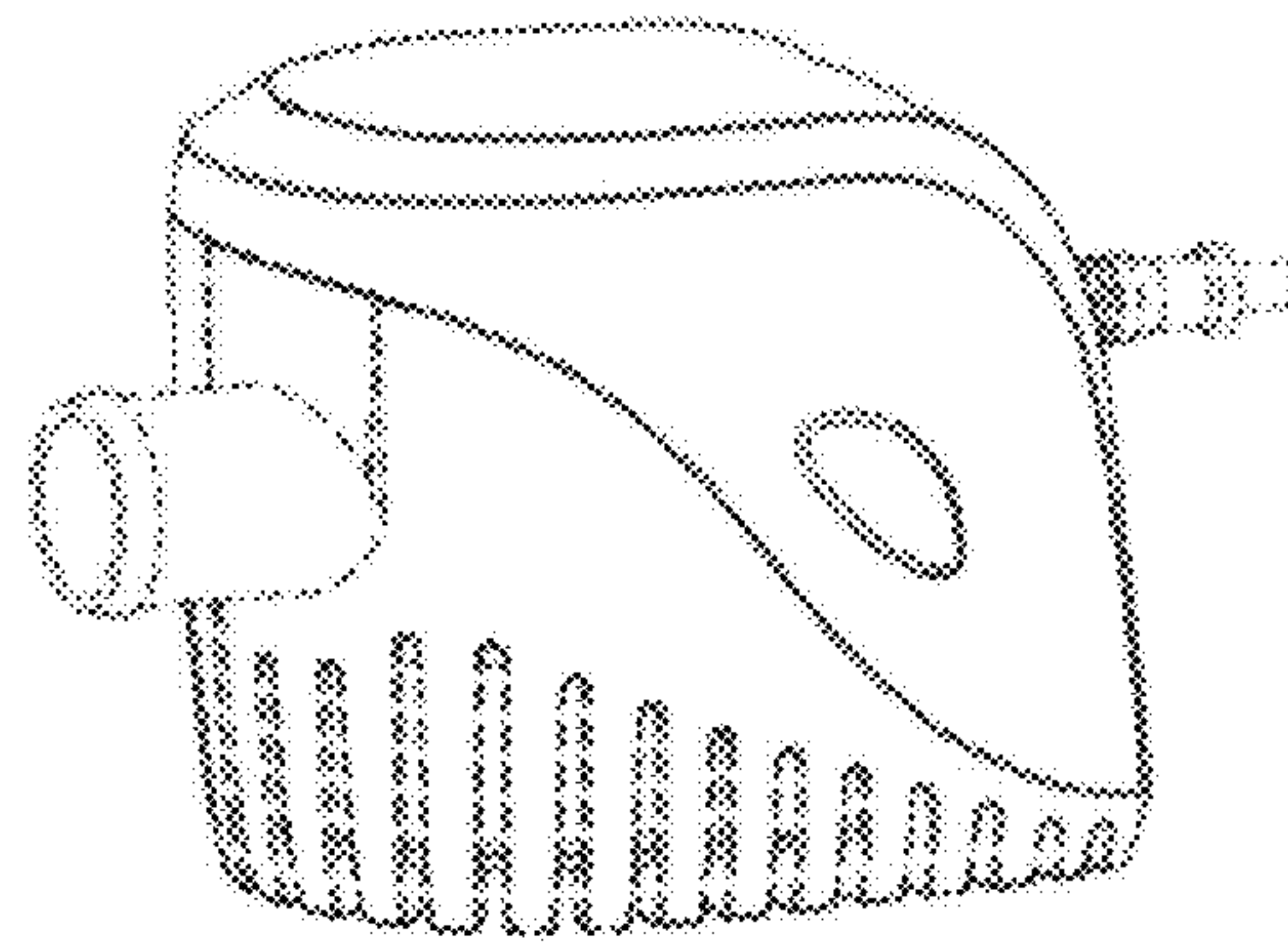

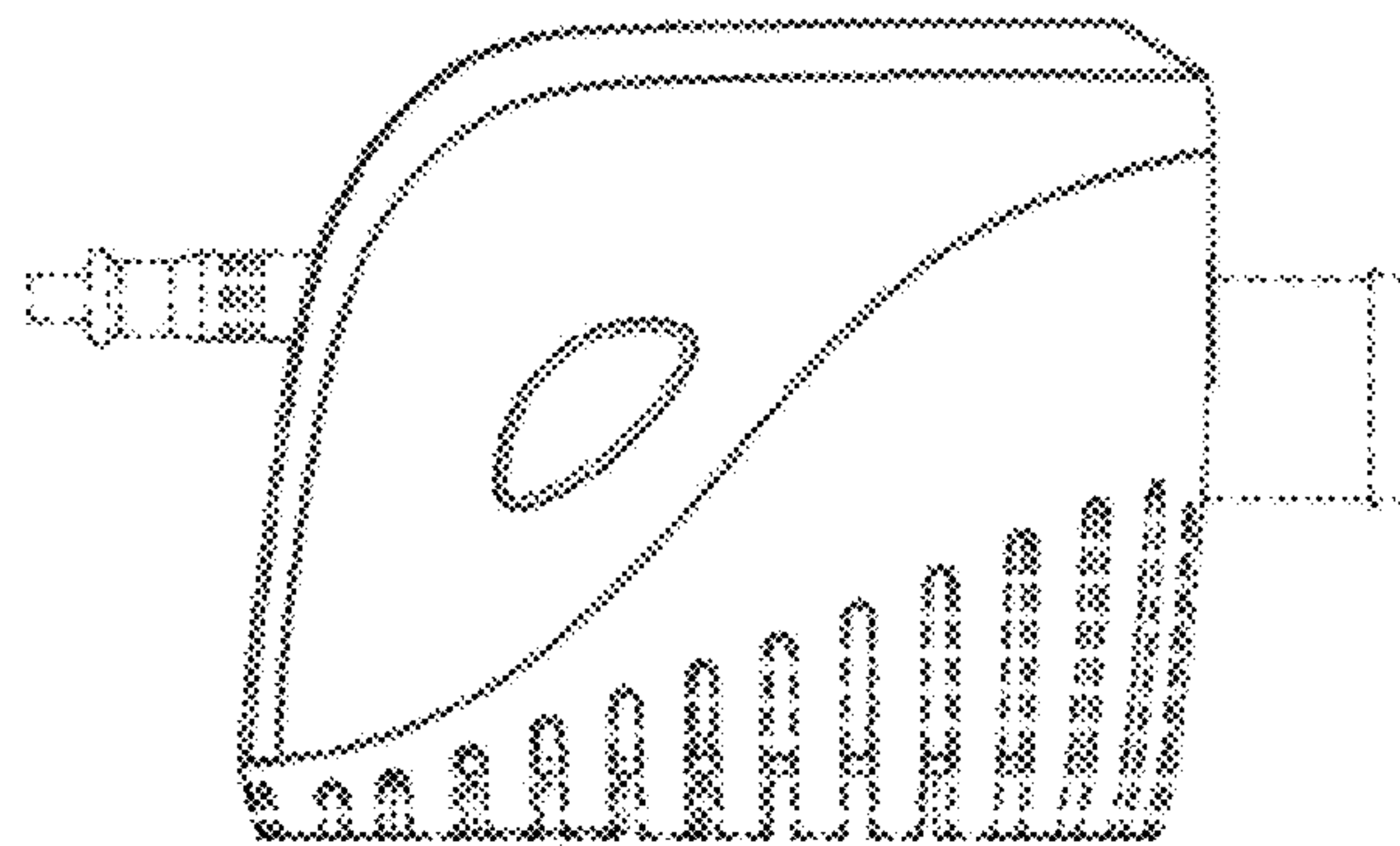

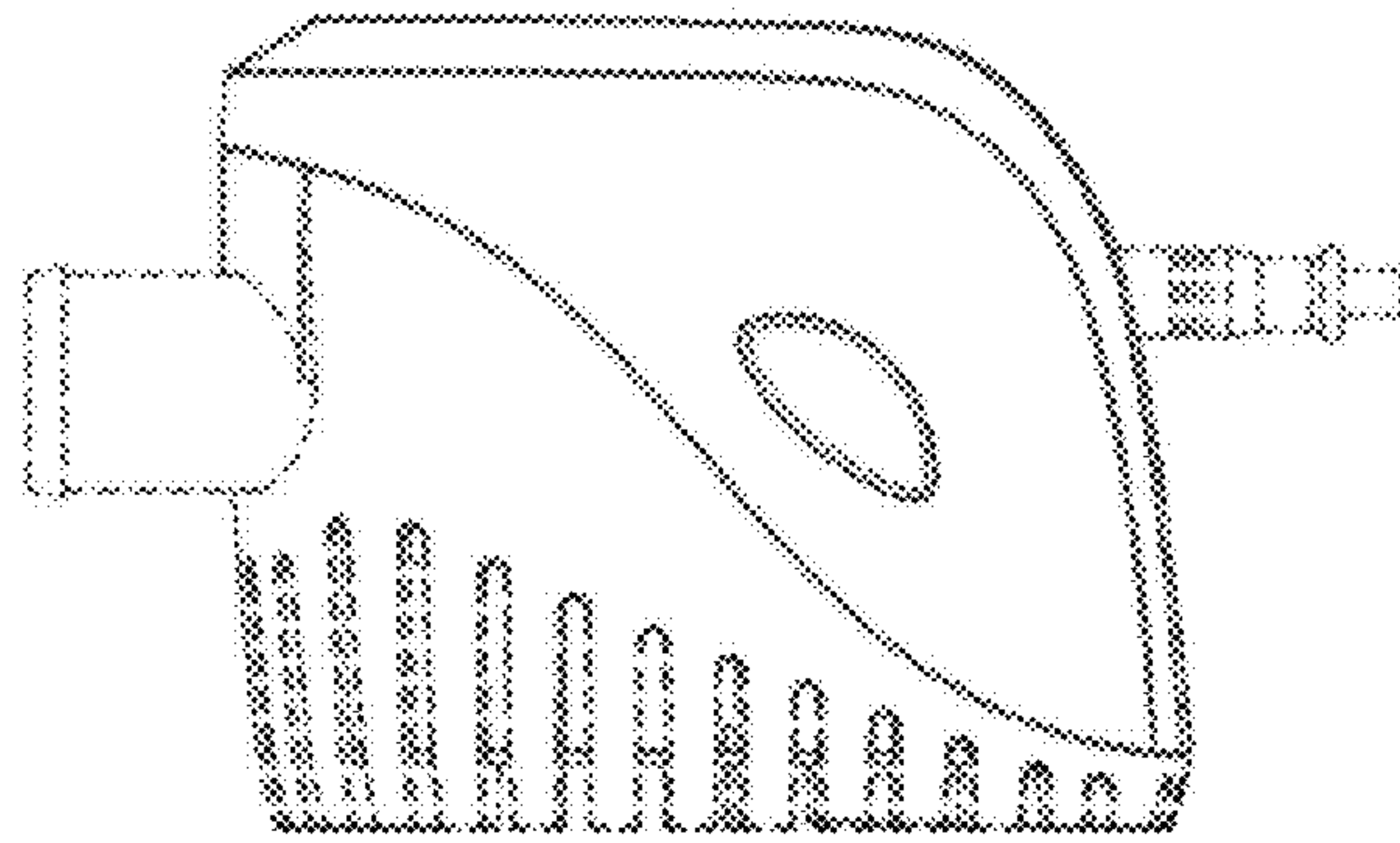

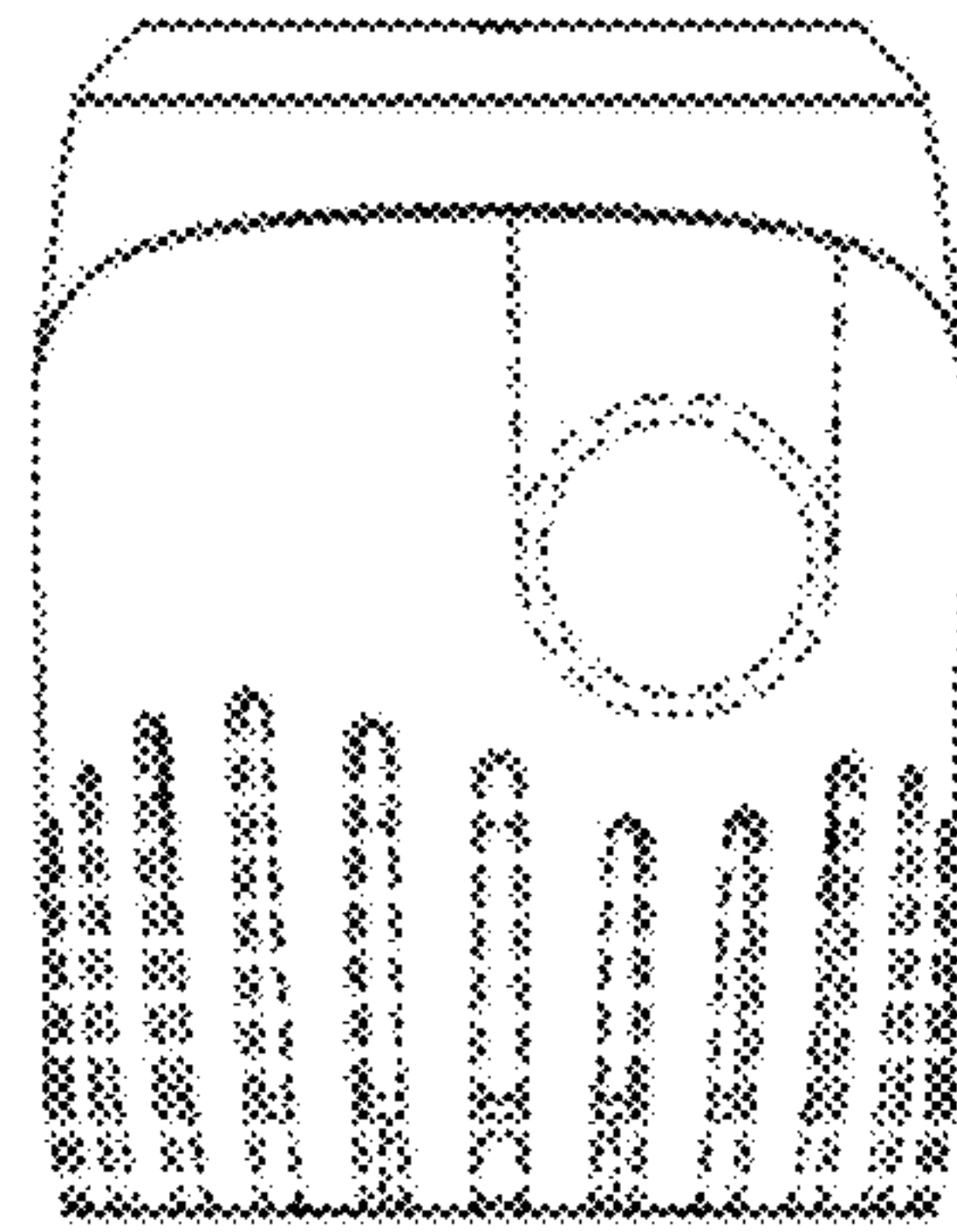

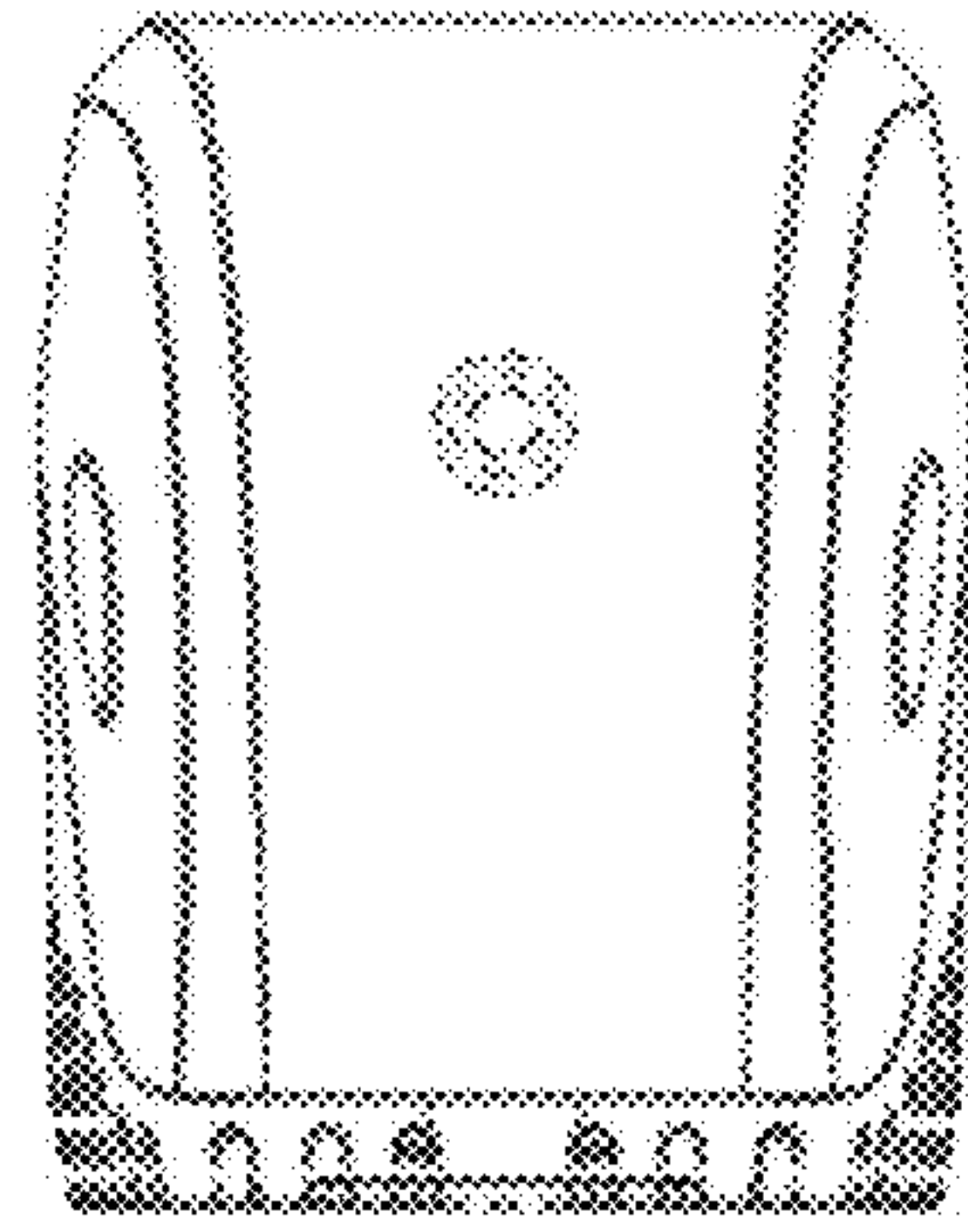

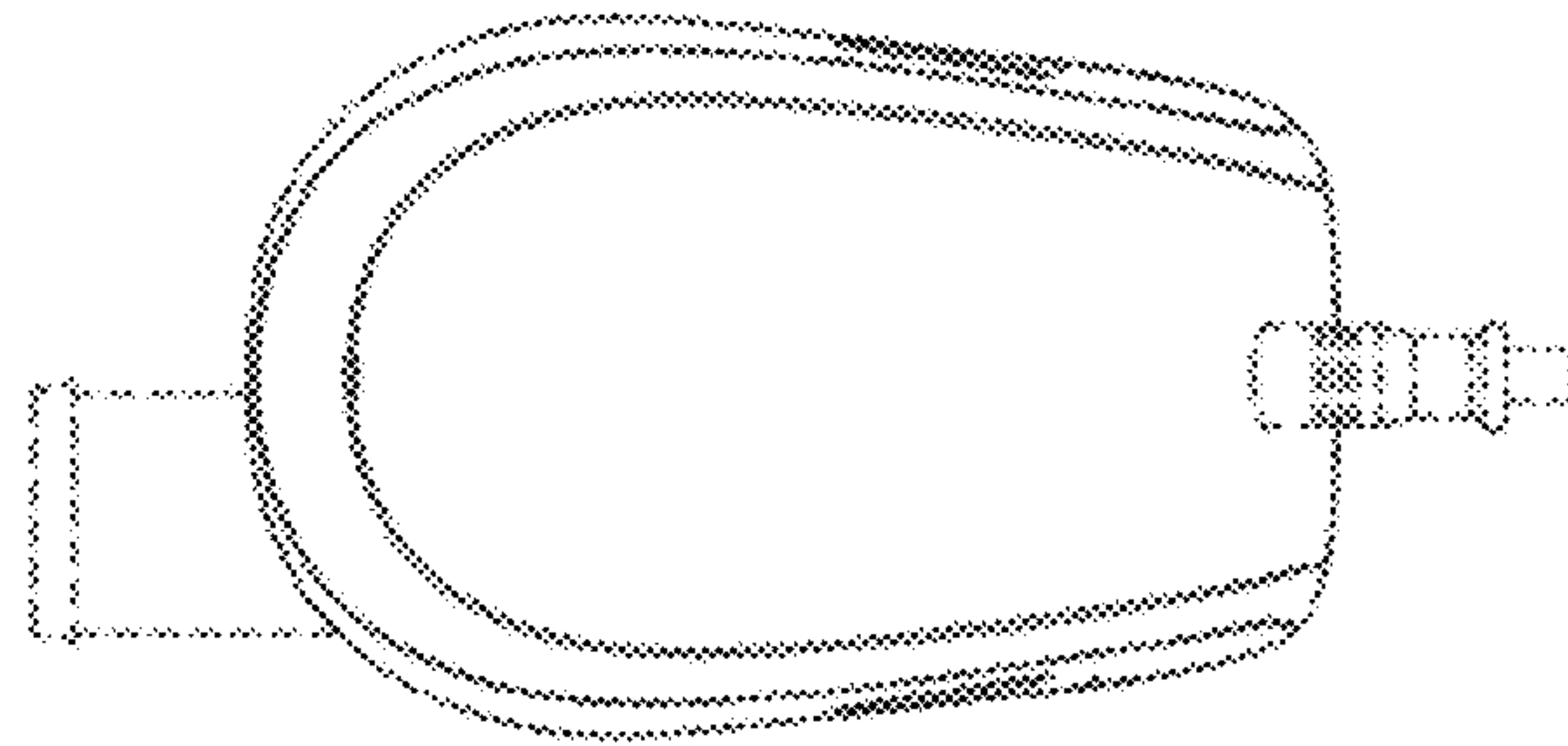

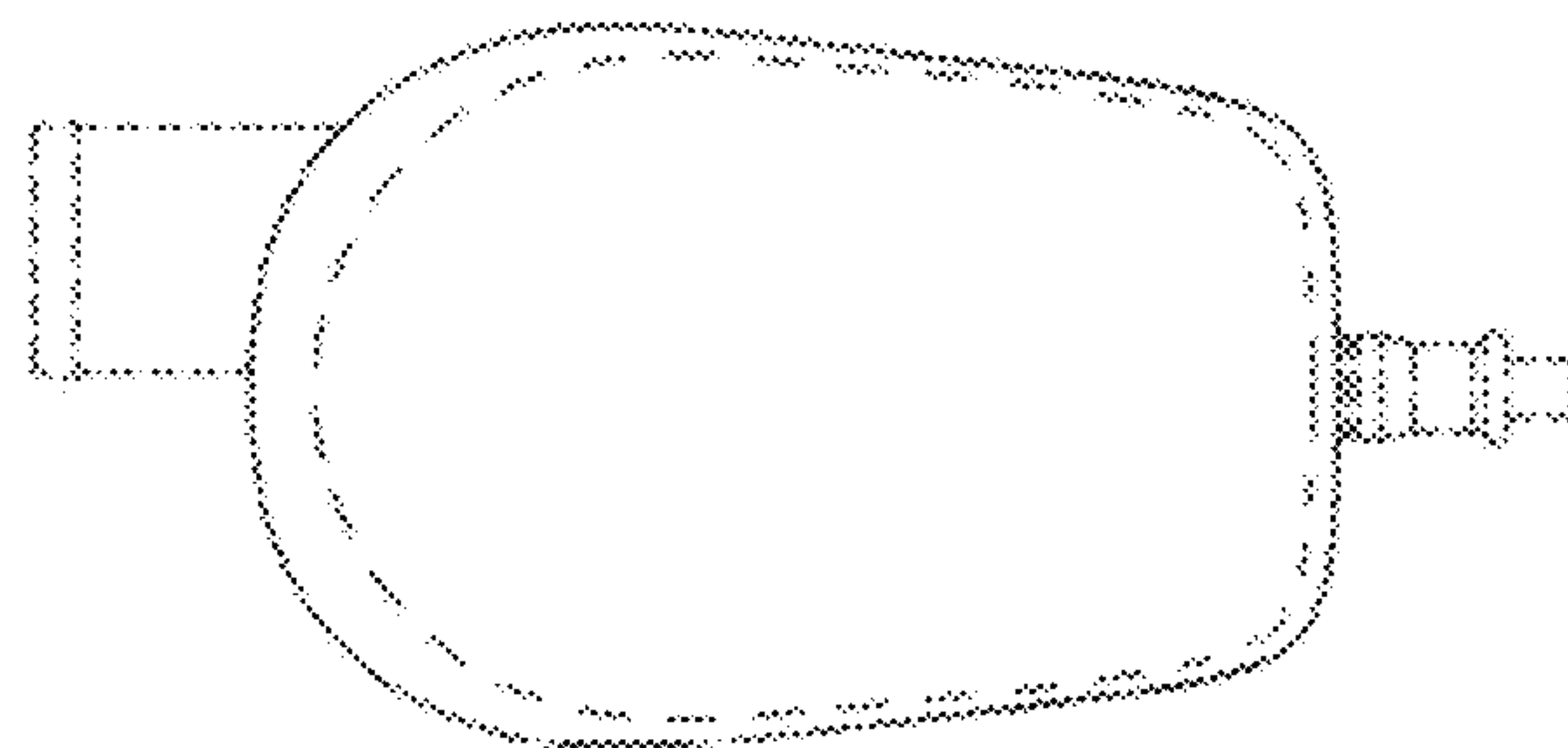
